(57) **CLAIM**

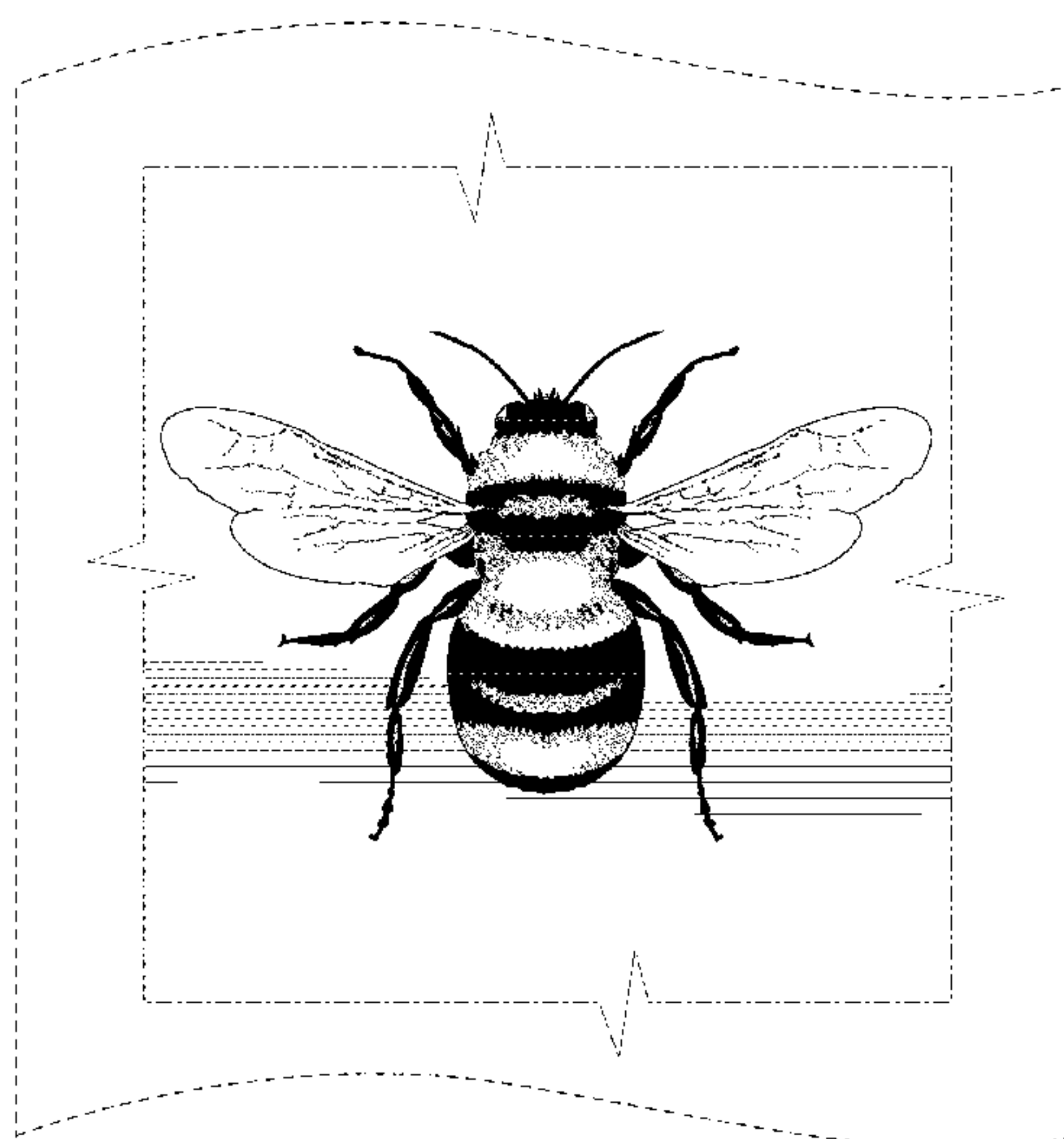
The ornamental design for a bumblebee craft fabric, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the bumblebee craft fabric according to the present design;
FIG. 2 is a front view of the bumblebee craft fabric as shown in FIG. 1;
FIG. 3 is a rear view of the bumblebee craft fabric as shown in FIG. 1;
FIG. 4 is a front perspective view of a second embodiment of a bumblebee craft fabric shown in an environment of use on a pillow; and,
FIG. 5 is a top view of the bumblebee craft fabric as shown in FIG. 4.

The dot dash dot broken lines depict the boundaries of the claim and form no part thereof. The areas and evenly spaced broken lines outside of the dot dash dot broken lines illustrate environmental subject matter that forms no part of the claimed design.

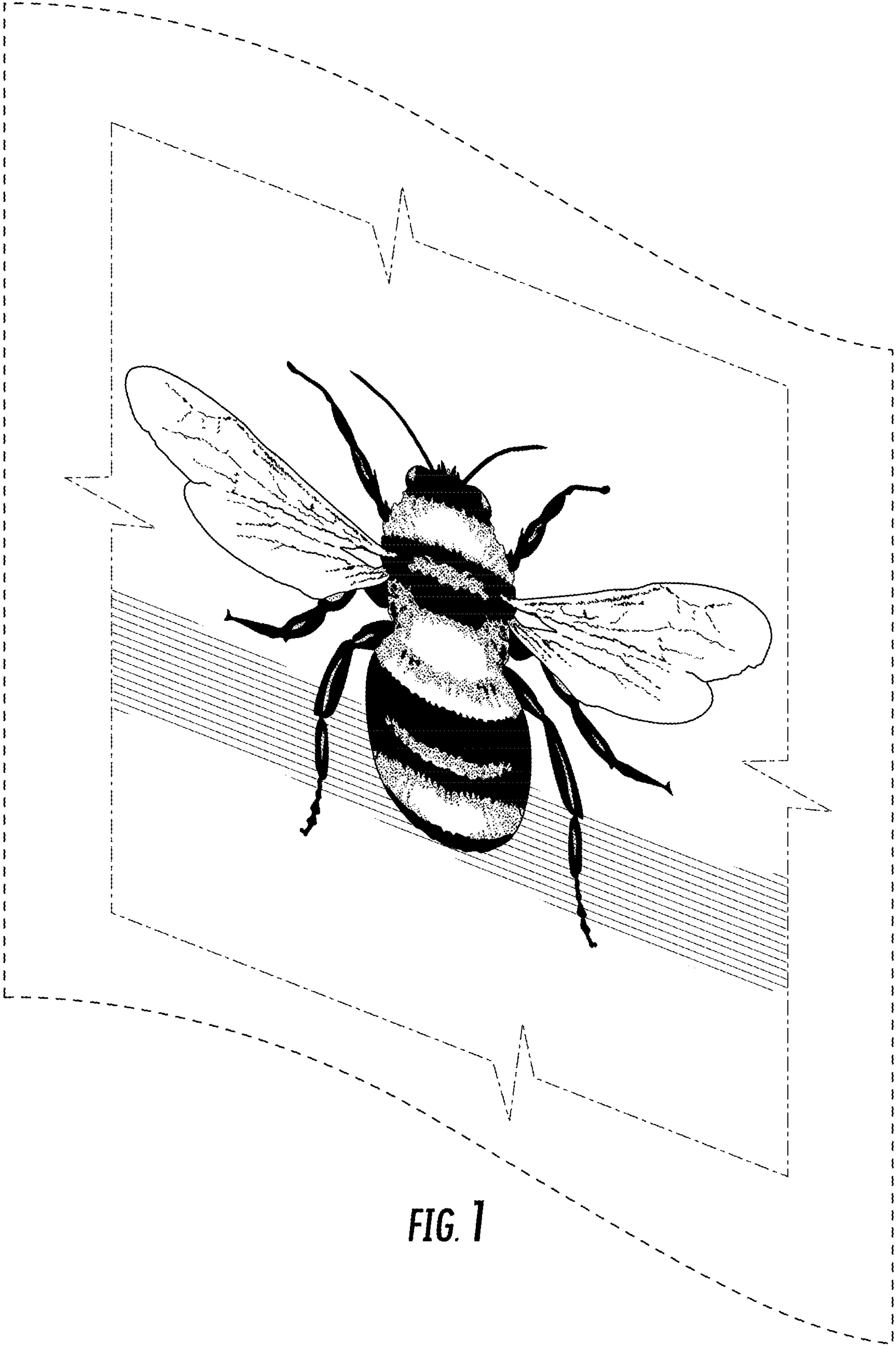

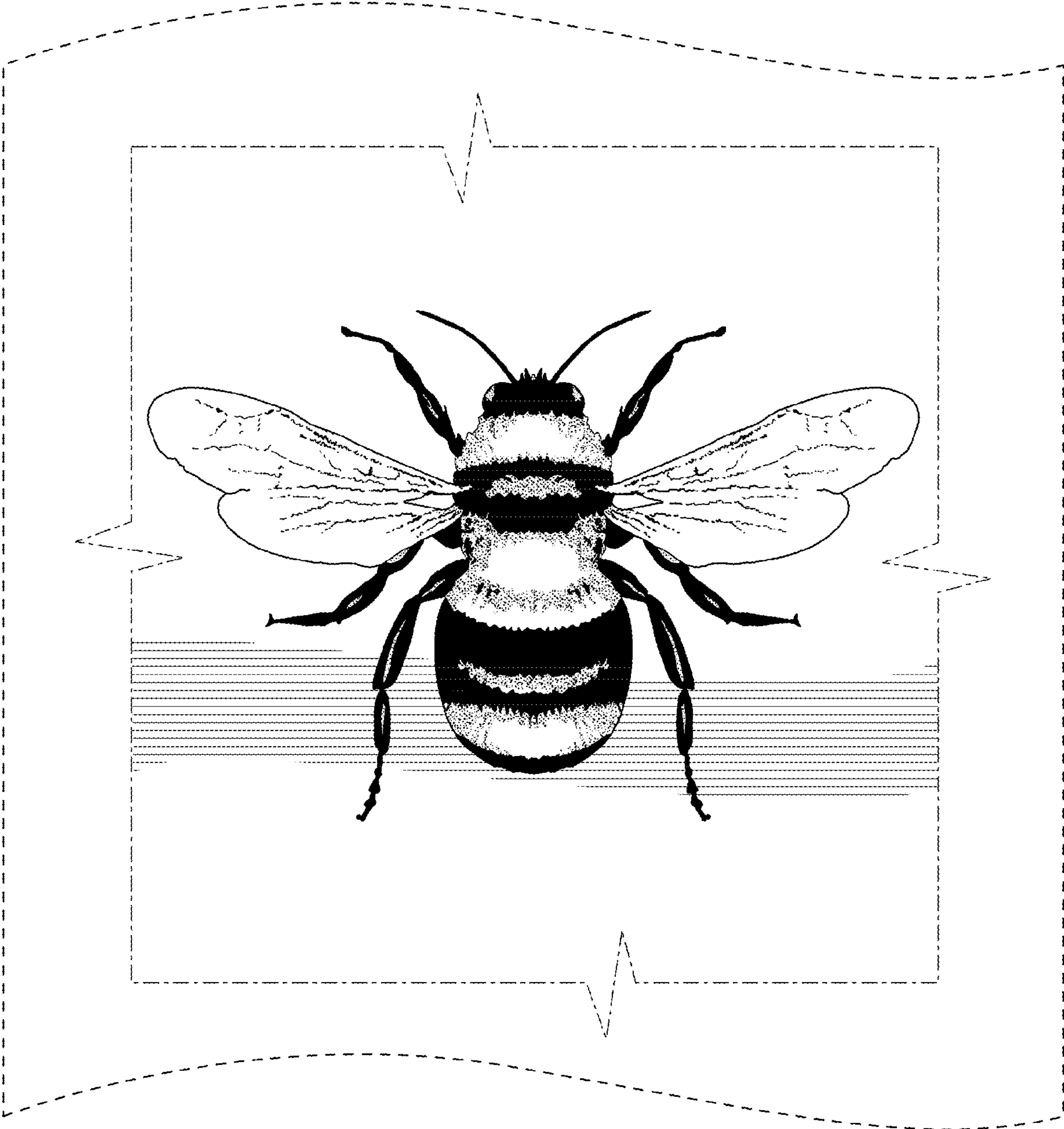

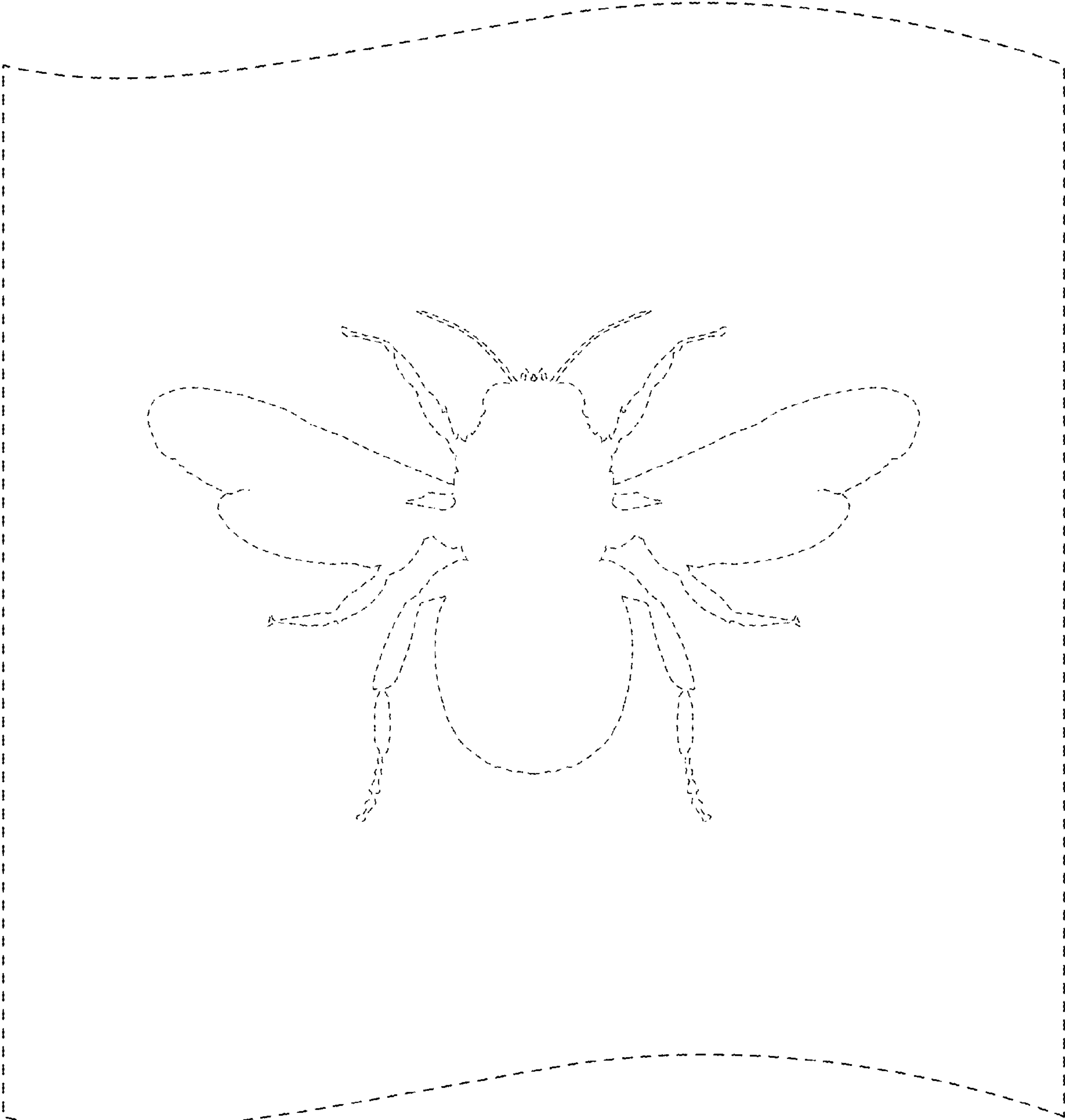

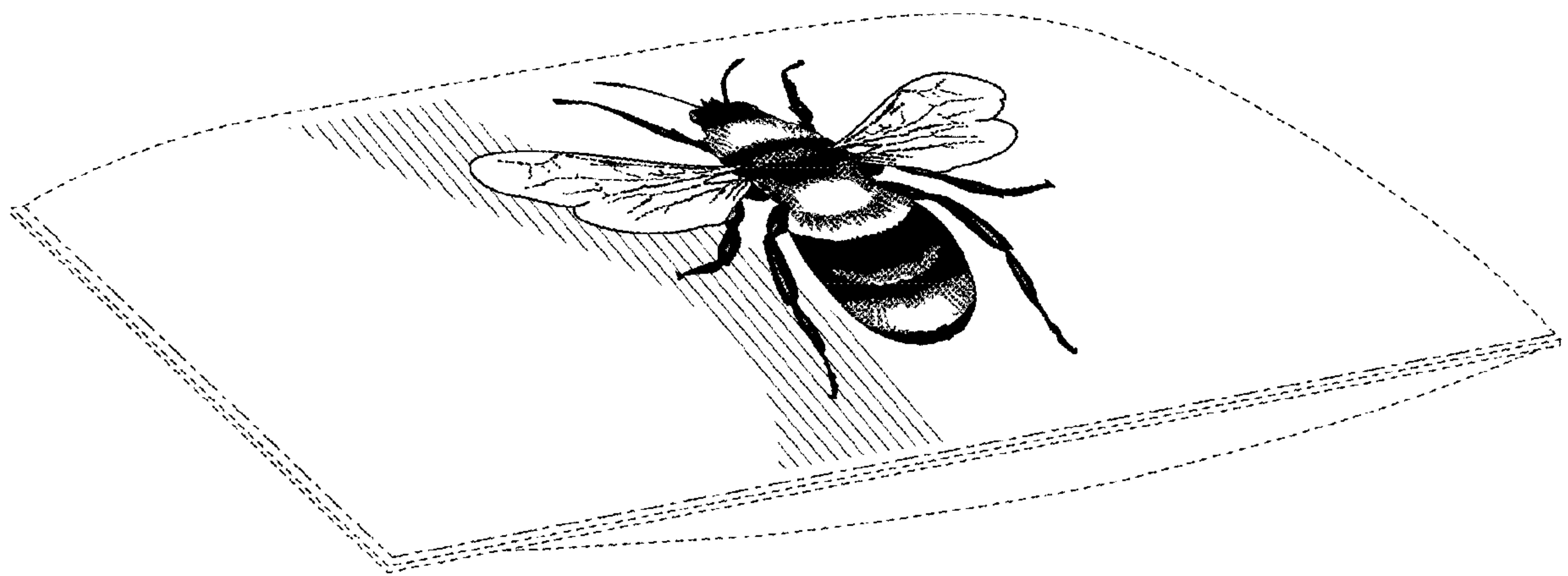

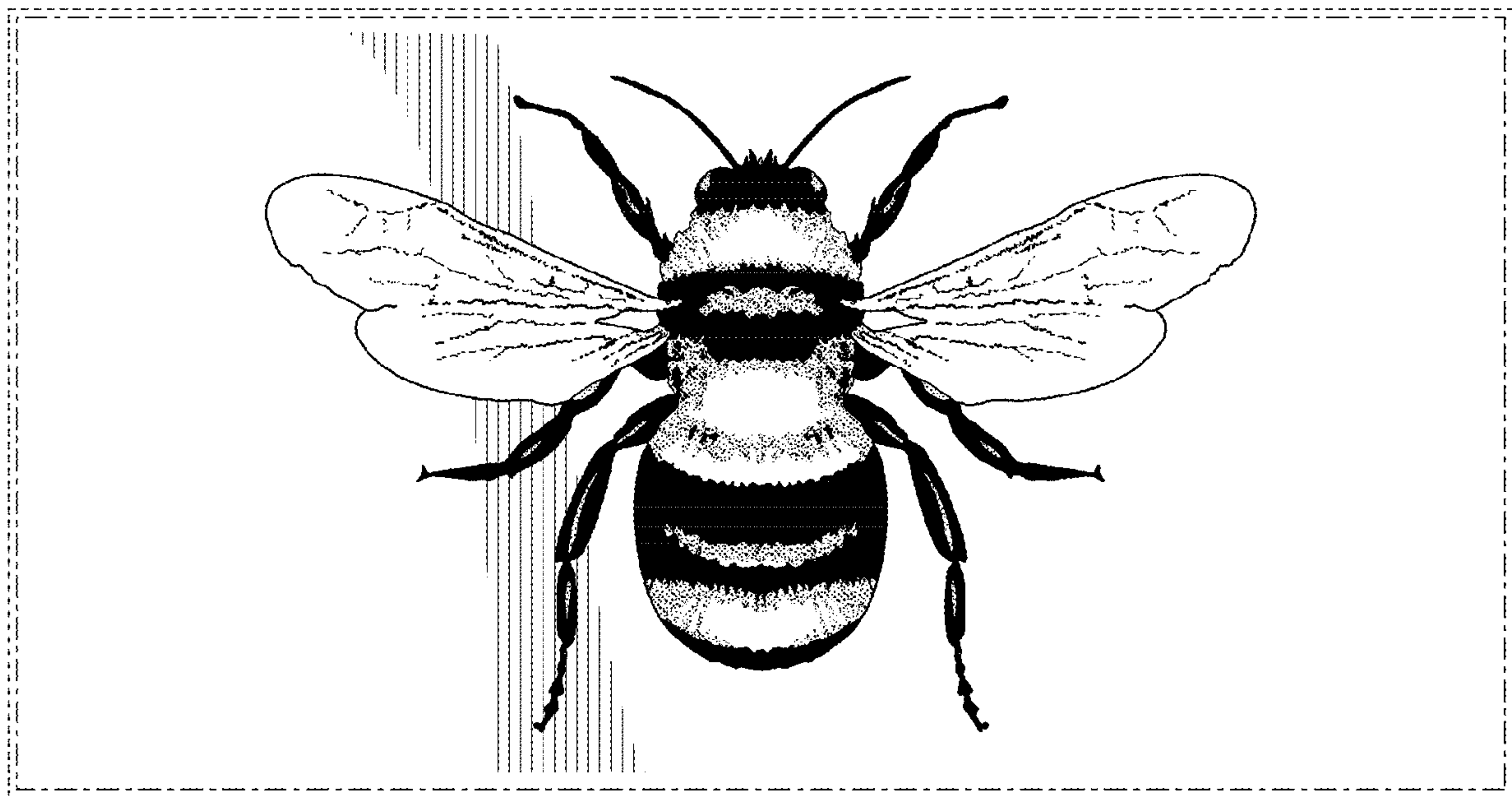
