DESCRIPTION

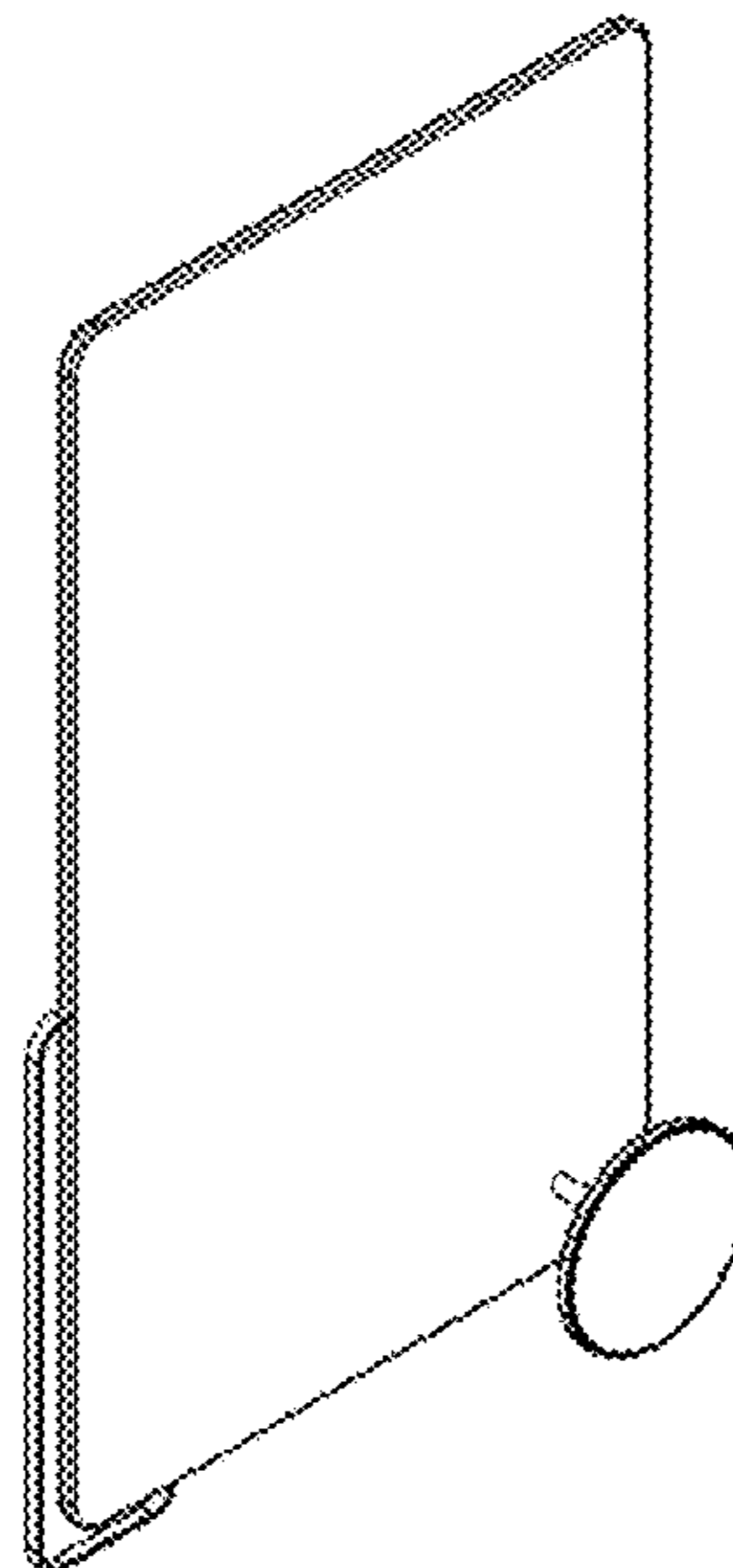
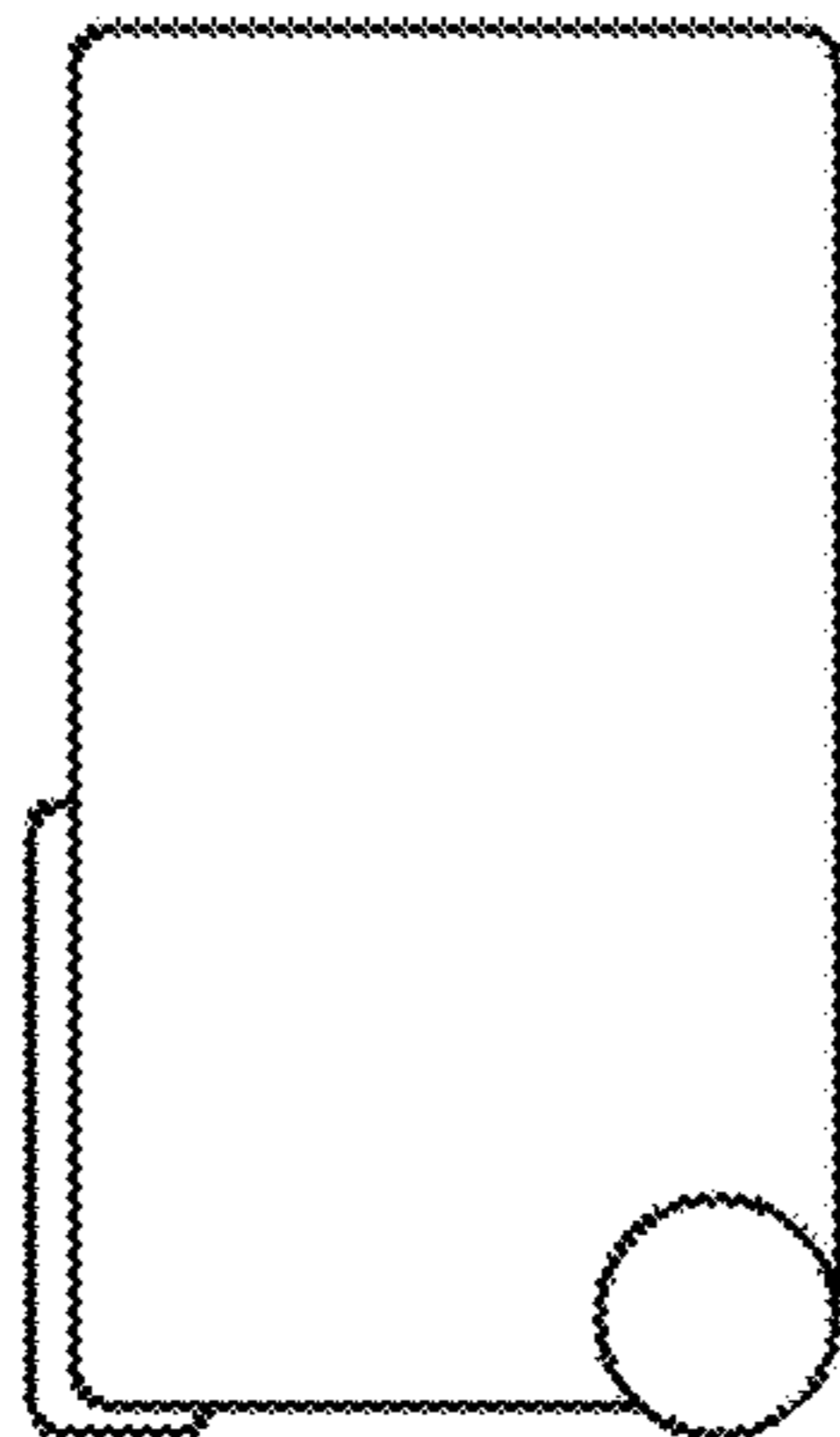
FIG. 1 is a side view of a single panel portable wall showing my new design.

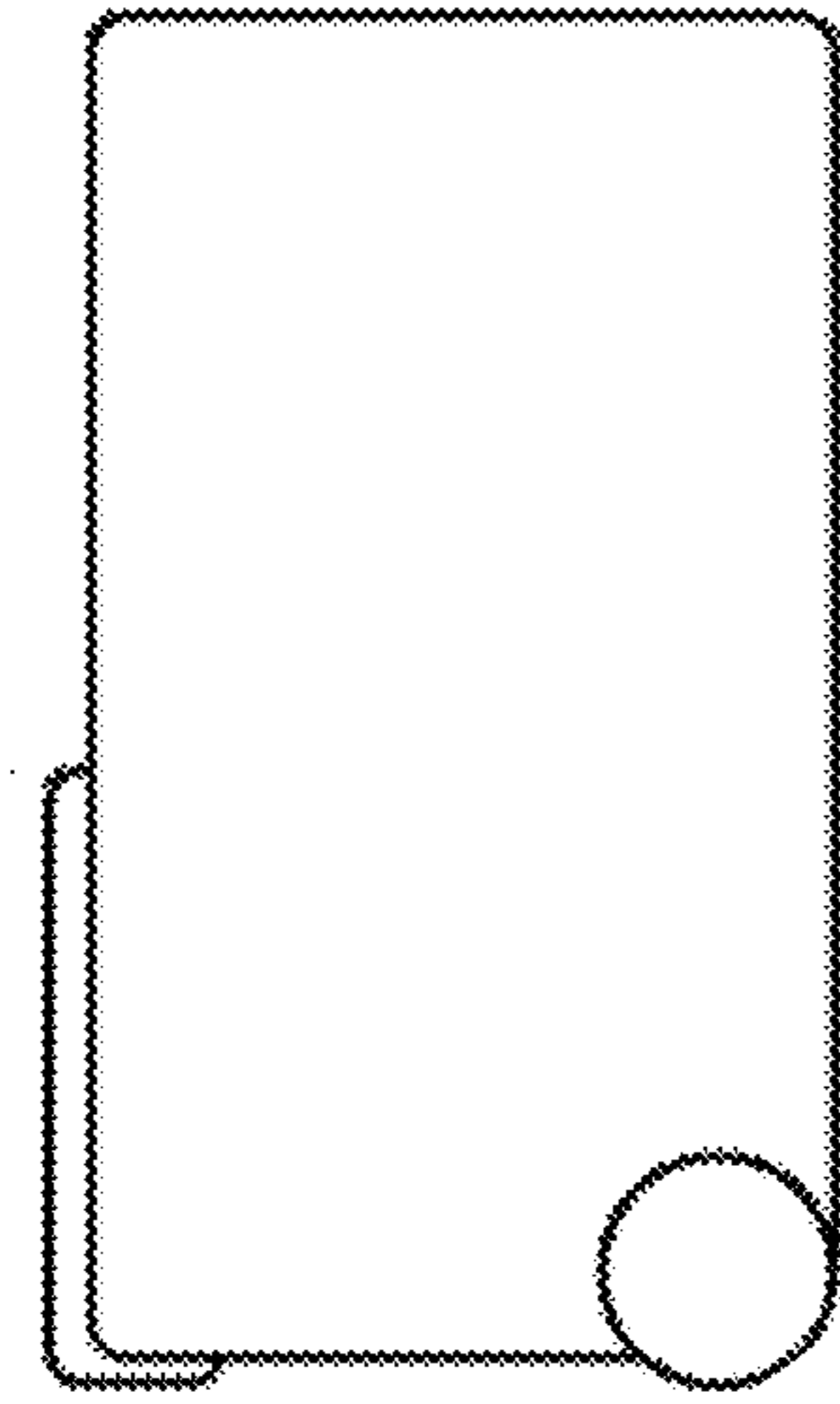

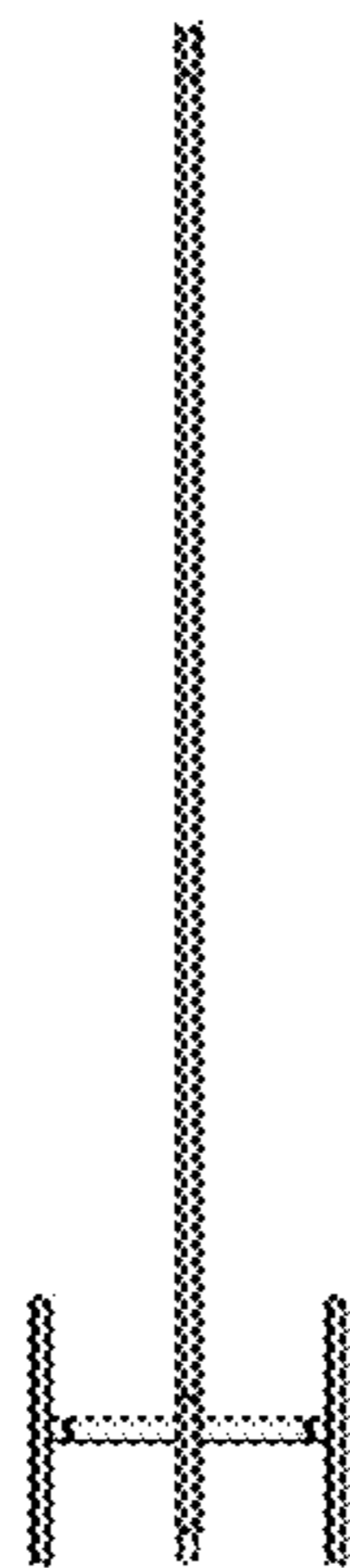

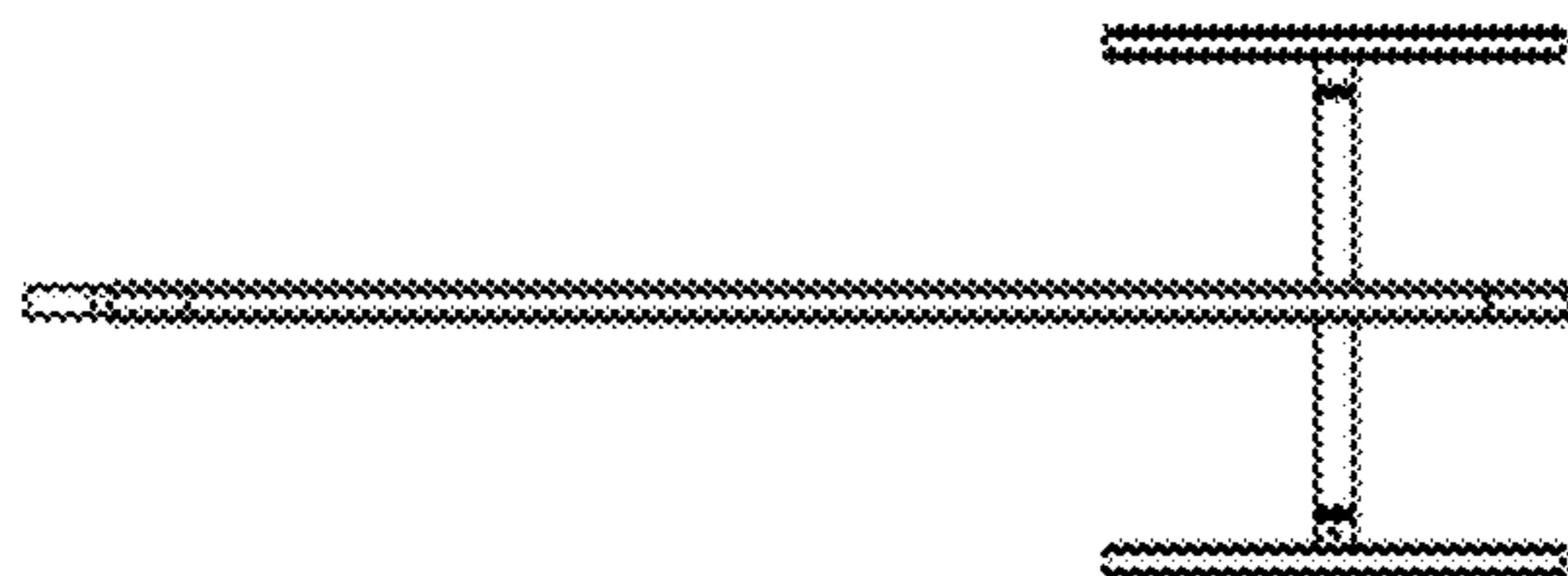

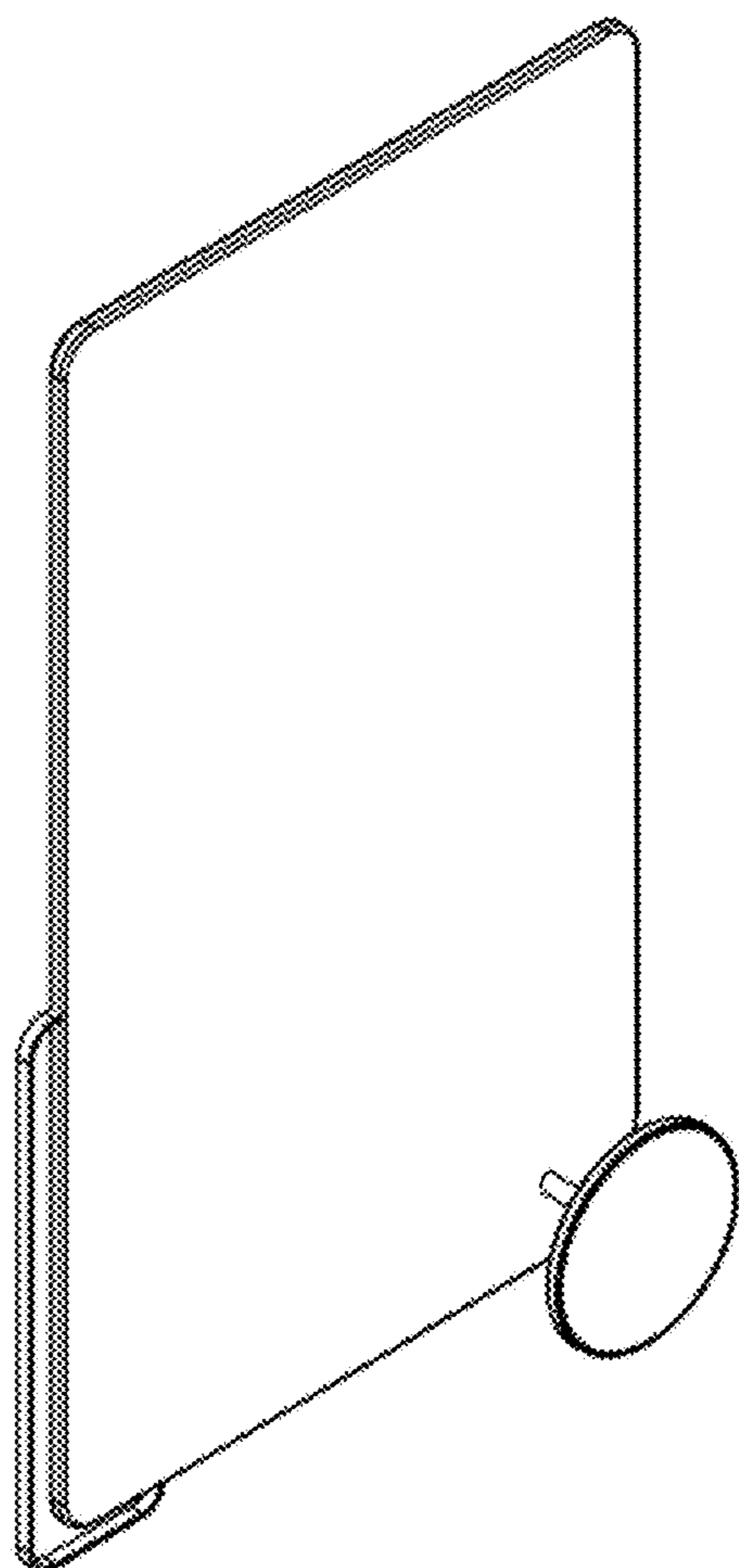
