(57) **CLAIM**

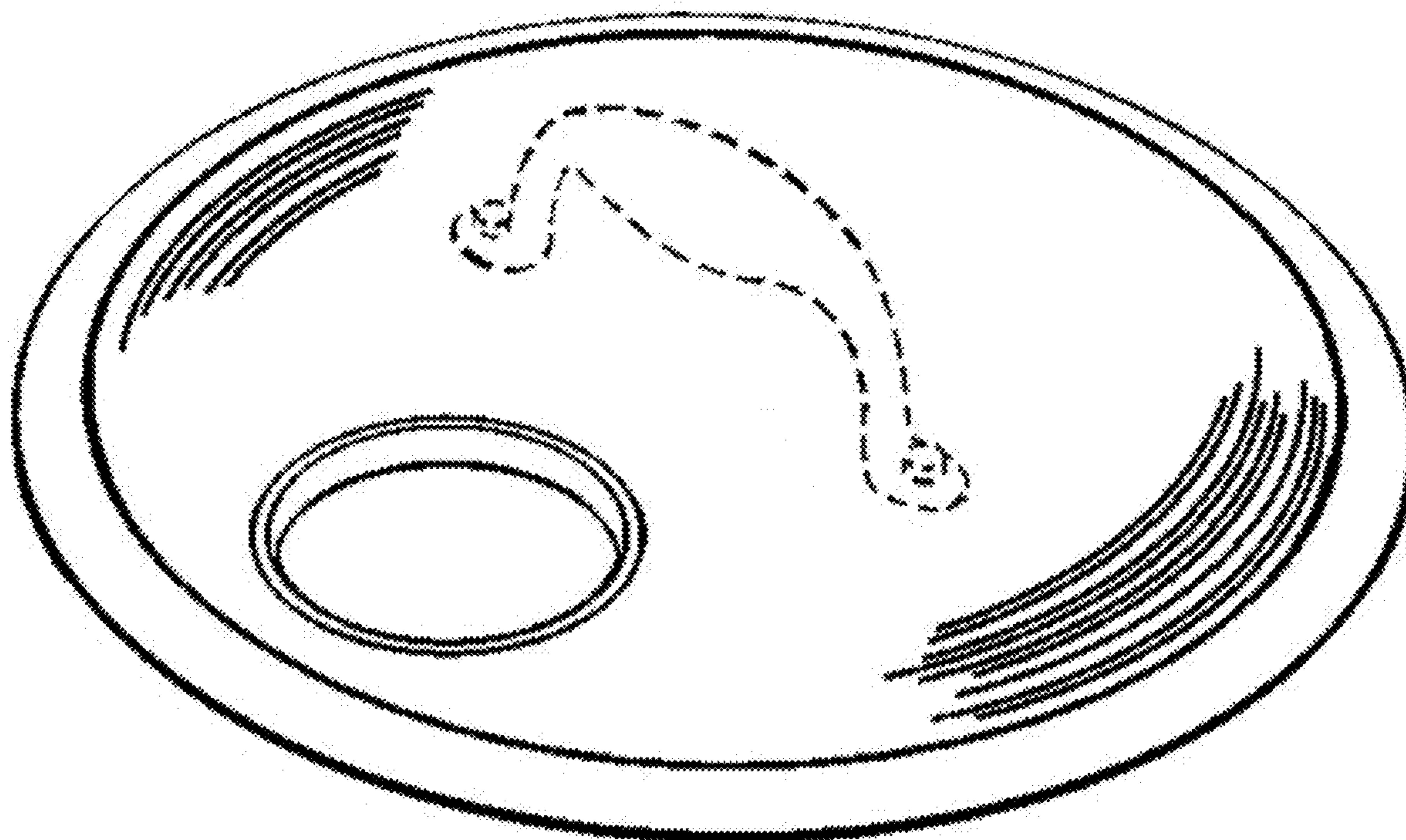
The ornamental design for a silicone cookware lid with a hole, as shown.

DESCRIPTION

FIG. 1 is a perspective view as seen from the top of the silicone cookware lid with a hole showing our new design; FIG. 2. is a top view thereof; FIG. 3. is a right side view thereof; FIG. 4. is a left side view thereof; FIG. 5. is a front view thereof; FIG. 6. is a bottom view thereof; and, FIG. 7. is a perspective view as seen from the bottom thereof.

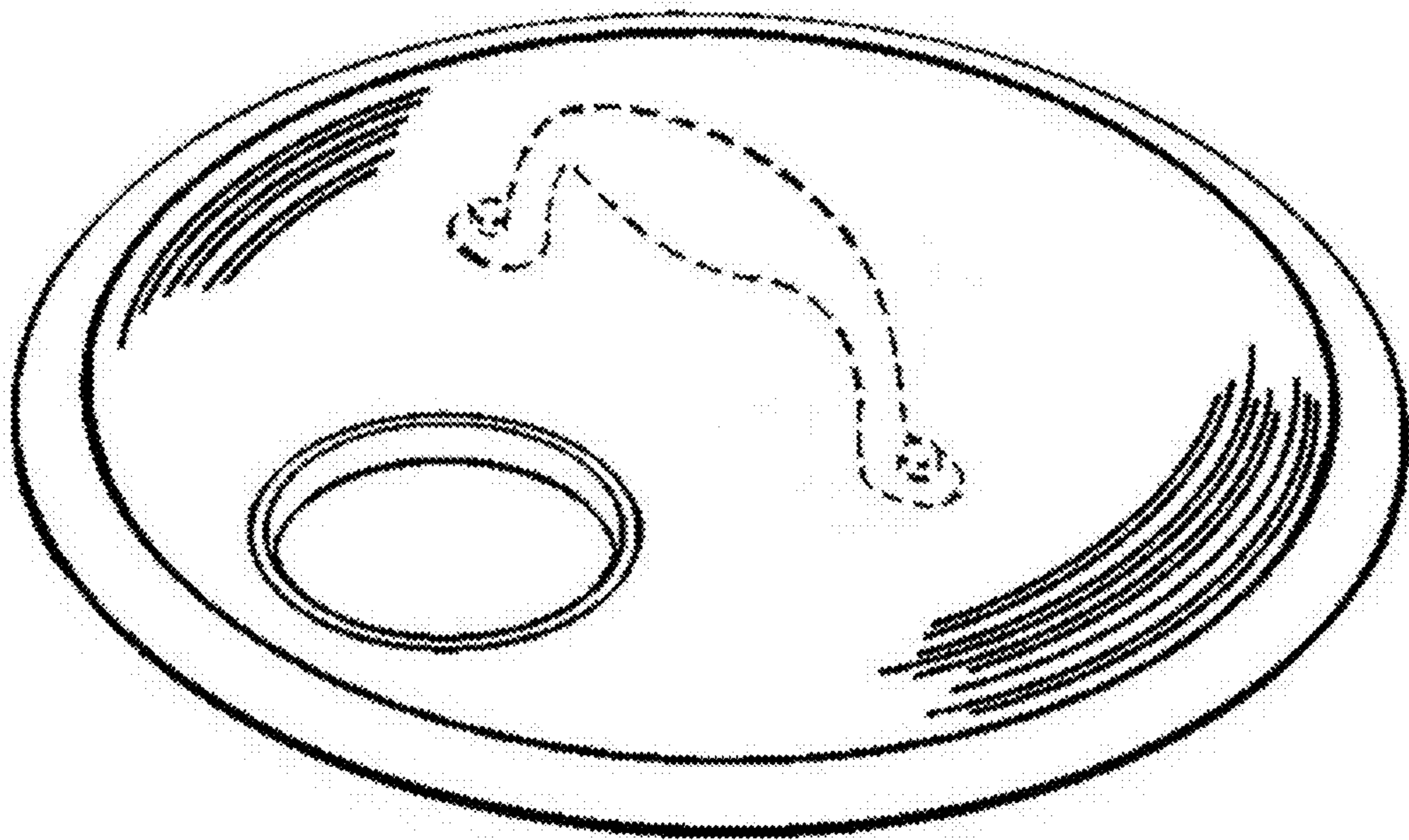

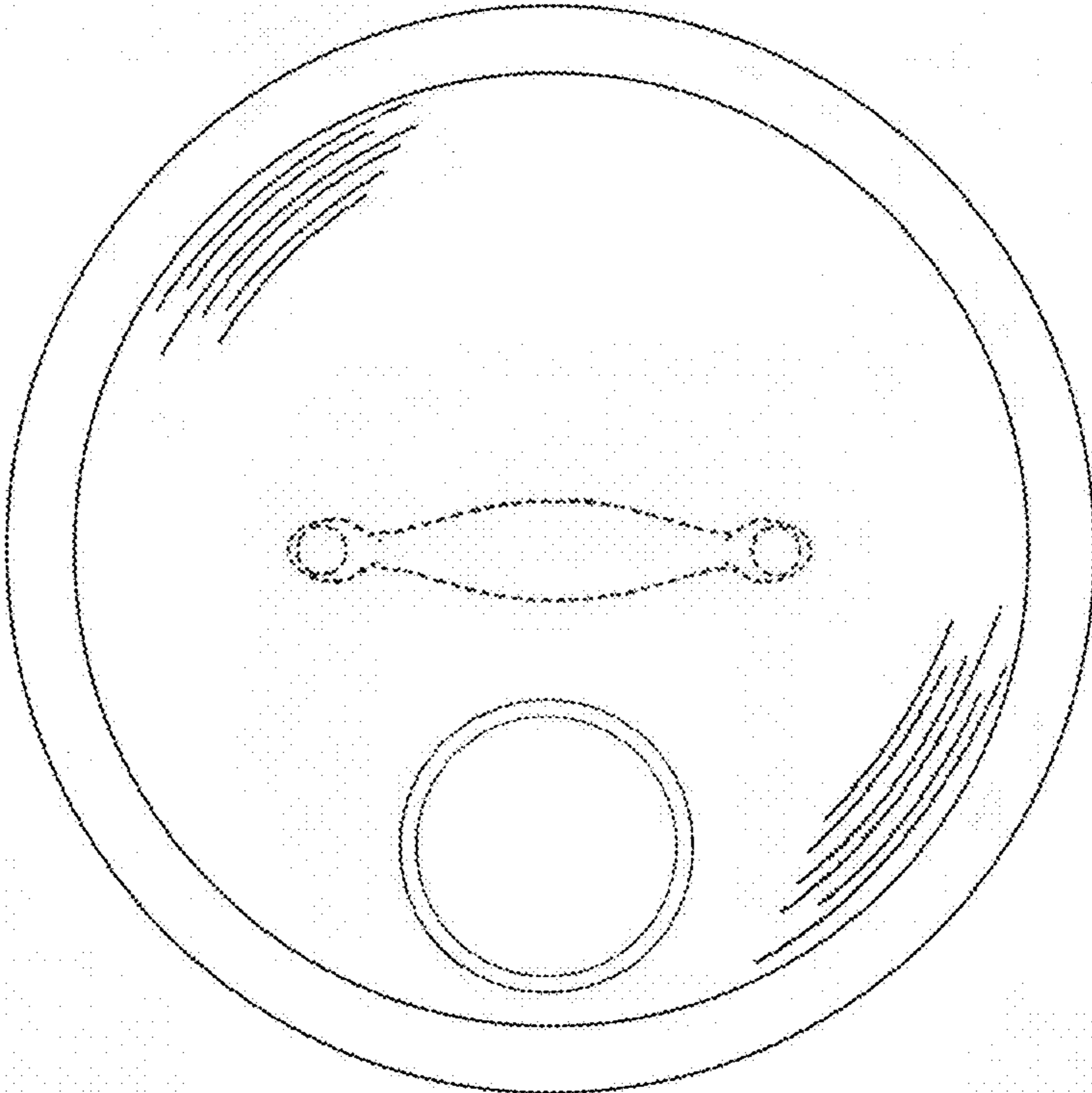

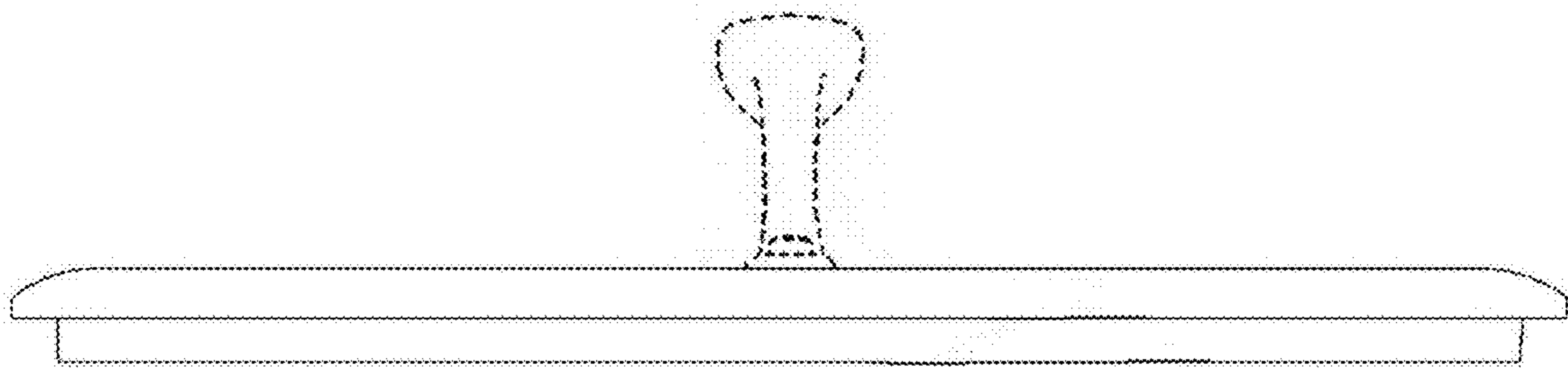

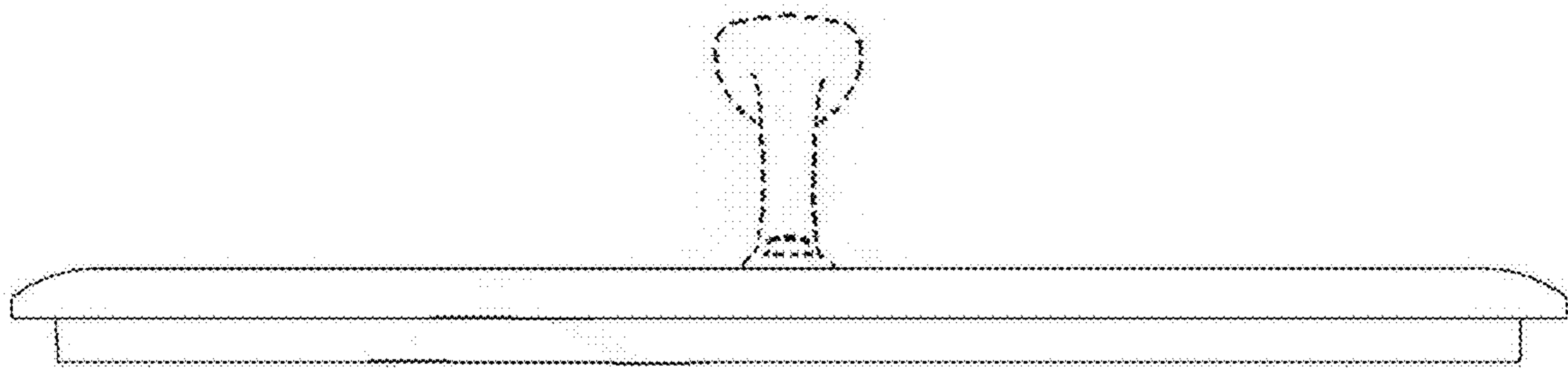

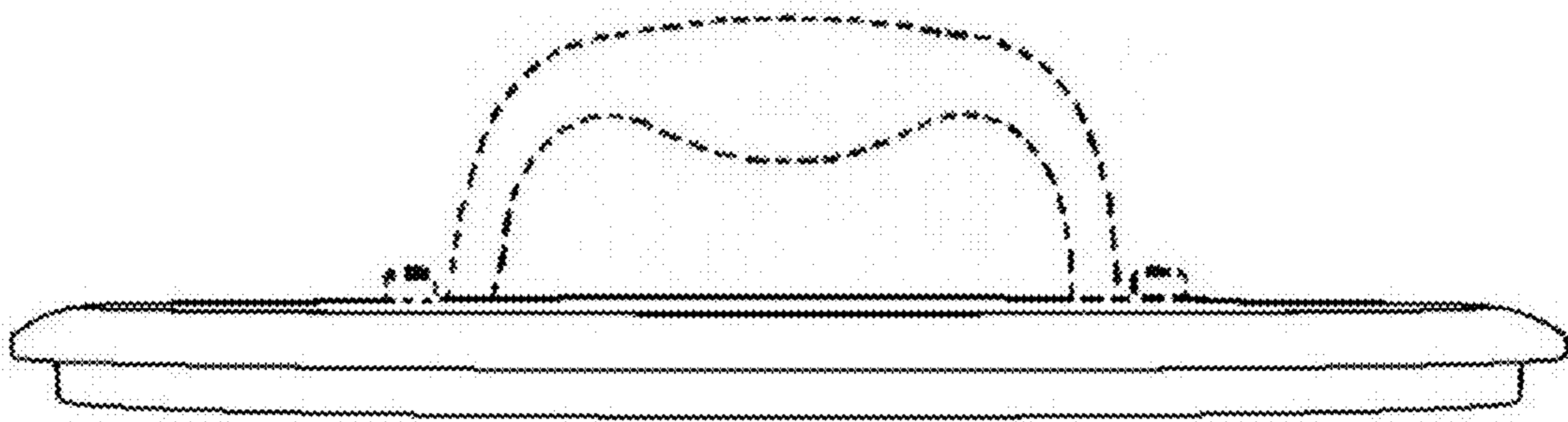

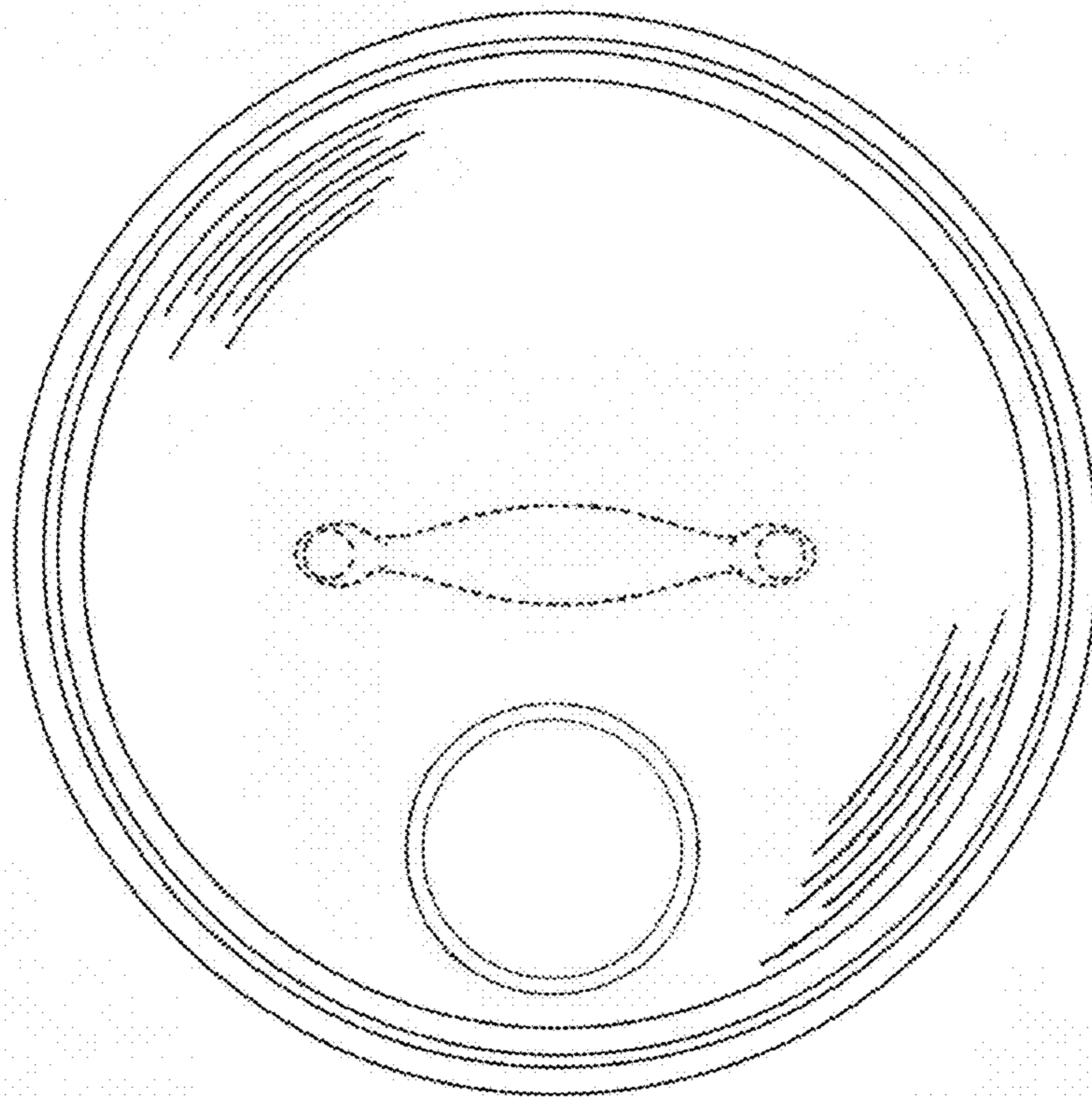

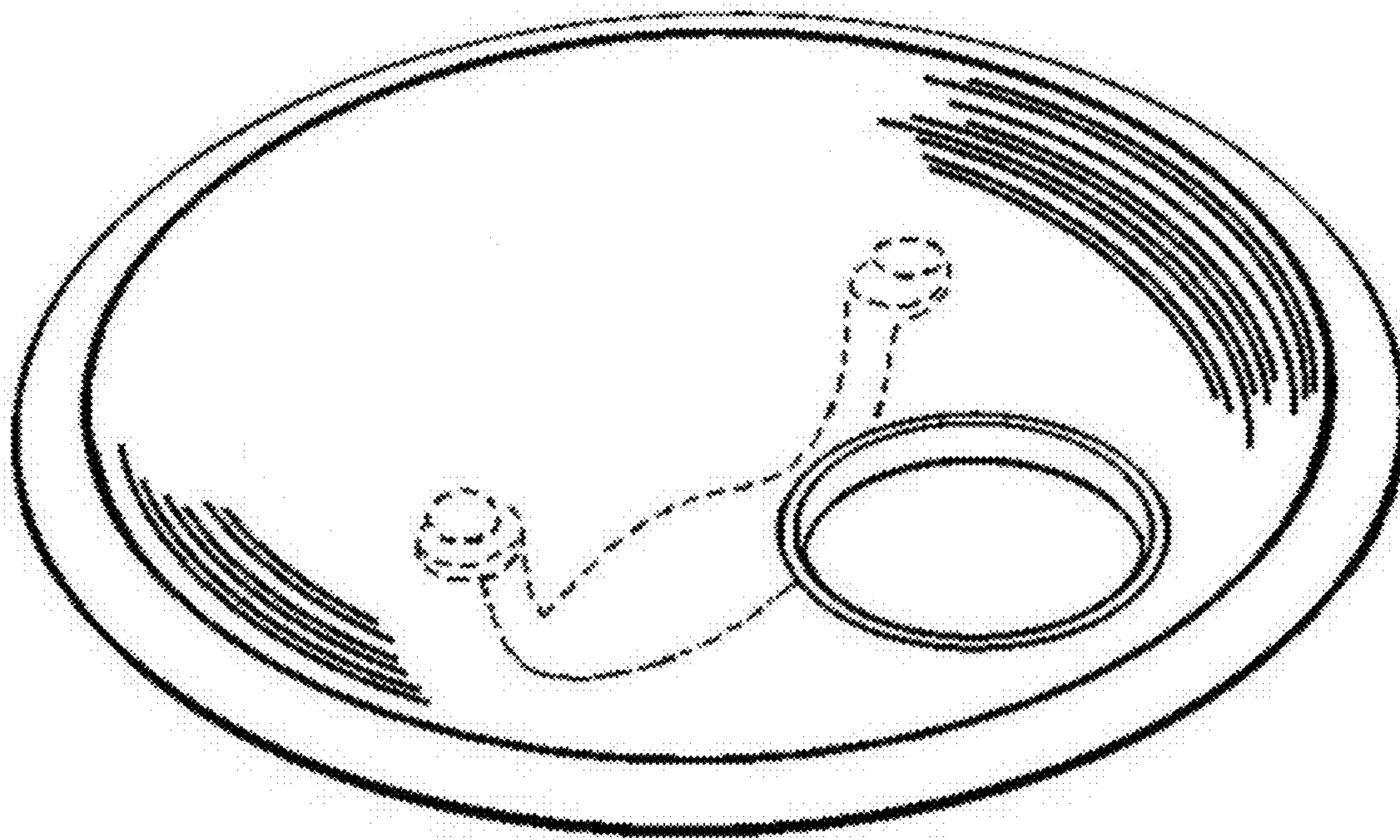
