**DESCRIPTION**

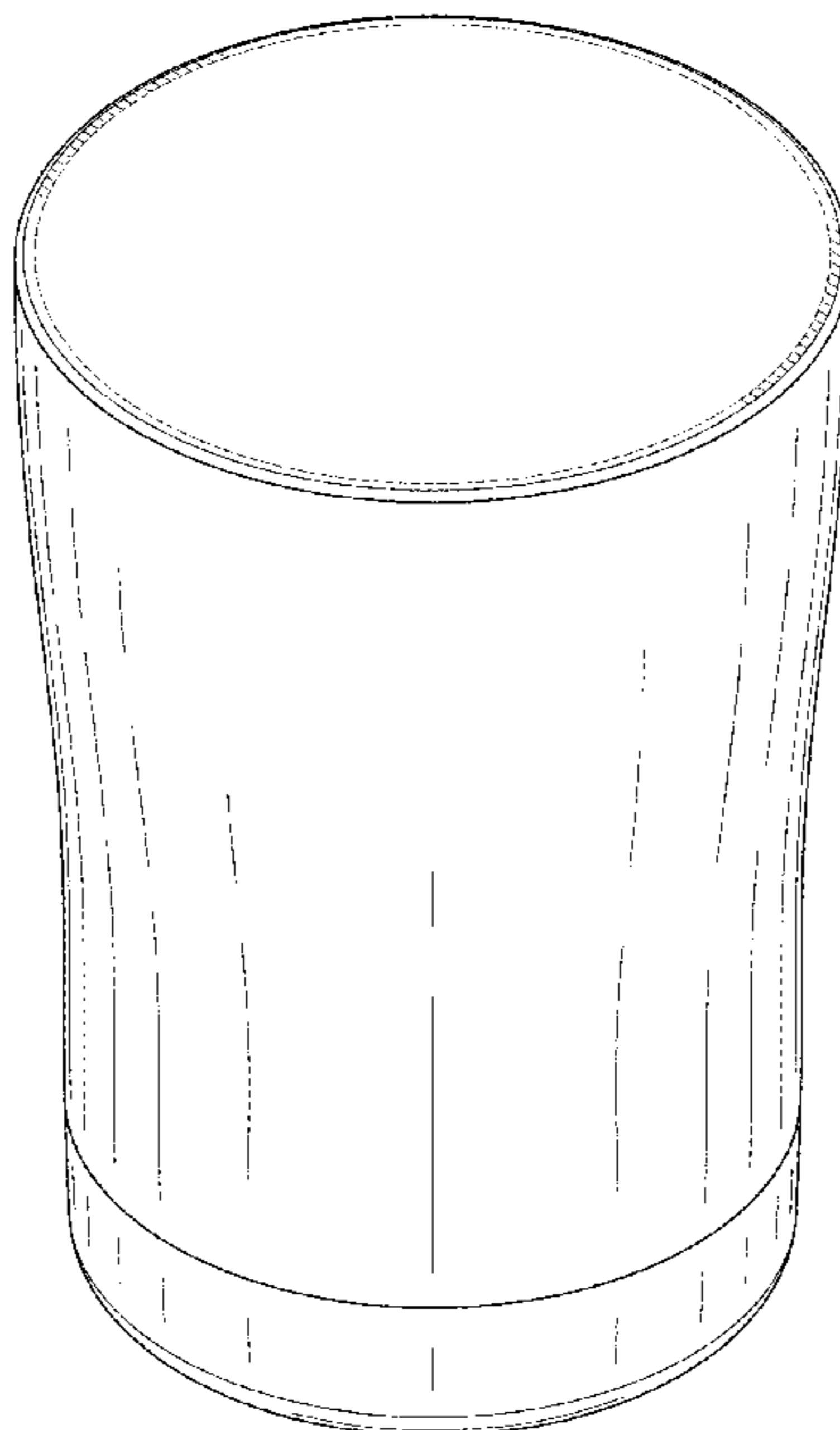
FIG. 1 is a top perspective view of a tumbler showing my new design;

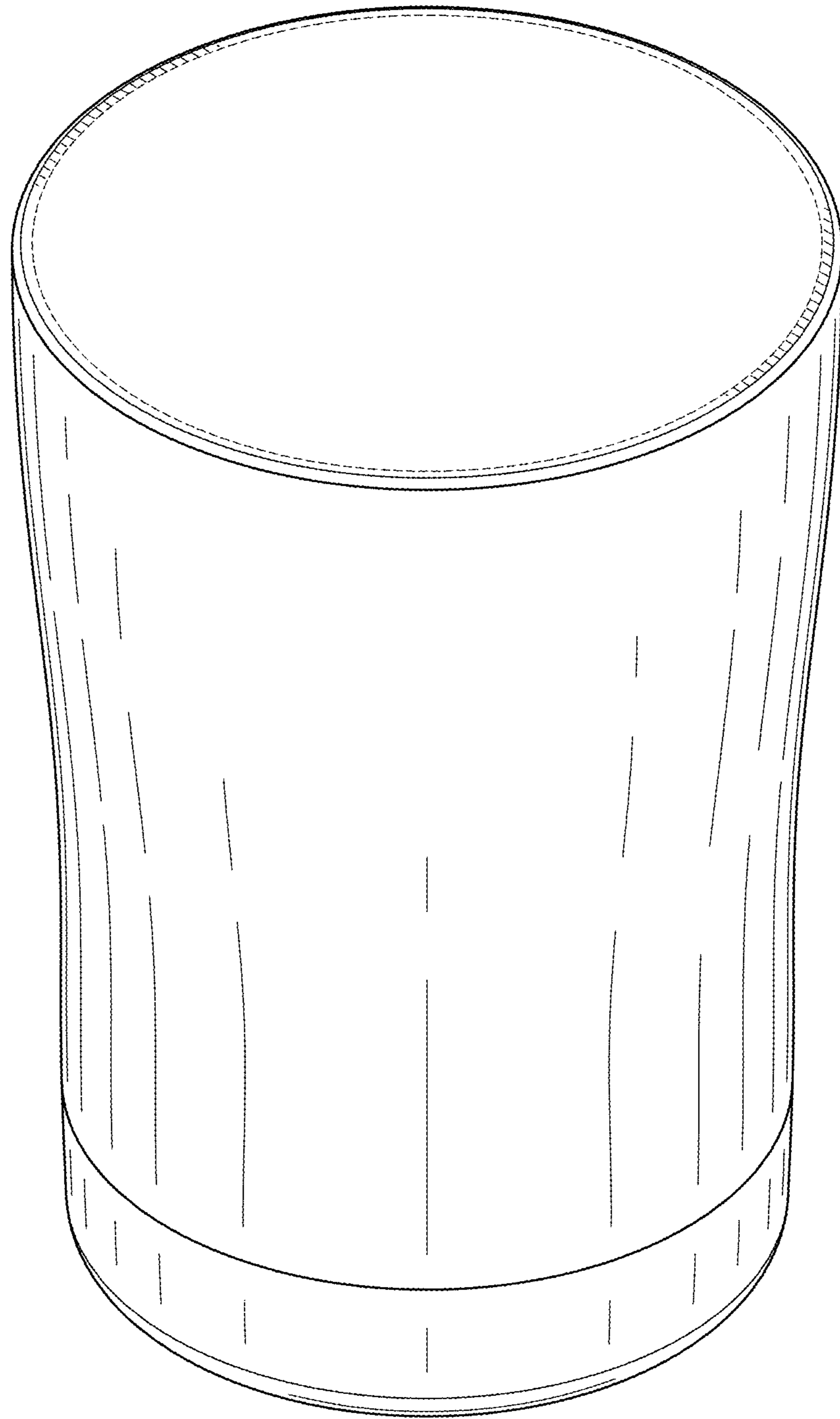

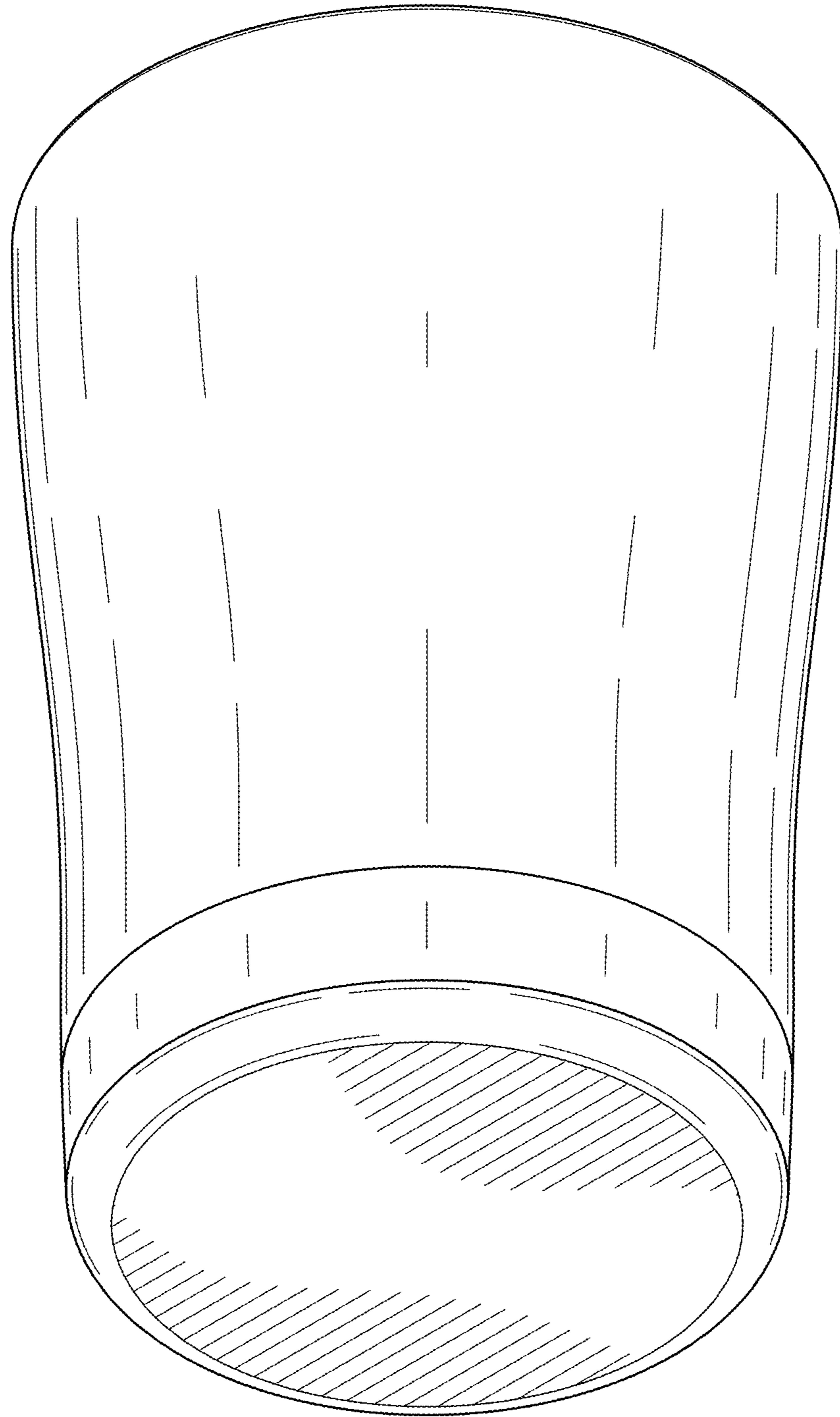

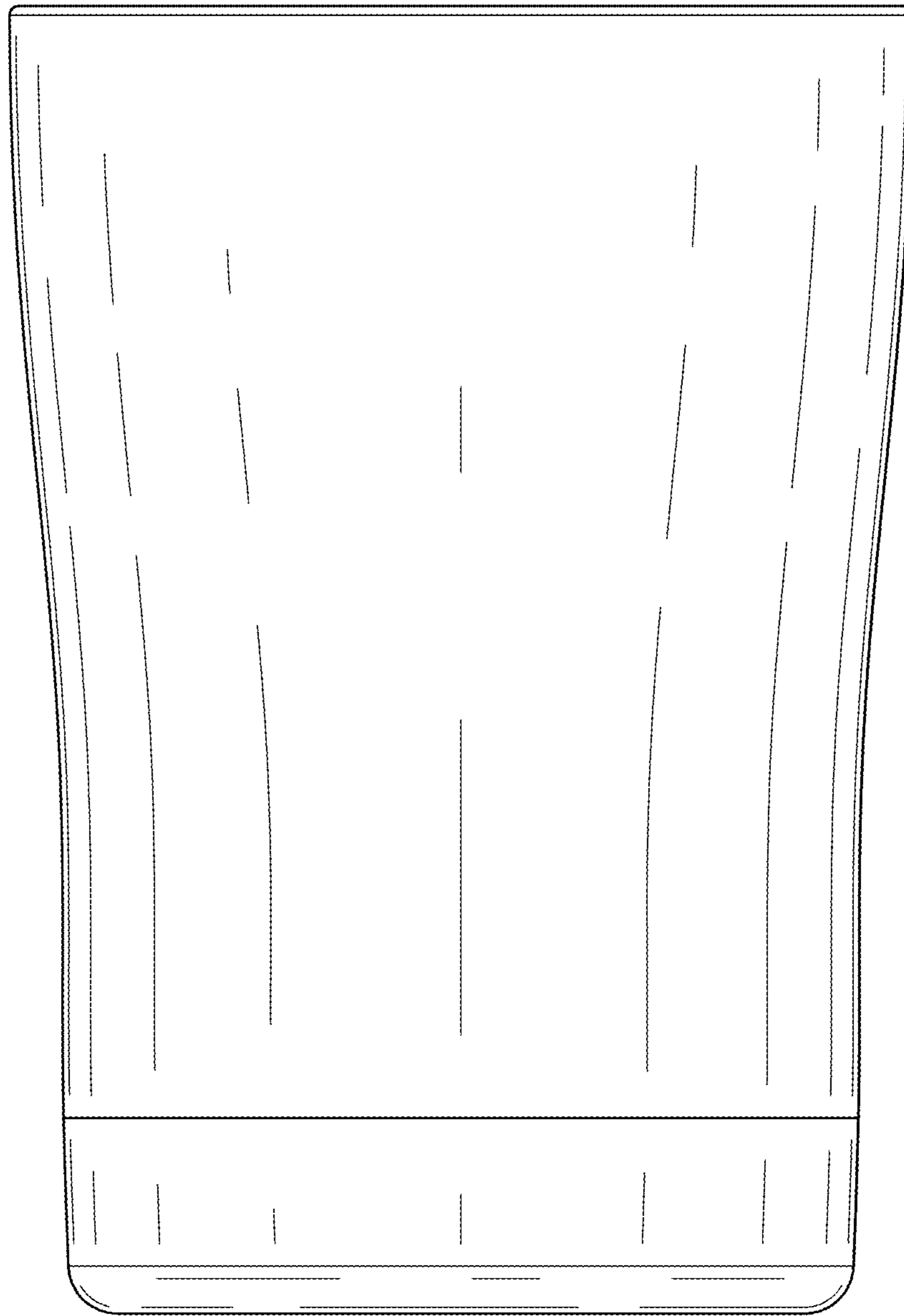

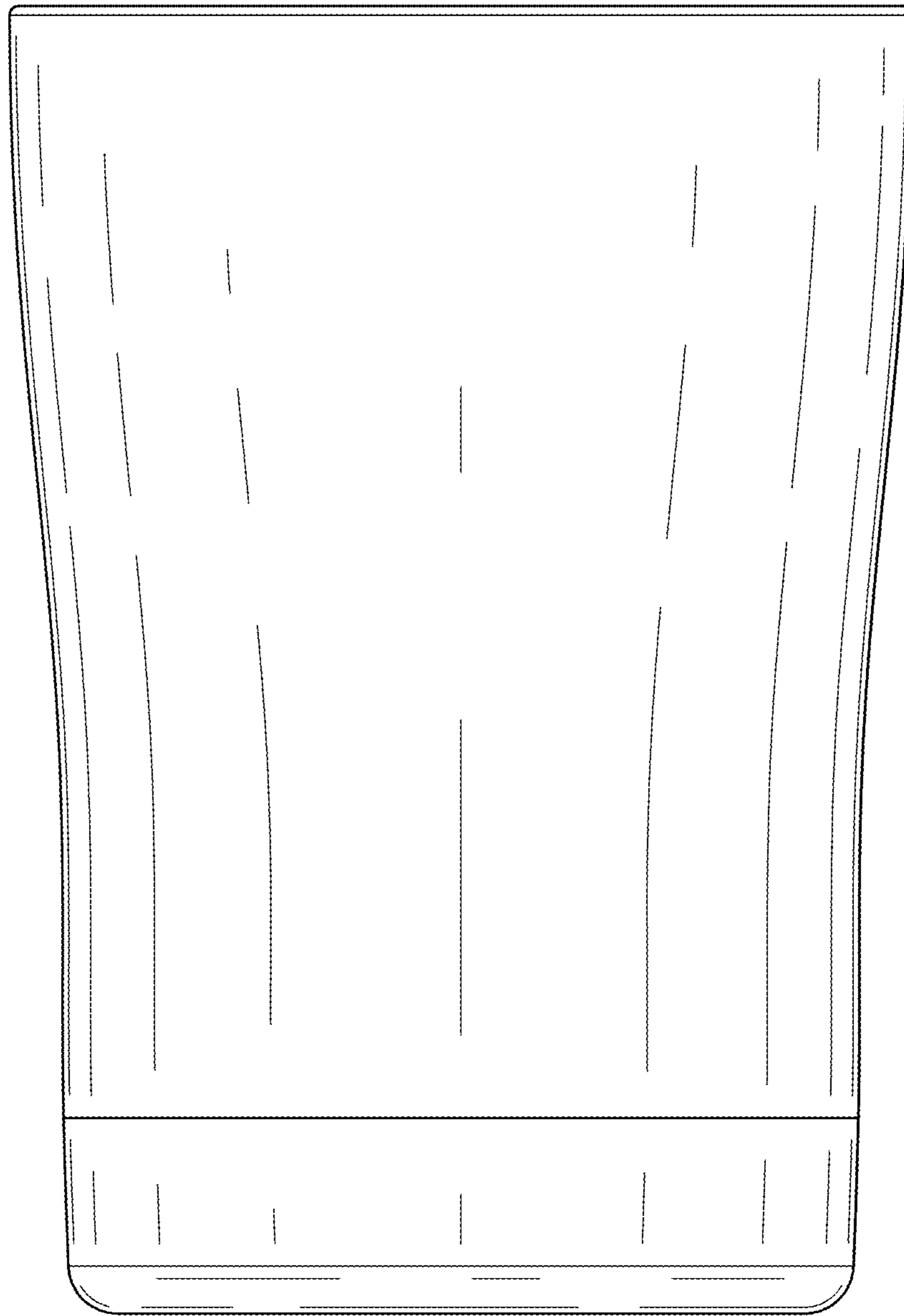

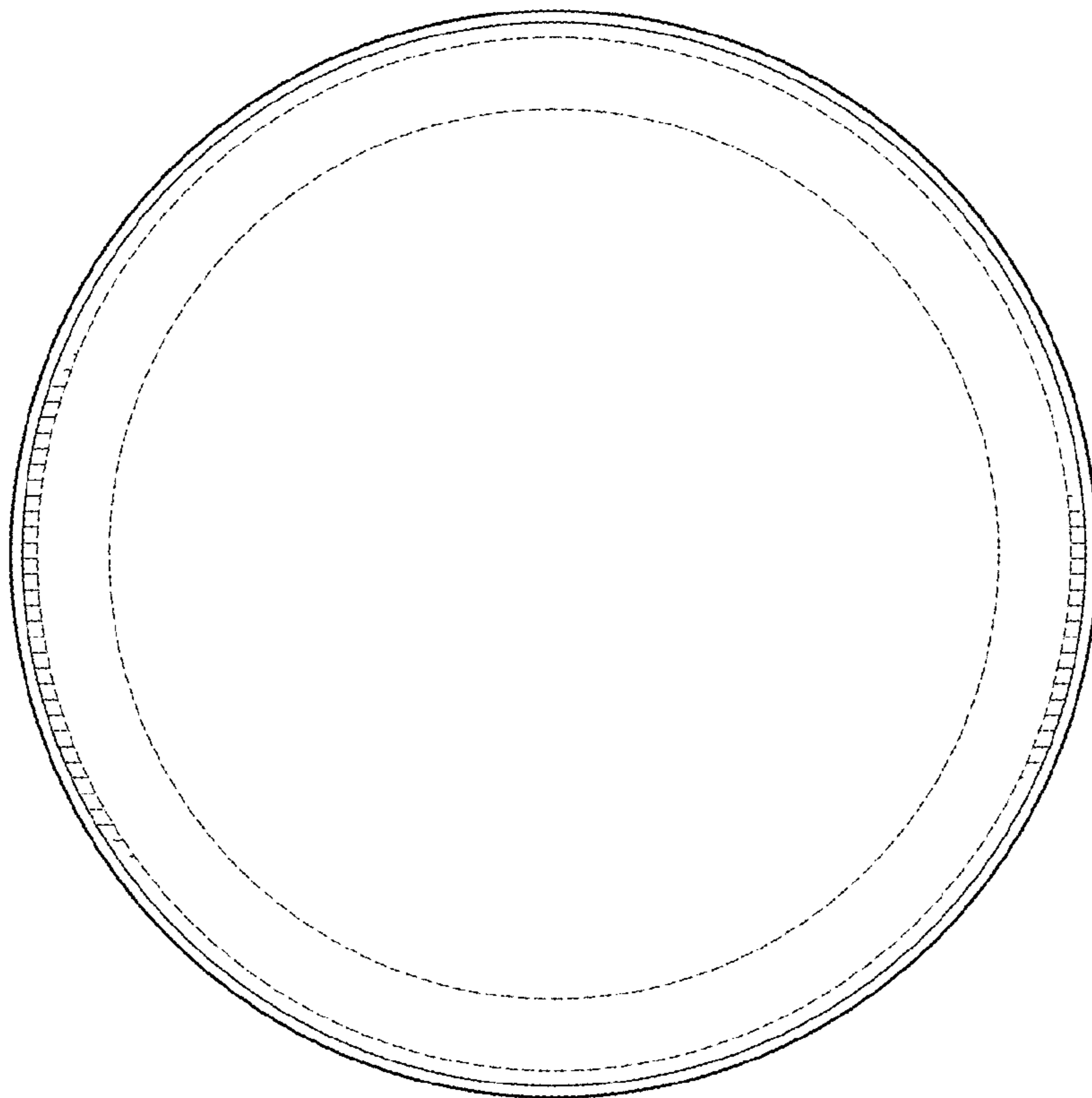

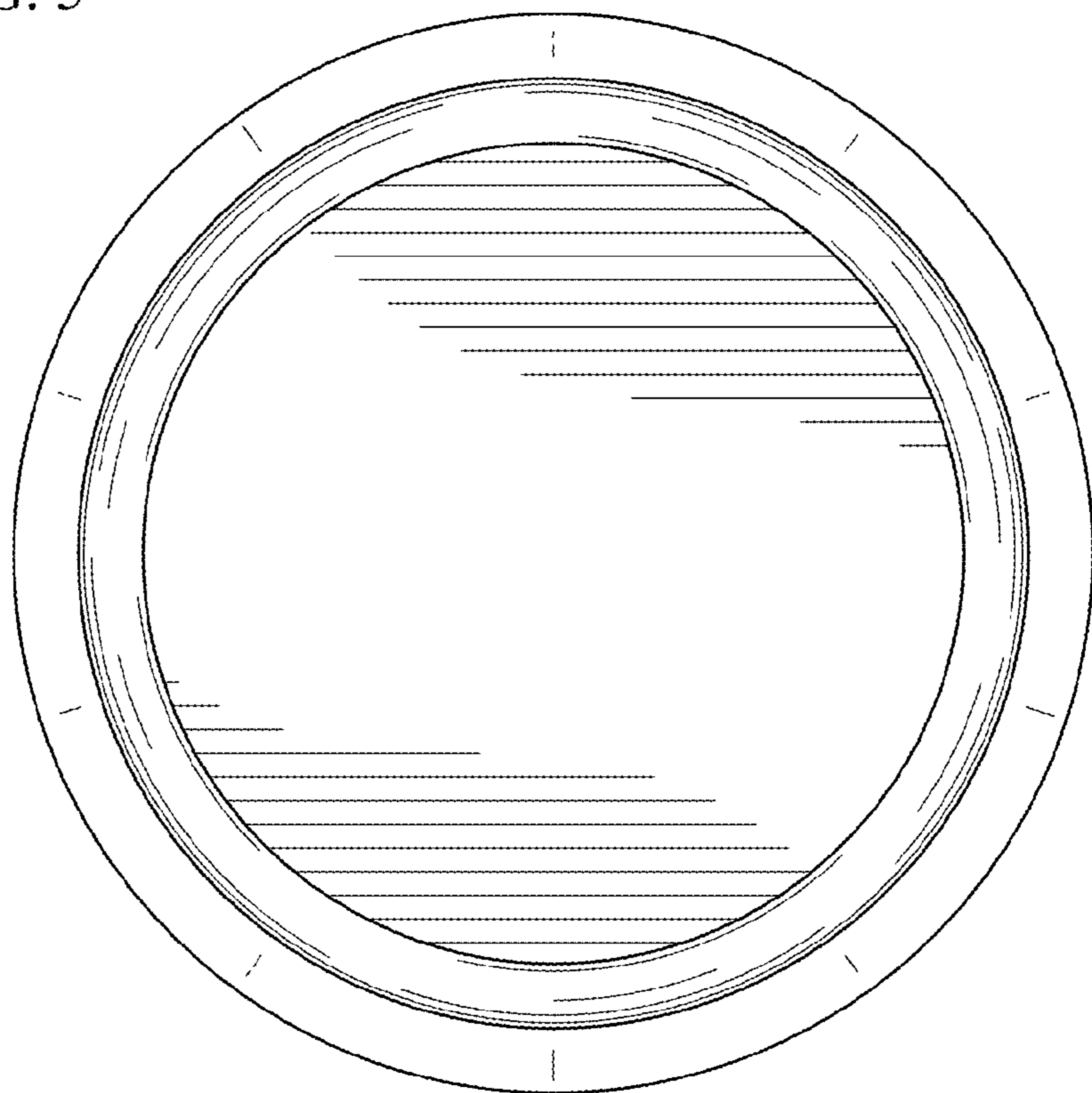
