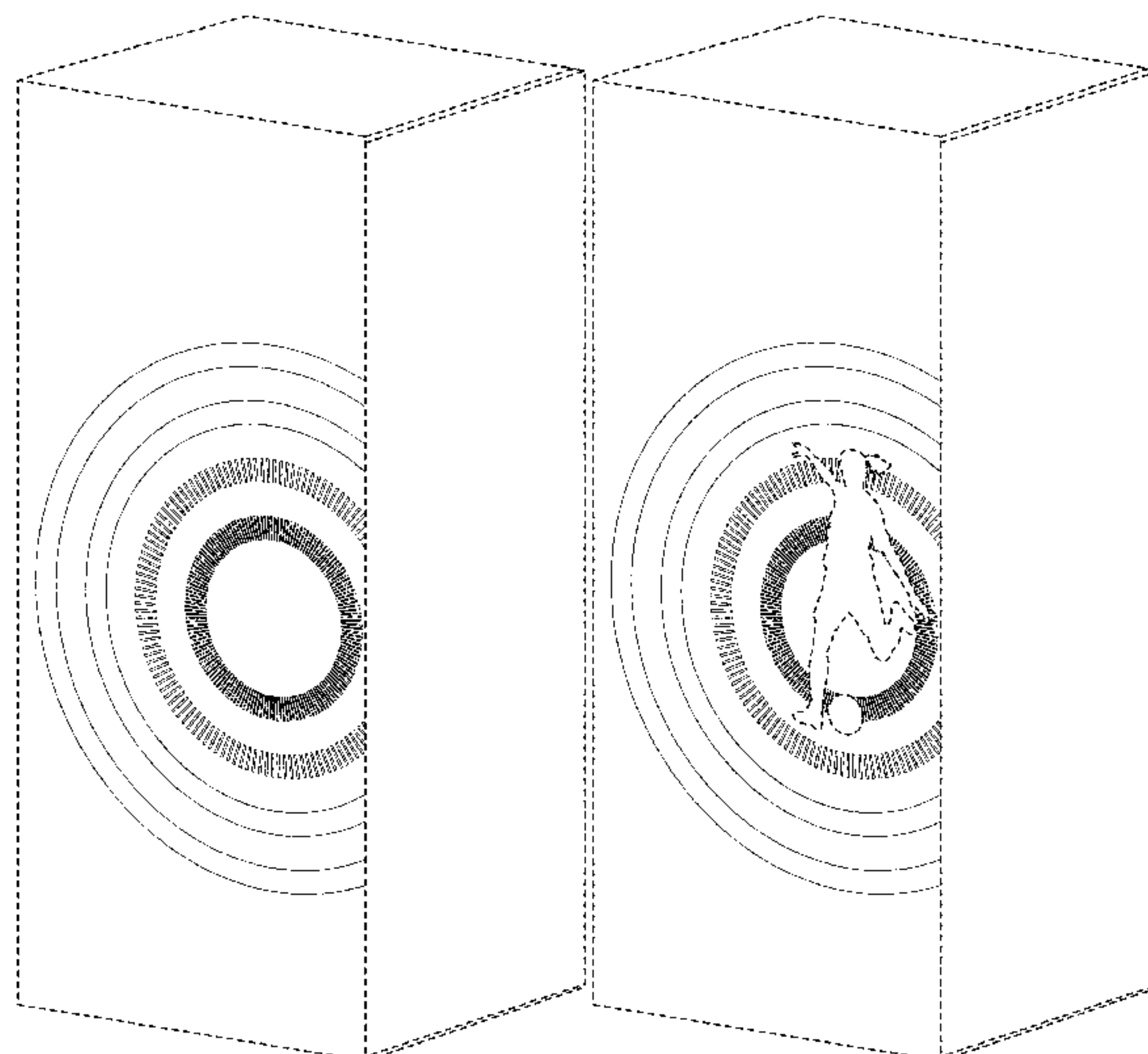
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a carton, showing our new design;
FIG. 2 is a front view of FIG. 1;
FIG. 3 is a perspective view of a second embodiment of a carton showing our new design; and,
FIG. 4 is a front view of FIG. 3.

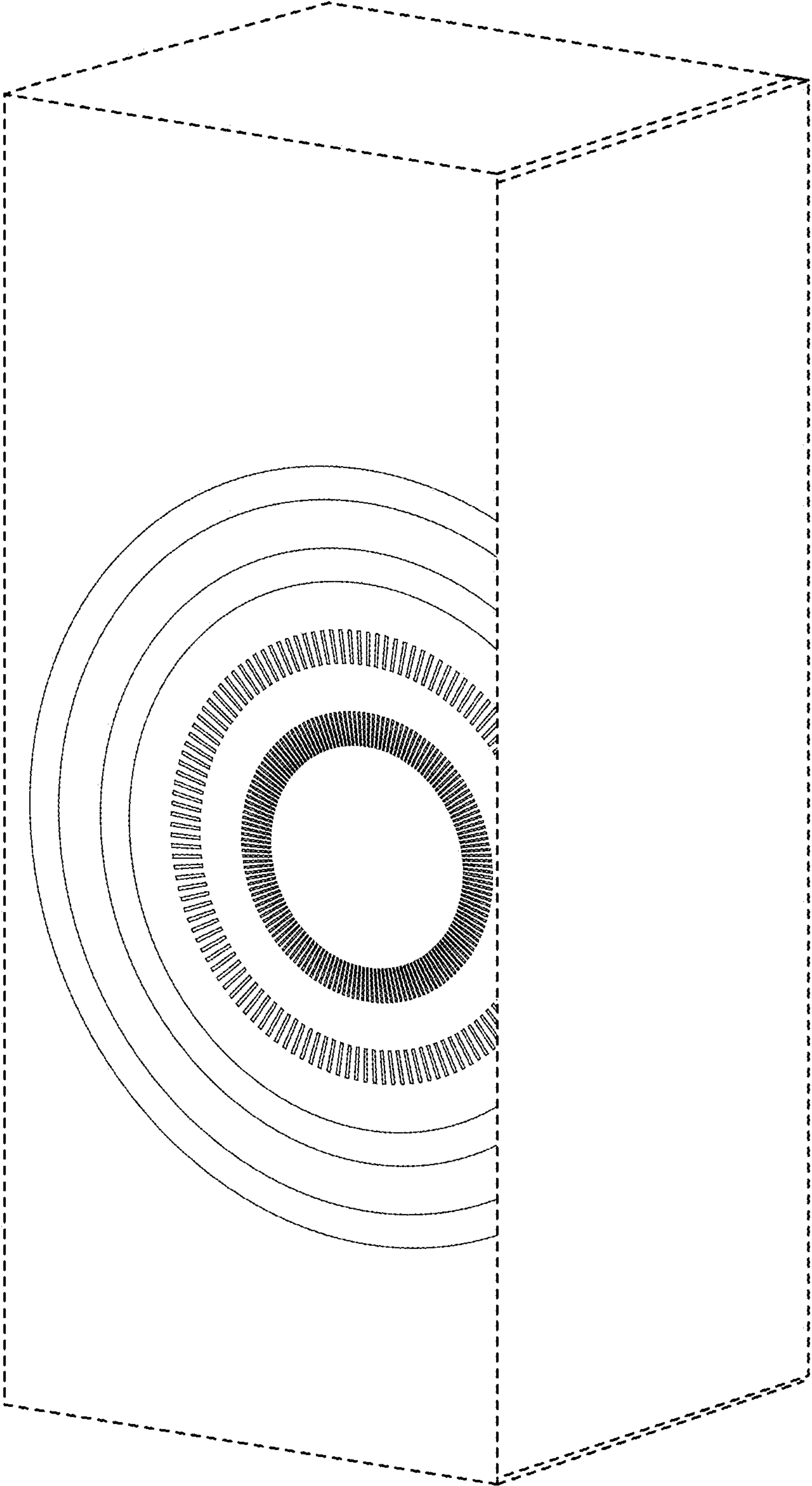

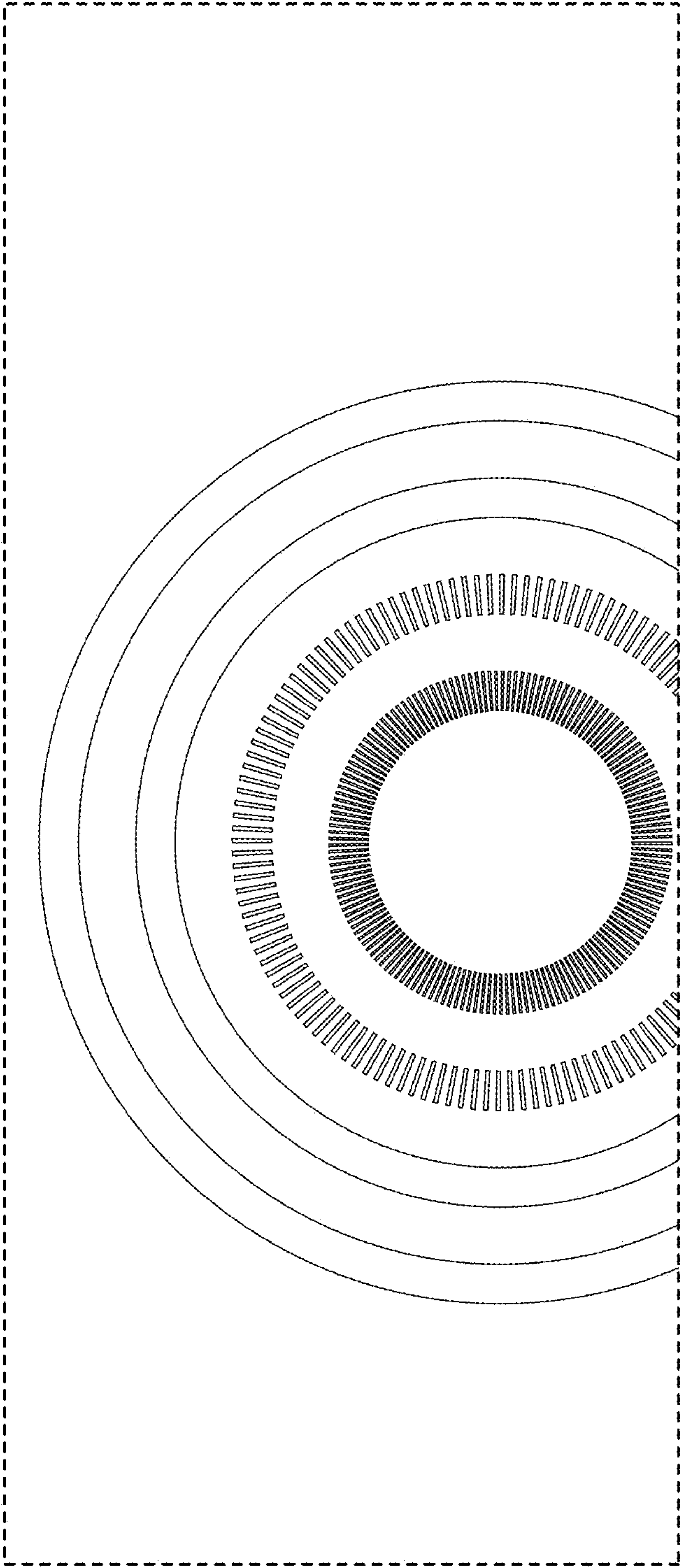

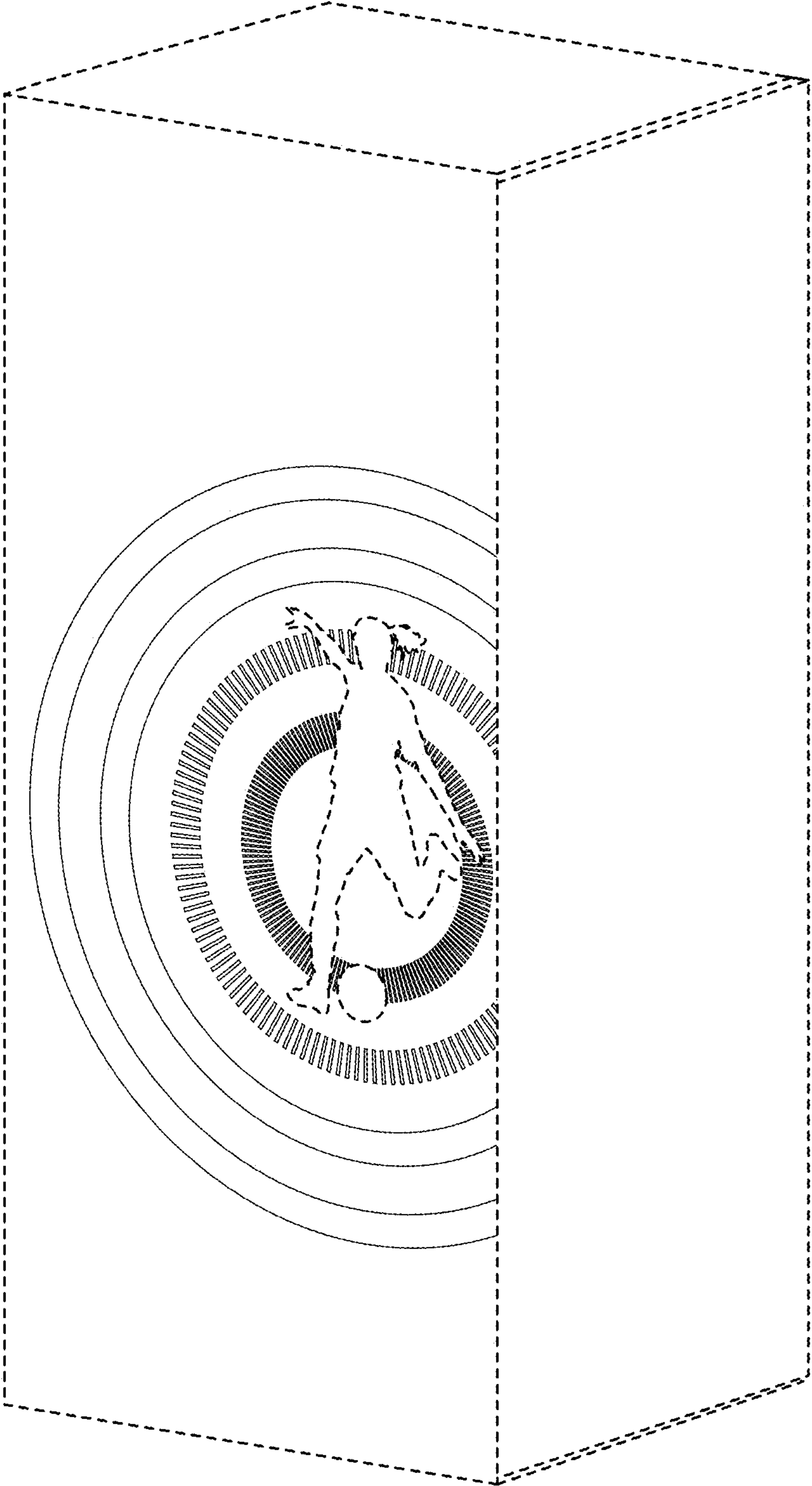

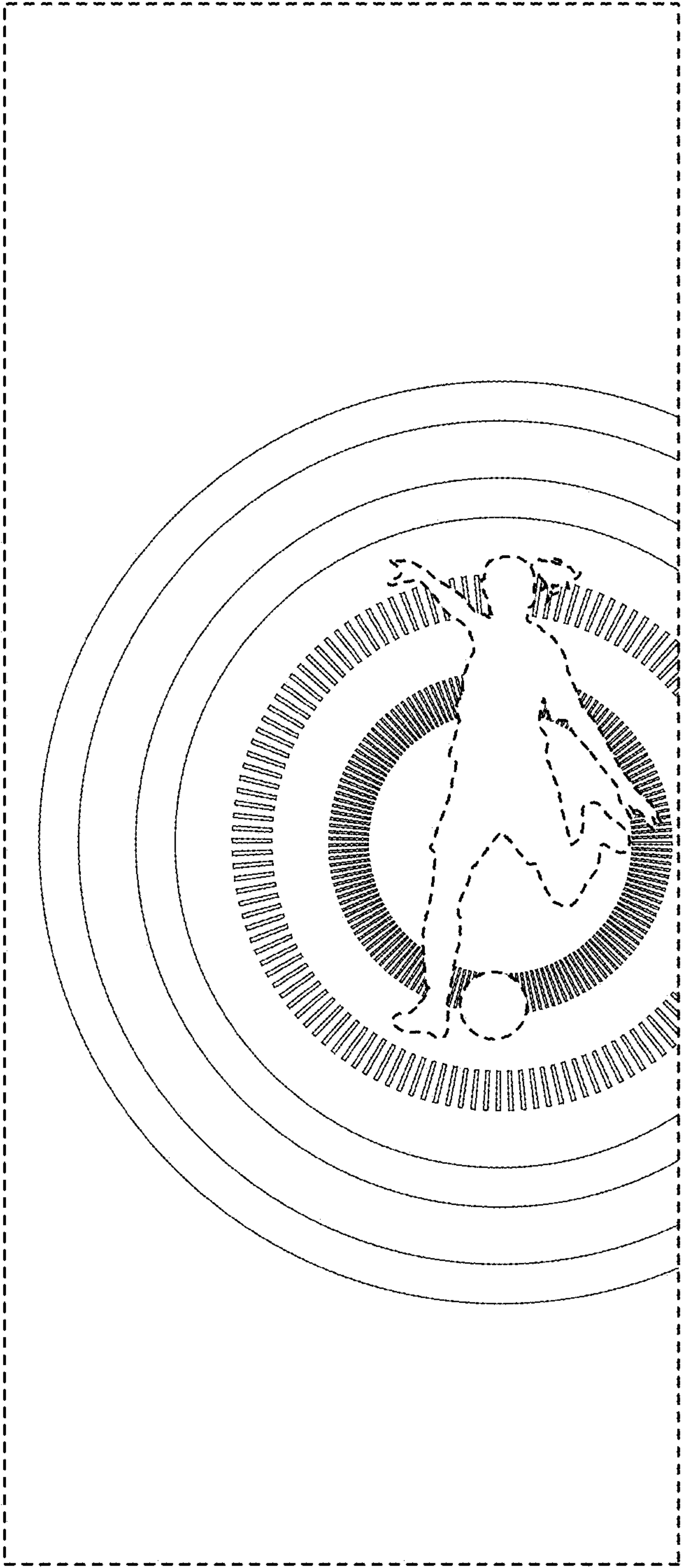
