The ornamental design for a football cross, as shown and described.

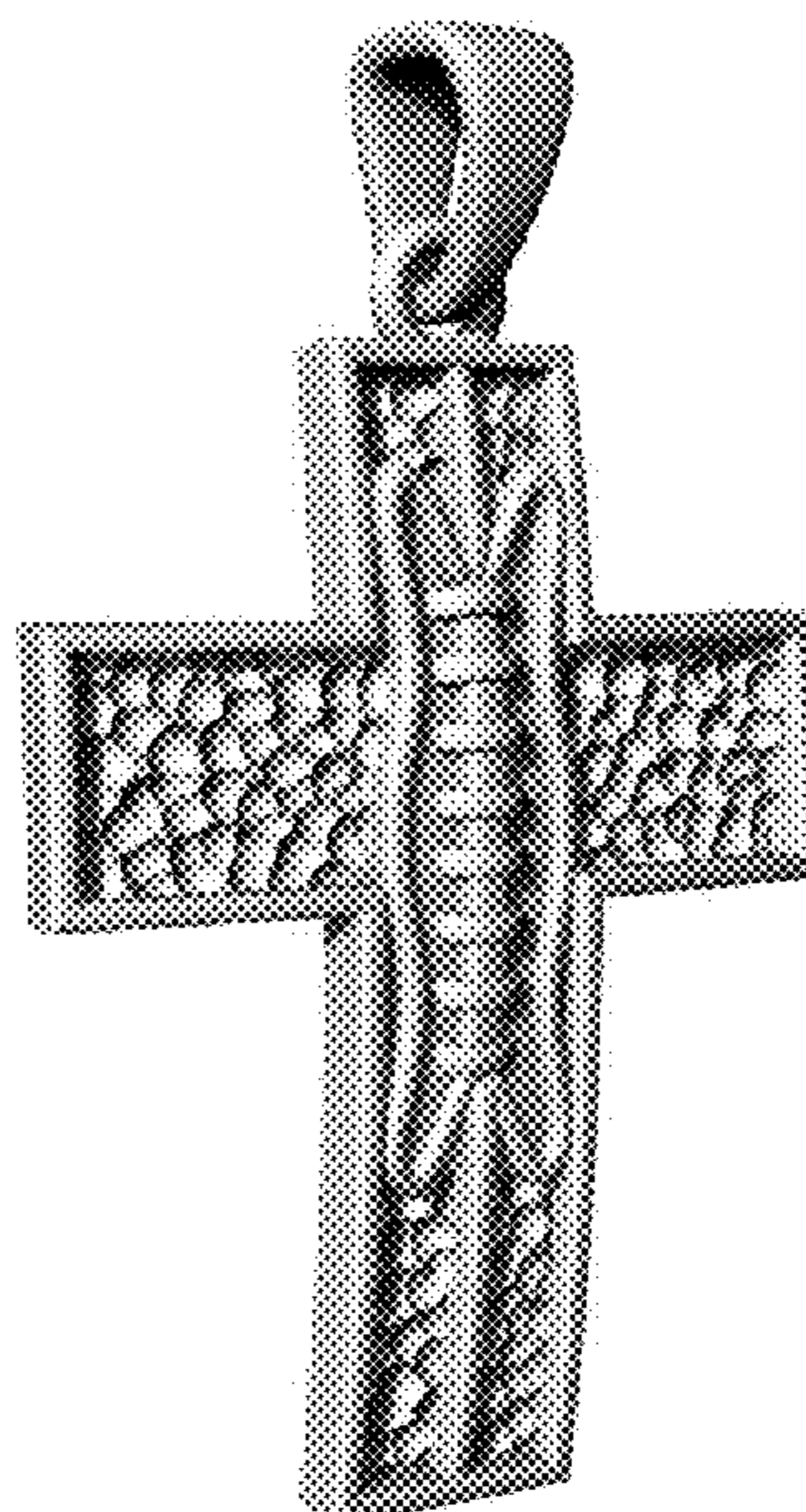
DESCRIPTION

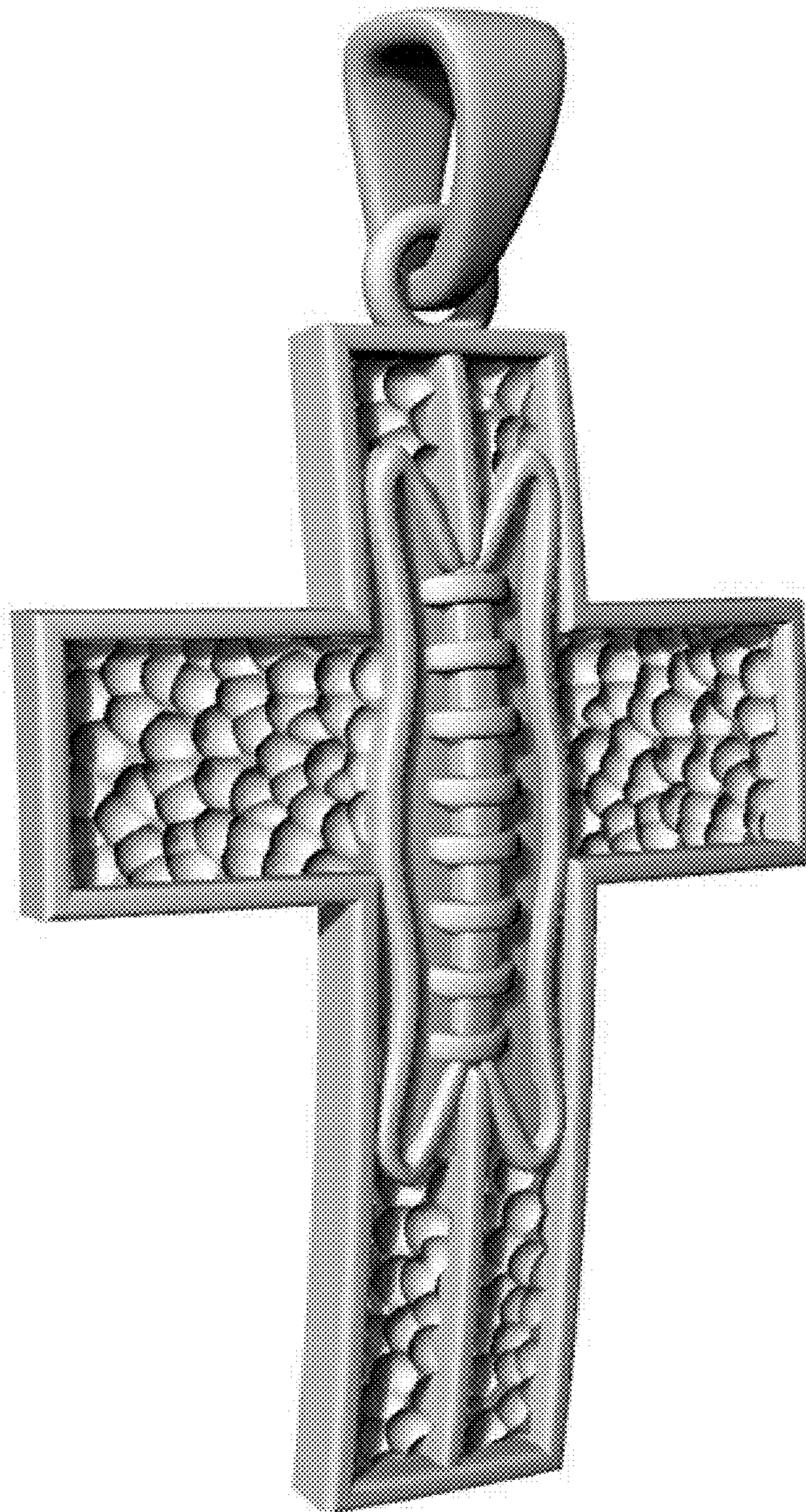

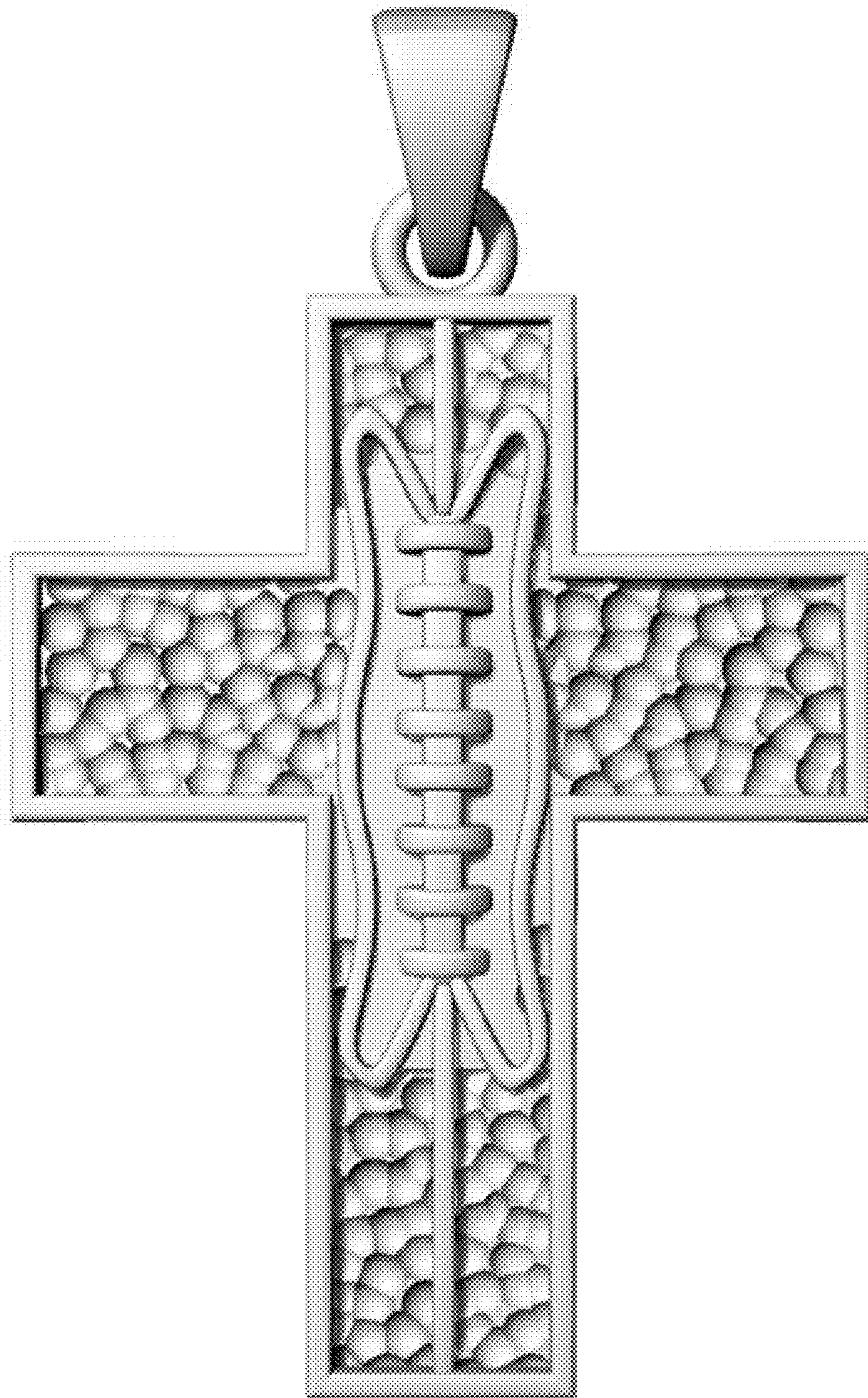

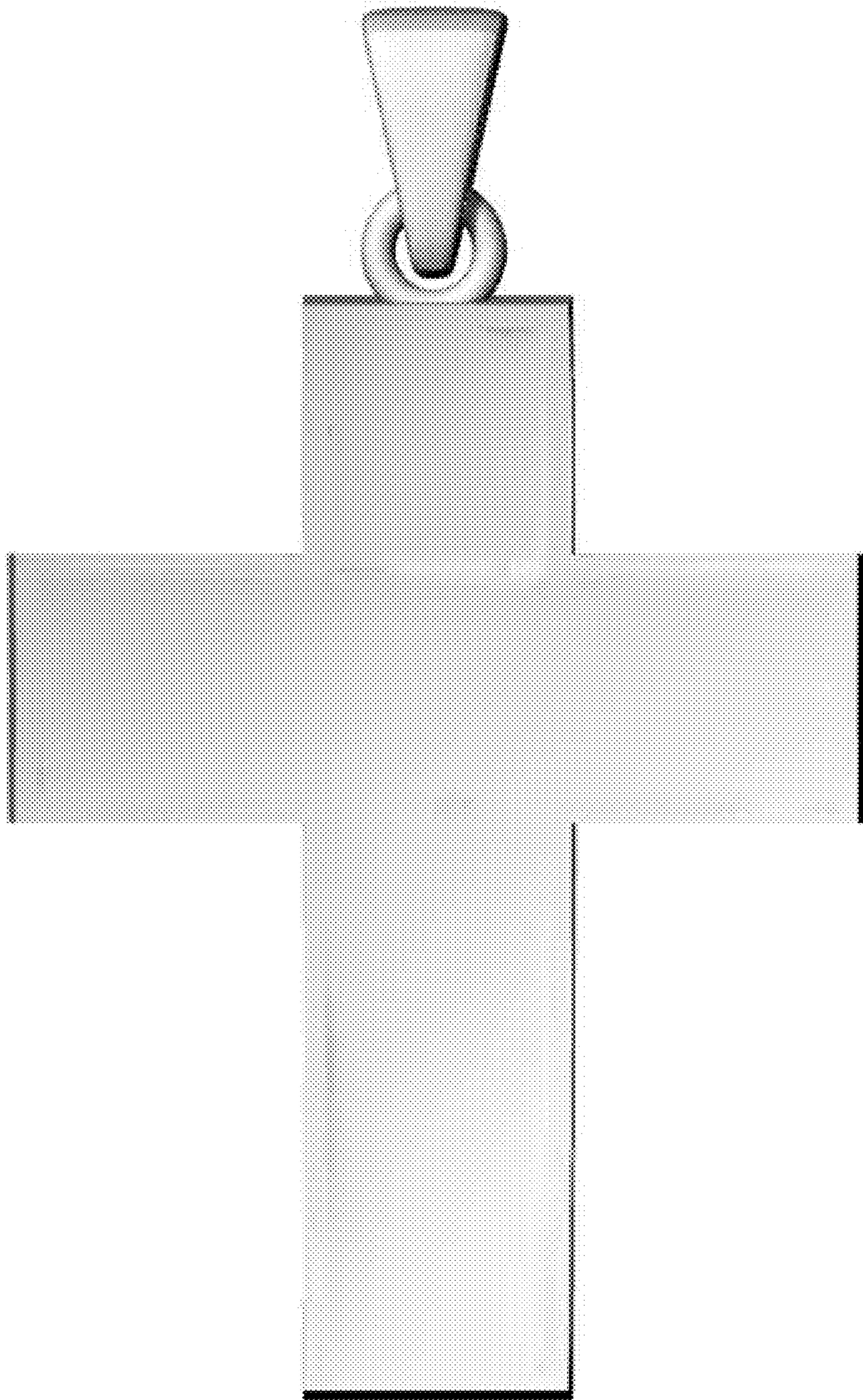

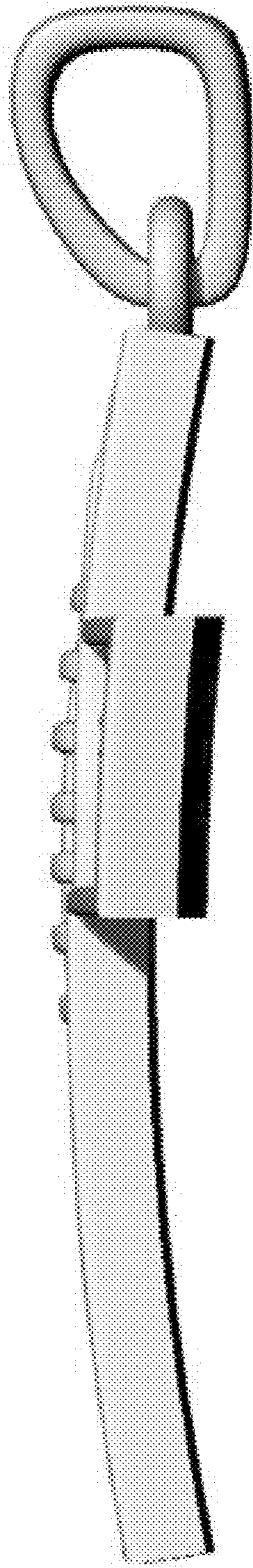

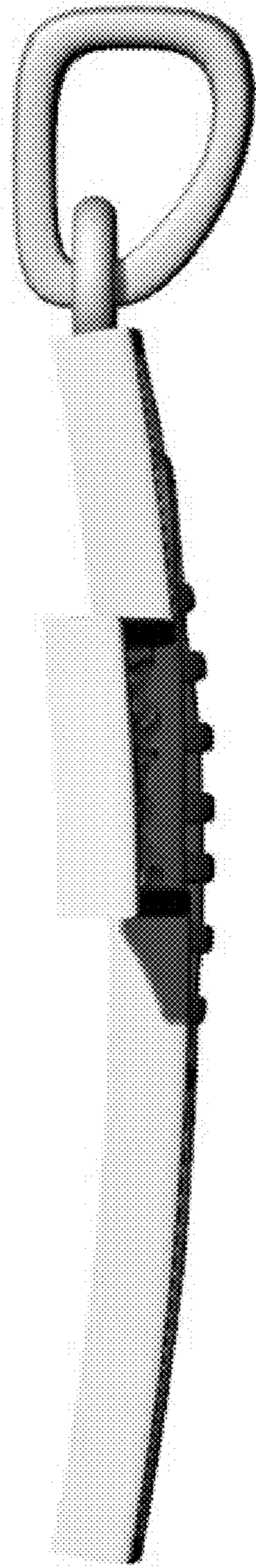

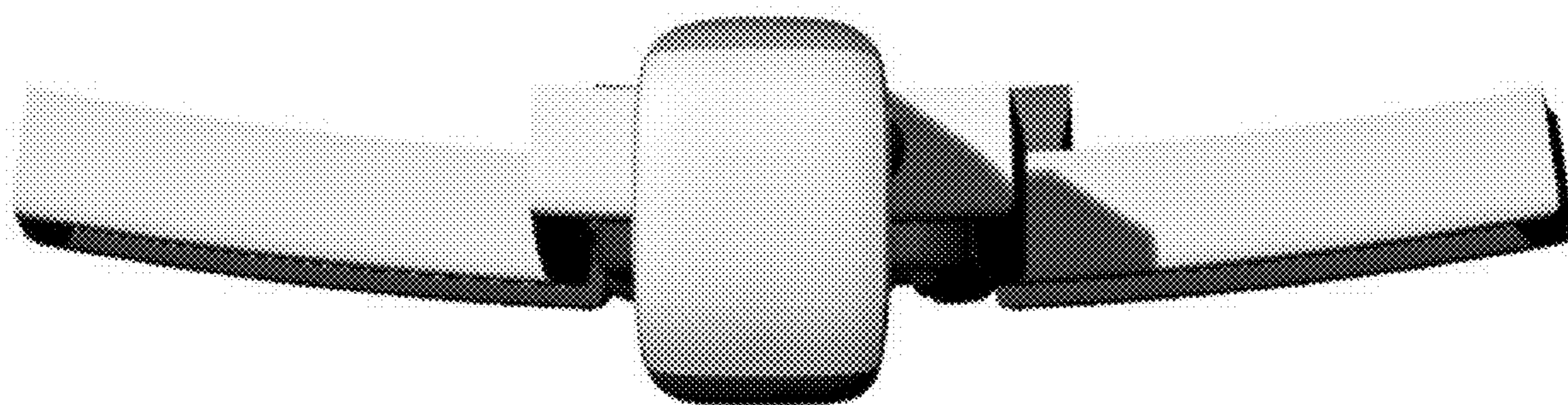

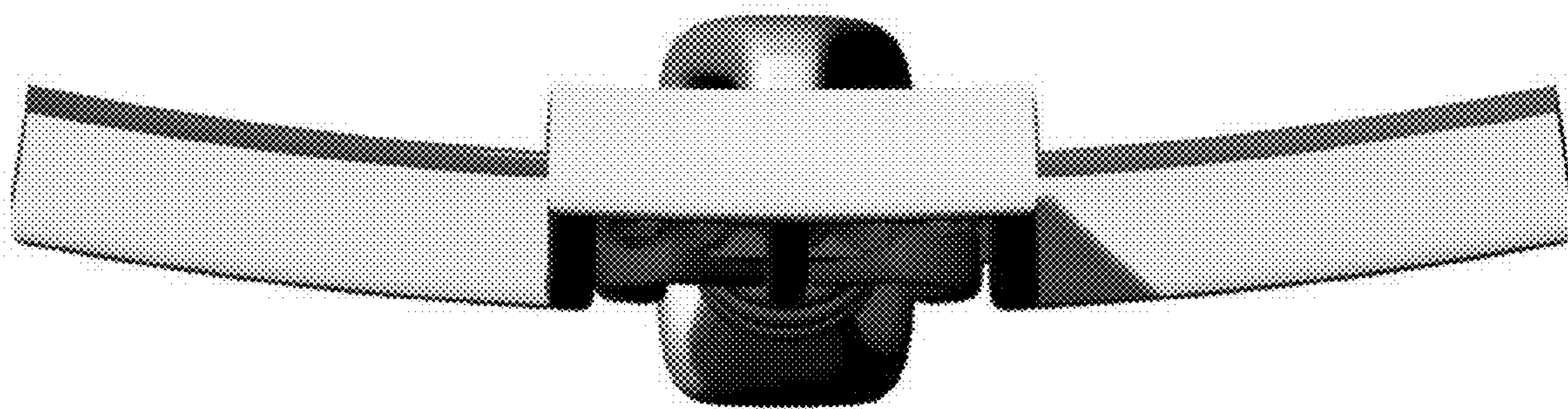
