The ornamental design for a vehicle, toy replica and/or other replica, as shown and described.

DESCRIPTION

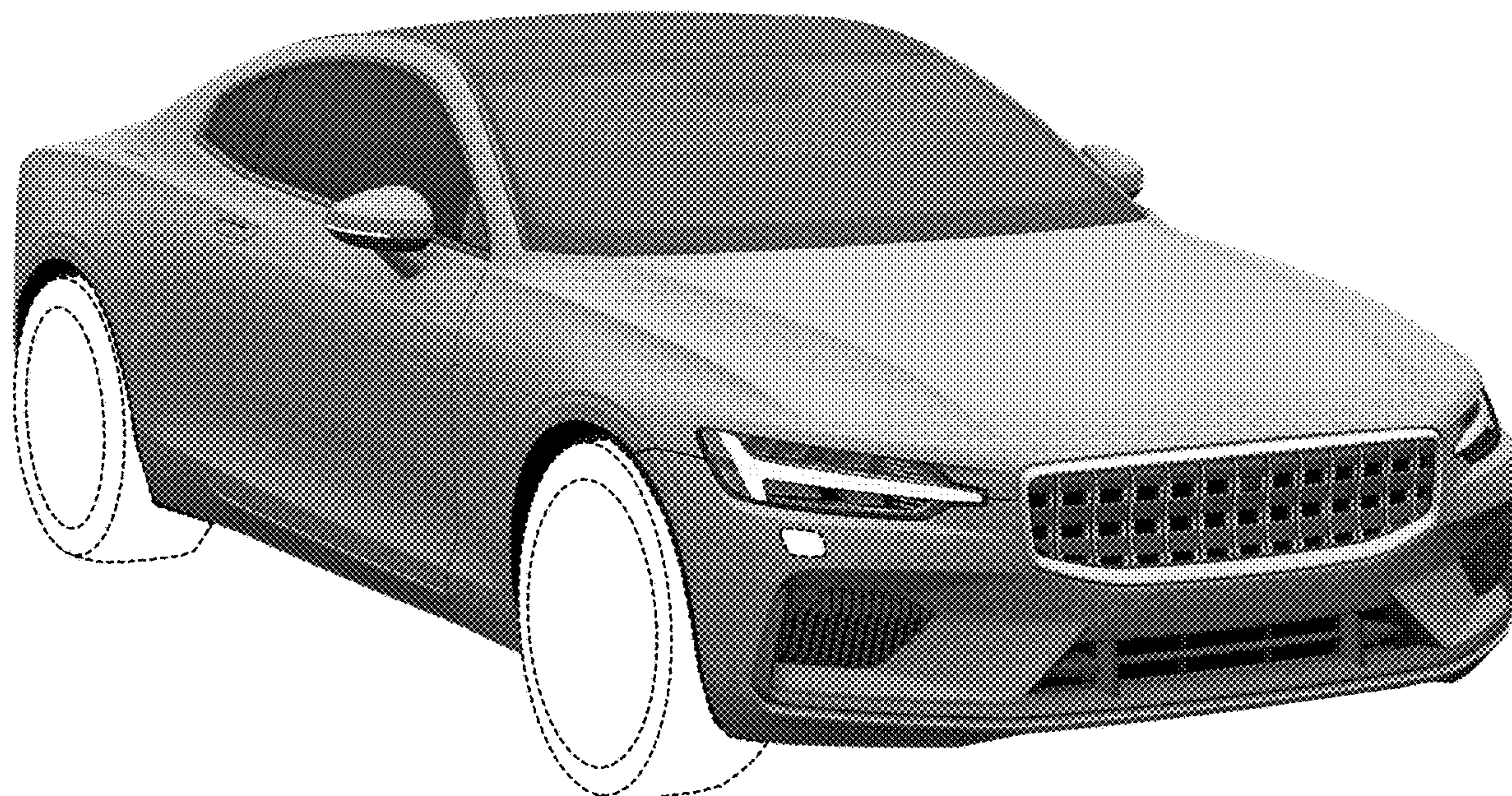

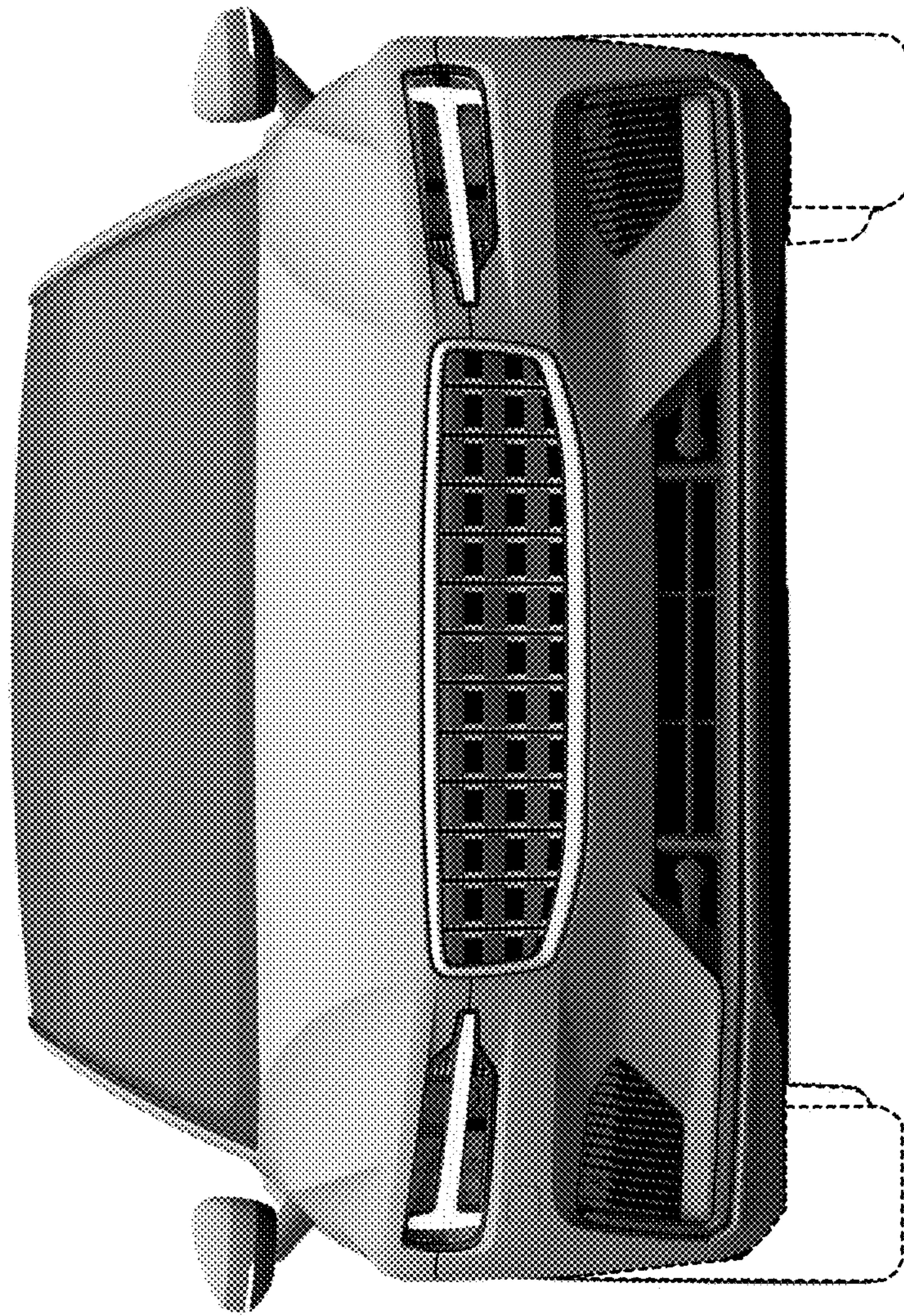

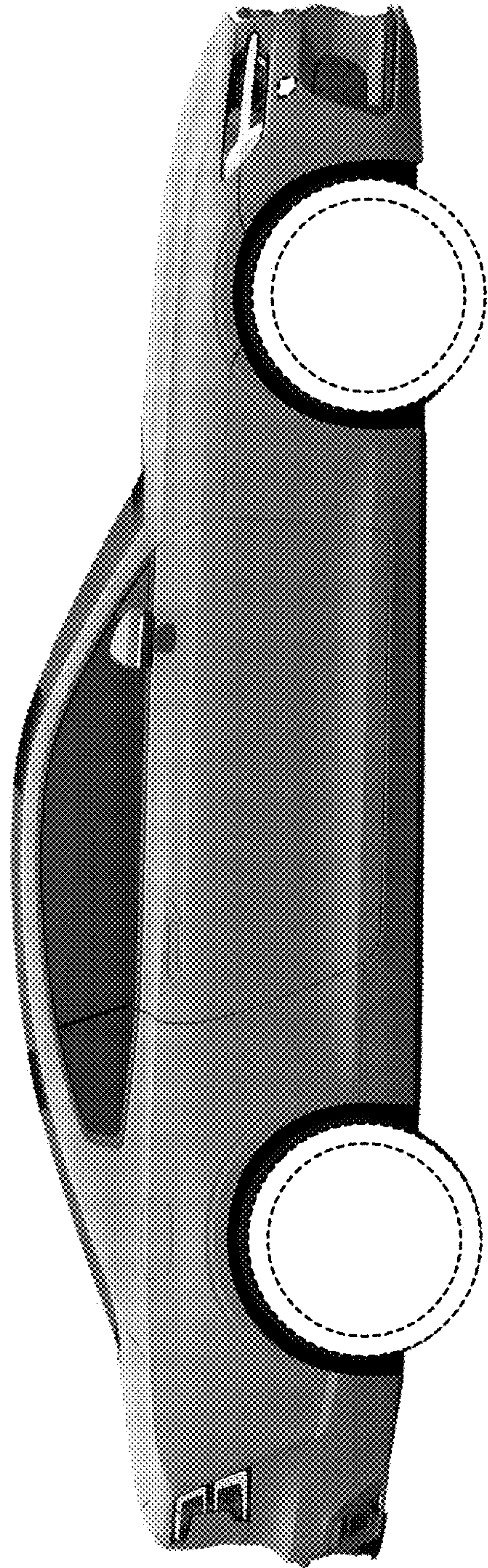

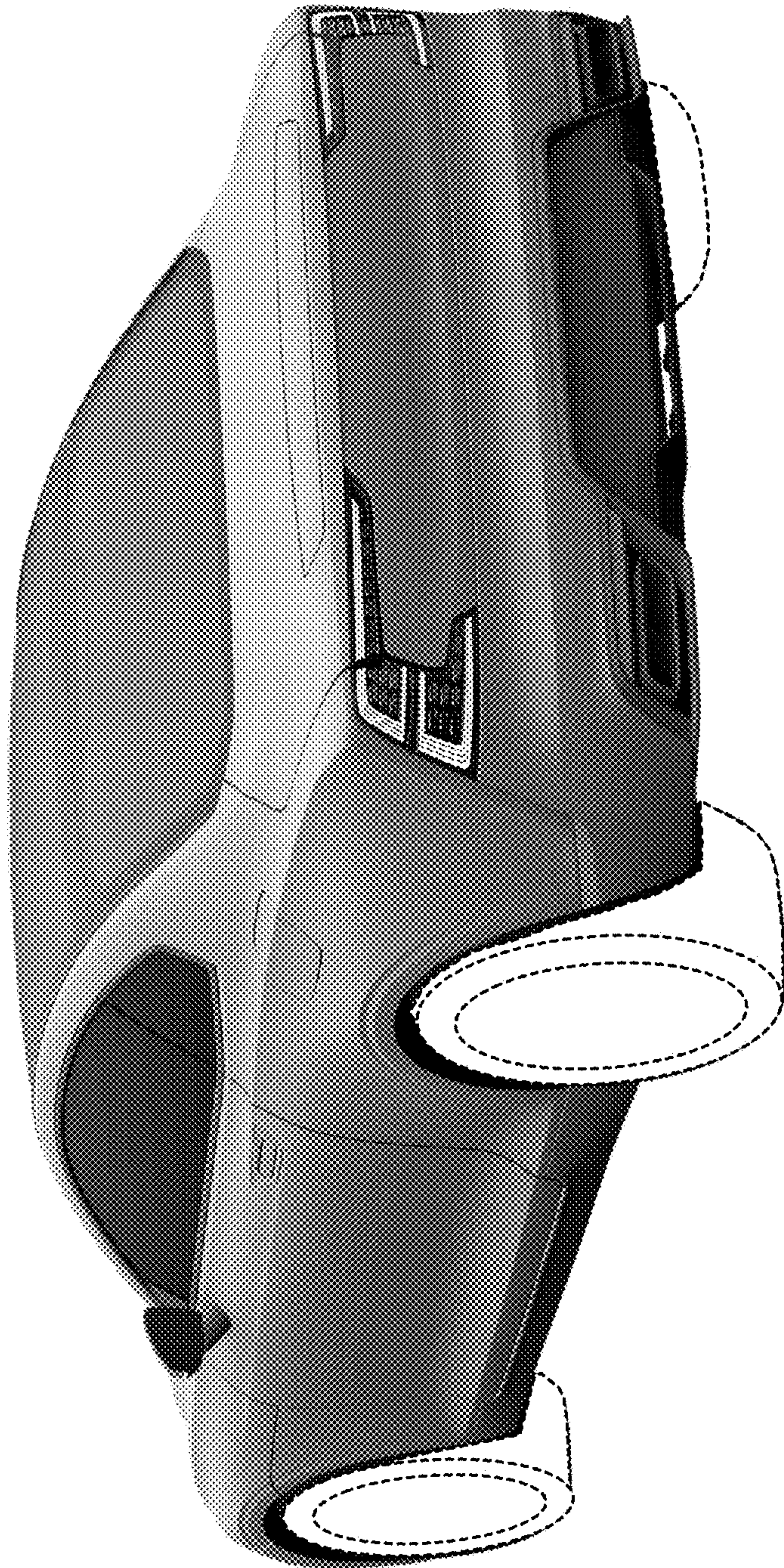

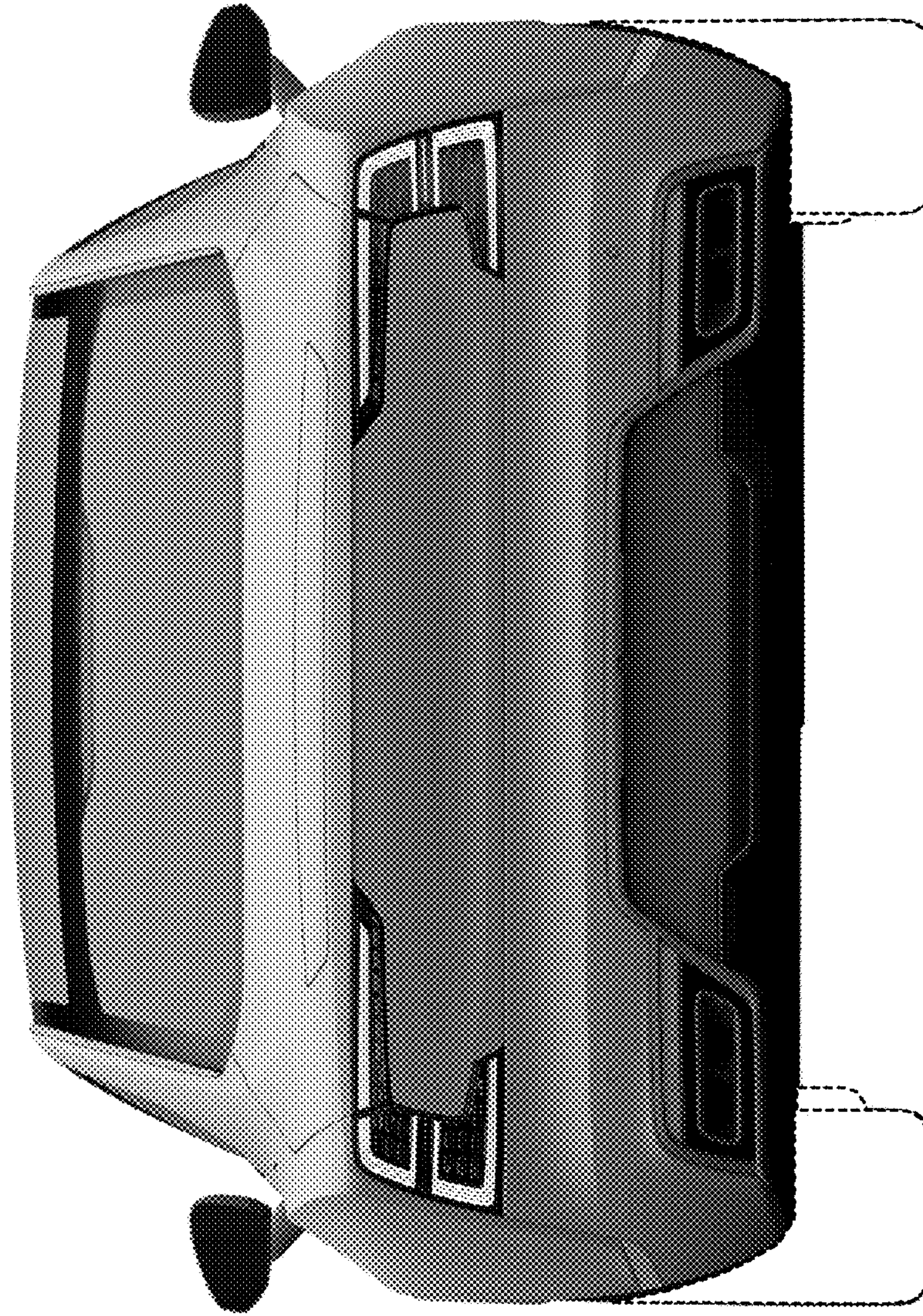

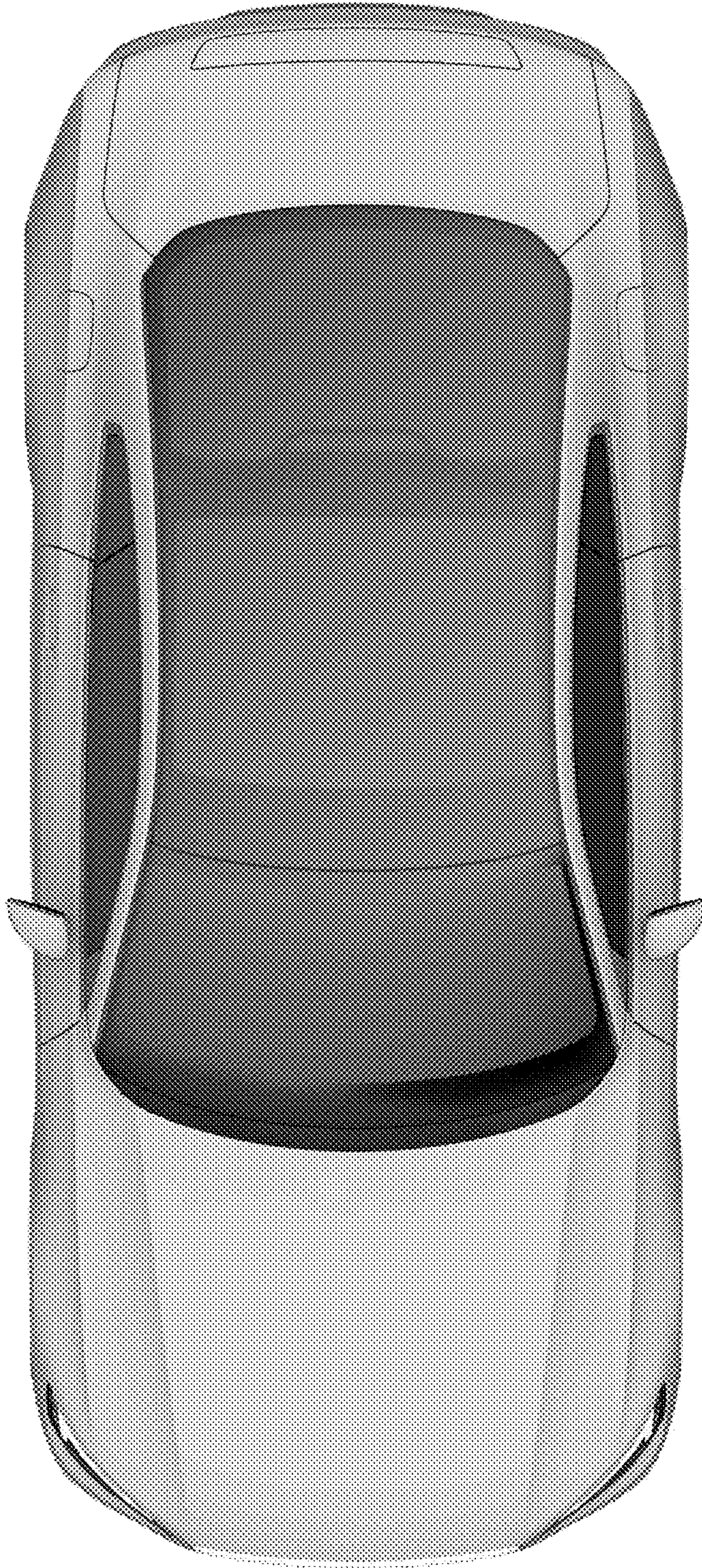

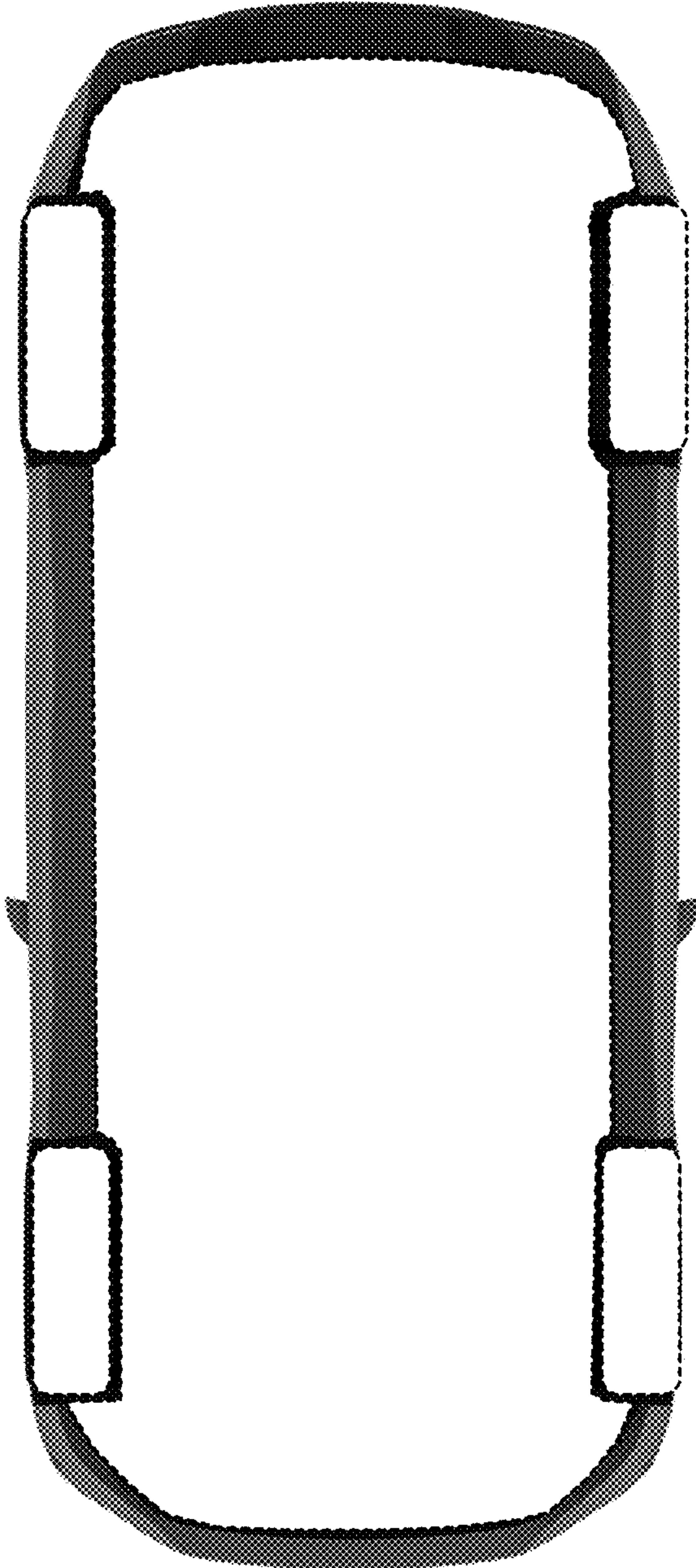
