FIG. 4 is a Front view of the tablet case as shown in FIG. 1;

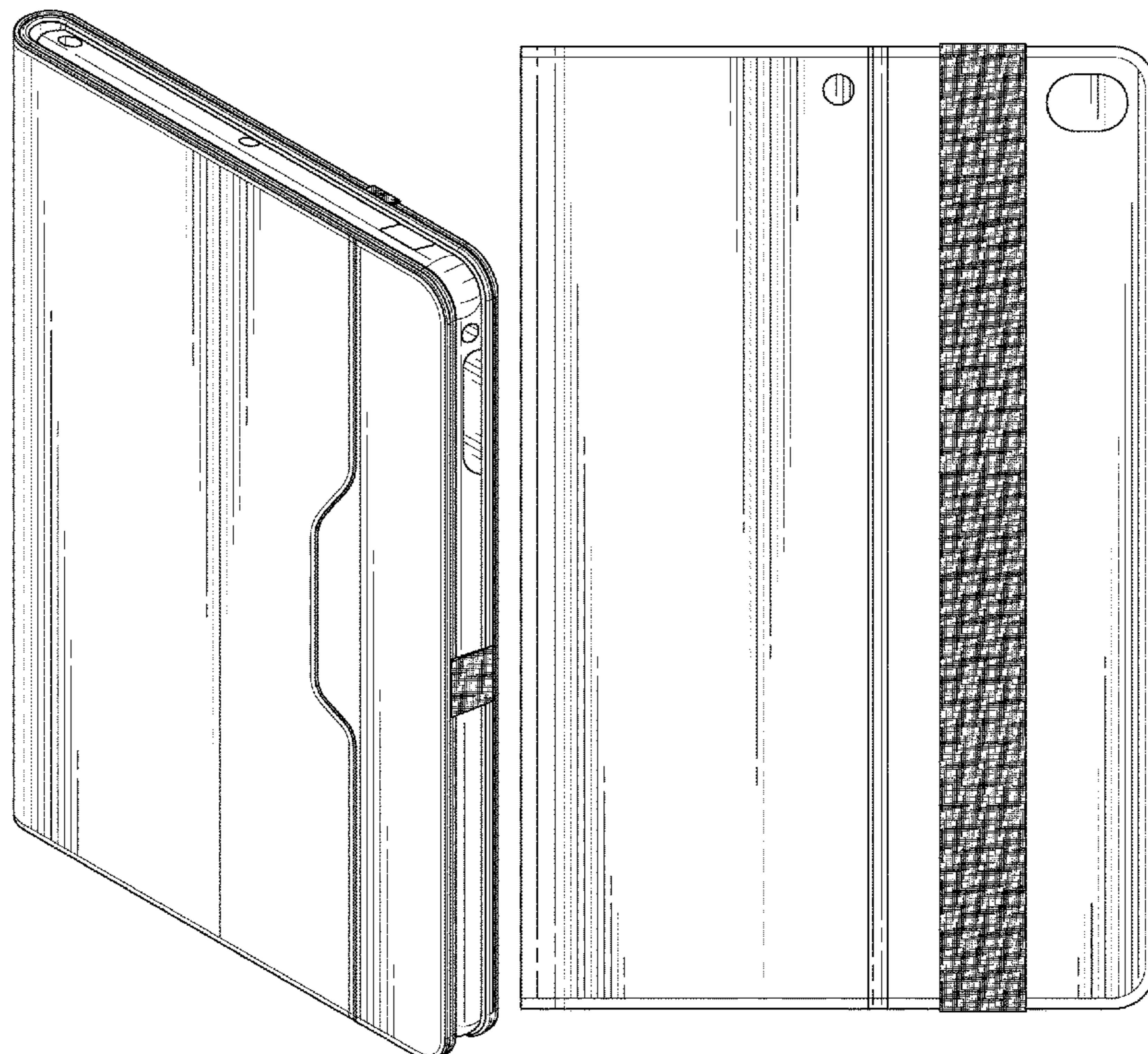
FIG. 5 is a Back view of the tablet case as shown in FIG. 1;

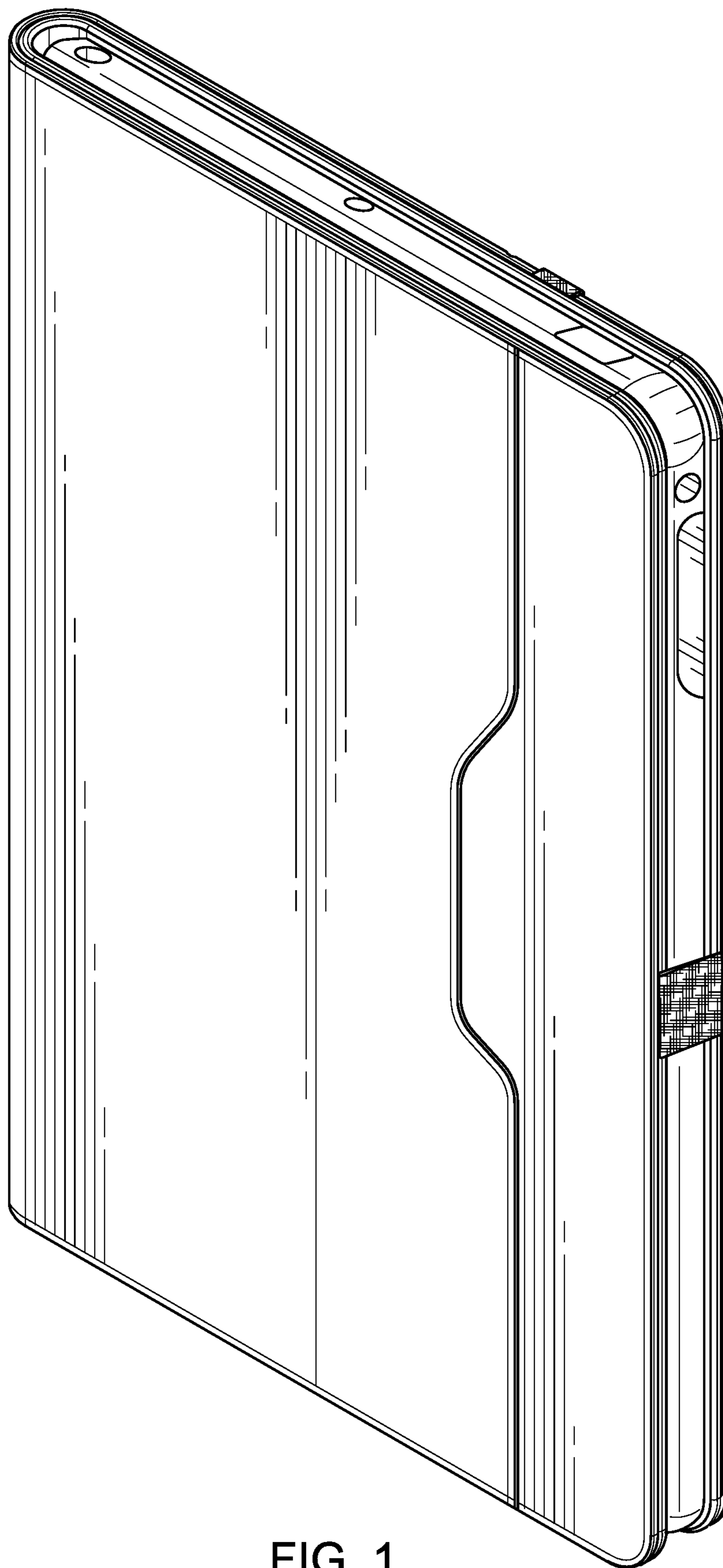

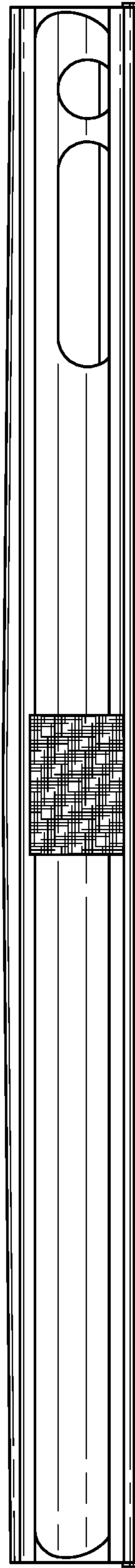

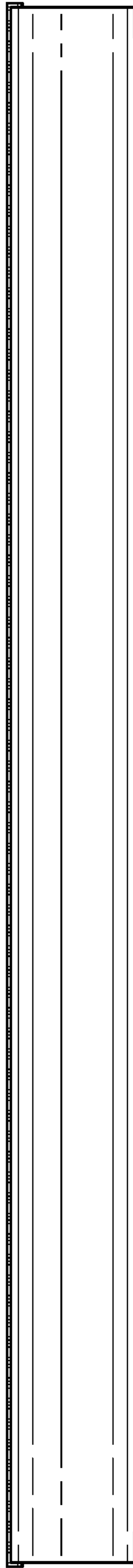

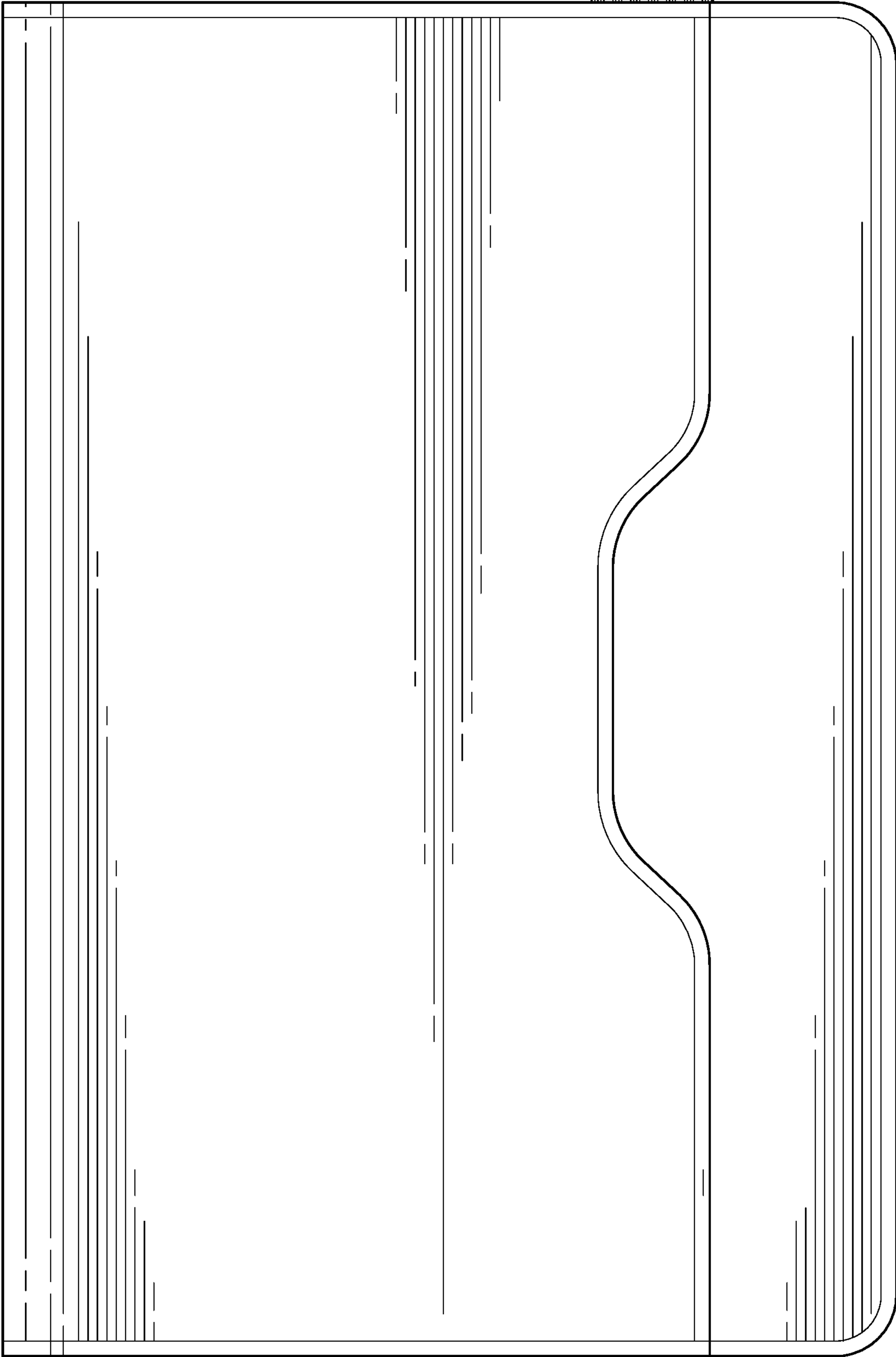

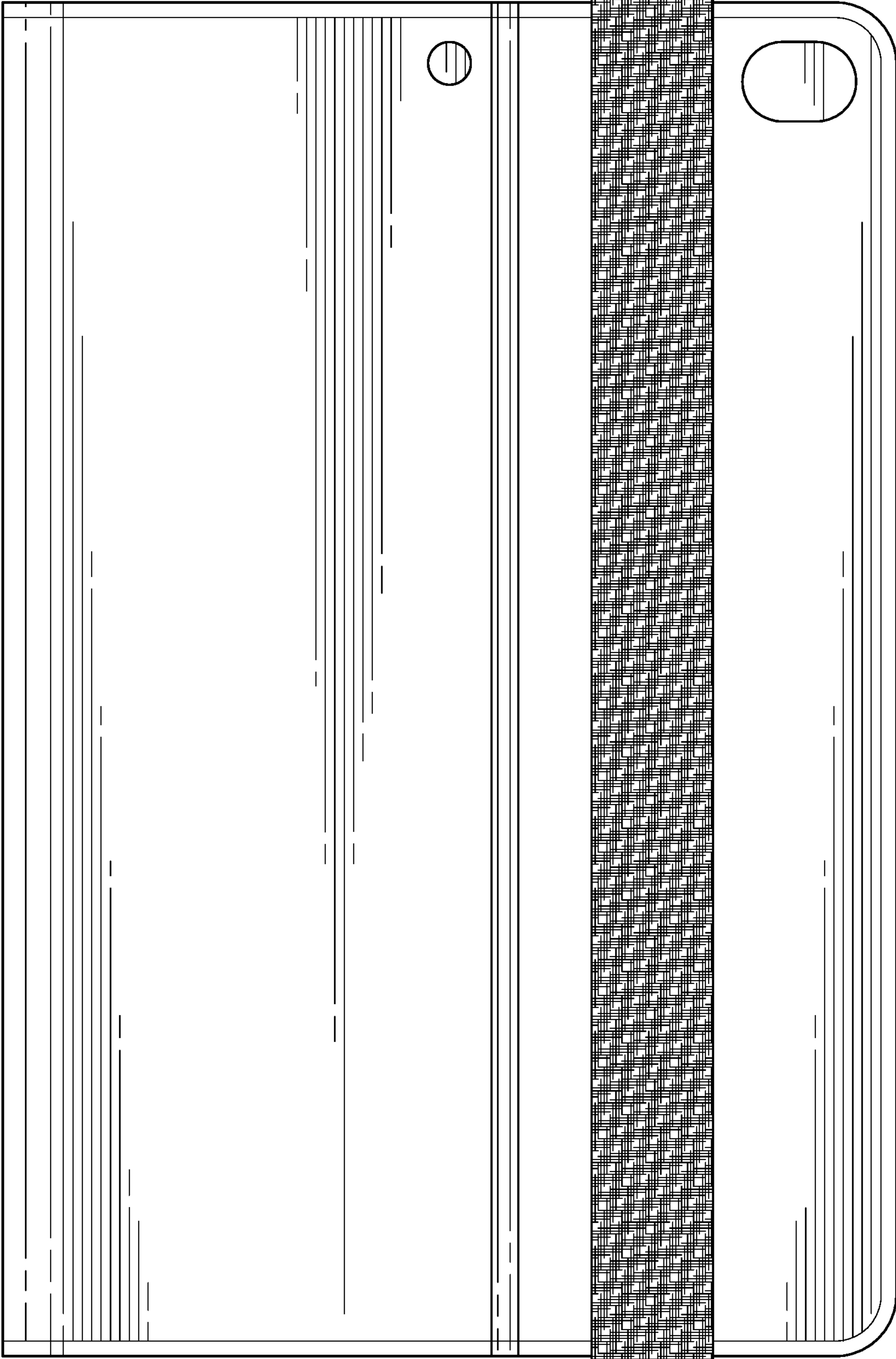

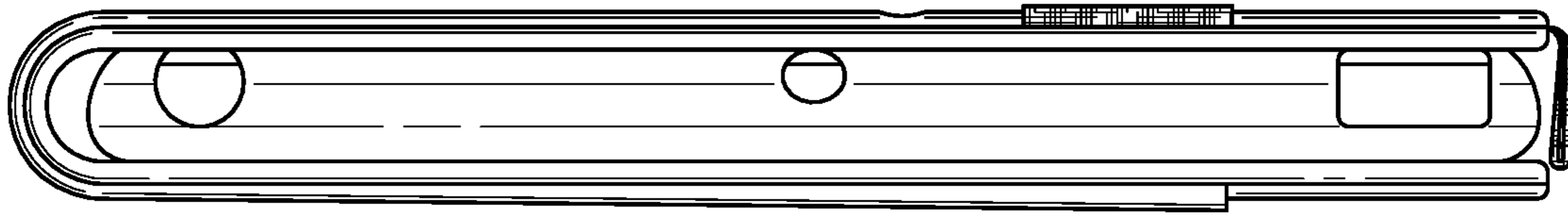

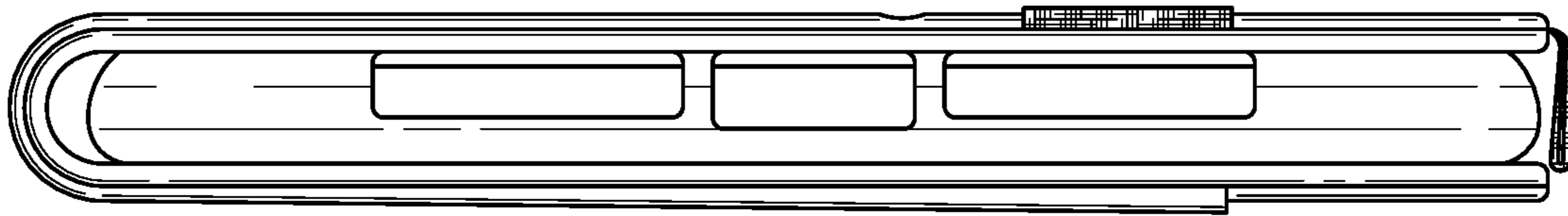

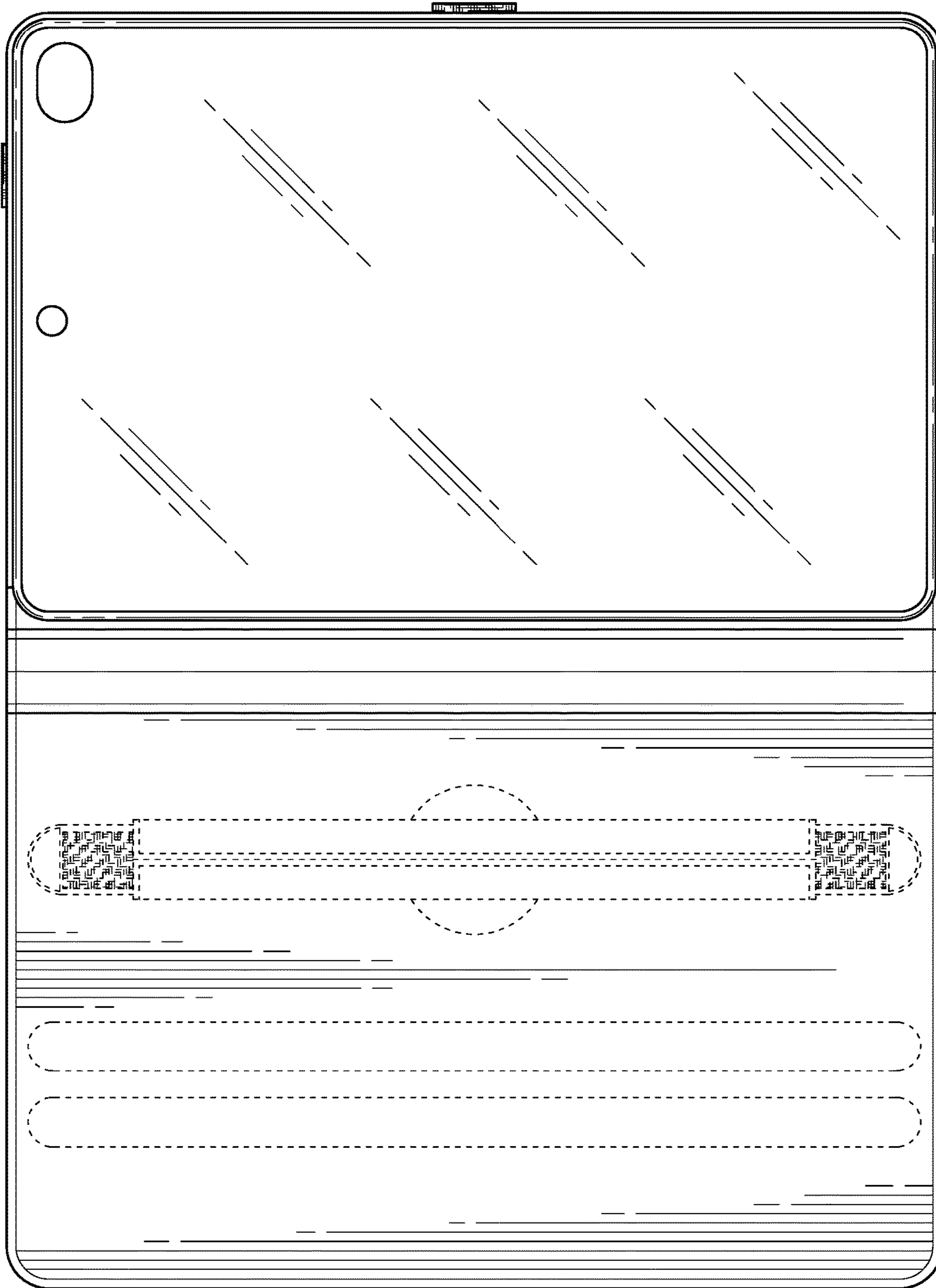
