**DESCRIPTION**

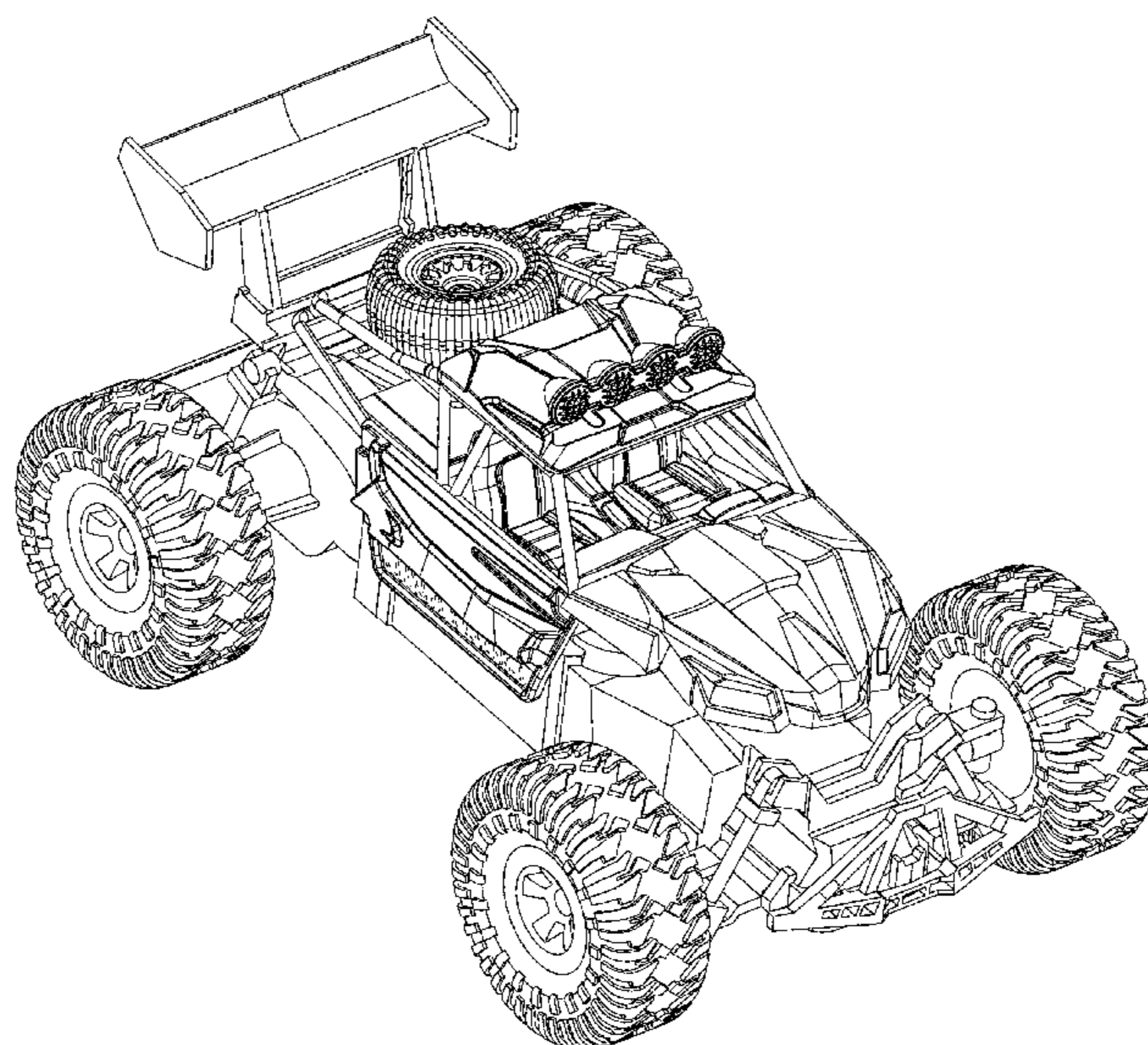
FIG. 1 is a front view of a remote control car of the present invention.

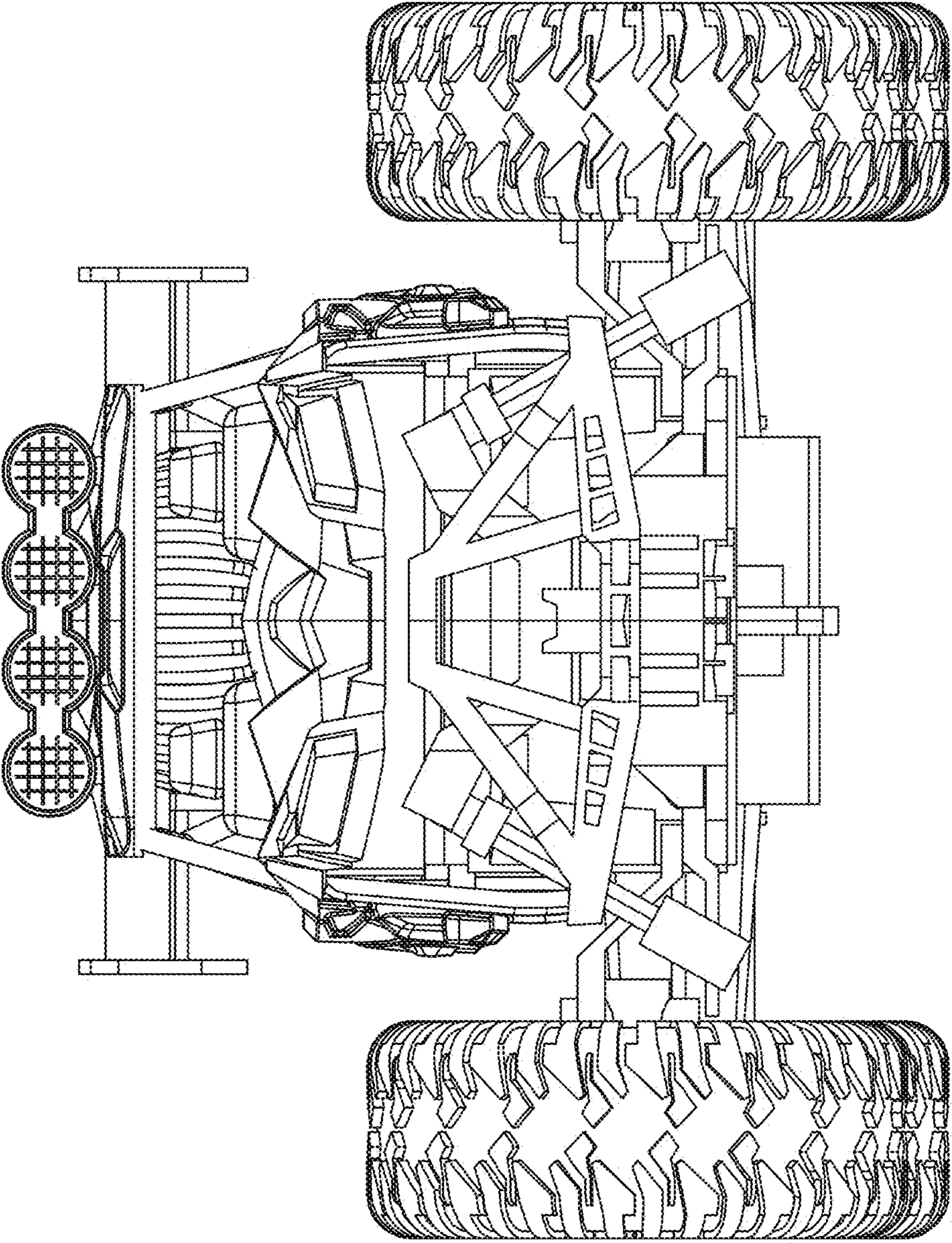

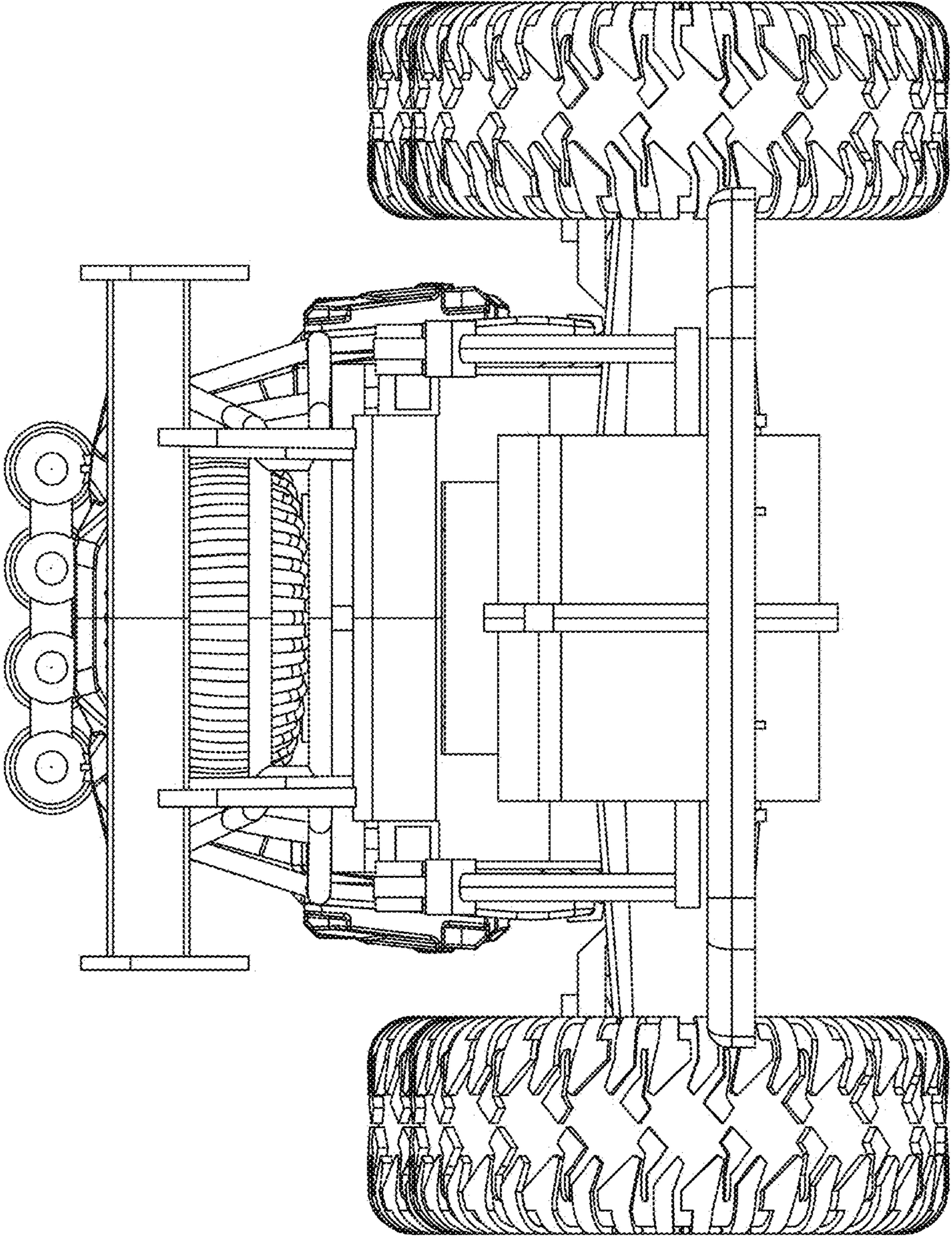

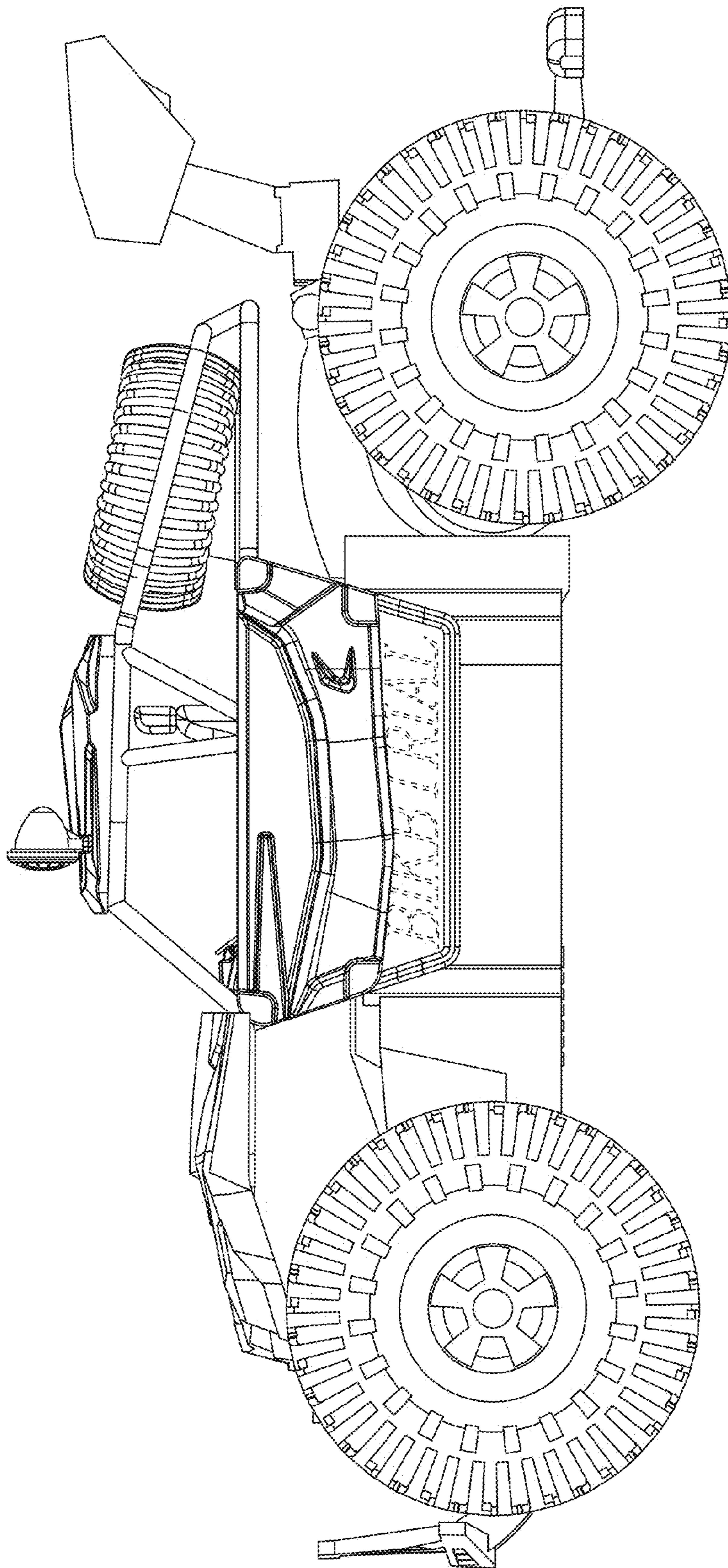

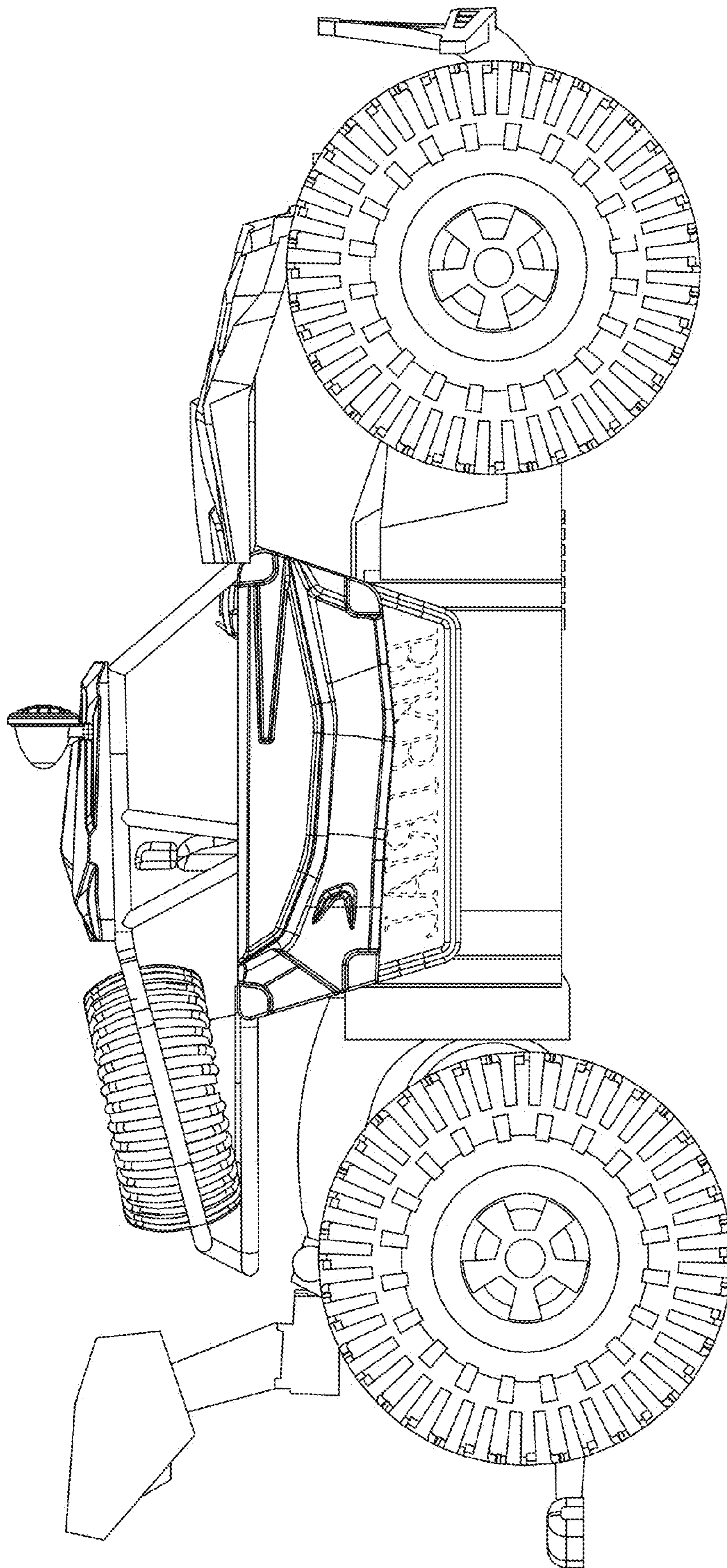

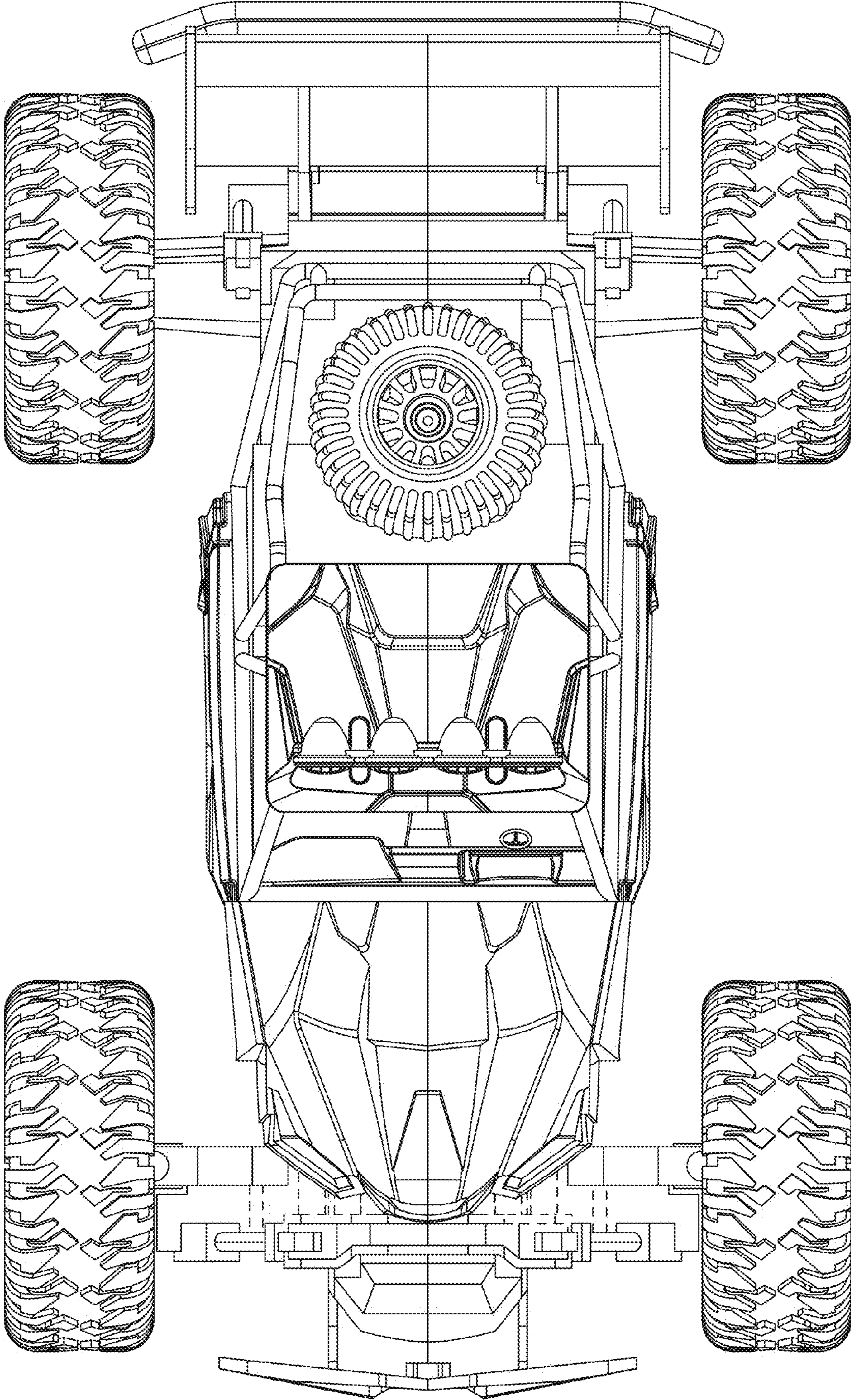

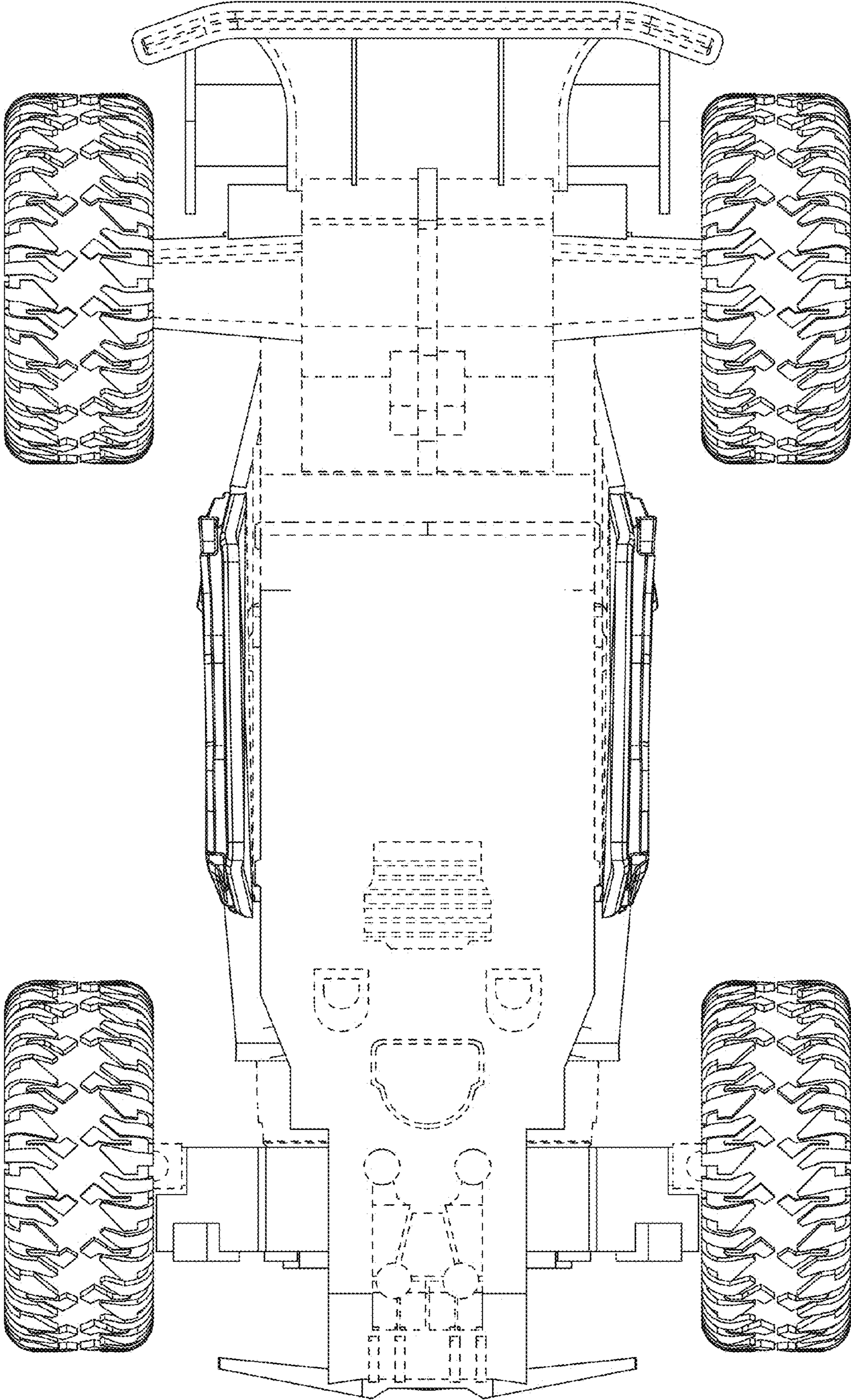

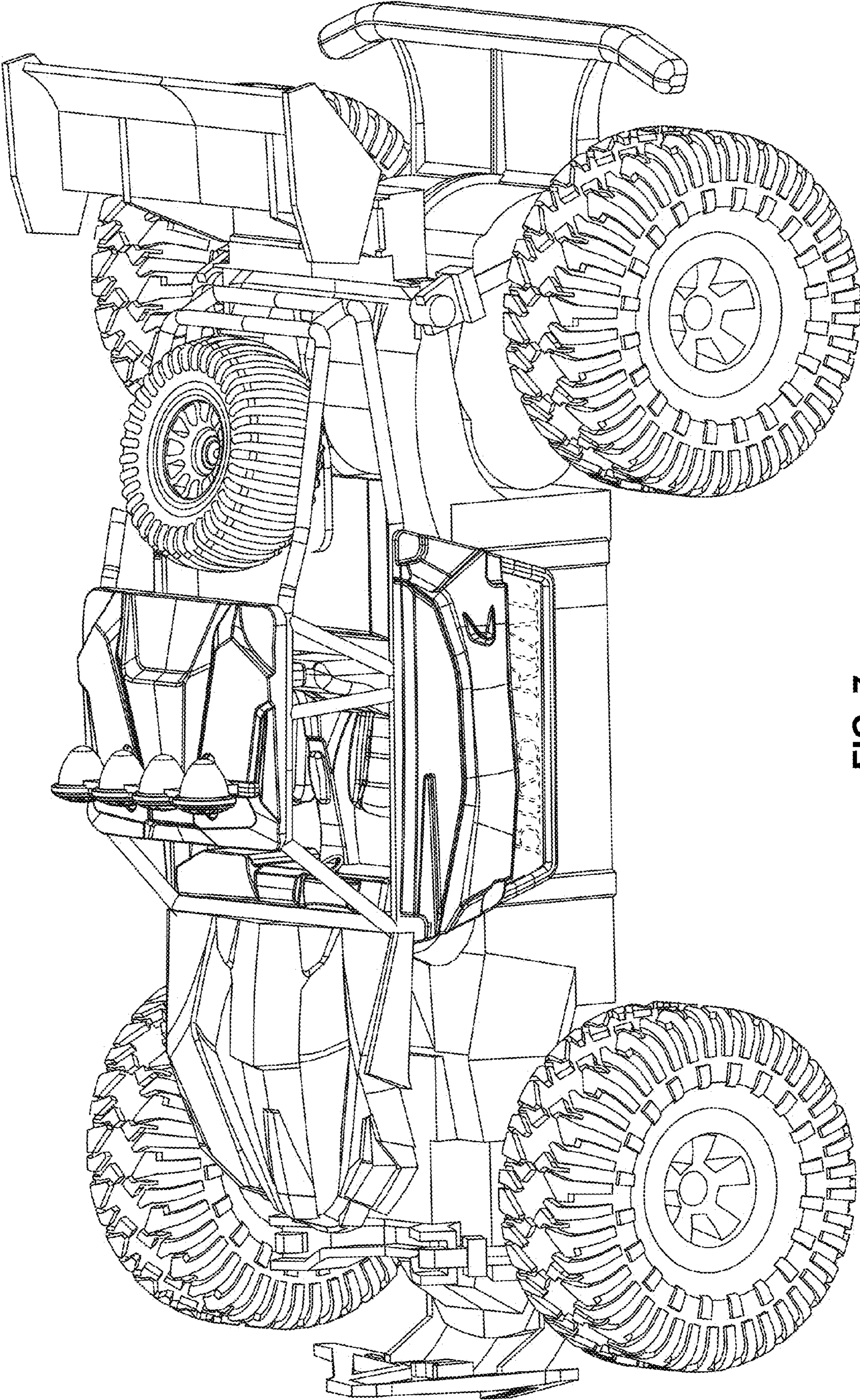

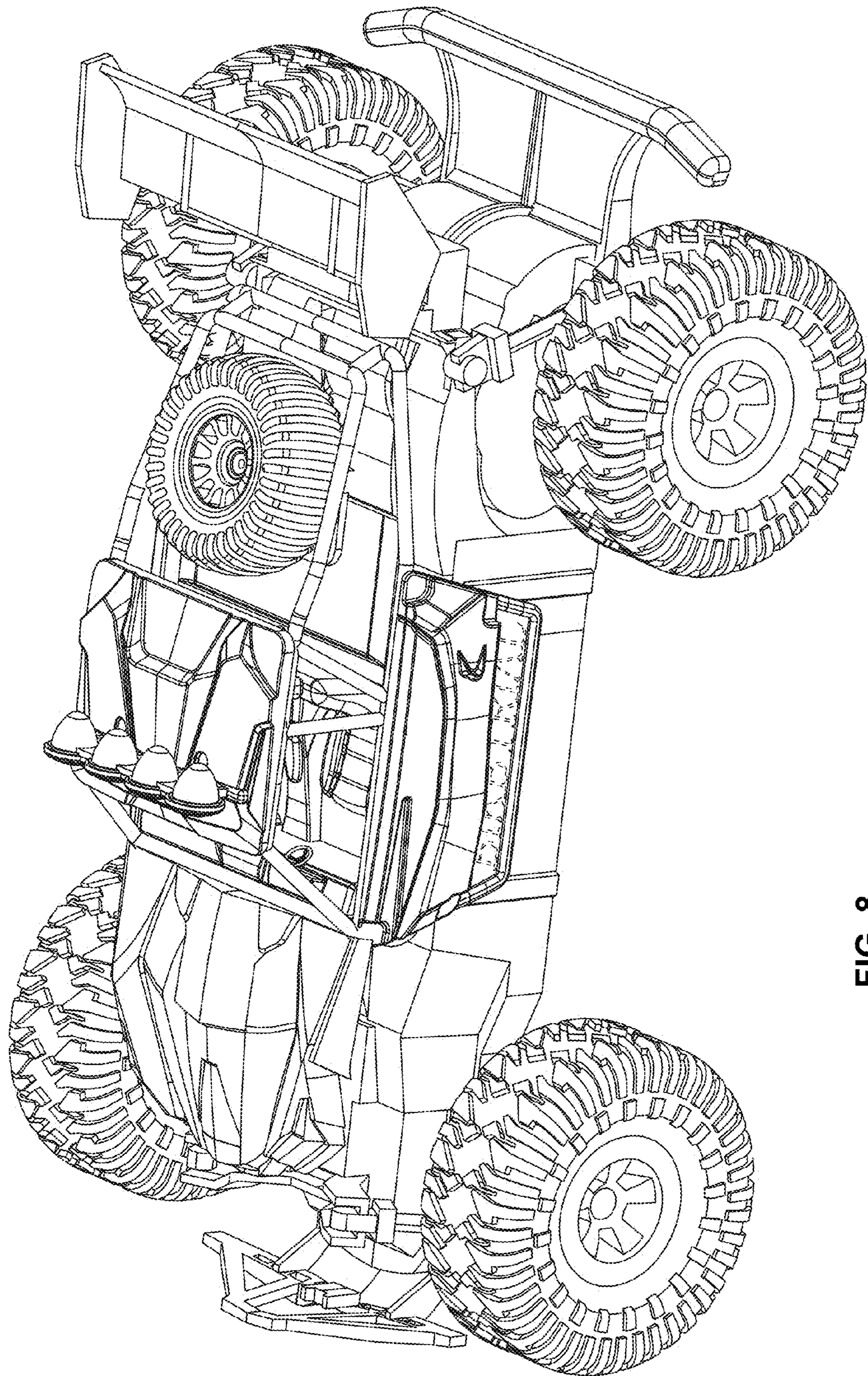

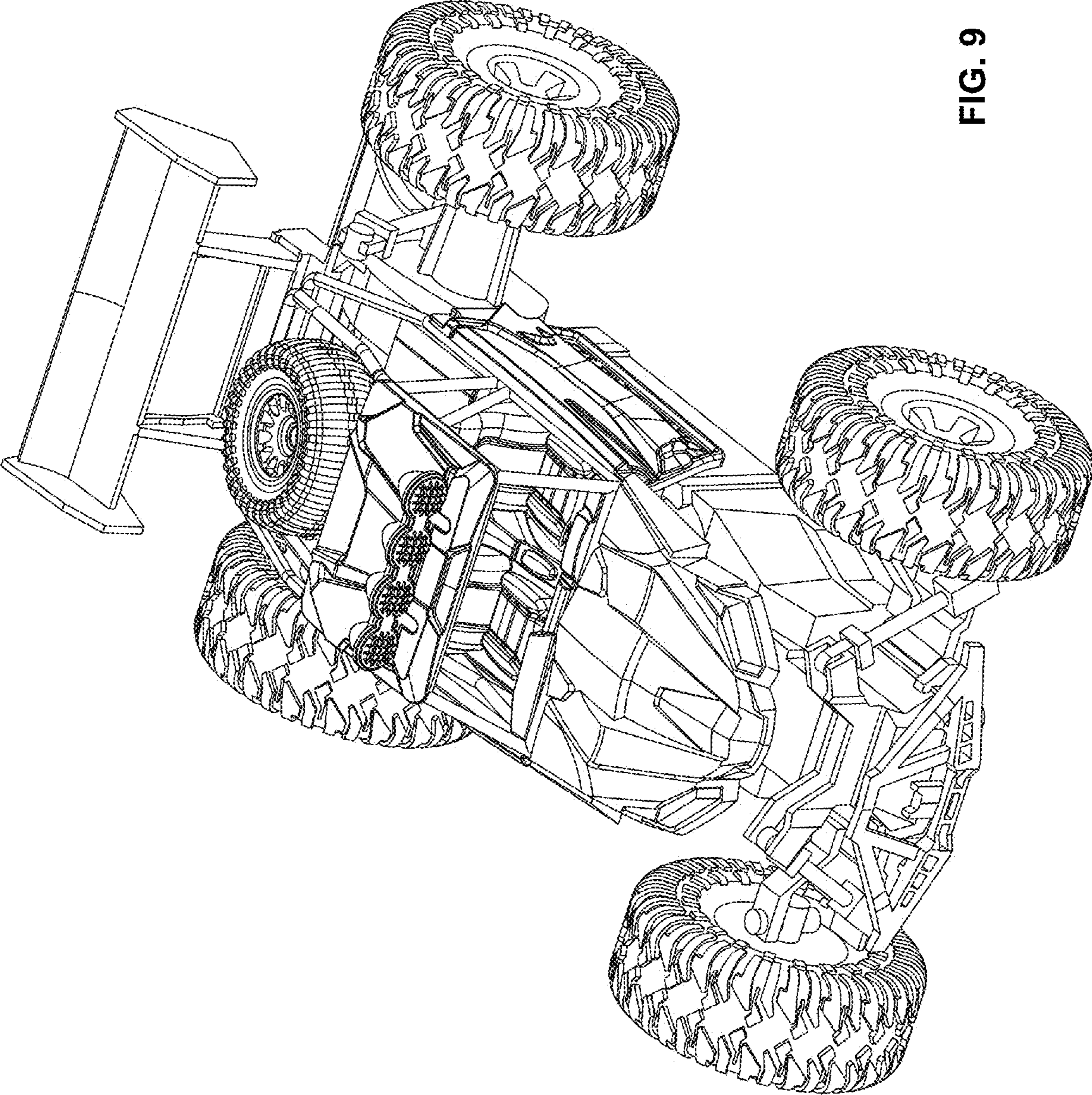

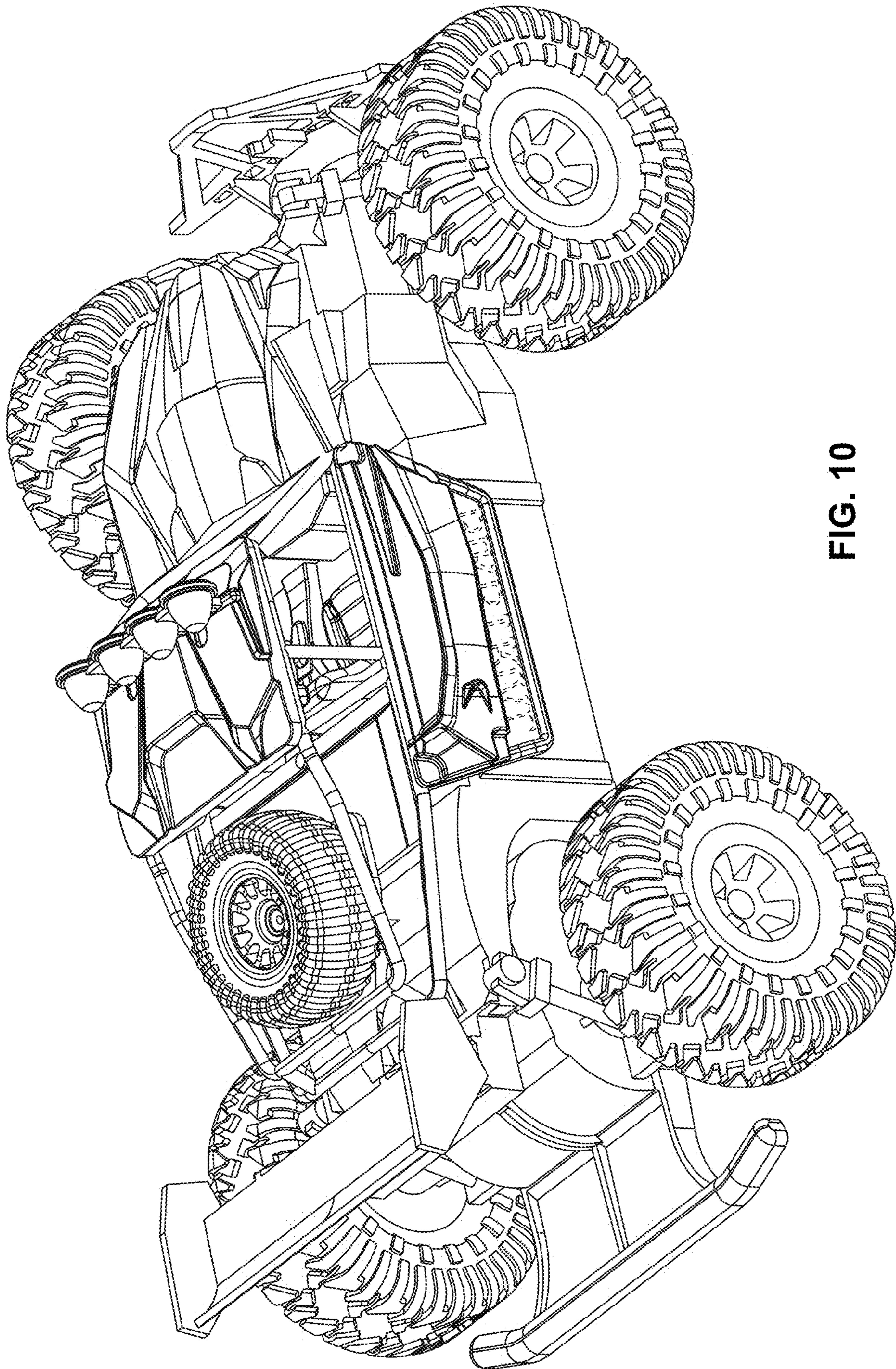

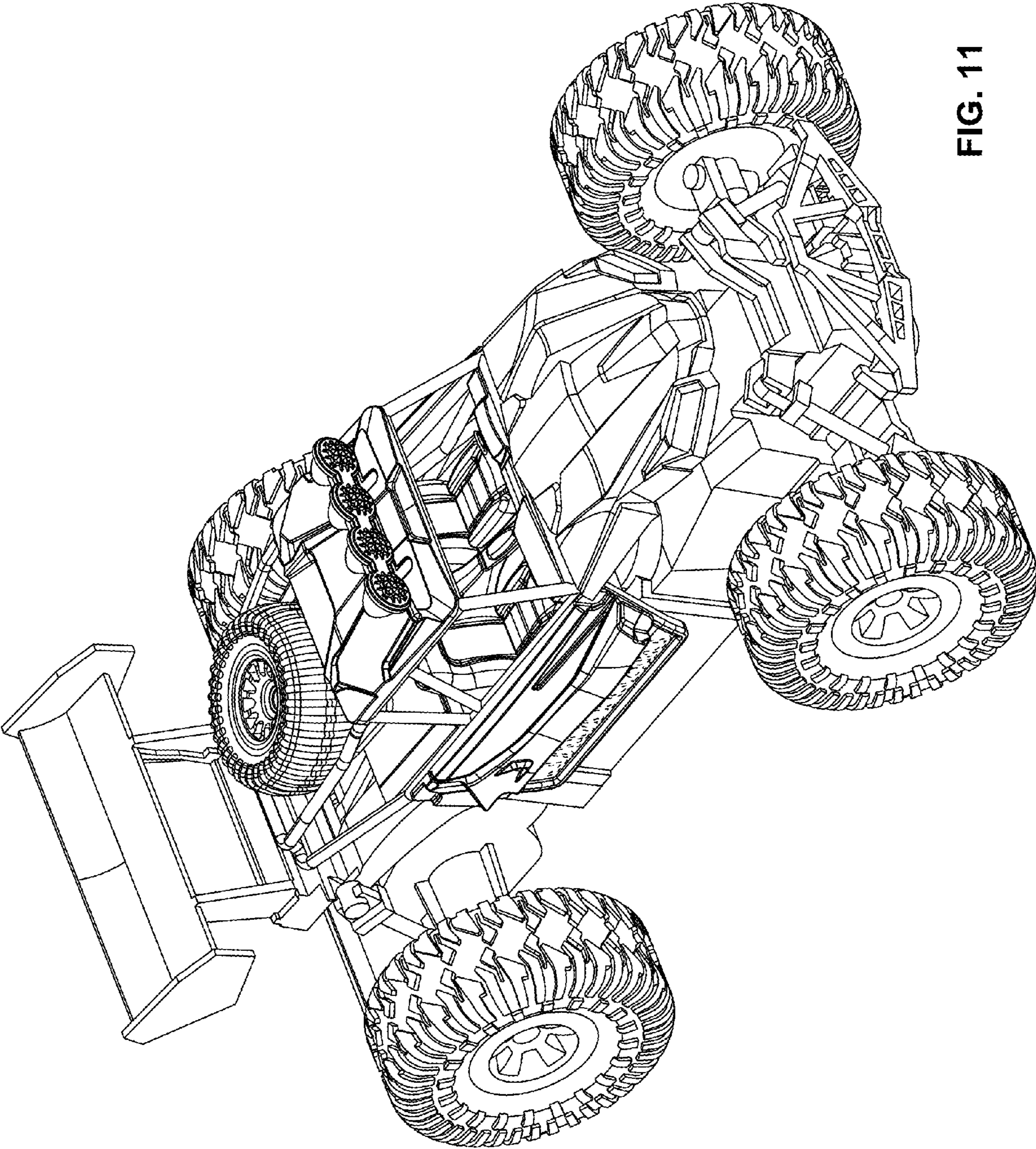

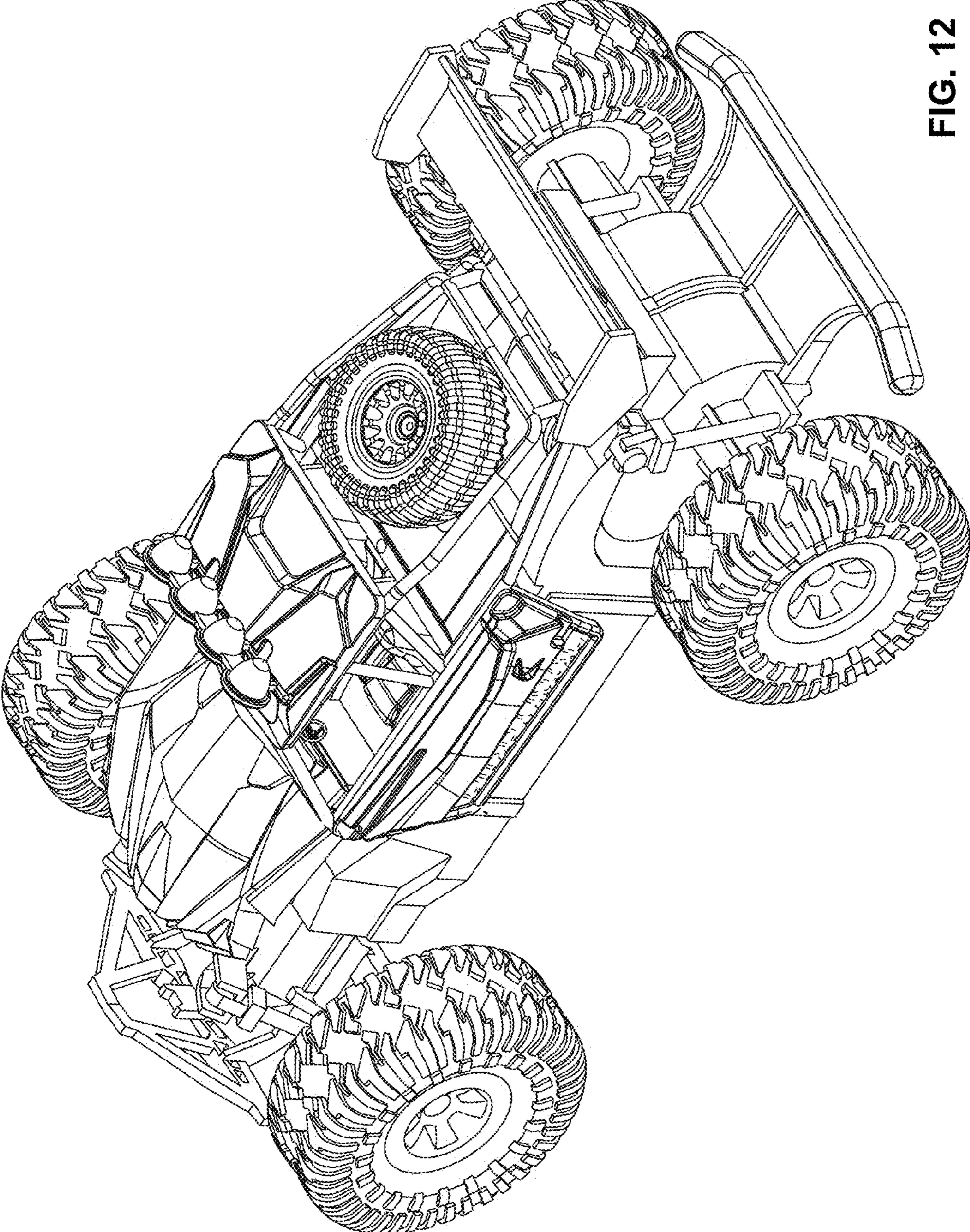
