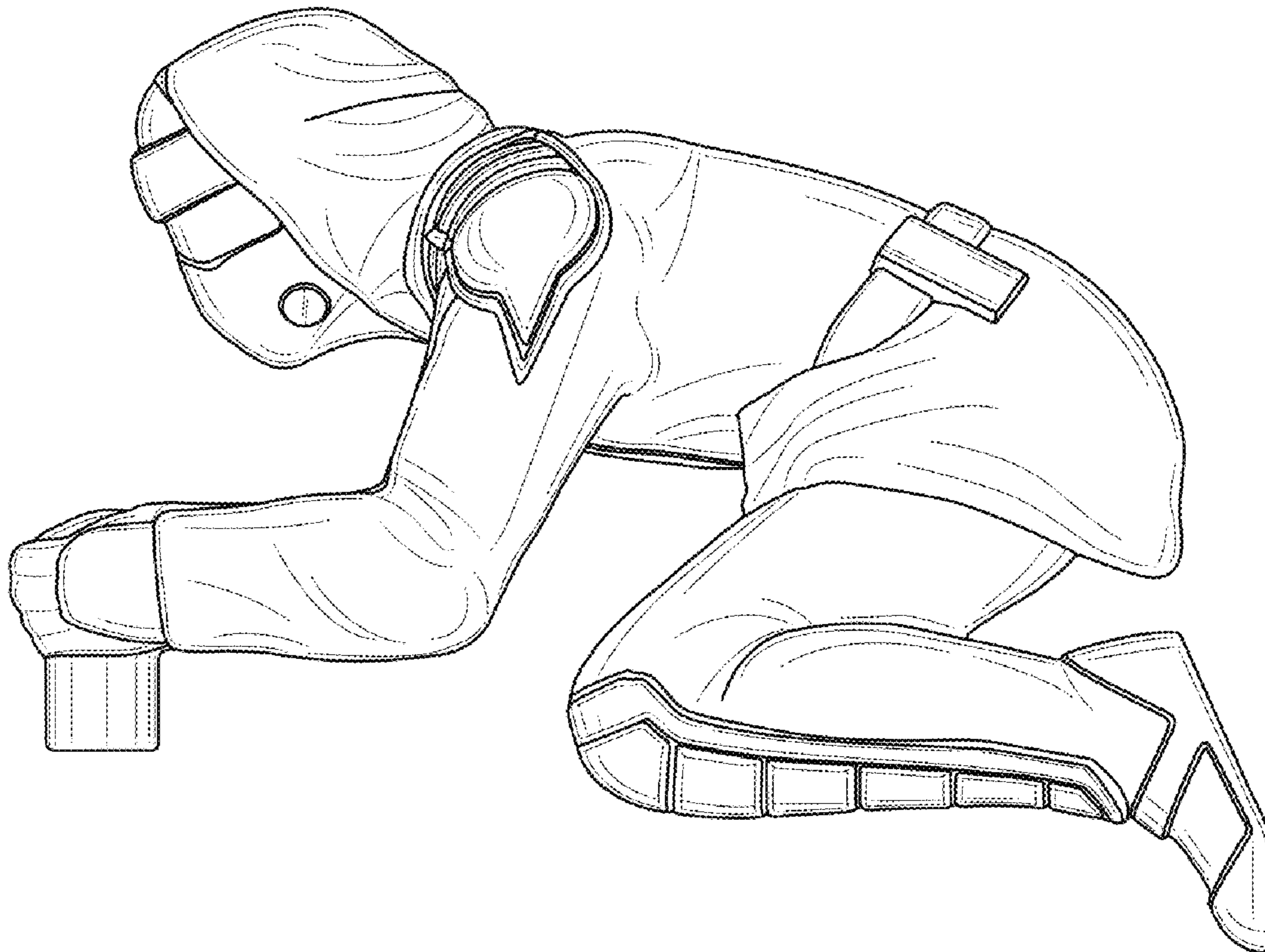
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right-side elevational view of the figure toy; FIG. 2 is a left-side elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a front, right-side, top perspective view thereof; and, FIG. 8 is a front, left-side, bottom perspective view thereof.

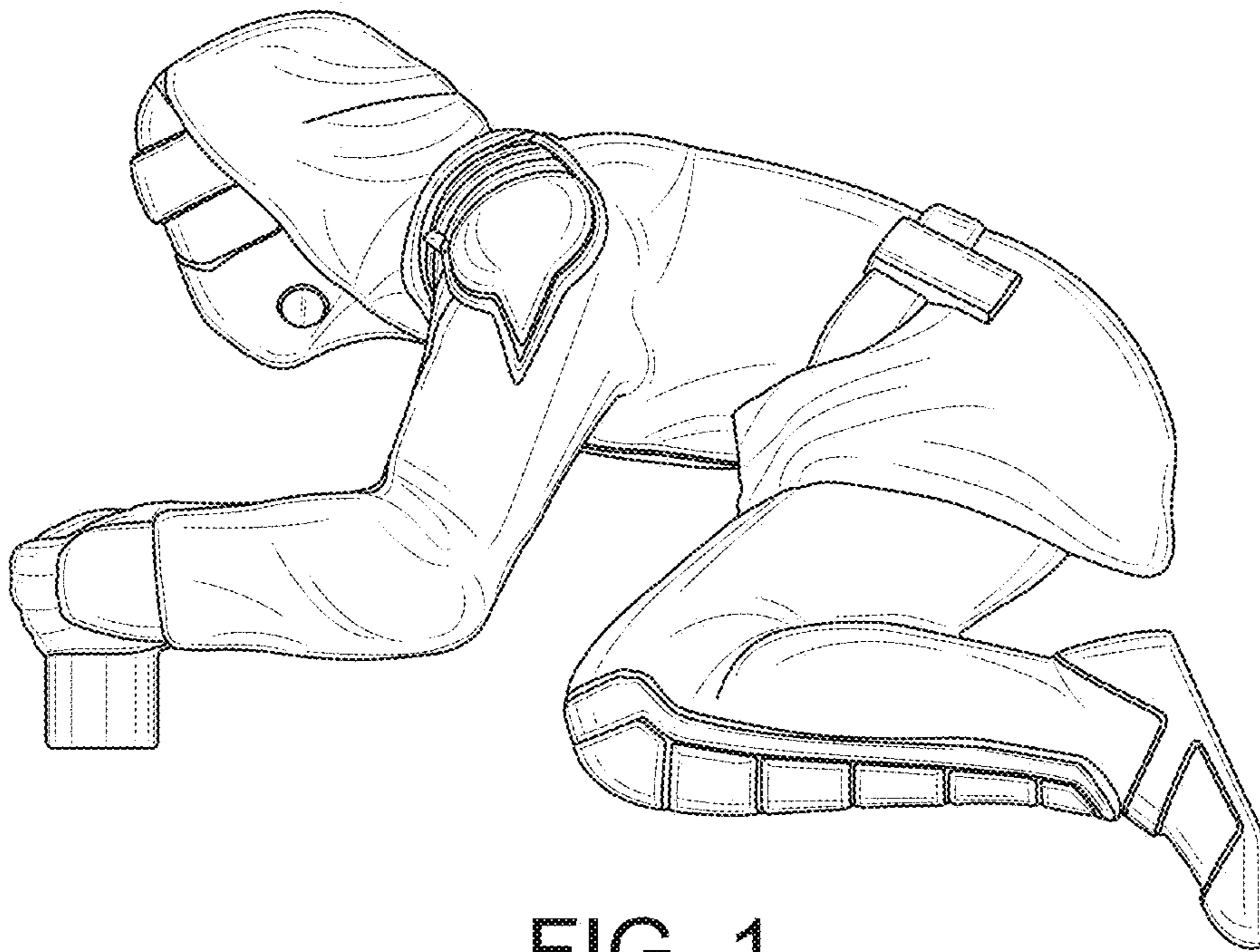

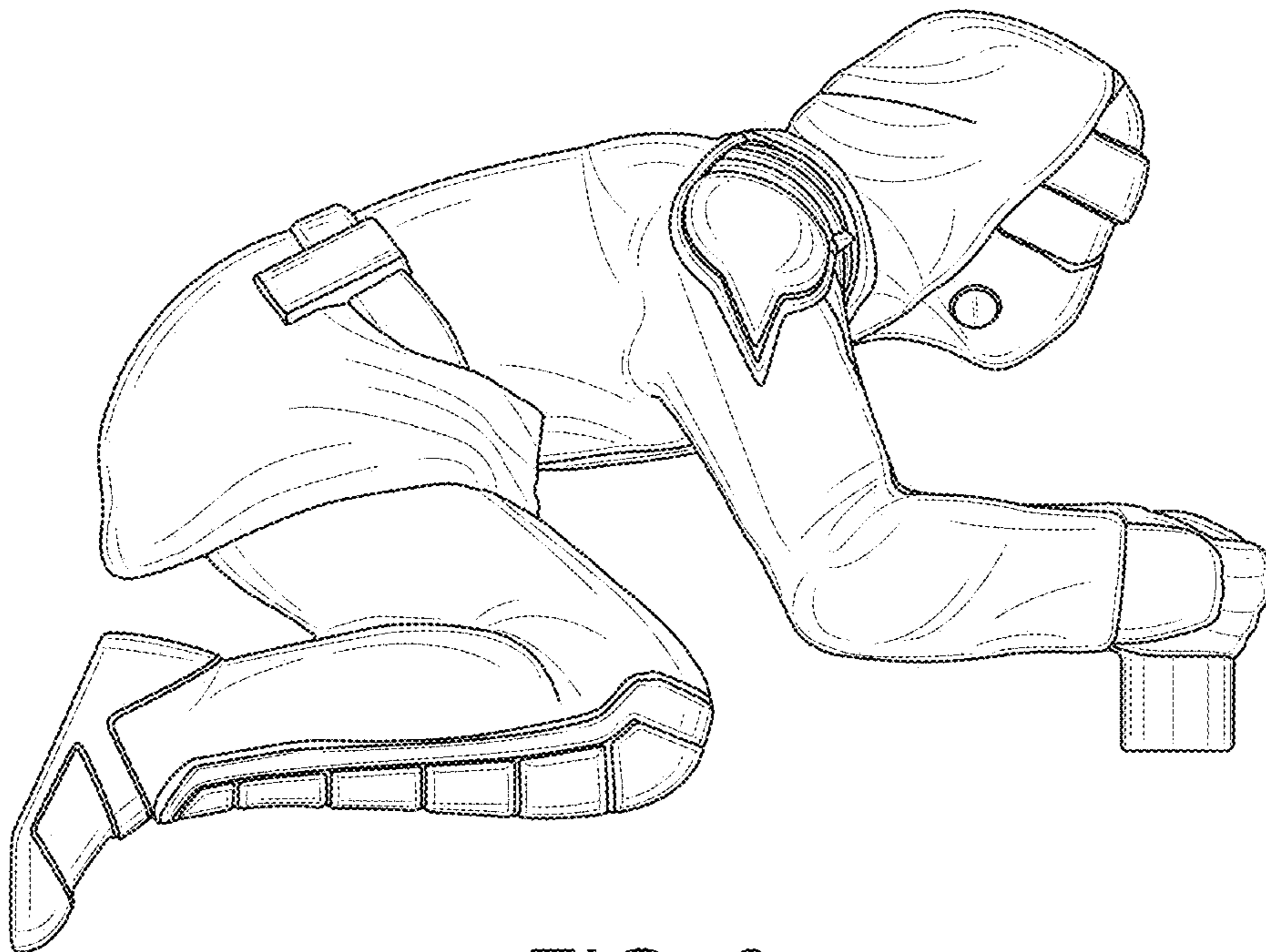

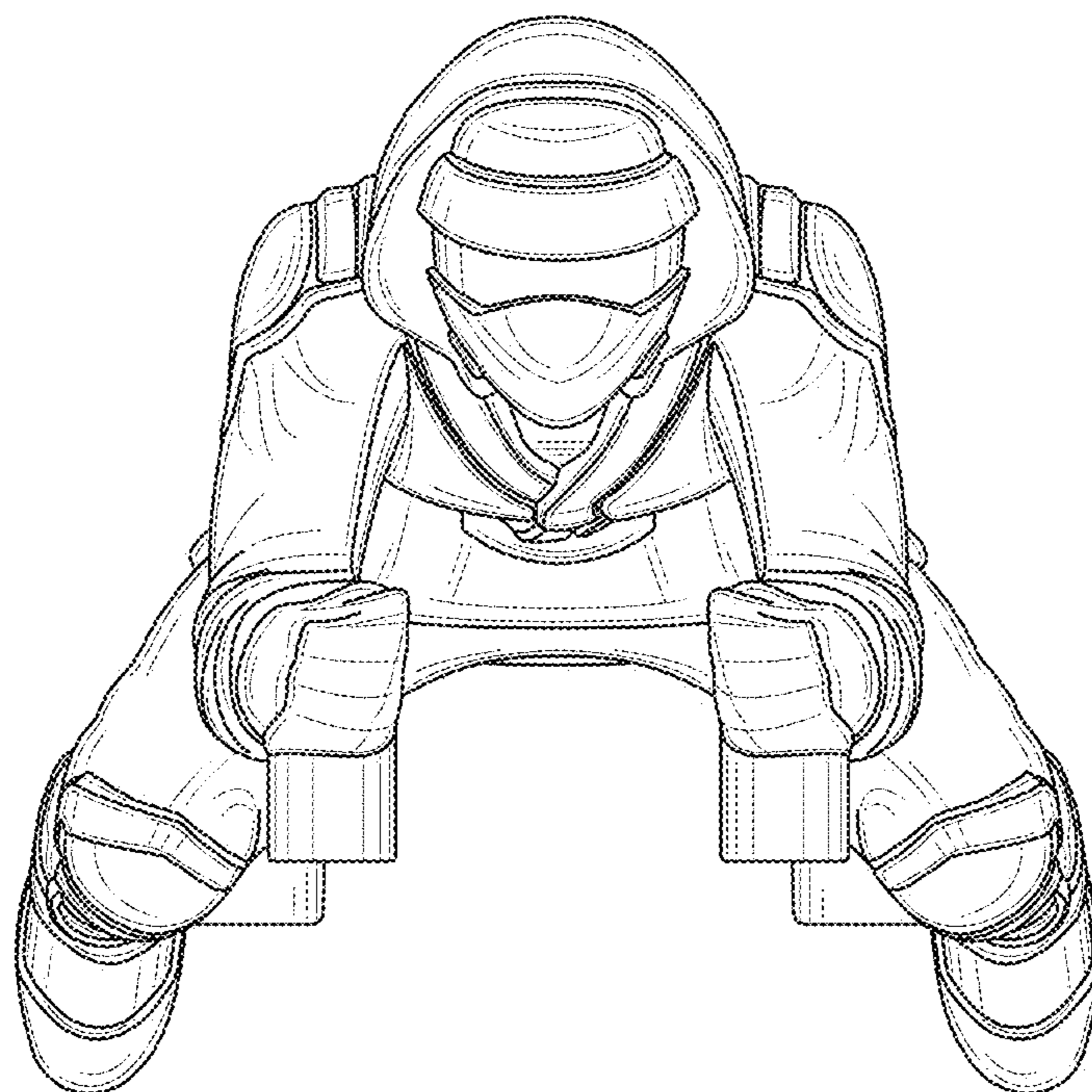

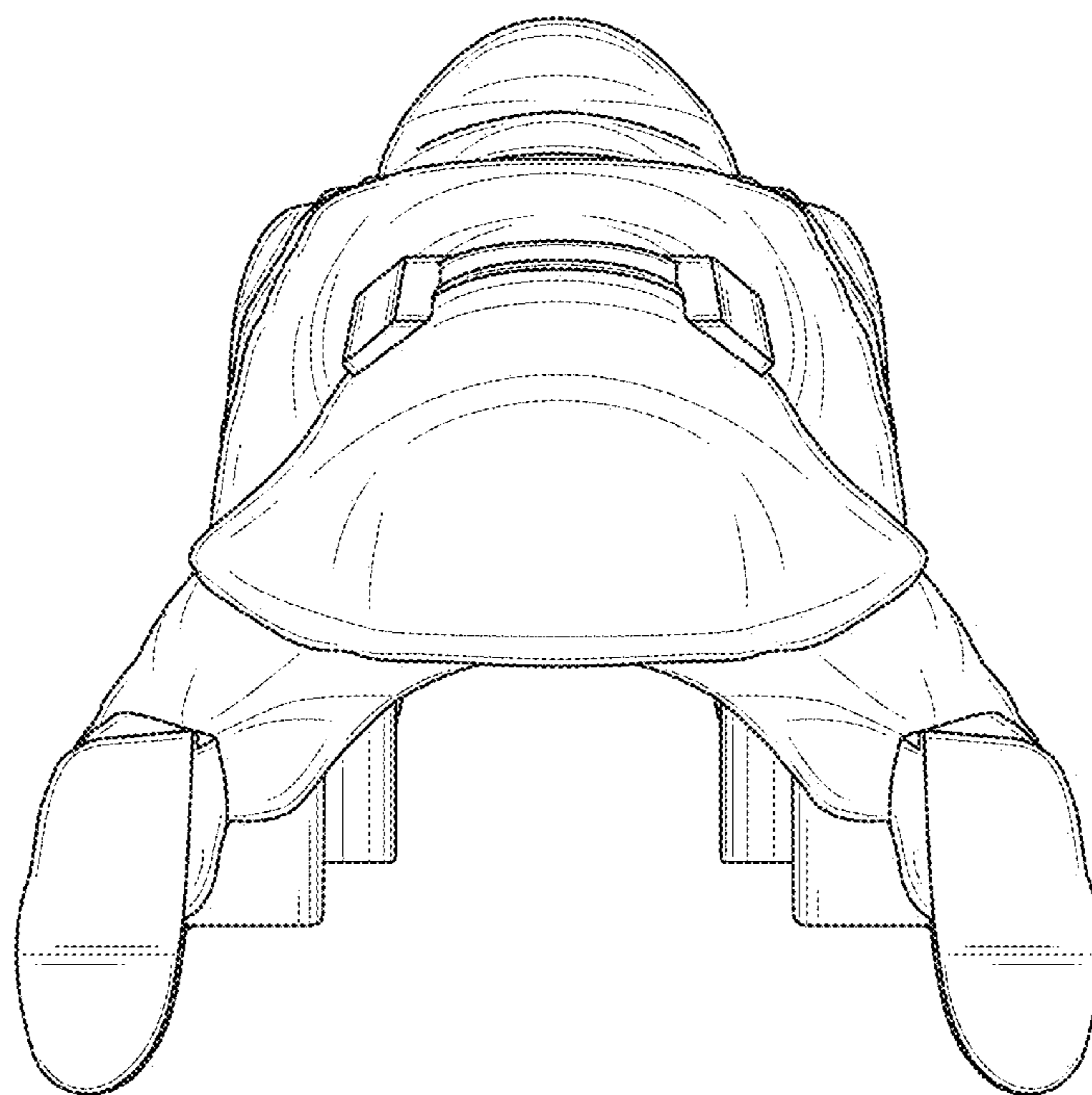

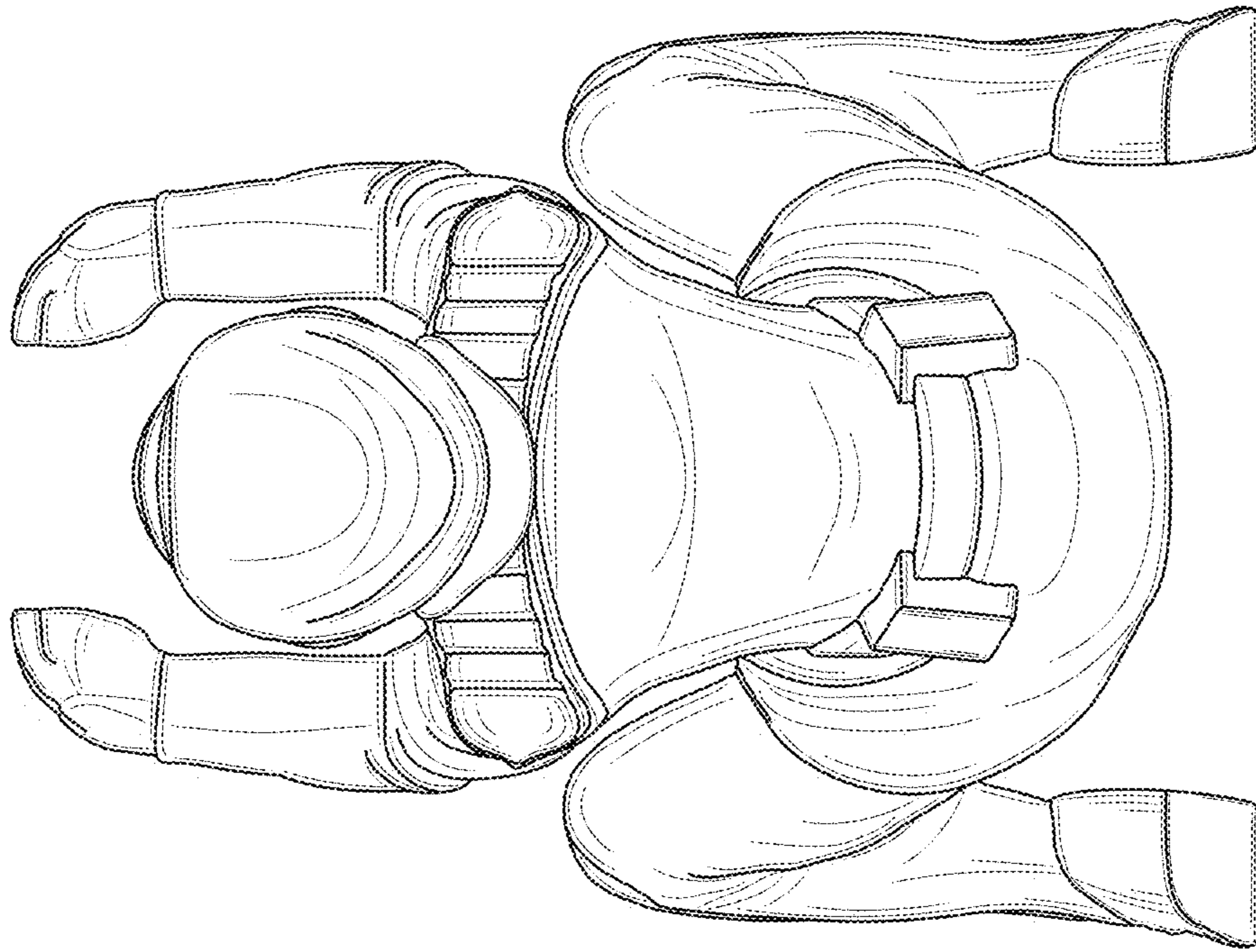

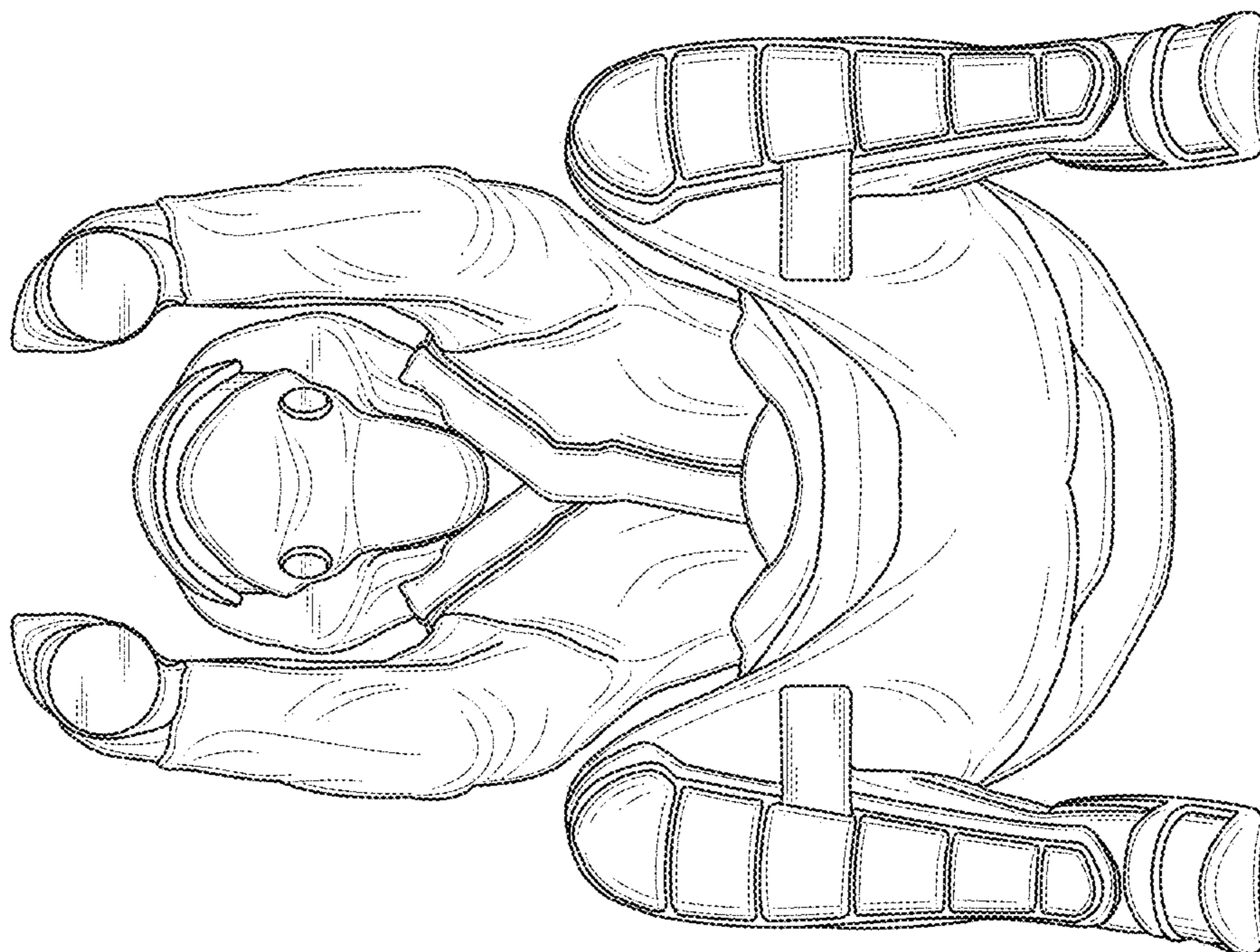

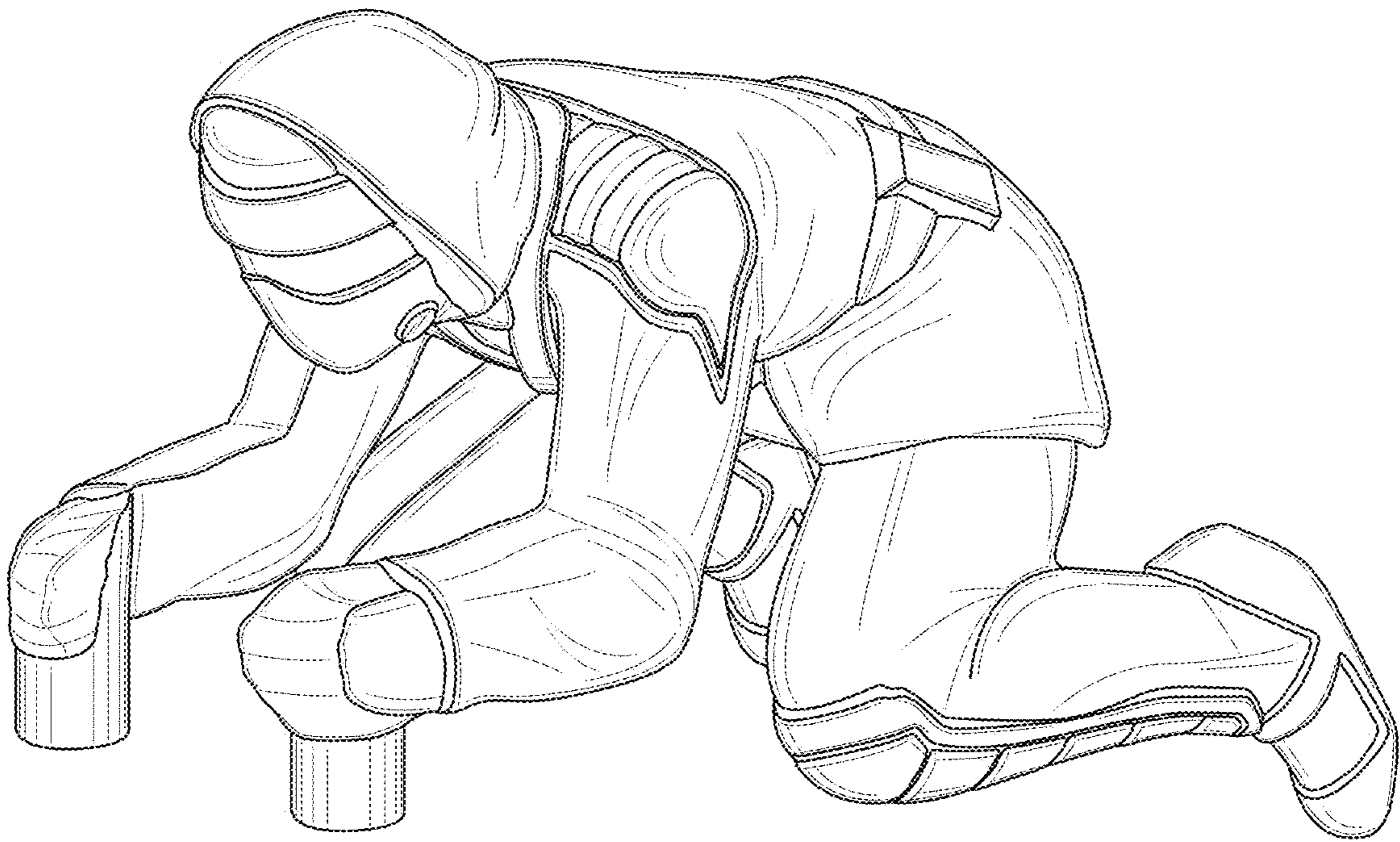
