(57) **CLAIM**

The ornamental design for a sphygmomanometer with electrocardiograph, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, and right side perspective view of a sphygmomanometer with electrocardiograph showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a right side view thereof; and,

FIG. 7 is a left side view thereof.

The dashed broken lines shown in the figures illustrate portions of the sphygmomanometer with electrocardiograph that form no part of the claimed design. The dot-dash broken lines shown in the figures define the bounds of the claim and form no part thereof.

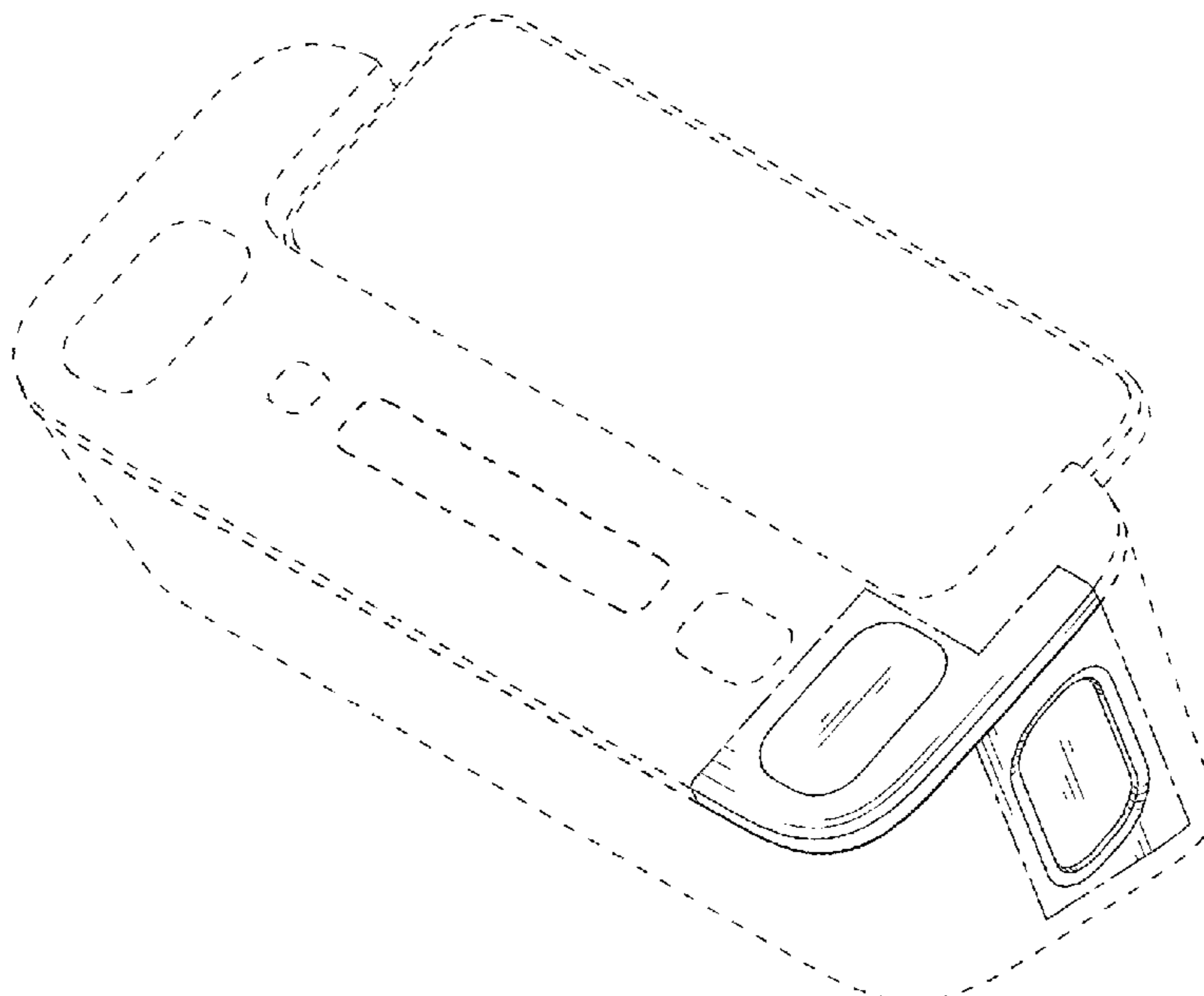

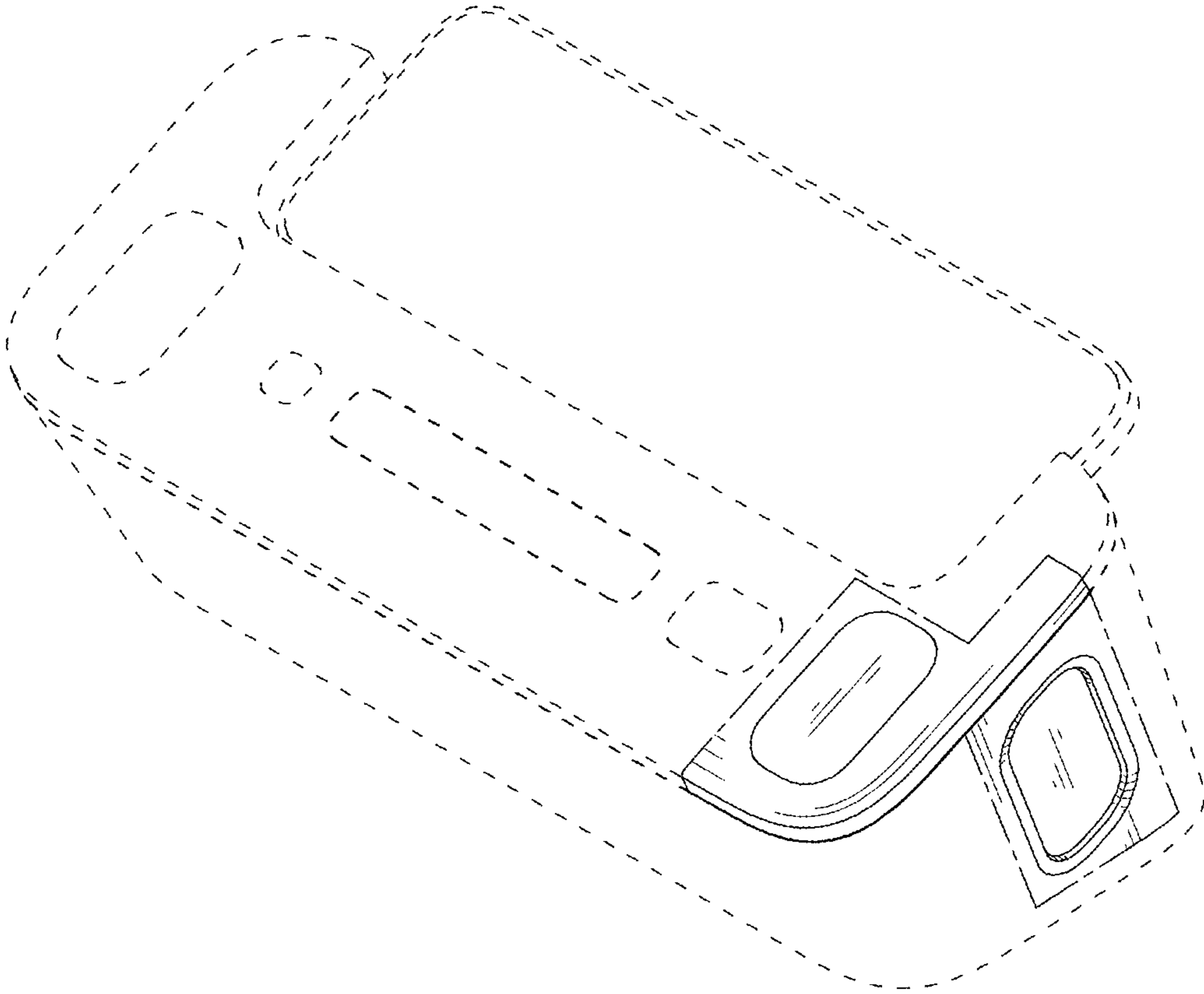

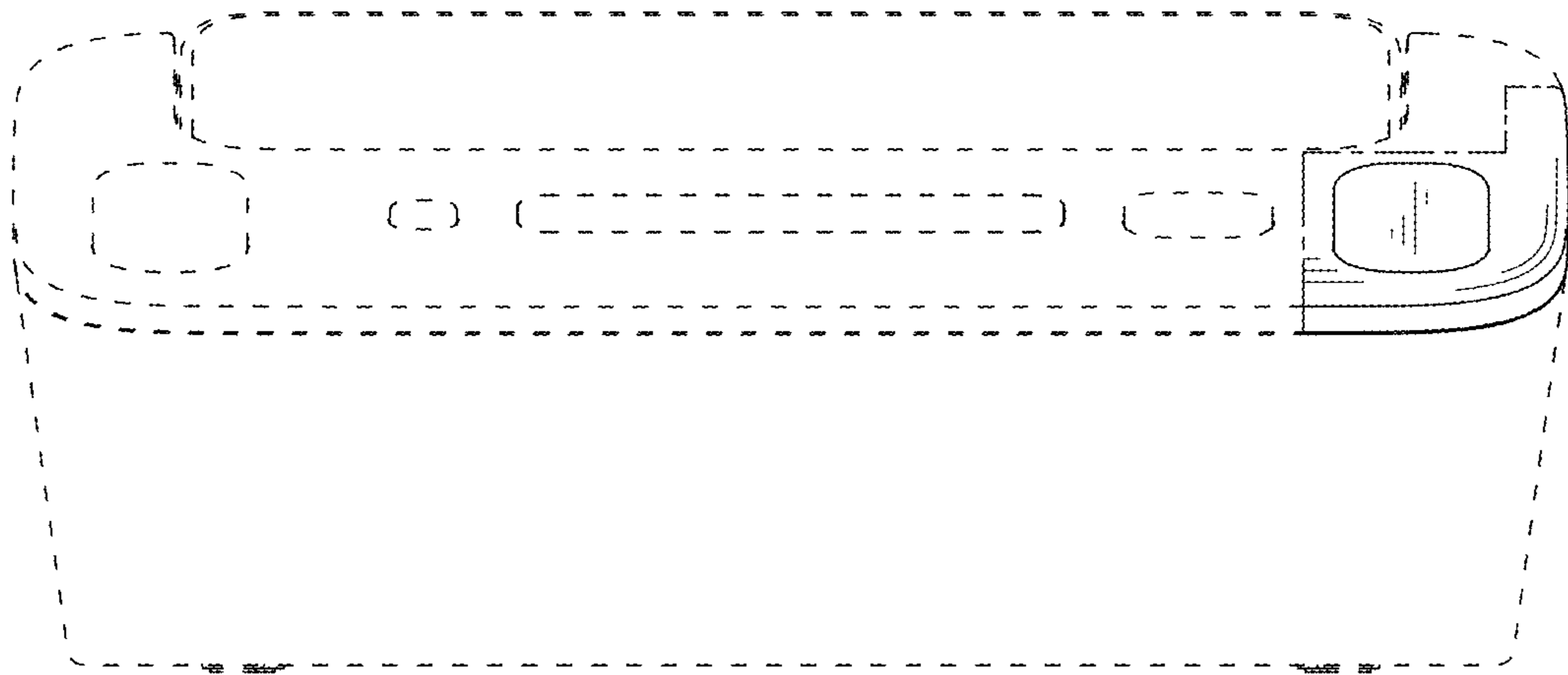

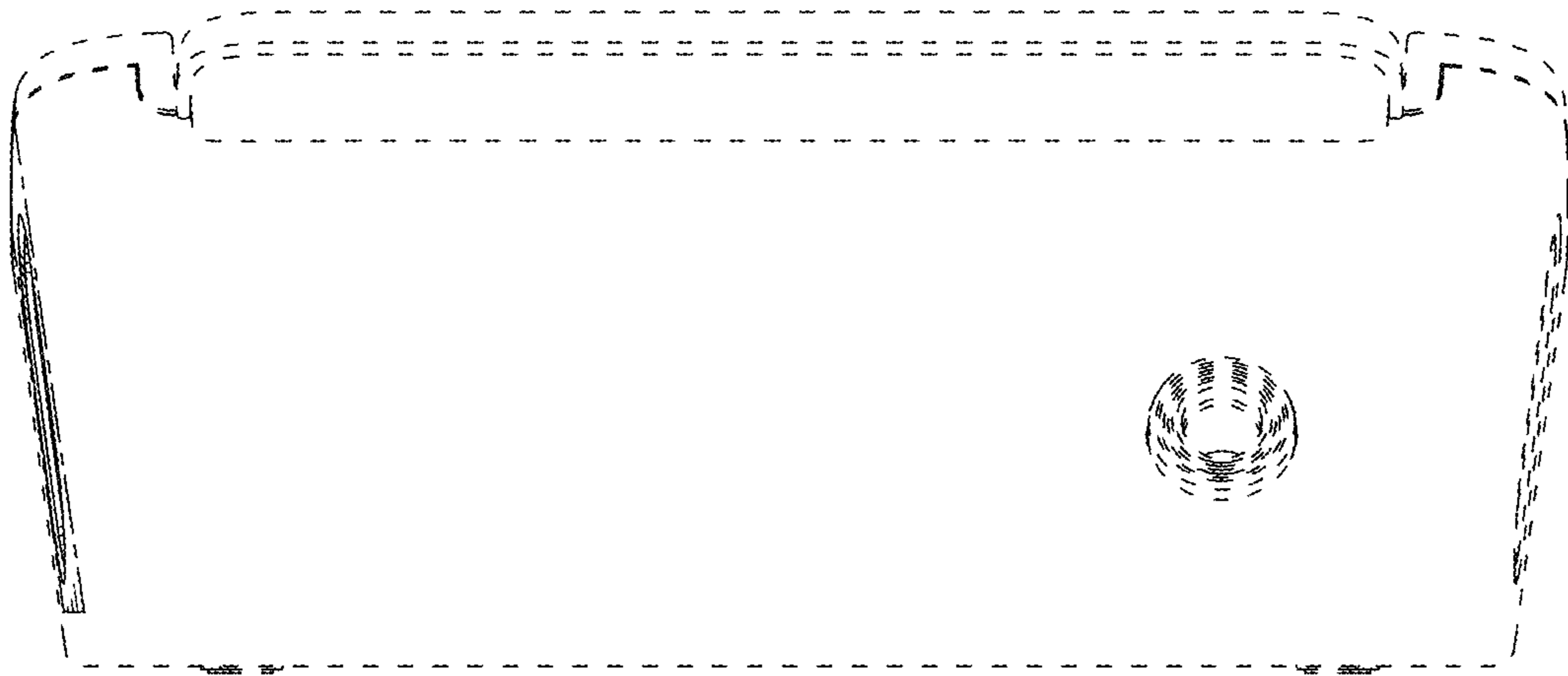

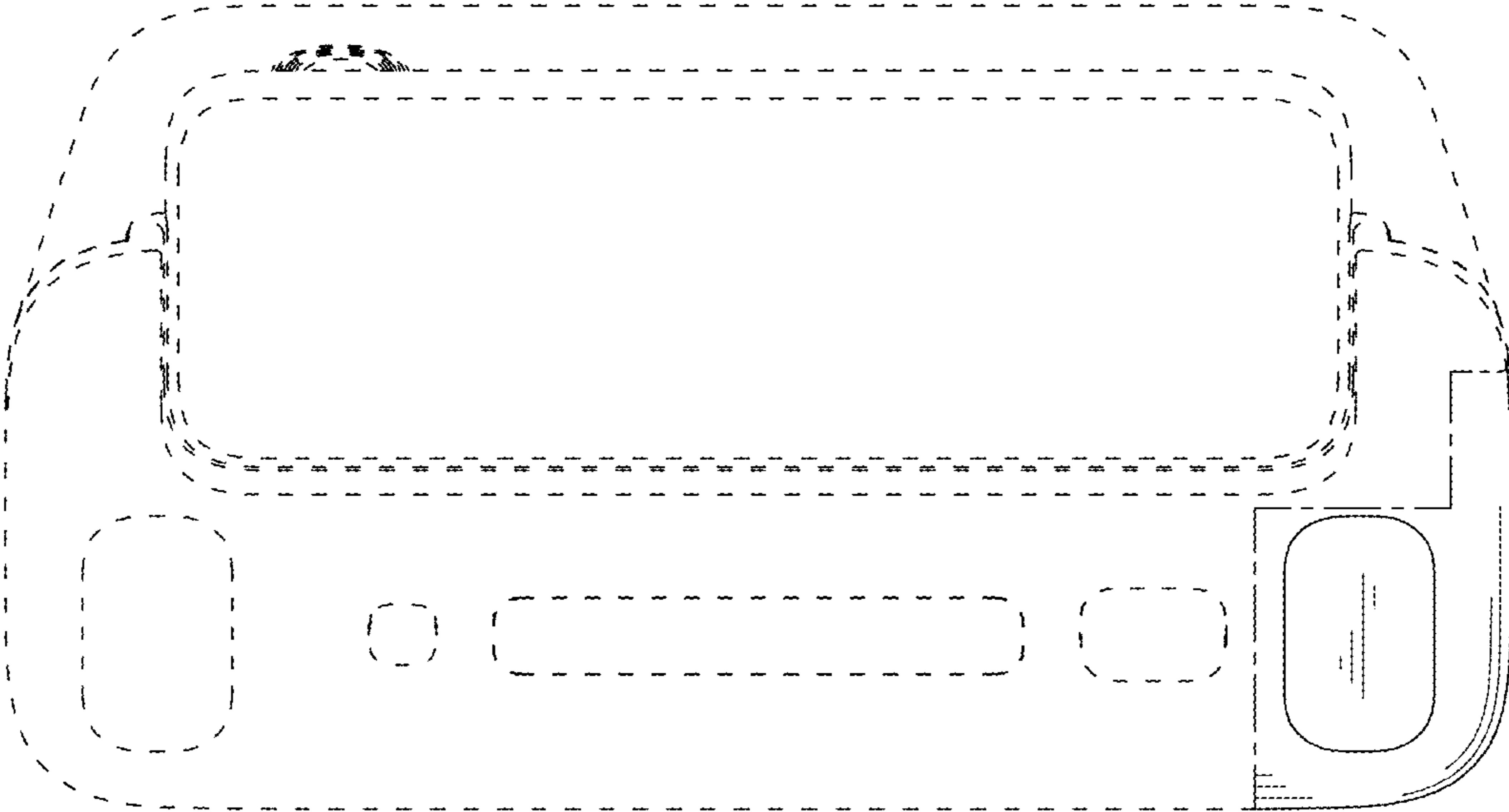

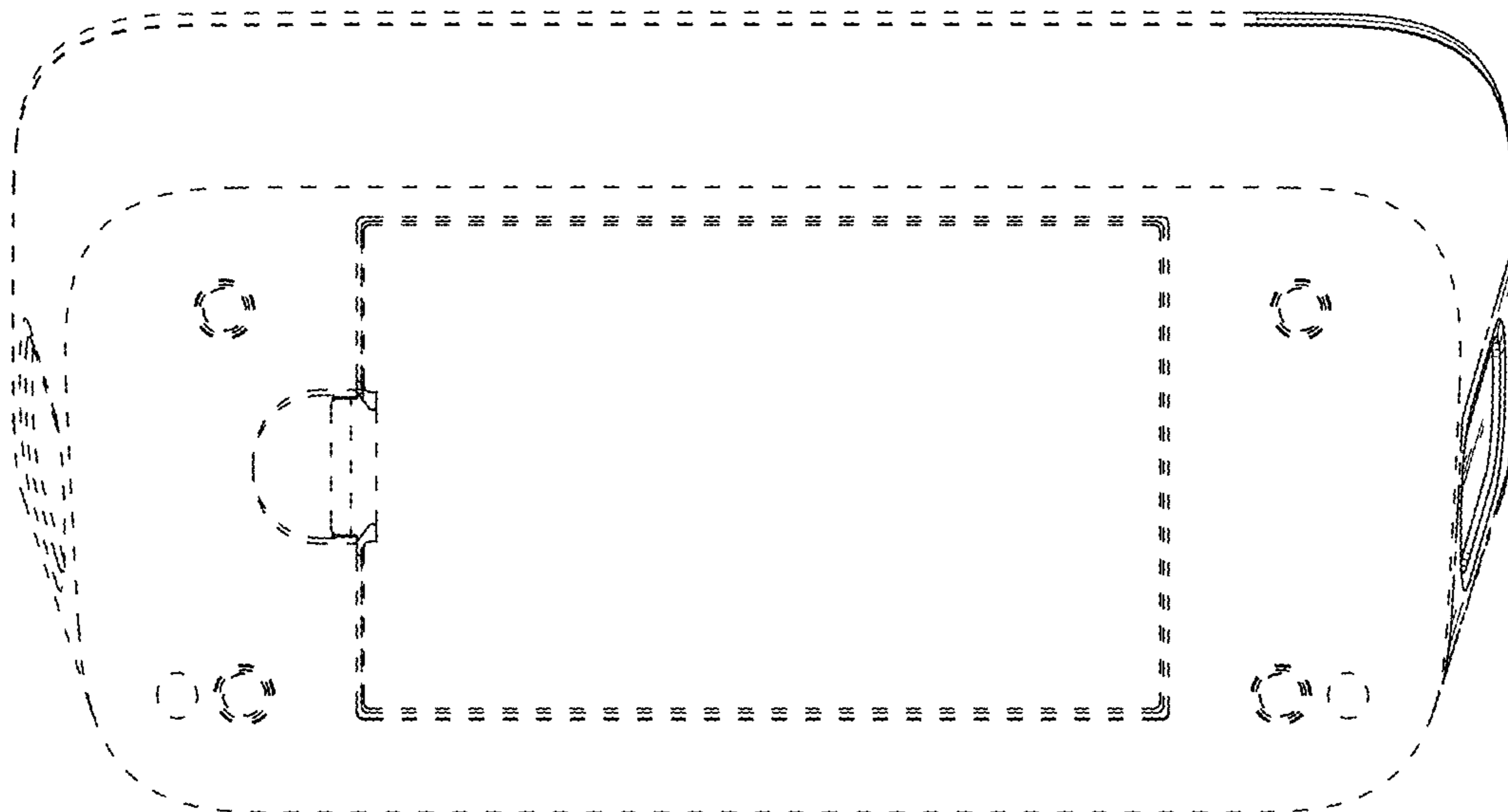

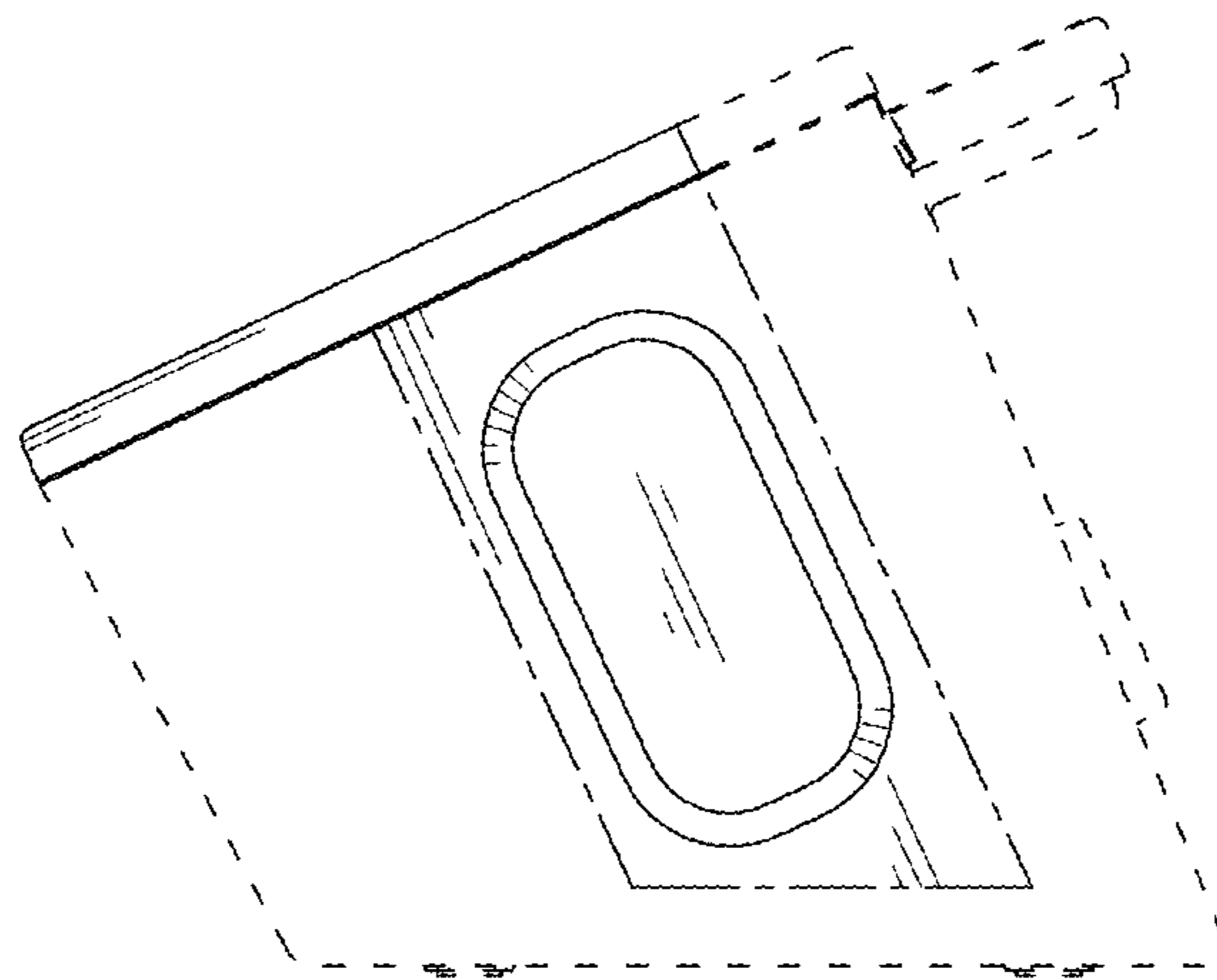
