DESCRIPTION

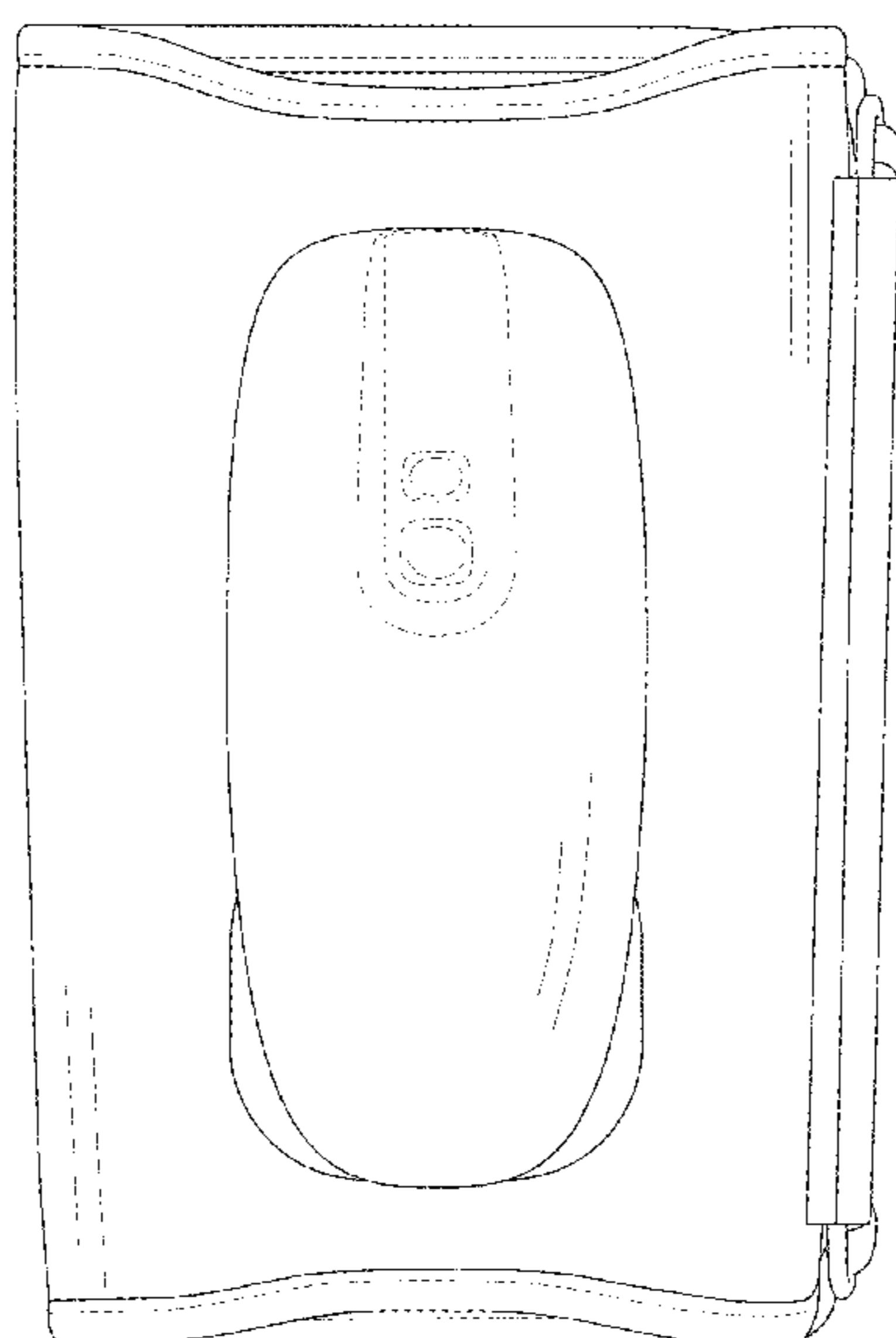
FIG. 1 is a front elevation view of a leg massager, showing my new design;

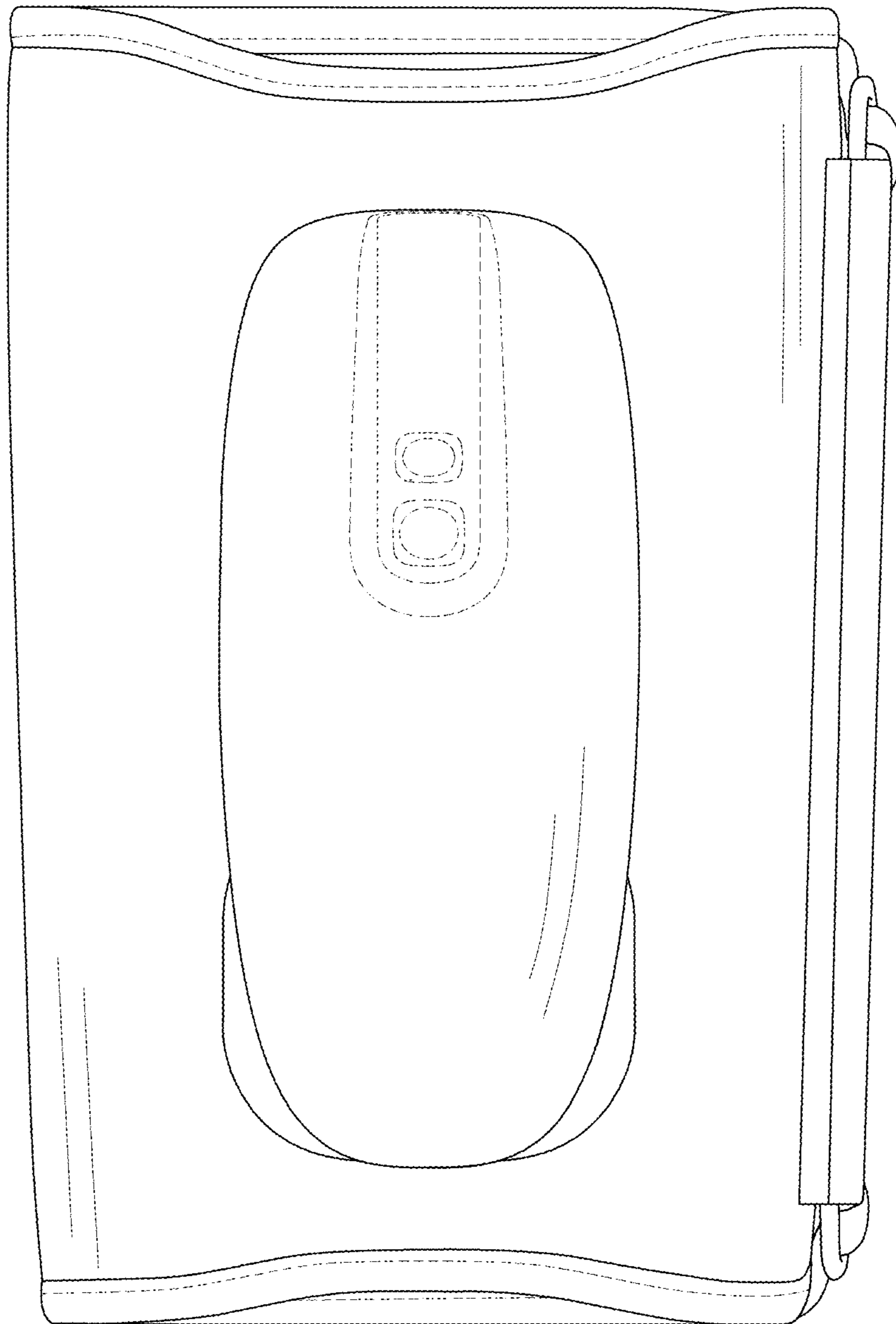

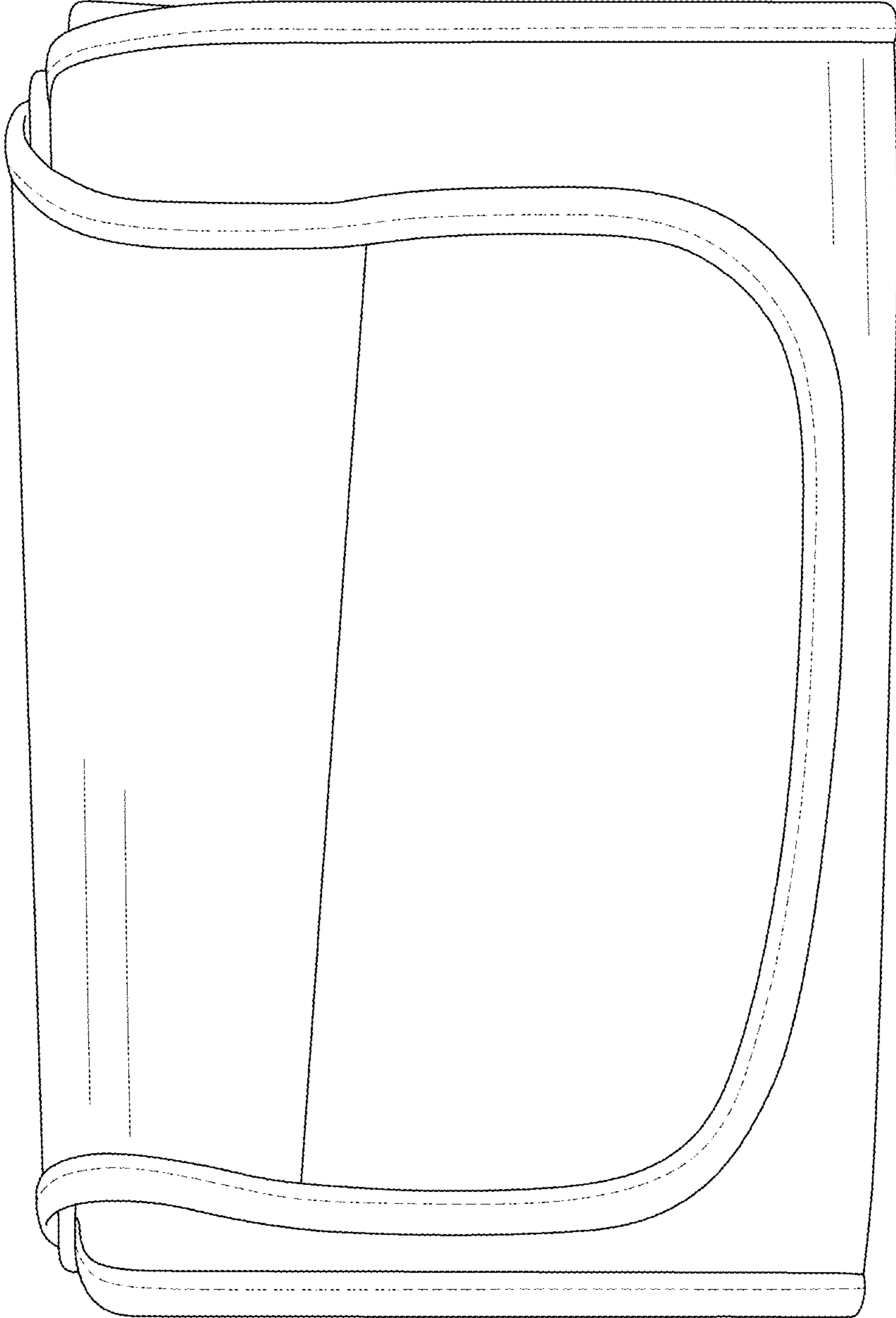

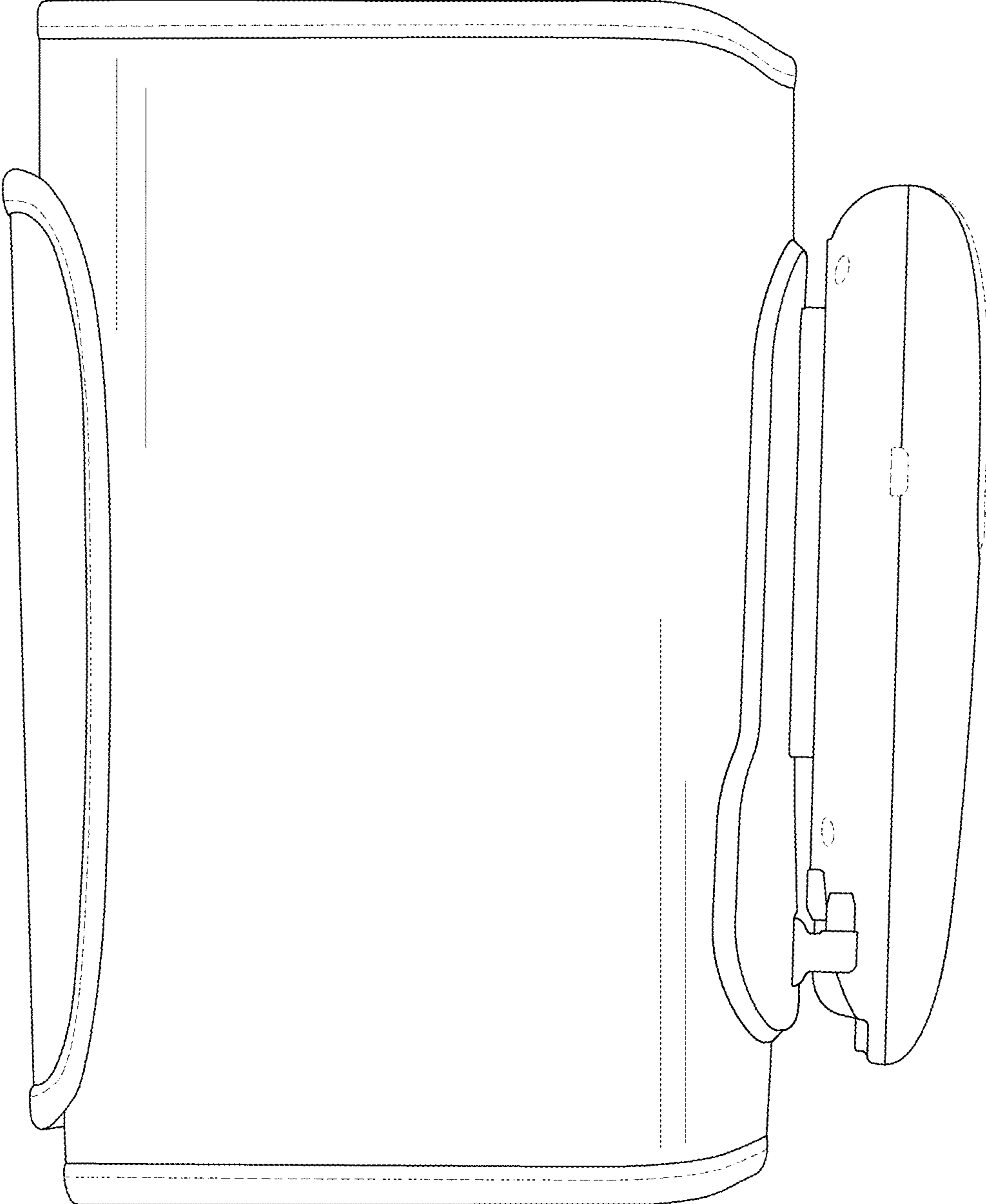

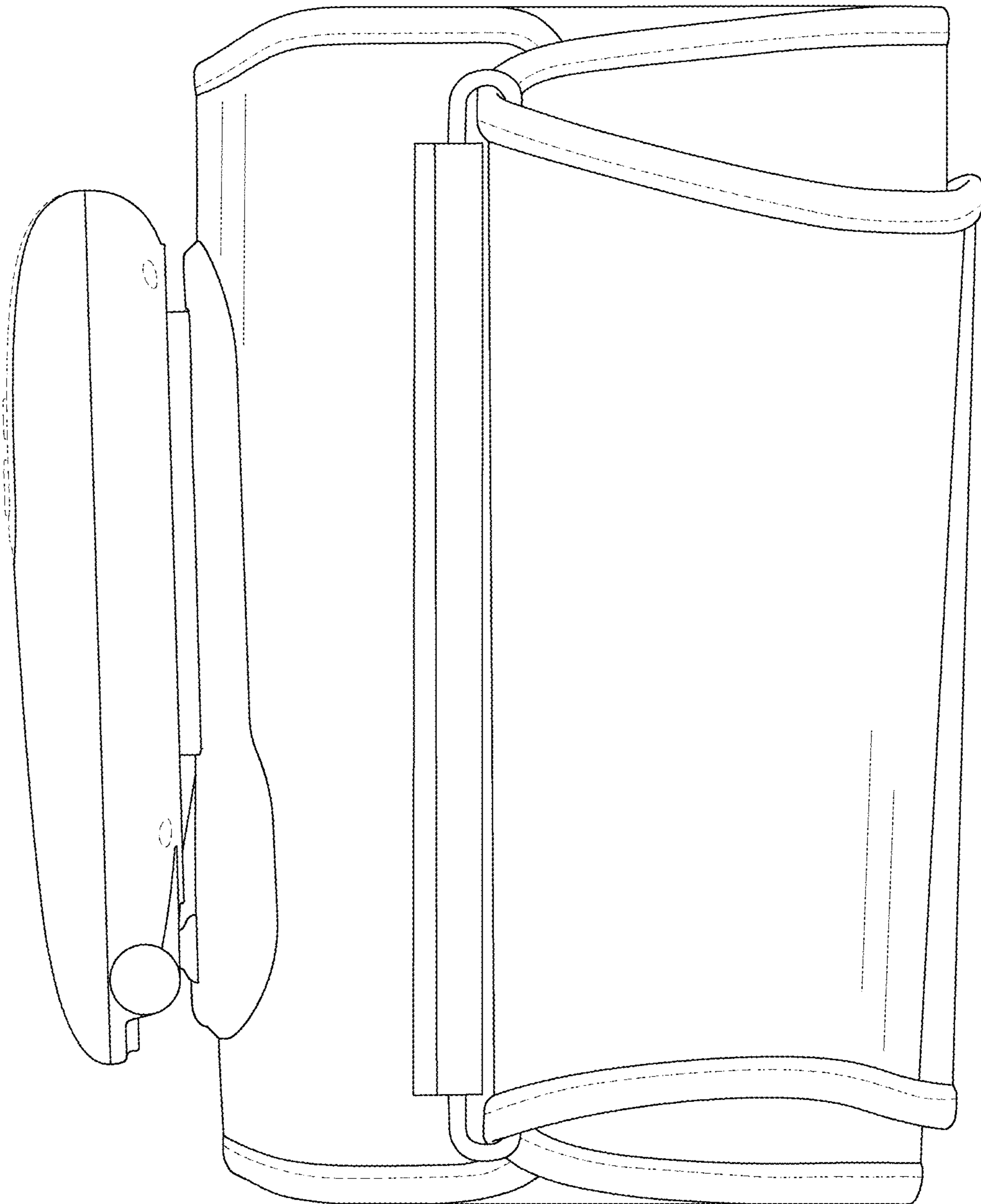

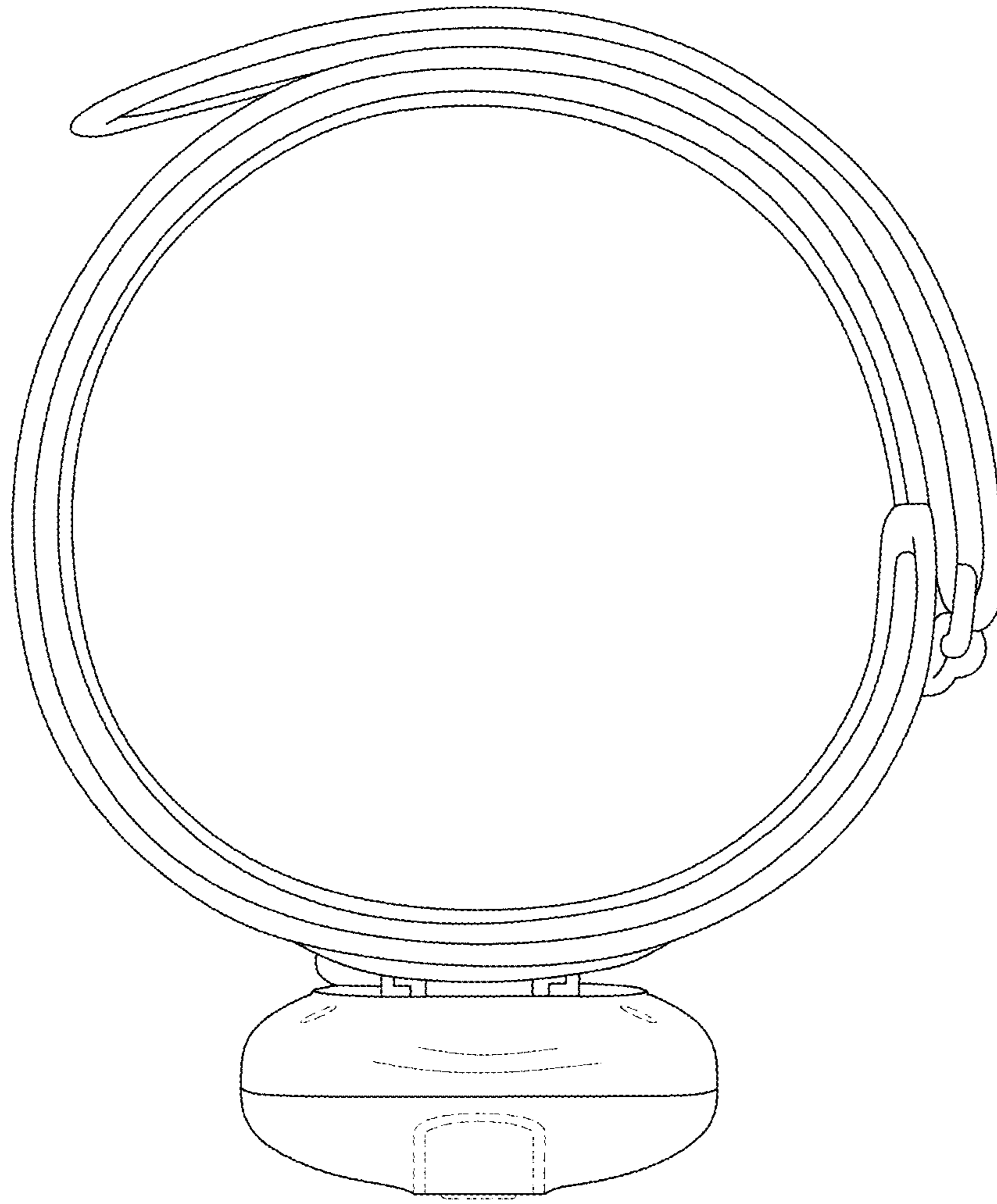

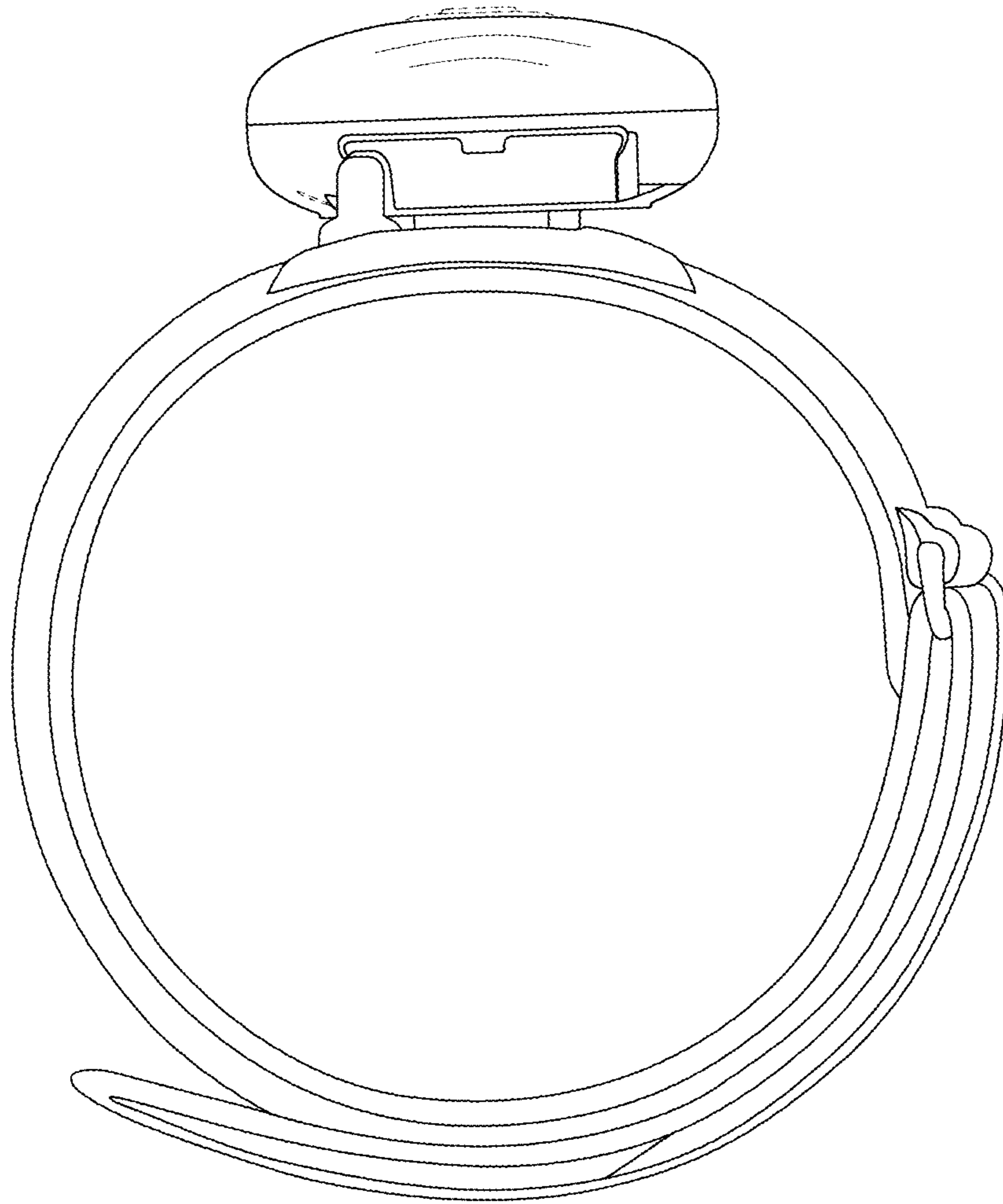
