(57) **CLAIM**

I claim the ornamental design for a tent, as shown and described.

DESCRIPTION

FIG. 1 is a top front left perspective view of a tent; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; and, FIG. 6 is a top plan view thereof. The broken lines shown in the drawings depict portions of the tent that form no part of the claimed design.

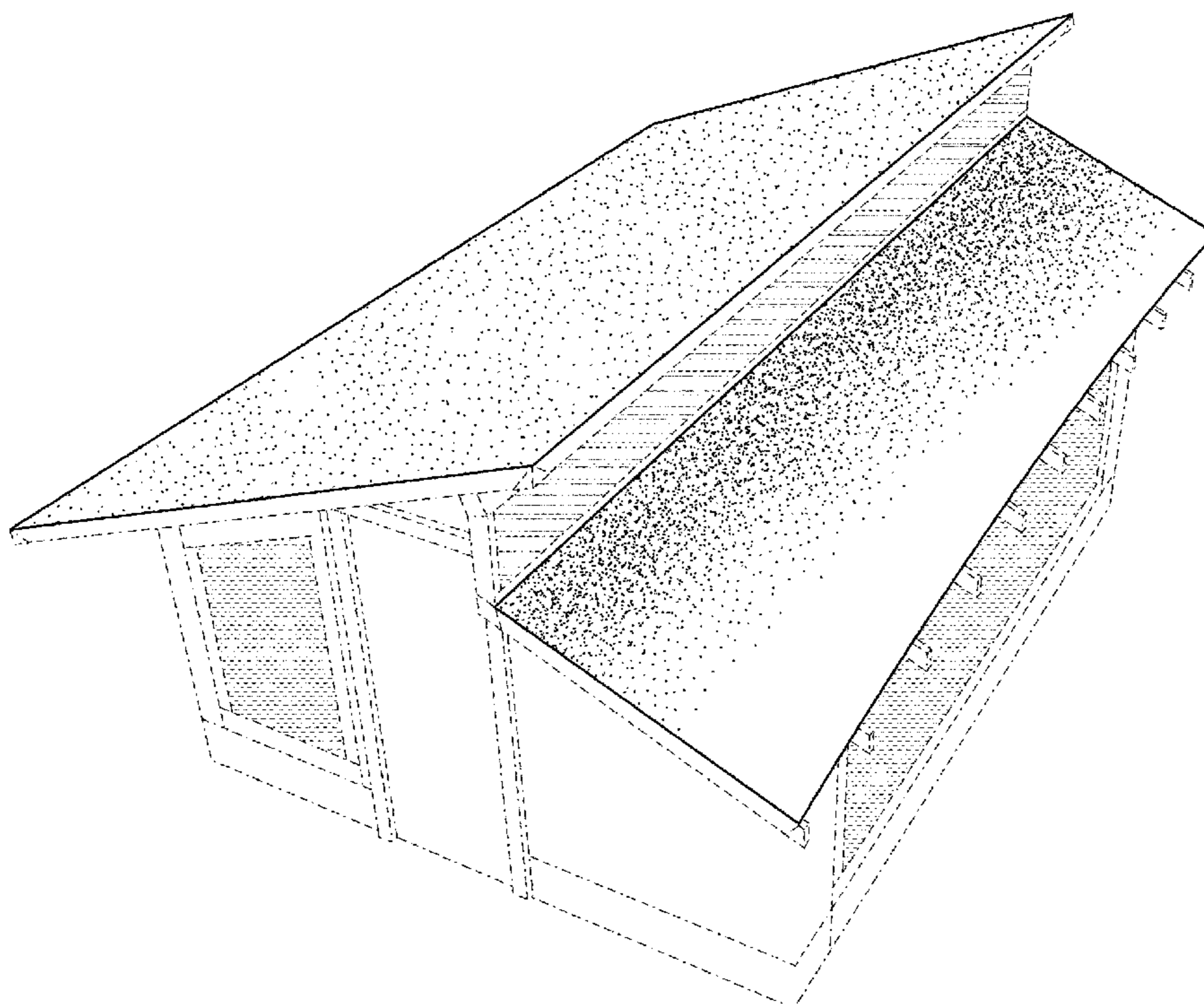

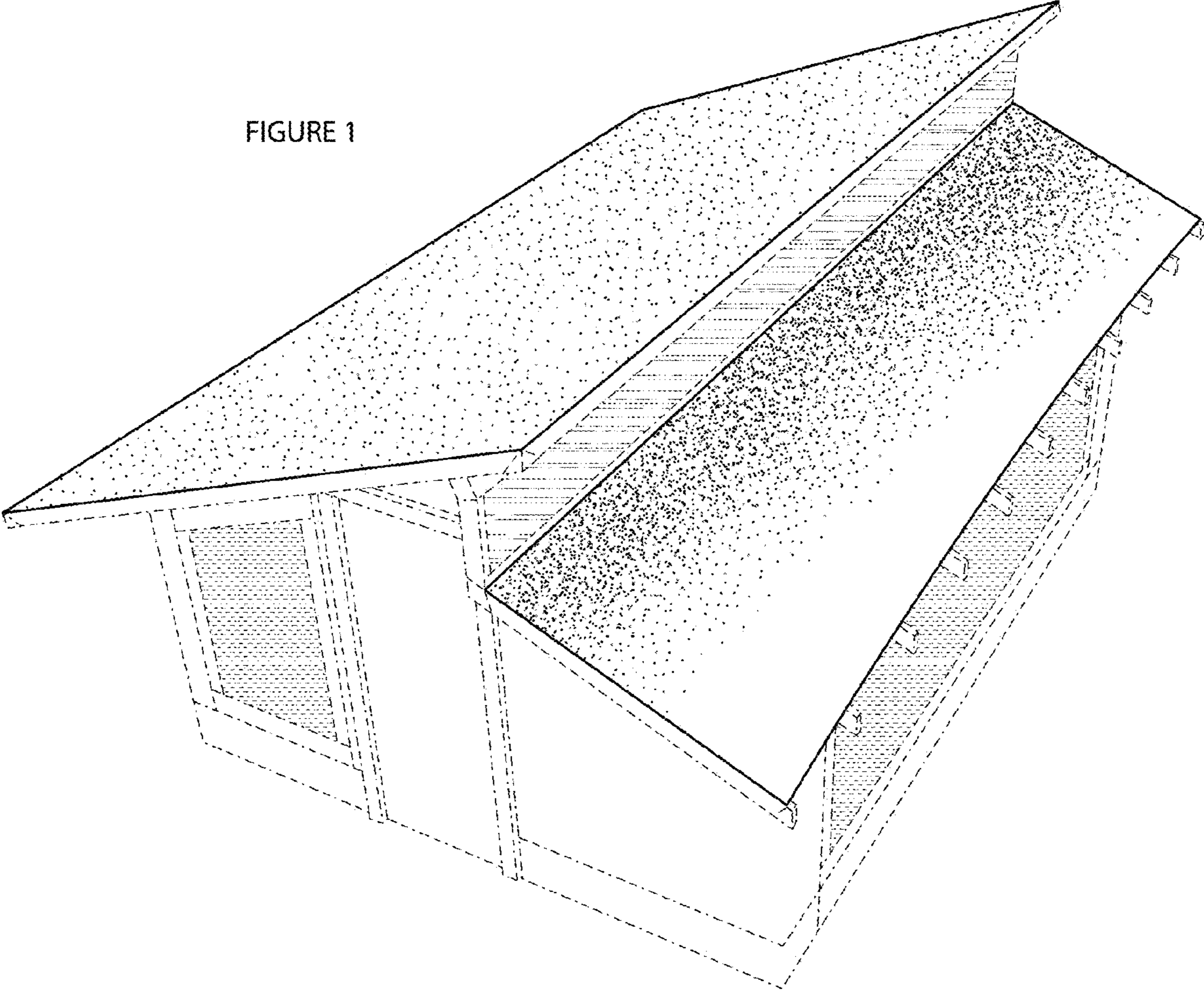

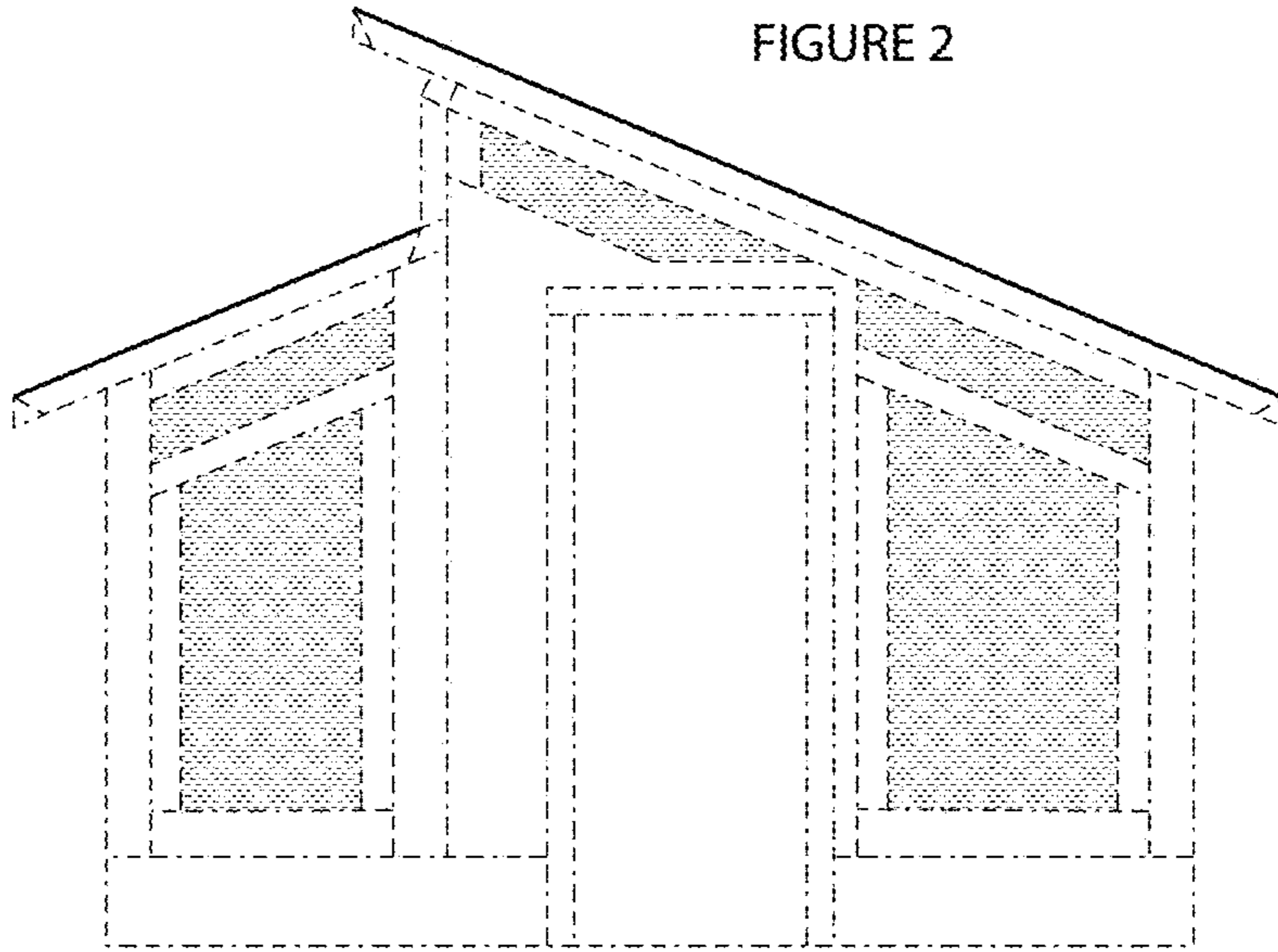

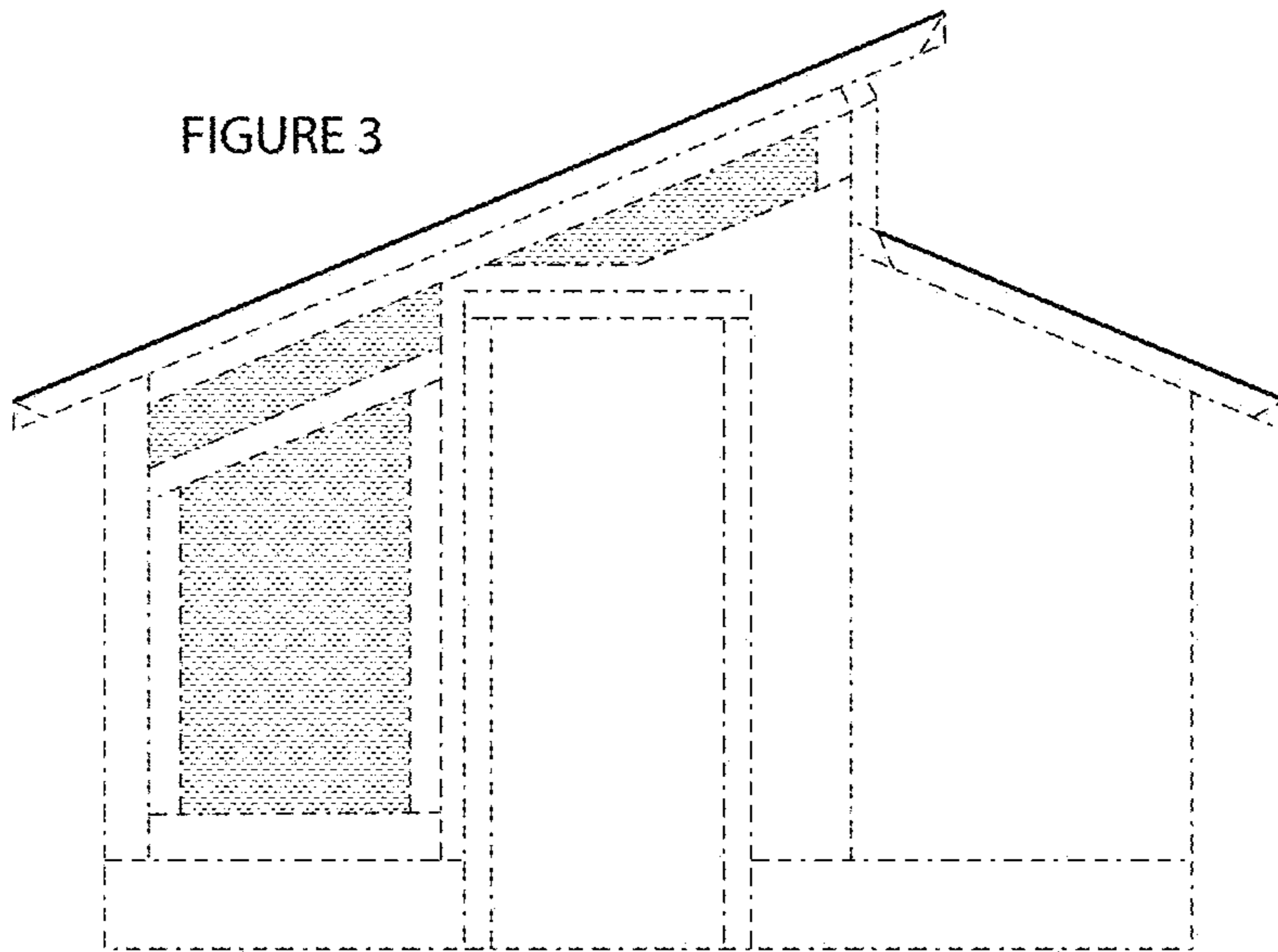

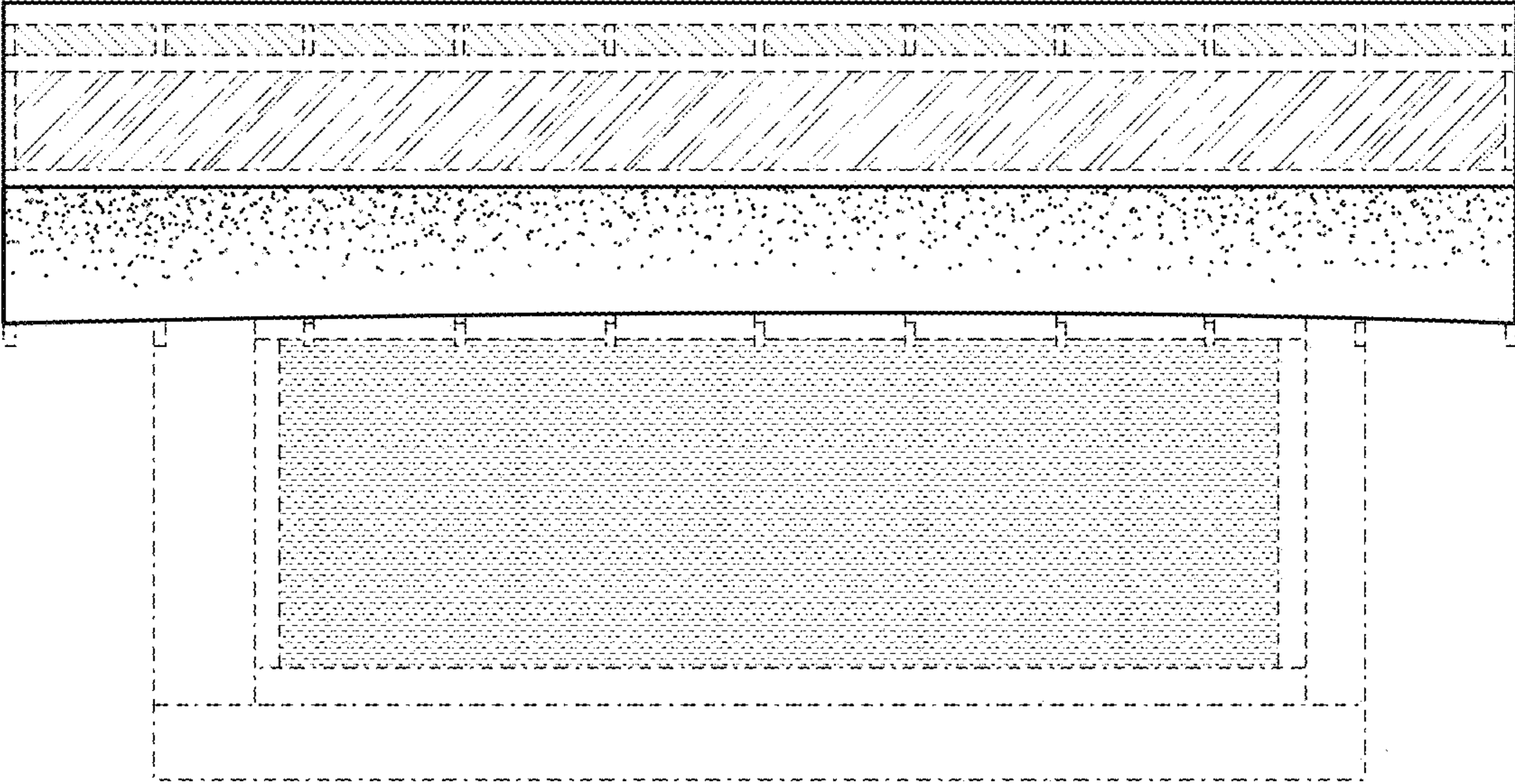

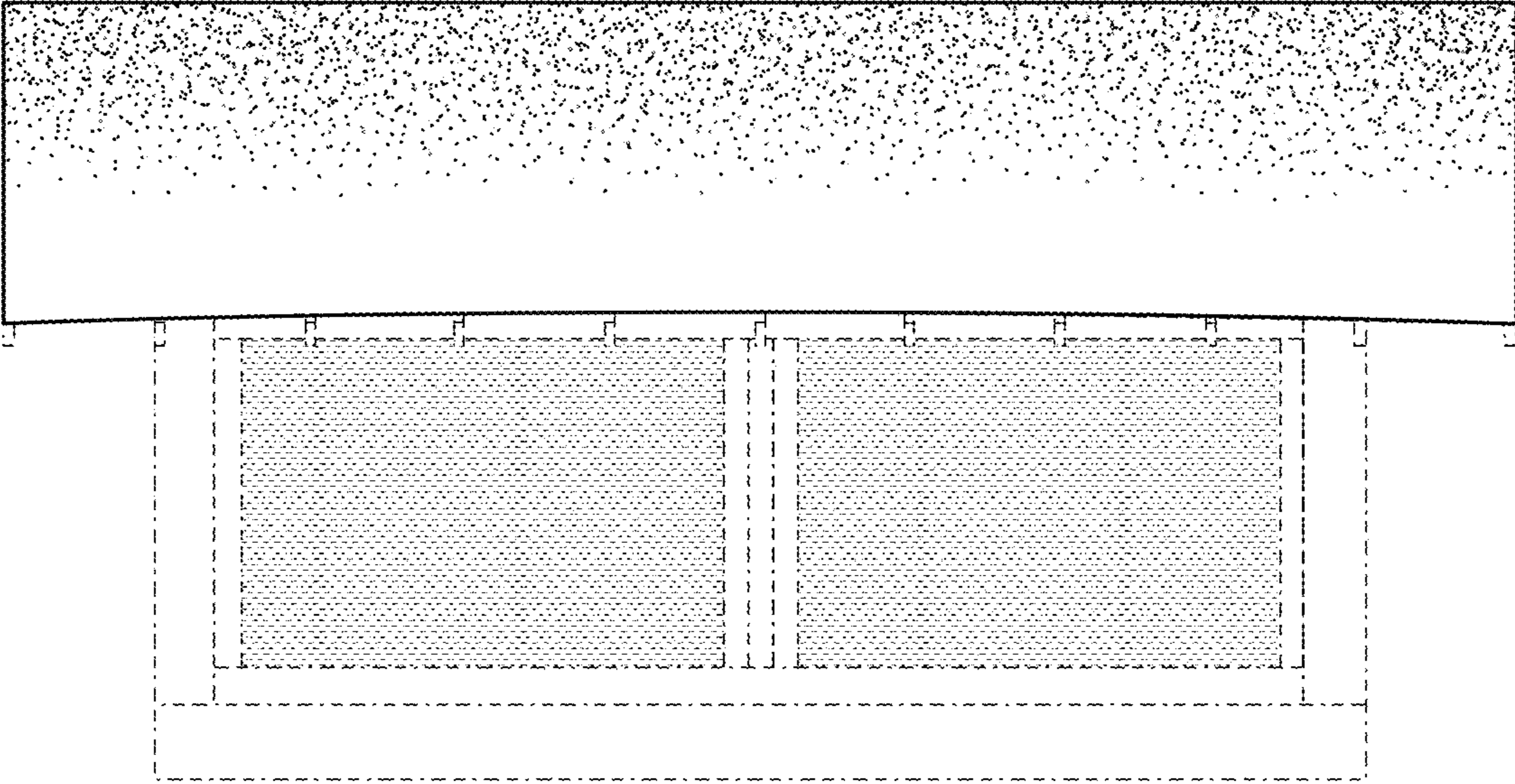
