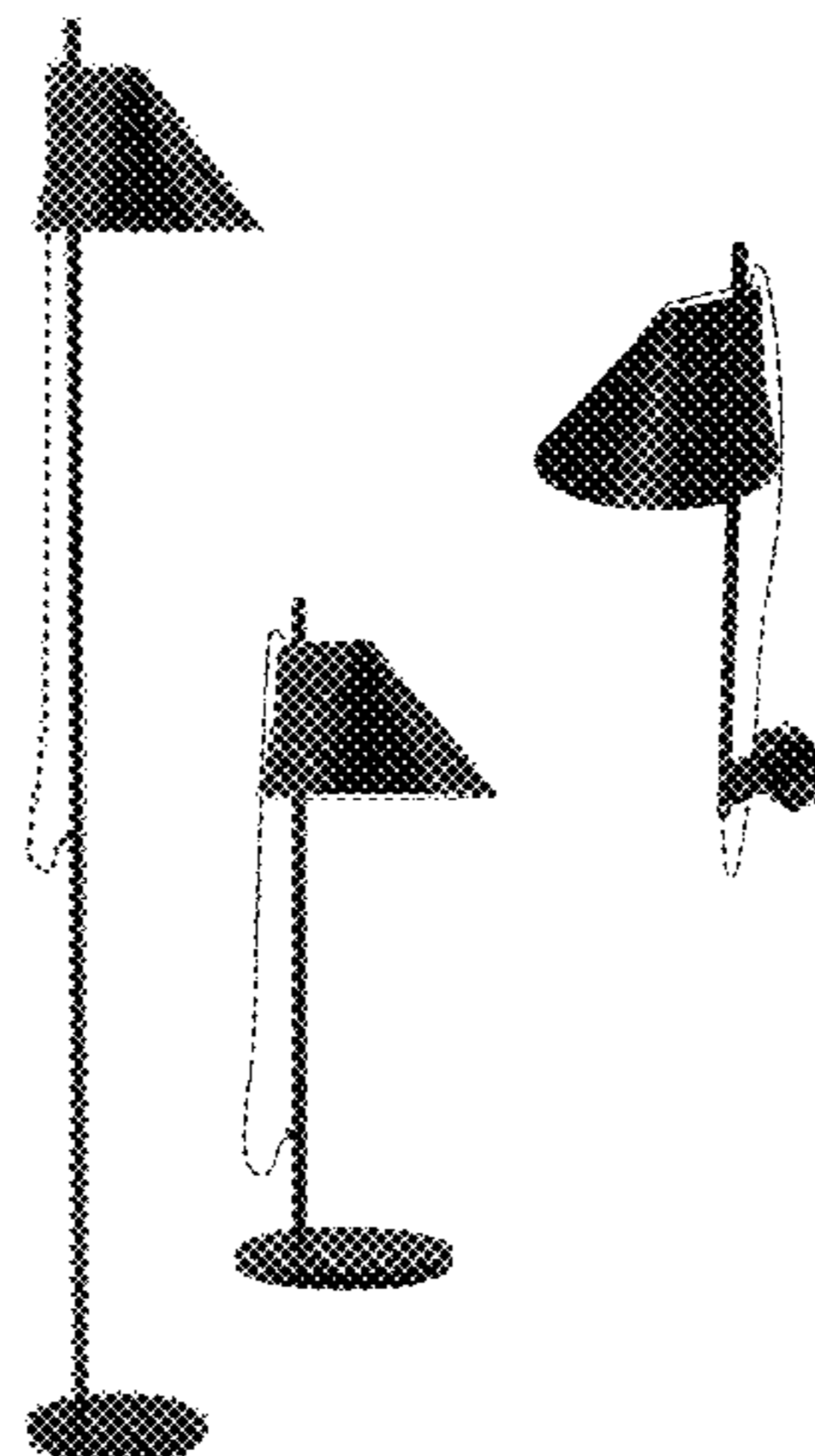


Figure 2.5 is a top front left-side perspective view of the table lamp element of the design of Figure 1.0 shown removed from the ensemble for clarity of disclosure;

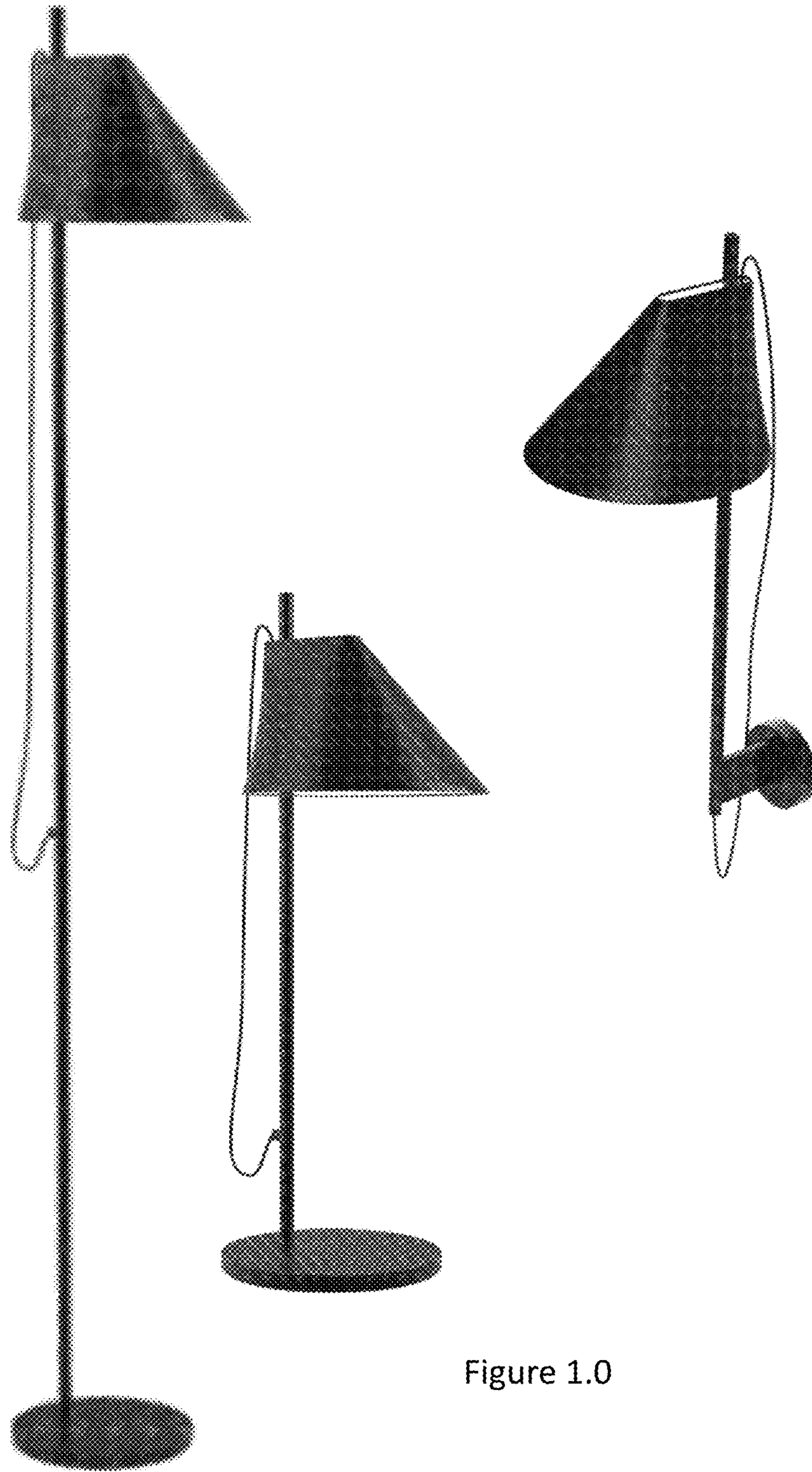

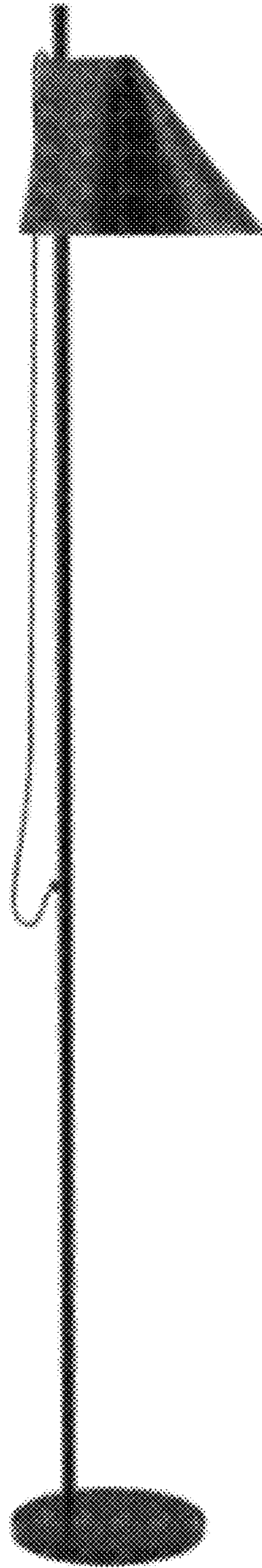

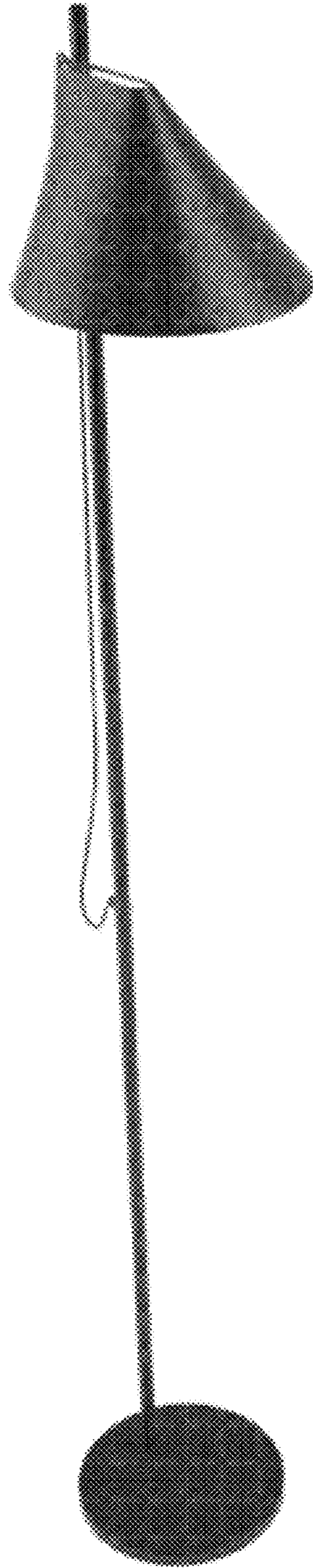

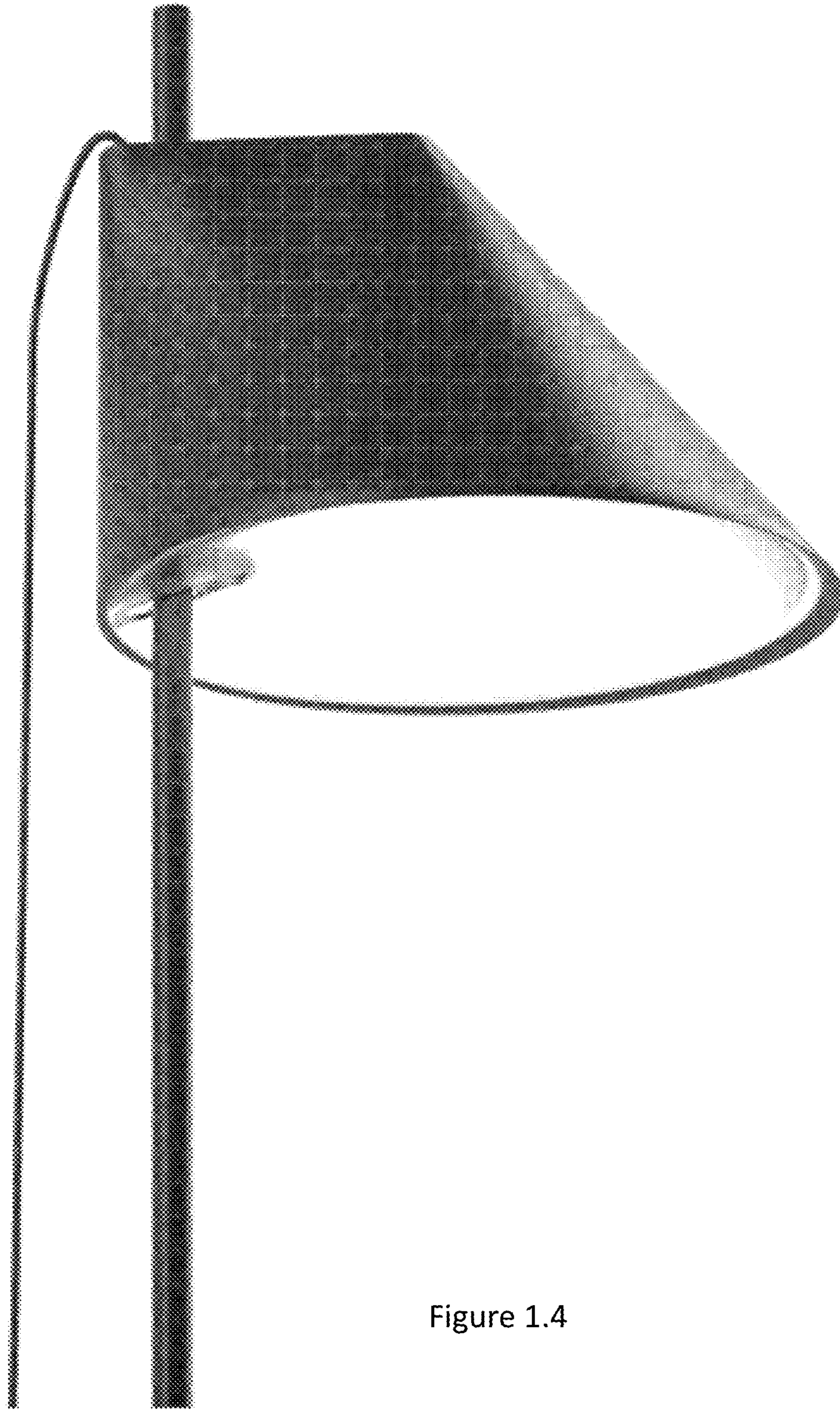

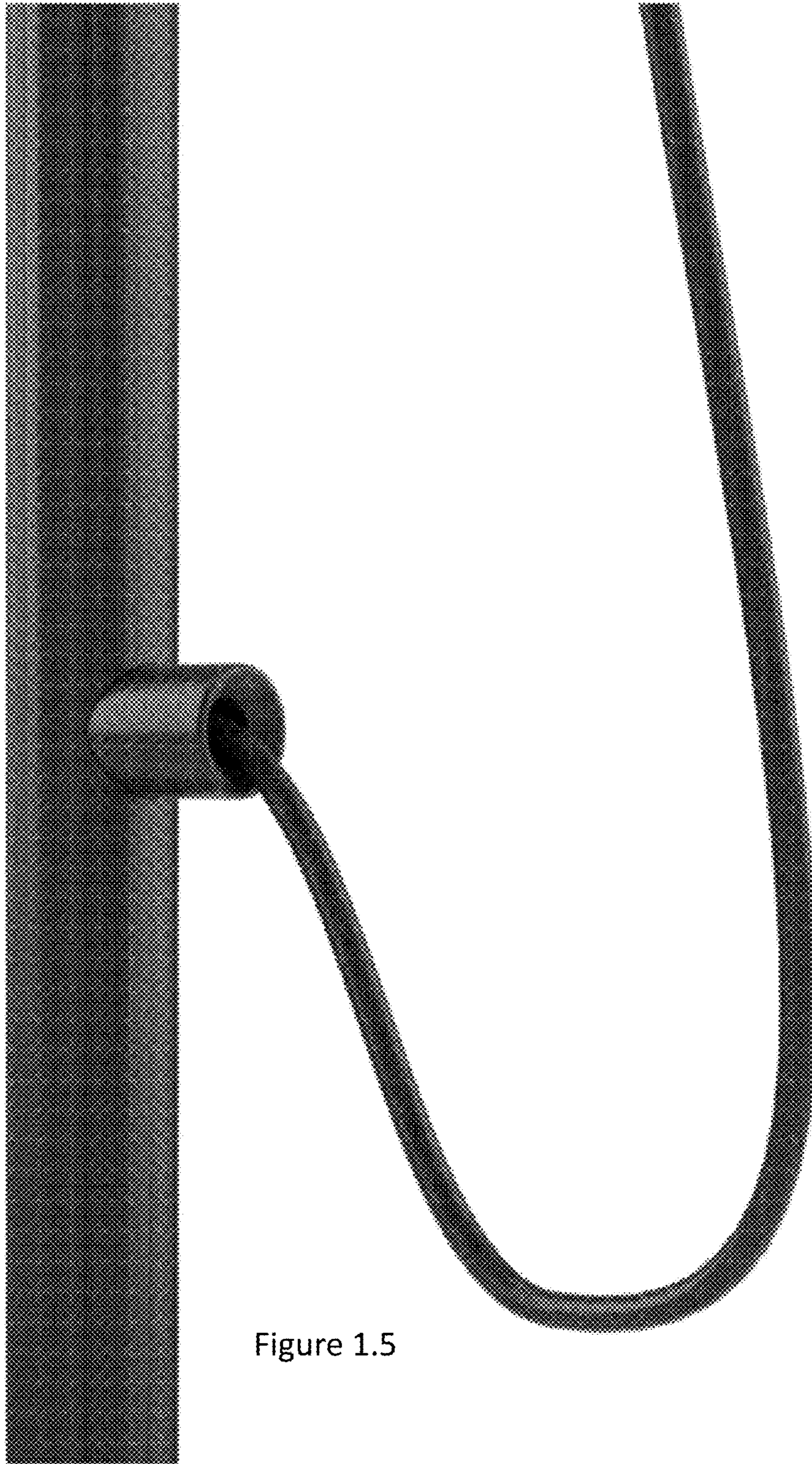

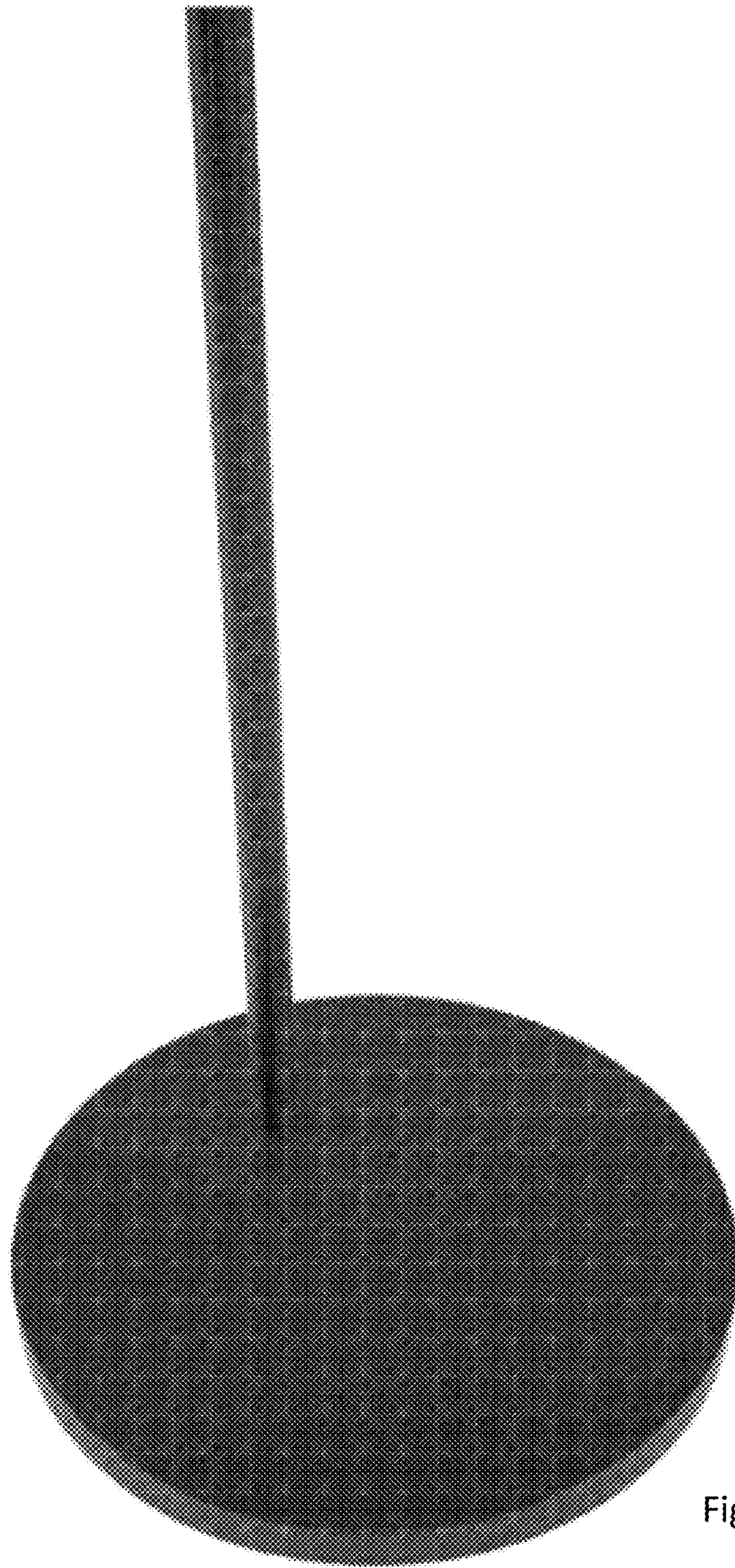

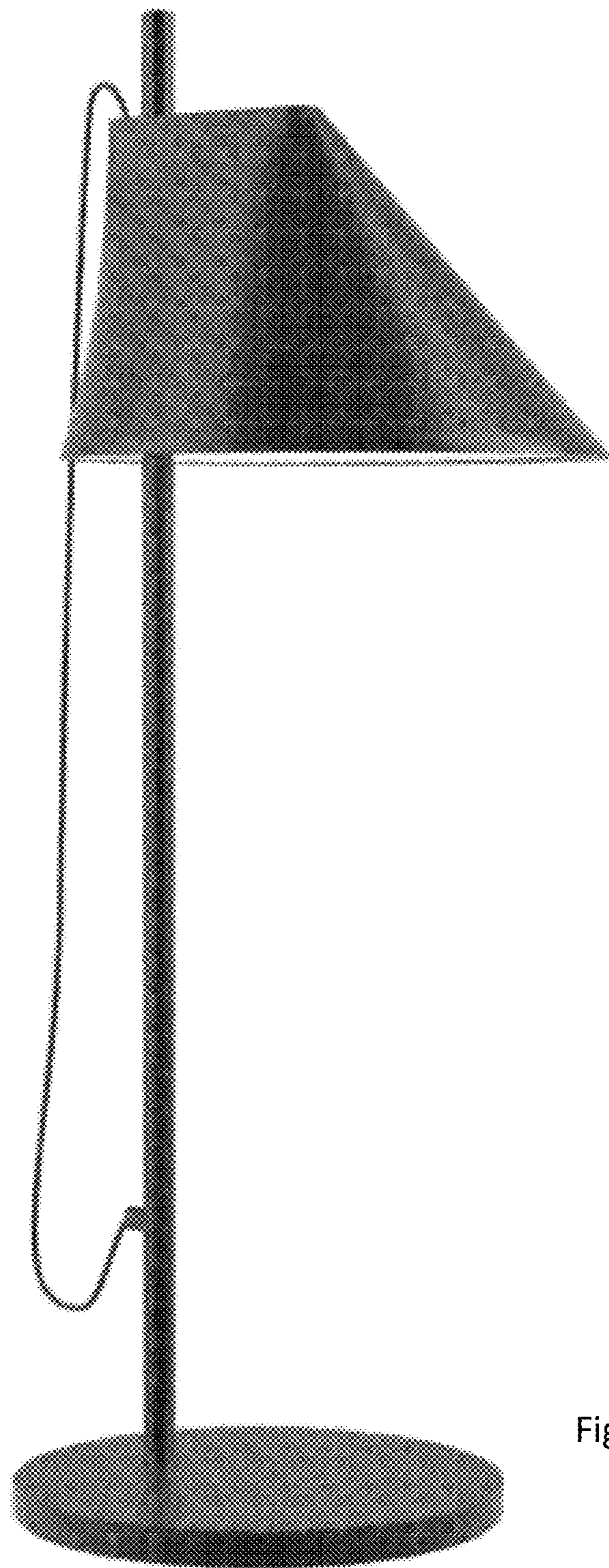

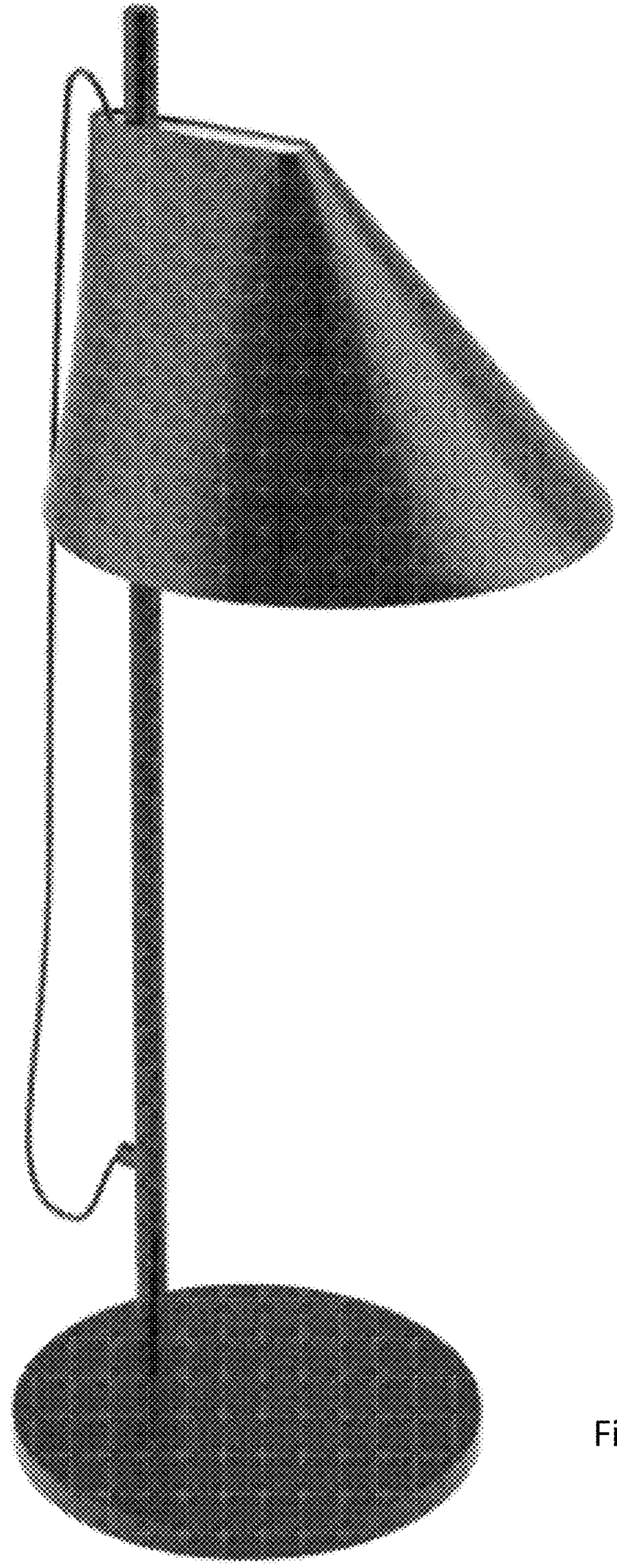

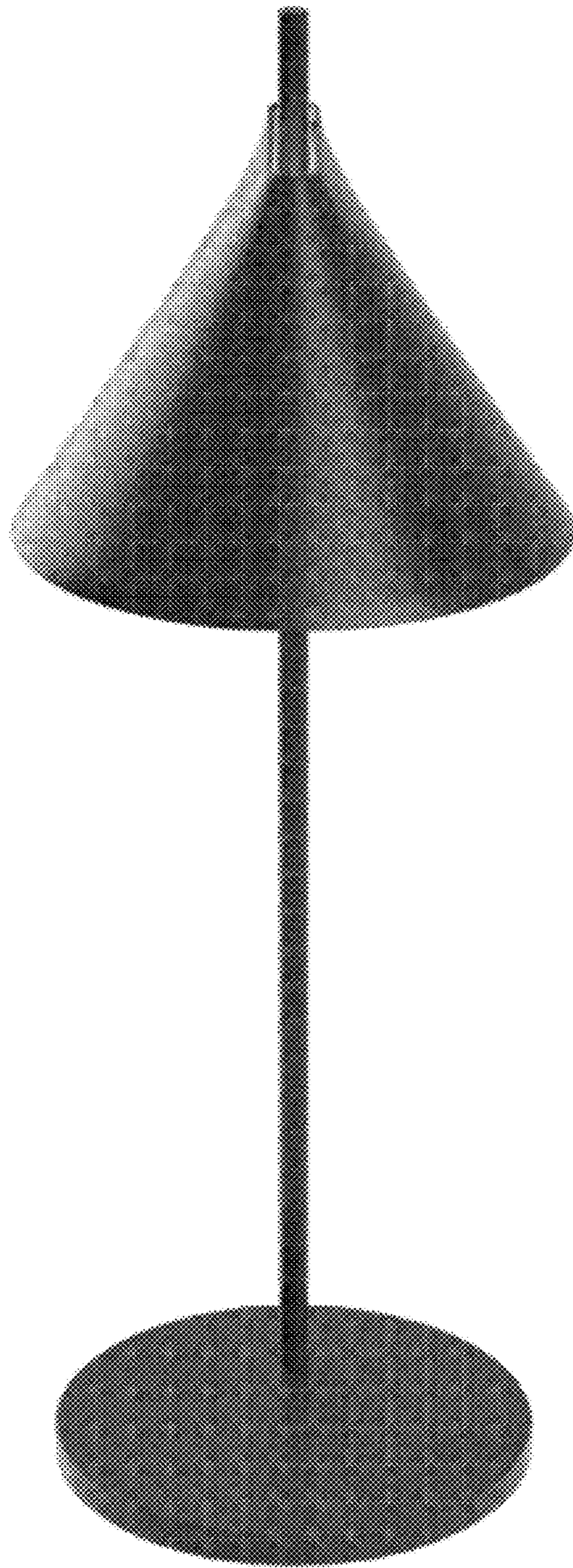

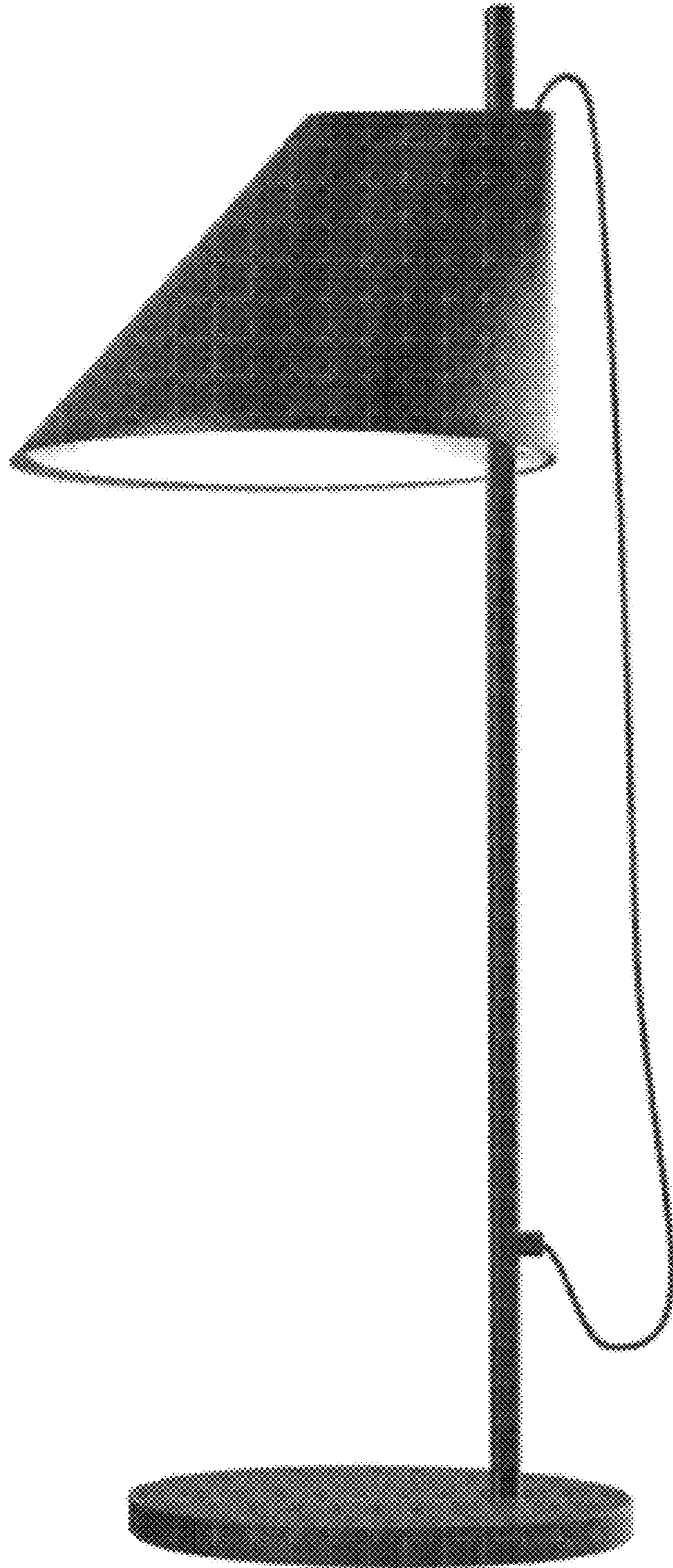

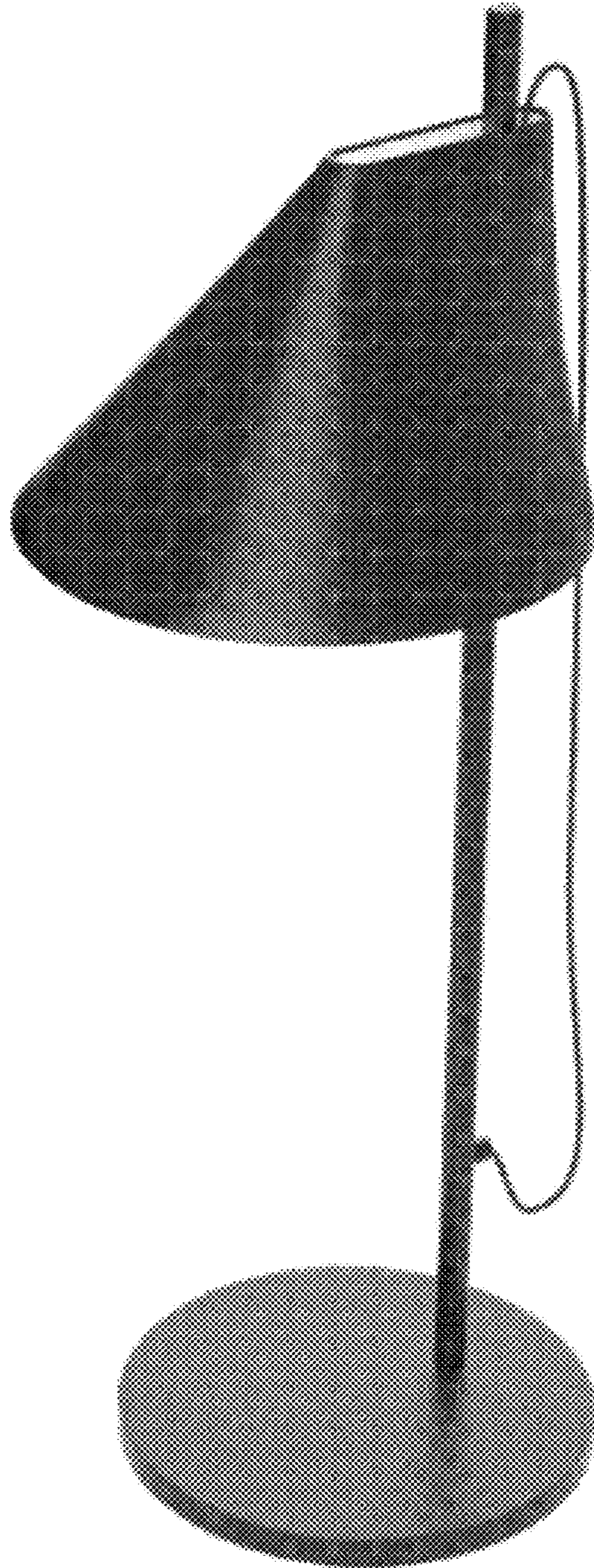

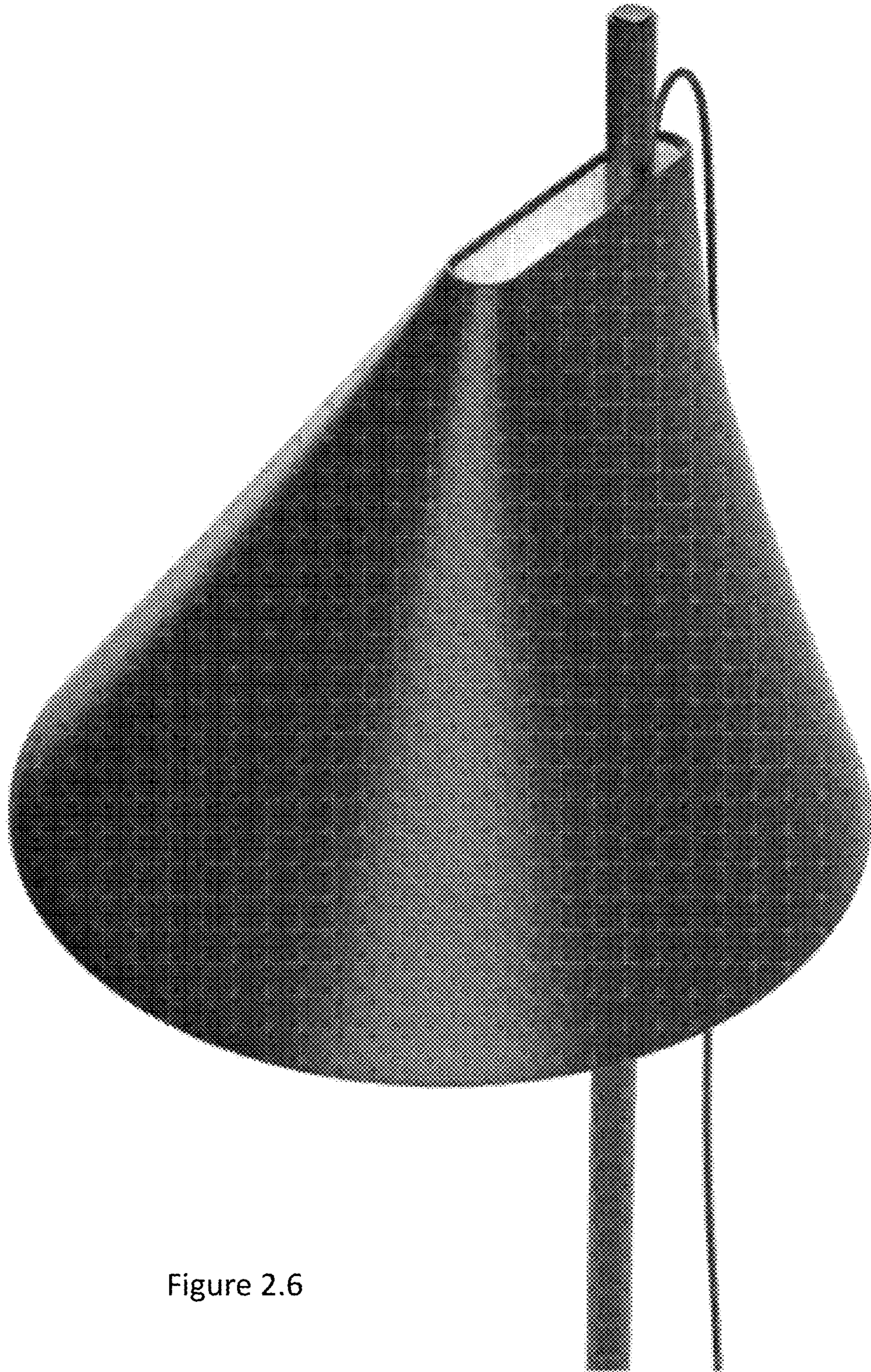

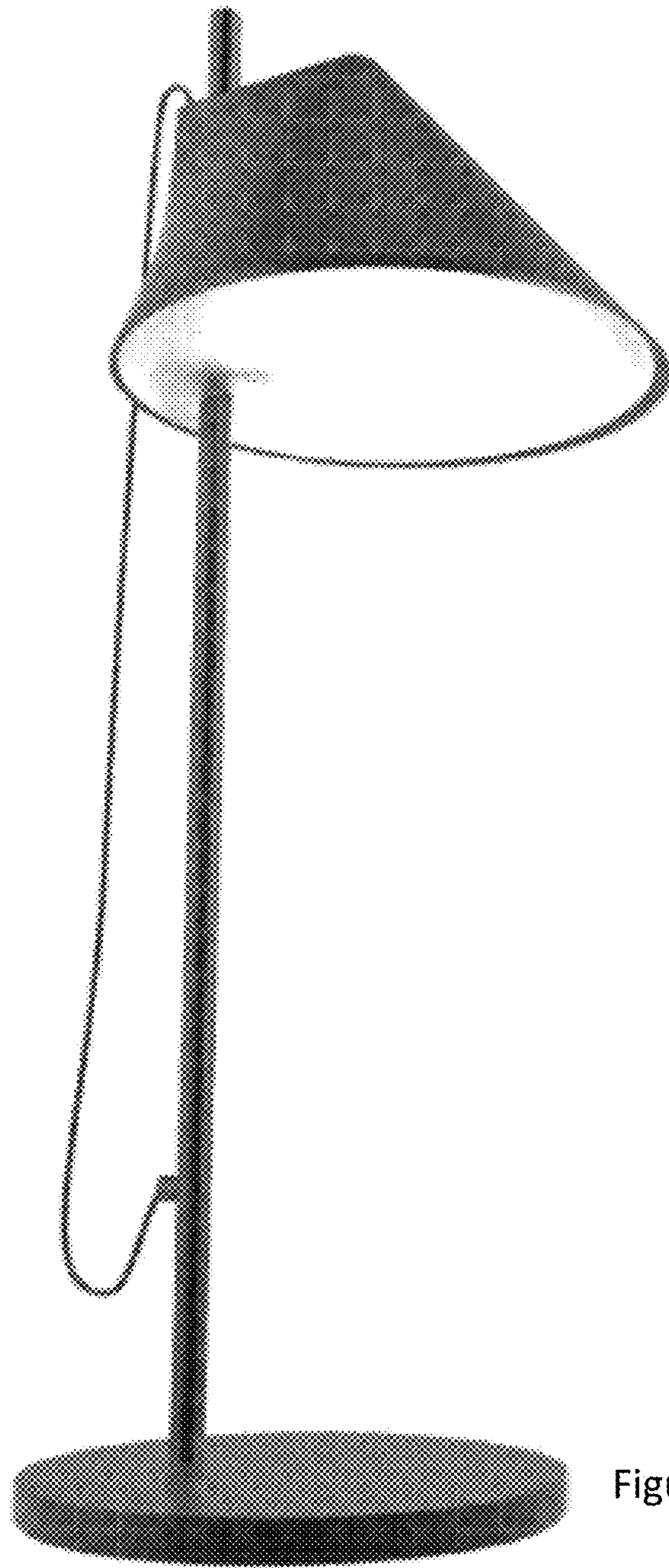

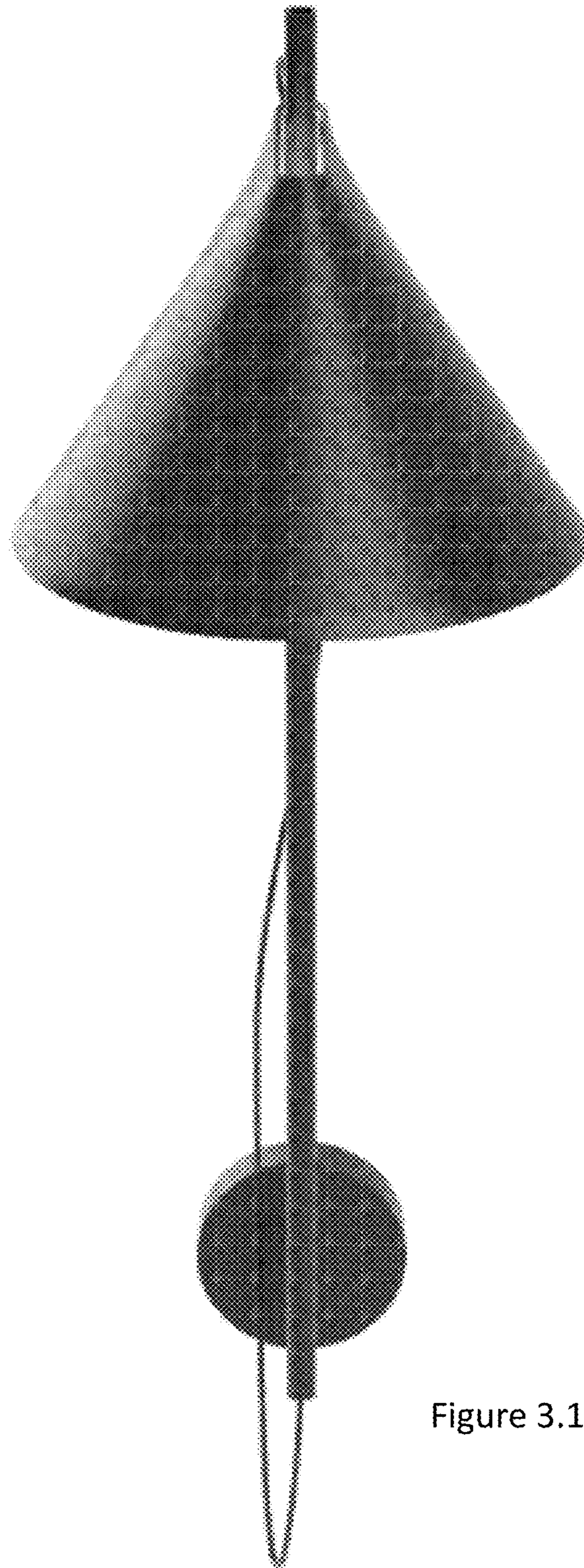

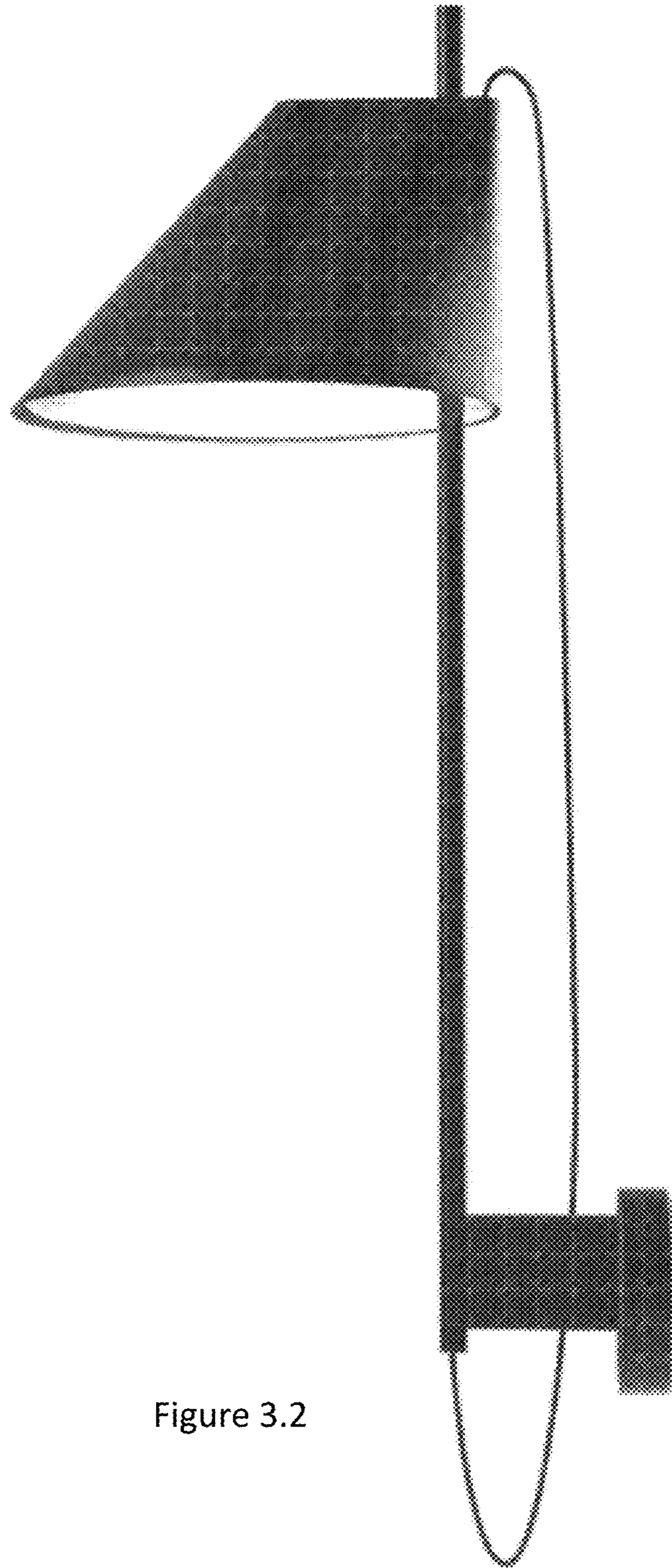

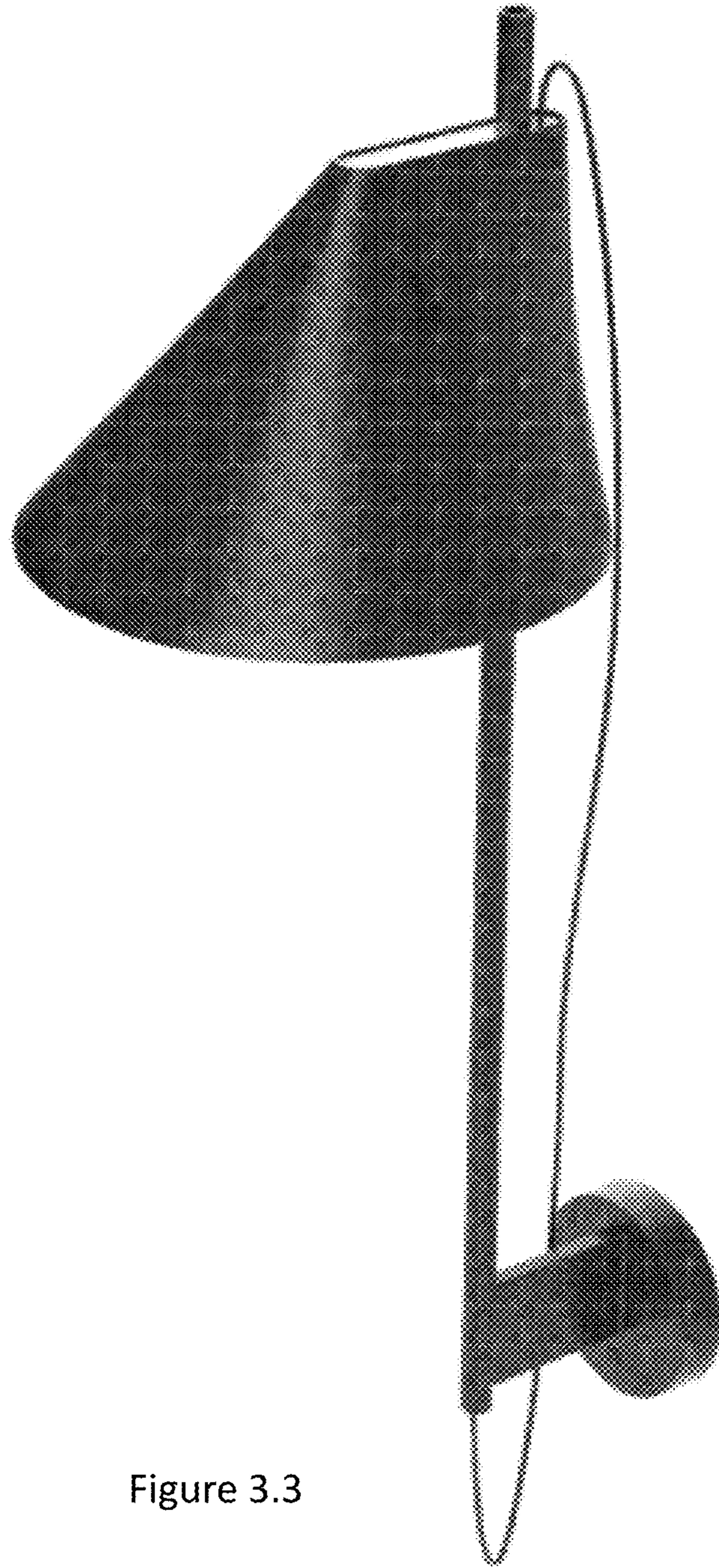

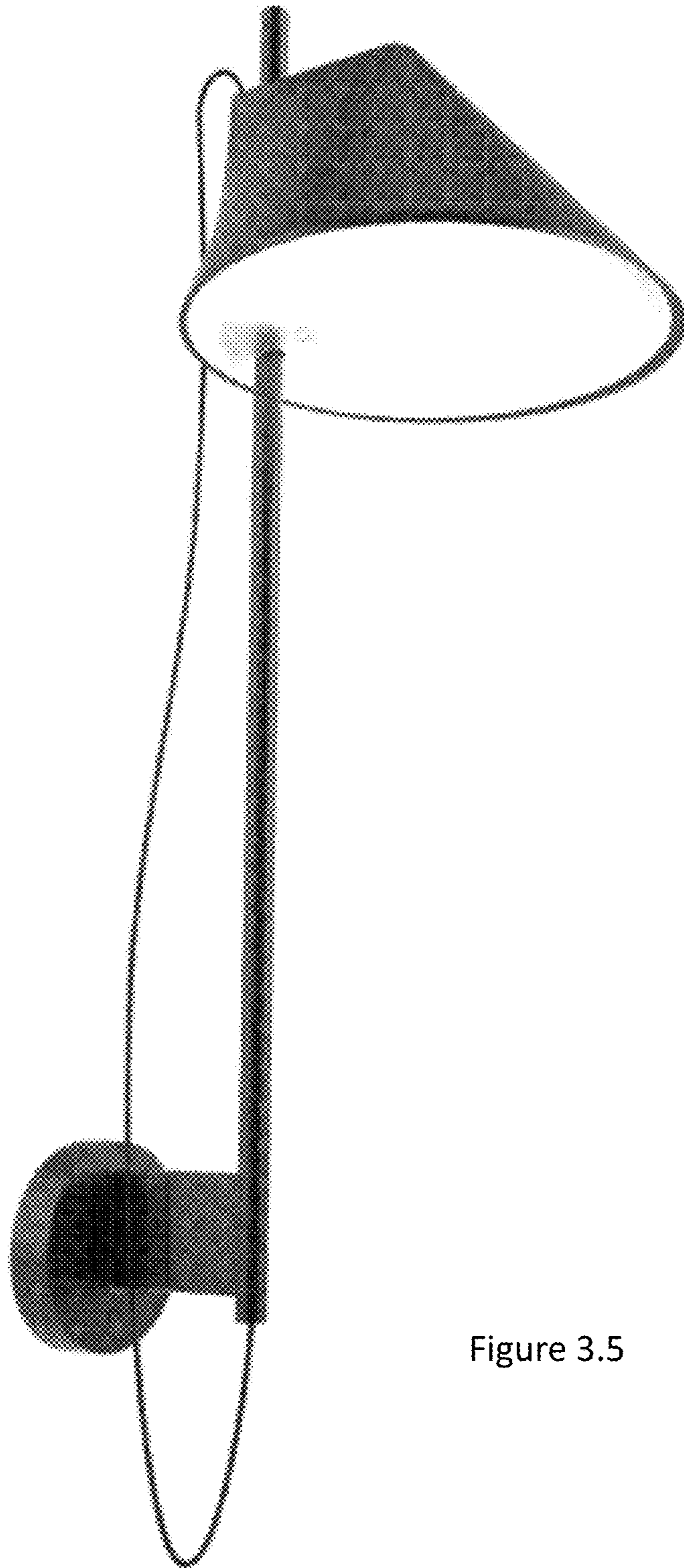

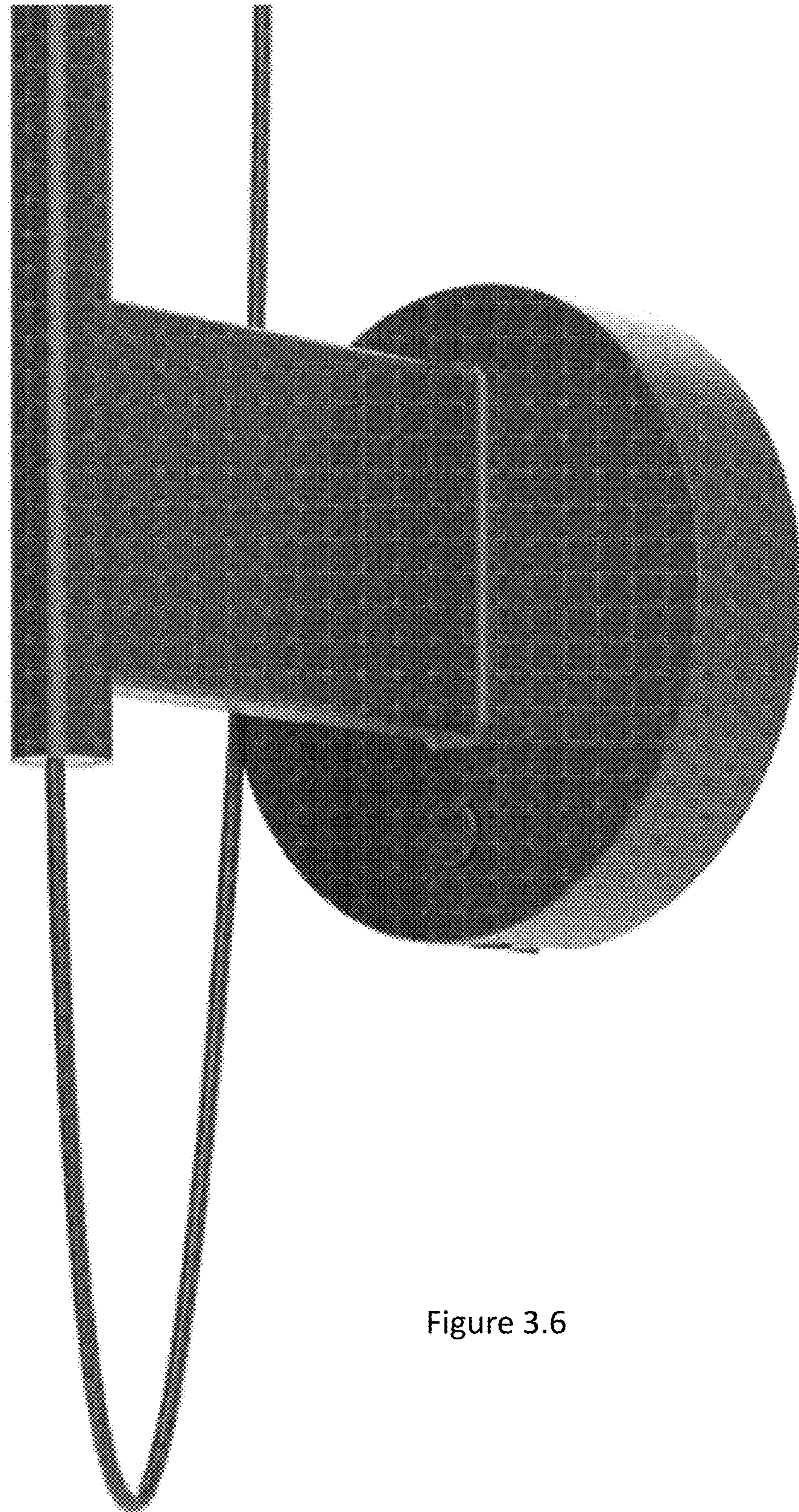
