(57) **CLAIM**

The ornamental design for a rear combination lamp for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a rear combination lamp for an automobile showing our new design;

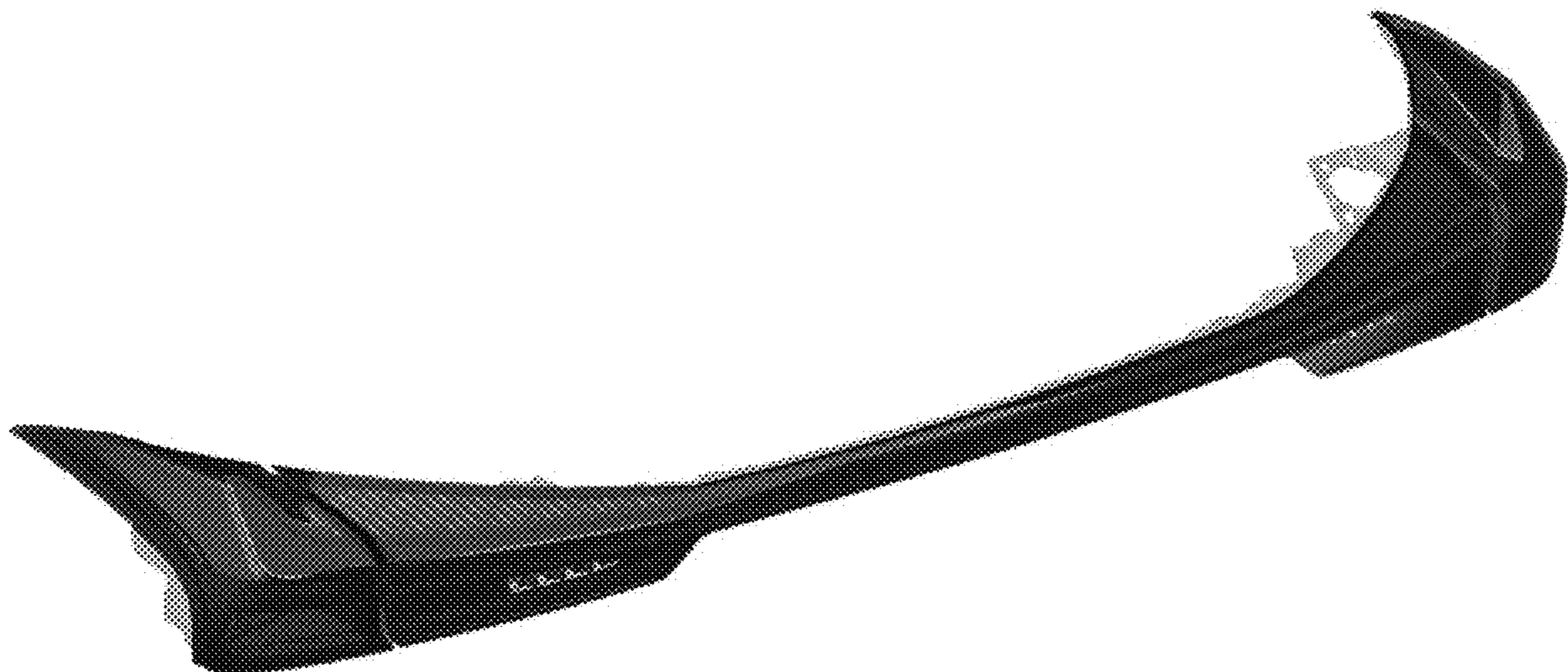

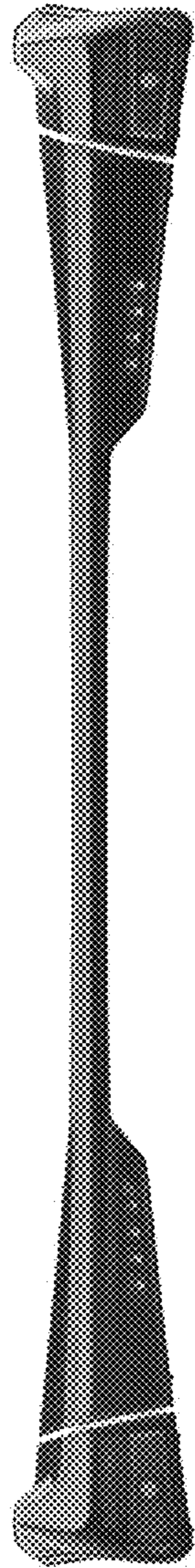

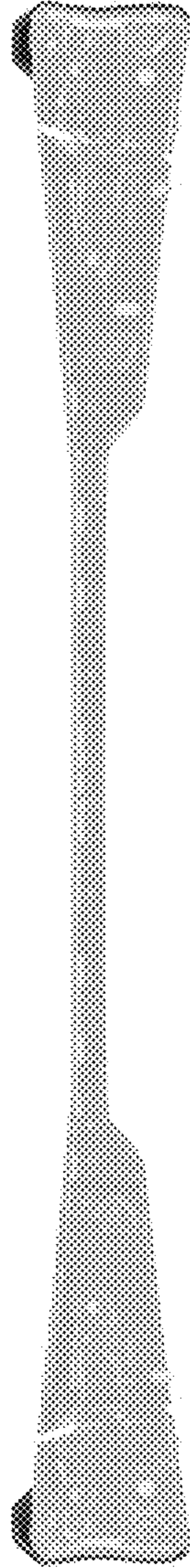

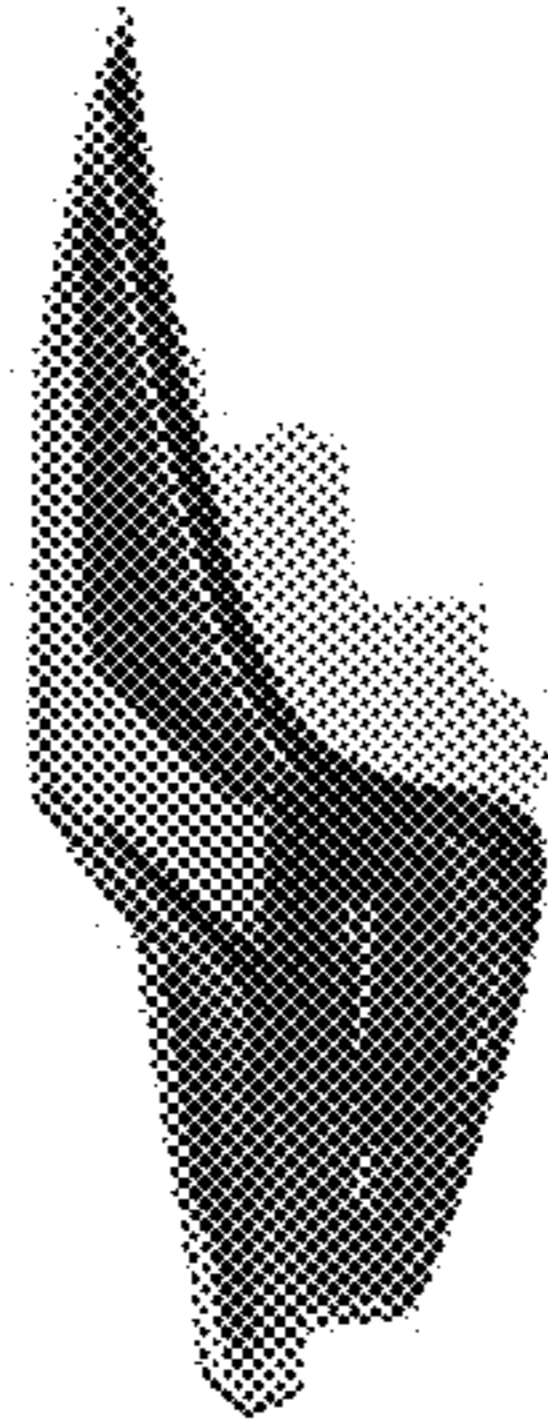

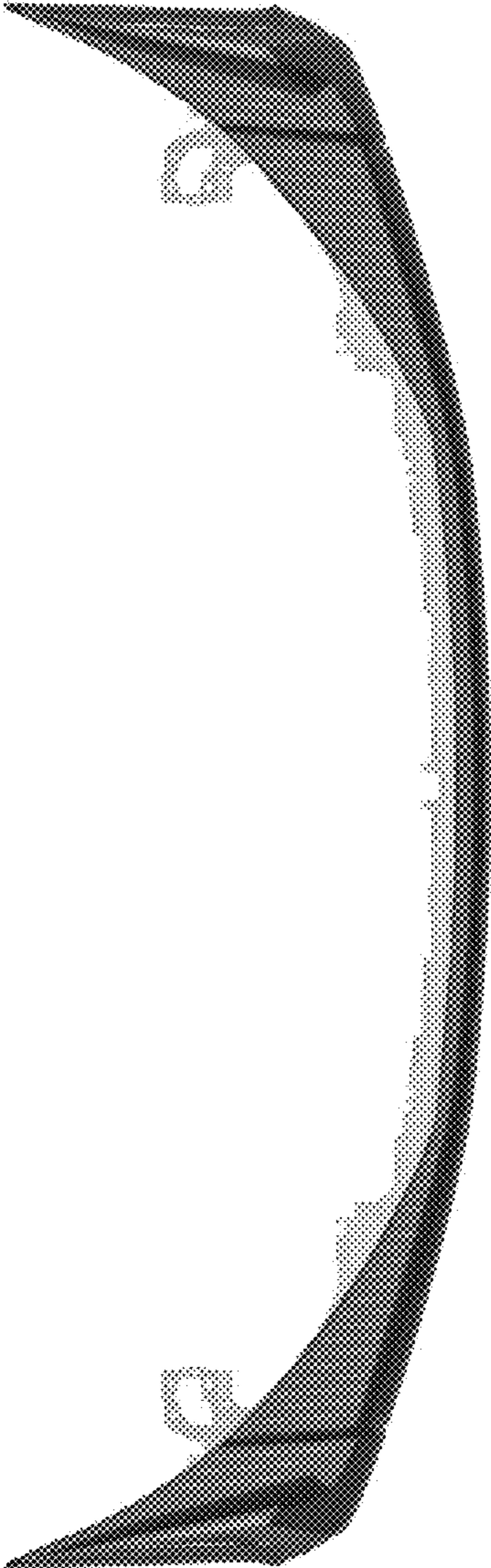

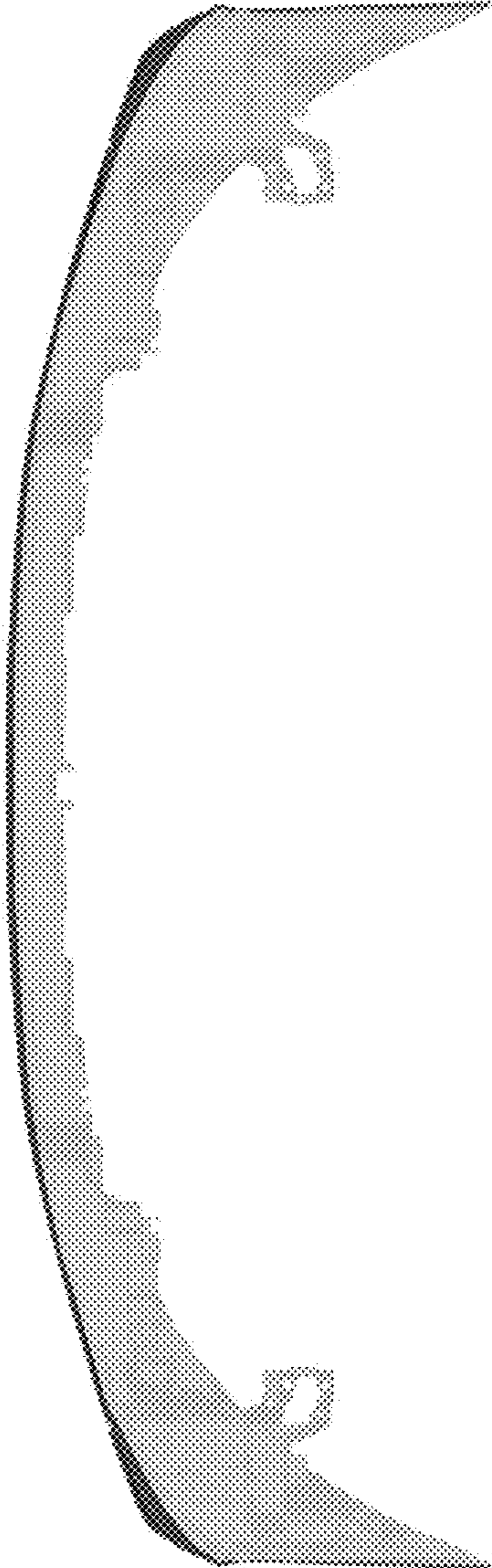
