(57) **CLAIM**

I claim the ornamental design for an antenna whip light, as shown and described.

DESCRIPTION

FIG. 1 is a Perspective view of an antenna whip light showing my new design;

FIG. 2 is a Front view of the antenna whip light as shown in FIG. 1;

FIG. 3 is a Back view of the antenna whip light as shown in FIG. 1;

FIG. 4 is a Left-side view of the antenna whip light as shown in FIG. 1;

FIG. 5 is a Right-side view of the antenna whip light as shown in FIG. 1;

FIG. 6 is a Top view of the antenna whip light as shown in FIG. 1;

FIG. 7 is a Bottom view of the antenna whip light as shown in FIG. 1; and,

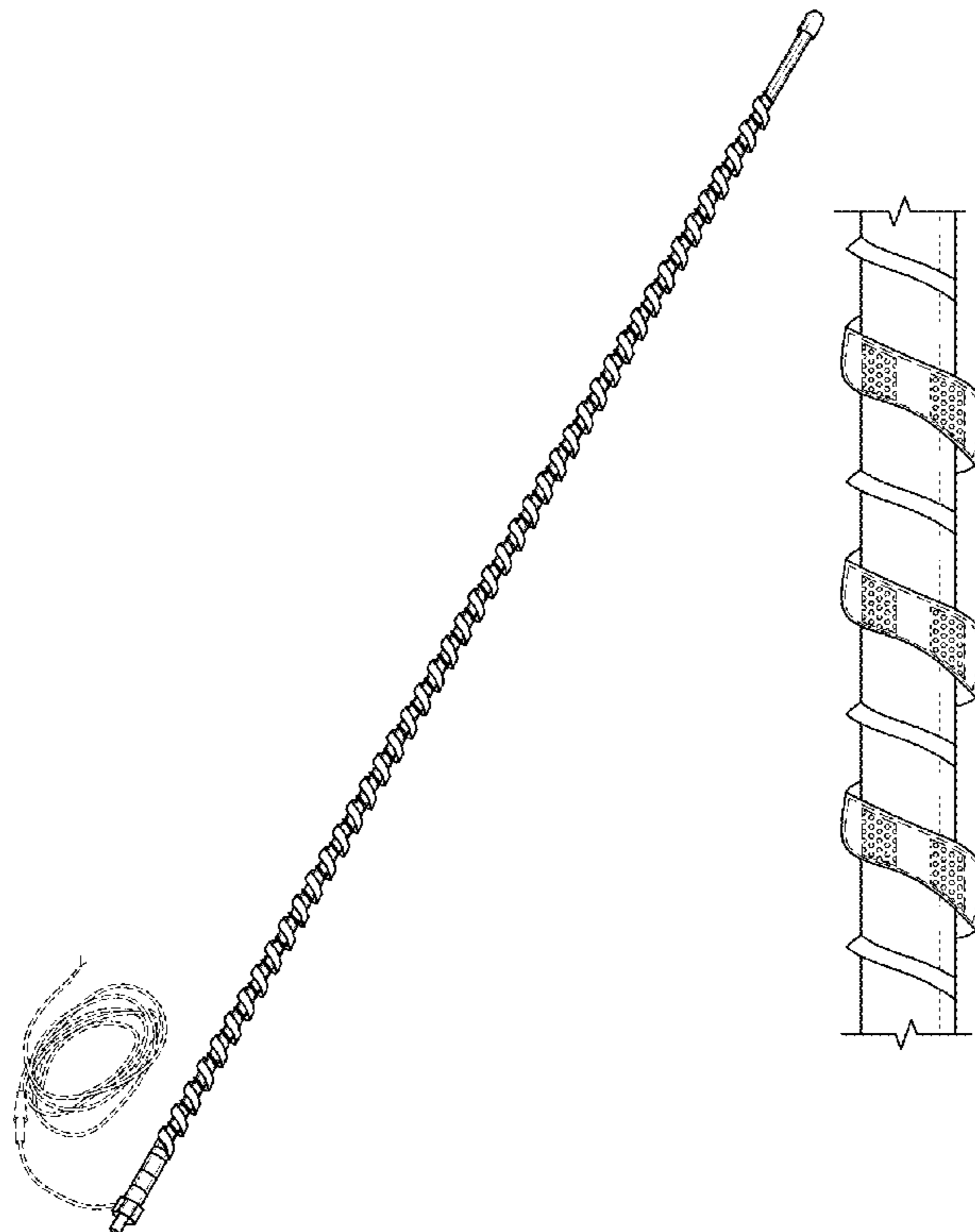

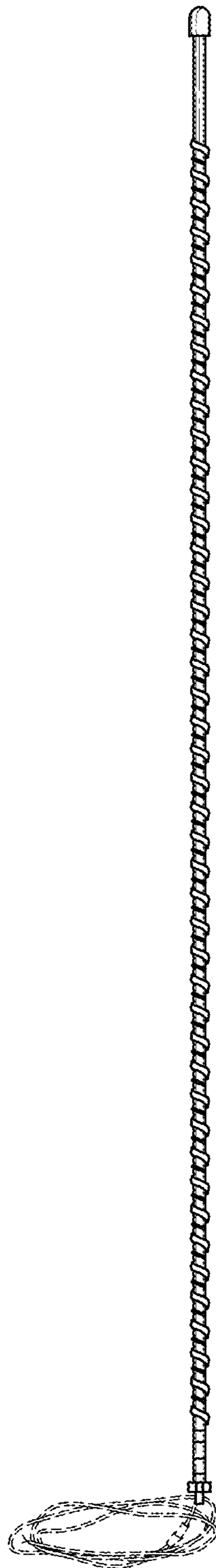

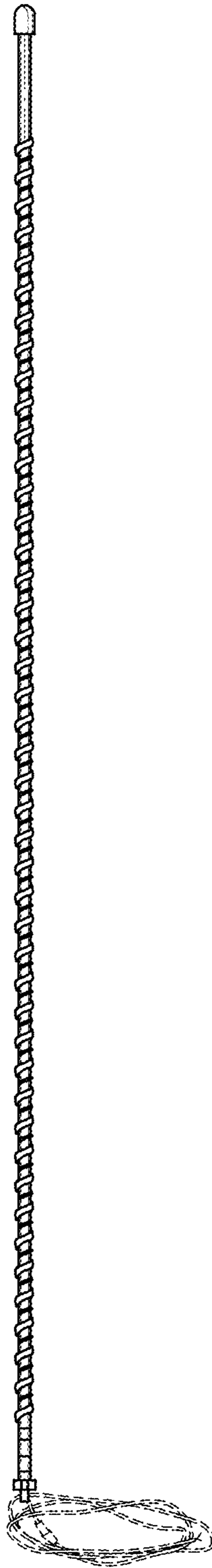

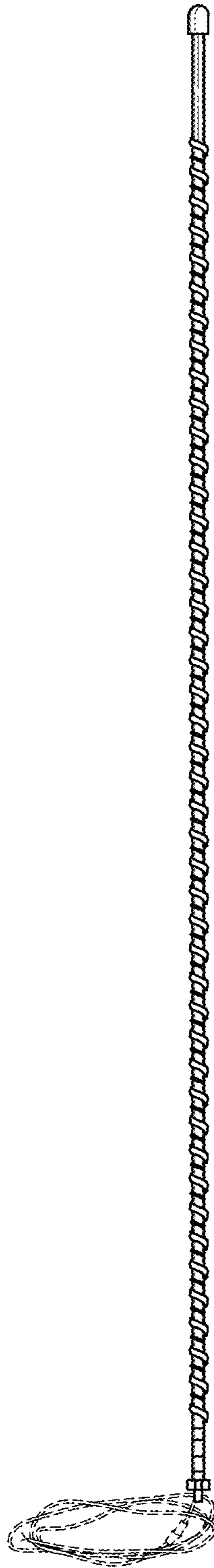

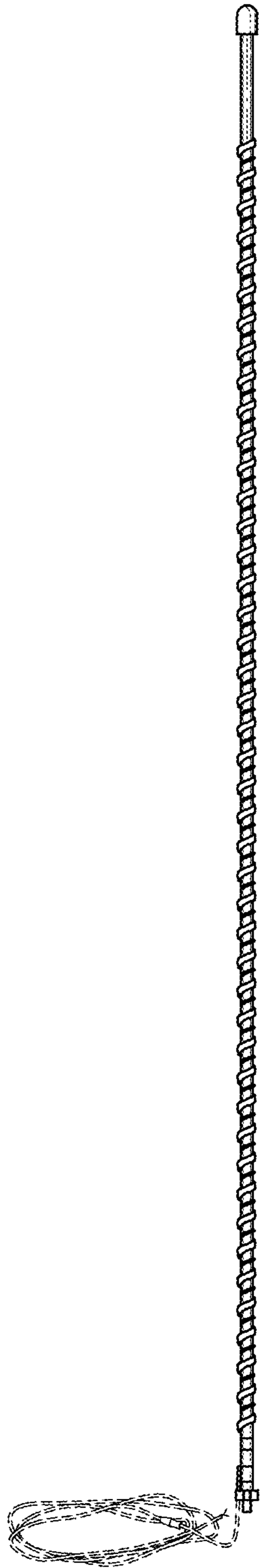

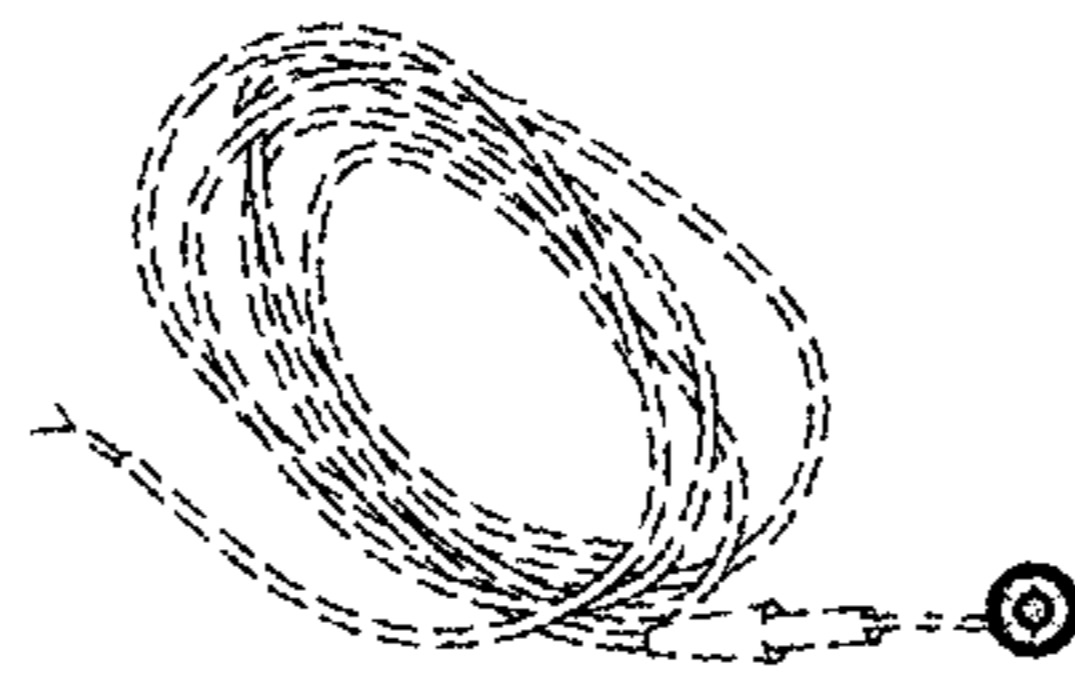

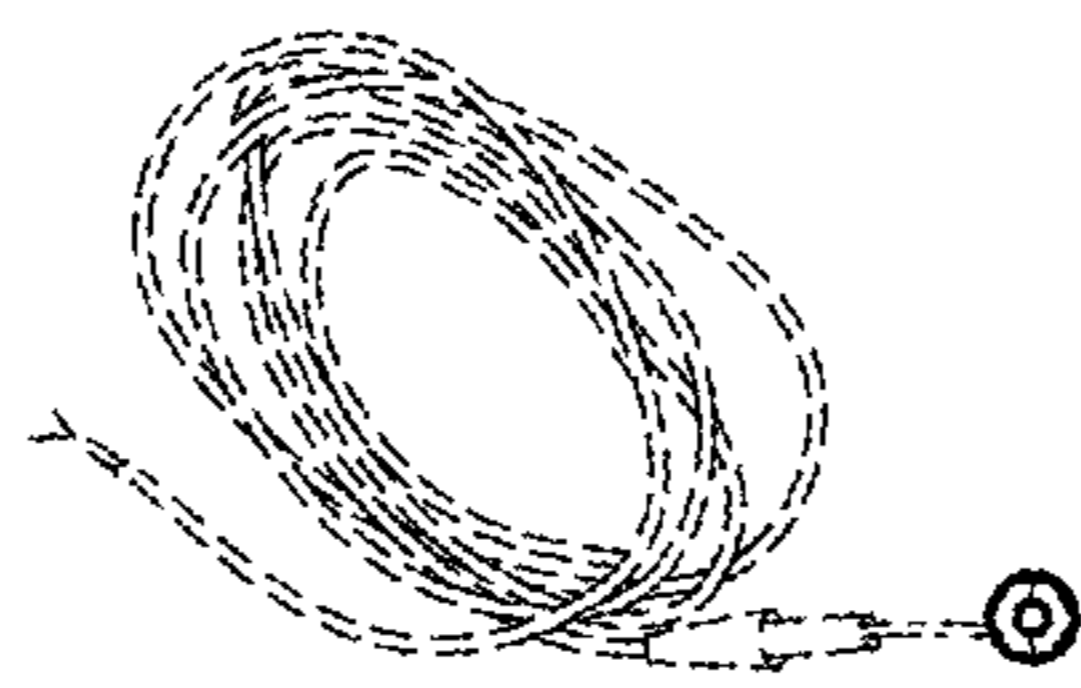

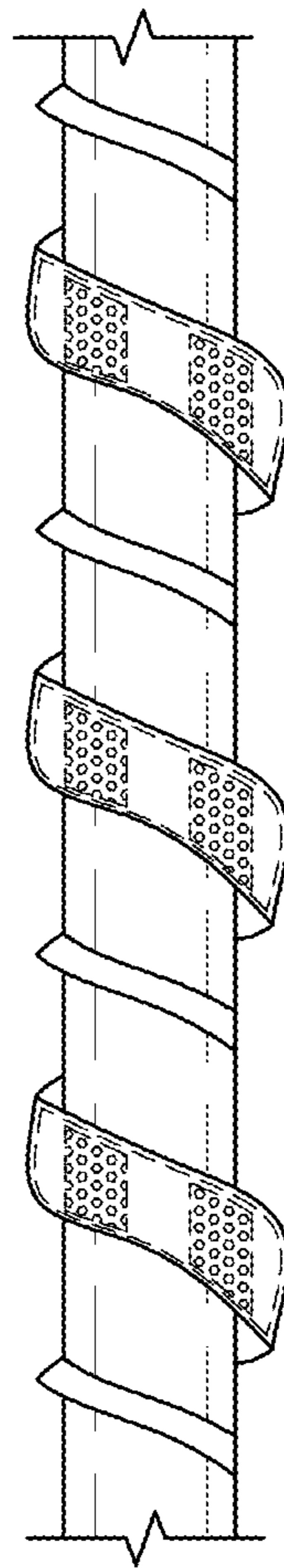
