DESCRIPTION

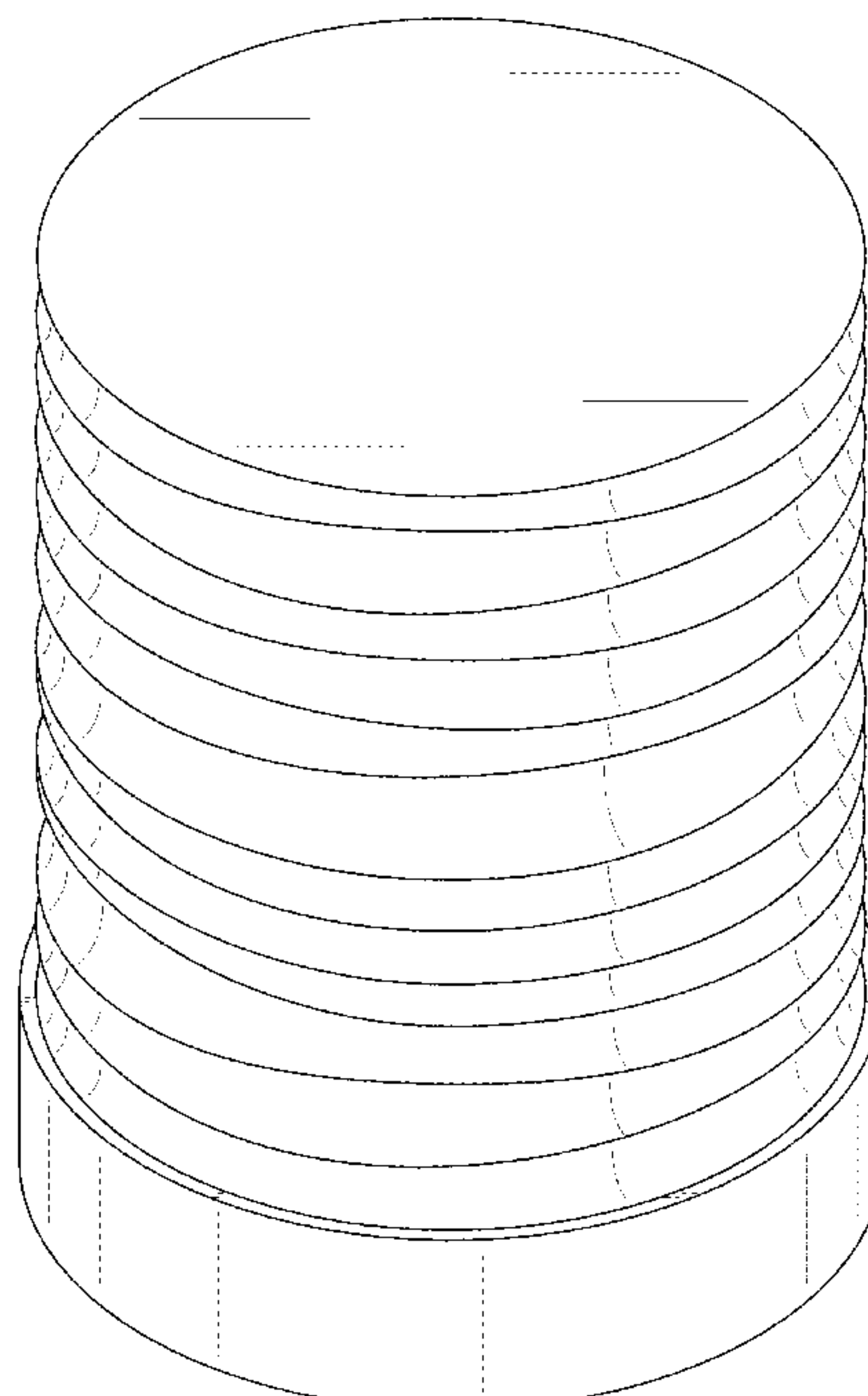
FIG. 1 is a perspective view of a first embodiment of a light trim showing my new design;

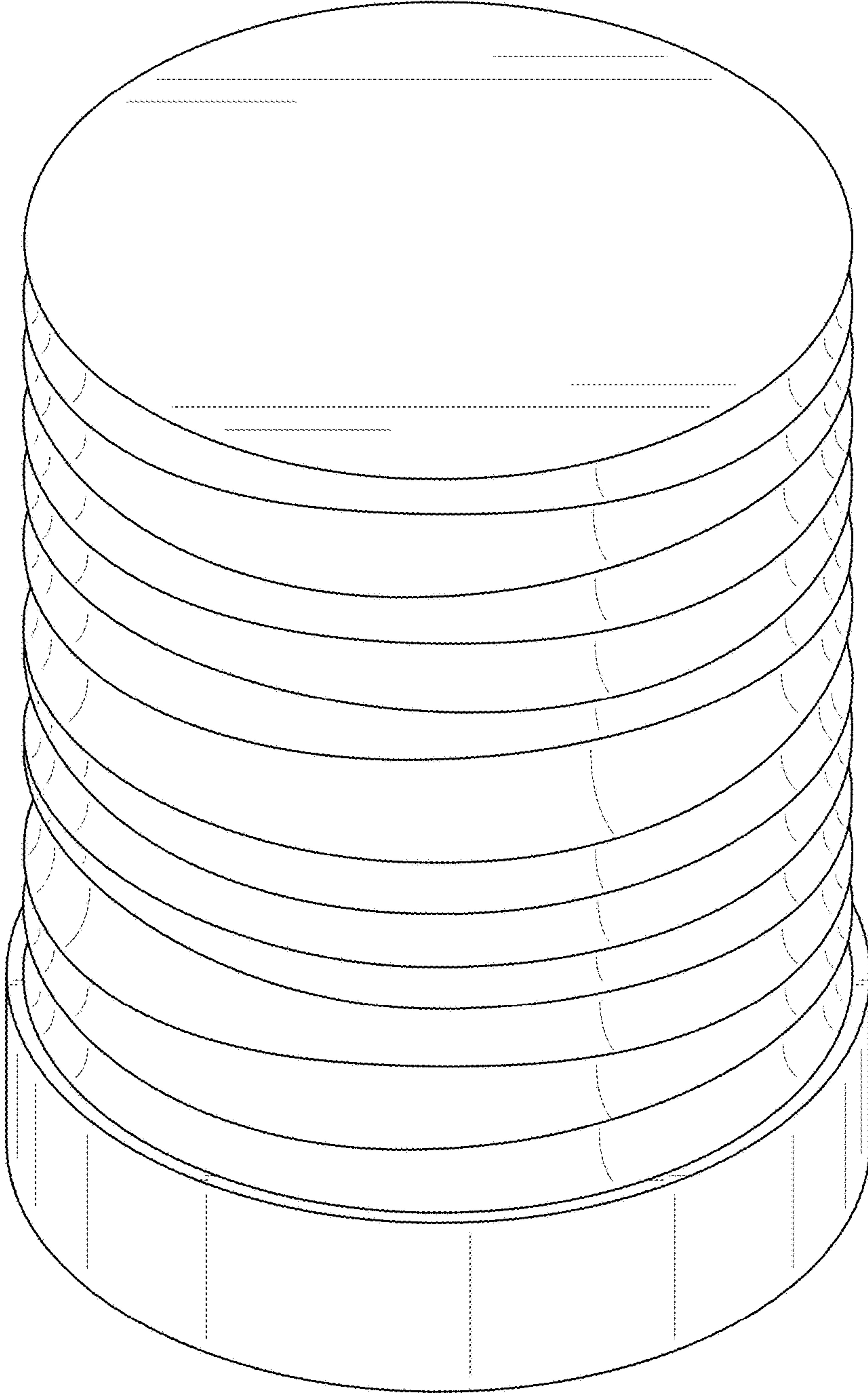

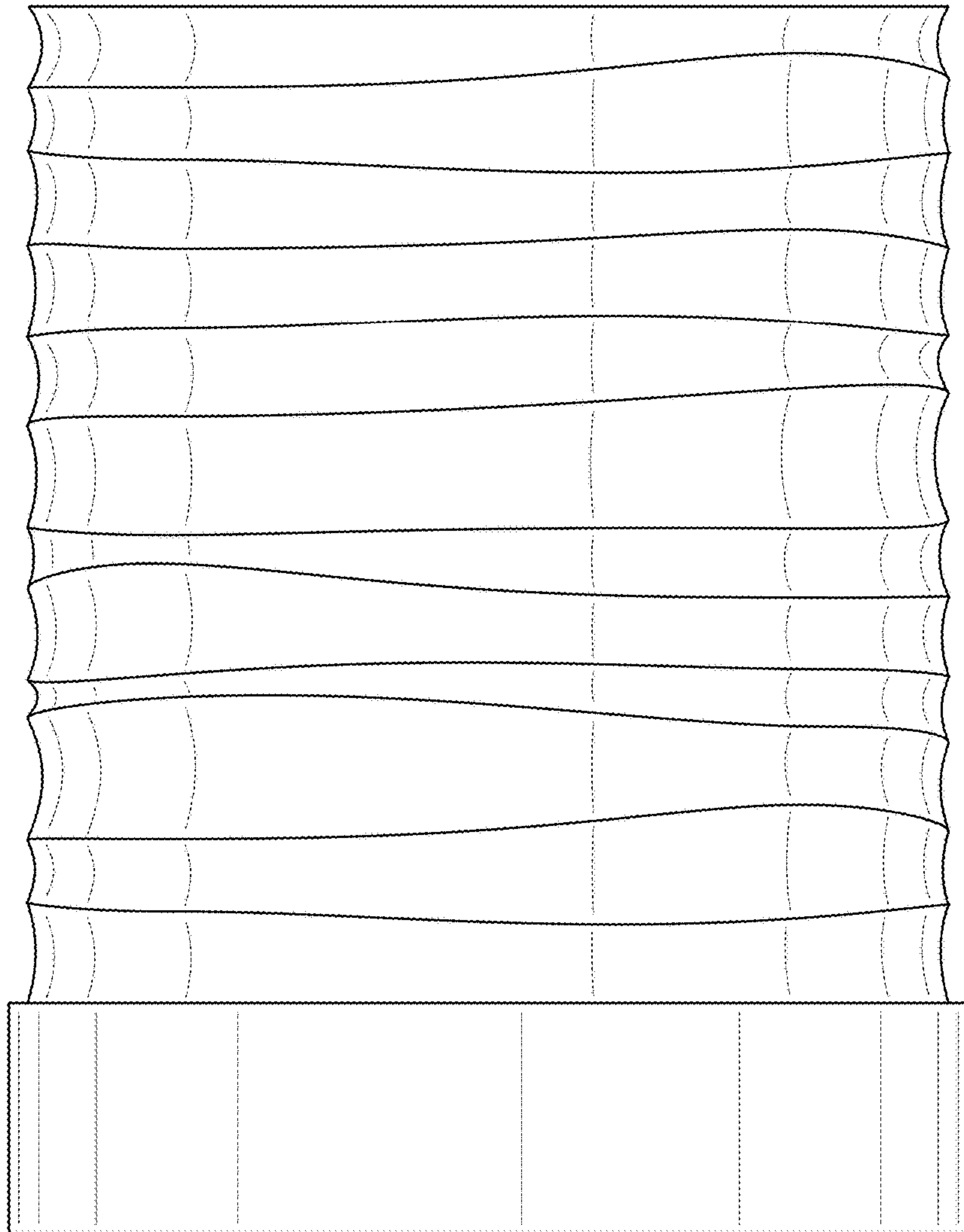

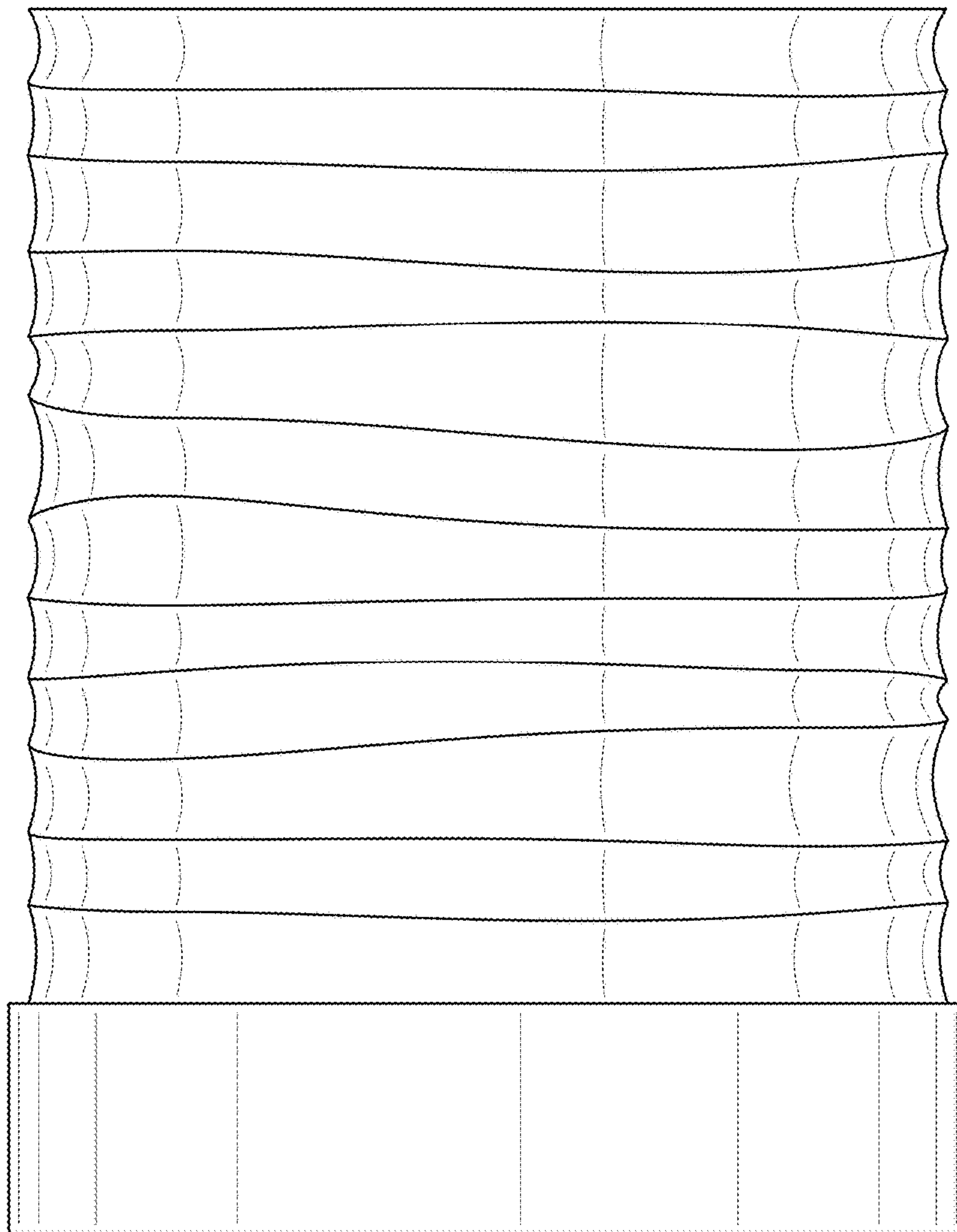

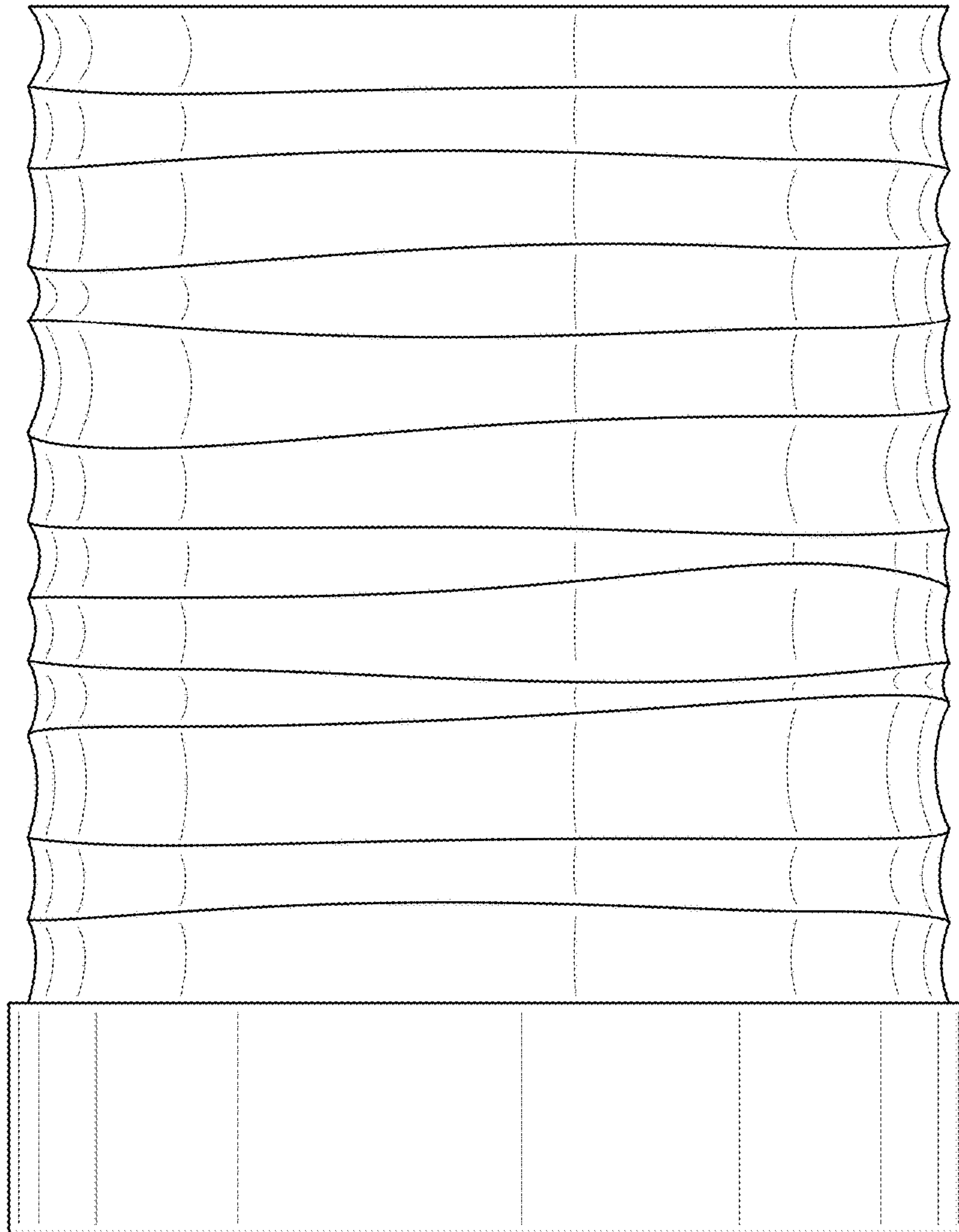

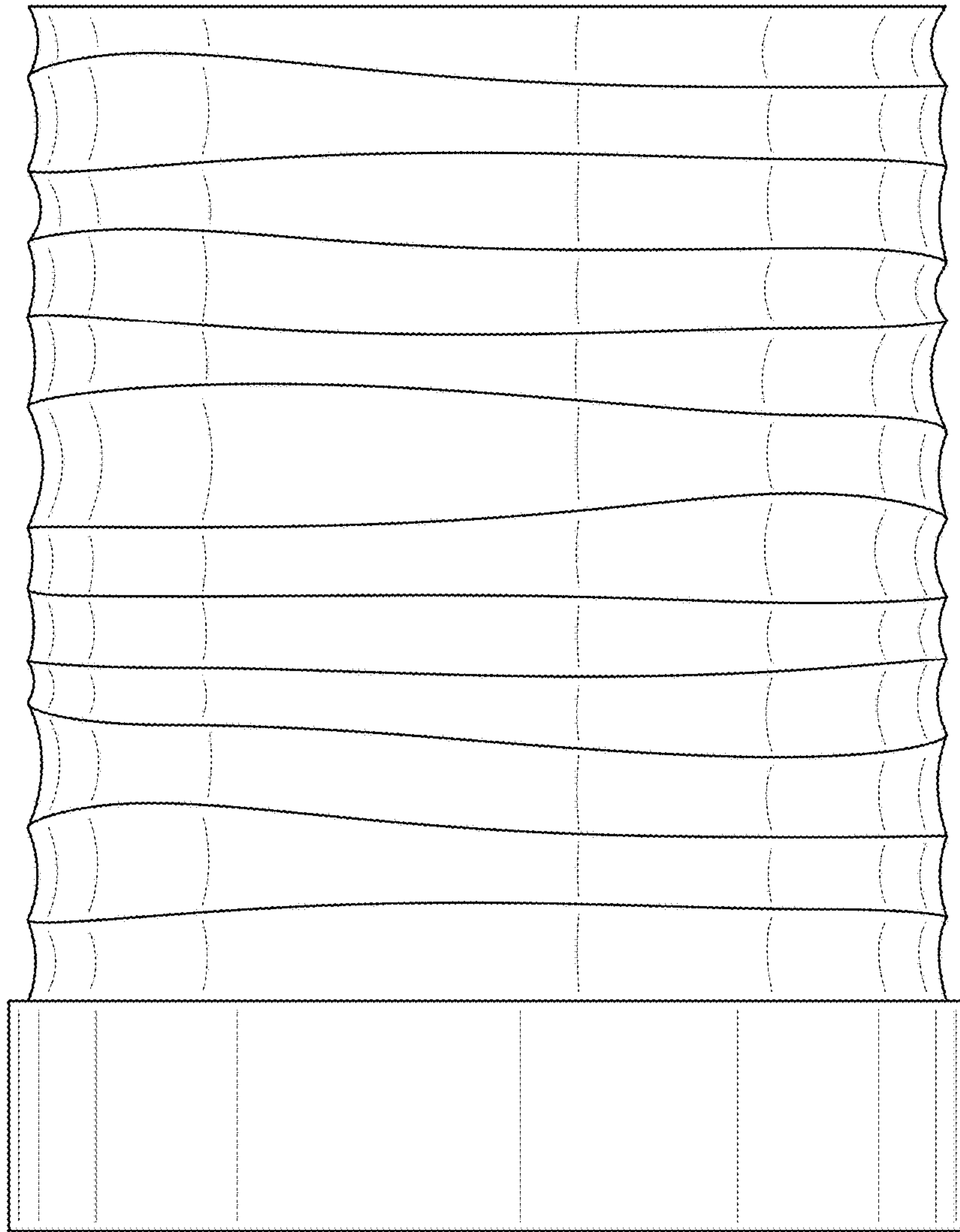

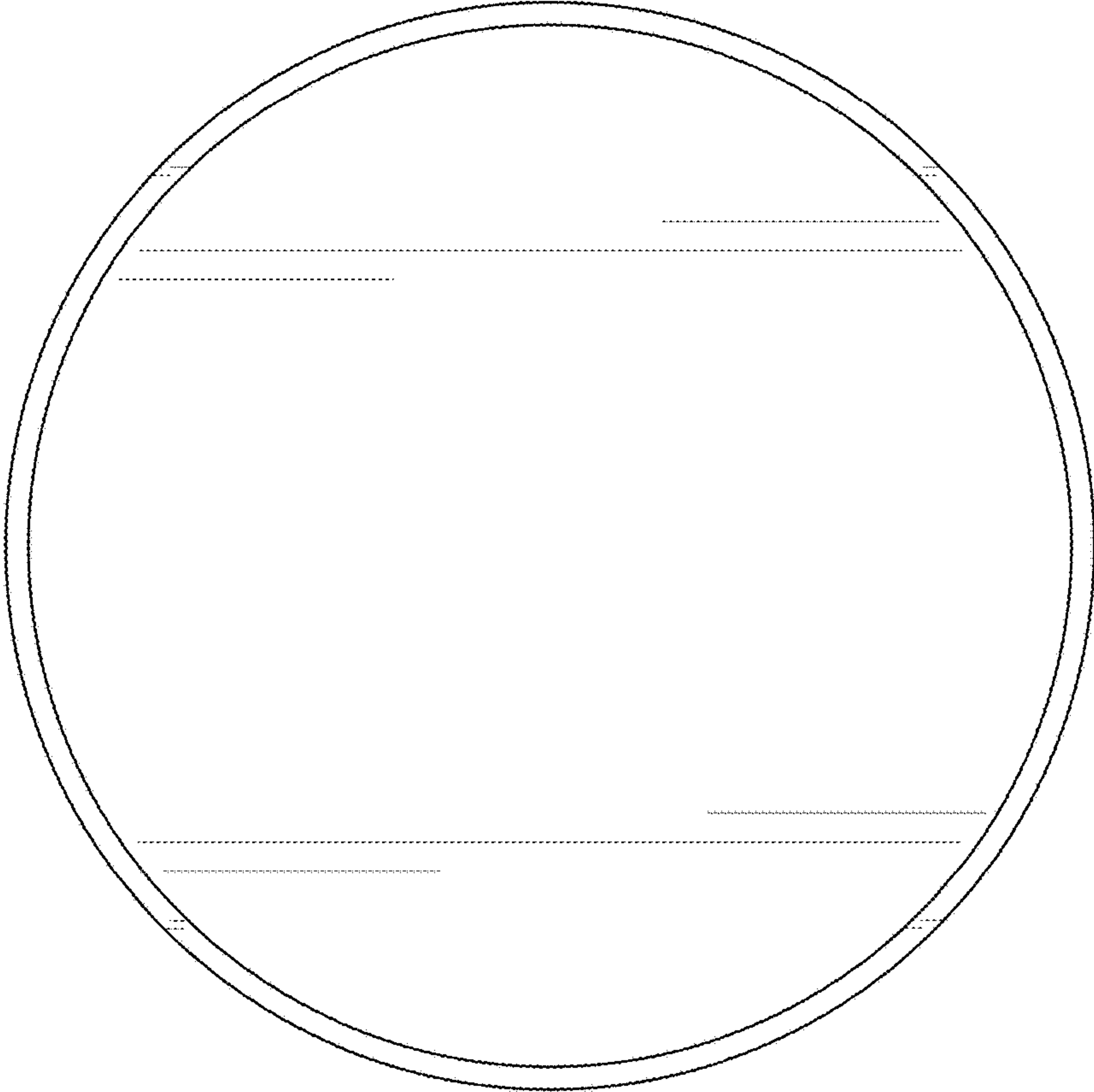

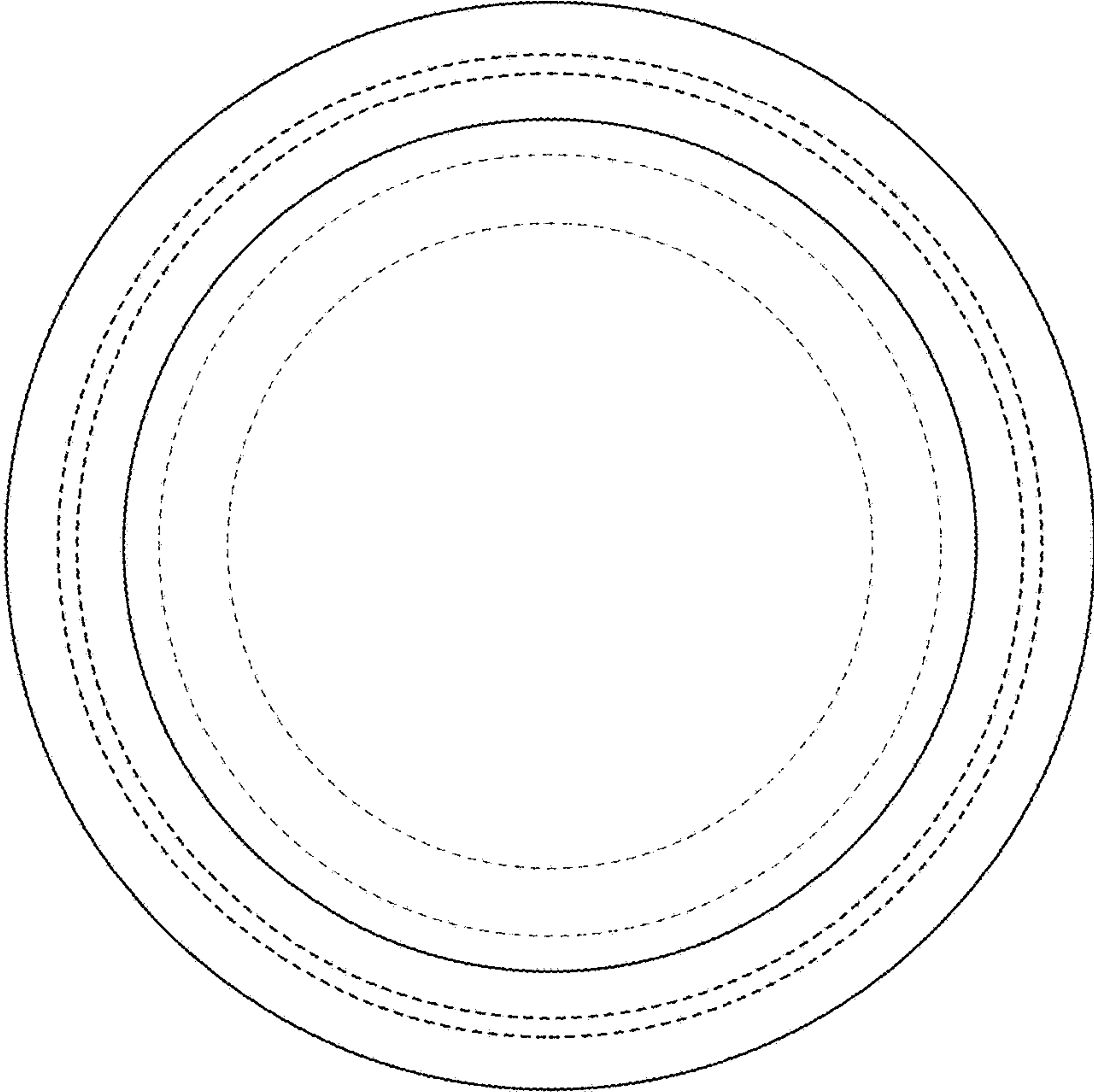

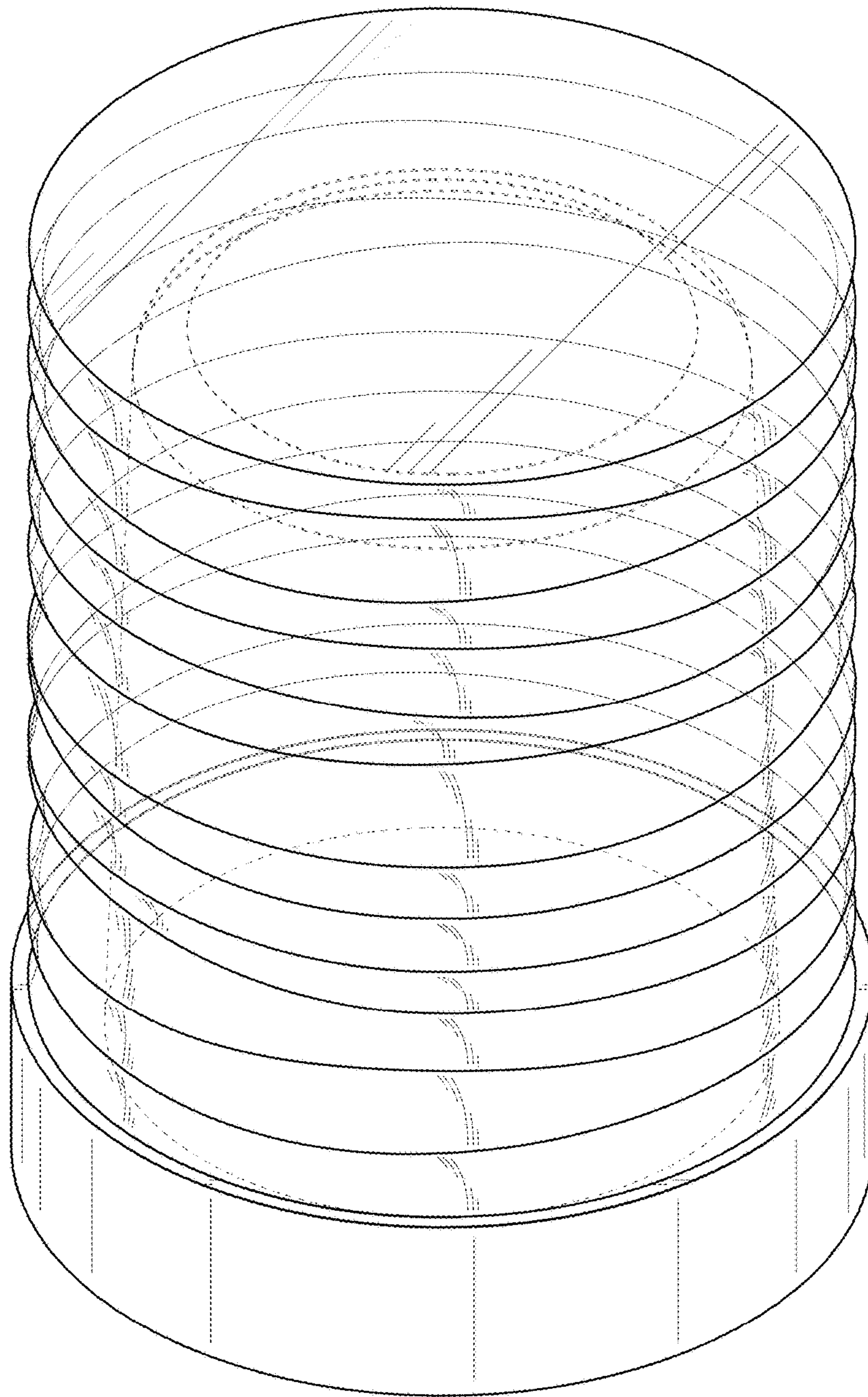

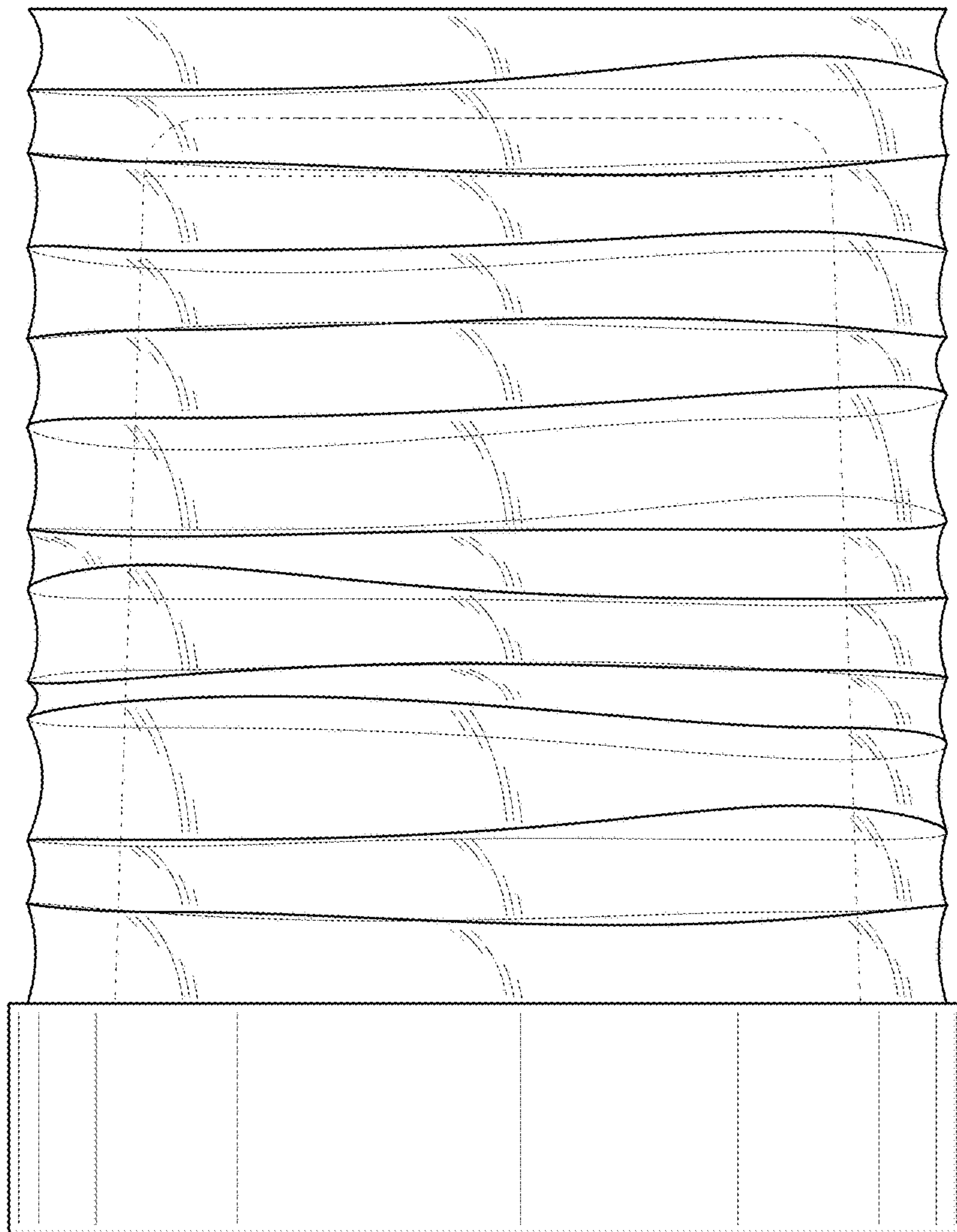

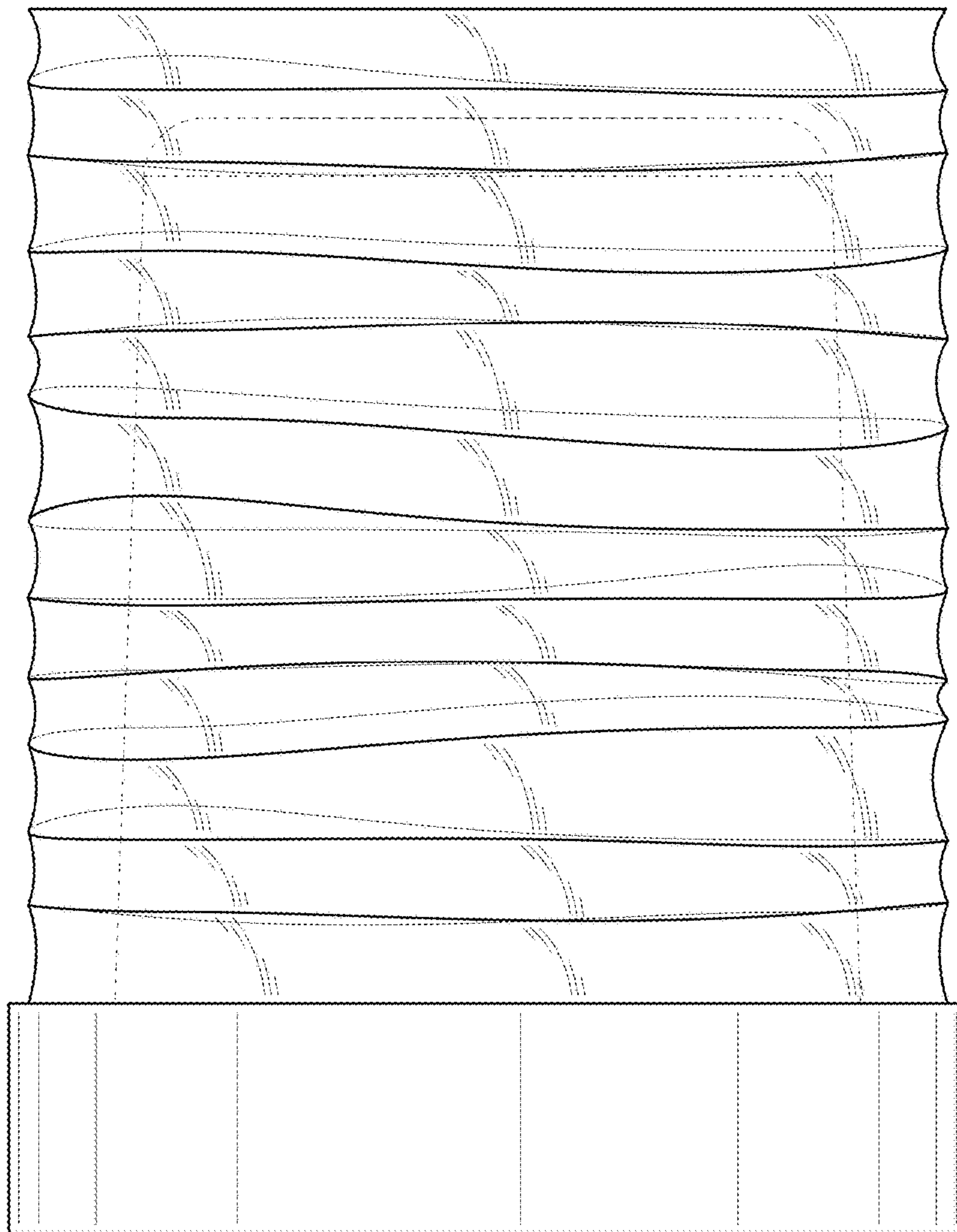

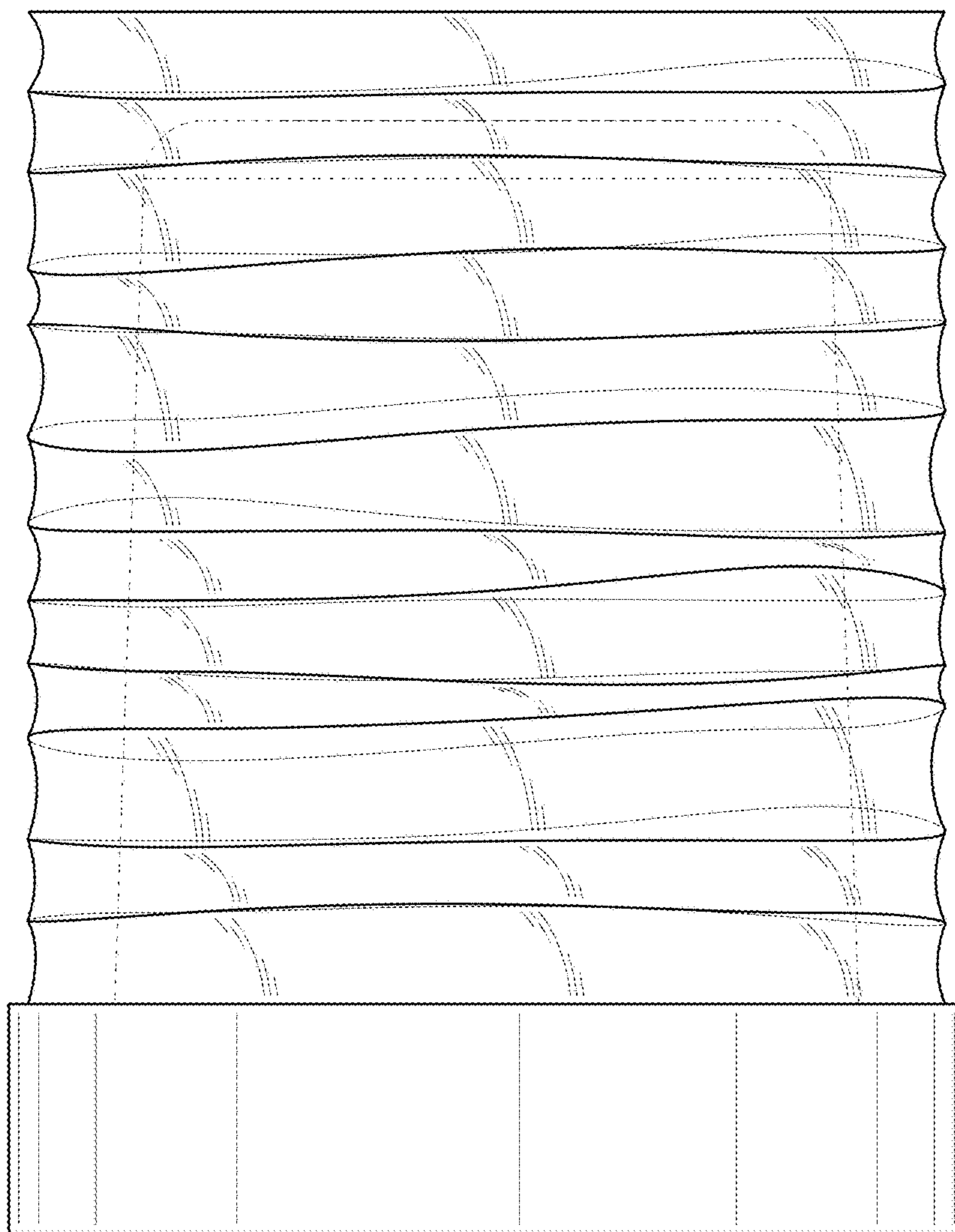

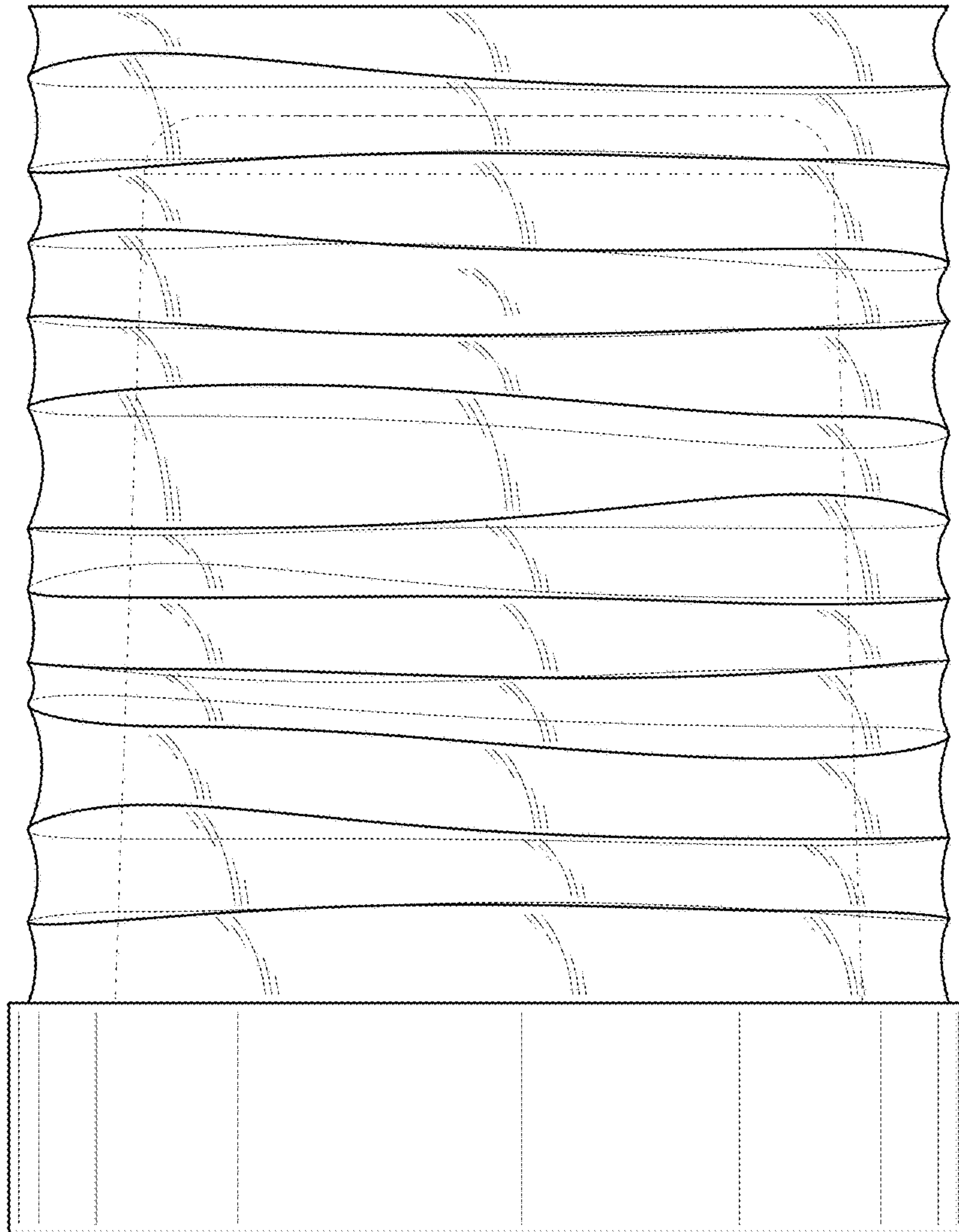

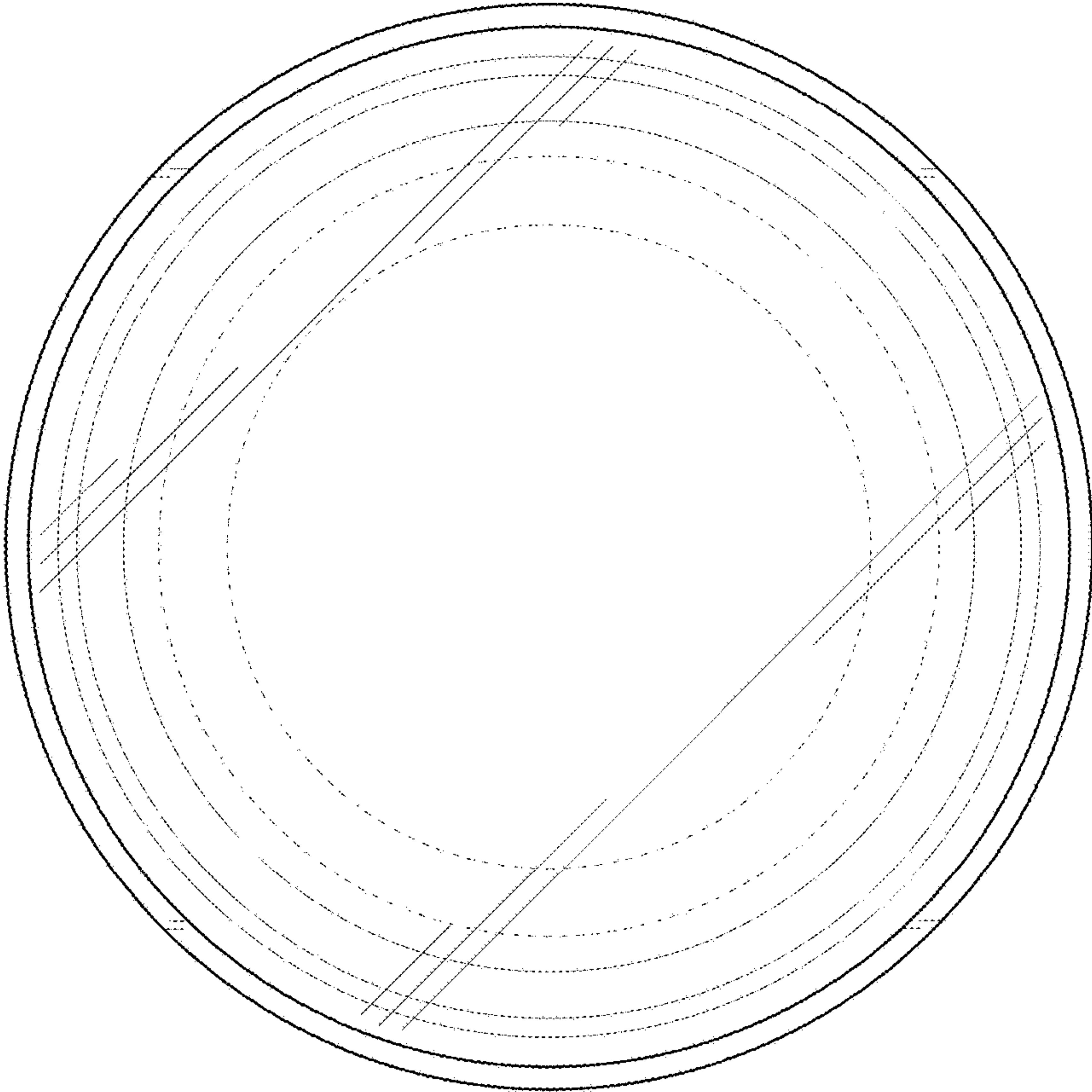

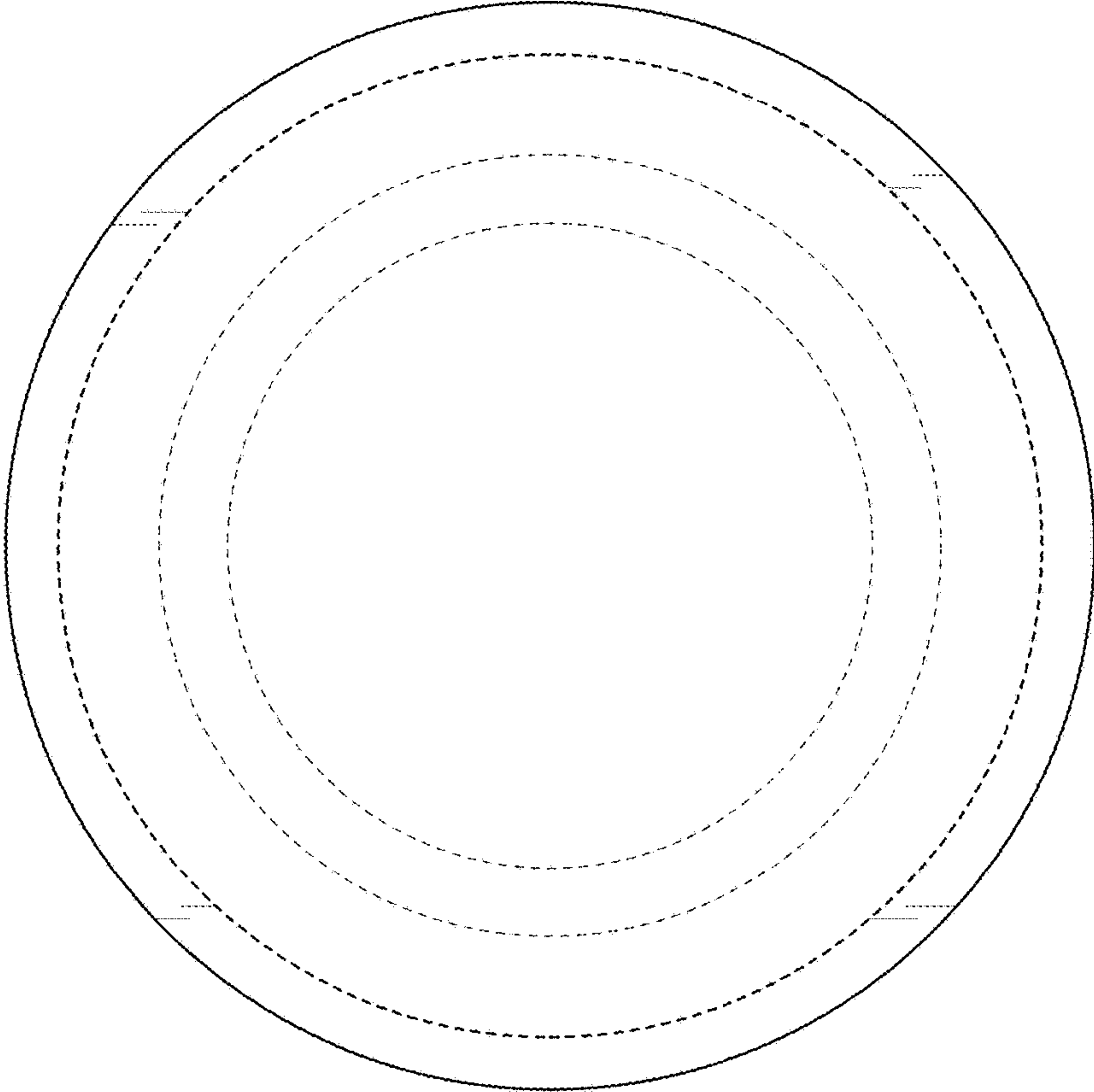
