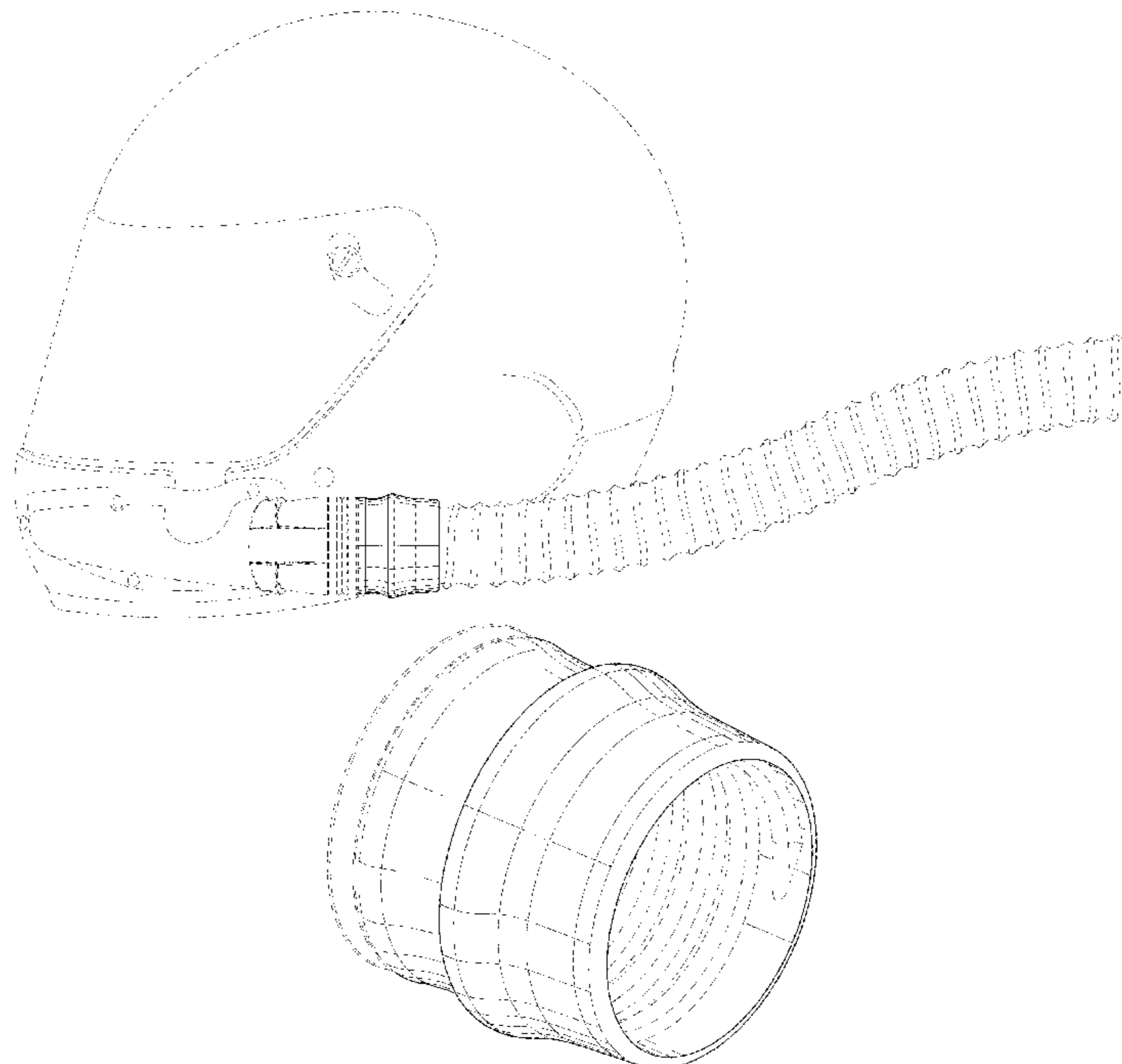
(57) **CLAIM**

The ornamental design for a magnetic quick connect for use with forced air headgear, as shown and described.

**DESCRIPTION**

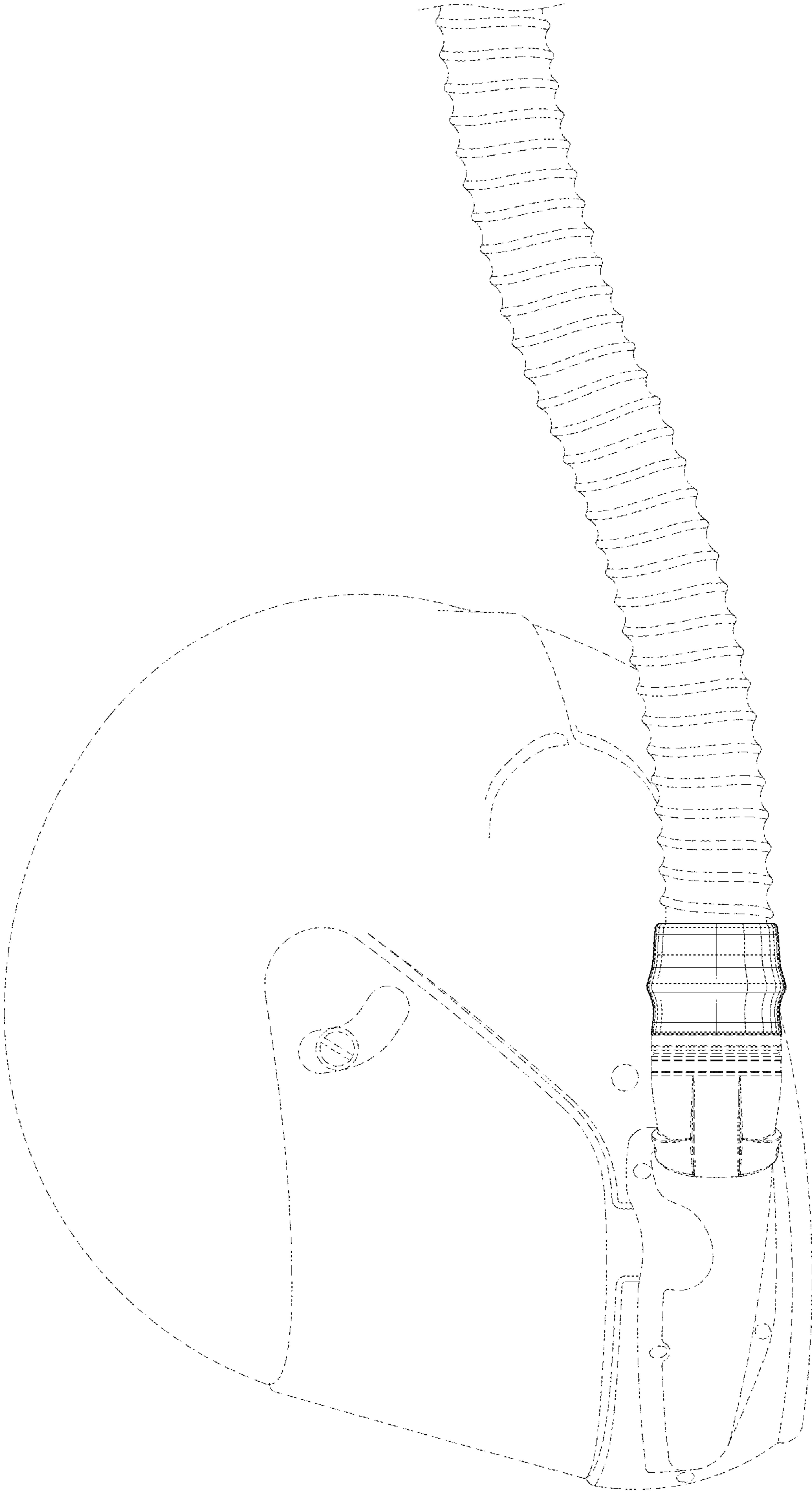
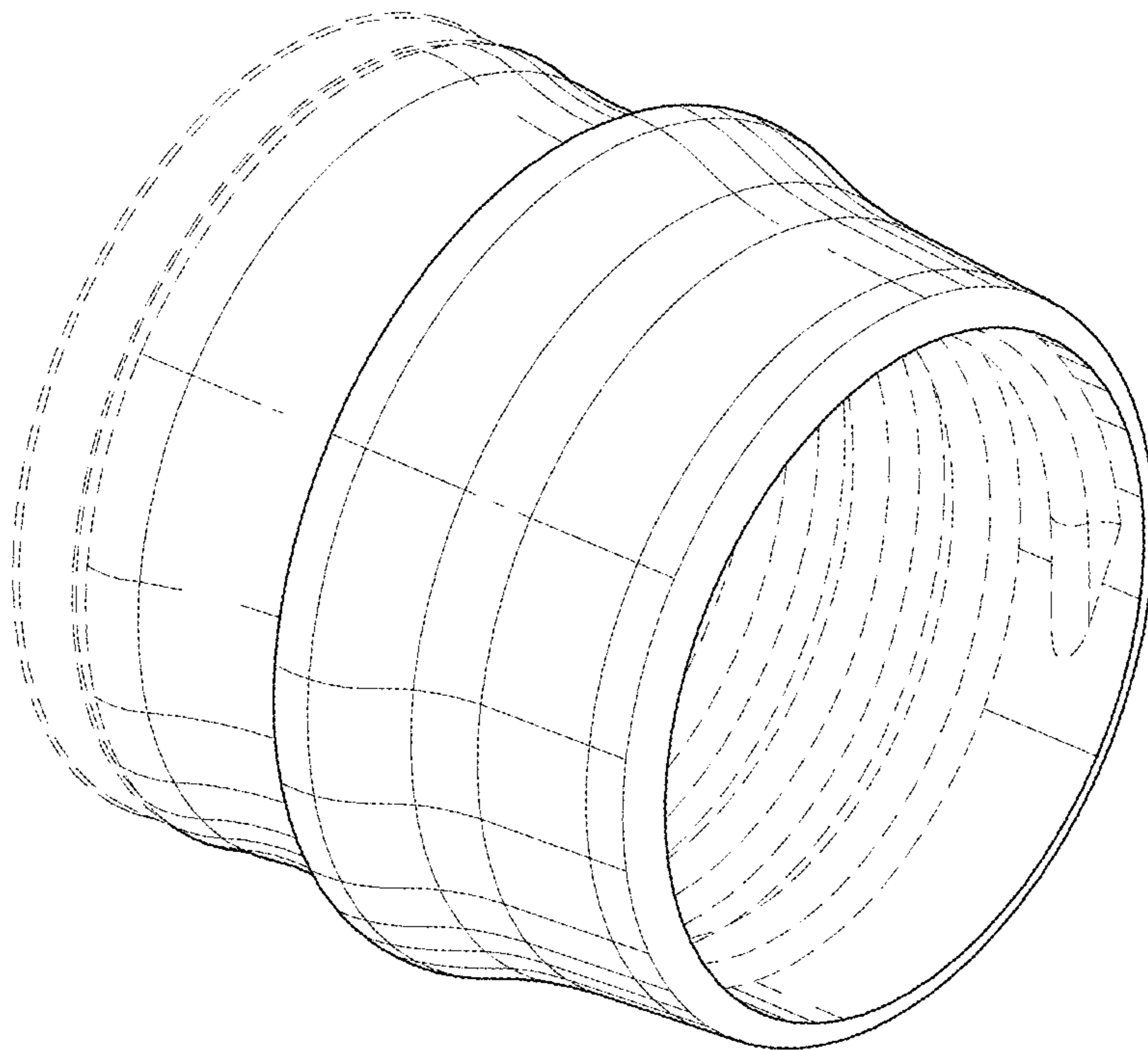
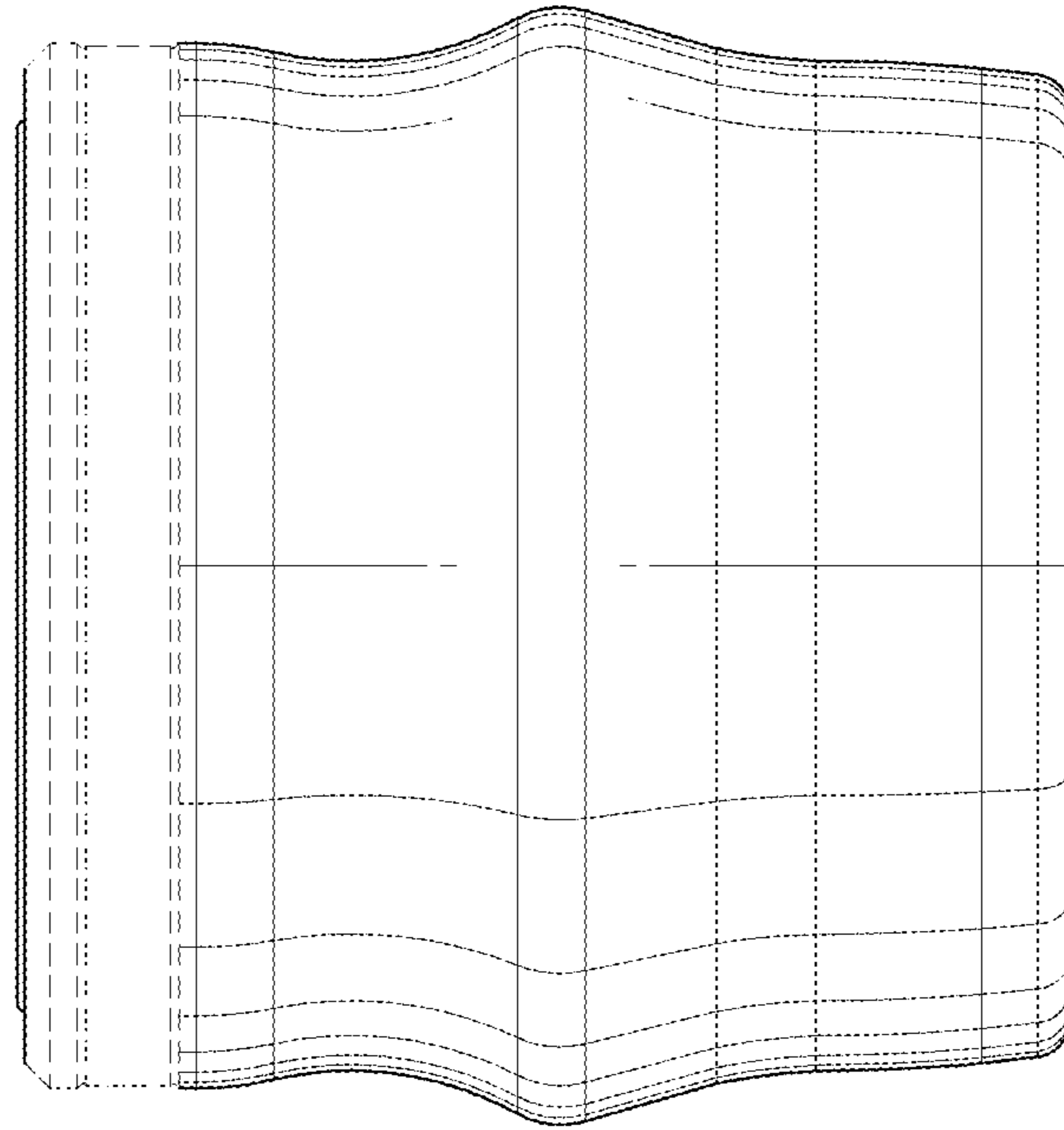


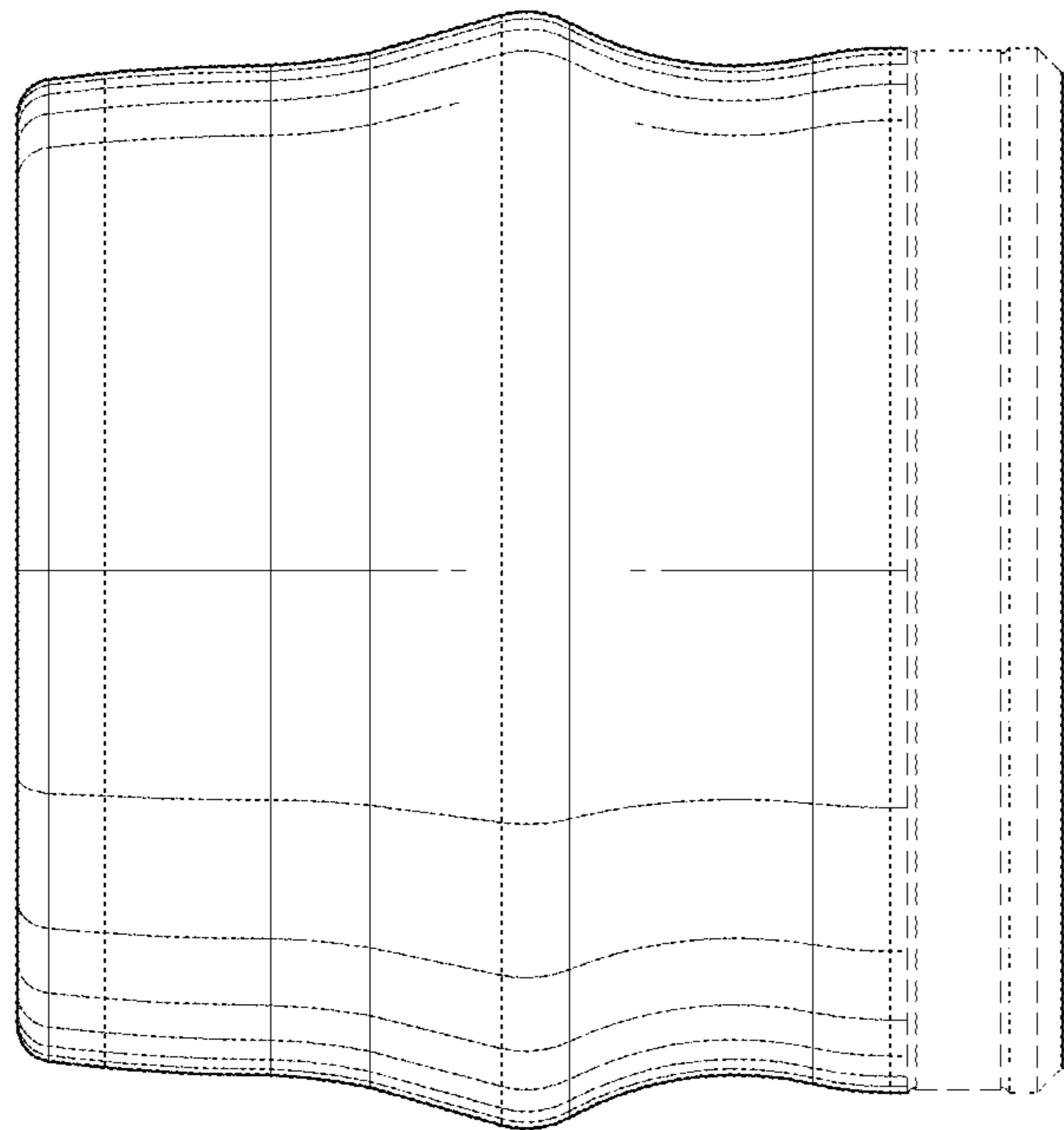

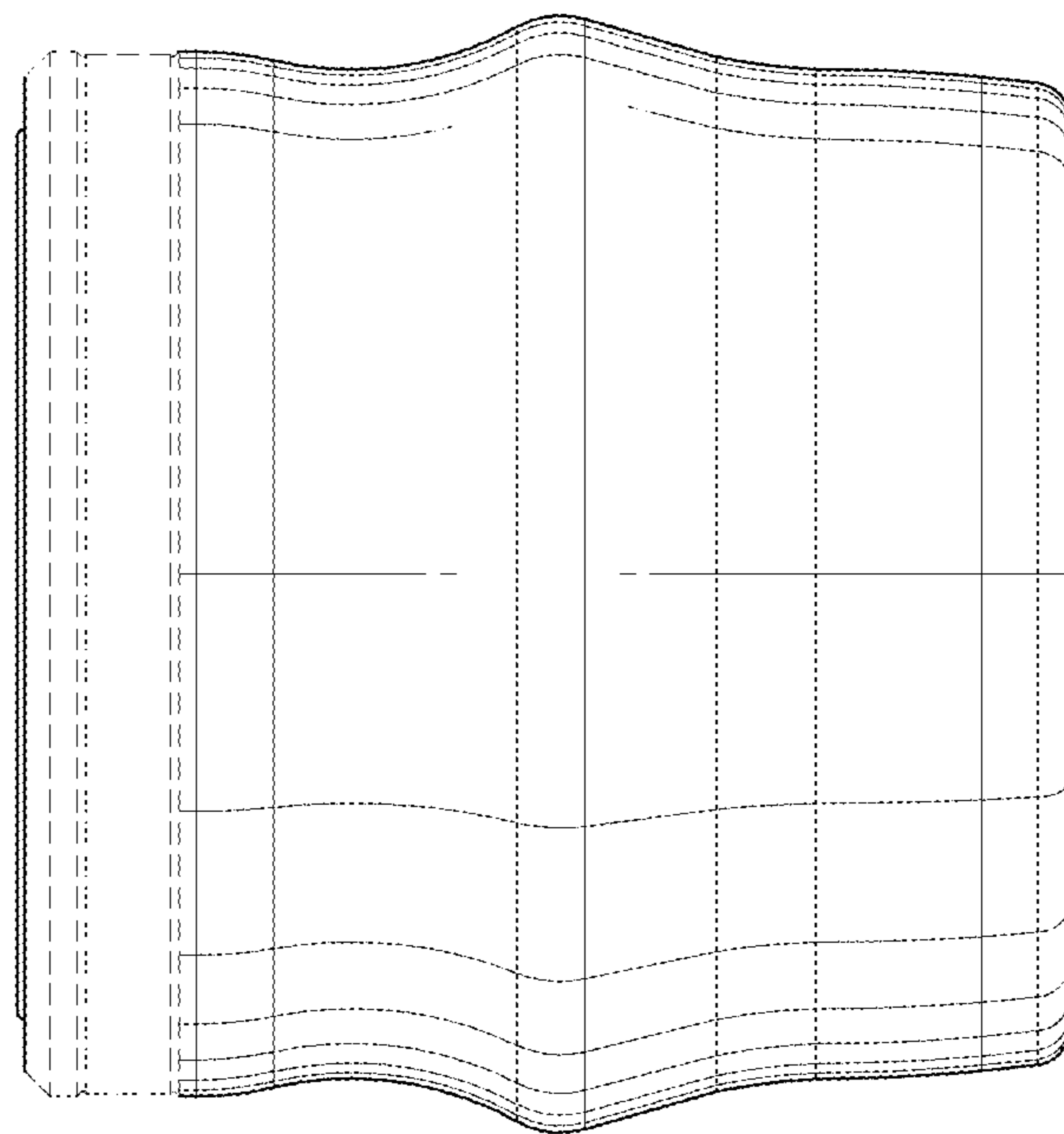

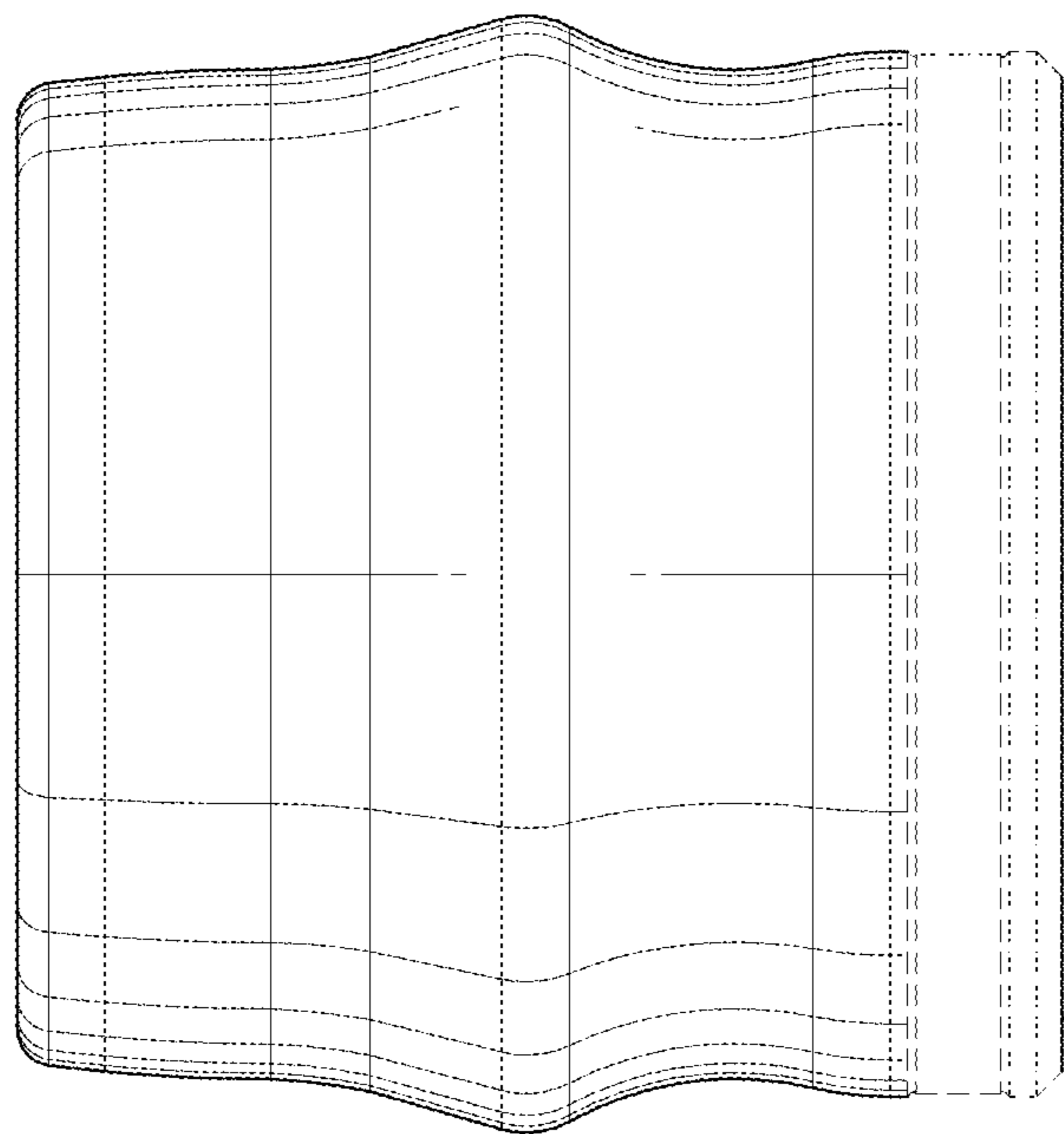

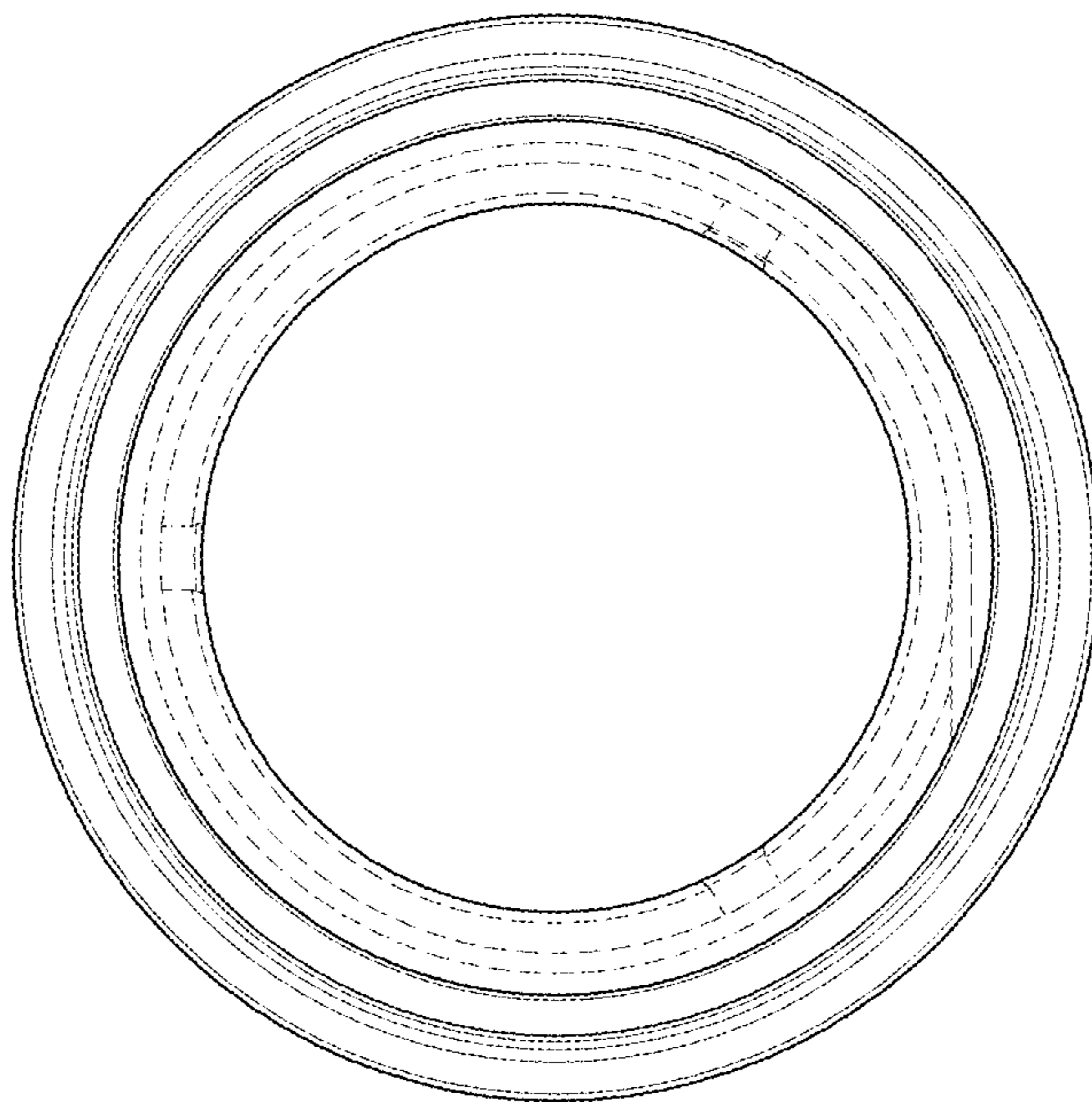

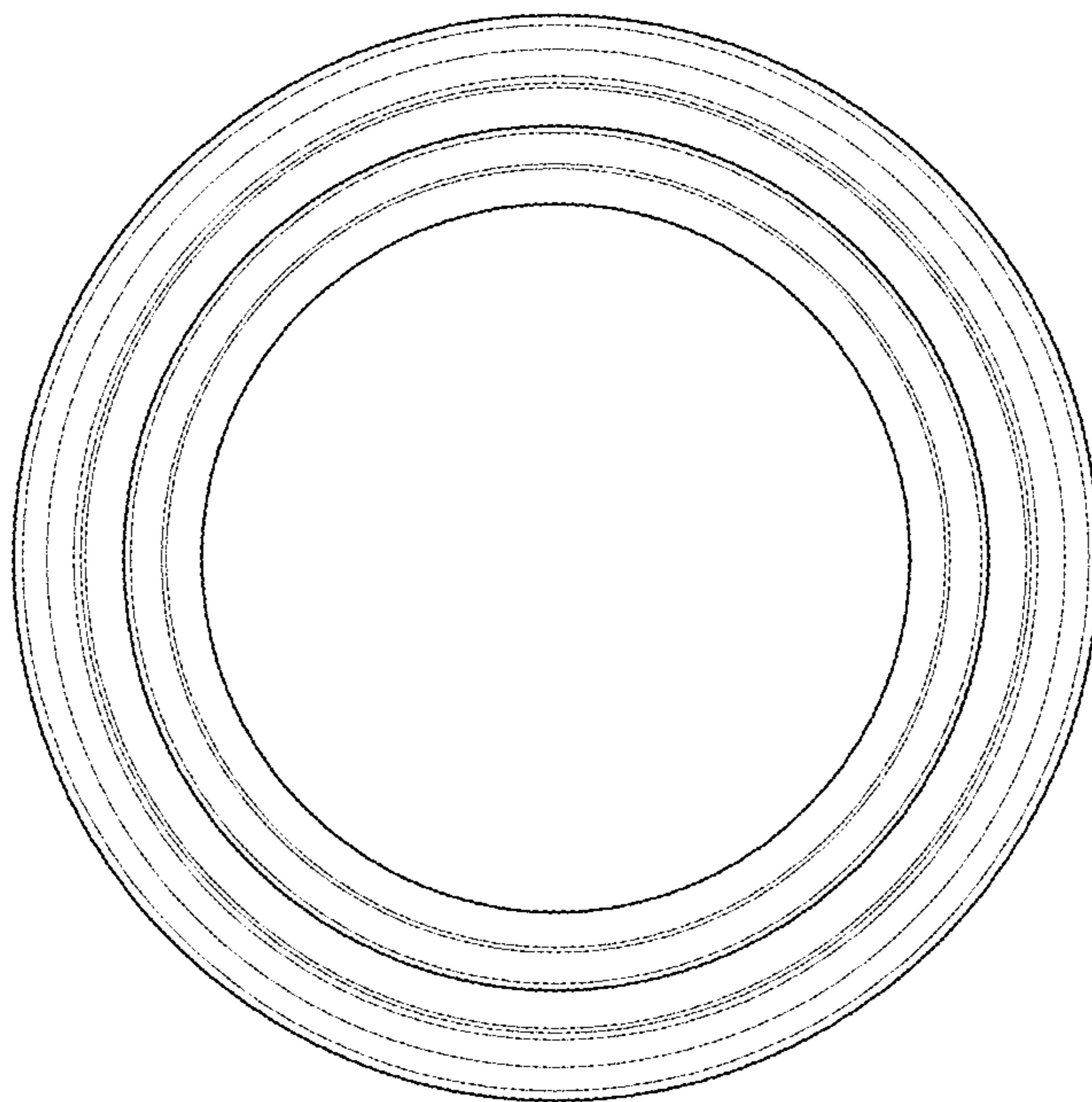
