The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 3 is a rear elevation view thereof;

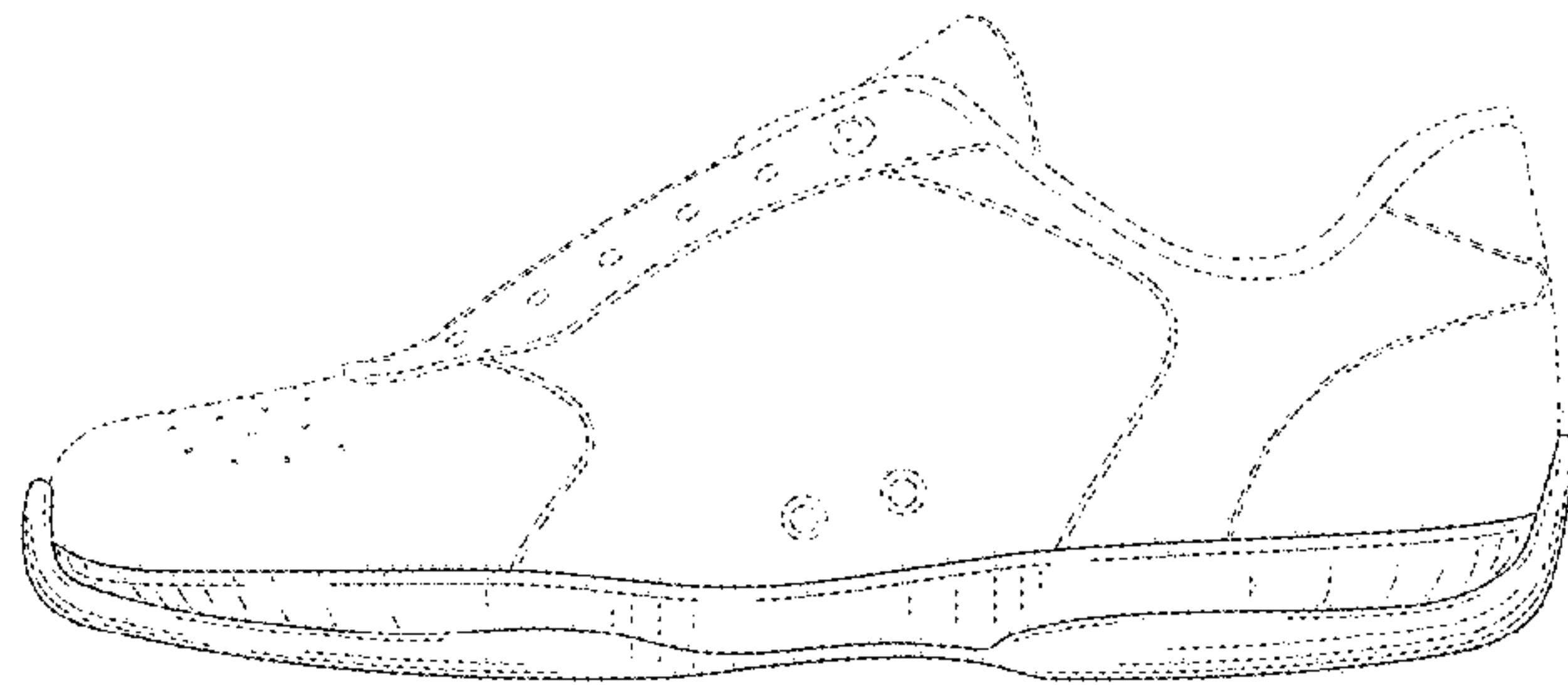
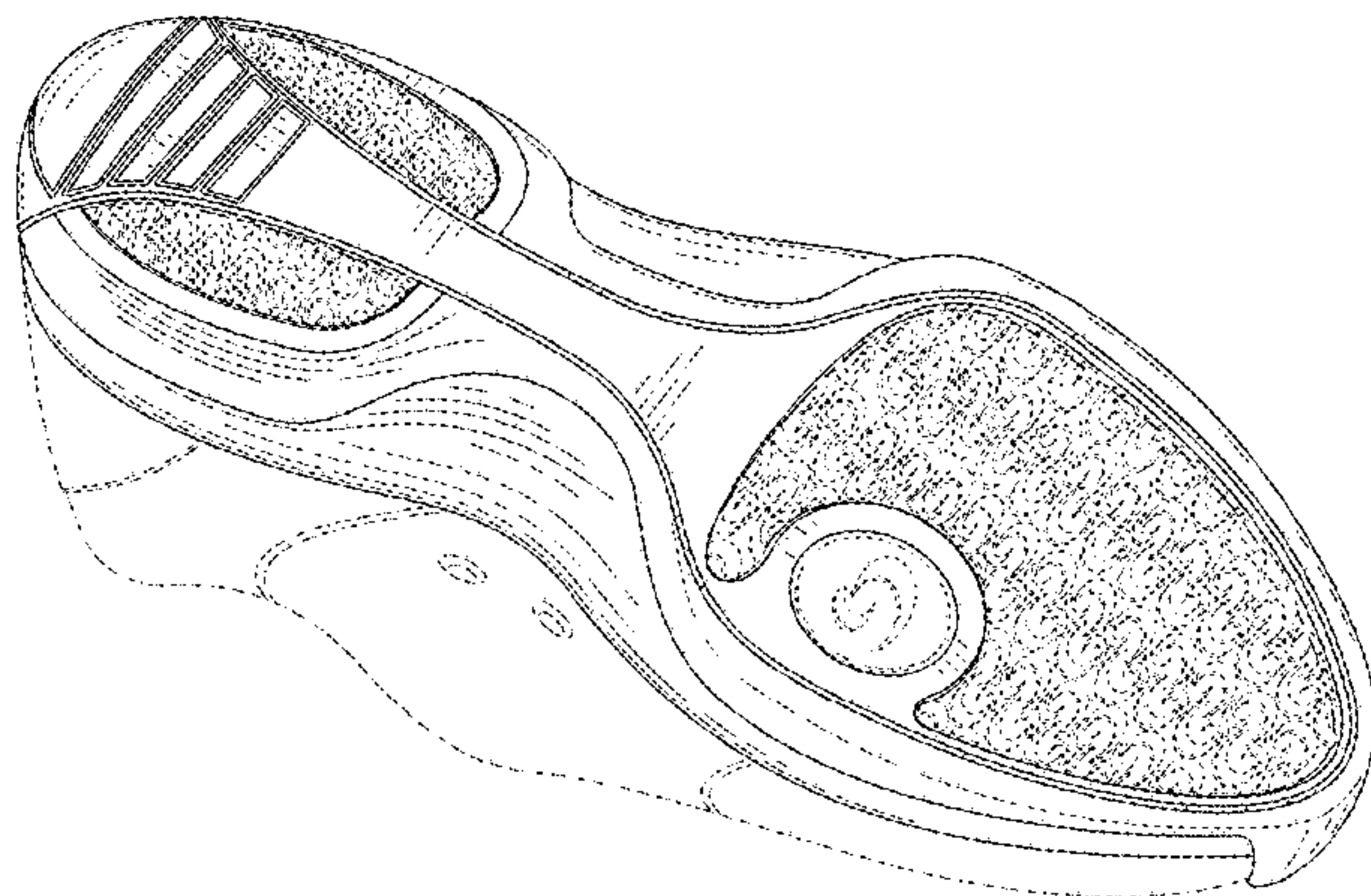
FIG. 4 is a right side elevation view thereof;

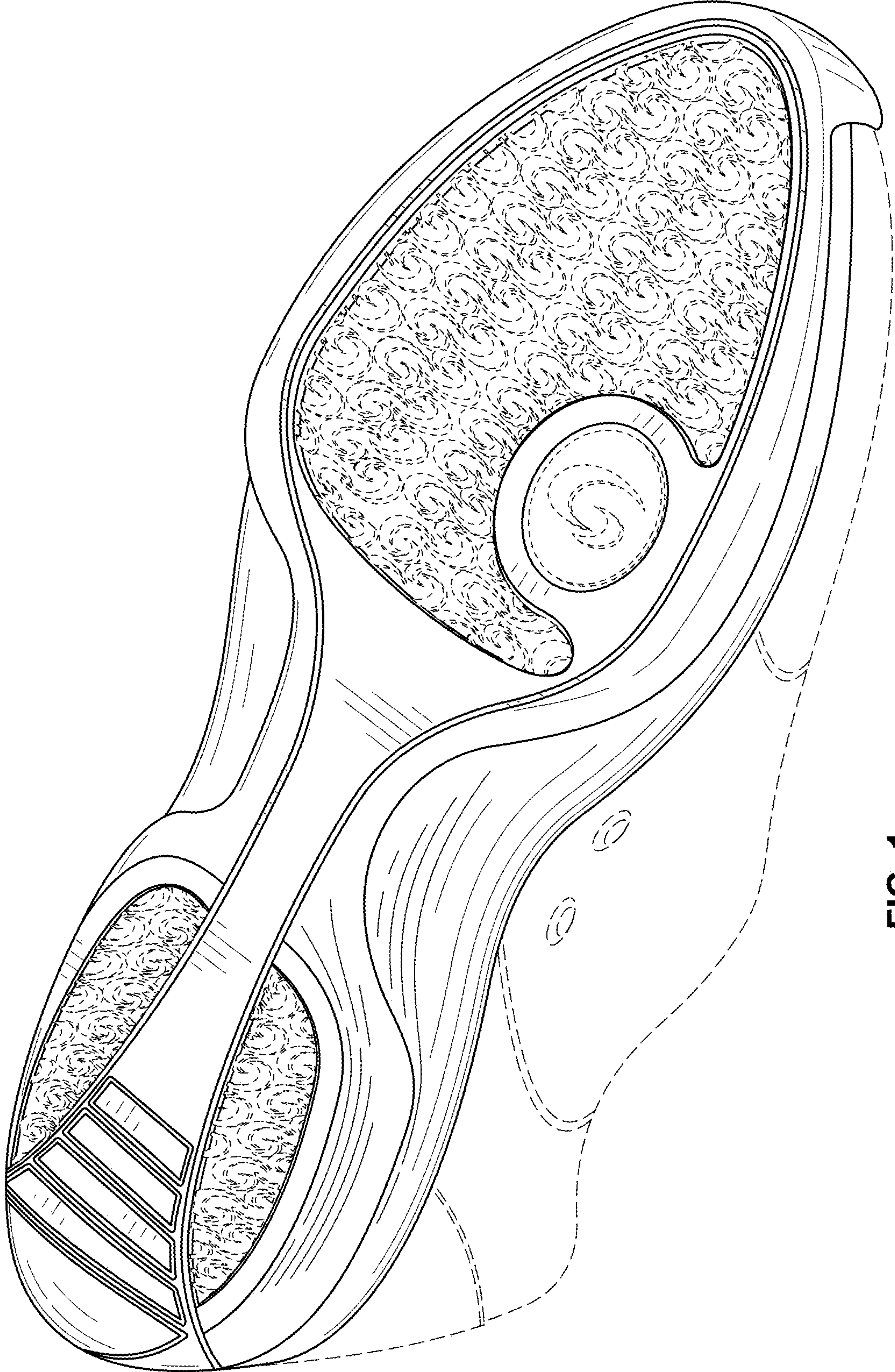

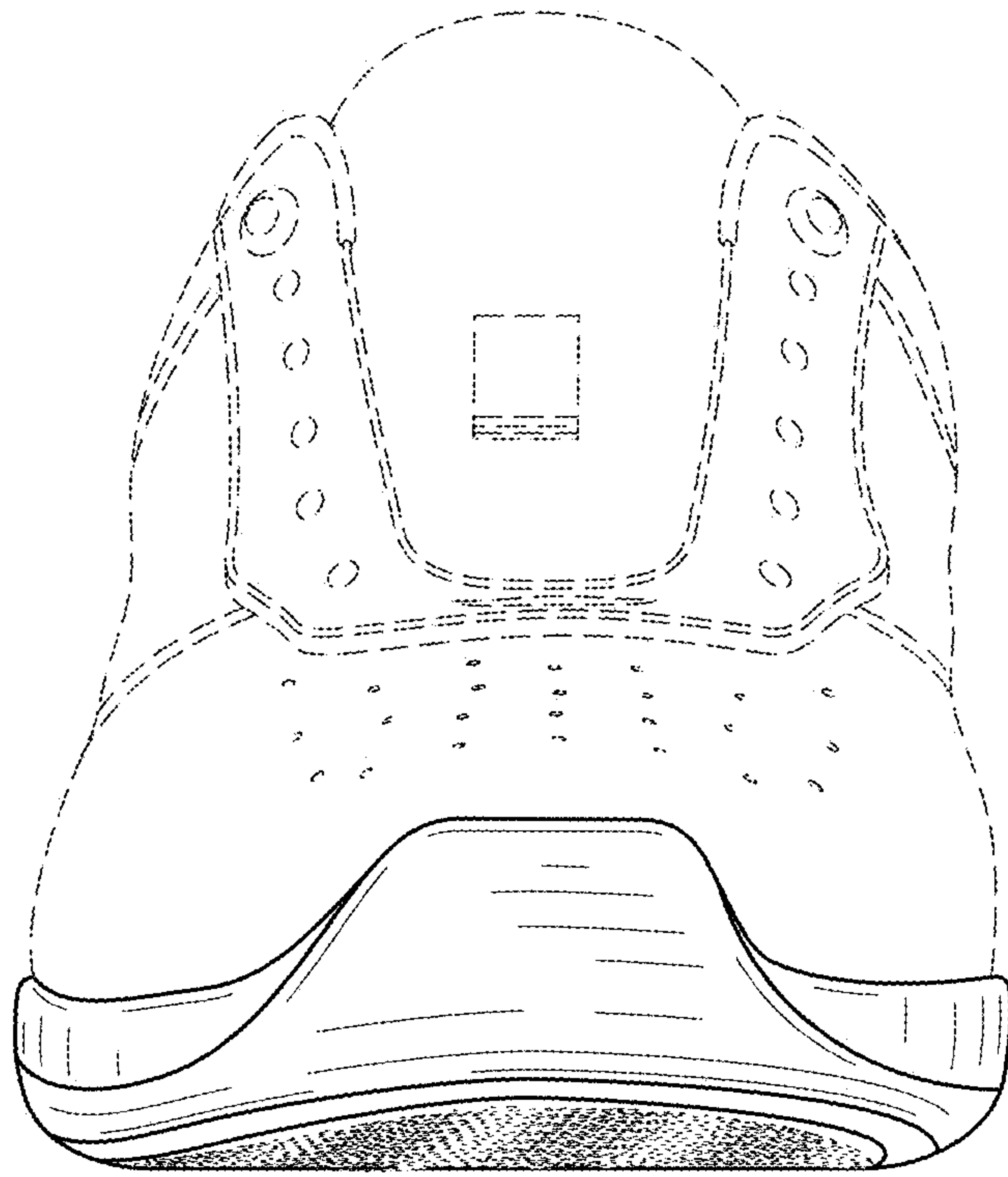

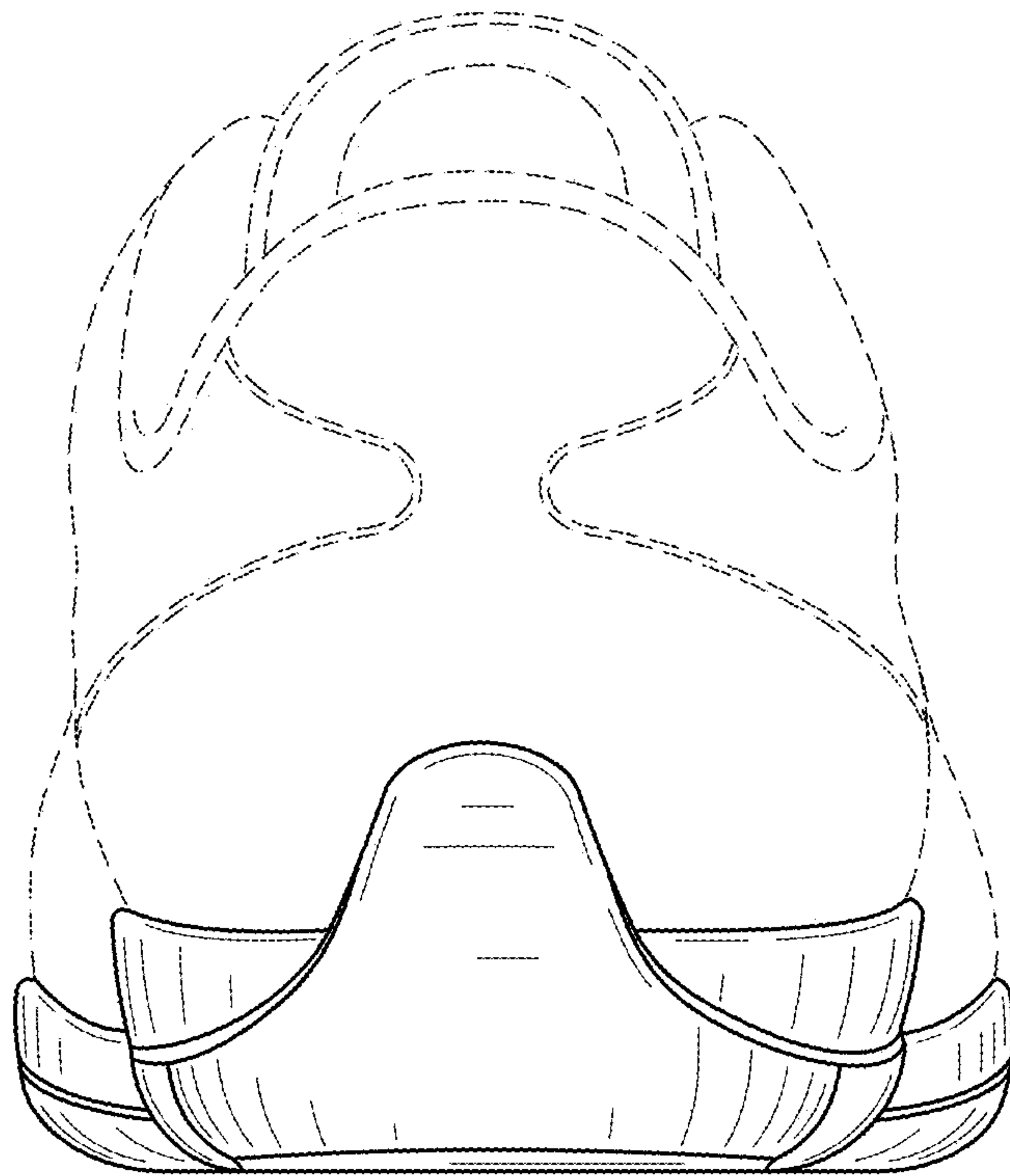

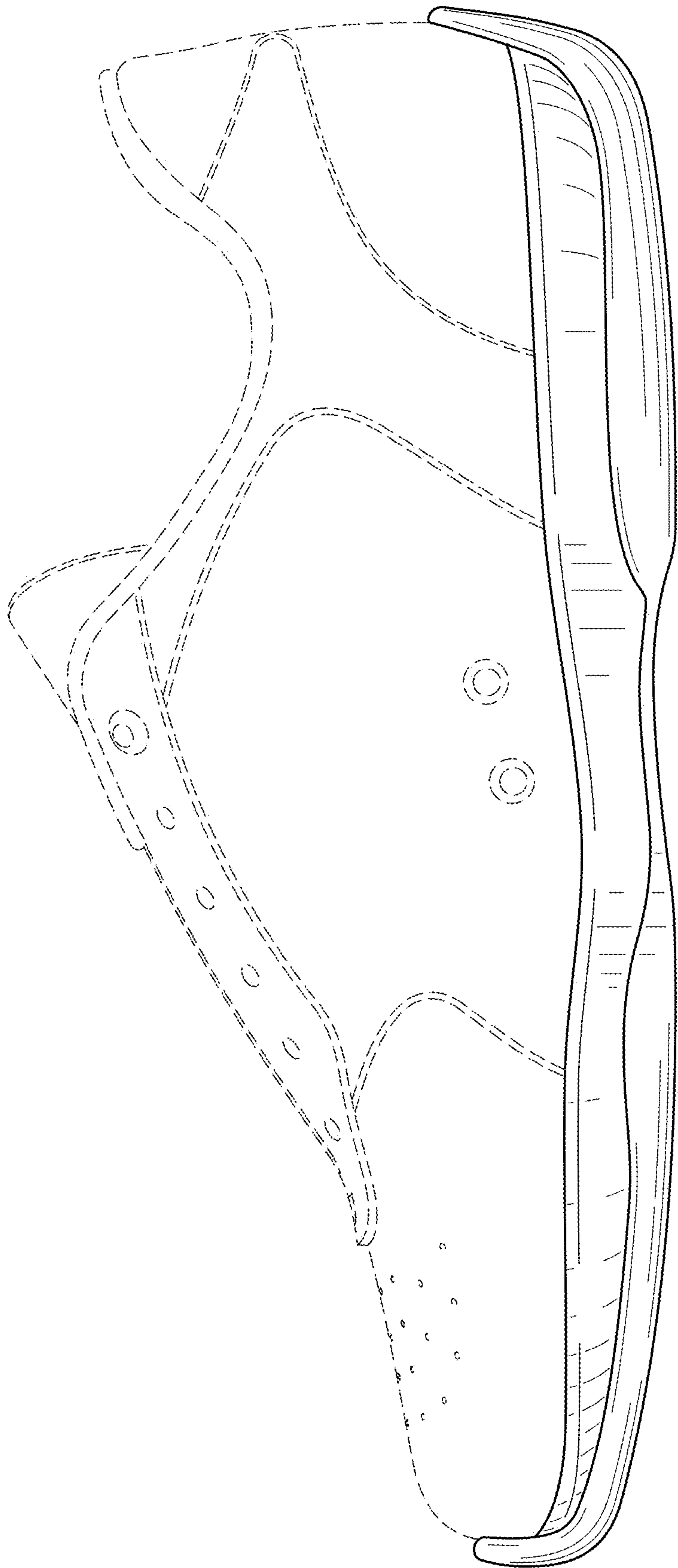

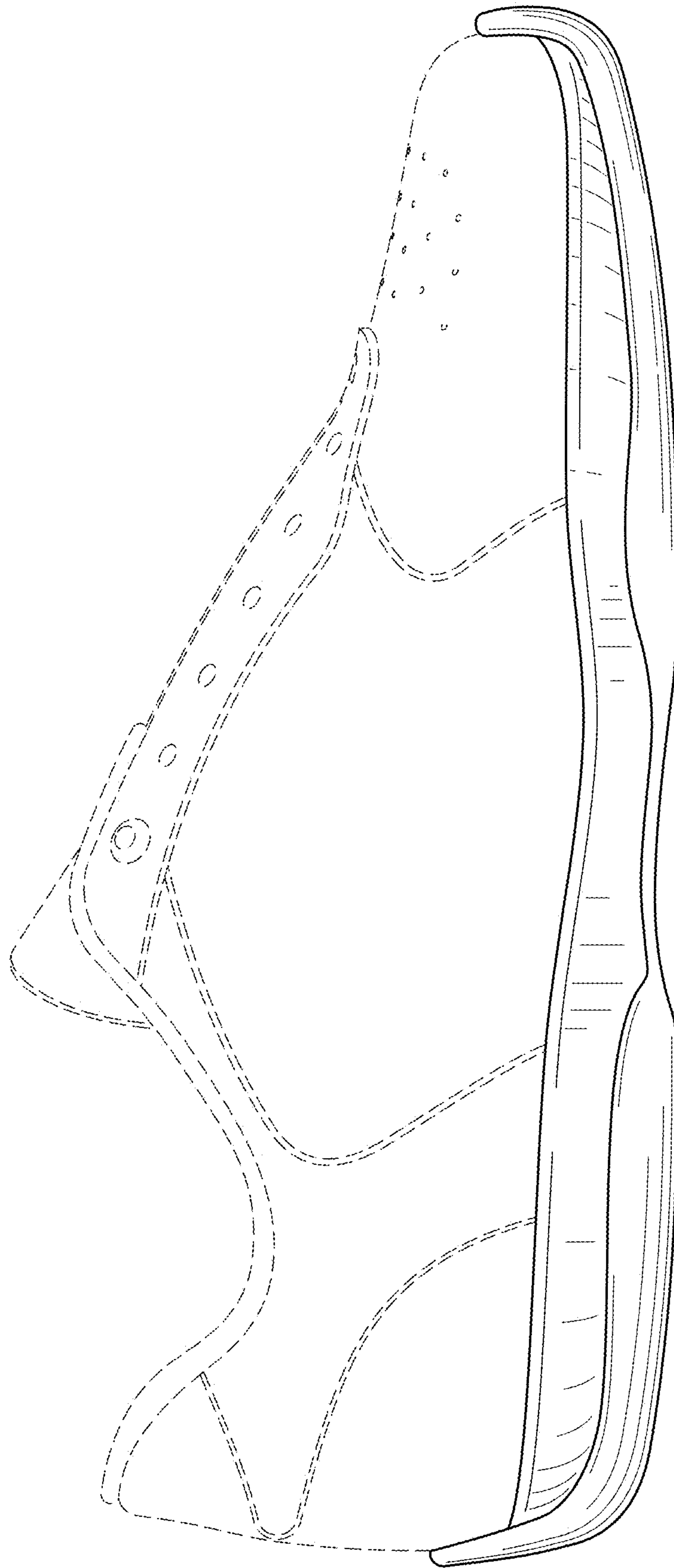

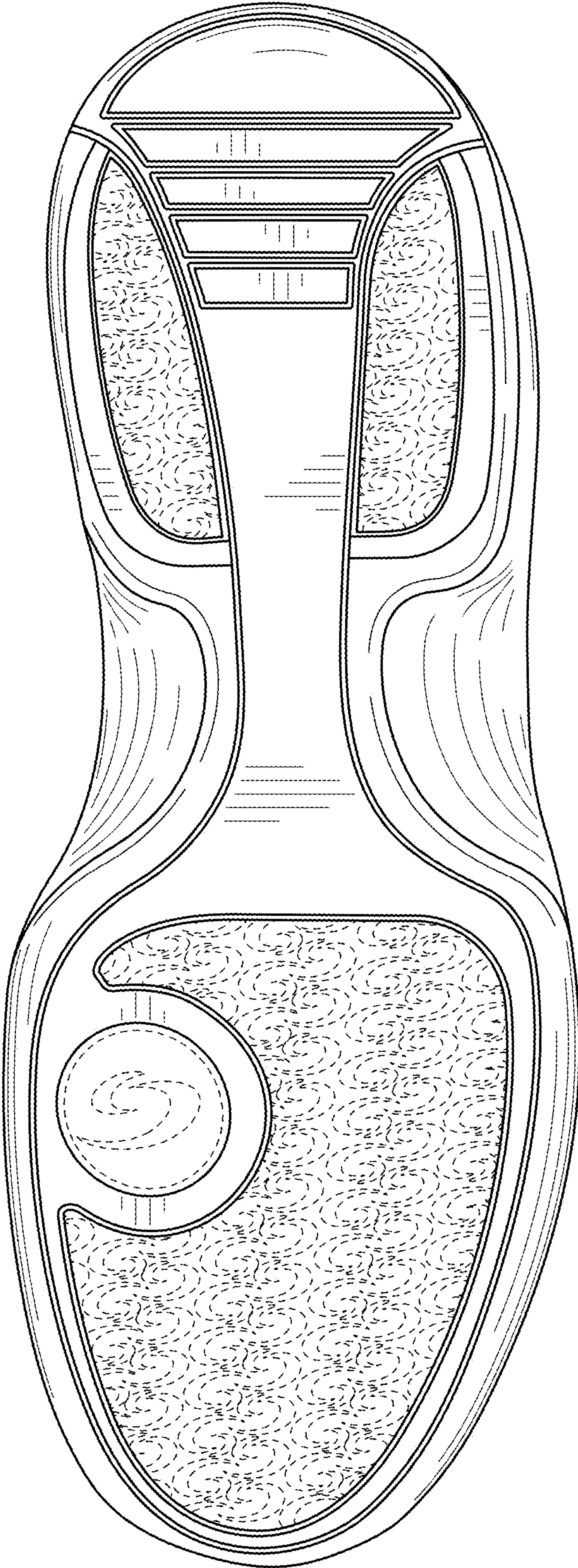
