(57) **CLAIM**

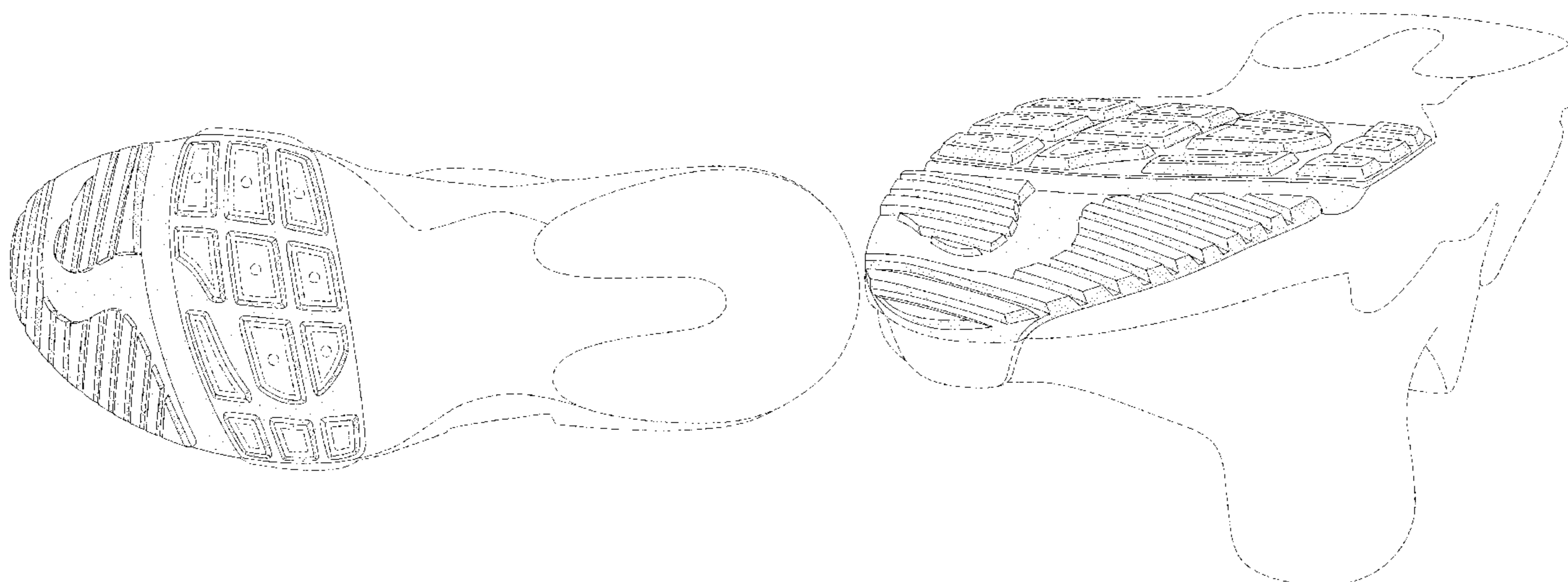
The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom plan view of a shoe showing my design; FIG. 2 is a bottom, front perspective view thereof; and, FIG. 3 is a bottom, side perspective view thereof.

The even-length broken lines are directed to environment, represent unclaimed subject matter, and form no part of the claimed design. The long and short broken lines near the toe are unclaimed boundaries between claimed and unclaimed subject matter. The long and short broken lines within the shaded regions surround unclaimed subject matter and also form no part of the claimed design.

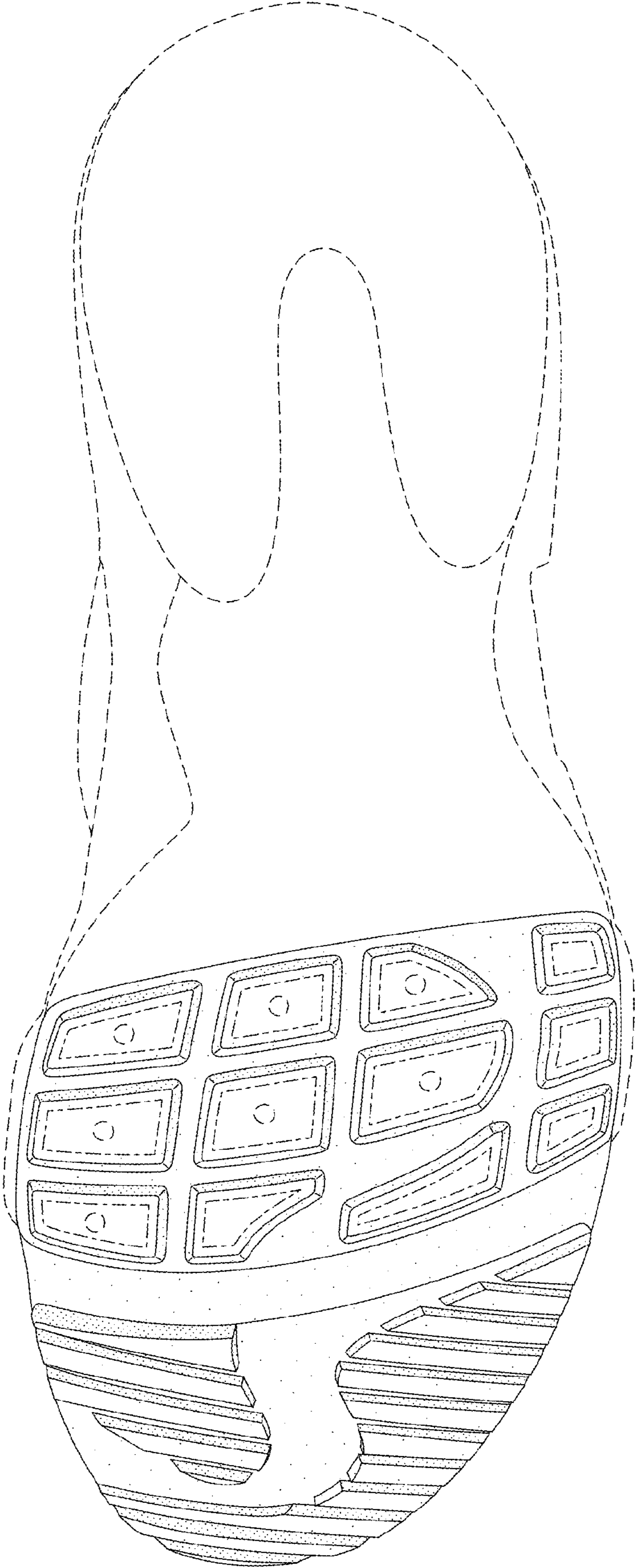

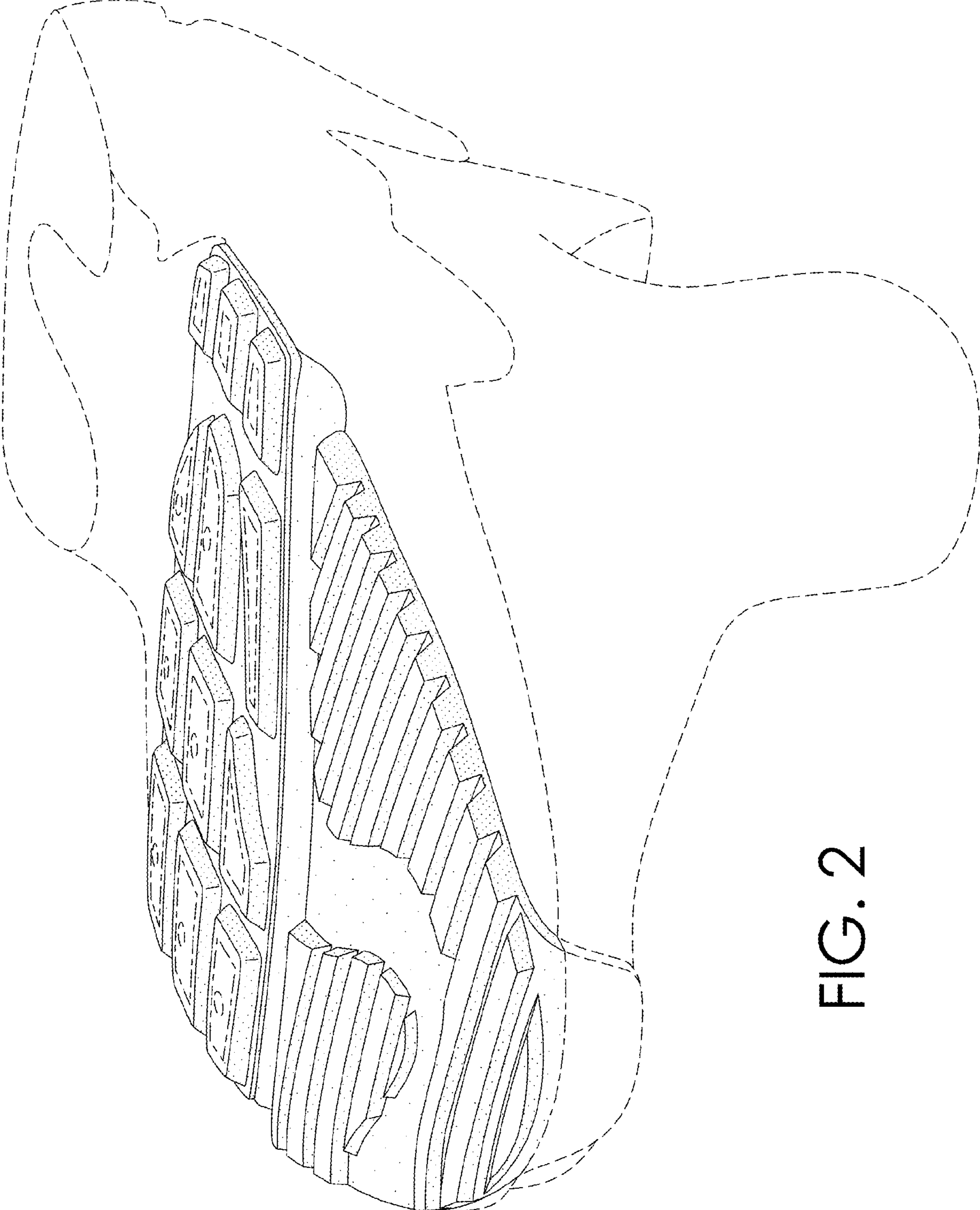

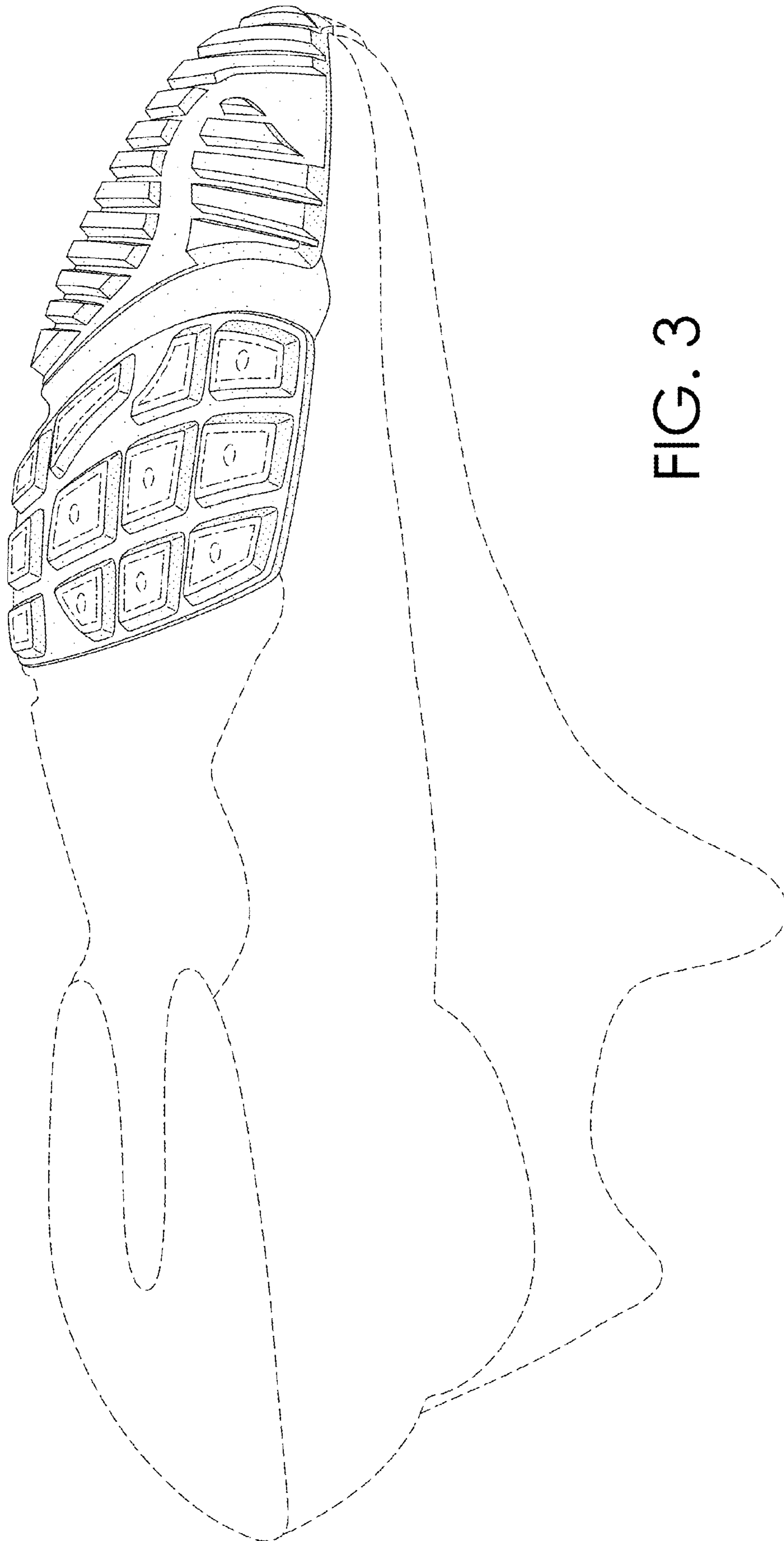
