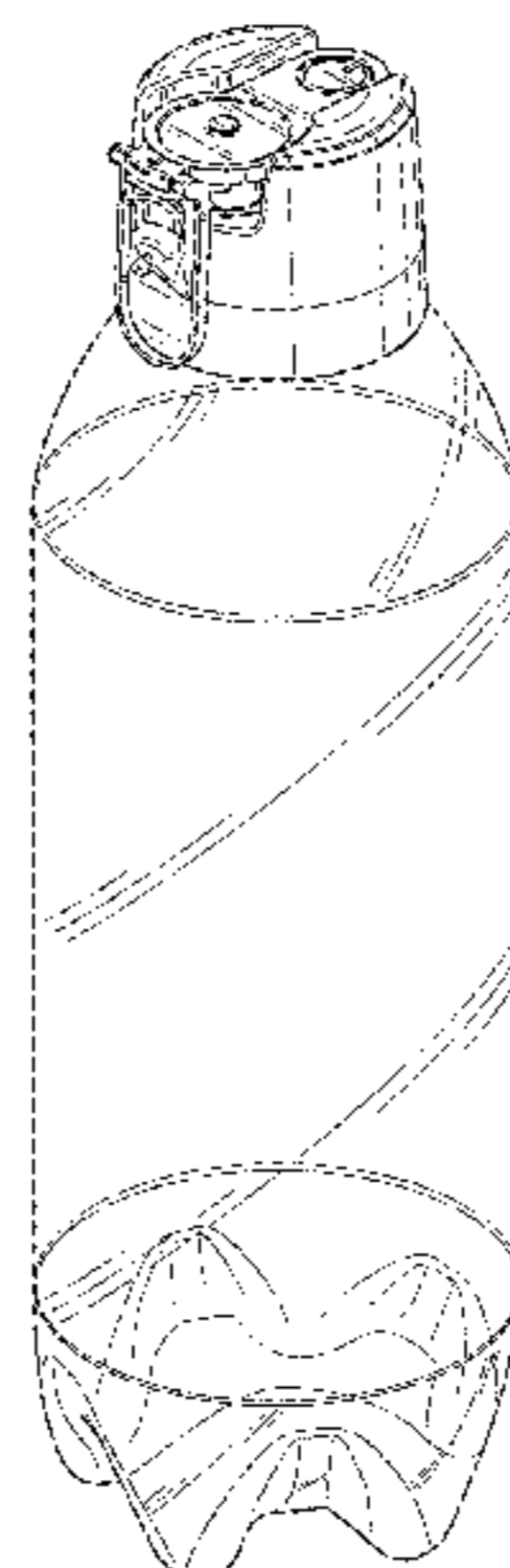
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a beverage dispenser in
a tap folded position, showing the new design;
FIG. 2 is a rear perspective view of the beverage dispenser
in the tap folded position;
FIG. 3 is a top view of the beverage dispenser in the tap
folded position;
FIG. 4 is a front perspective view of the beverage dispenser
in a tap unfolded position;

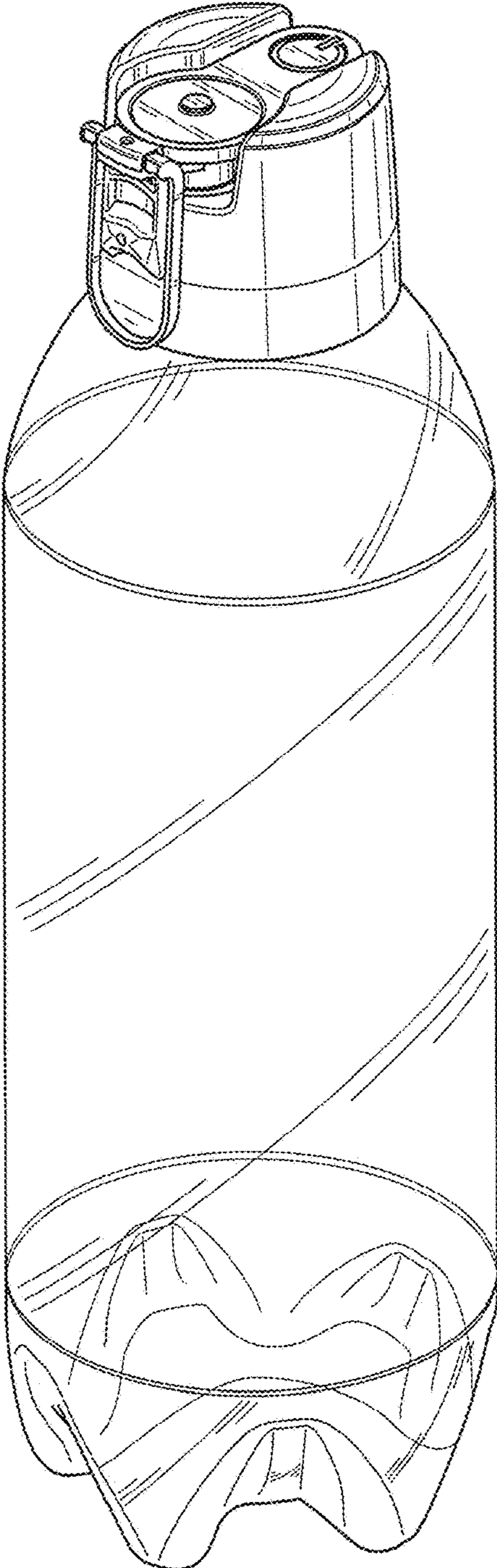

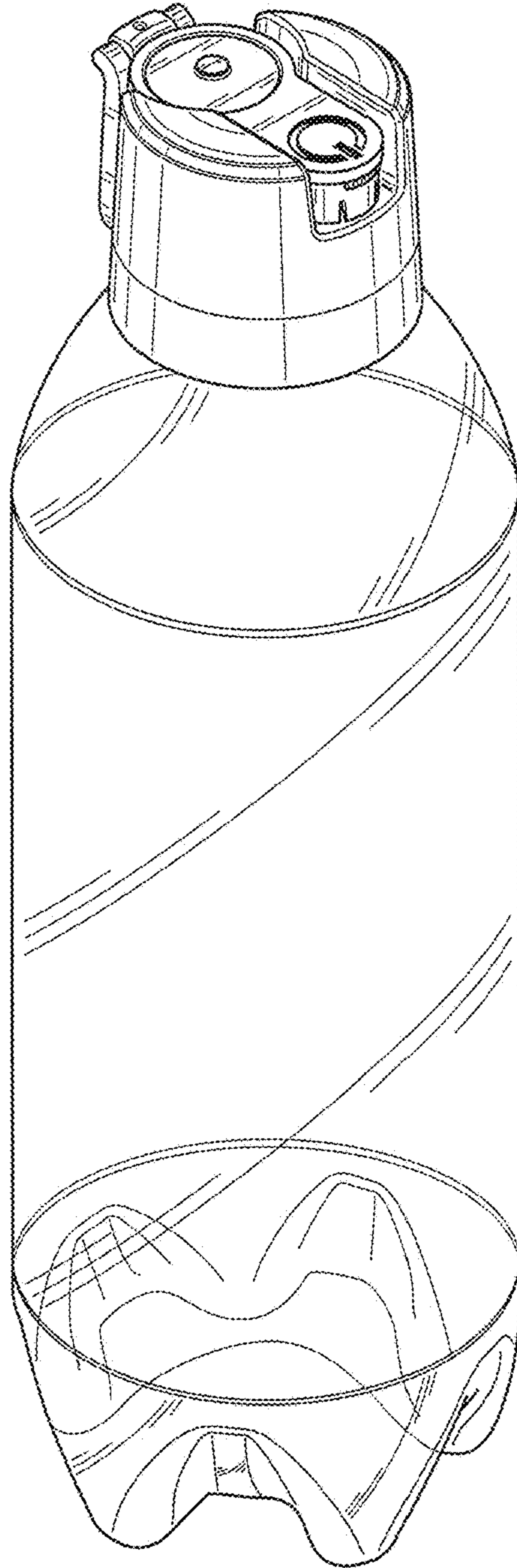

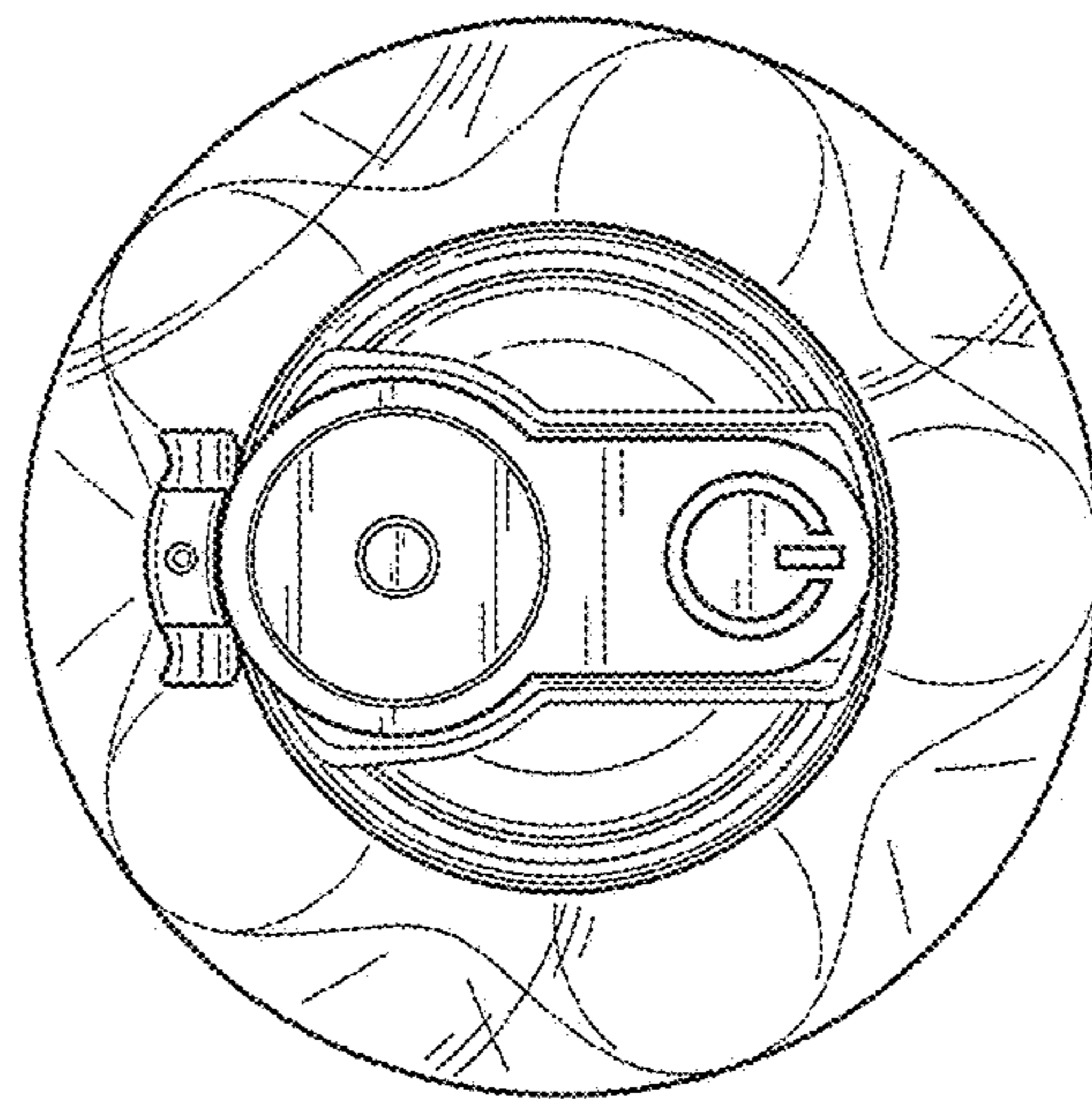

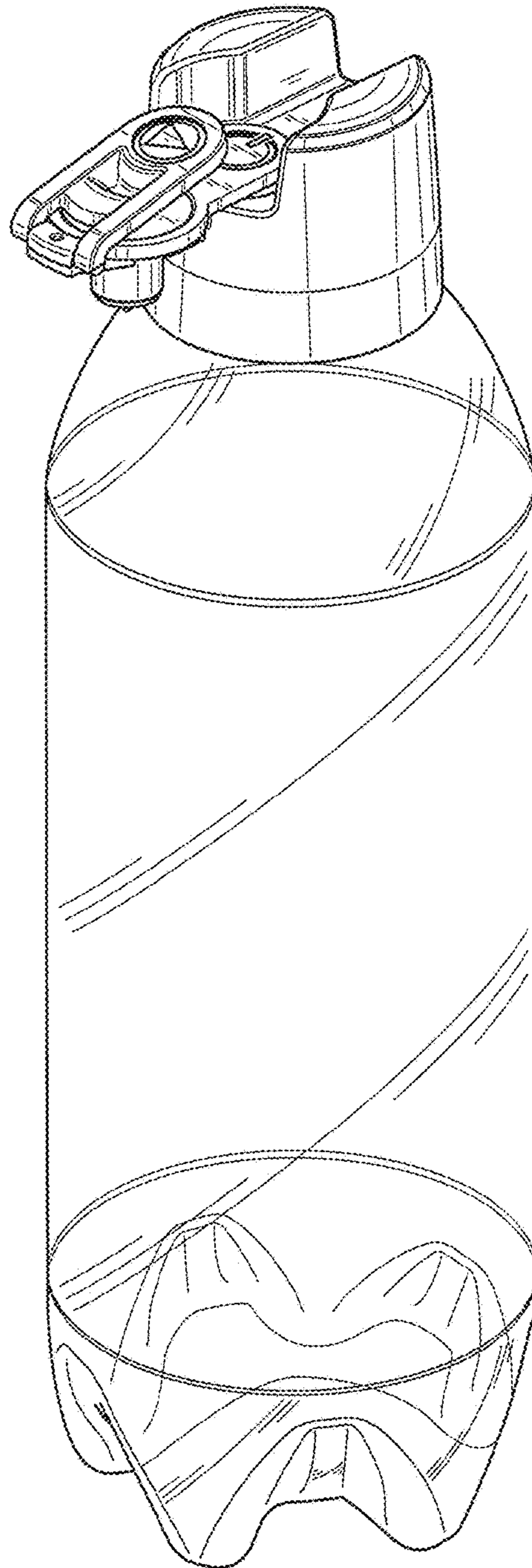

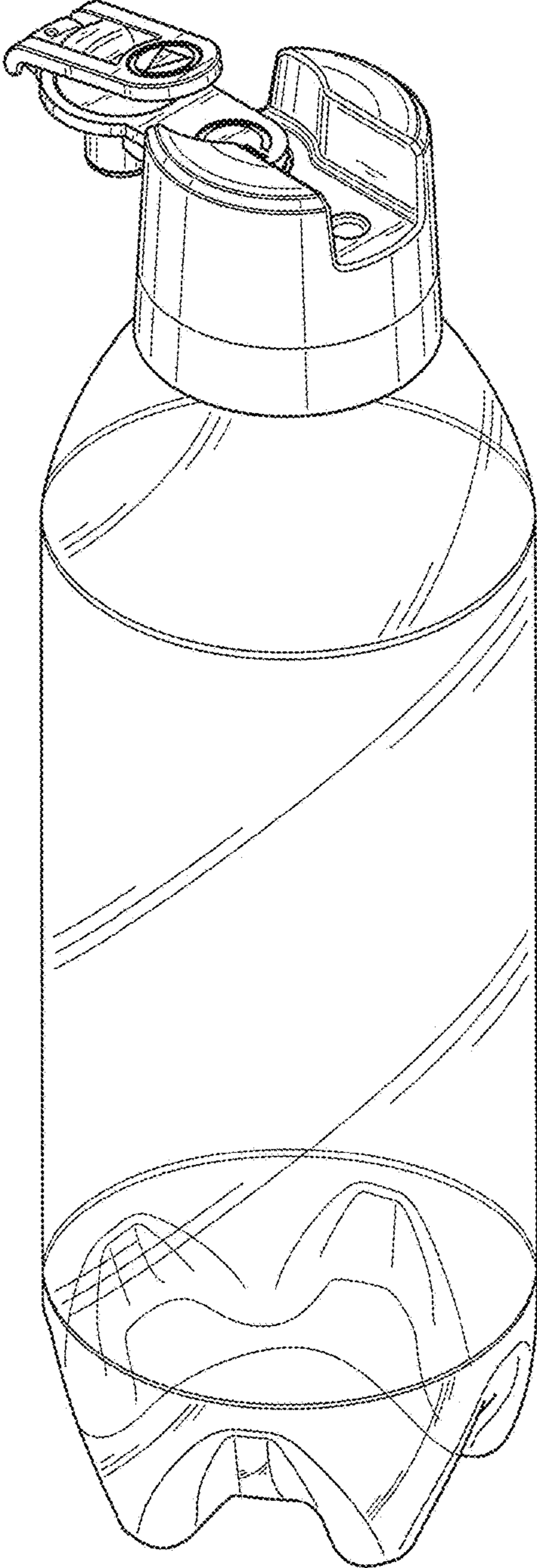

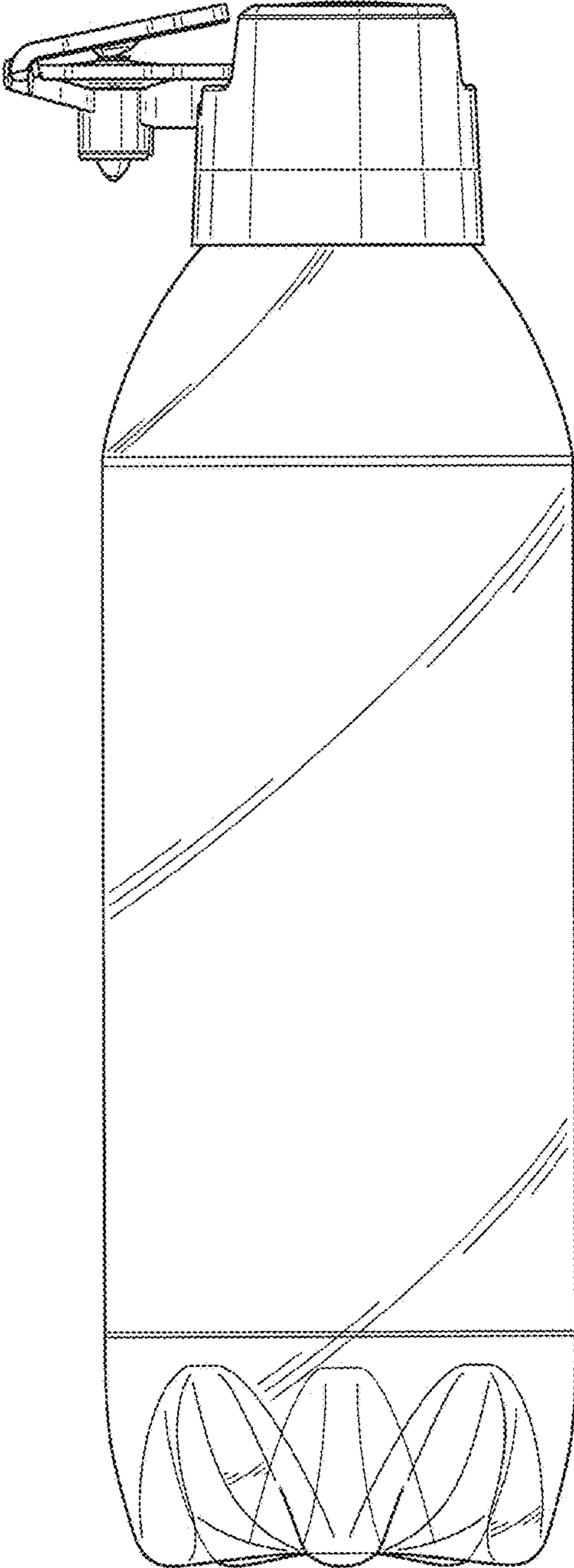

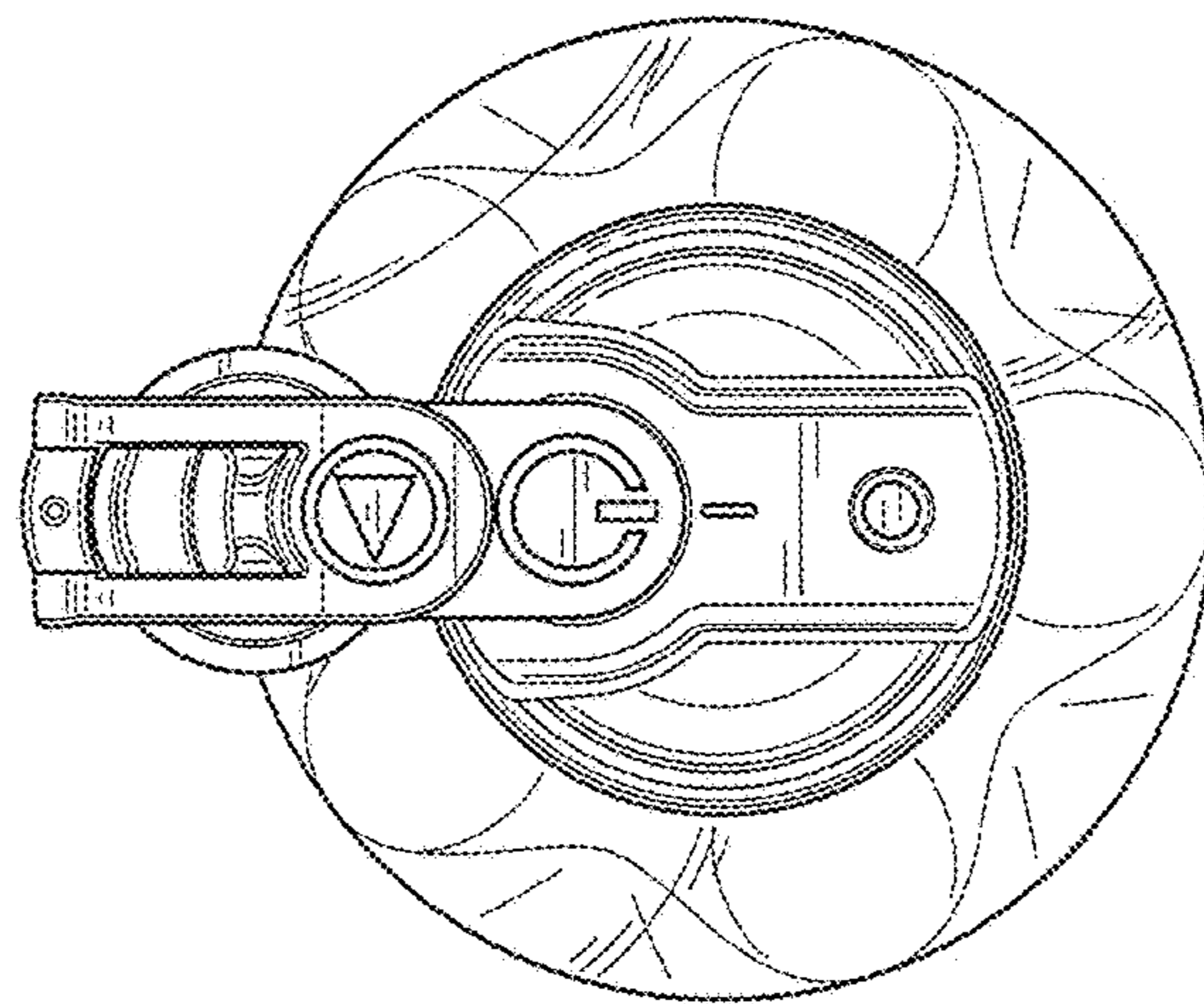
