I claim the ornamental design for a retainer for transport trays of eggs, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a retainer for transport trays of eggs showing my new design;

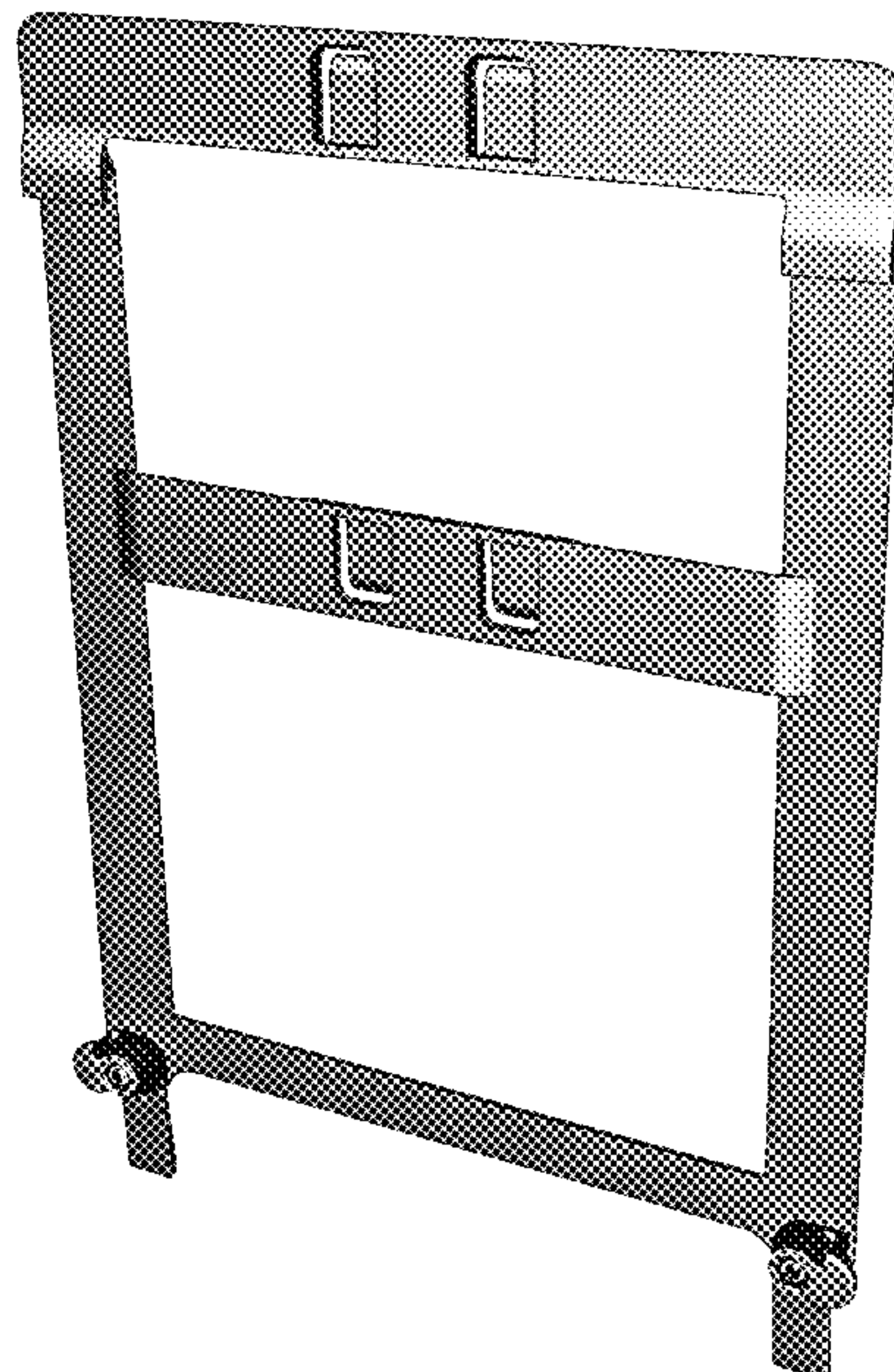

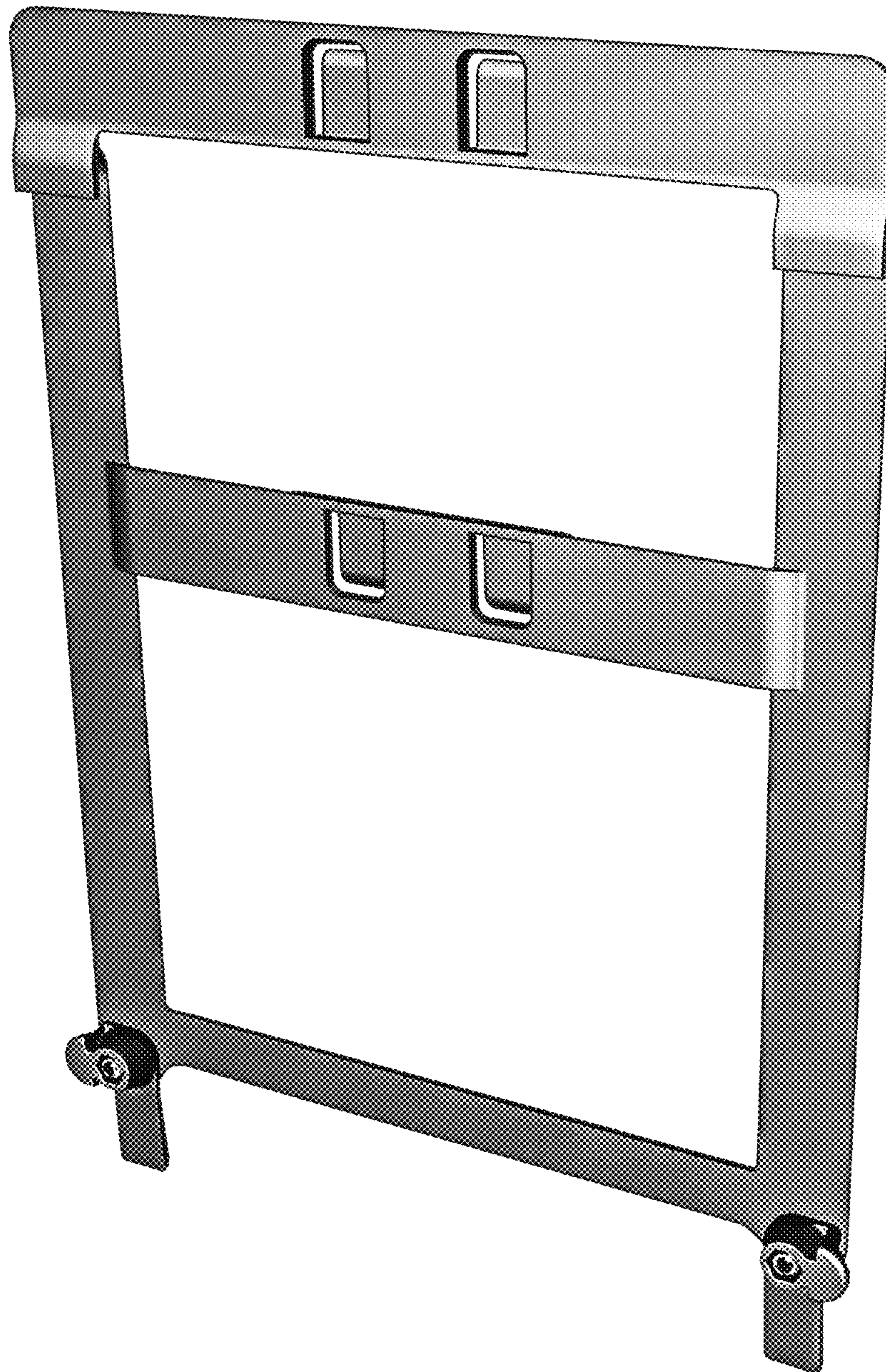

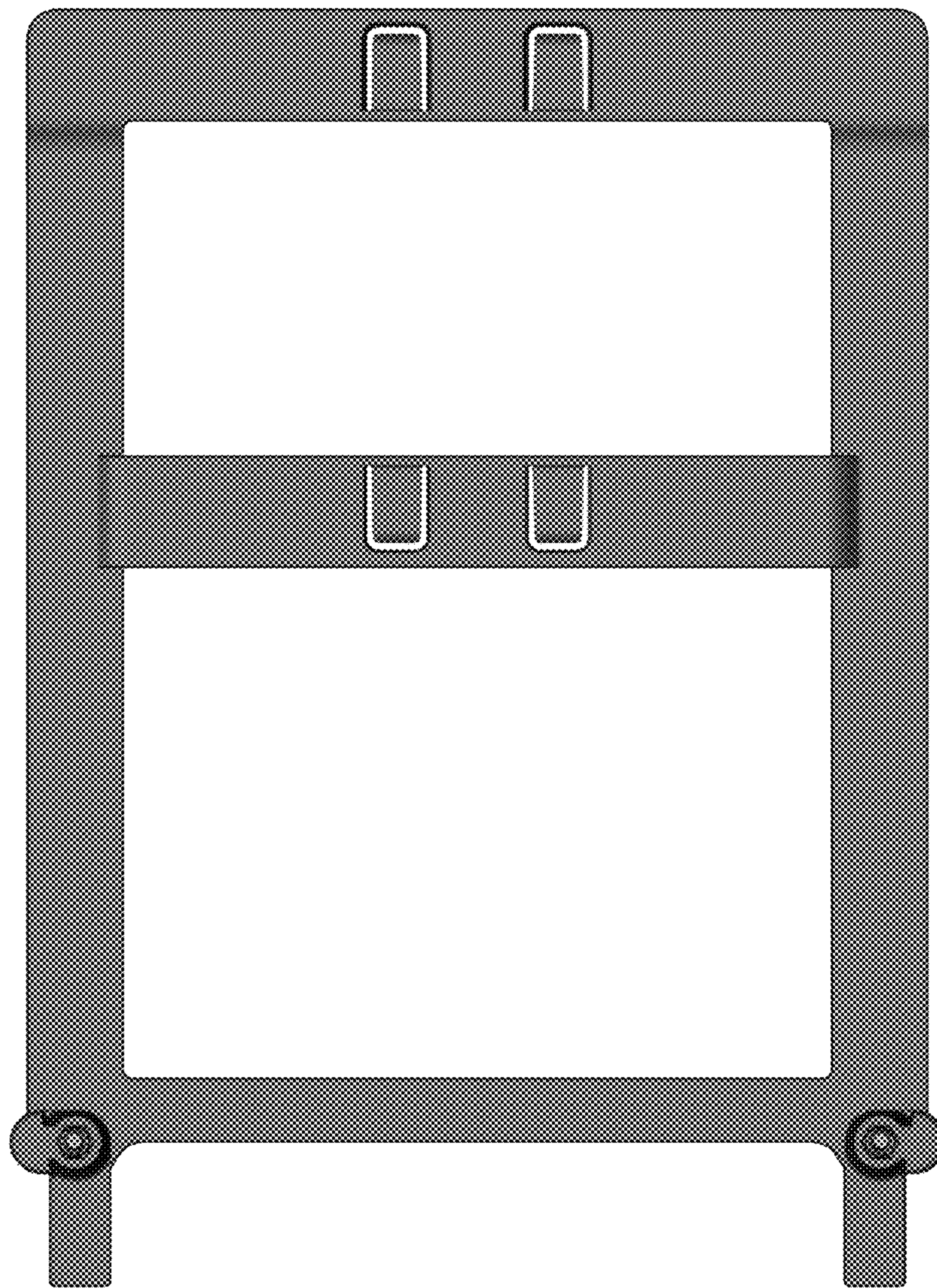
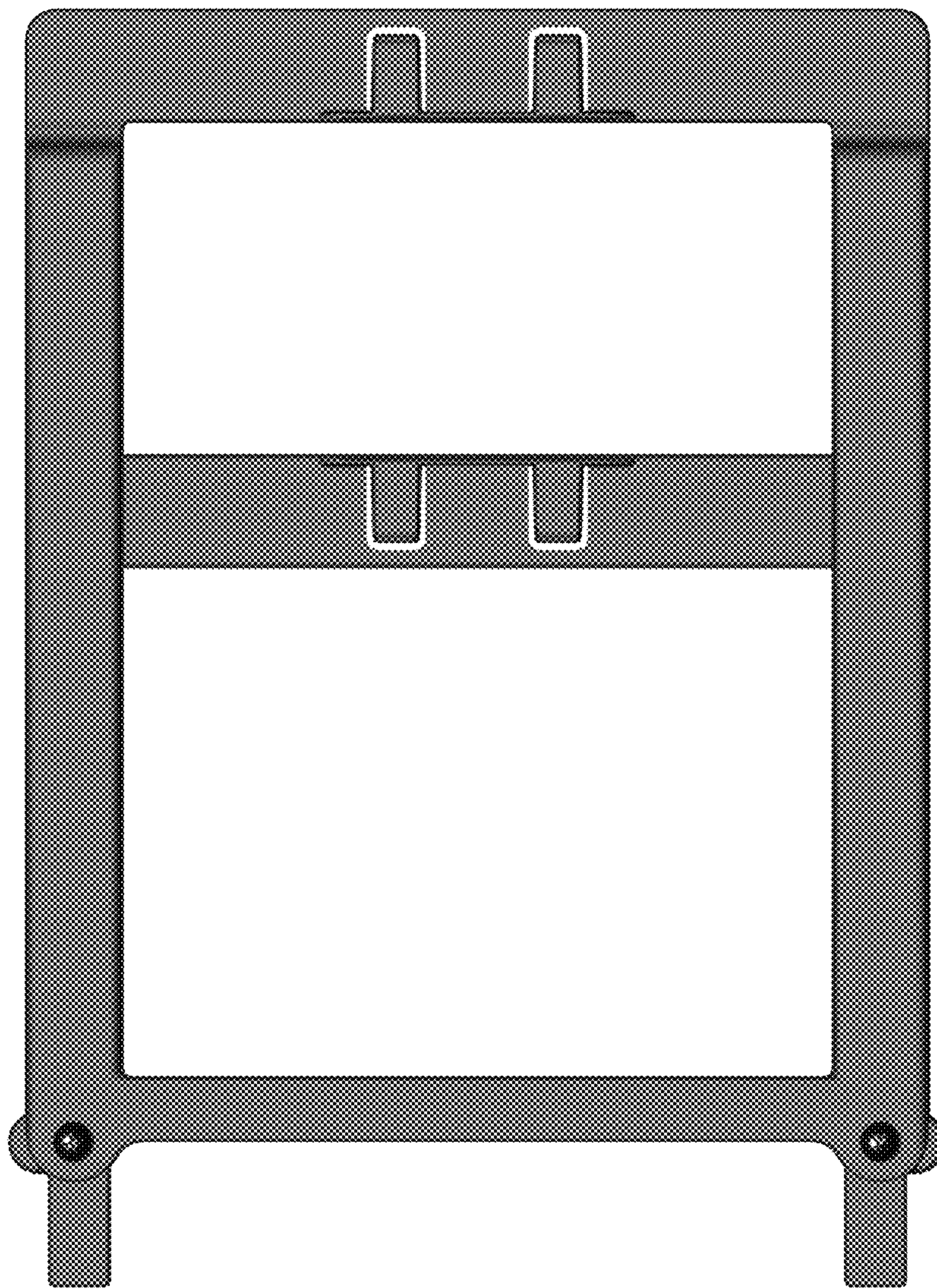

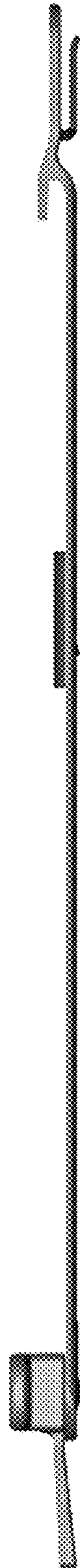

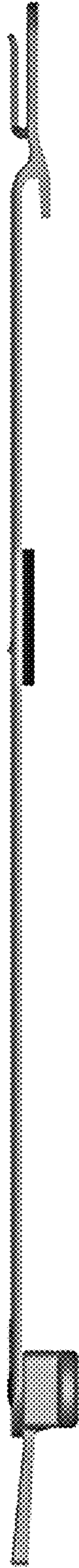

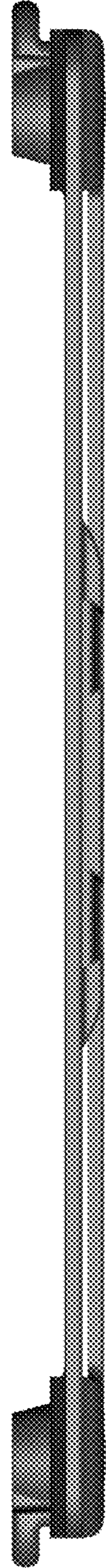
