(57) **CLAIM**

The ornamental design for handles for a front cover for cycles or motorcycles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a front cover for cycles or motorcycles showing my new design;

FIG. 4 is a side view thereof;

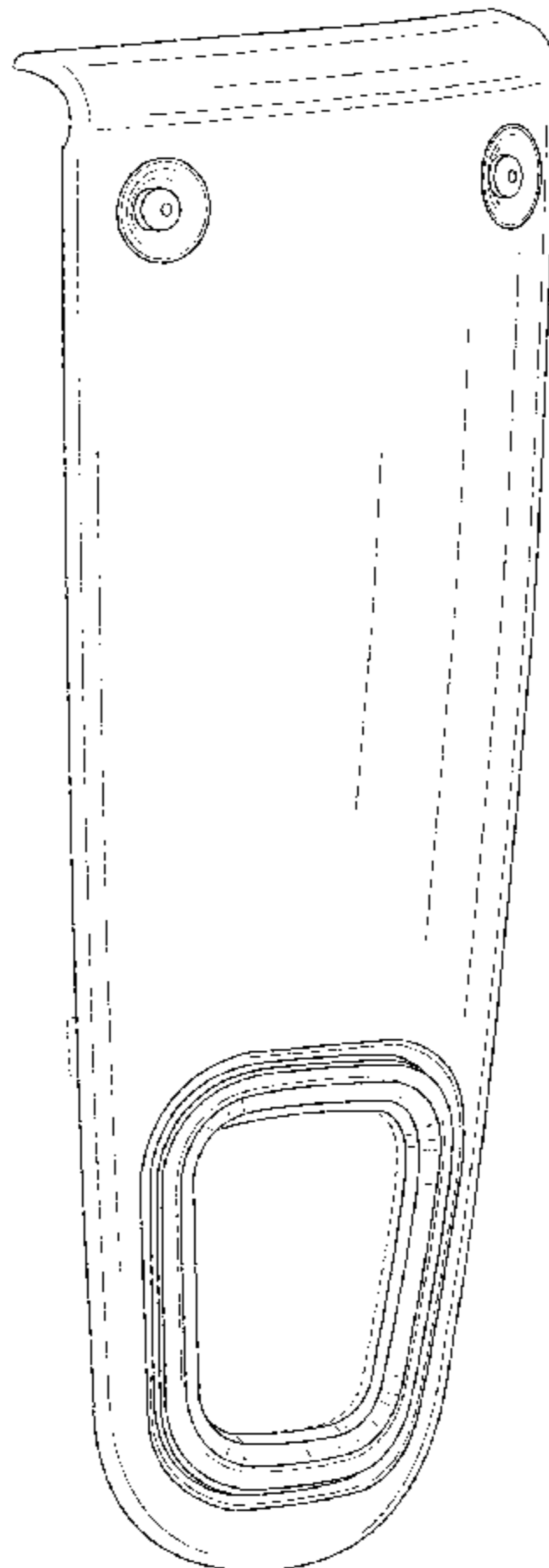
FIG. 5 is a side view thereof, opposite that of FIG. 4.

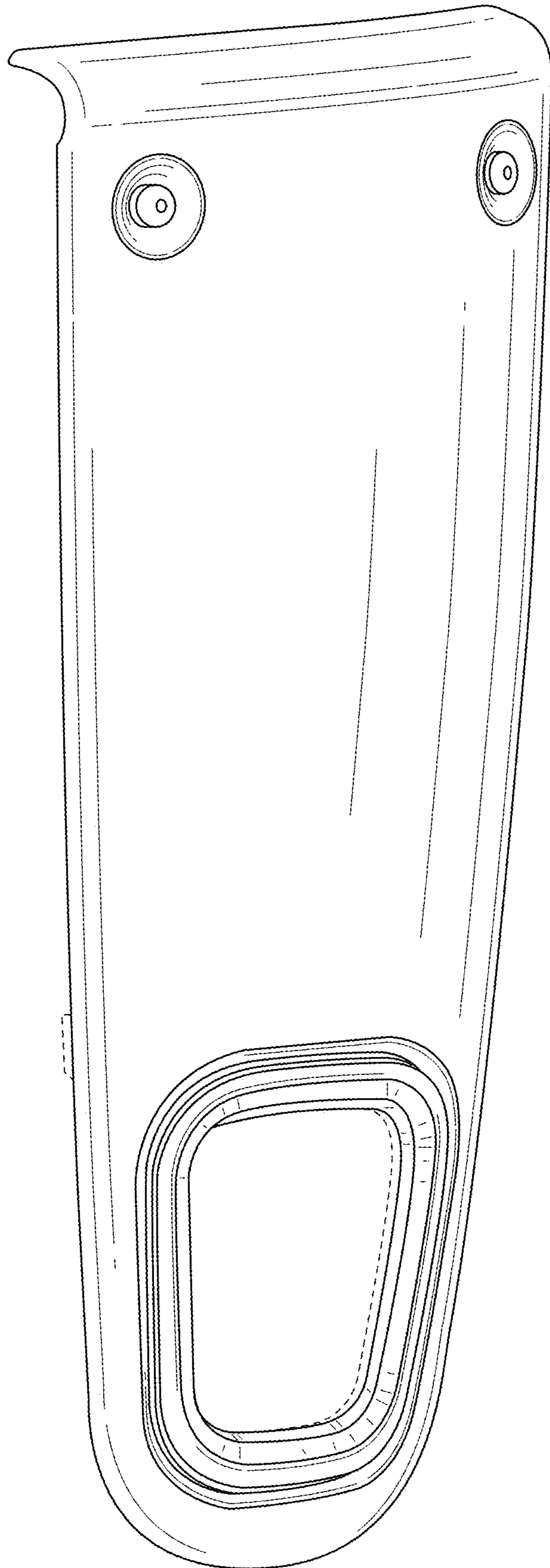

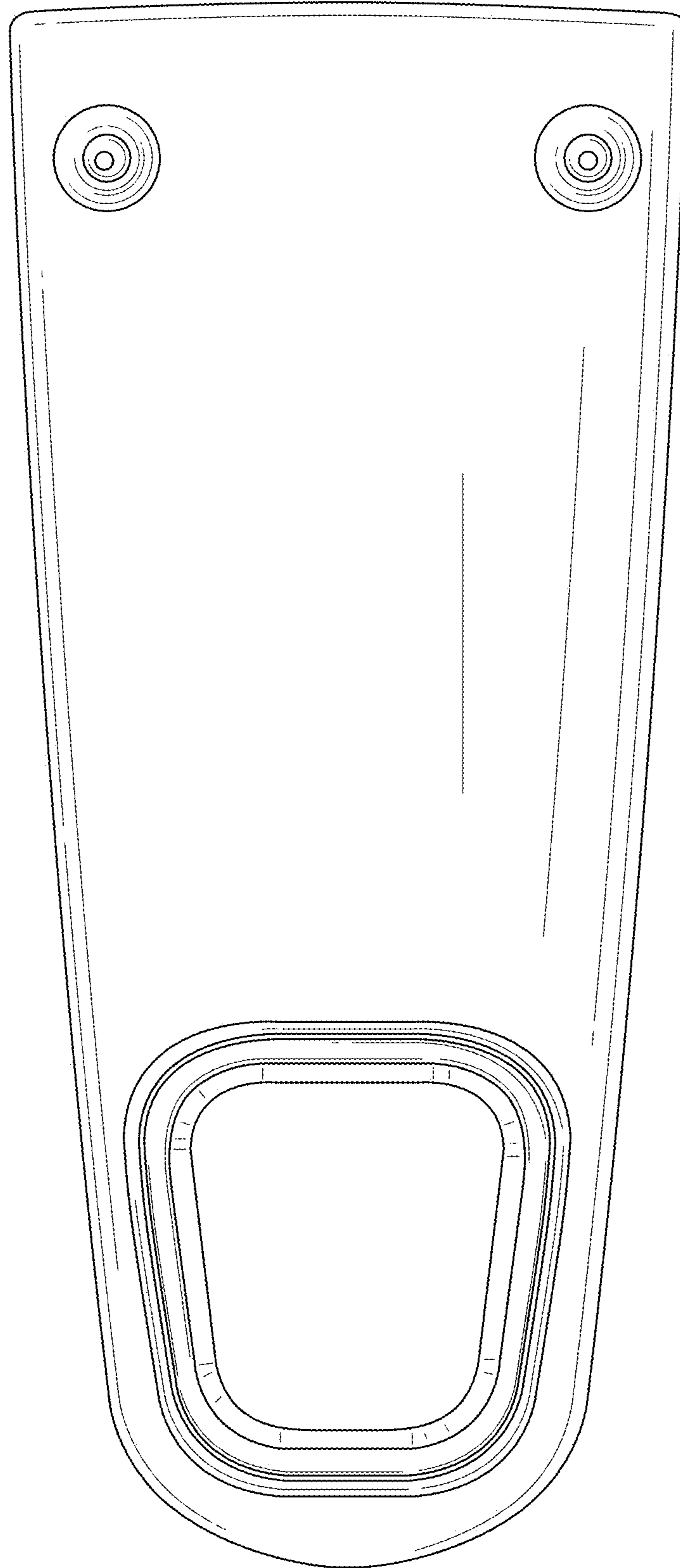

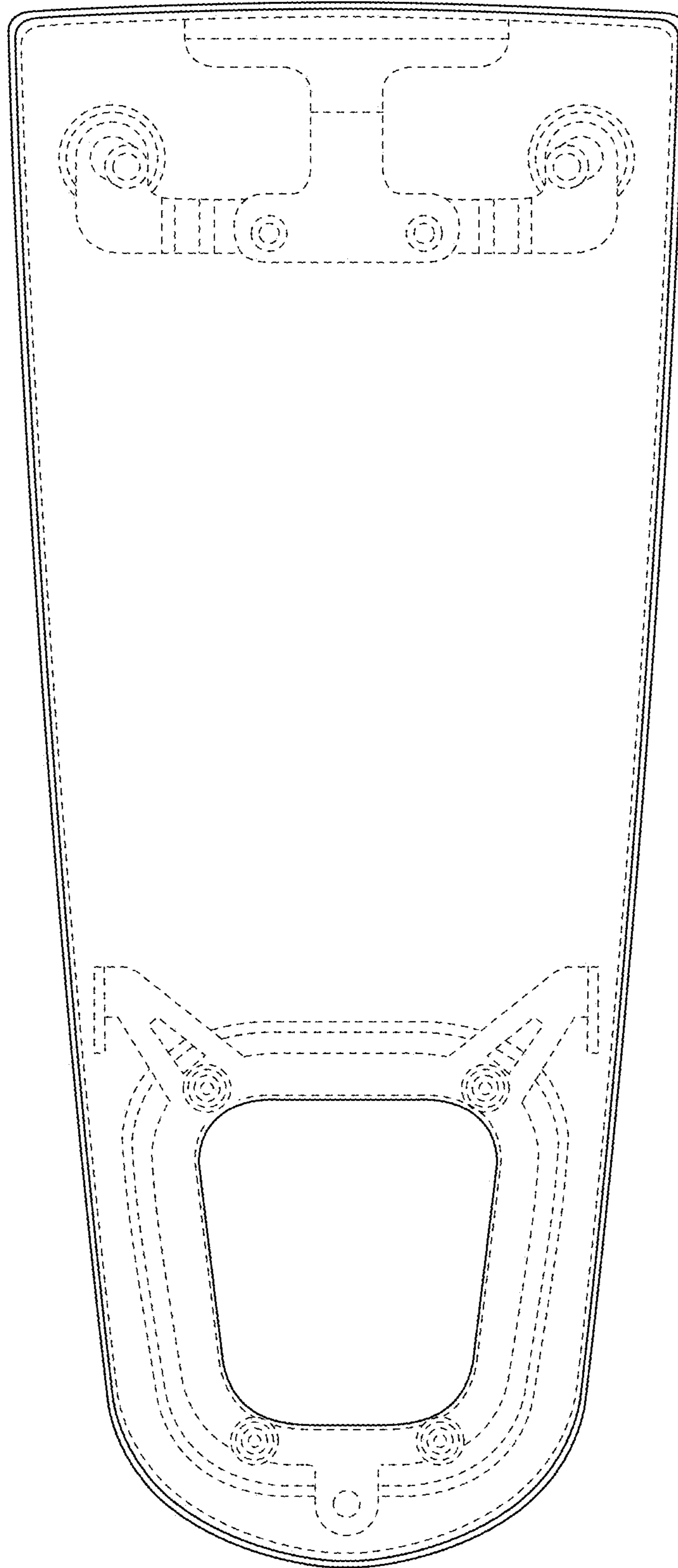

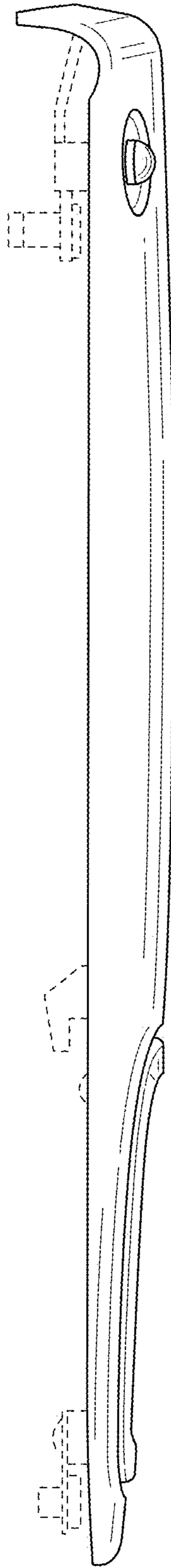

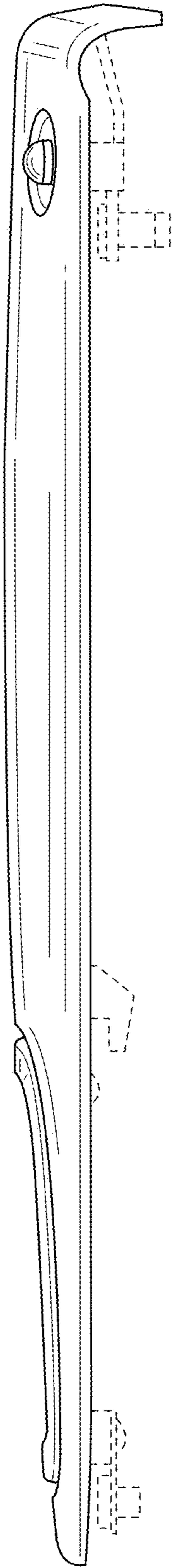

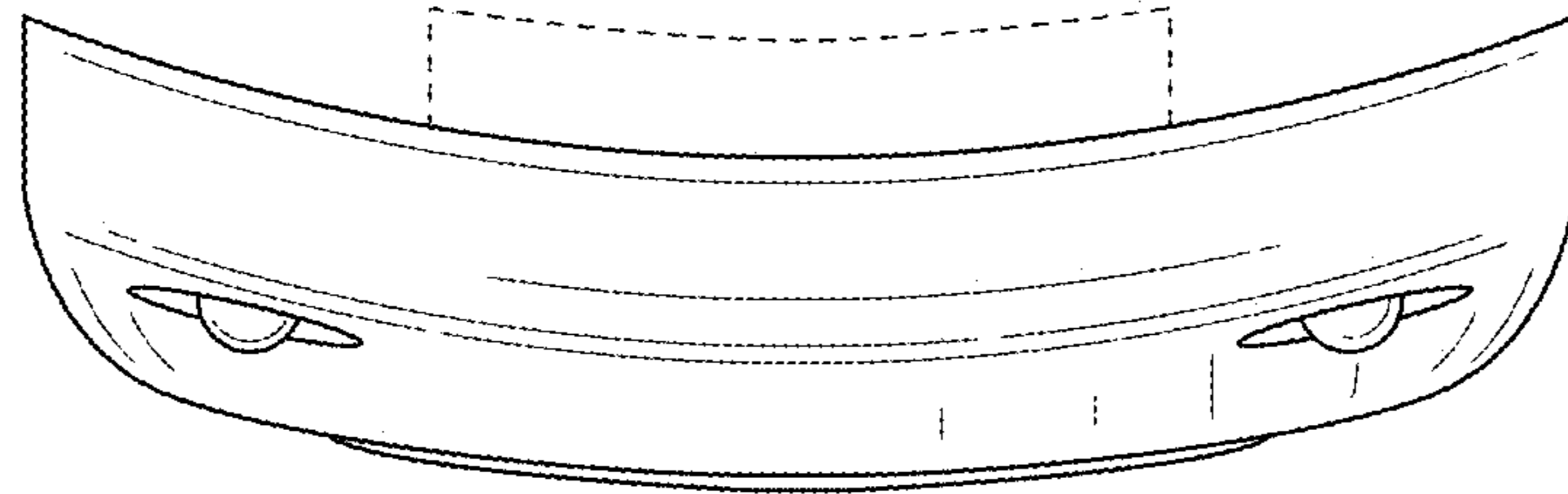

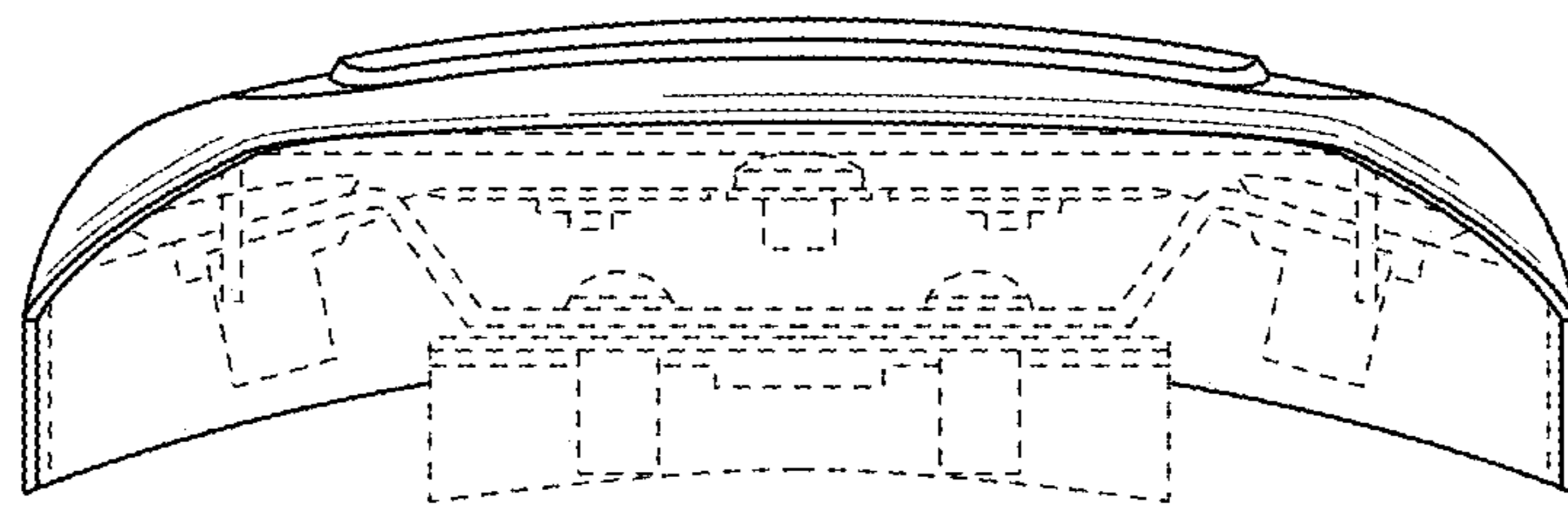
