(57) **CLAIM**

The ornamental design for front outward flange of a vehicle wheel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a front outward flange of a vehicle wheel according to my new design;
FIG. 2 is a elevational view thereof;
FIG. 3 is a side elevational view thereof; and,
FIG. 4 is an enlarged view of the generally oval indent feature of my new design.

The broken lines depict portions of the front outward flange of a vehicle wheel that form no part of the claim.

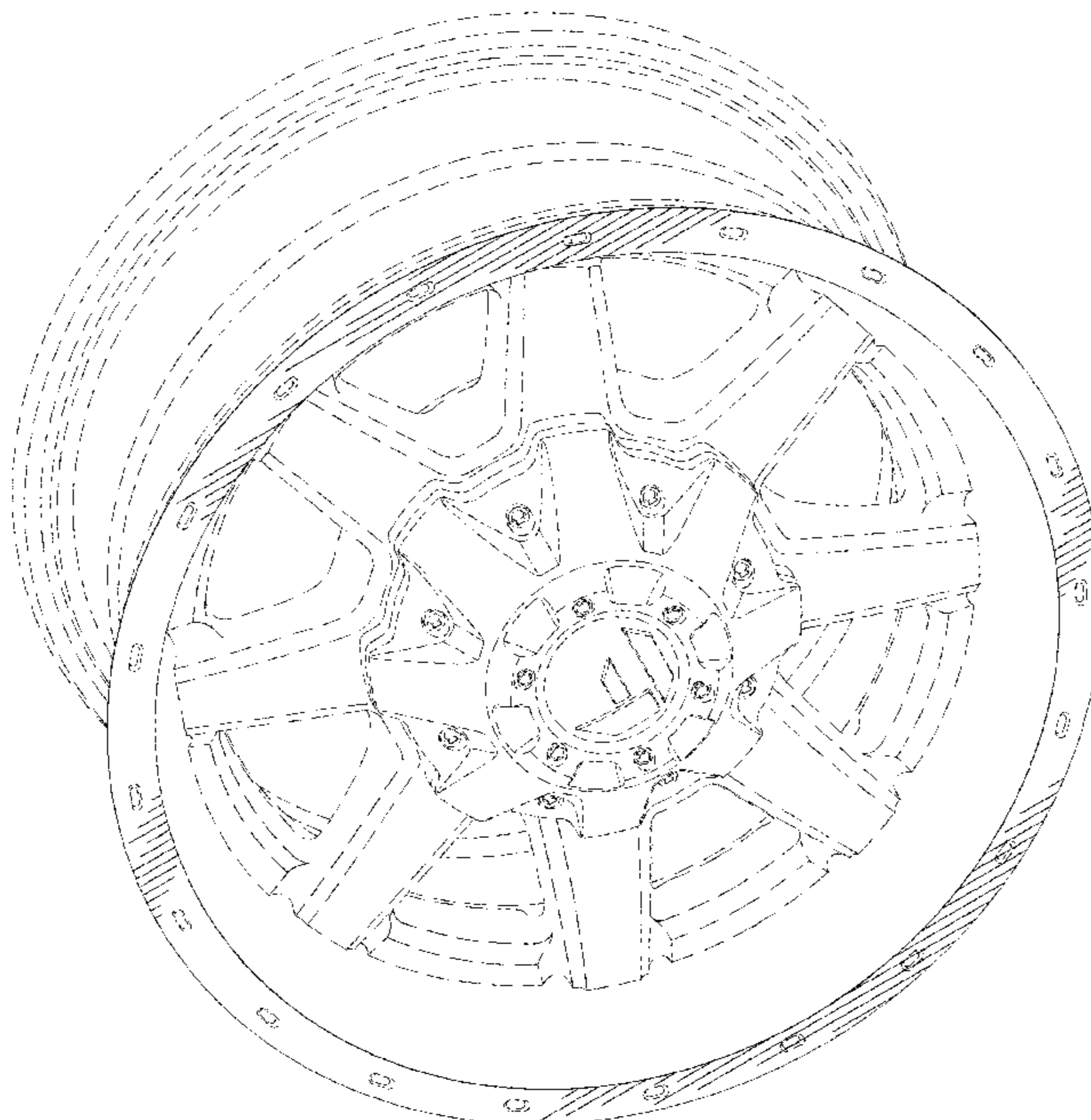

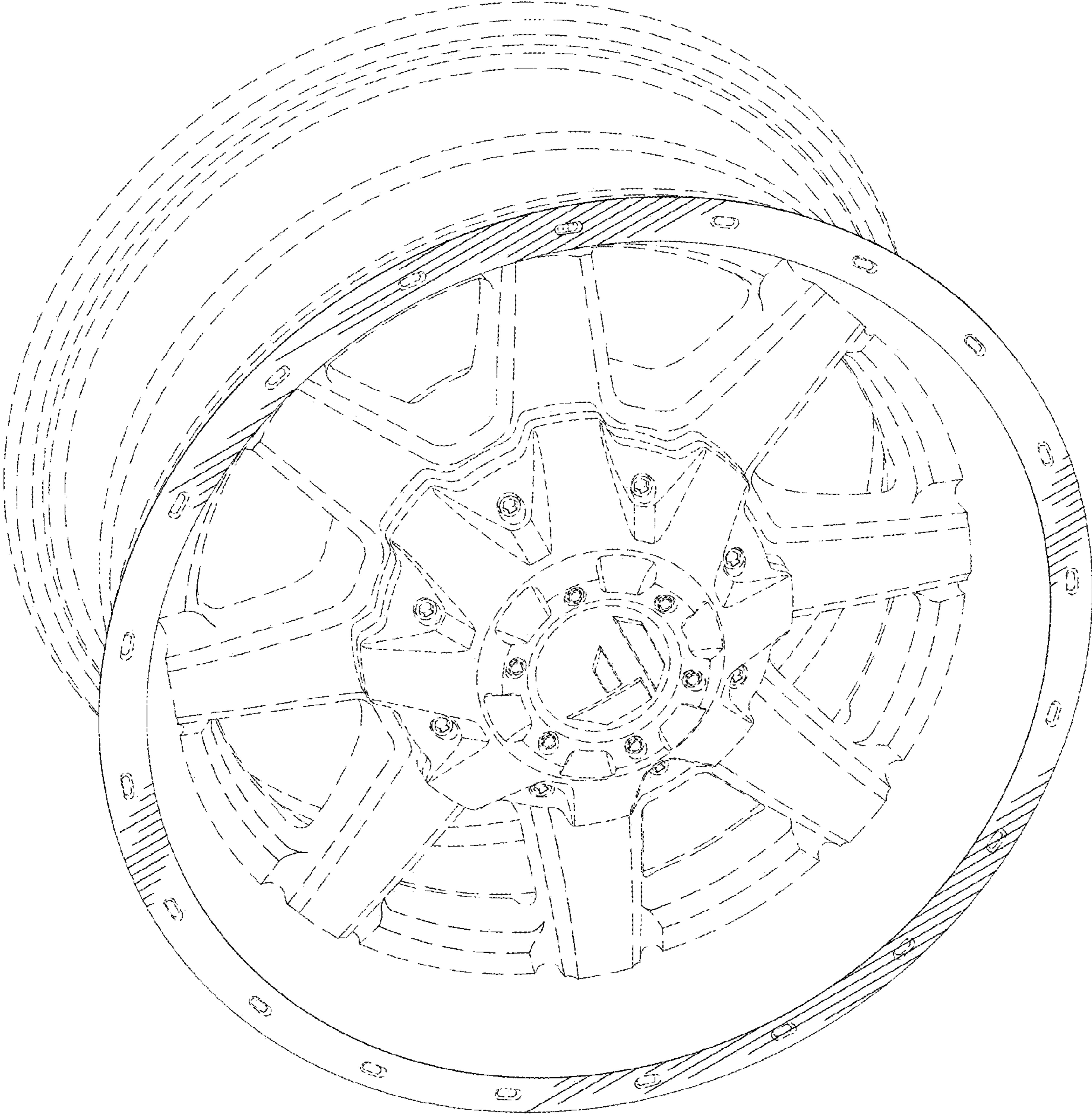

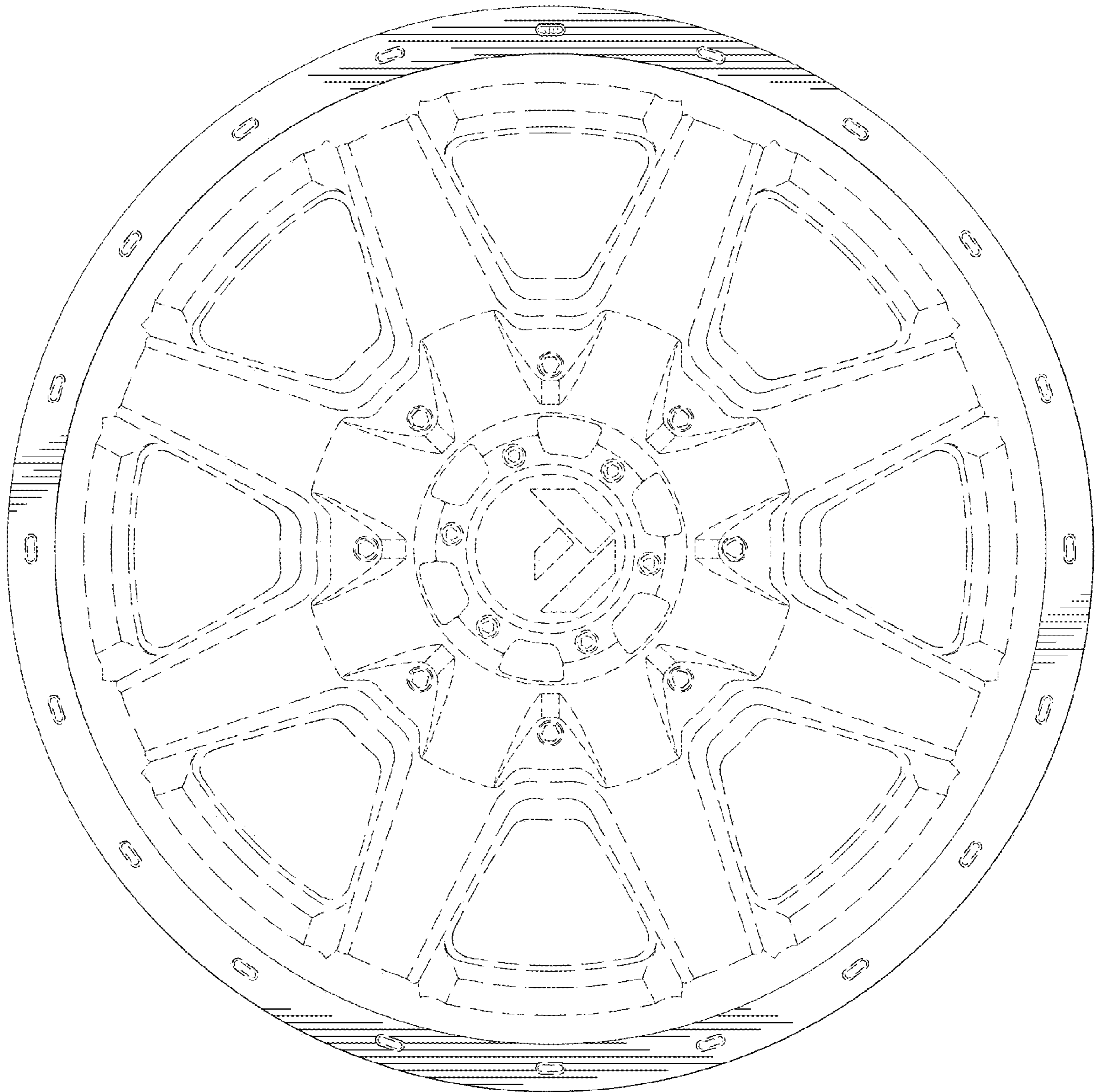

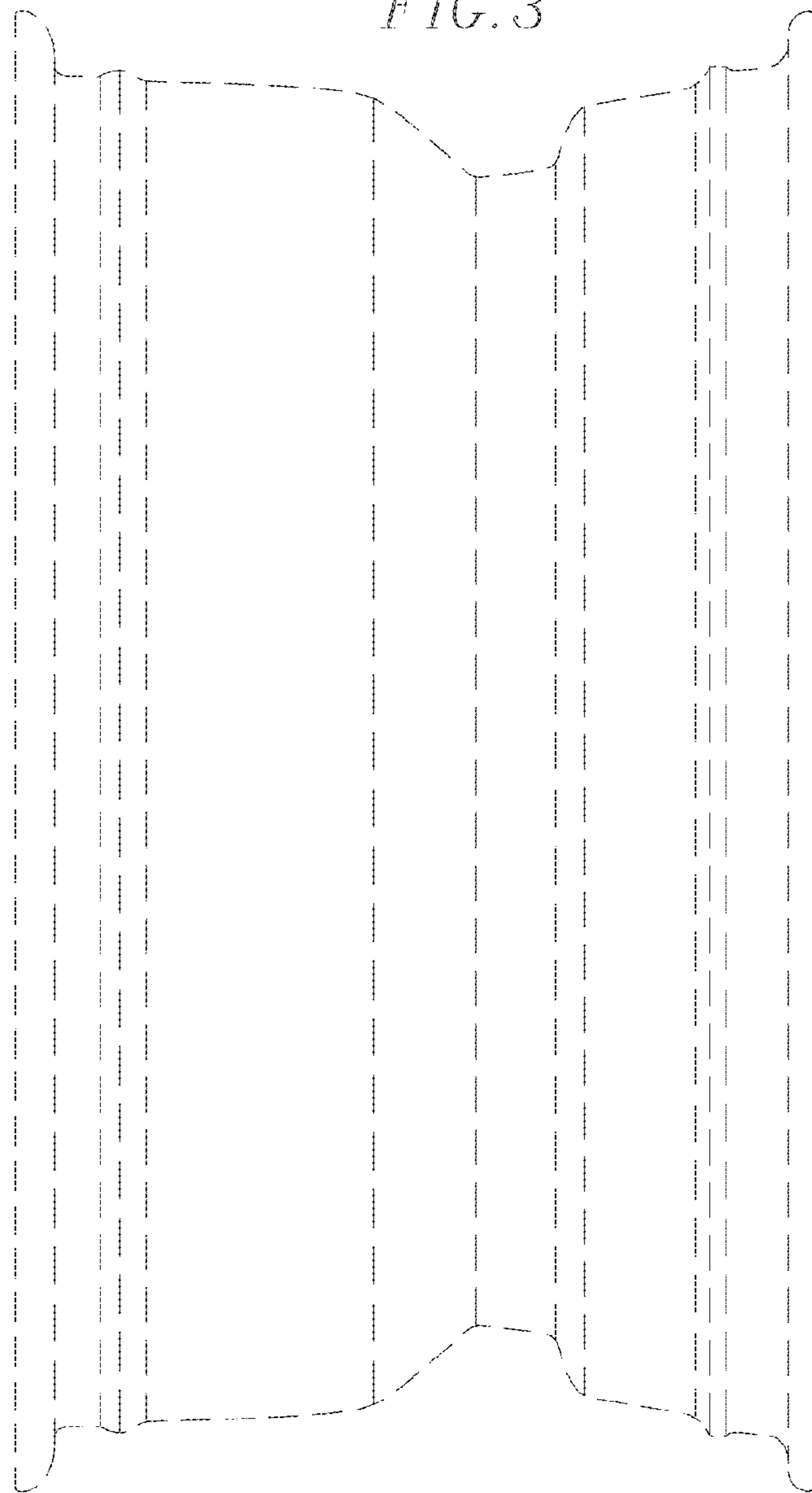
