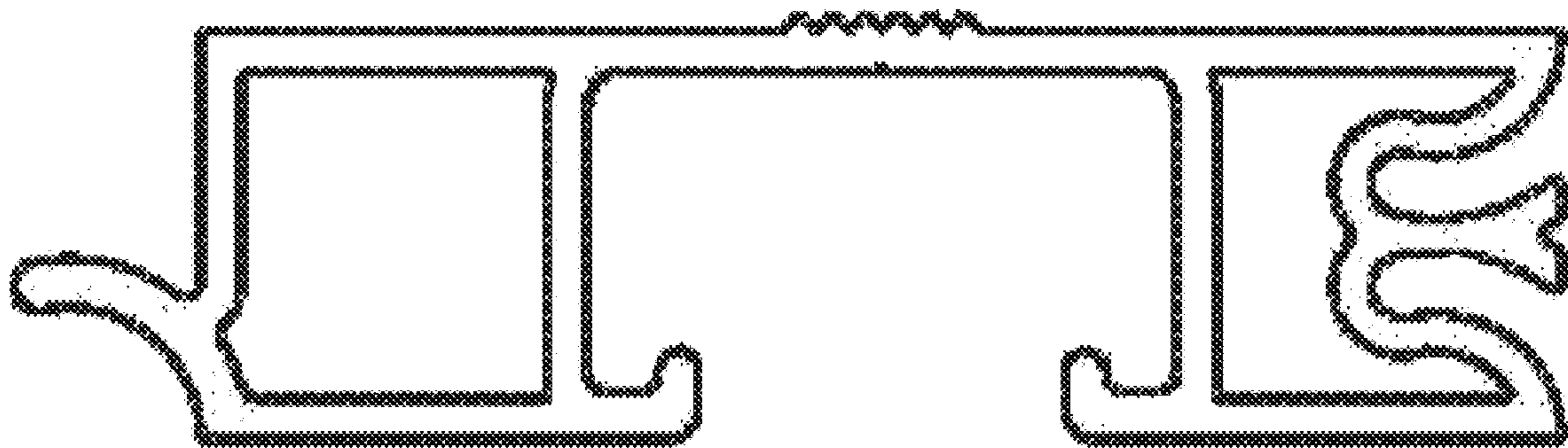
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an above front perspective view of an extrusion showing my new design;

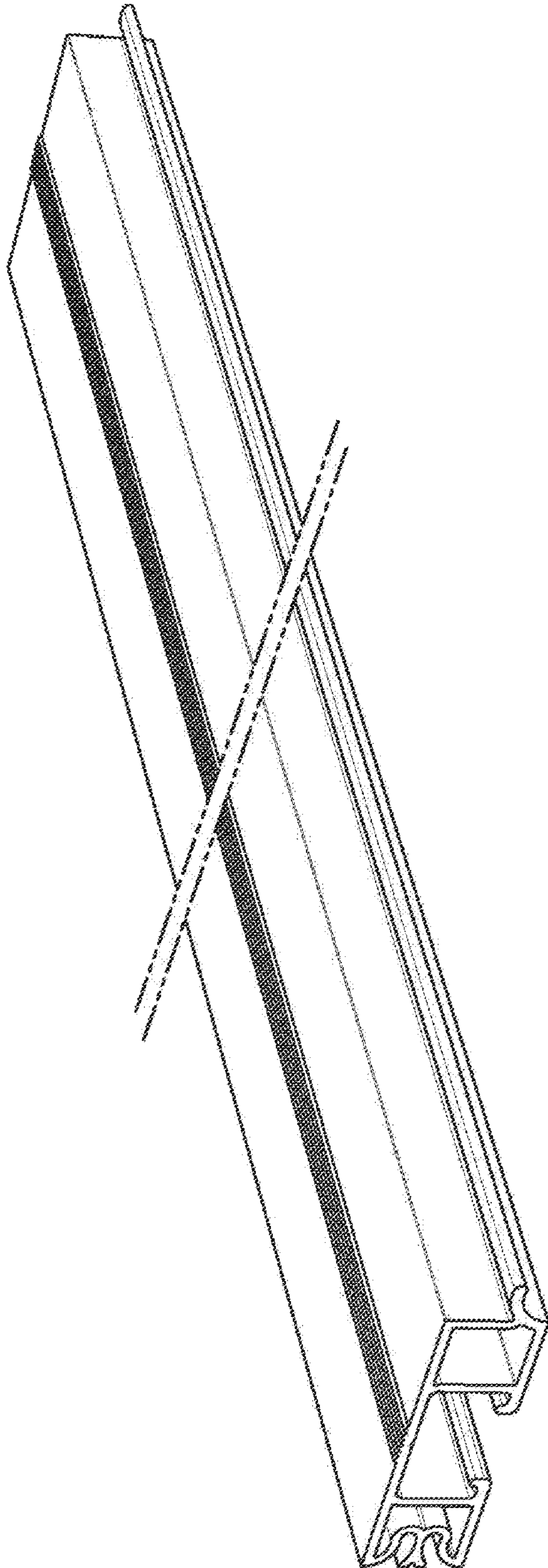

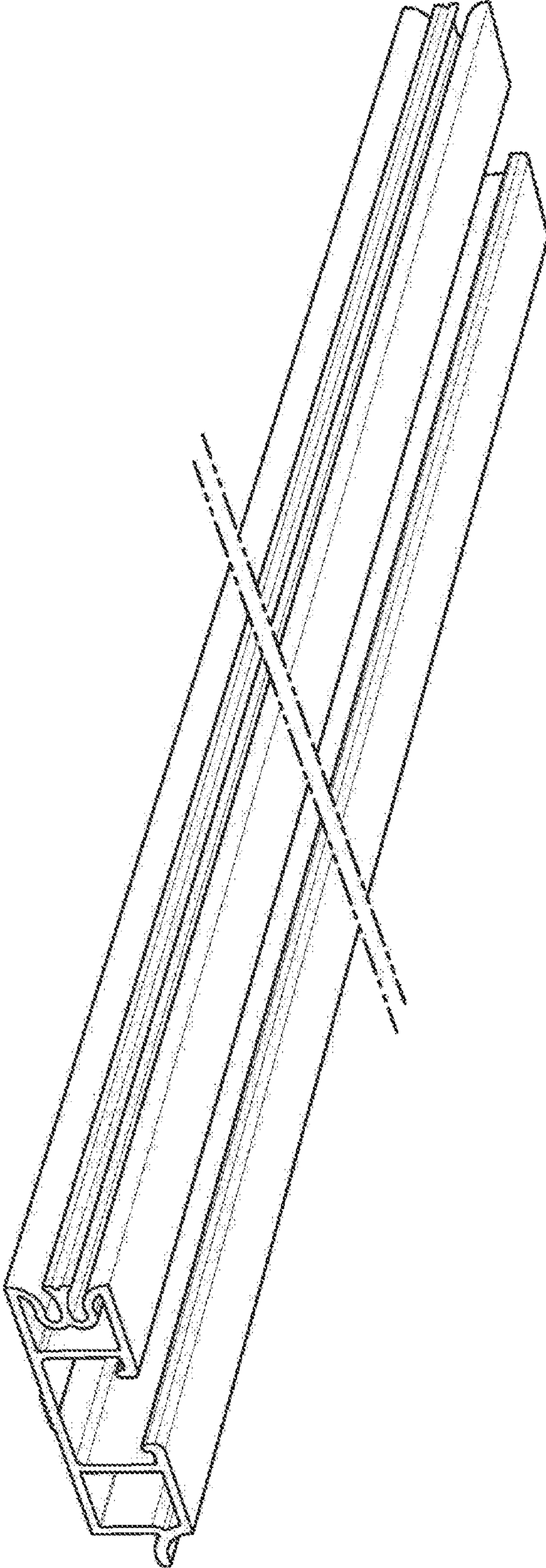

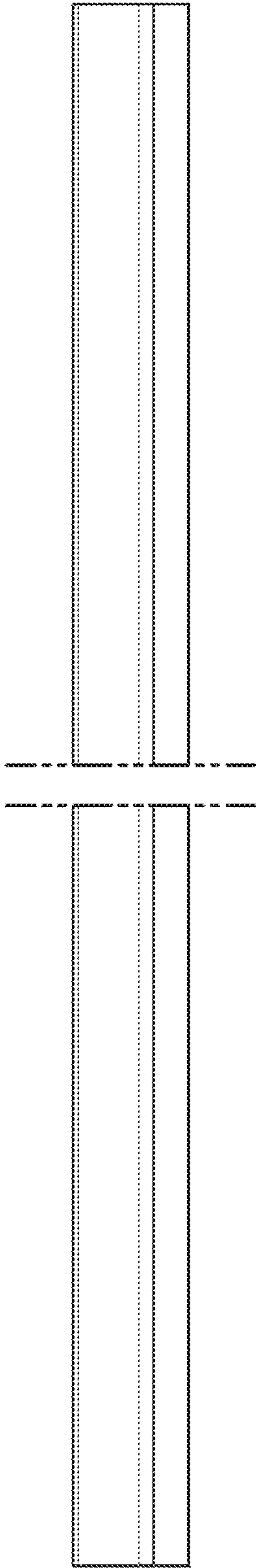

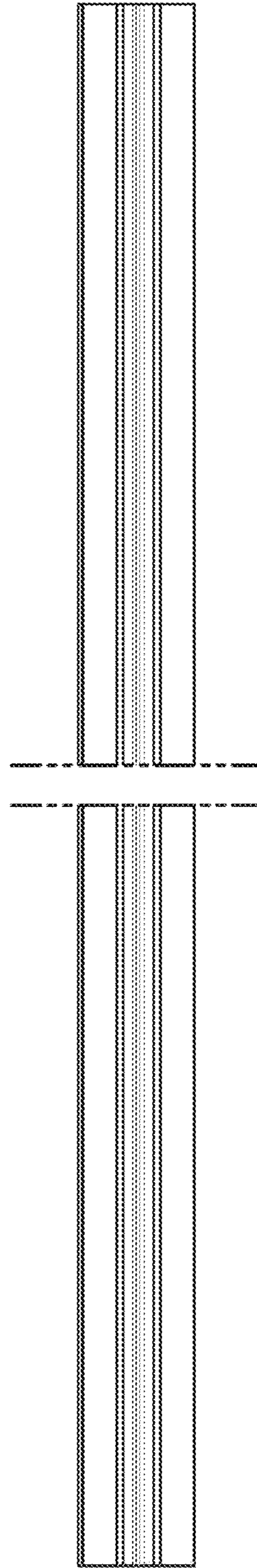

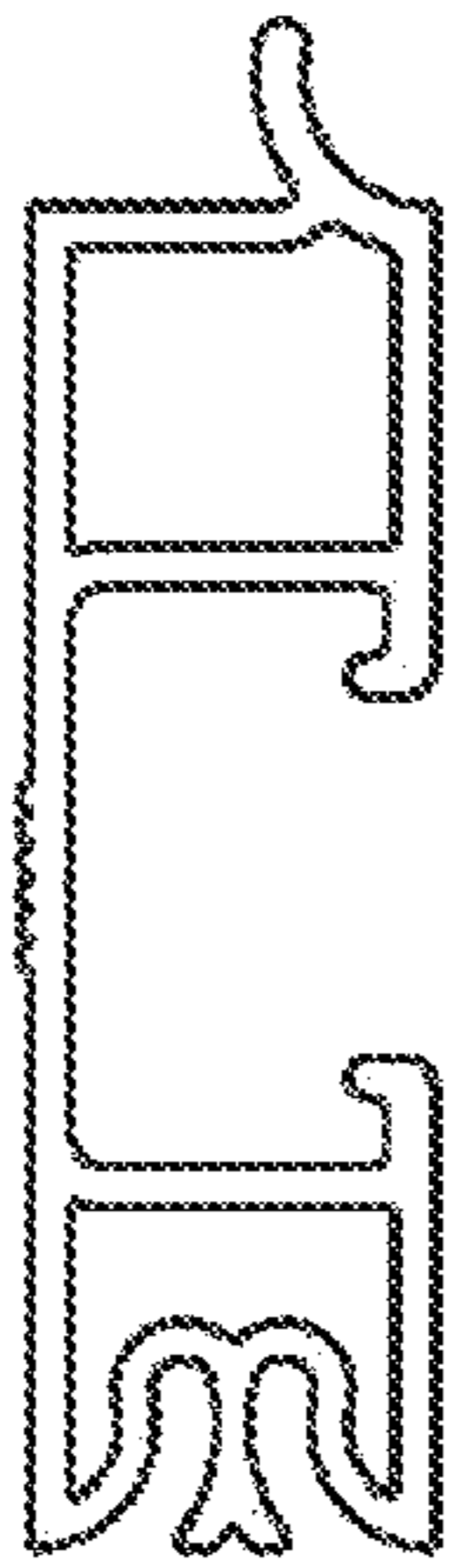

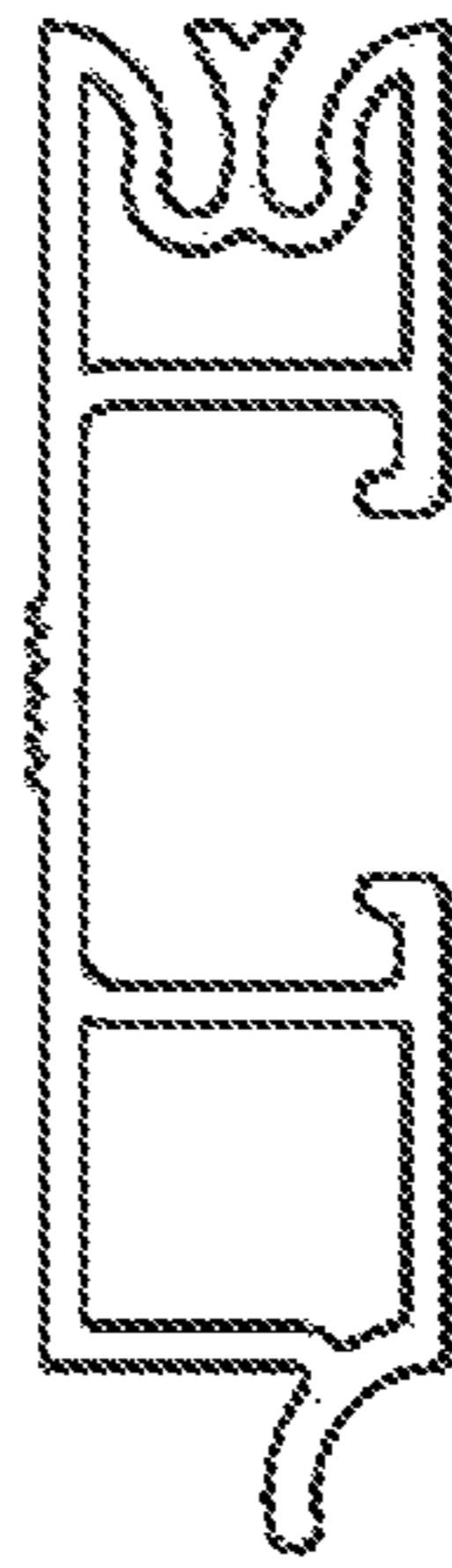

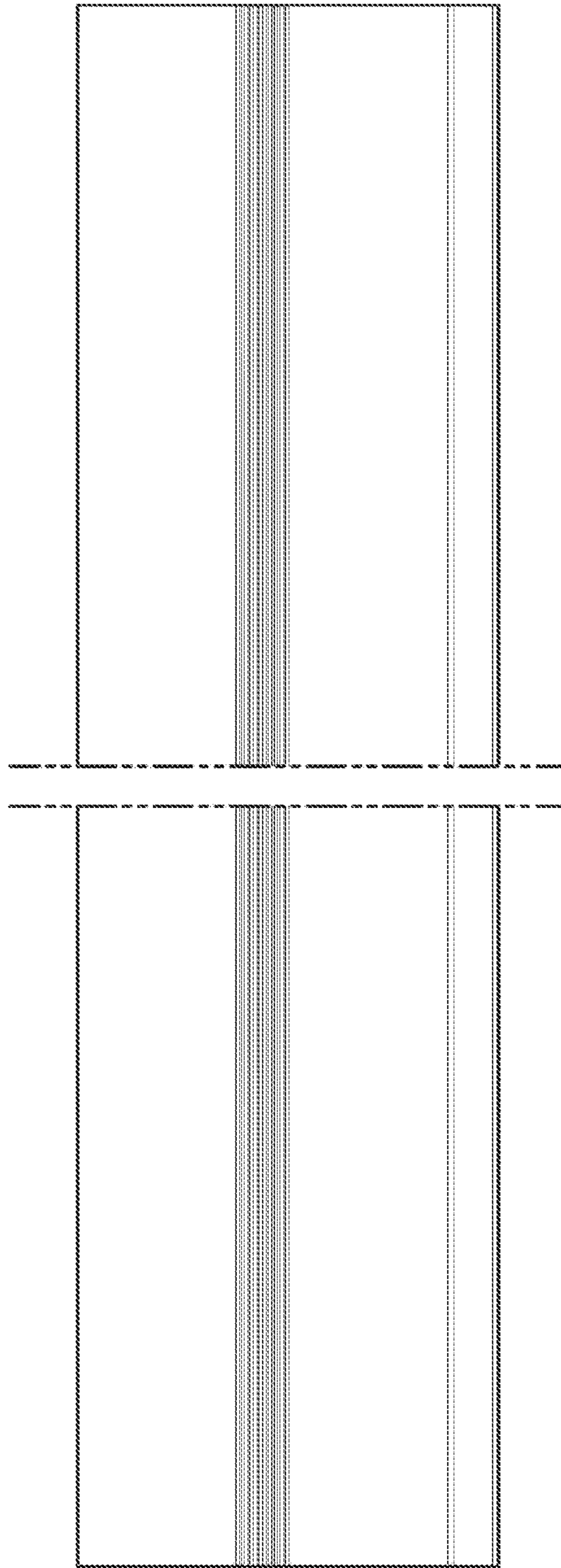

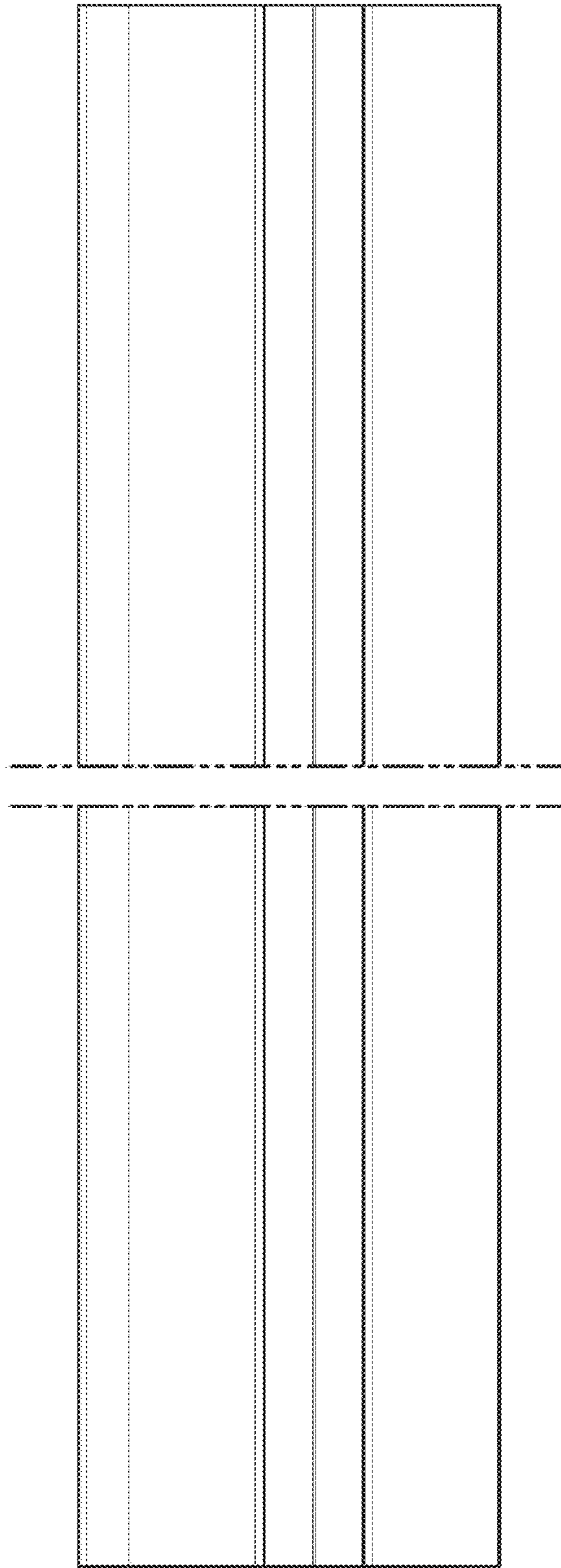
