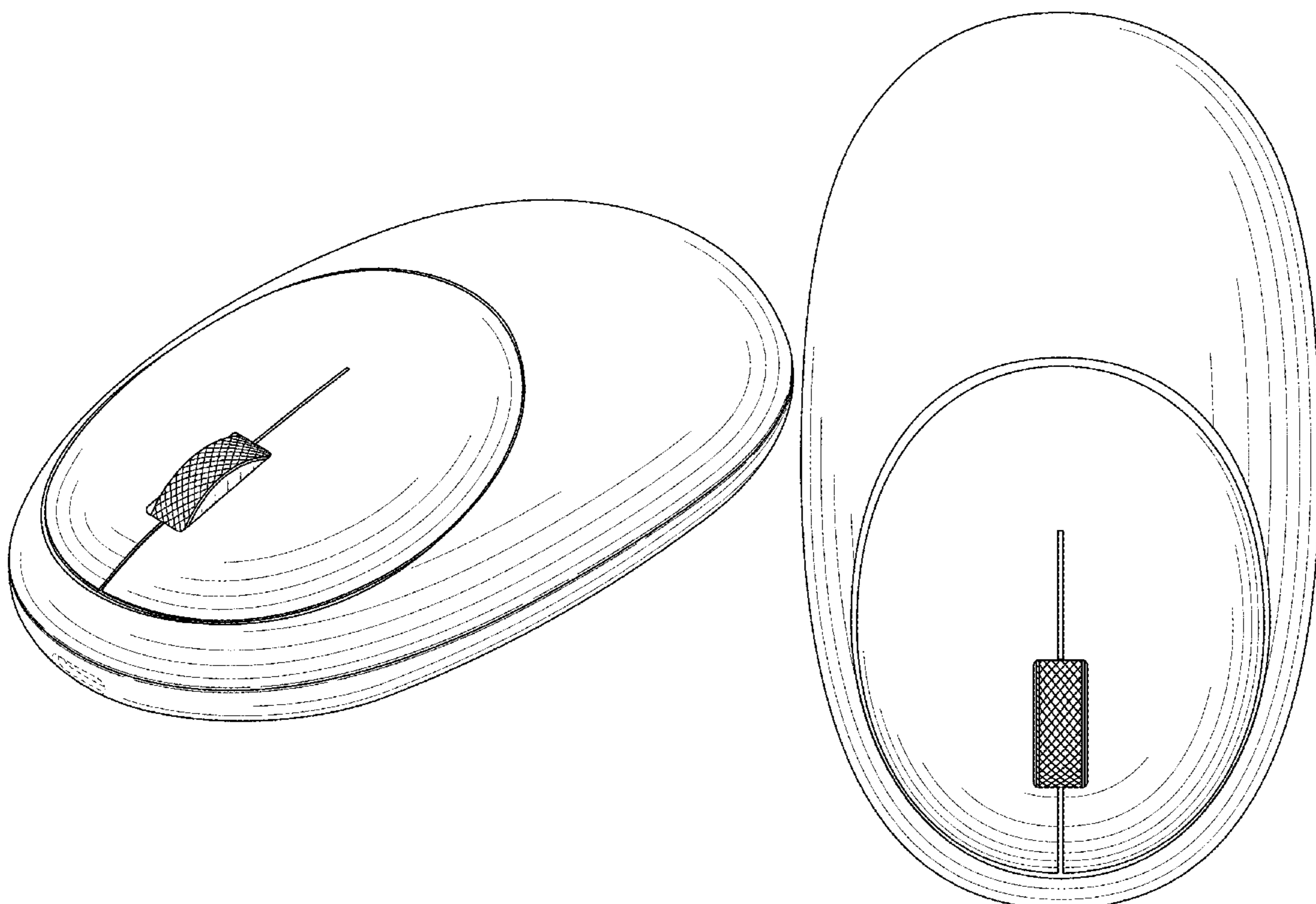
(57) **CLAIM**

What is claimed is an ornamental design for a computer mouse, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a computer mouse showing our new design;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

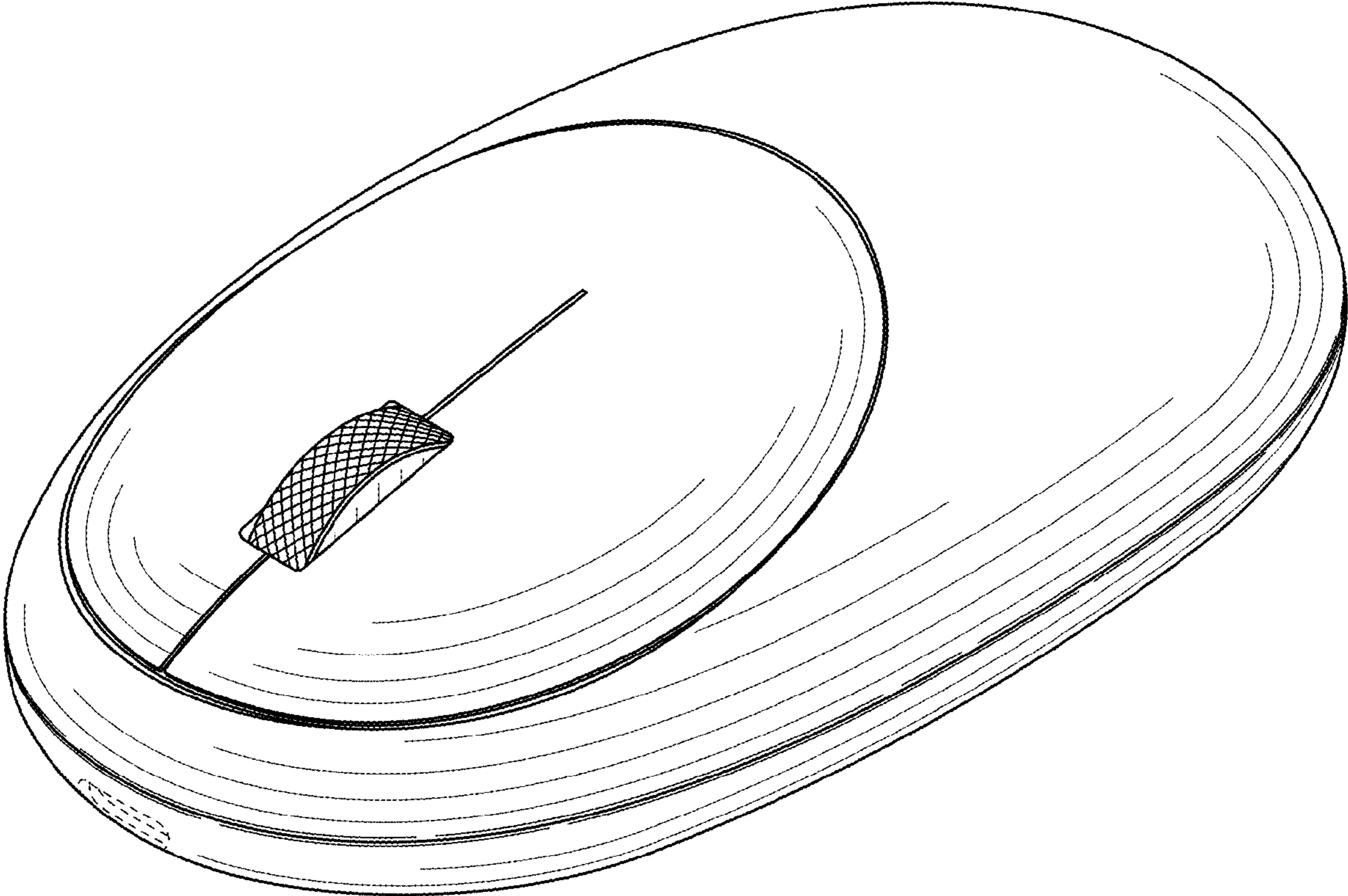

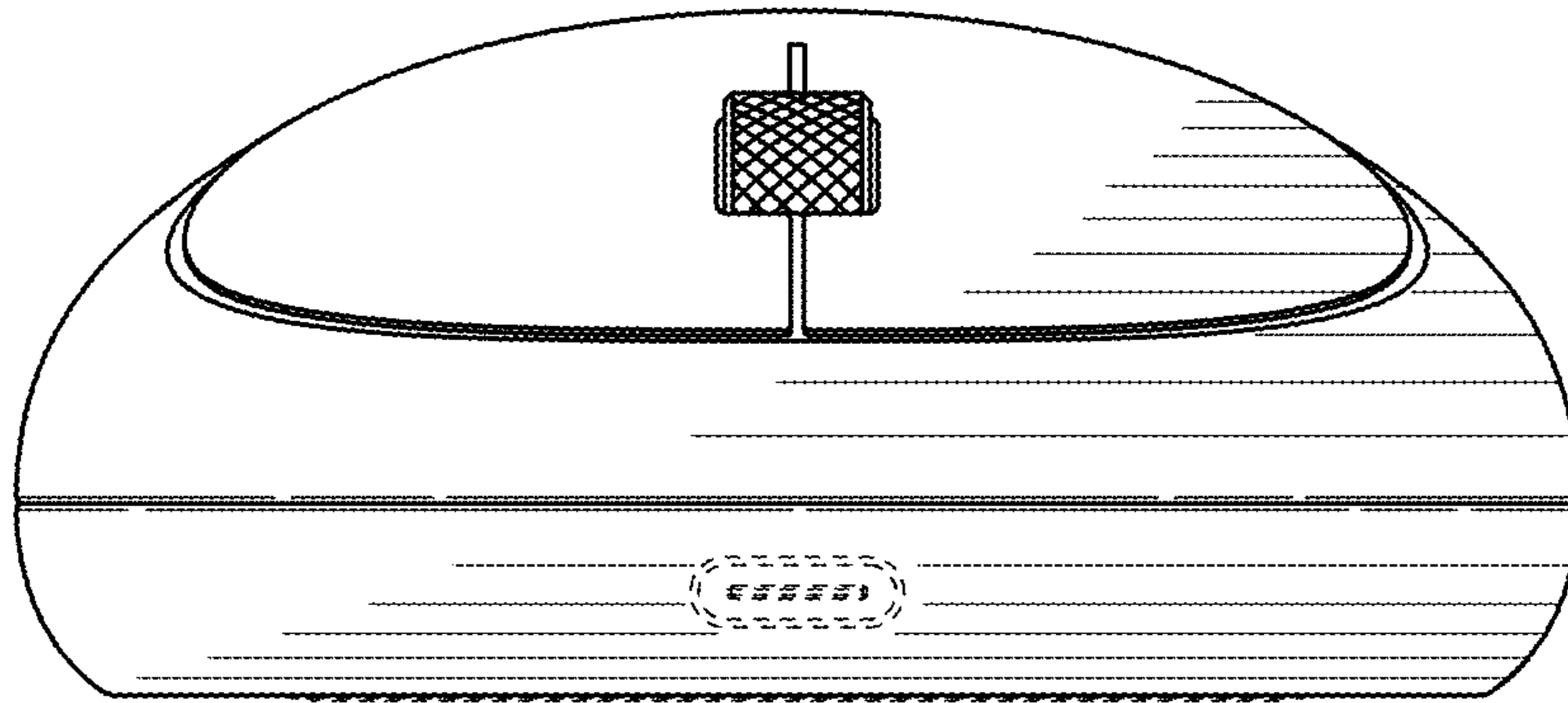

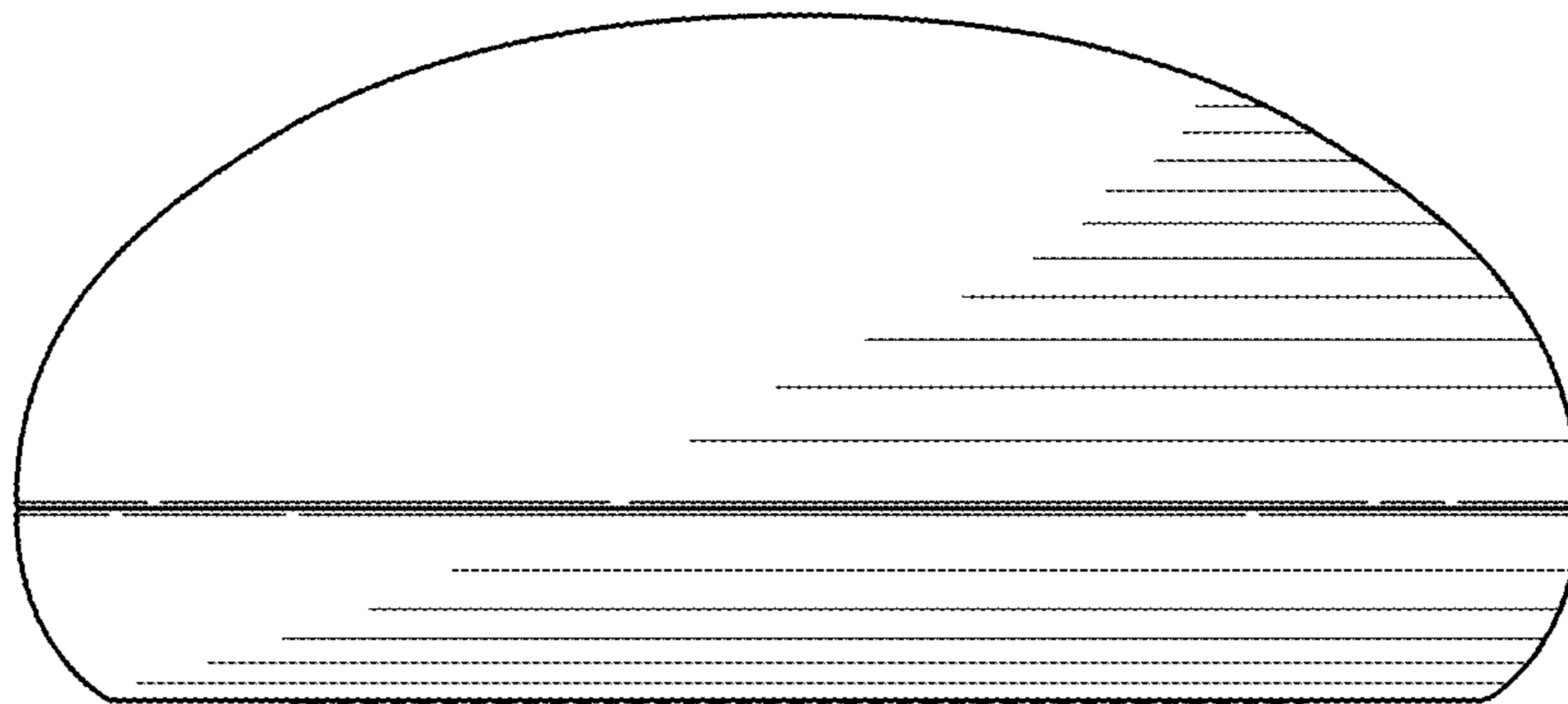

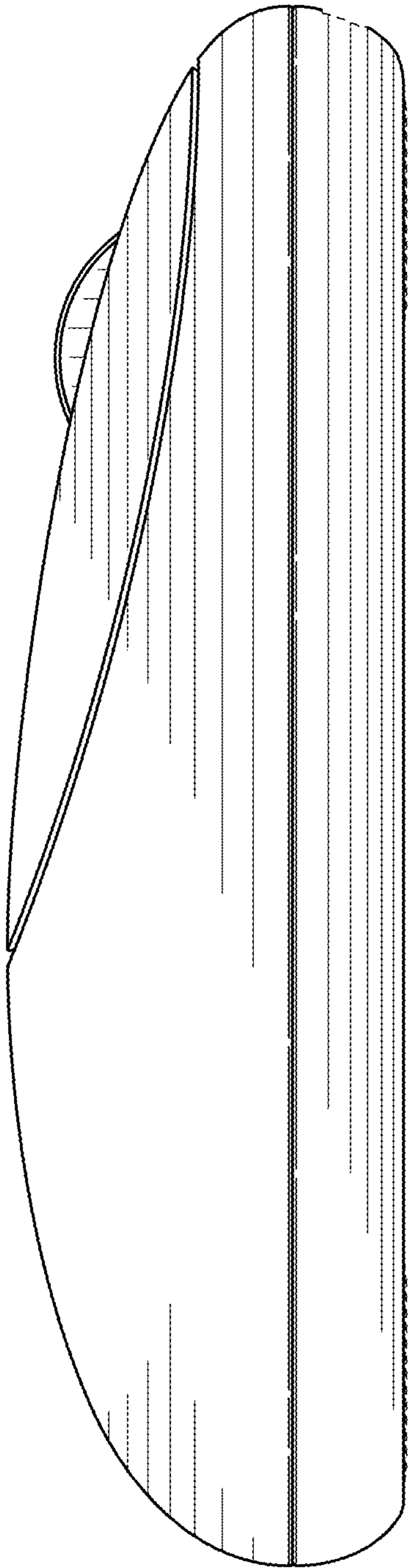

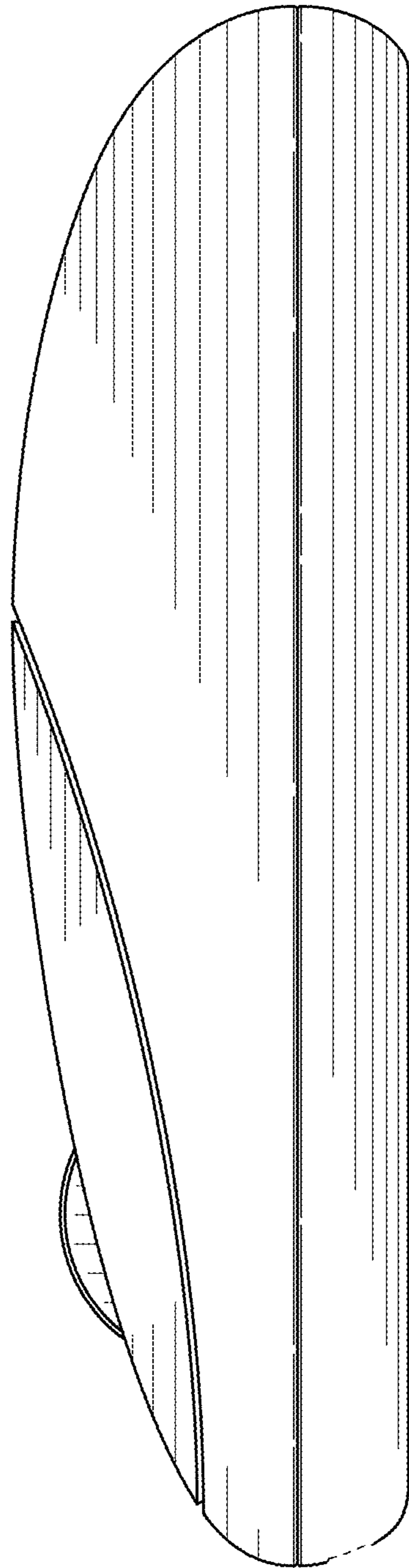

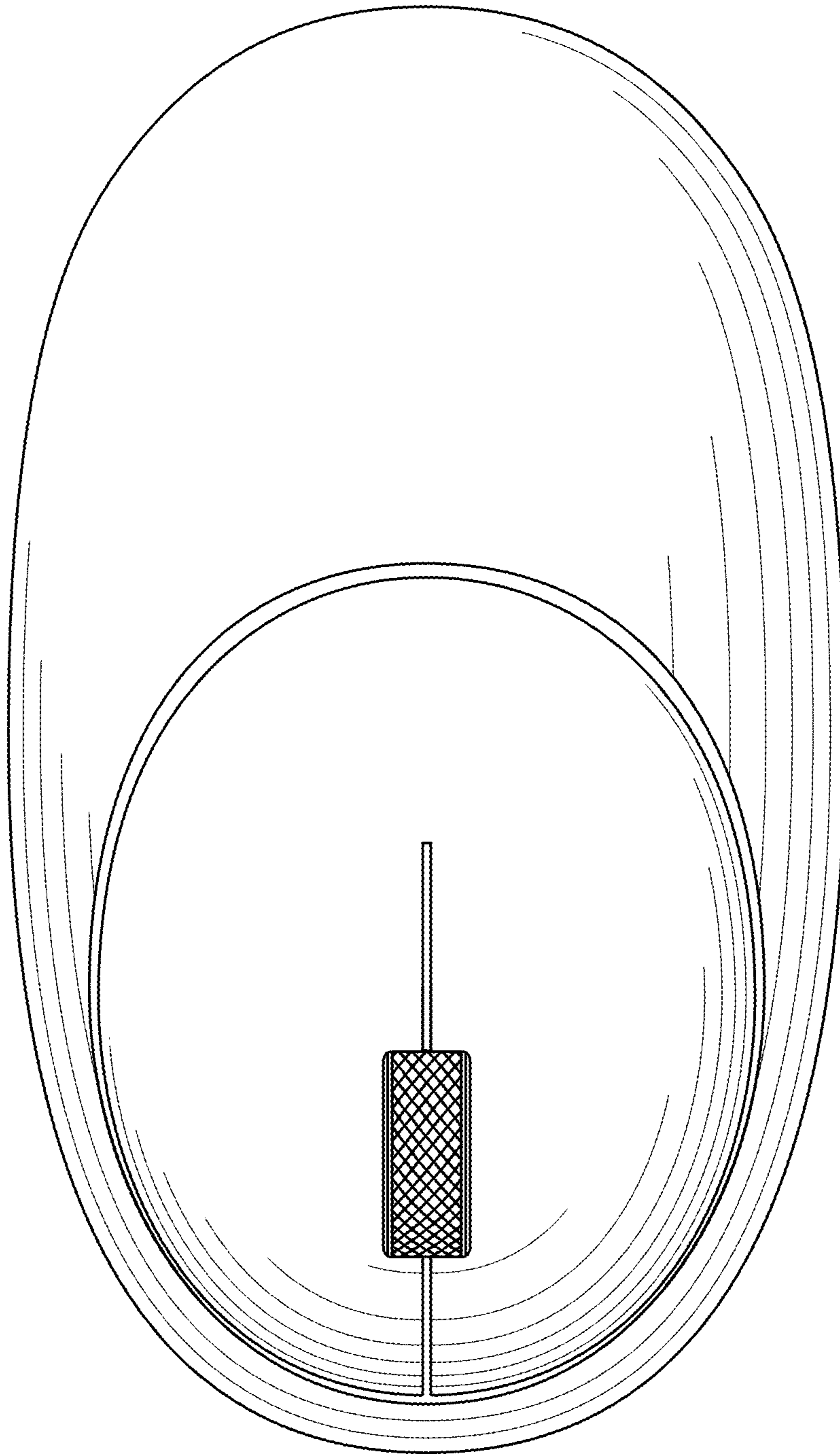

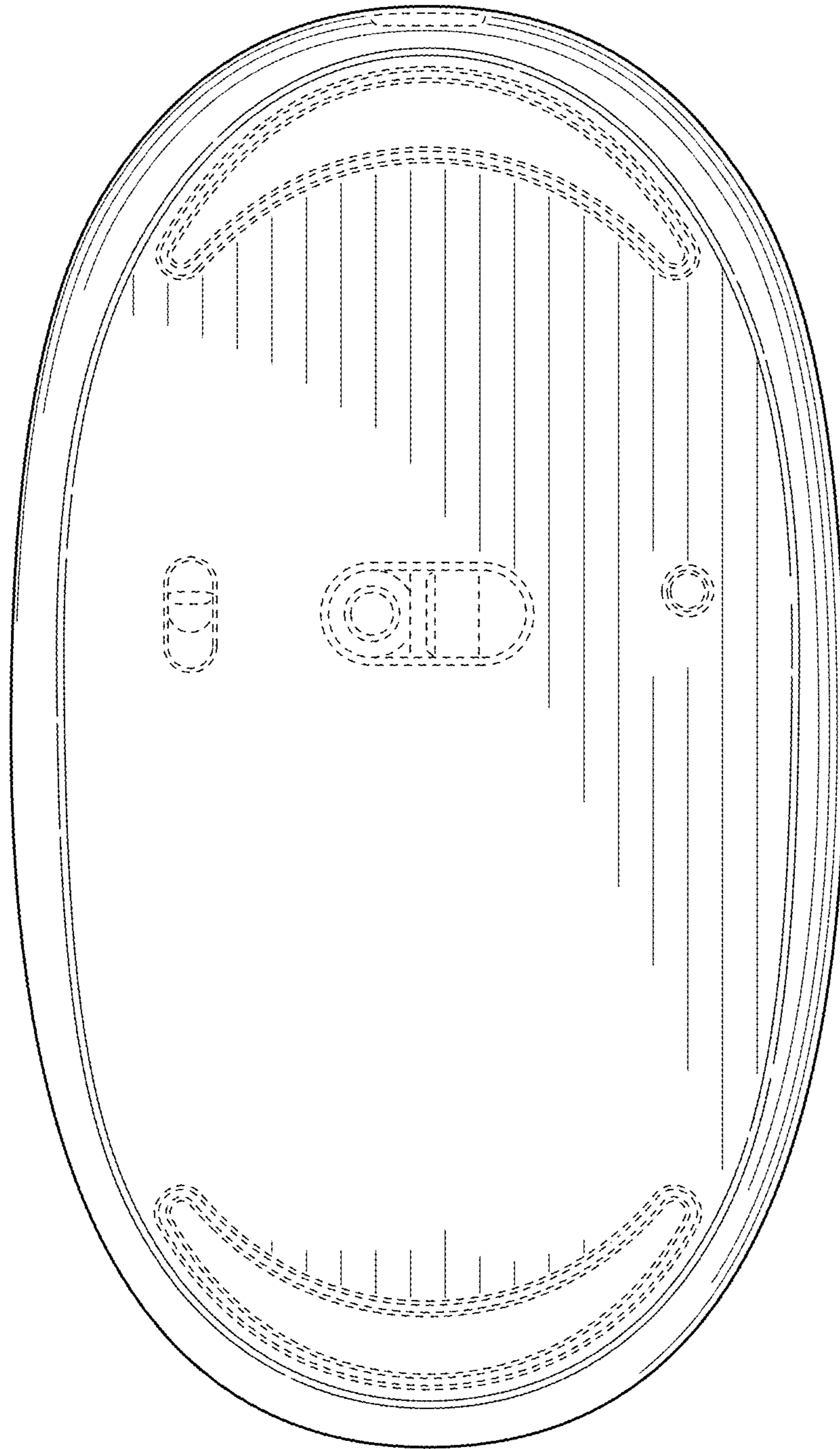
