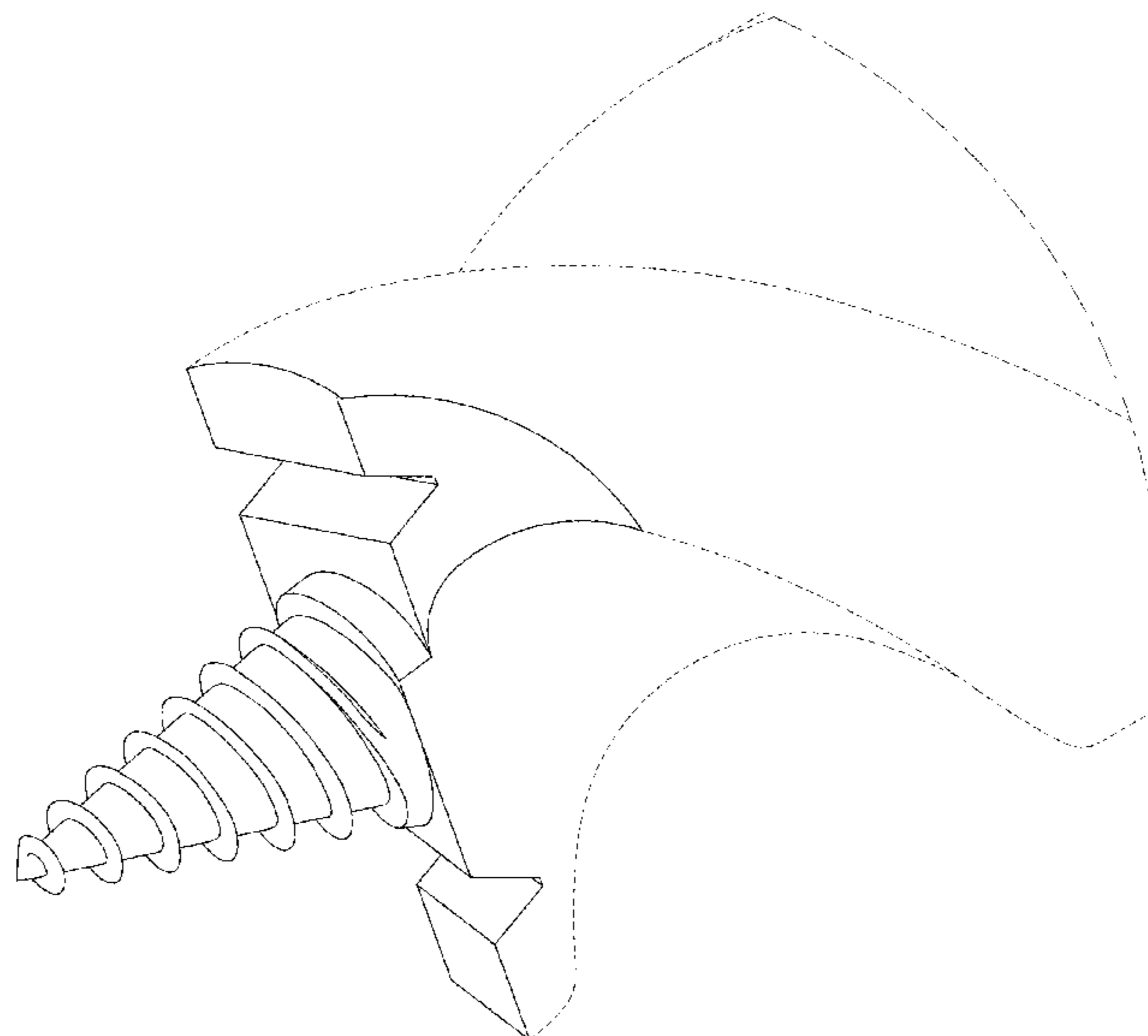
(57) **CLAIM**

The ornamental design for a drill bit, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of one embodiment of a drill bit showing our new design;
 FIG. 2 is a left side view thereof;
 FIG. 3 is a top view thereof;
 FIG. 4 is a right side view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a front view thereof;
 FIG. 7 is a rear view thereof;
 FIG. 8 is an enlarged, sectioned portion highlighted in FIG. 1;
 FIG. 9 is an enlarged, sectioned portion highlighted in FIG. 2;
 FIG. 10 is a top view of the enlarged, sectioned portions of FIGS. 8 and 9;
 FIG. 11 is a right side view of the enlarged, sectioned portions of FIGS. 8 and 9;
 FIG. 12 is a bottom view of the enlarged, sectioned portions of FIGS. 8 and 9;
 FIG. 13 is a front view of the enlarged, sectioned portions of FIGS. 8 and 9; and,
 FIG. 14 is a rear view of the enlarged, sectioned portions of FIGS. 8 and 9.

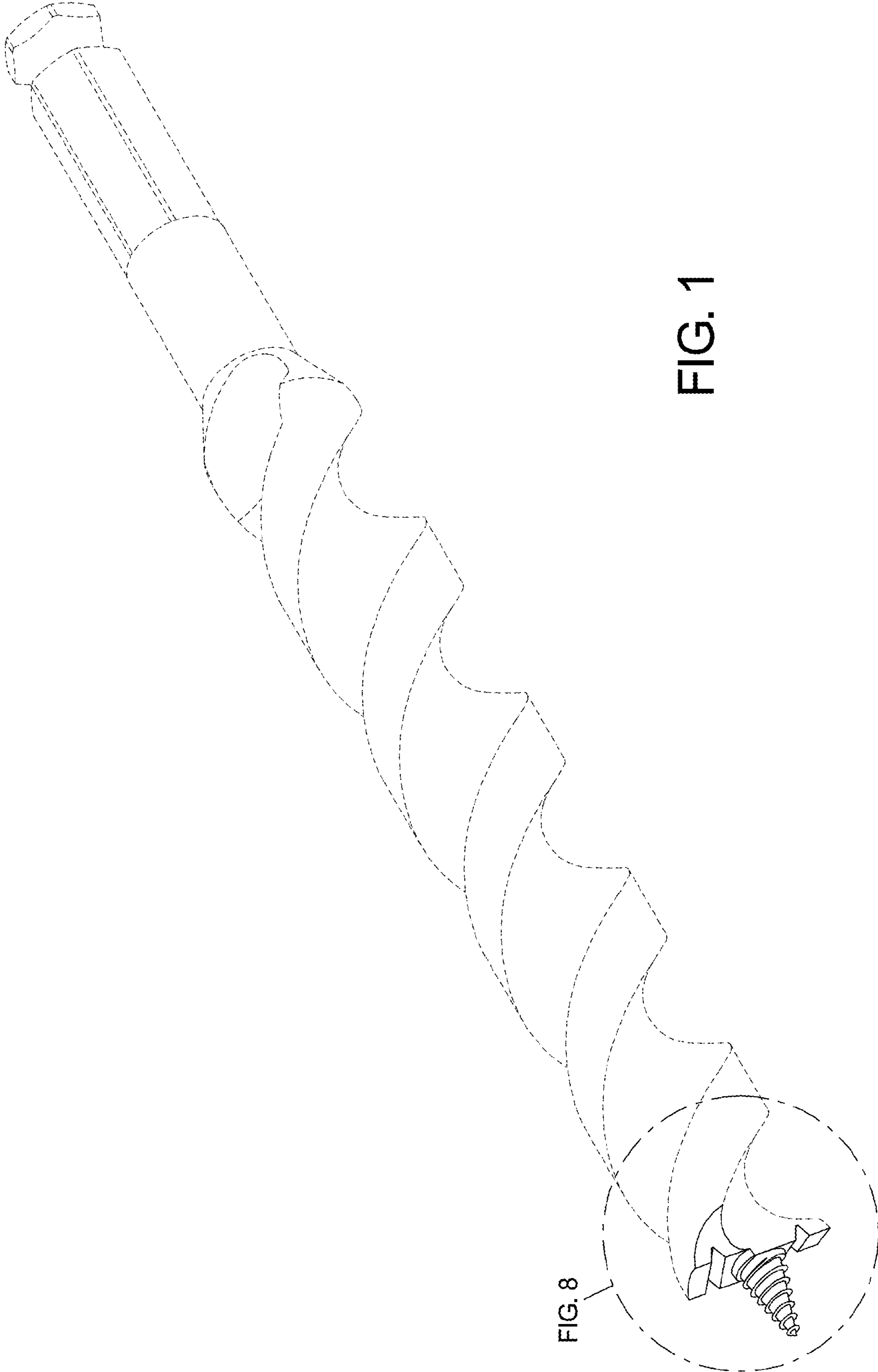
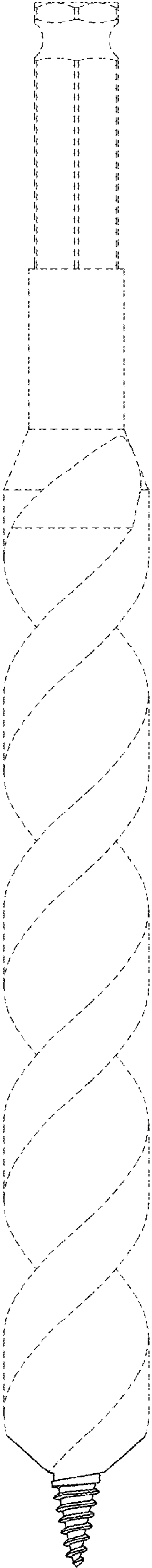
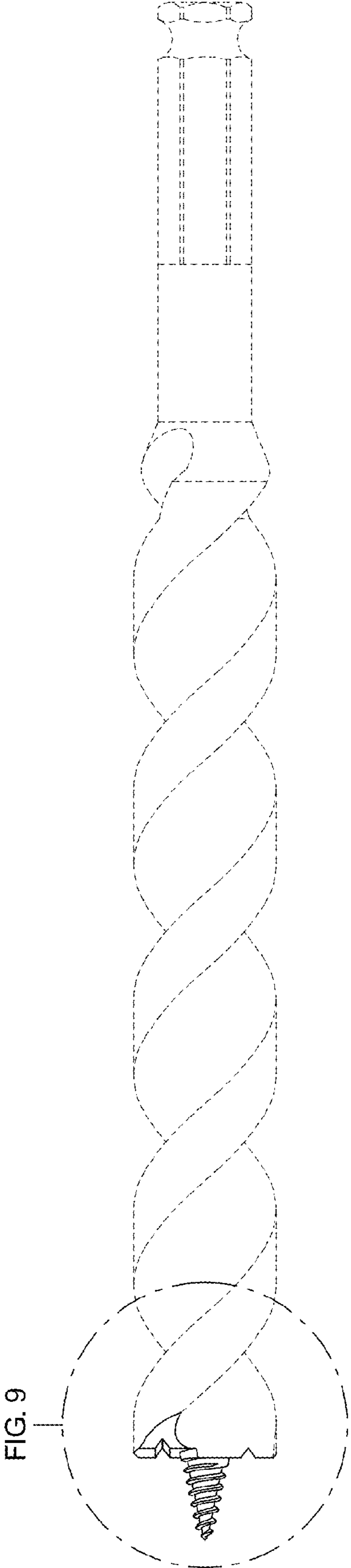

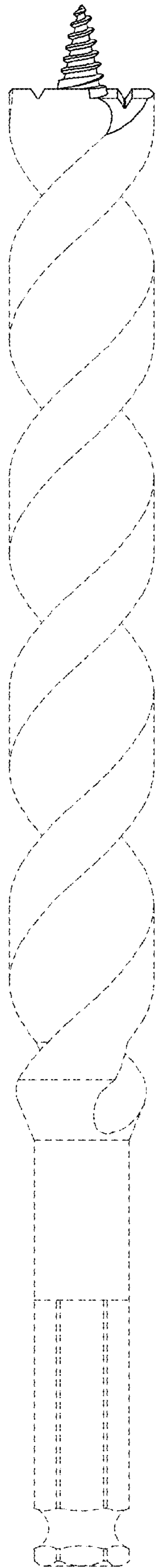

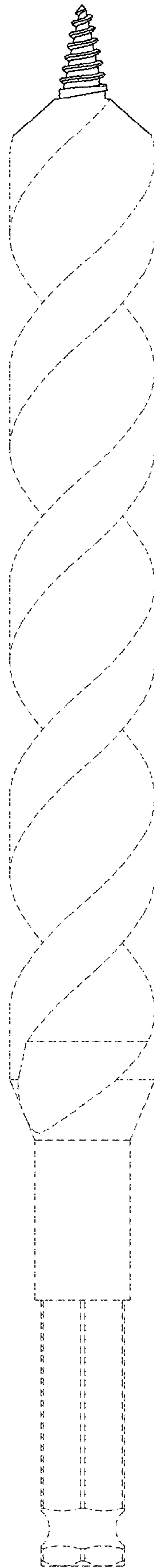

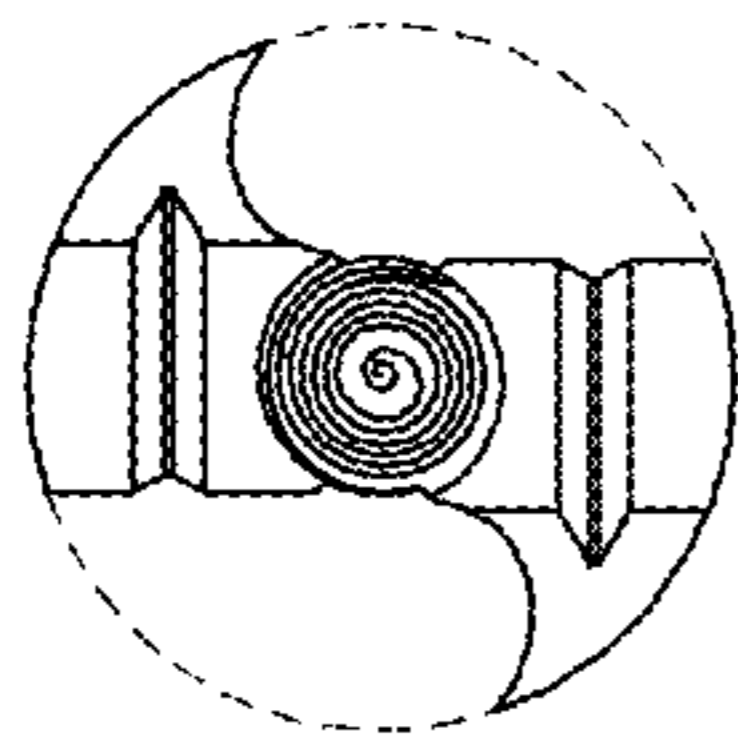

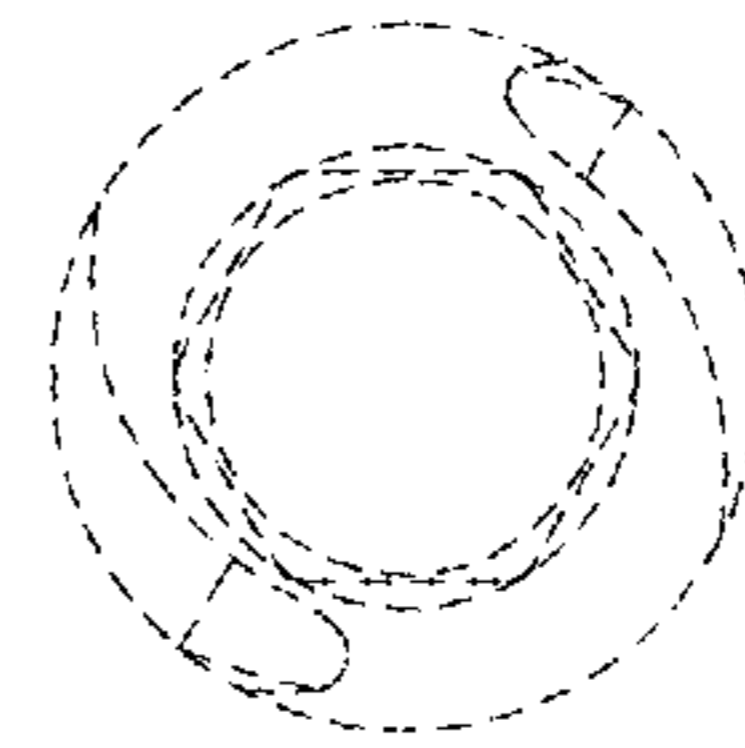

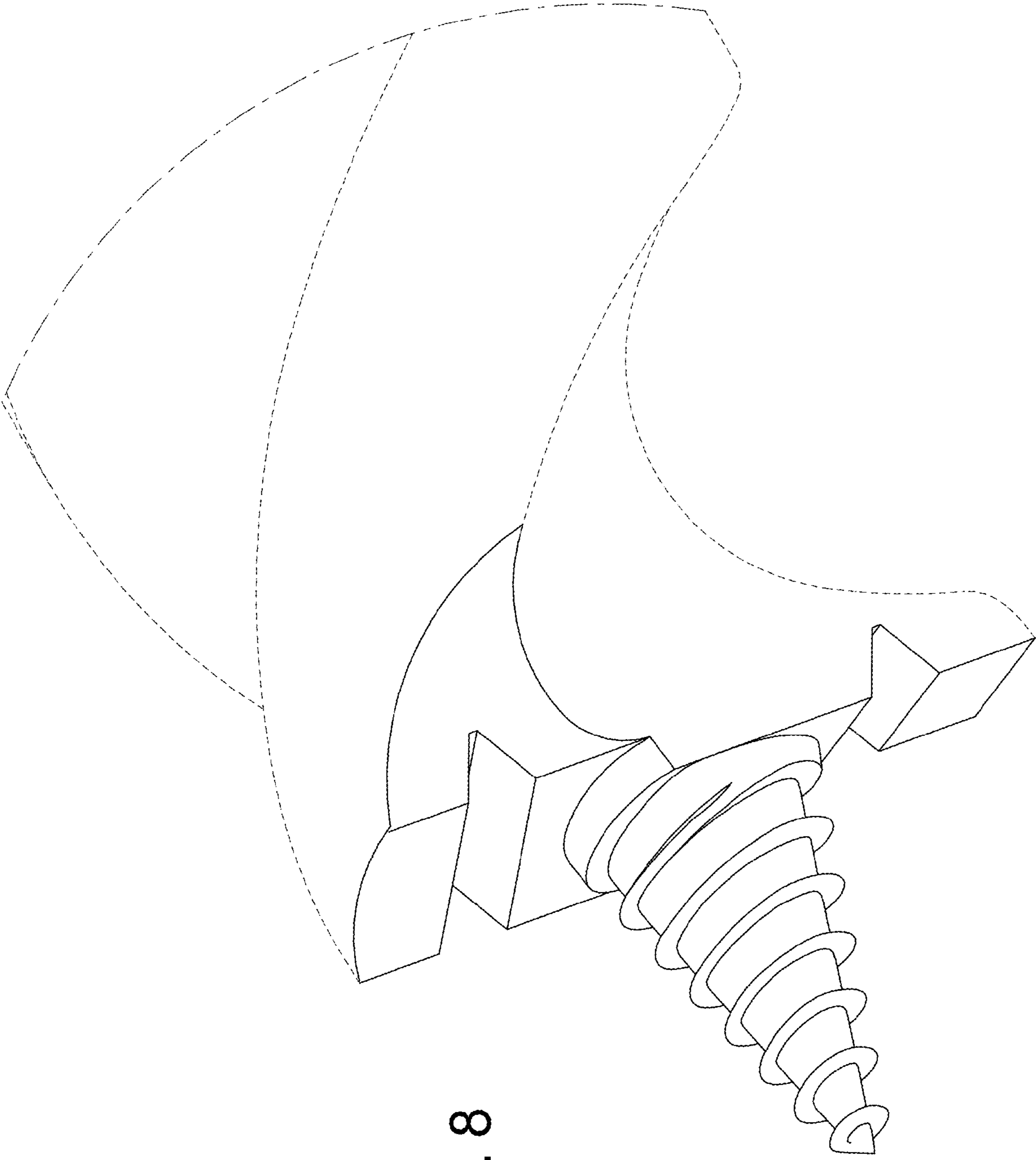

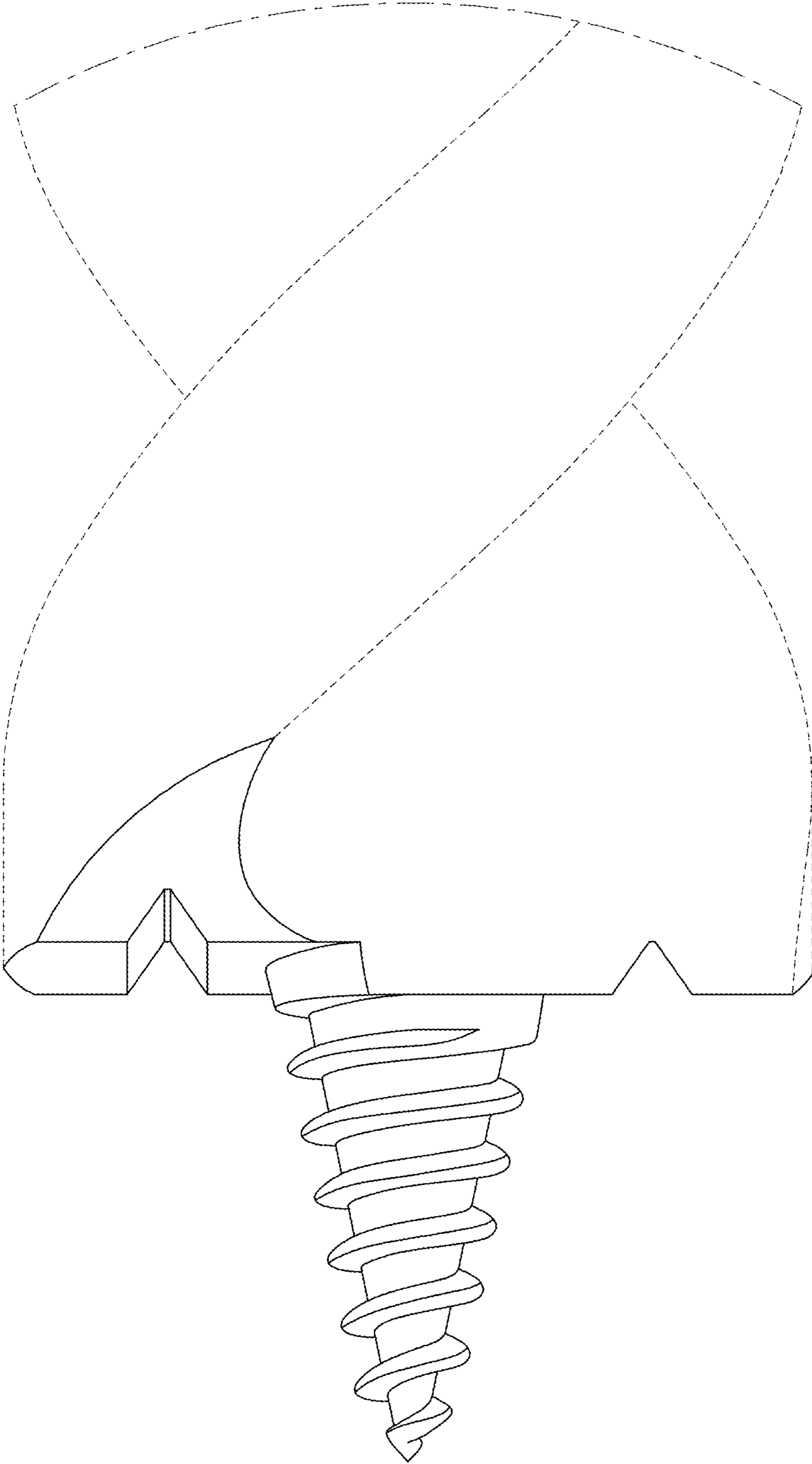

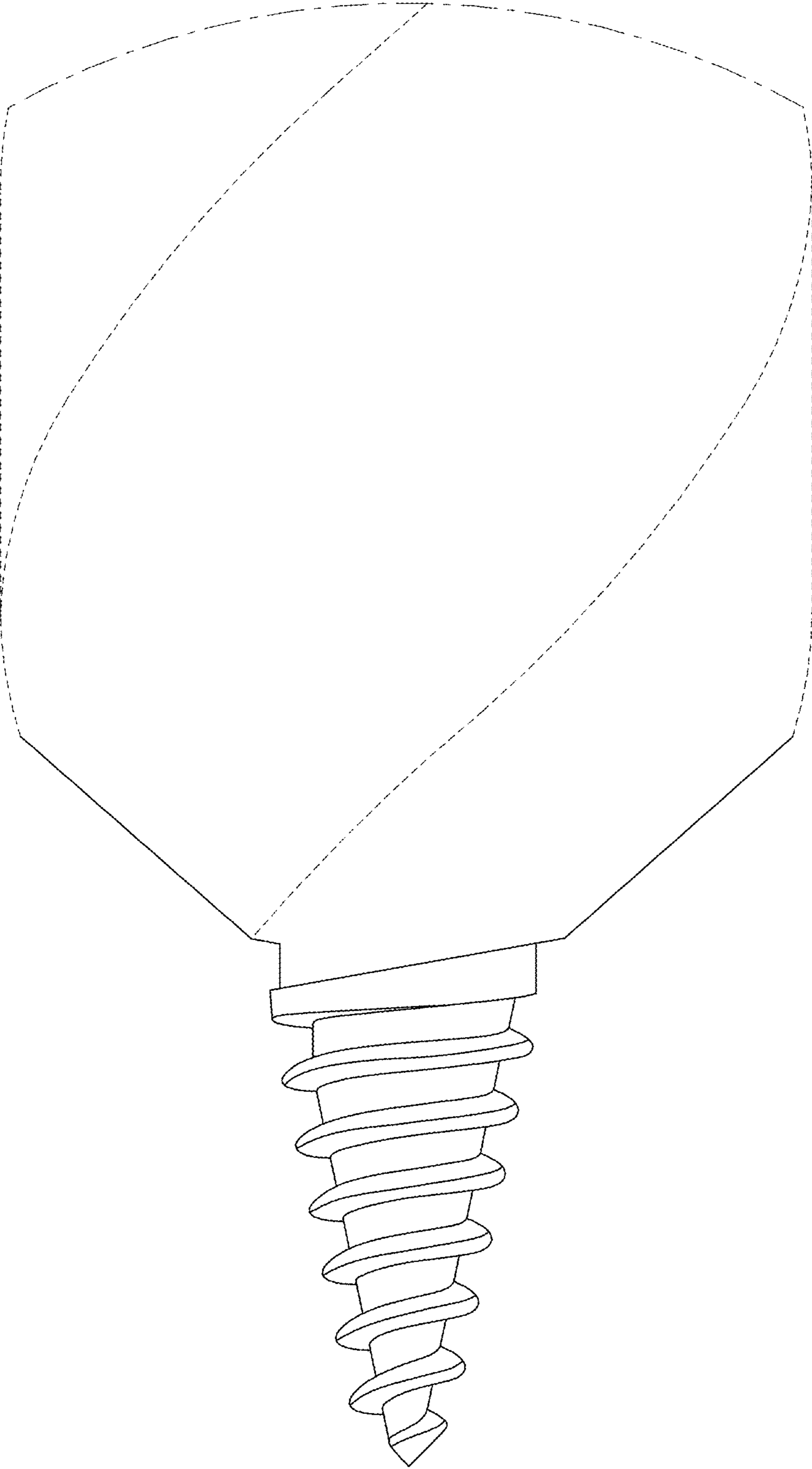

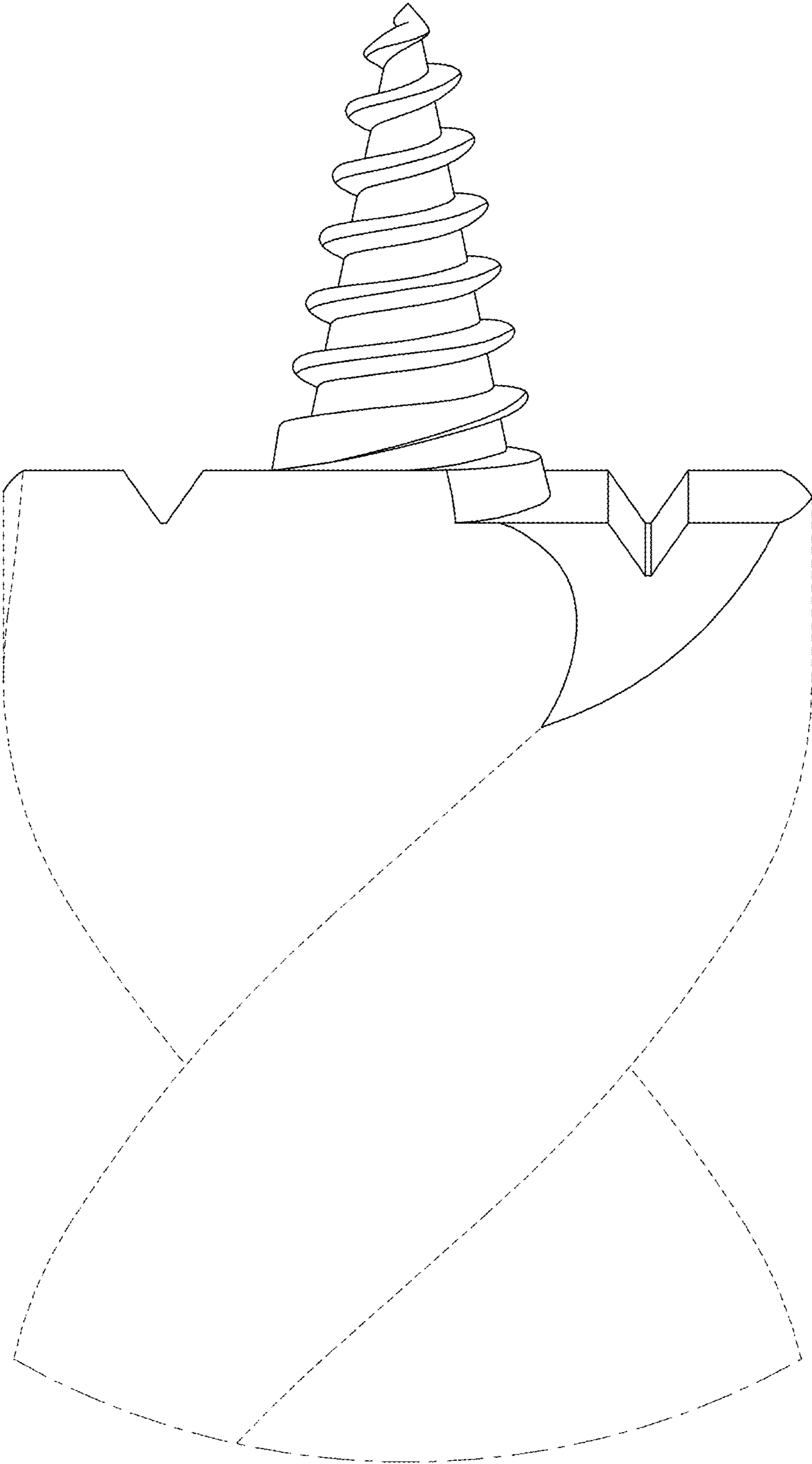

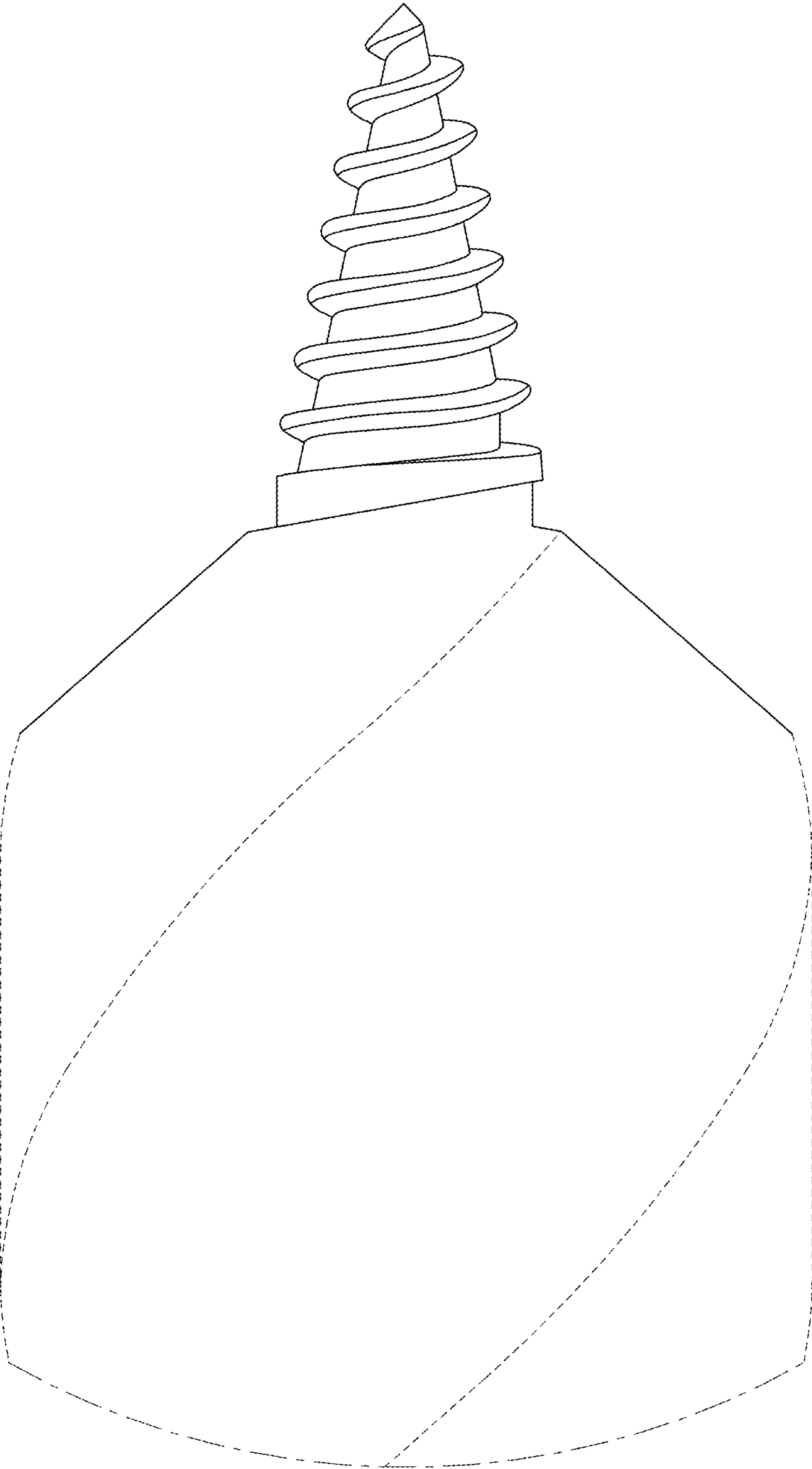

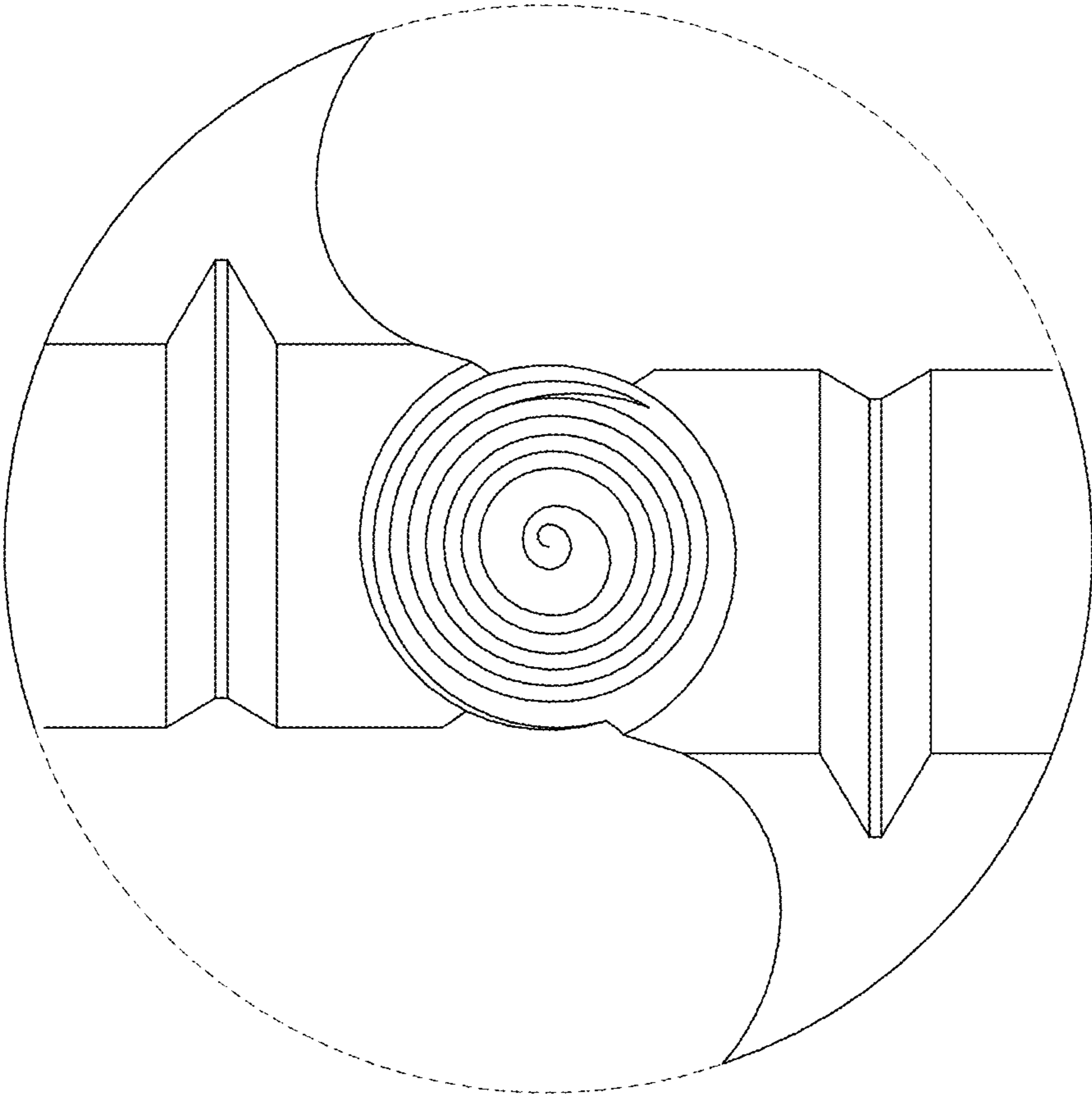

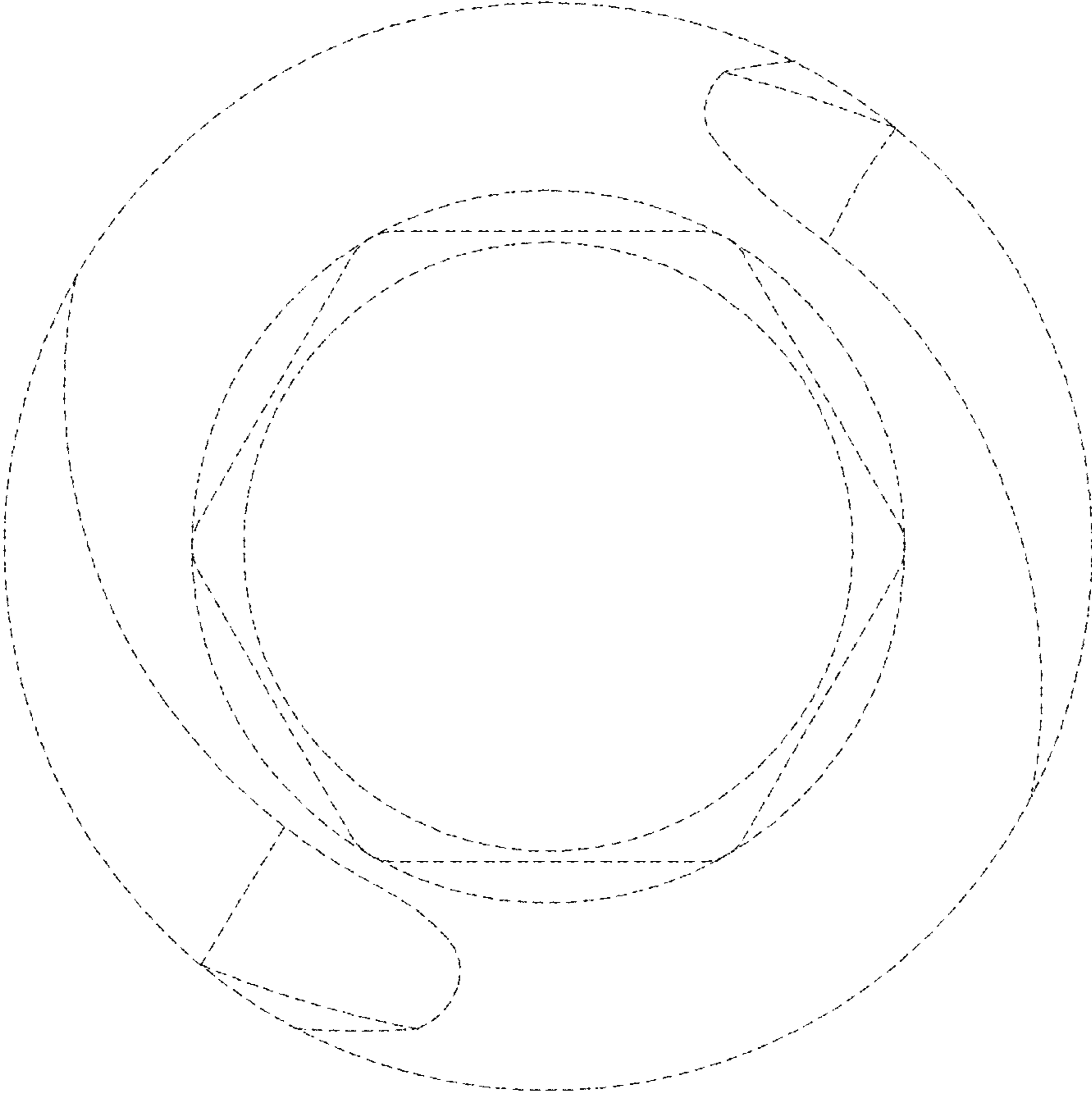
