We claim the ornamental design for a vending machine, as shown and described.

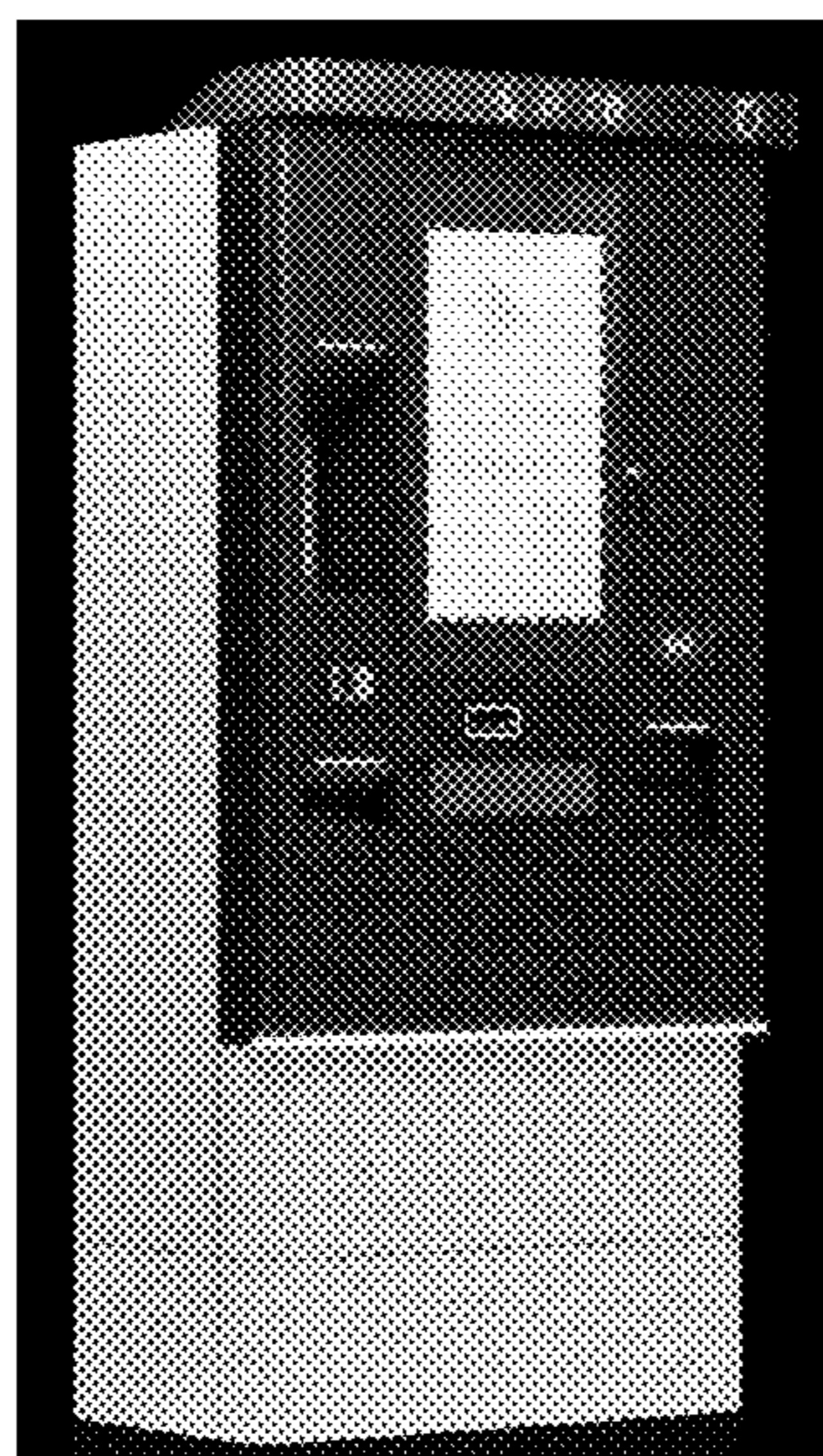
