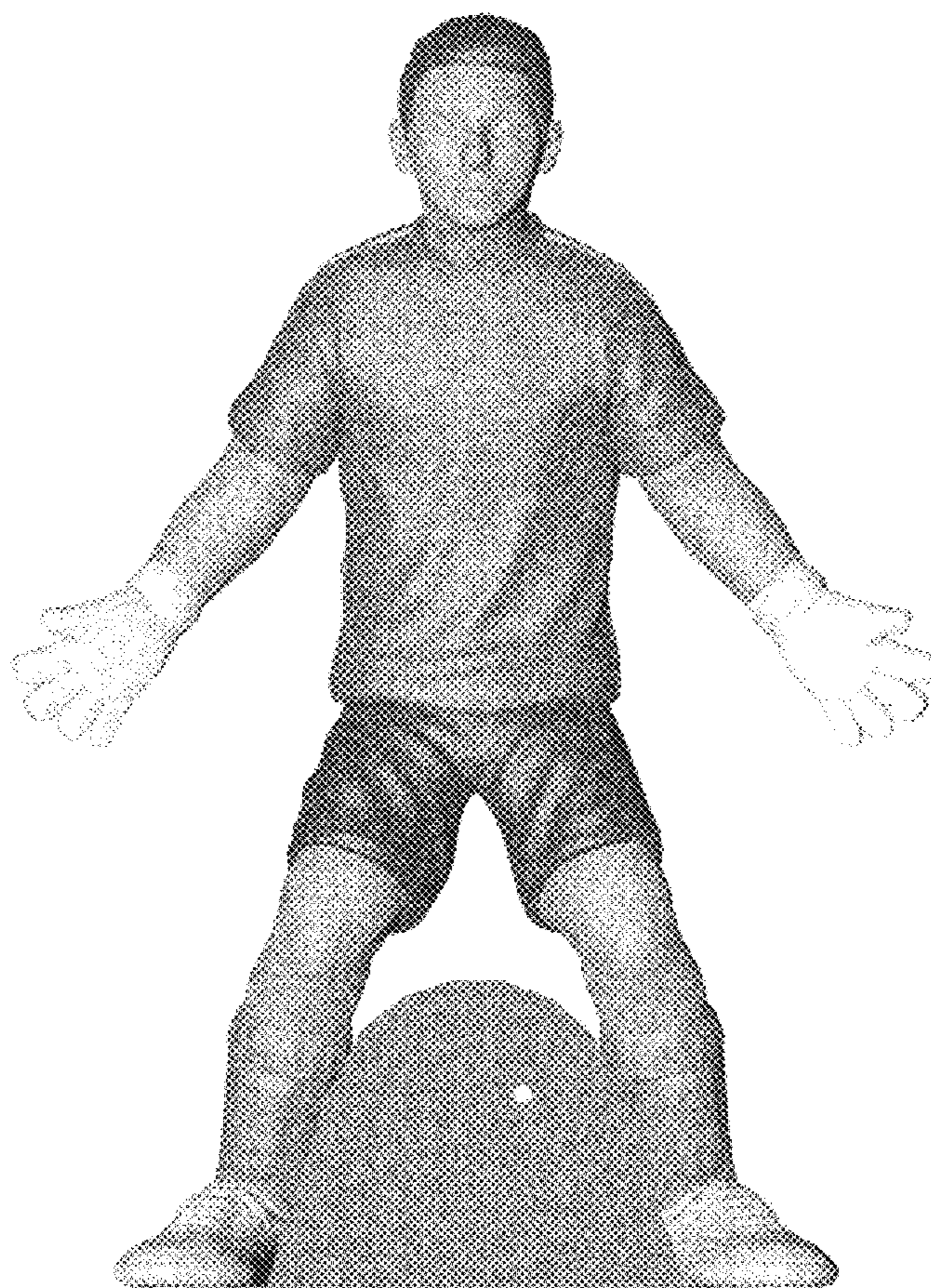

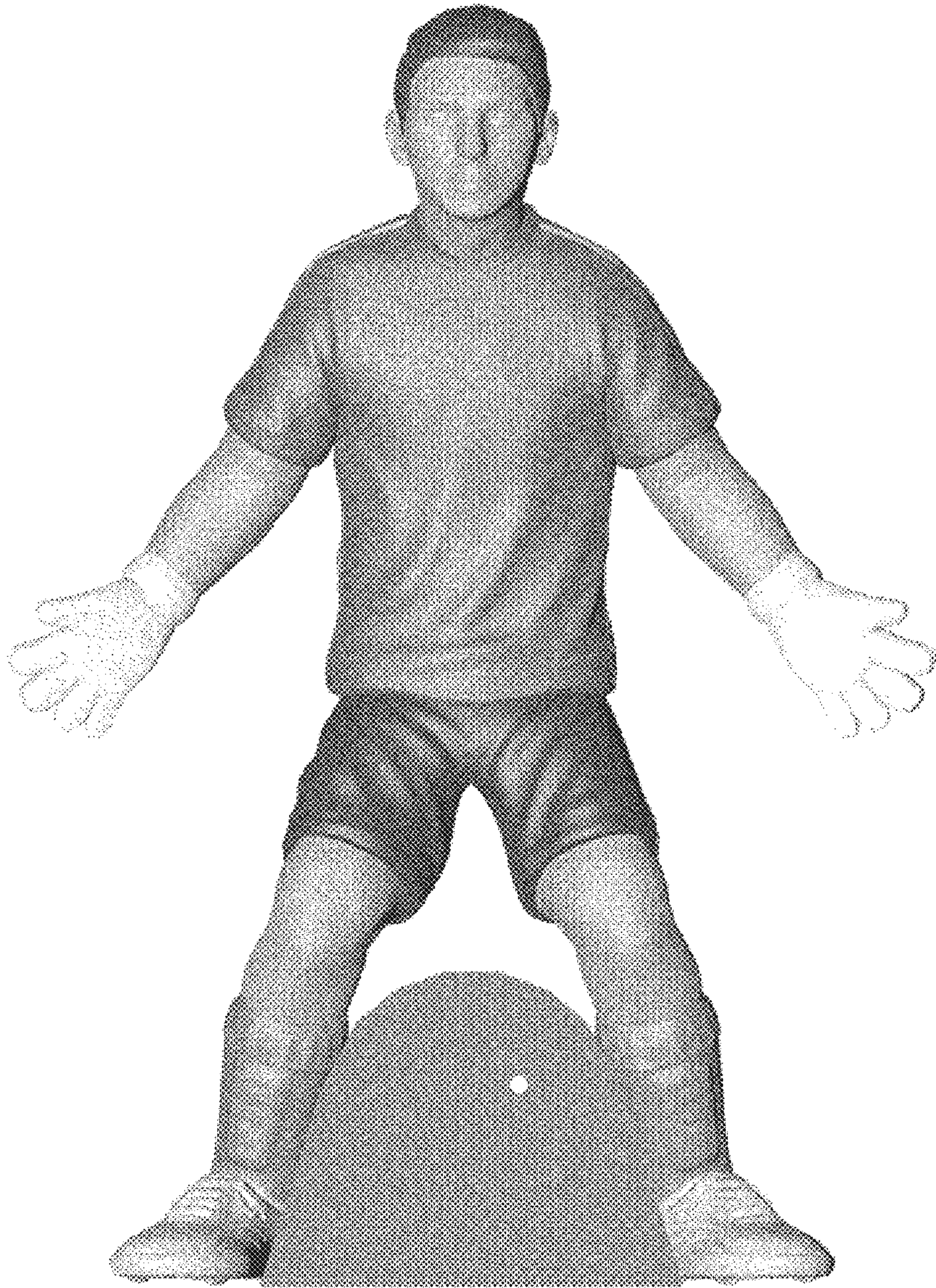
The ornamental design for a game figure, as shown.

**DESCRIPTION**

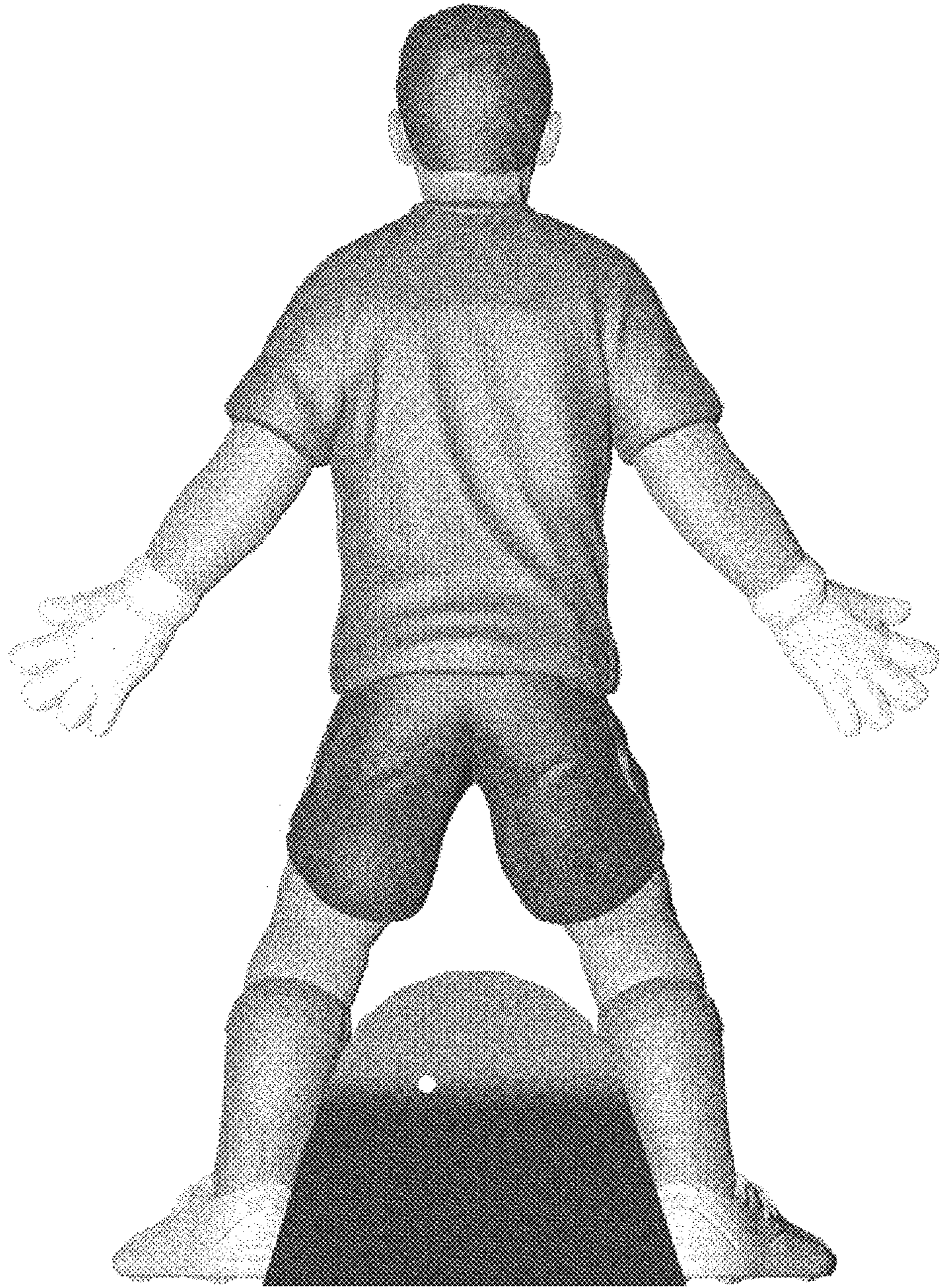
FIG. 1 is a front elevational view of a game figure showing our new design;

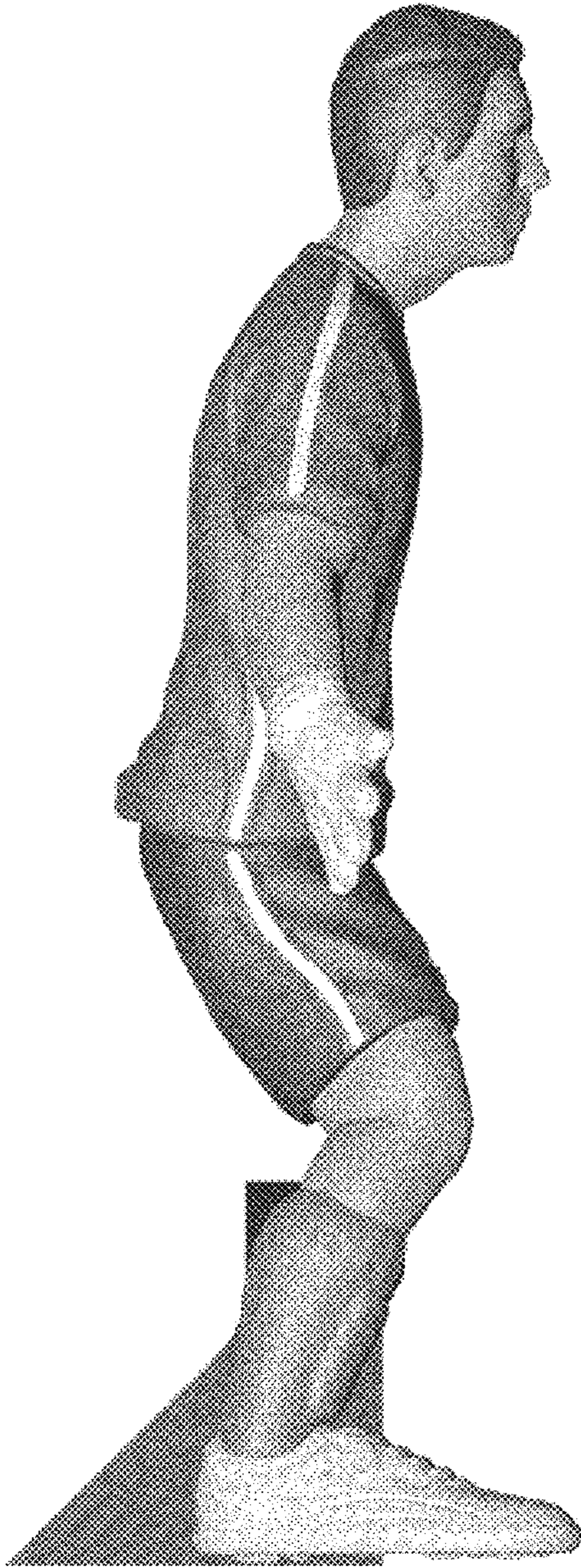




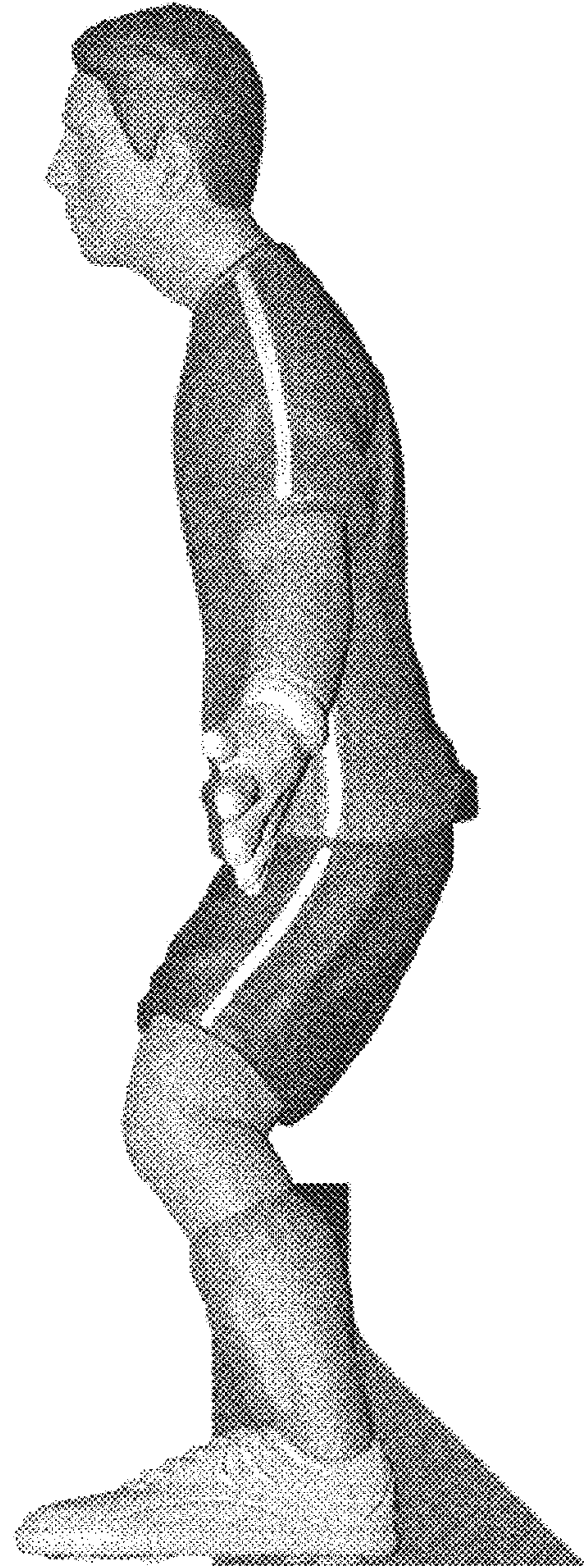

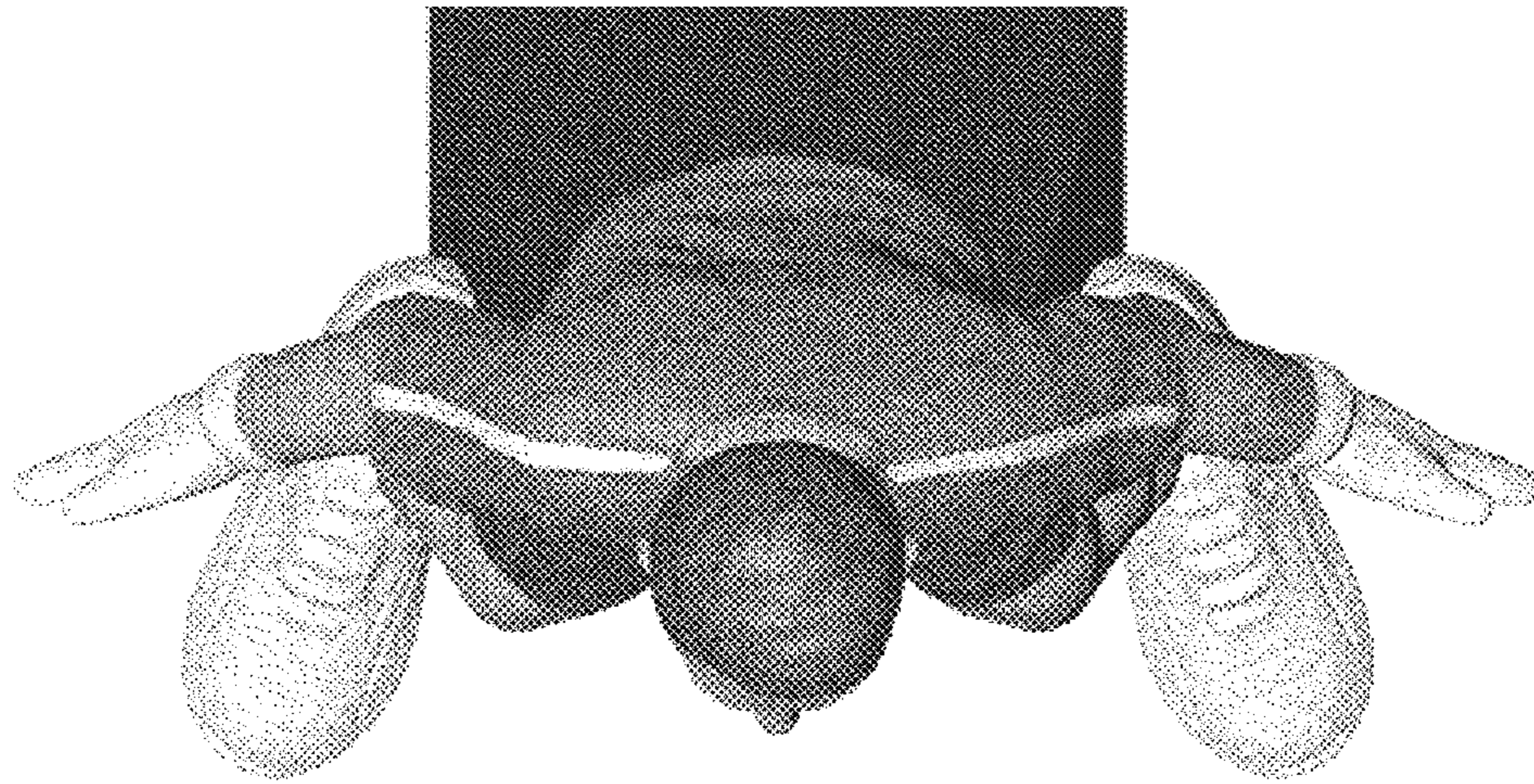

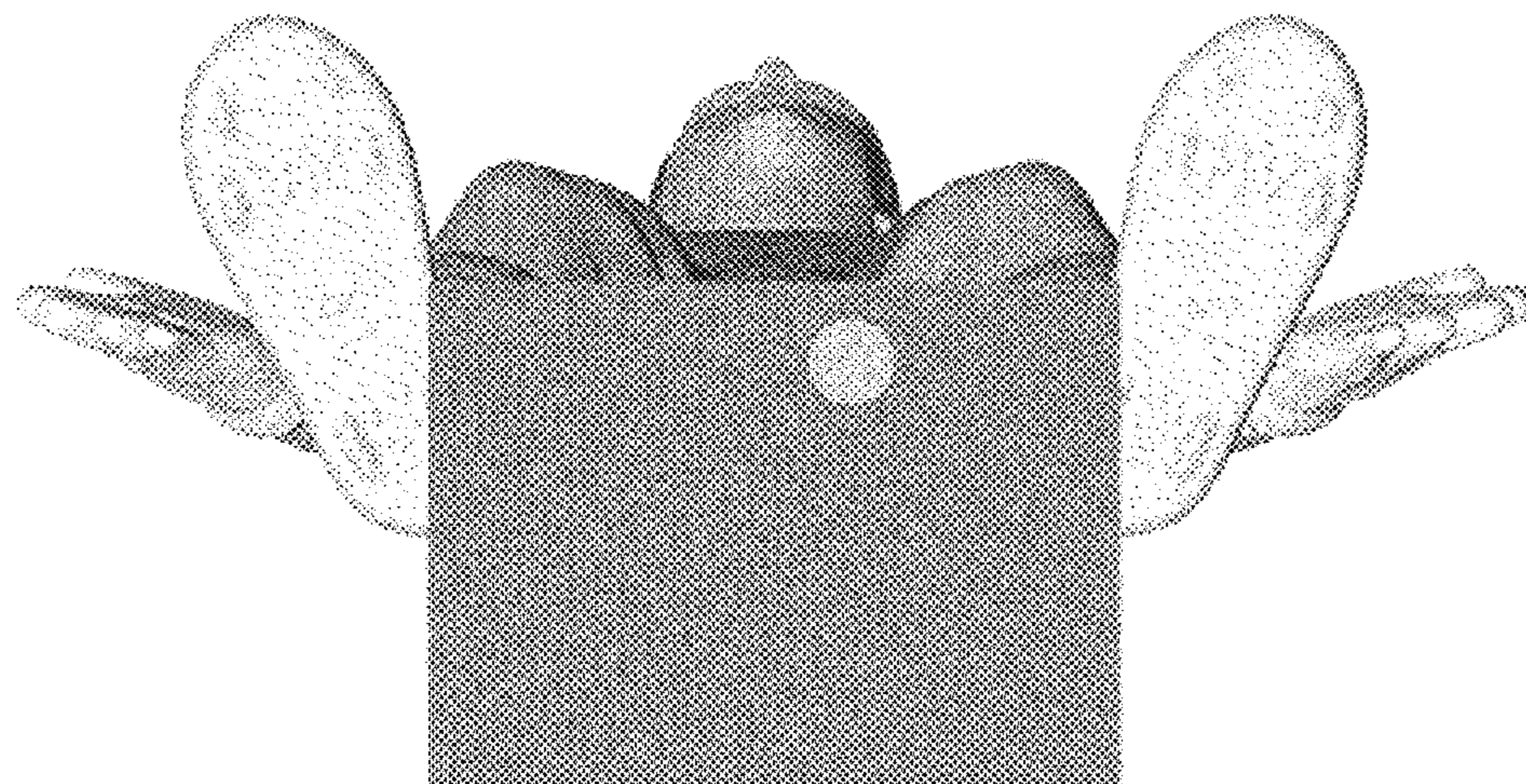
