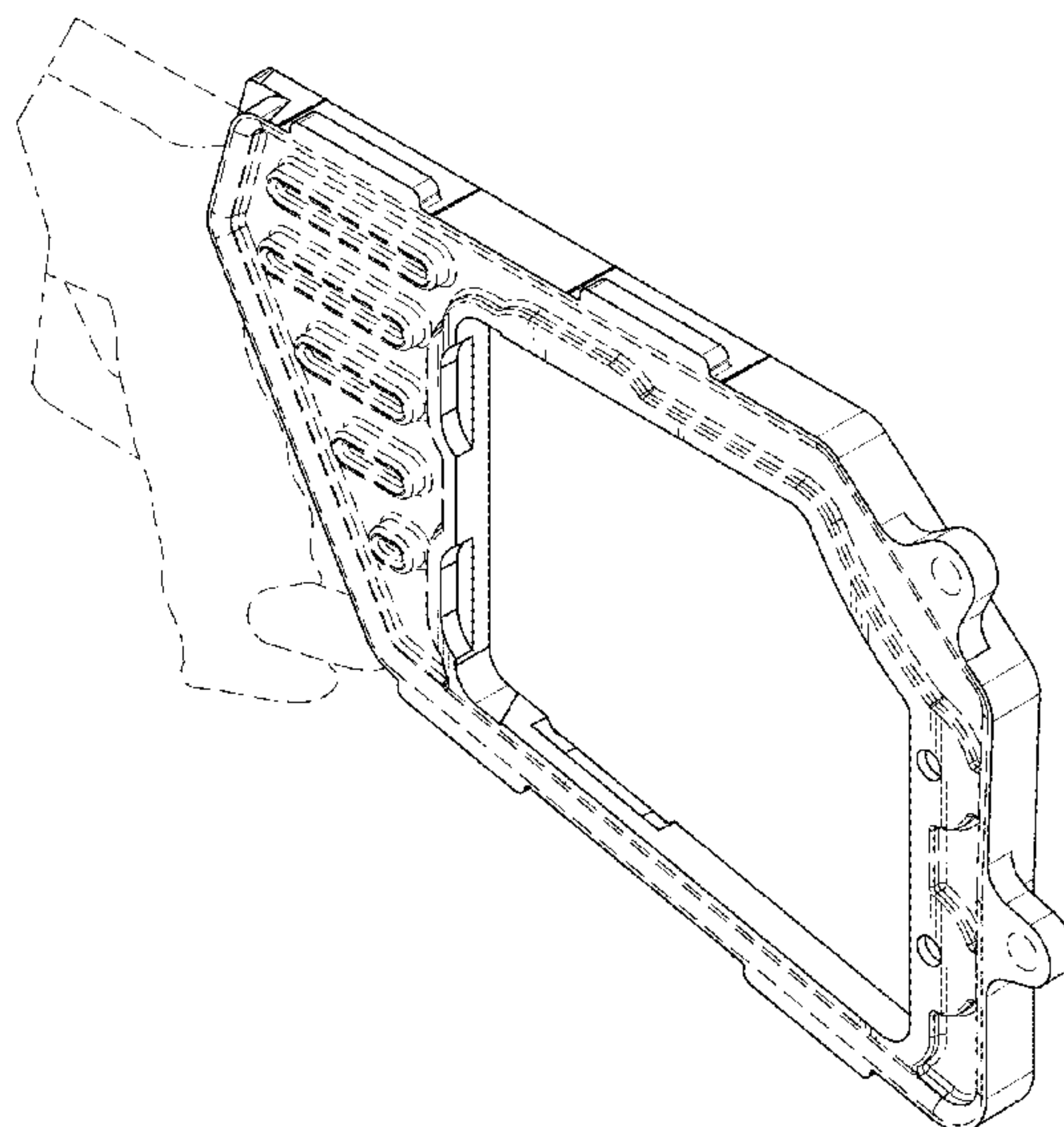
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a rear-right perspective view of a crossbow stock adaptor plate, showing my new design; FIG. 2 is a right side view thereof; and, FIG. 3 is a left side view thereof. The broken line in the drawings depicts unclaimed environment and portion of the adaptor plate only and forms no part of the claimed design.

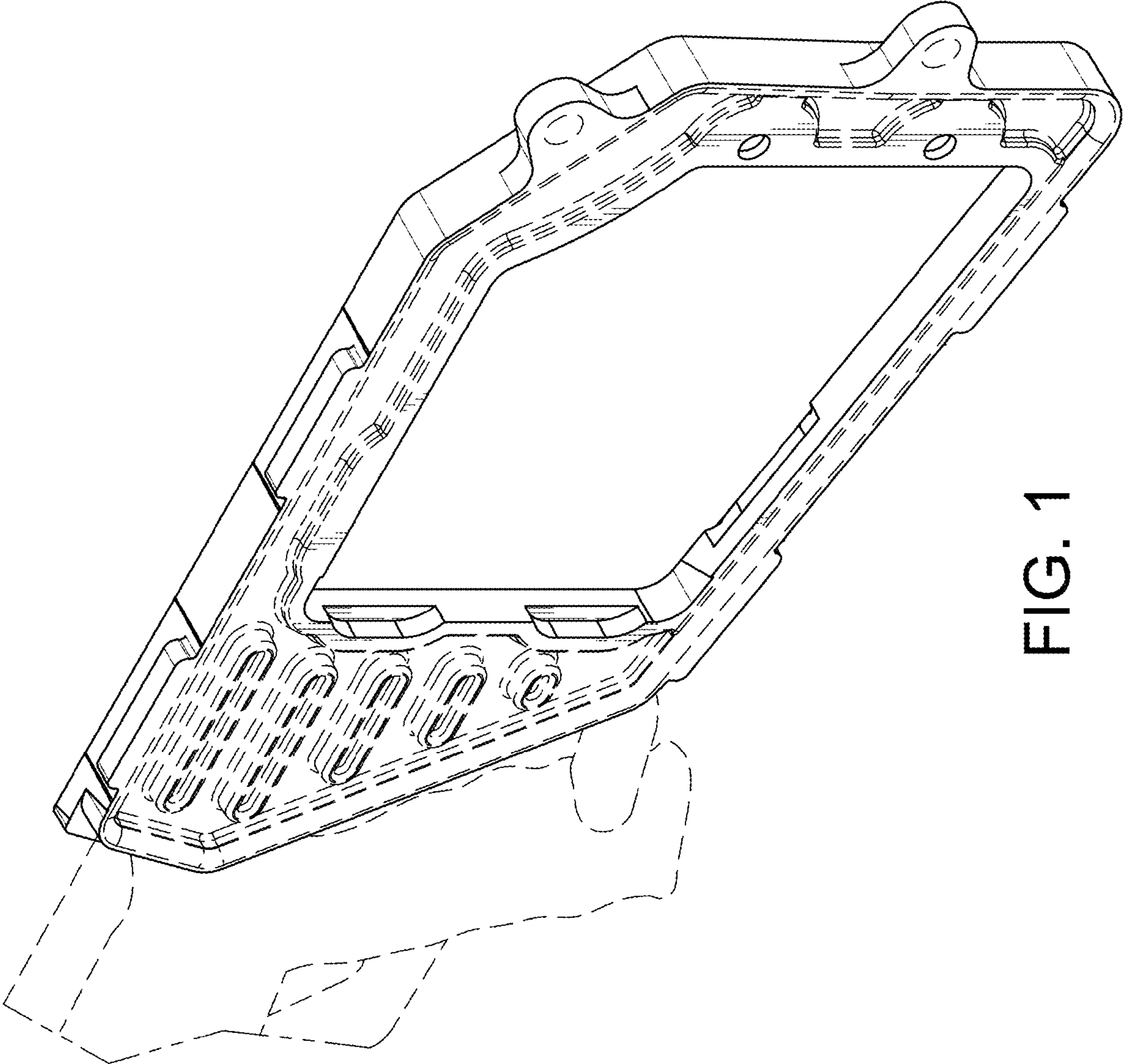

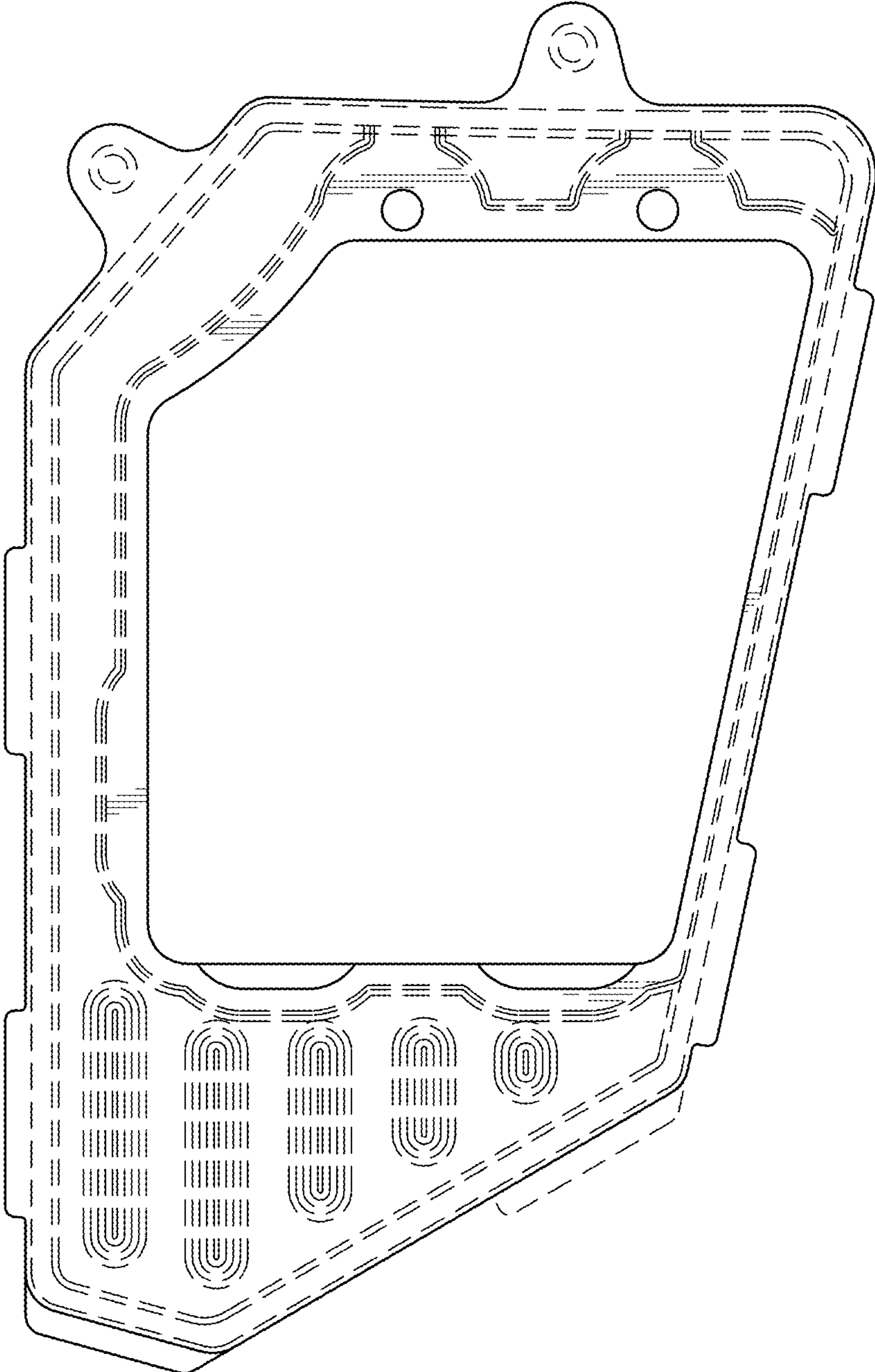

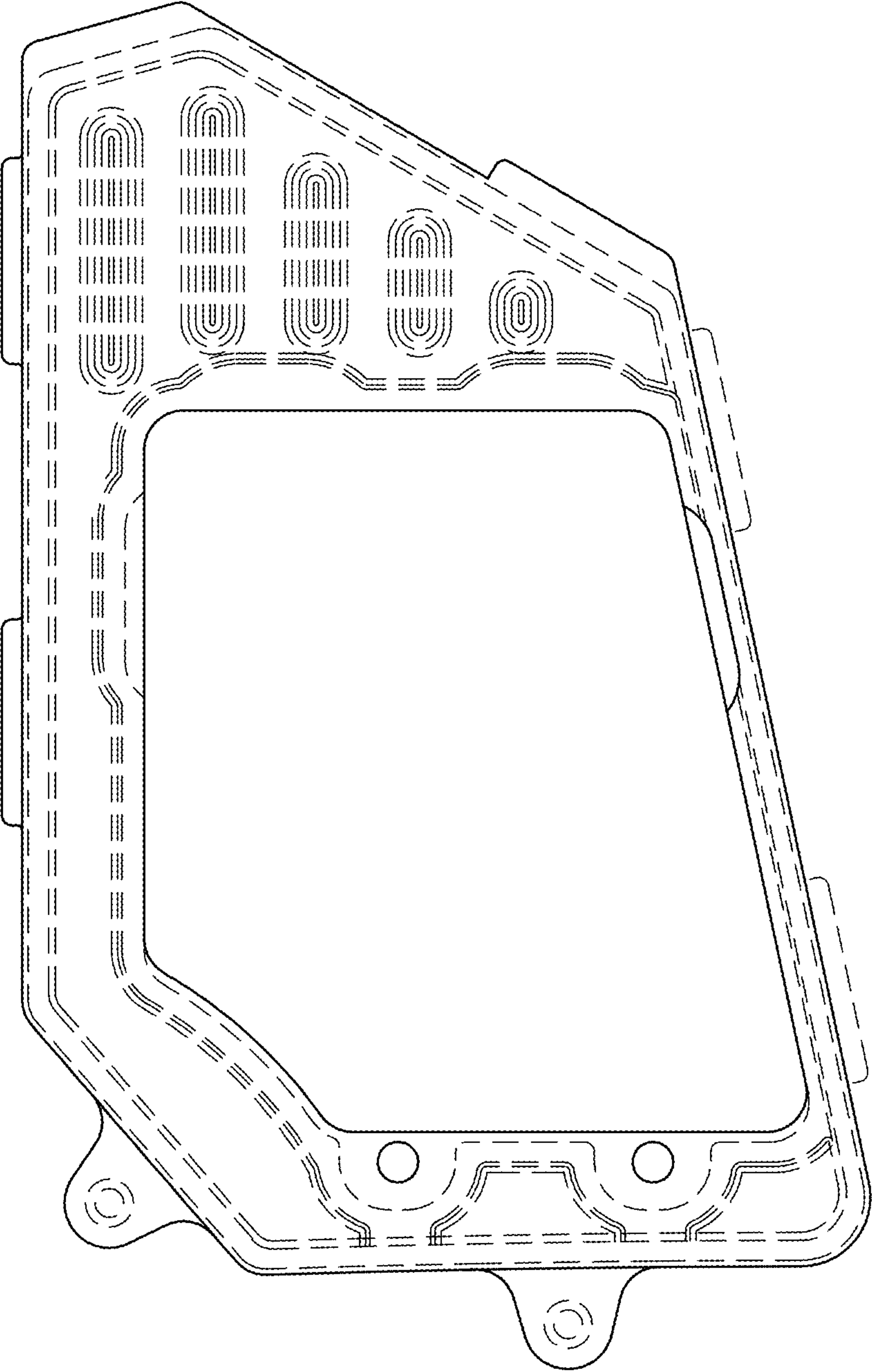
