(57) **CLAIM**

The ornamental design for a medical X-ray photographing apparatus, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a medical X-ray photographing apparatus of the present design; FIG. 2 is a rear view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a perspective view 1 thereof; and, FIG. 8 is a perspective view 2 thereof. The broken lines shown in the drawings represent portions of the medical X-ray photographing apparatus that form no part of the claimed design.

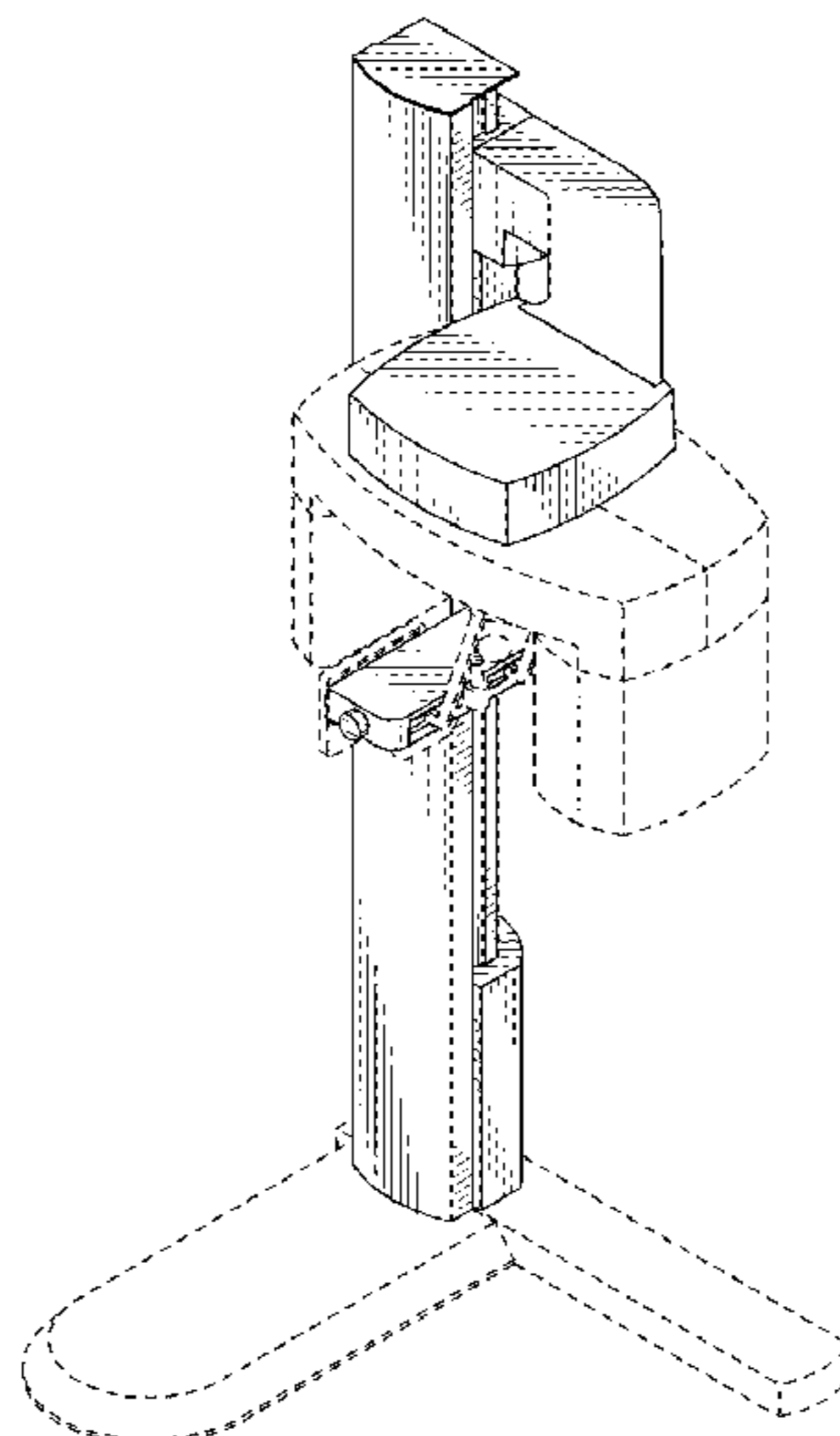

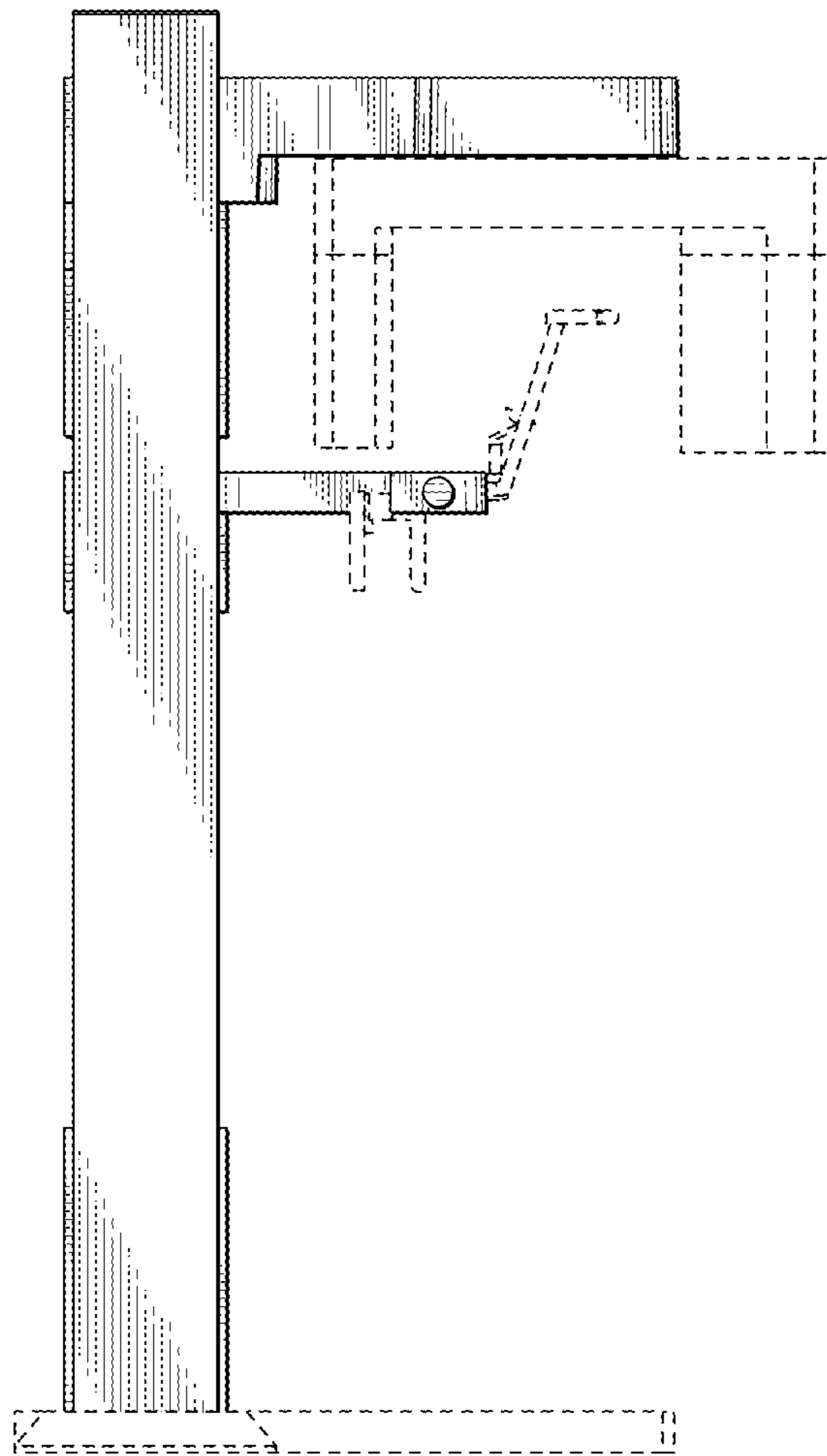

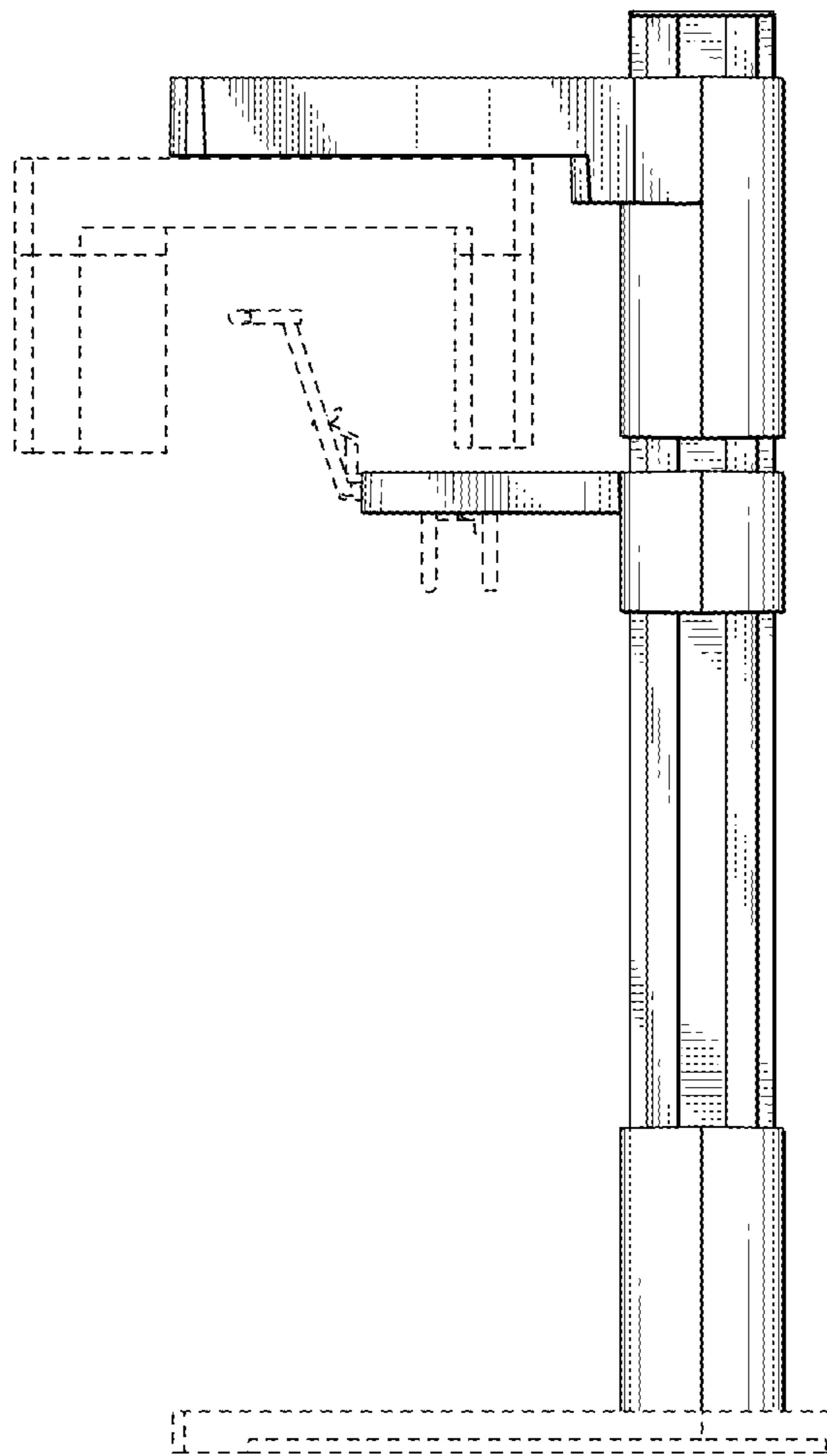

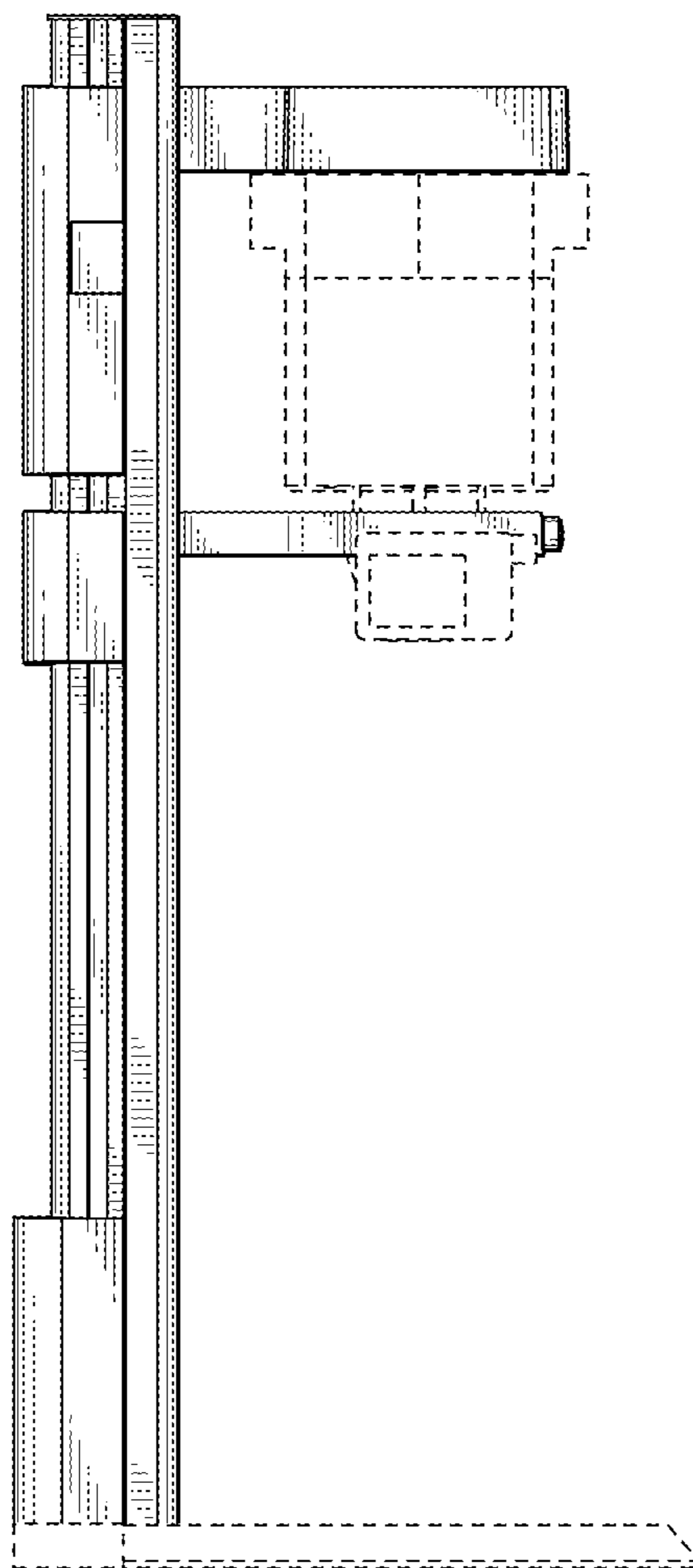

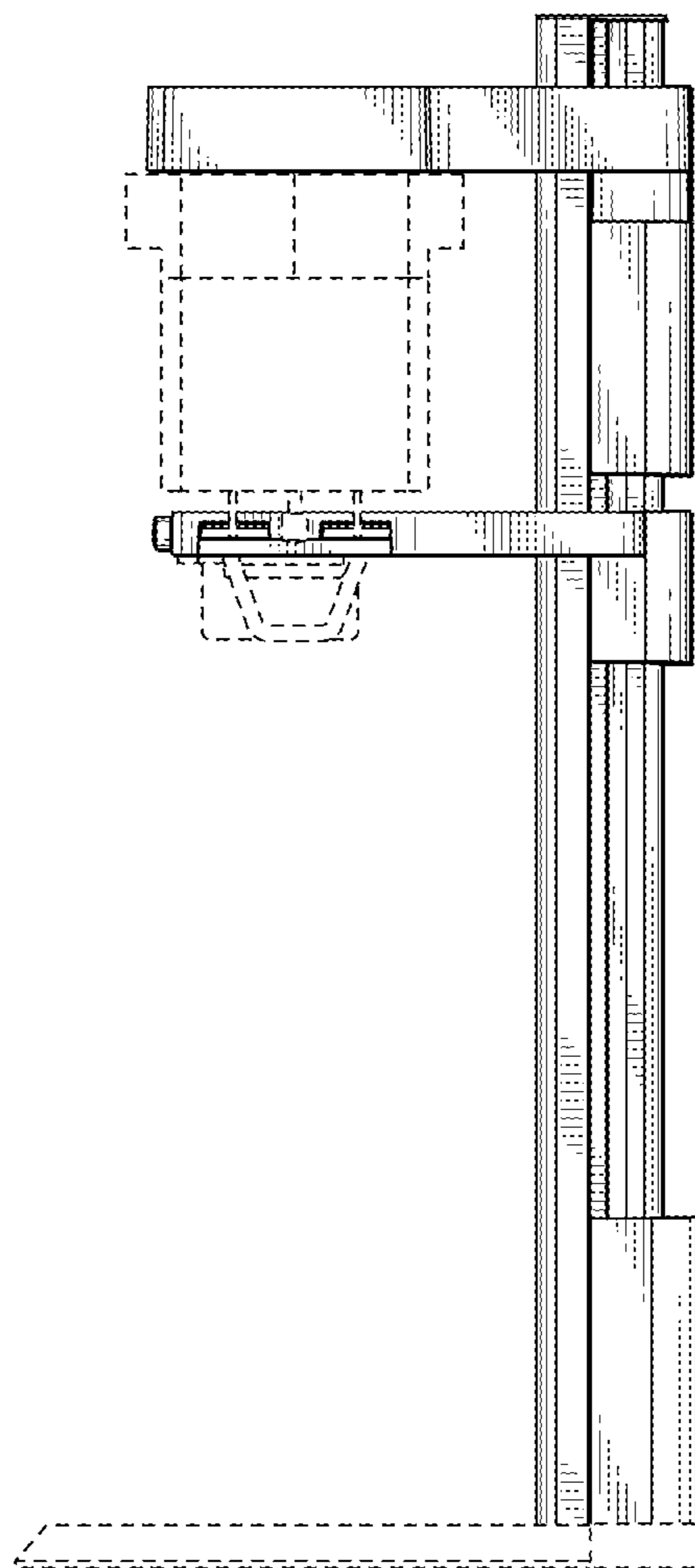

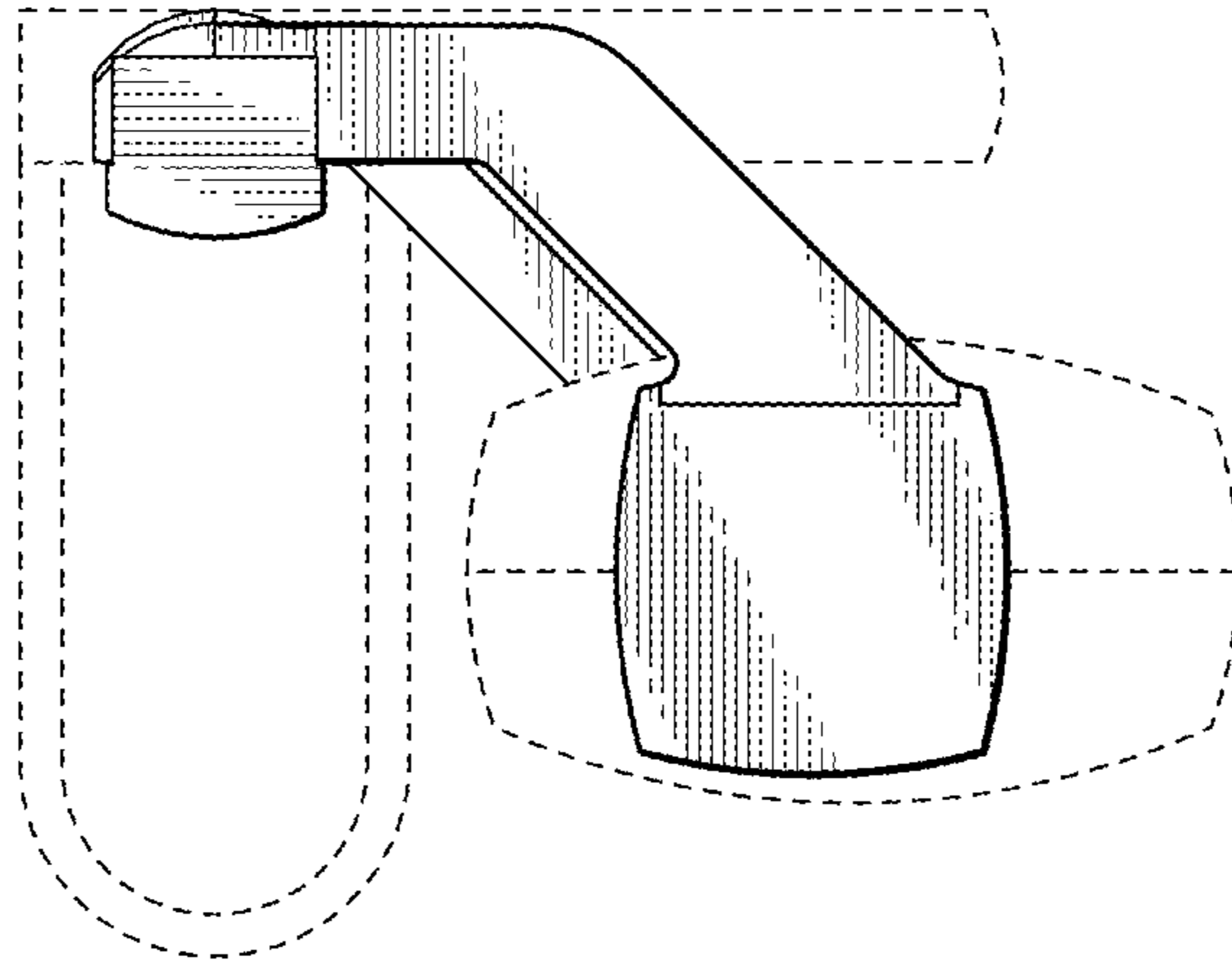

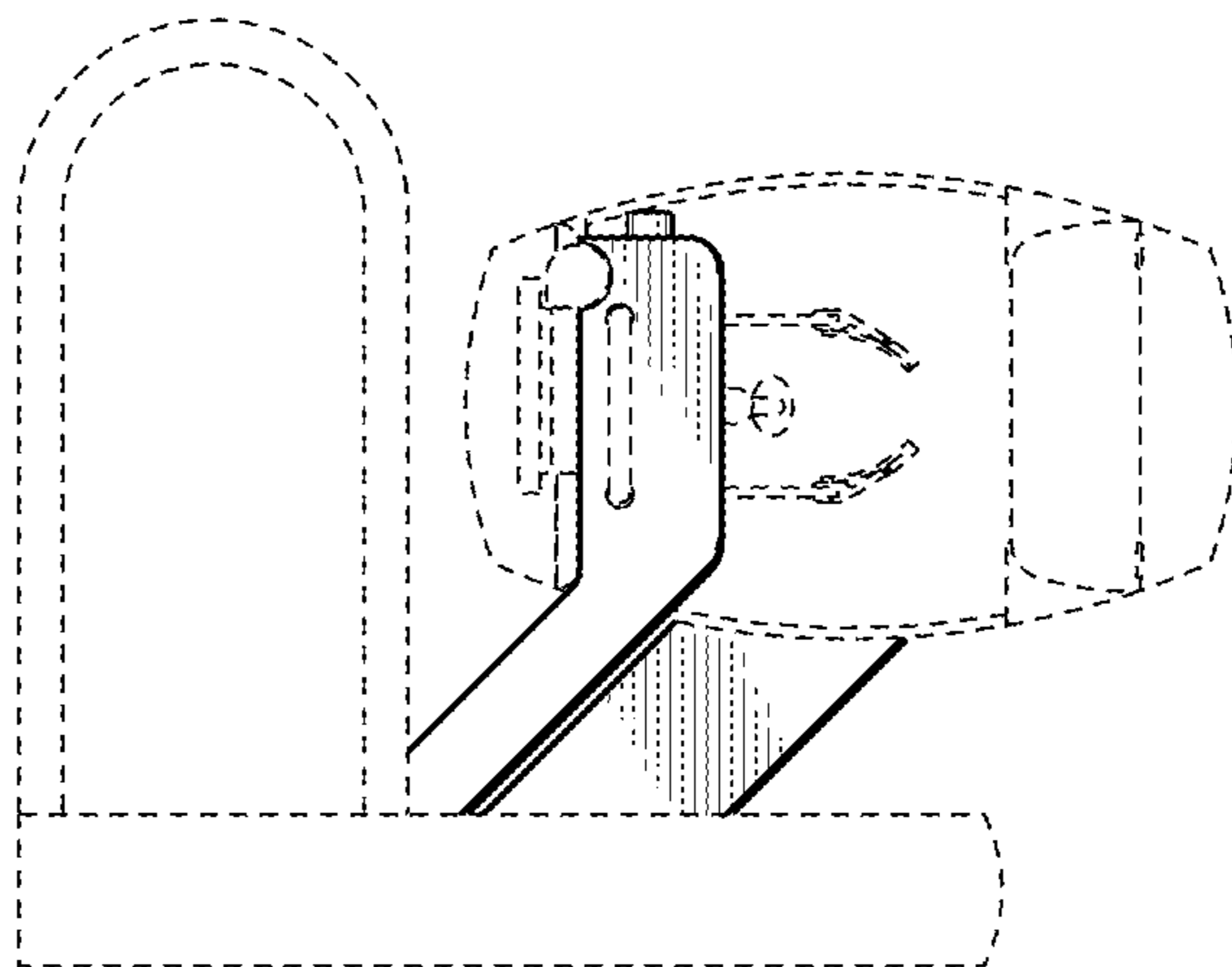

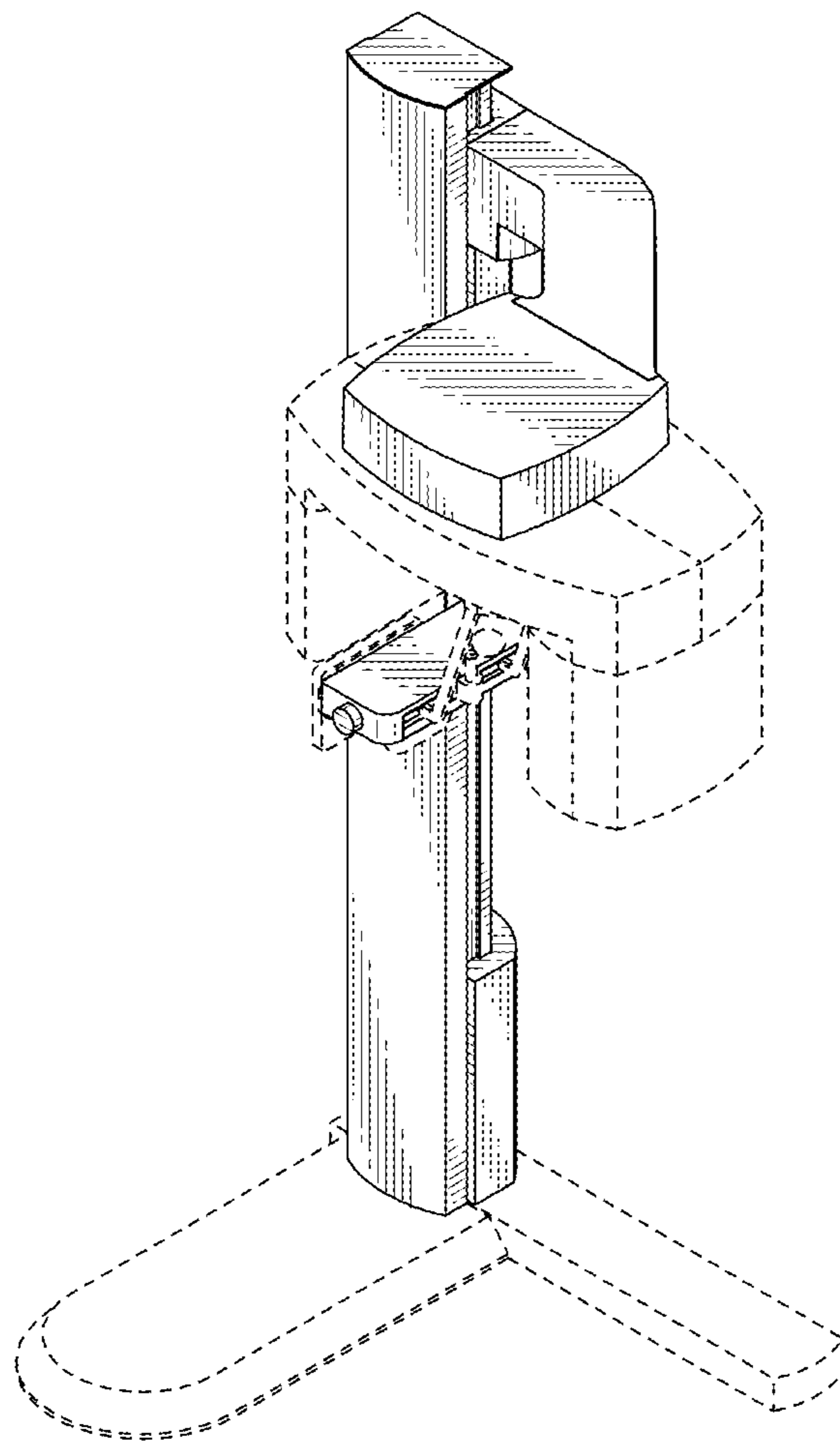
