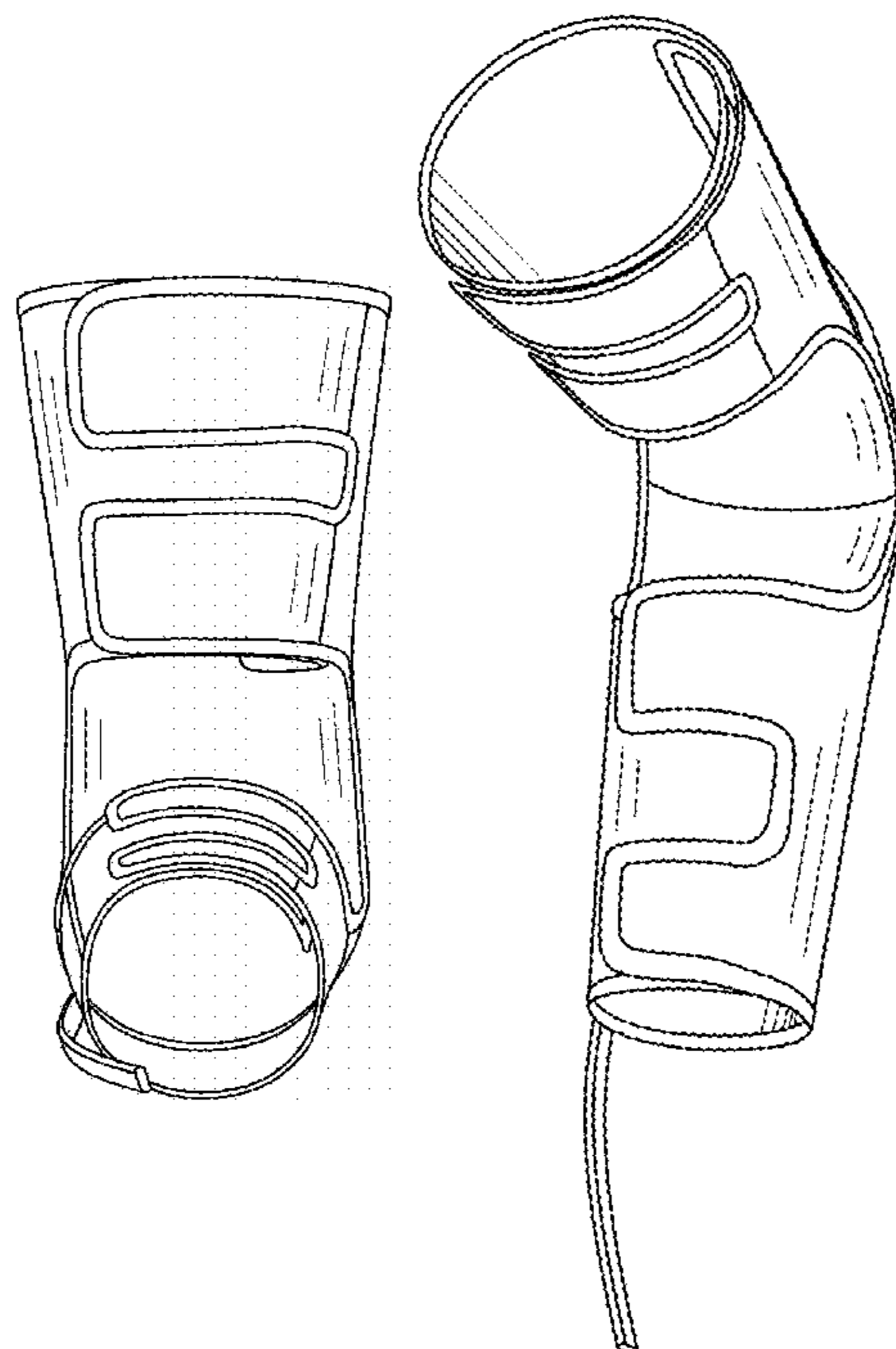
The ornamental design for a cover for foot, as shown and described.

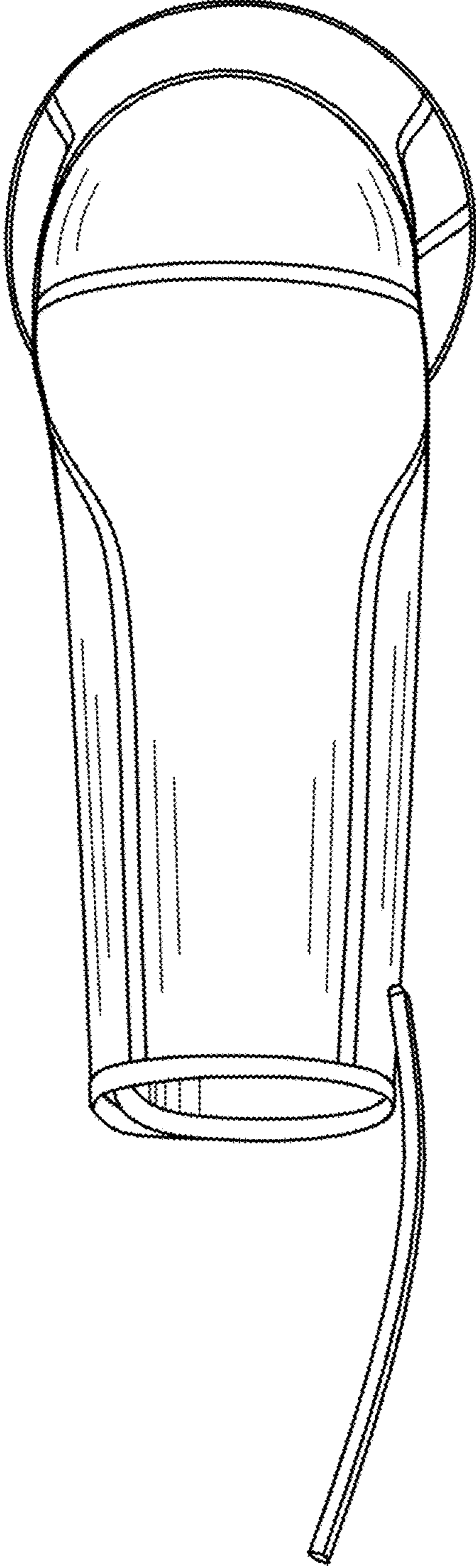

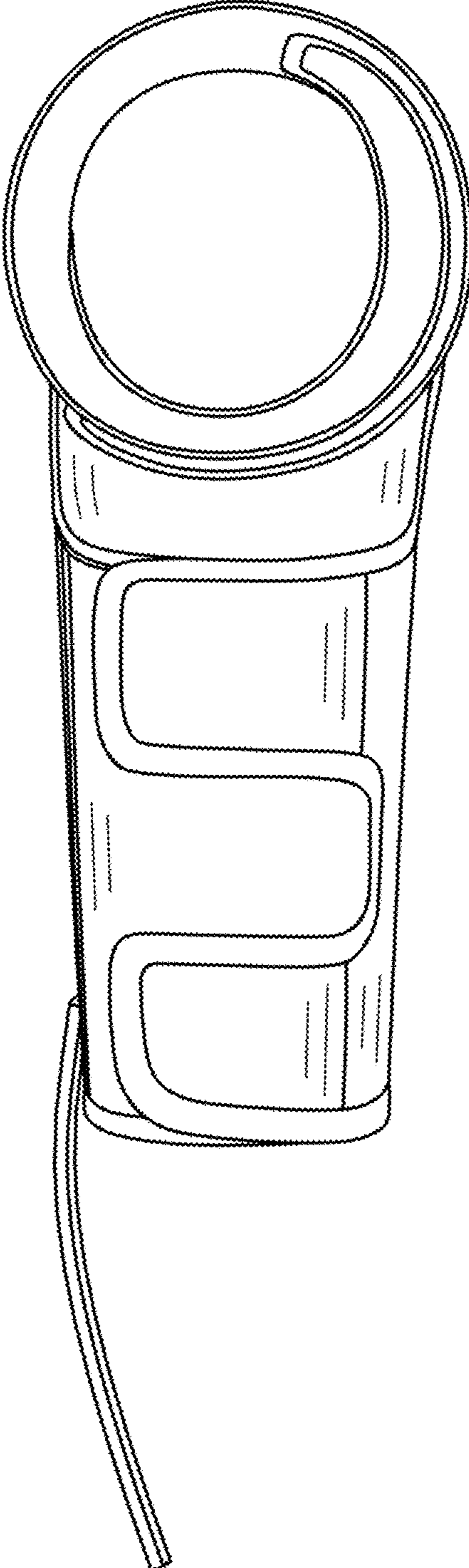

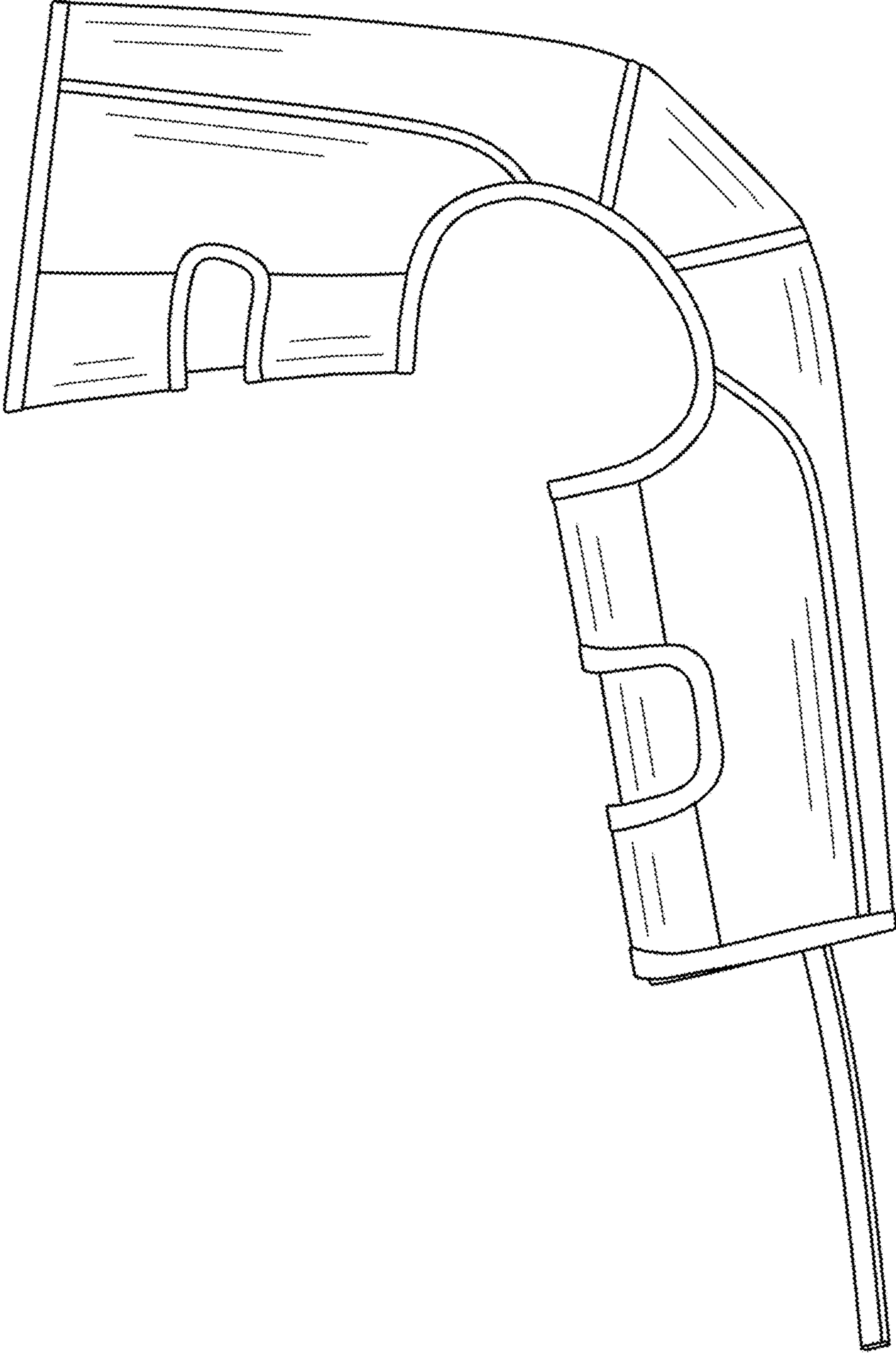

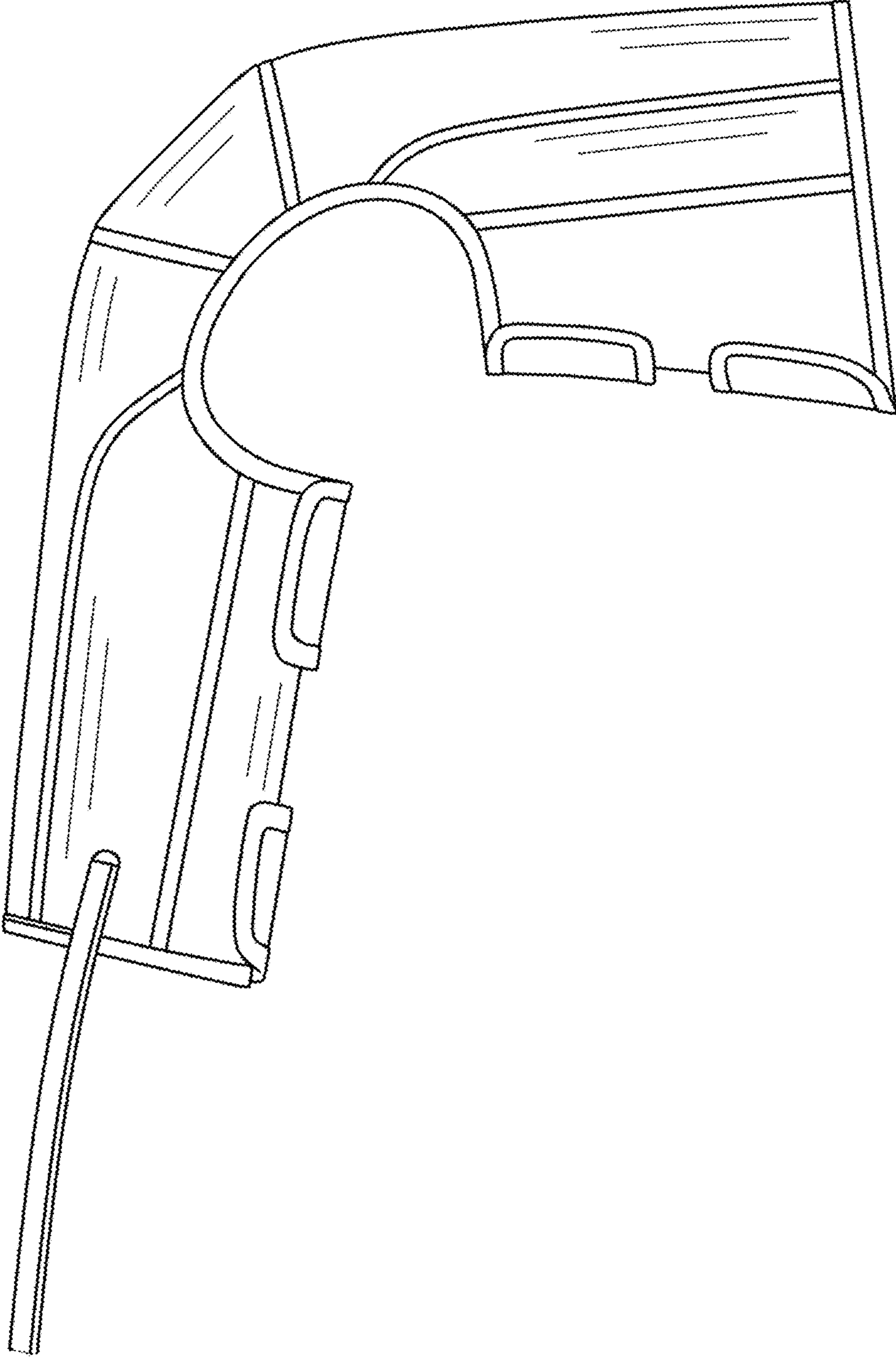

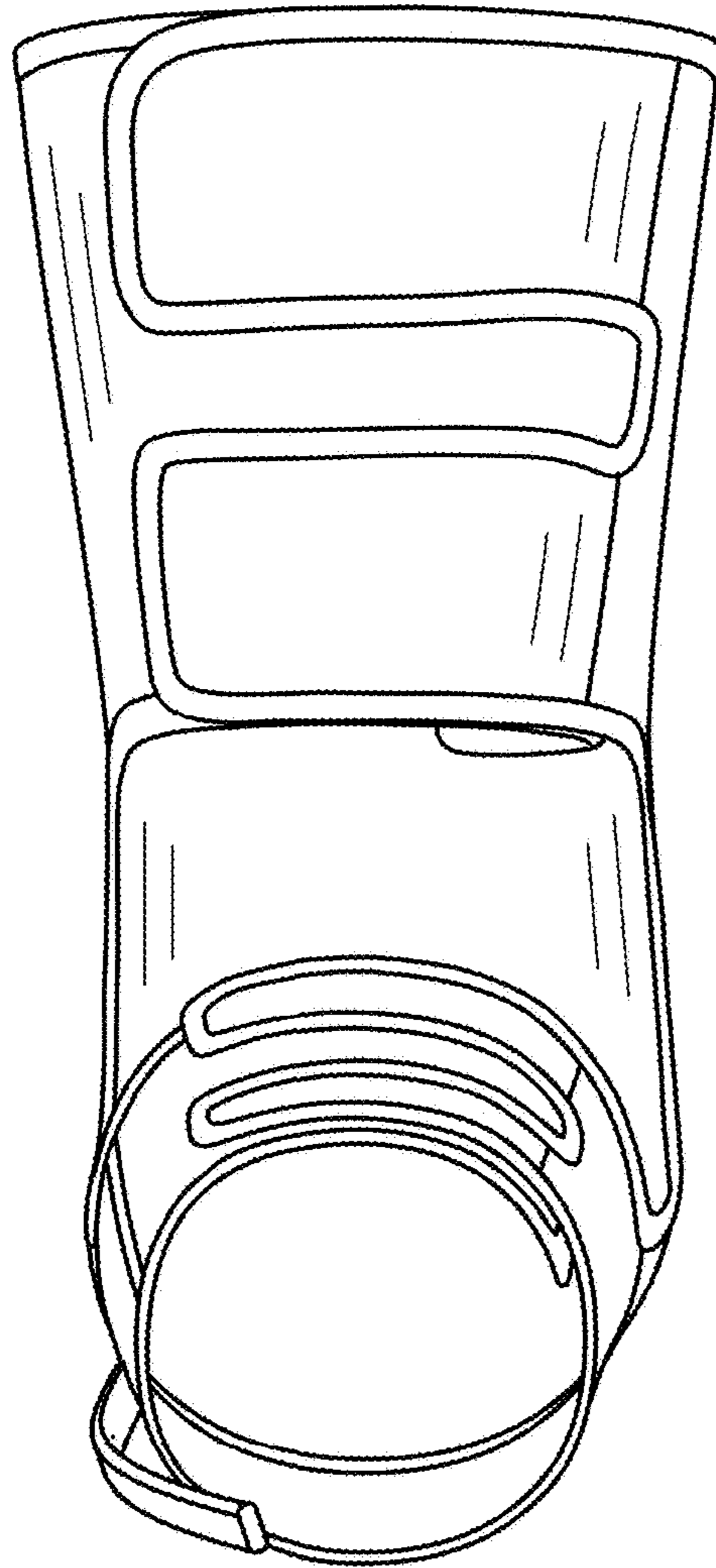

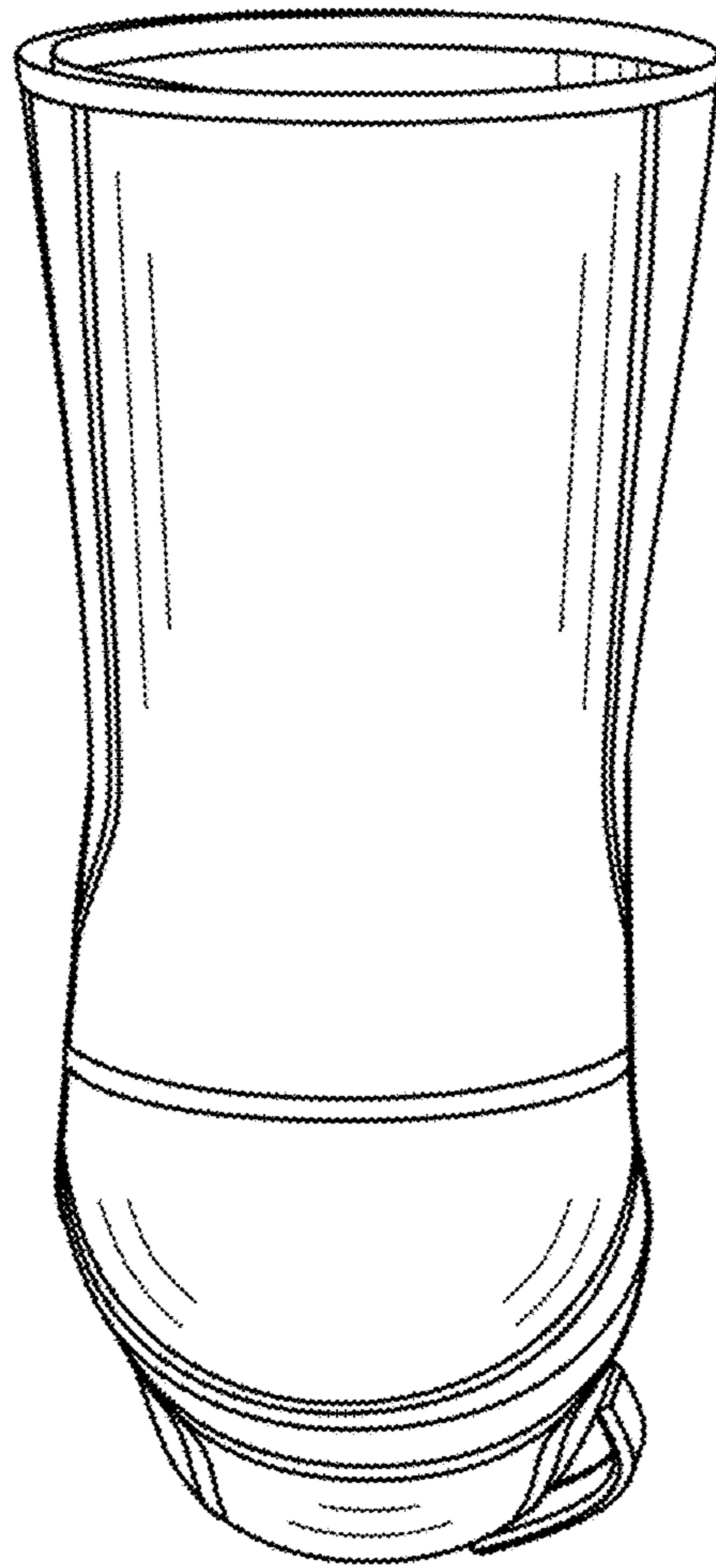

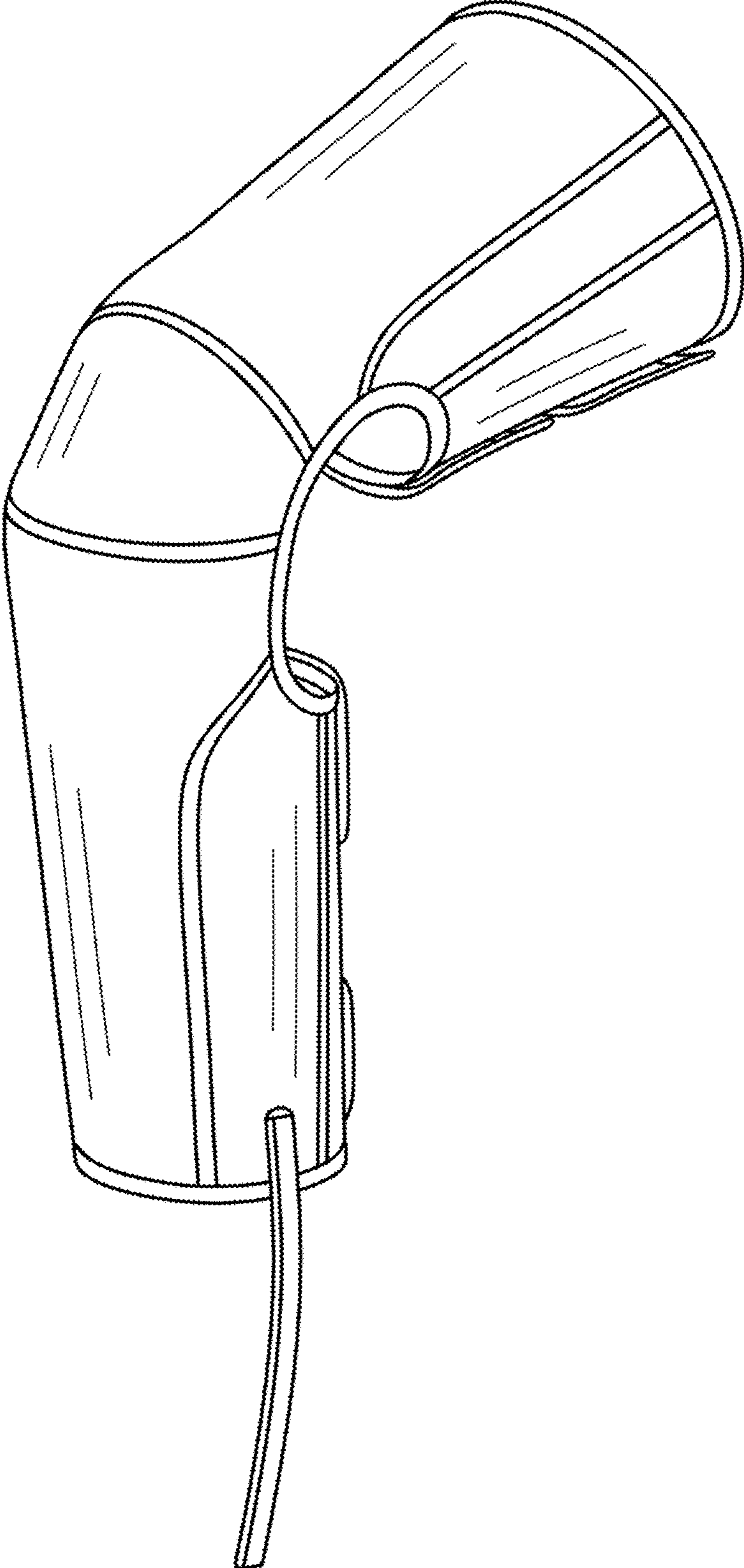

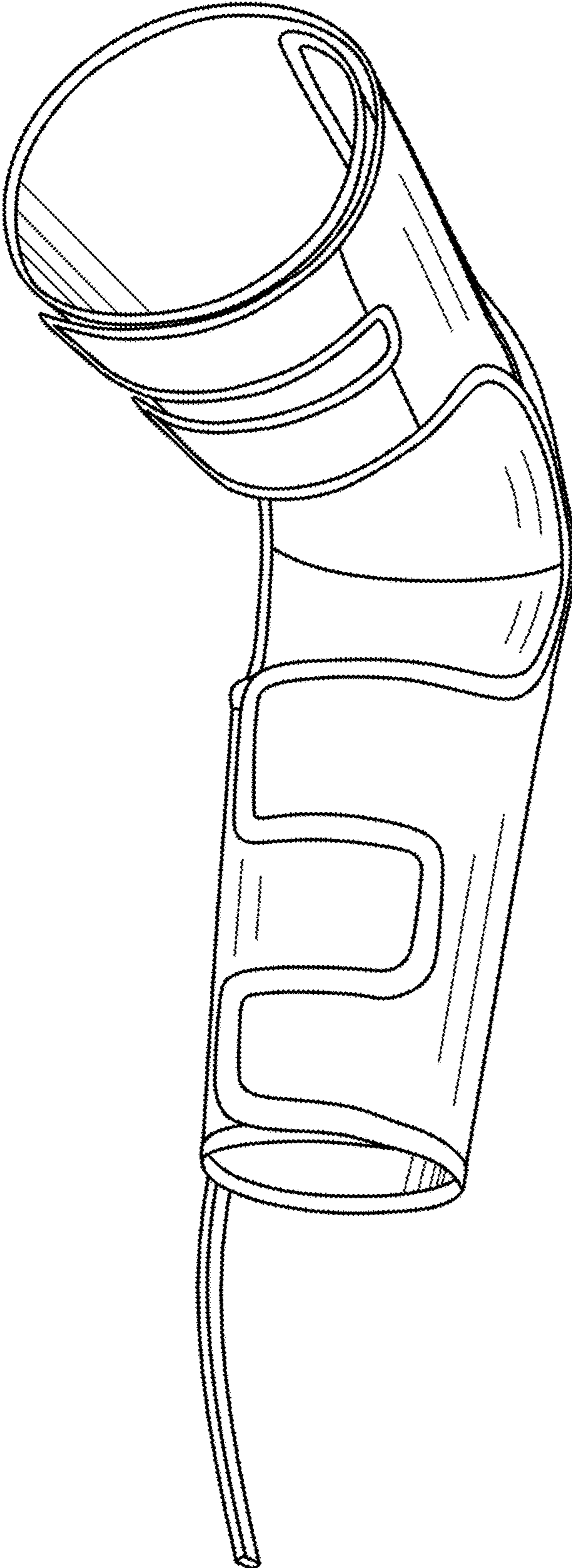
