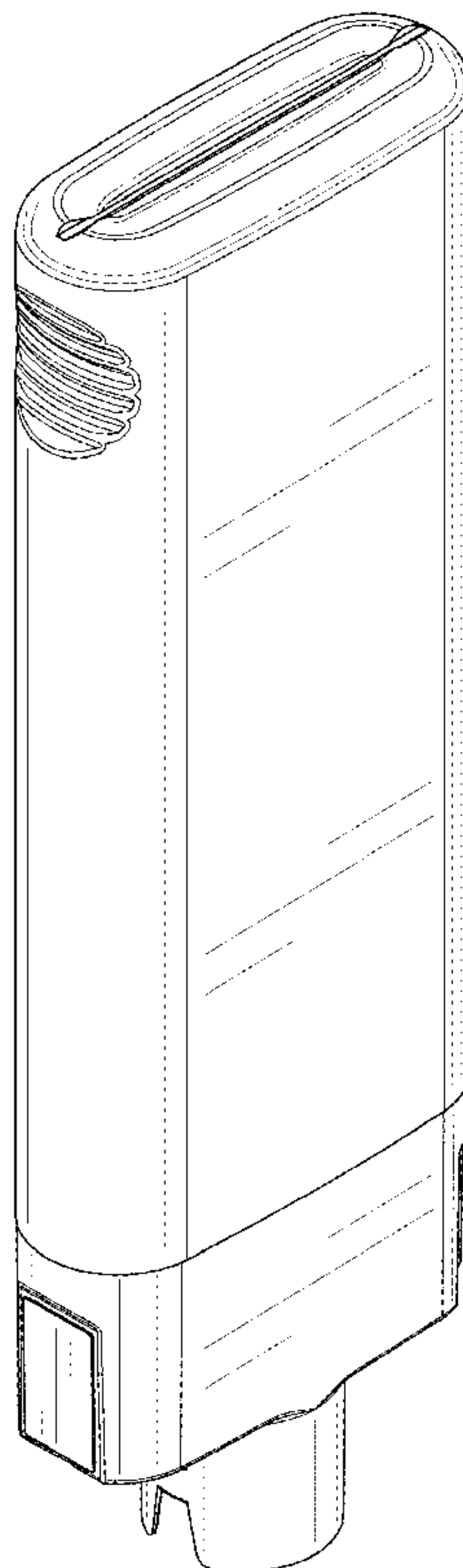
(57) **CLAIM**

The ornamental design for a docking bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a docking bottle showing the new design;
FIG. 2 is a top view of the docking bottle;
FIG. 3 is a bottom view of the docking bottle;
FIG. 4 is a front view of the docking bottle;
FIG. 5 is a back view of the docking bottle;
FIG. 6 is a left side view of the docking bottle; and,

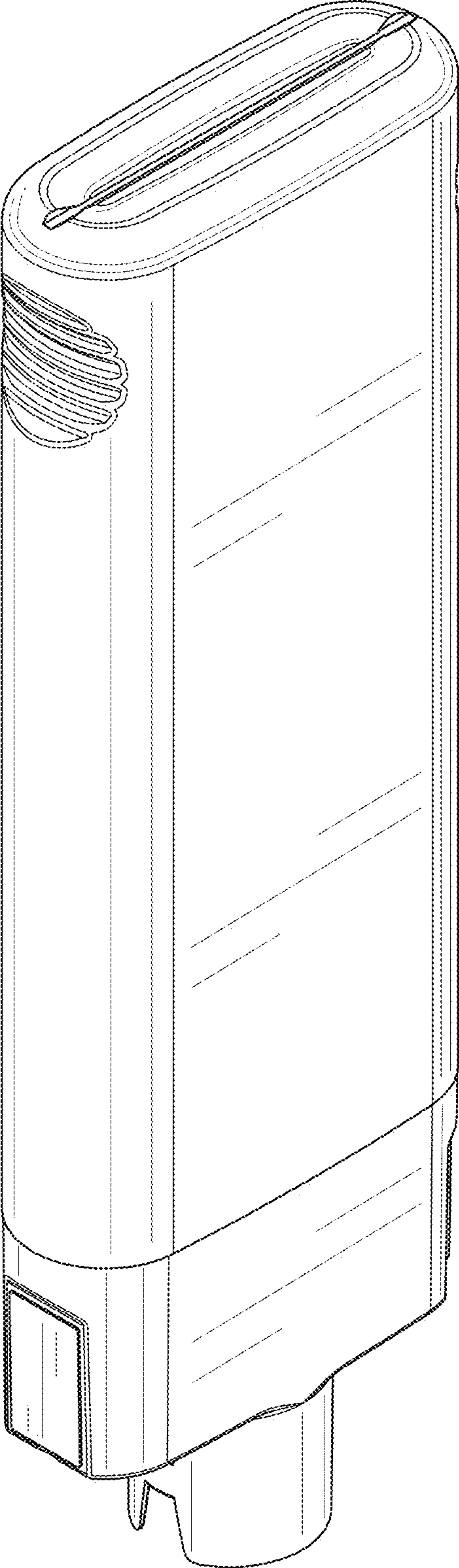

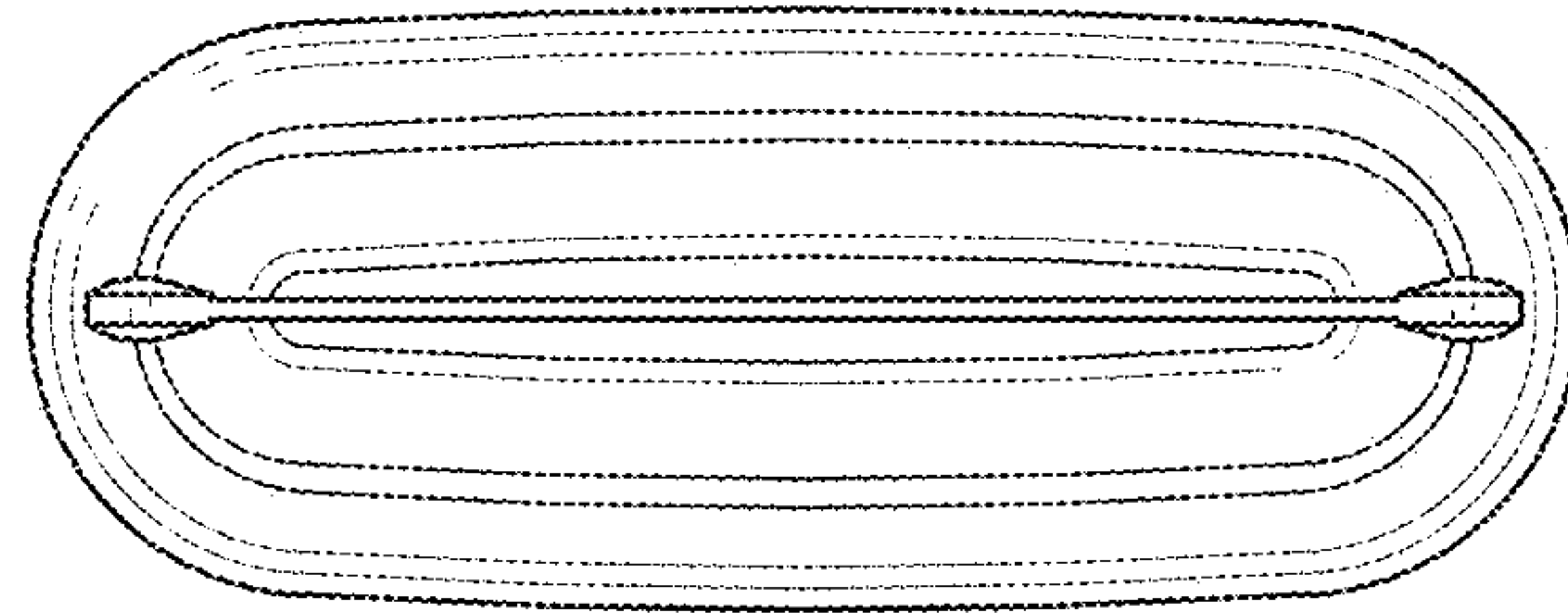

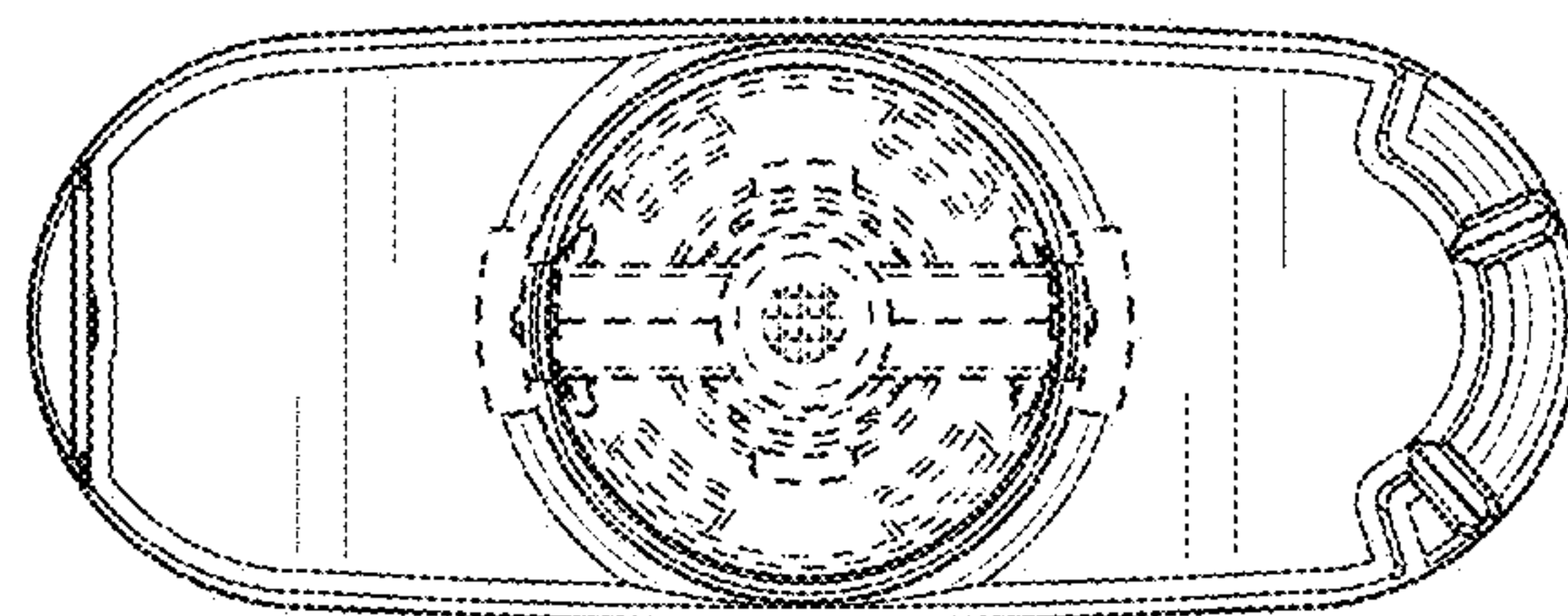

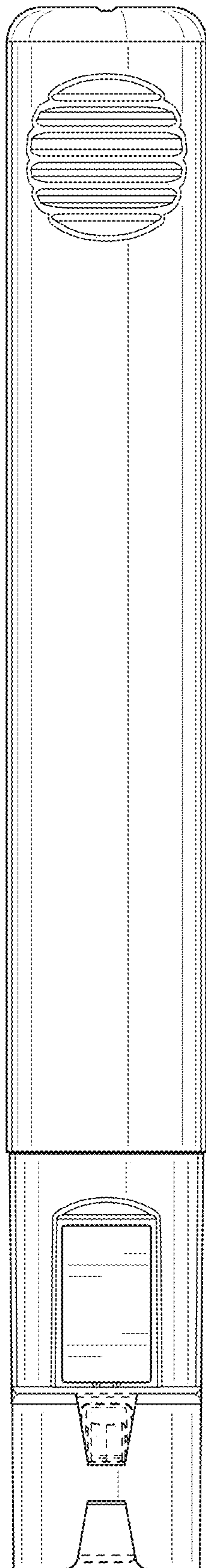

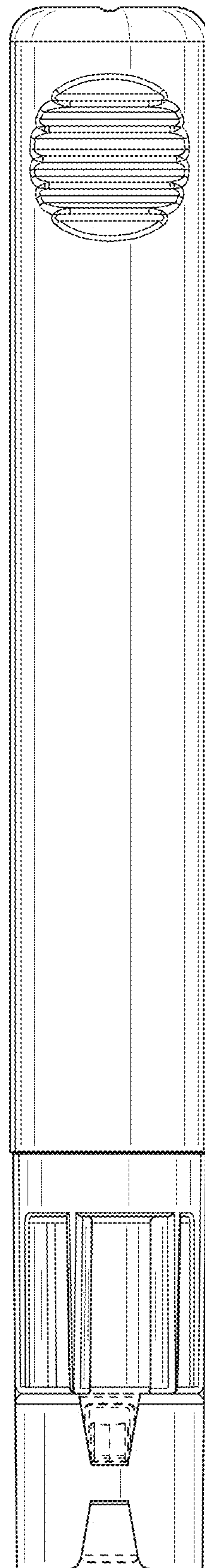

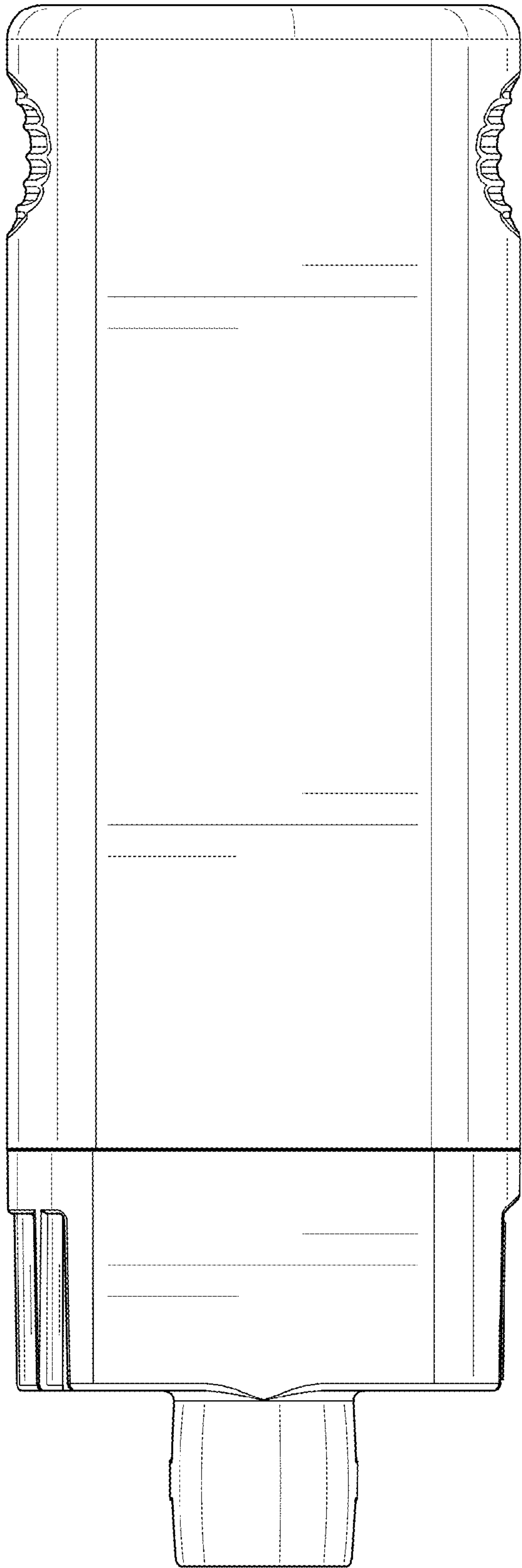

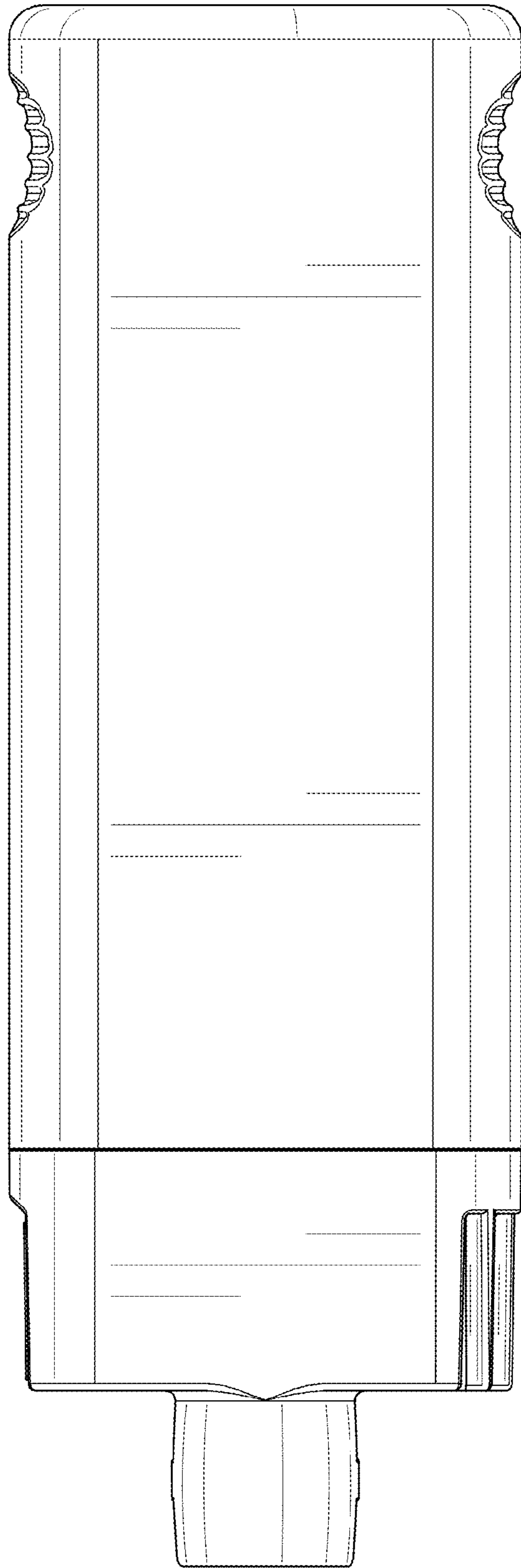
