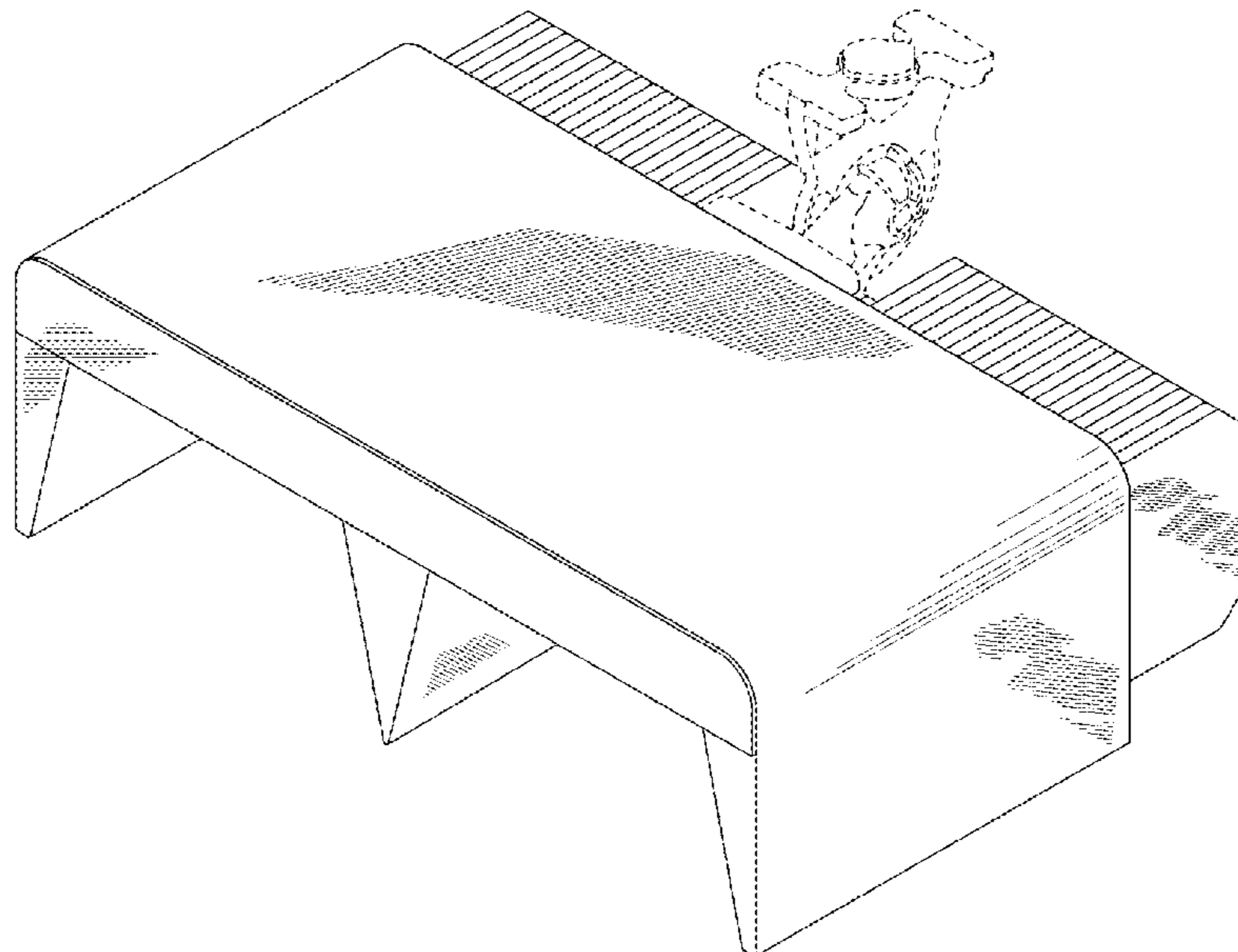
(57) **CLAIM**

The ornamental design for a lighting fixture with visor, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of the lighting fixture with visor;  
FIG. 2 is a bottom front perspective view of the lighting fixture with visor;  
FIG. 3 is a front elevation of FIG. 1;  
FIG. 4 is a back elevation of FIG. 1;  
FIG. 5 is a right side elevation of FIG. 1;

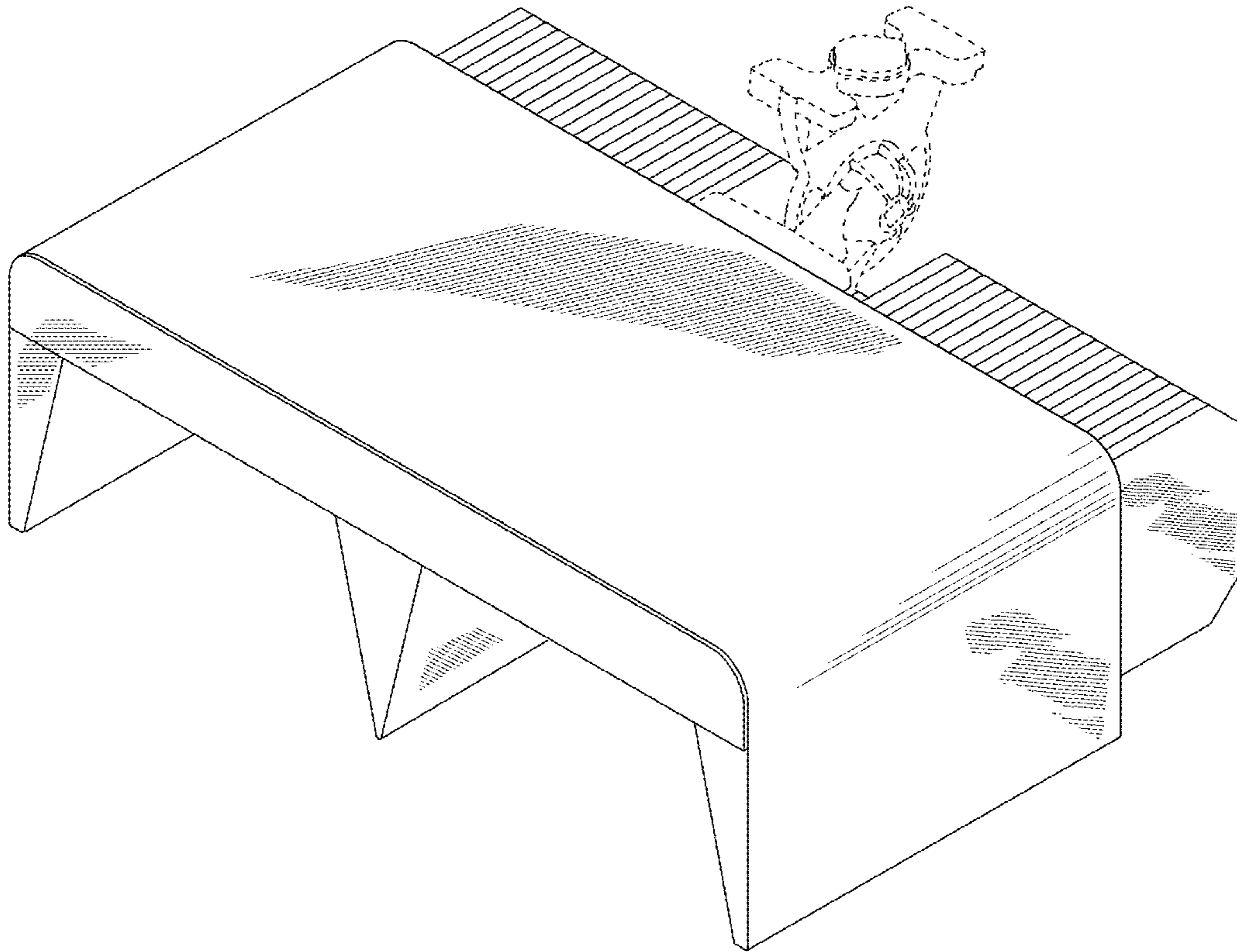

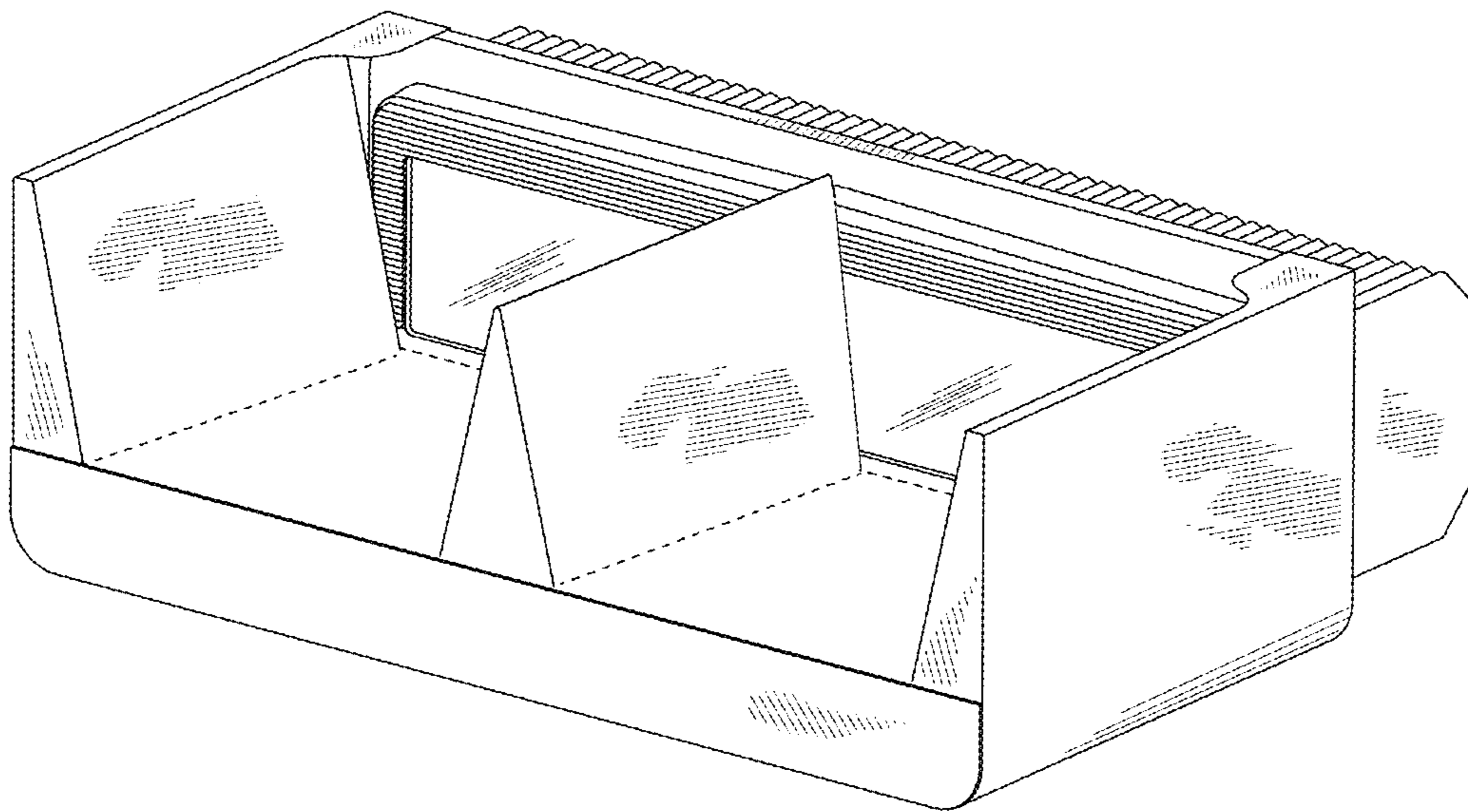

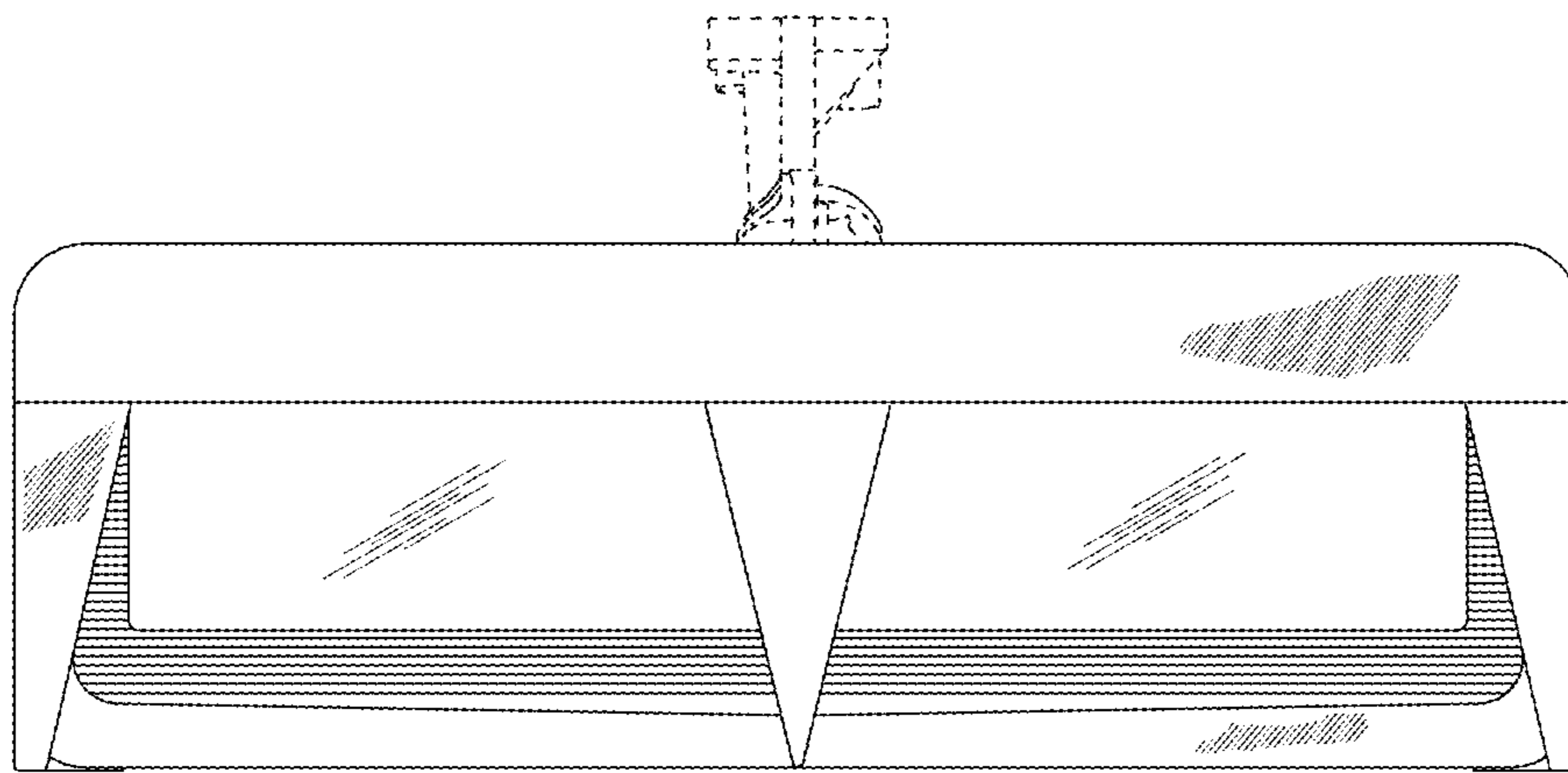

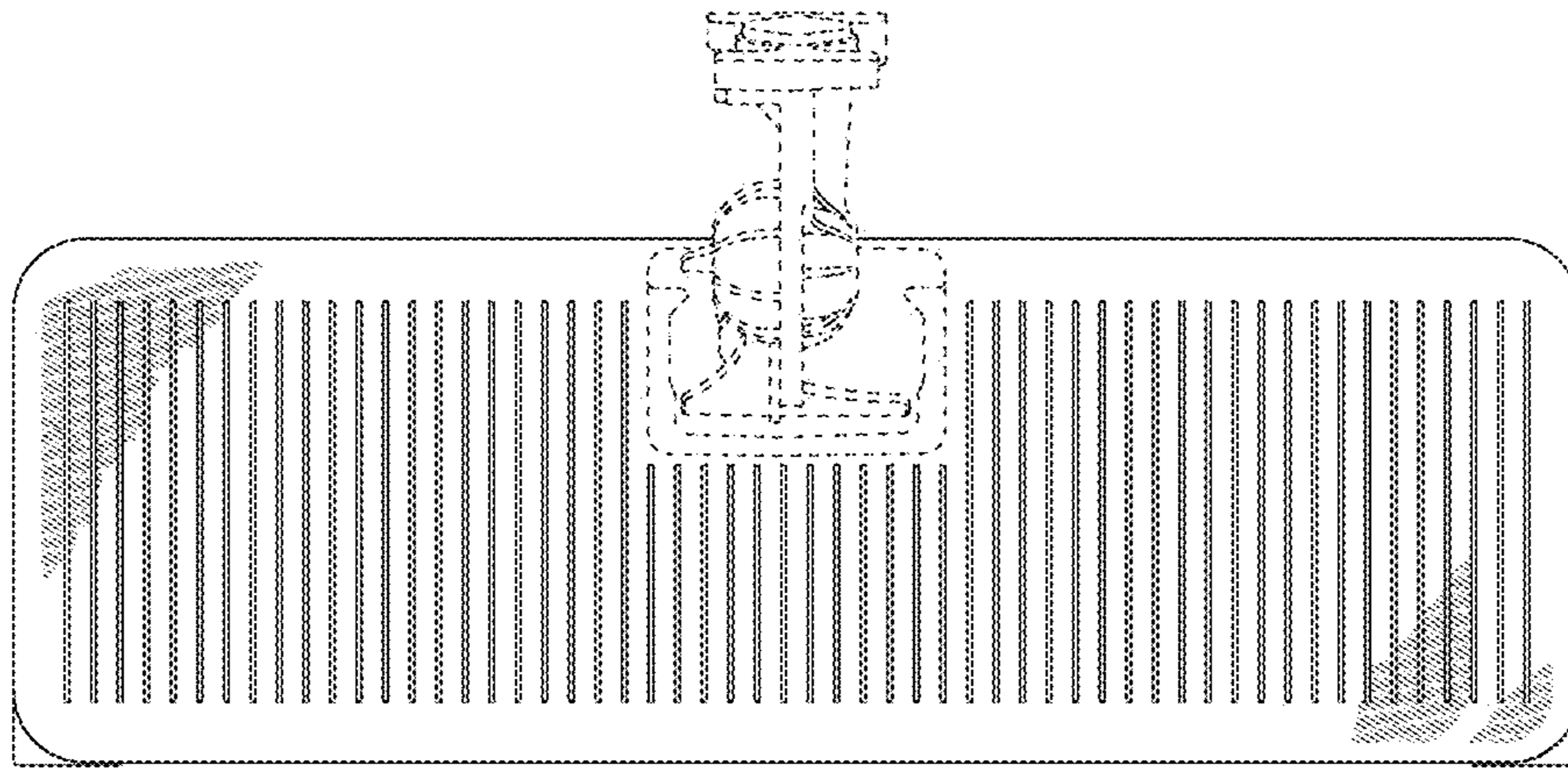

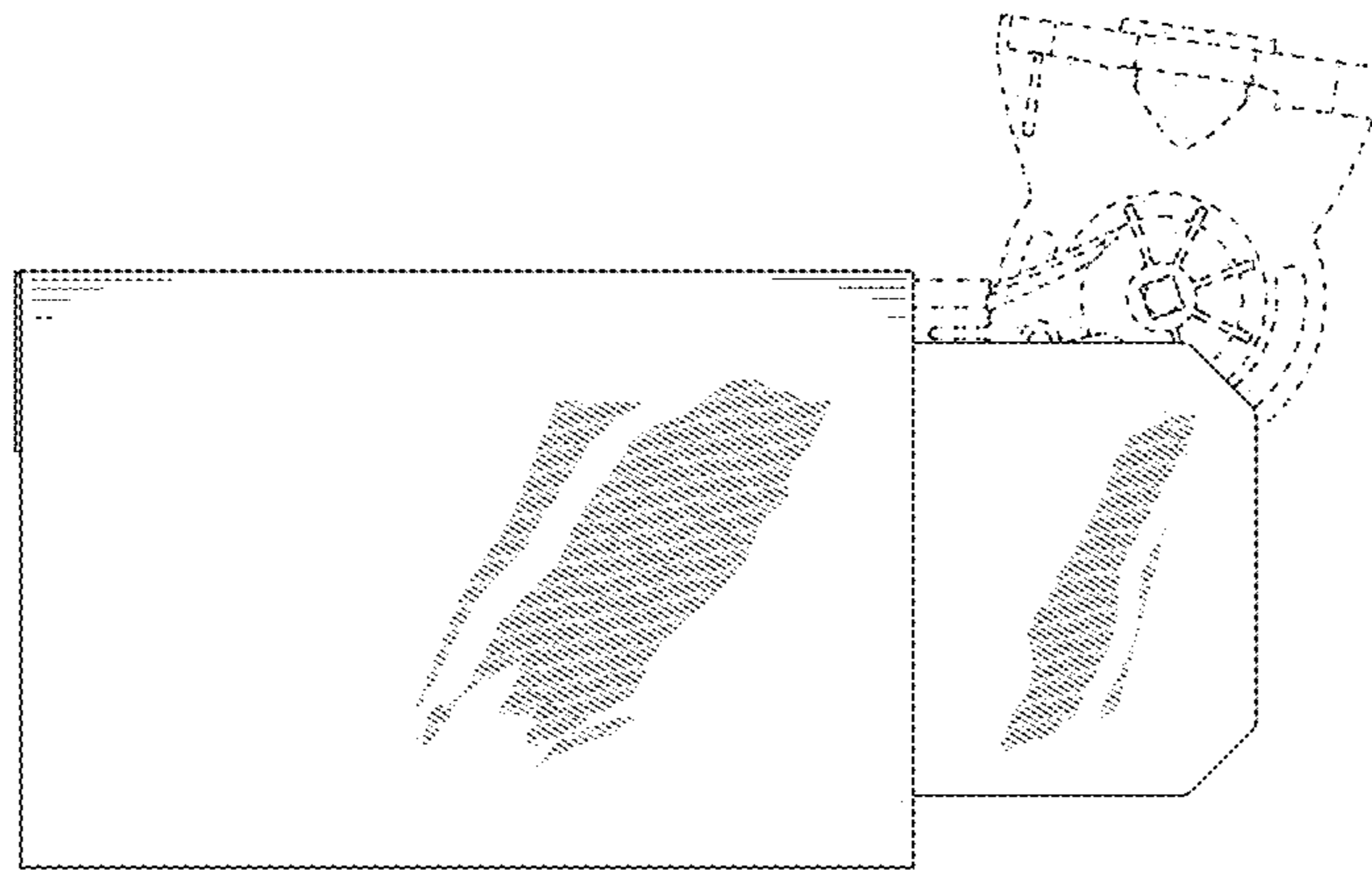

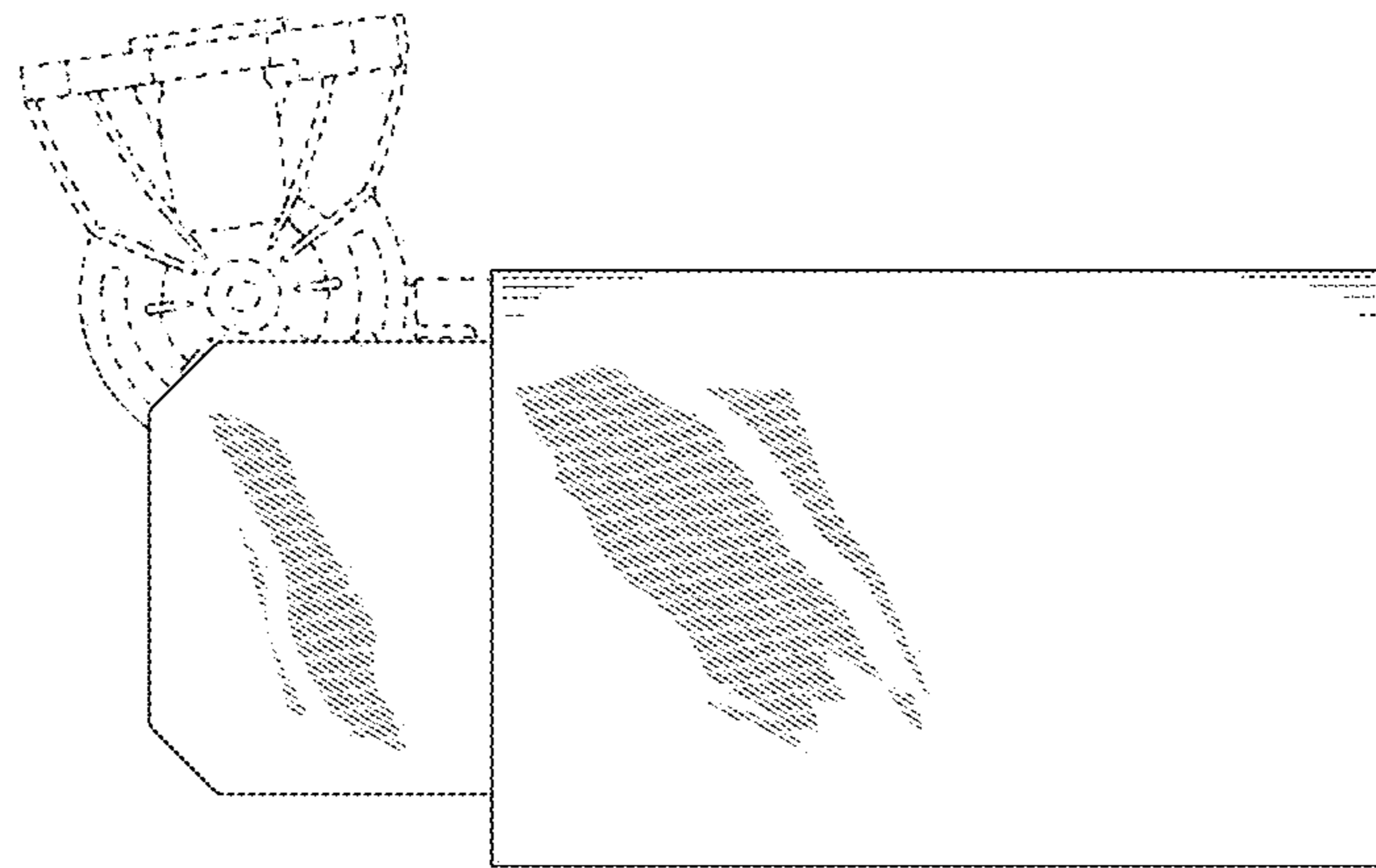

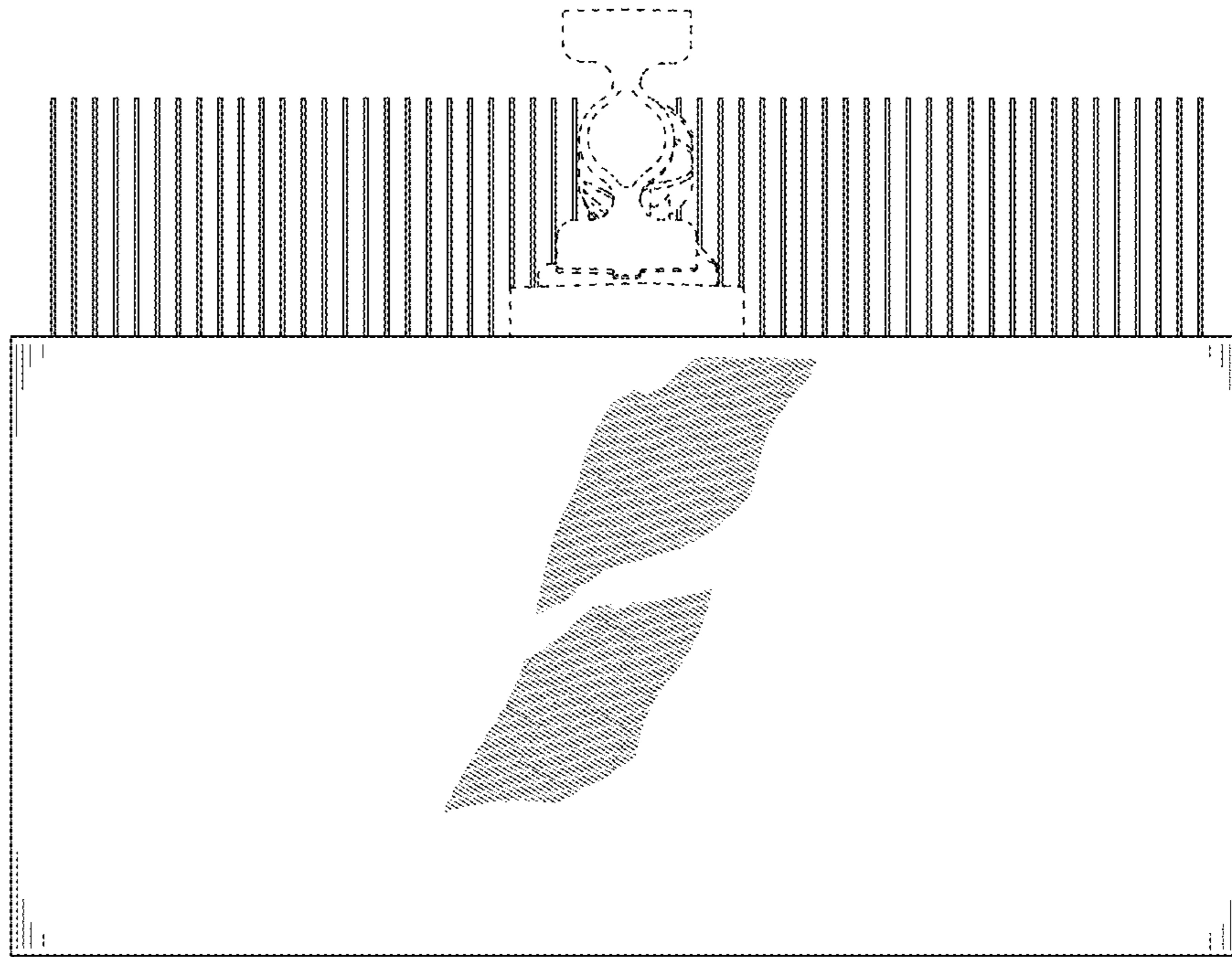

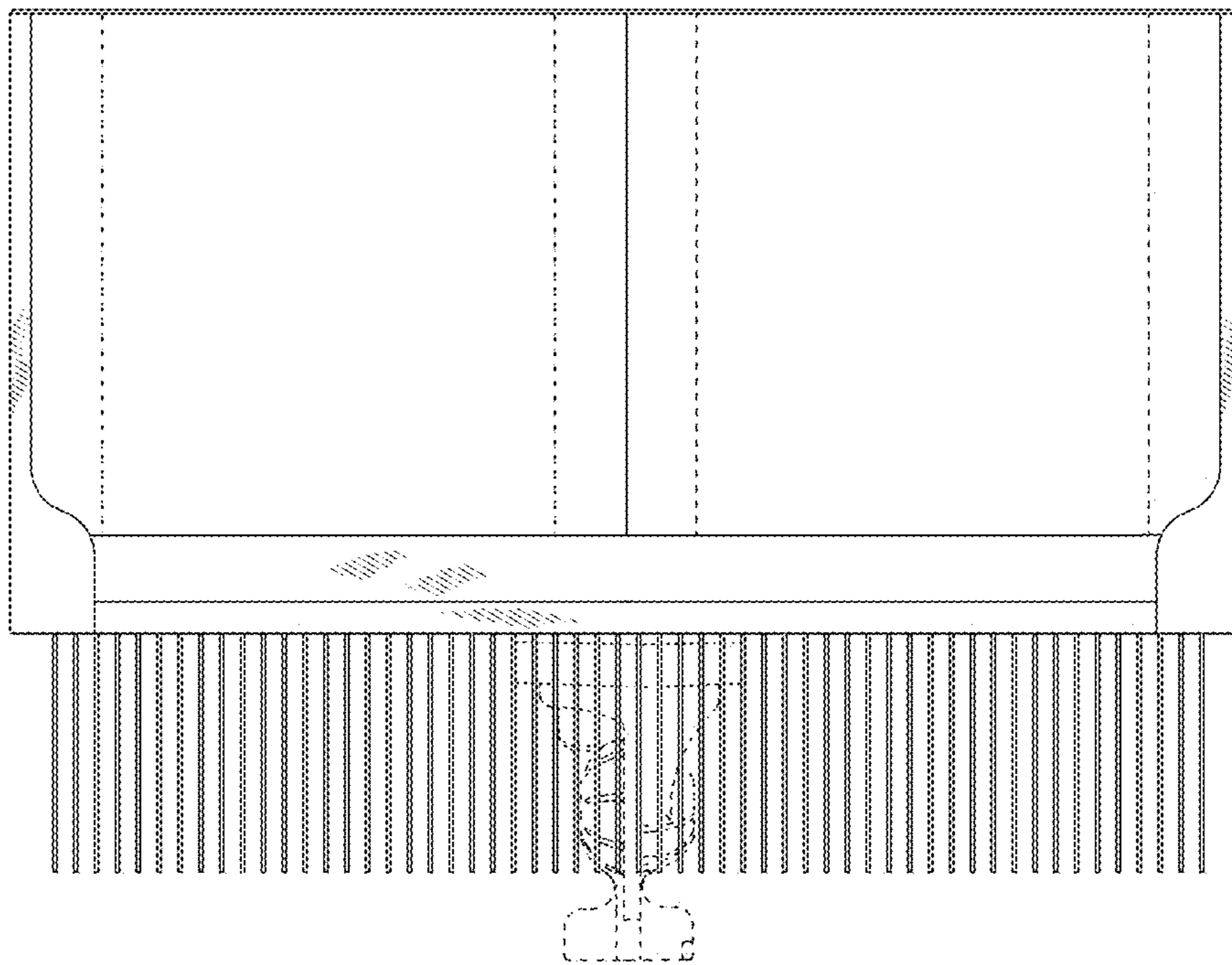
