(57) **CLAIM**

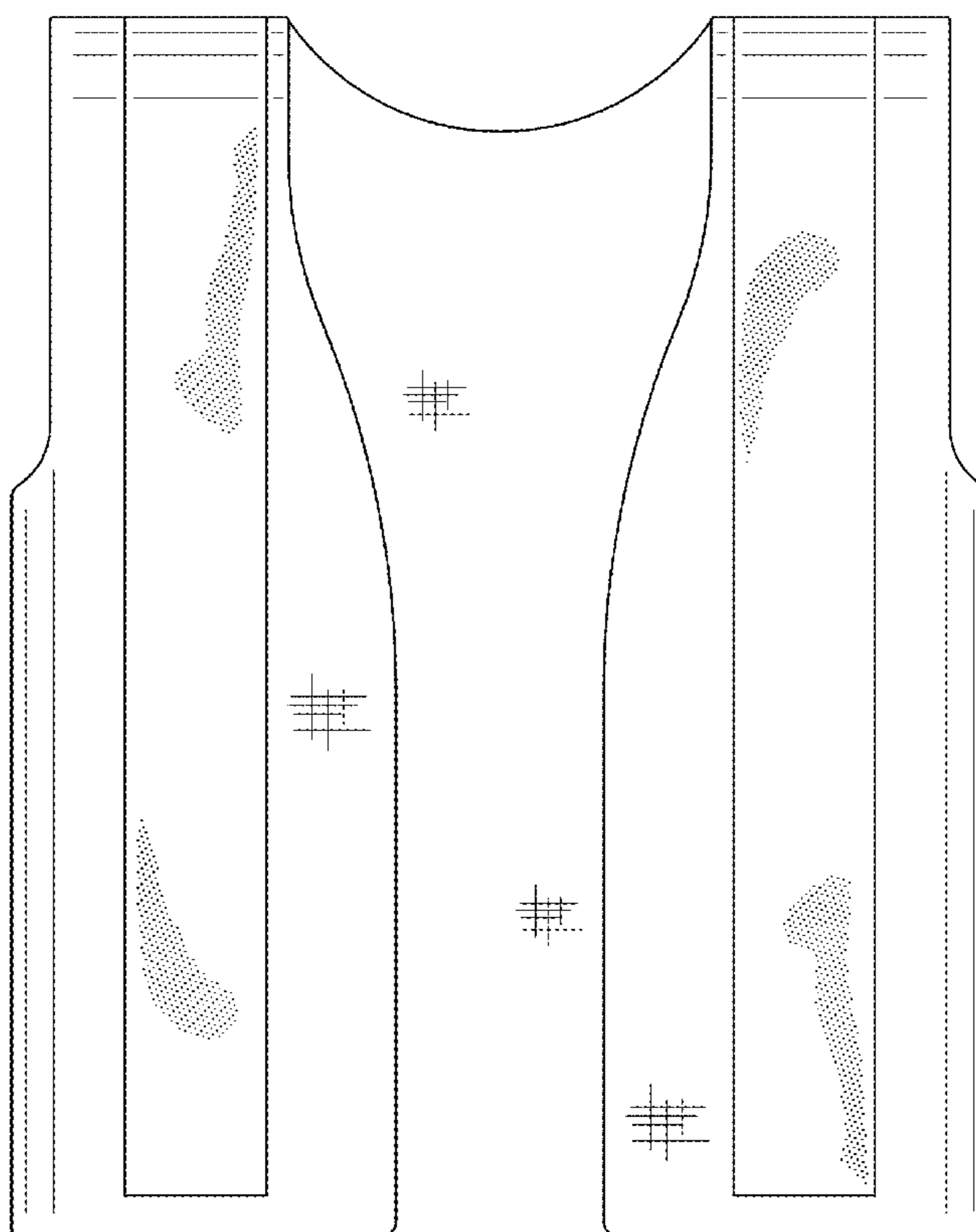
The ornamental design for a safety vest with reflective strips, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a safety vest with reflective strips showing my new design with a vest and a pair of reflective strips;  
FIG. 2 is a rear elevation thereof;

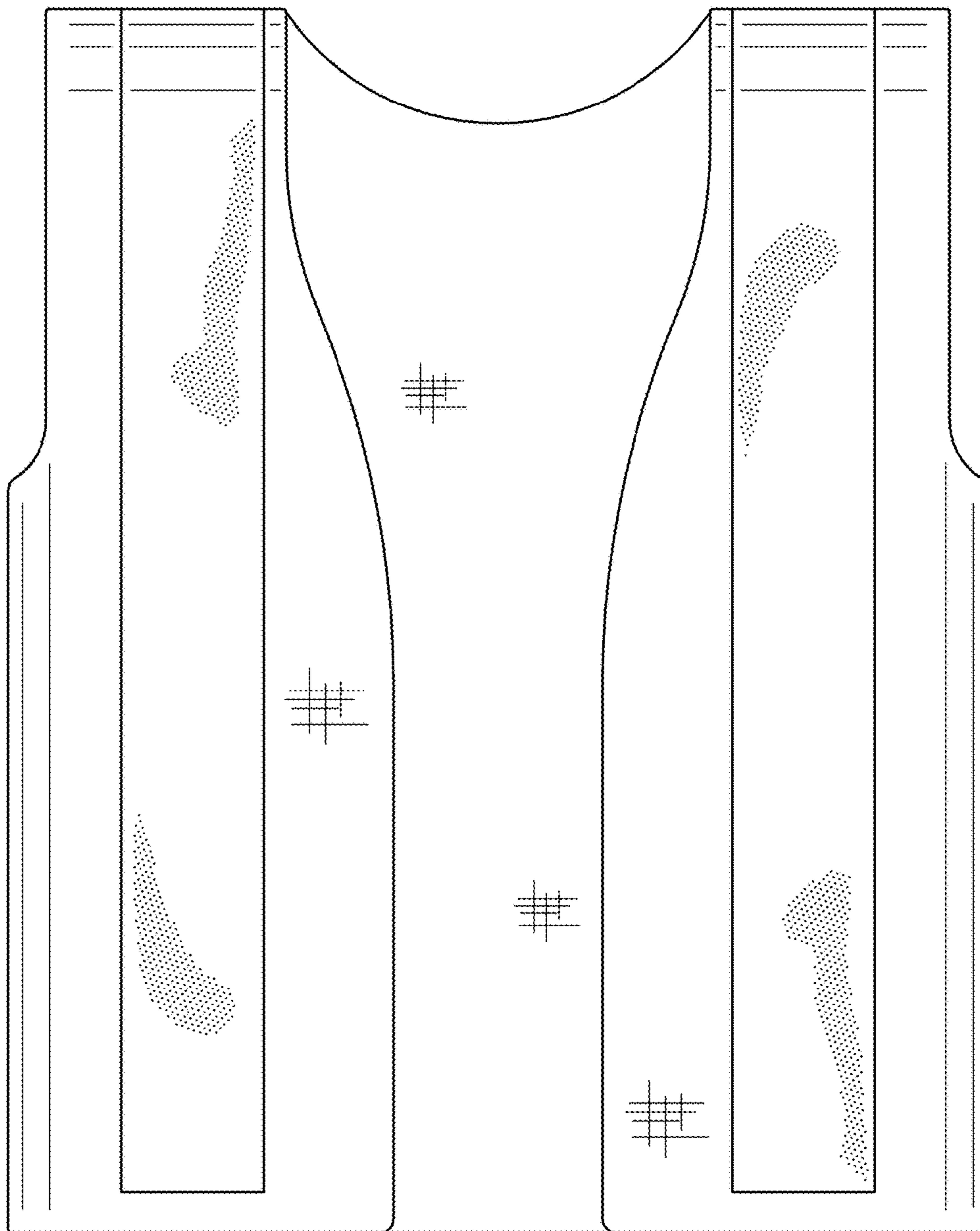

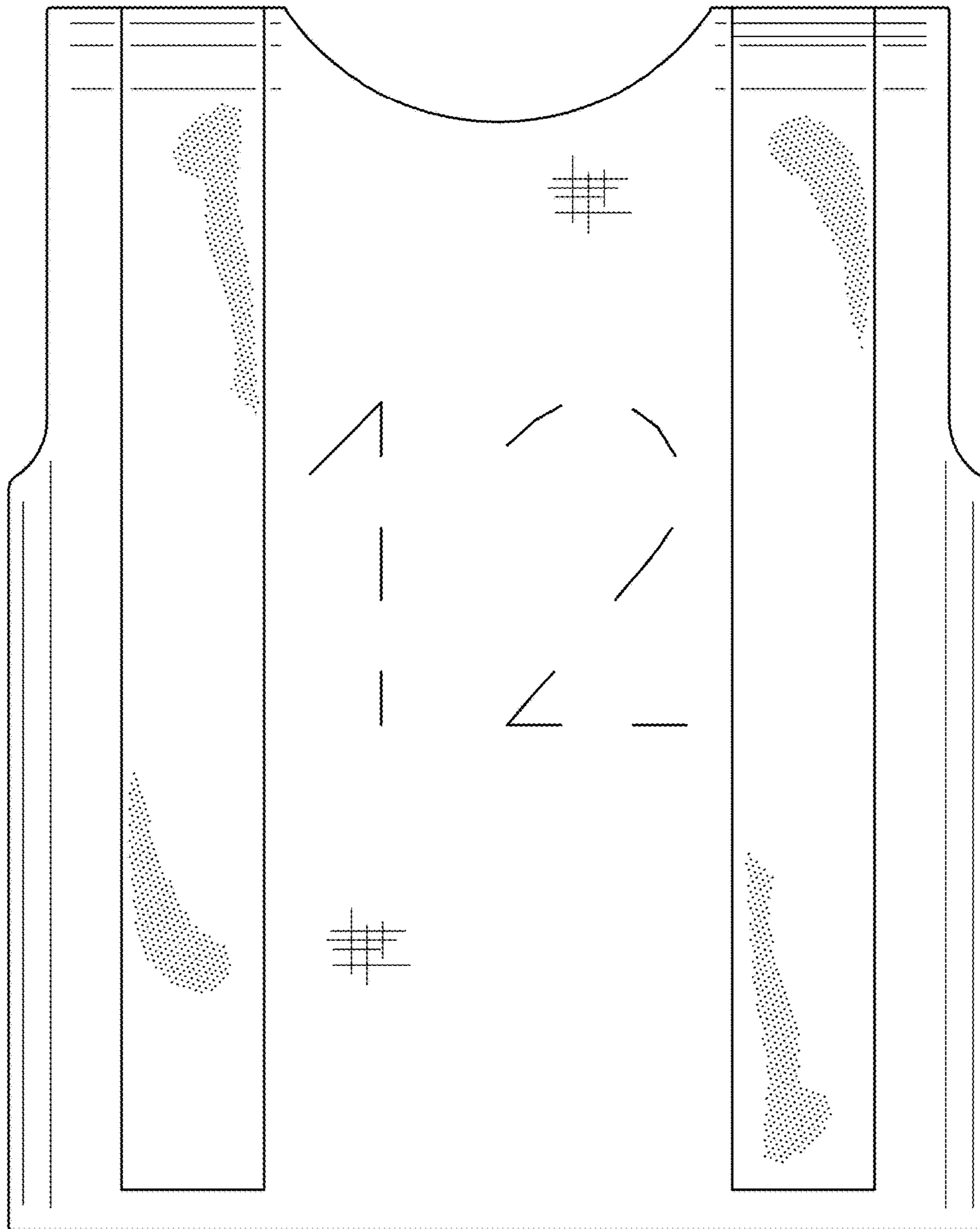

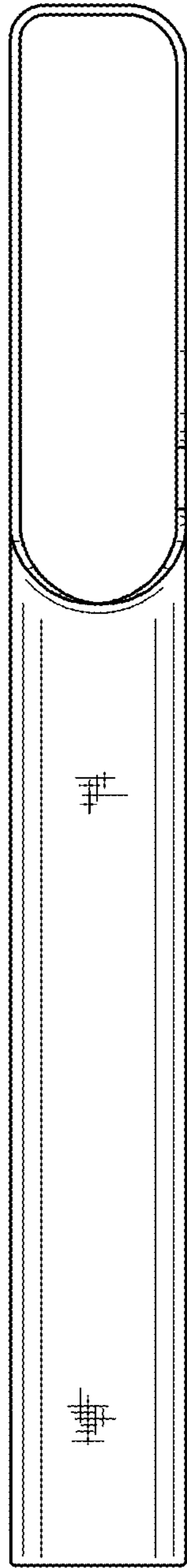

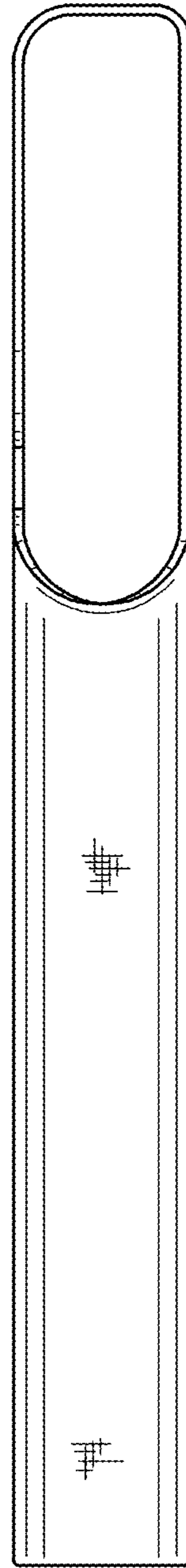

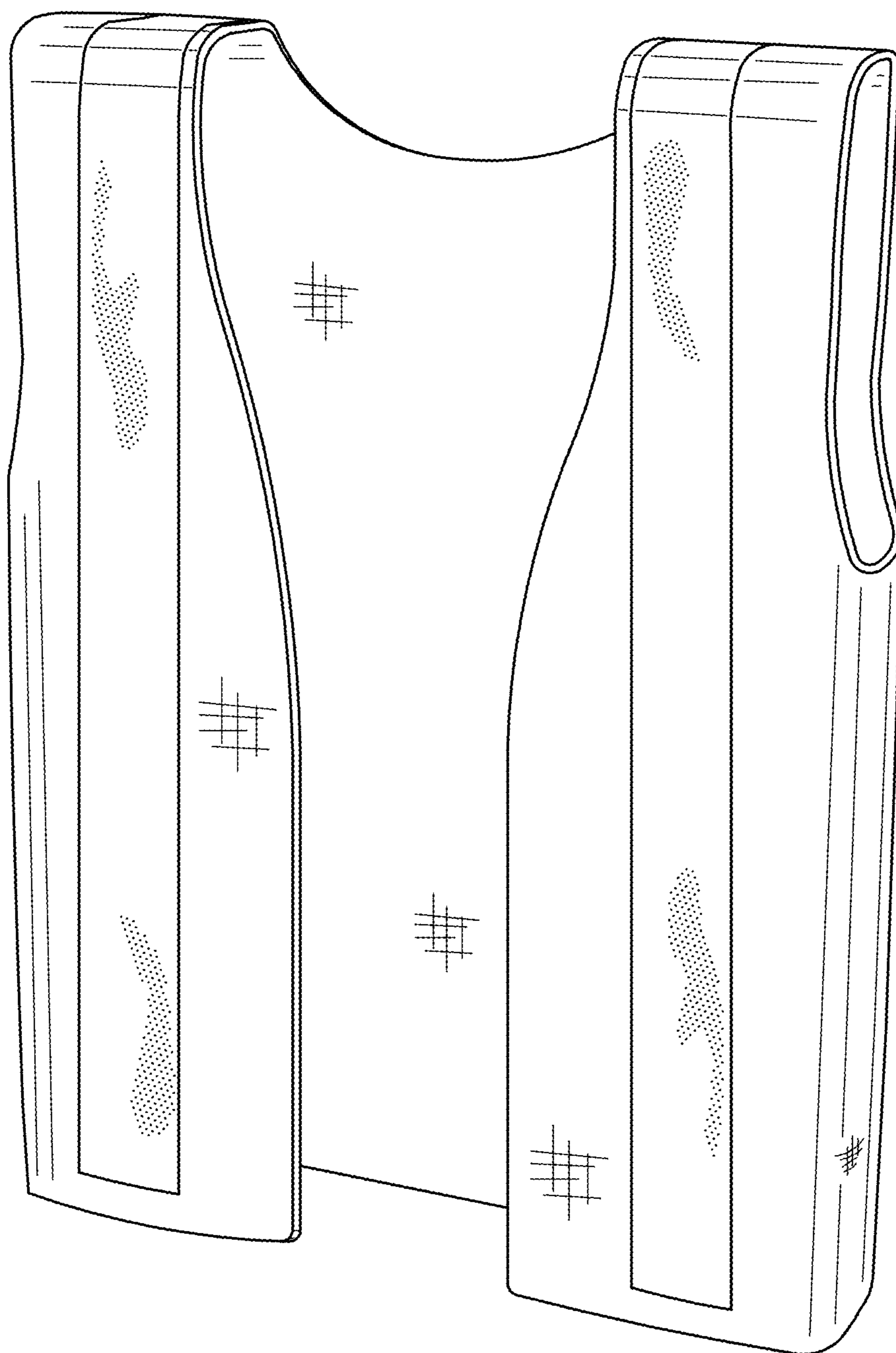
