DESCRIPTION

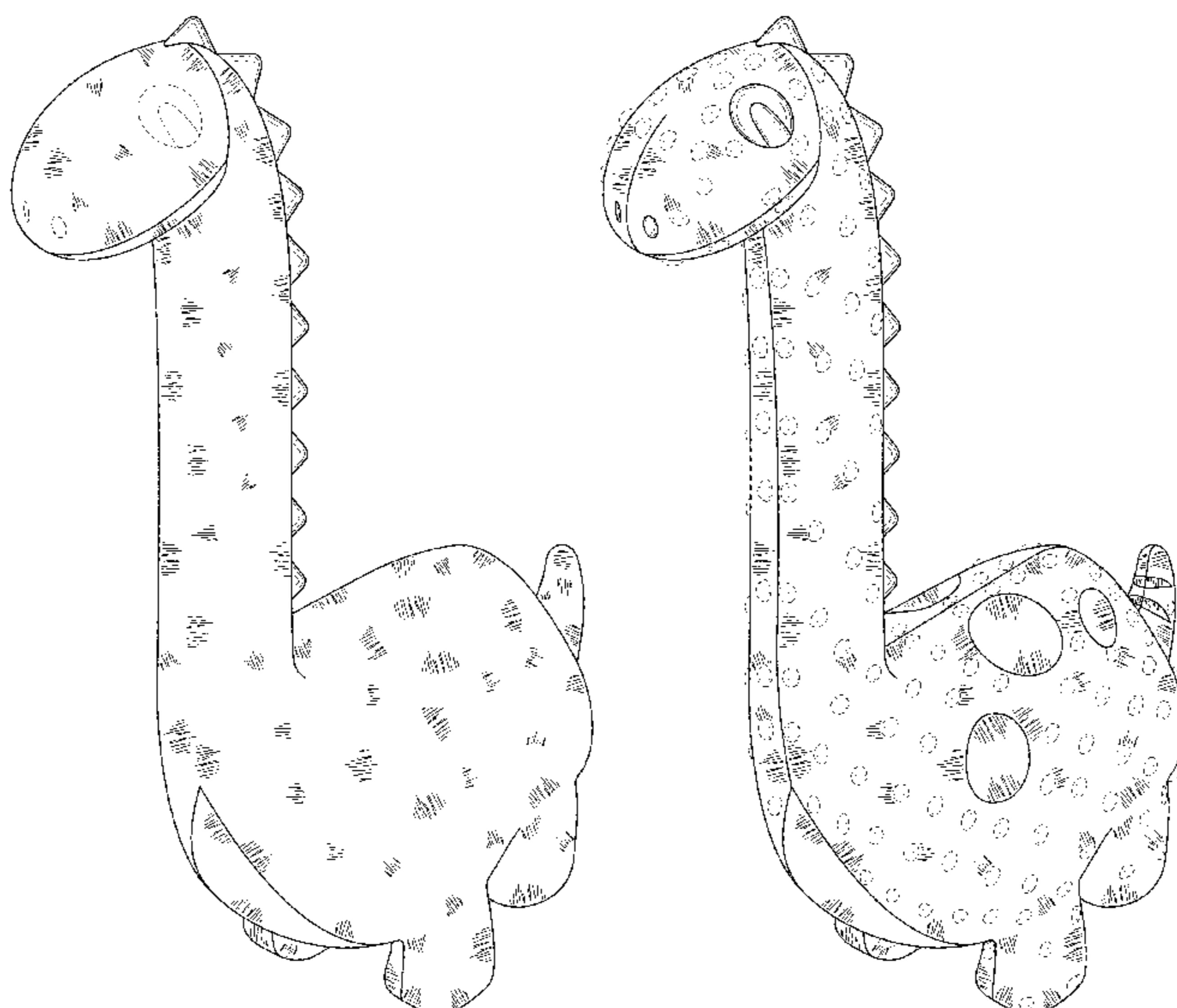
FIG. 1 is a perspective view of a first embodiment of the dinosaur-shaped animal toy showing our new design.

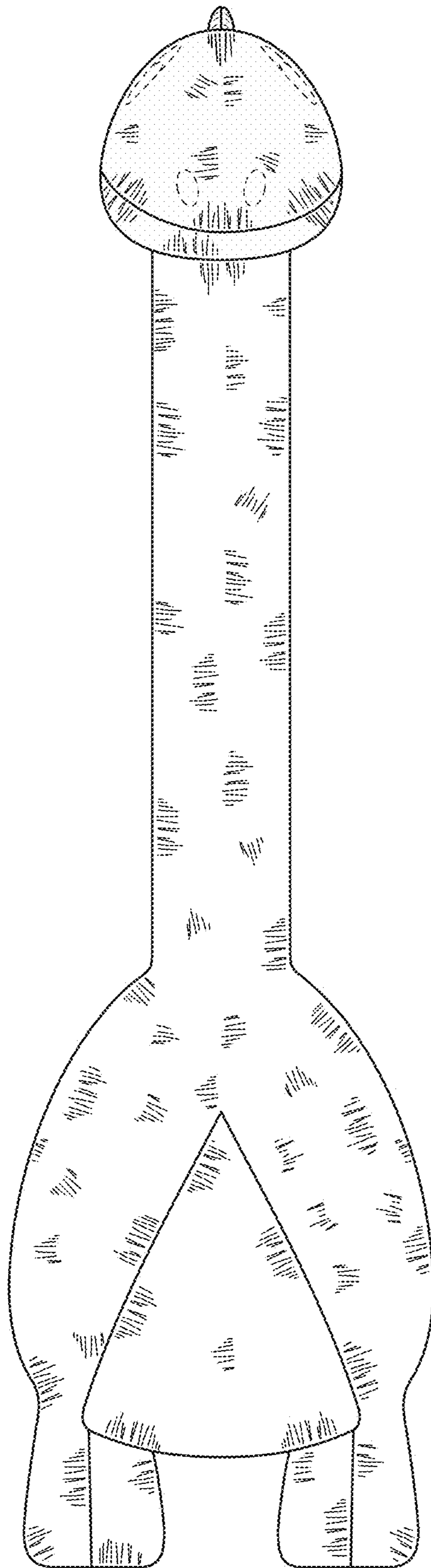

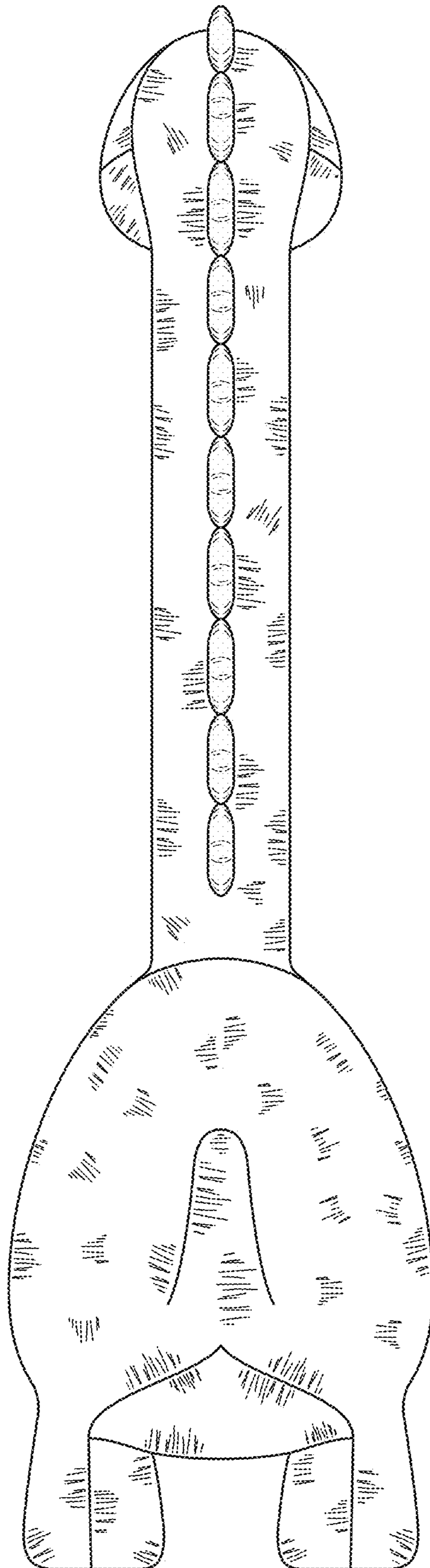

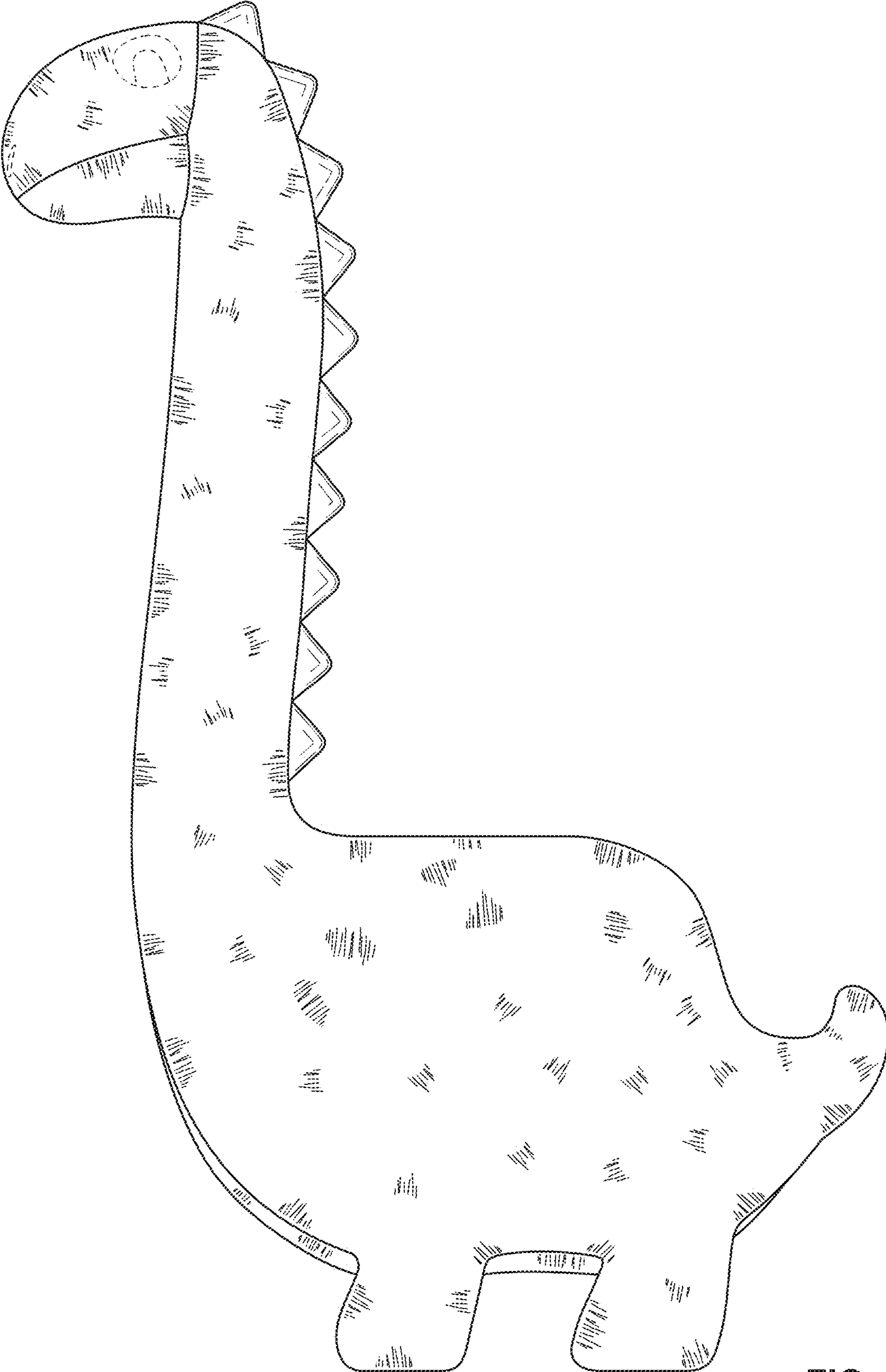

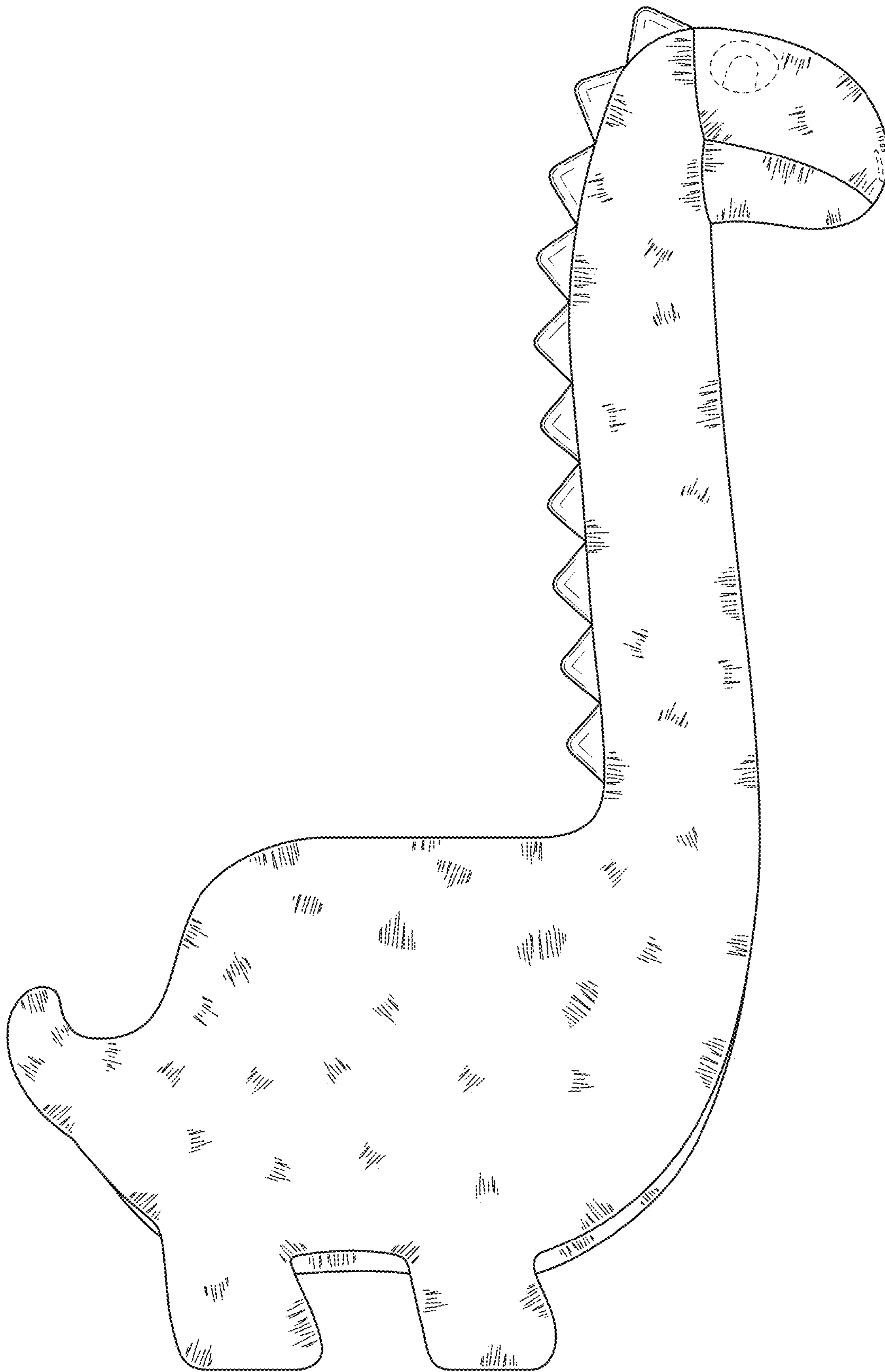

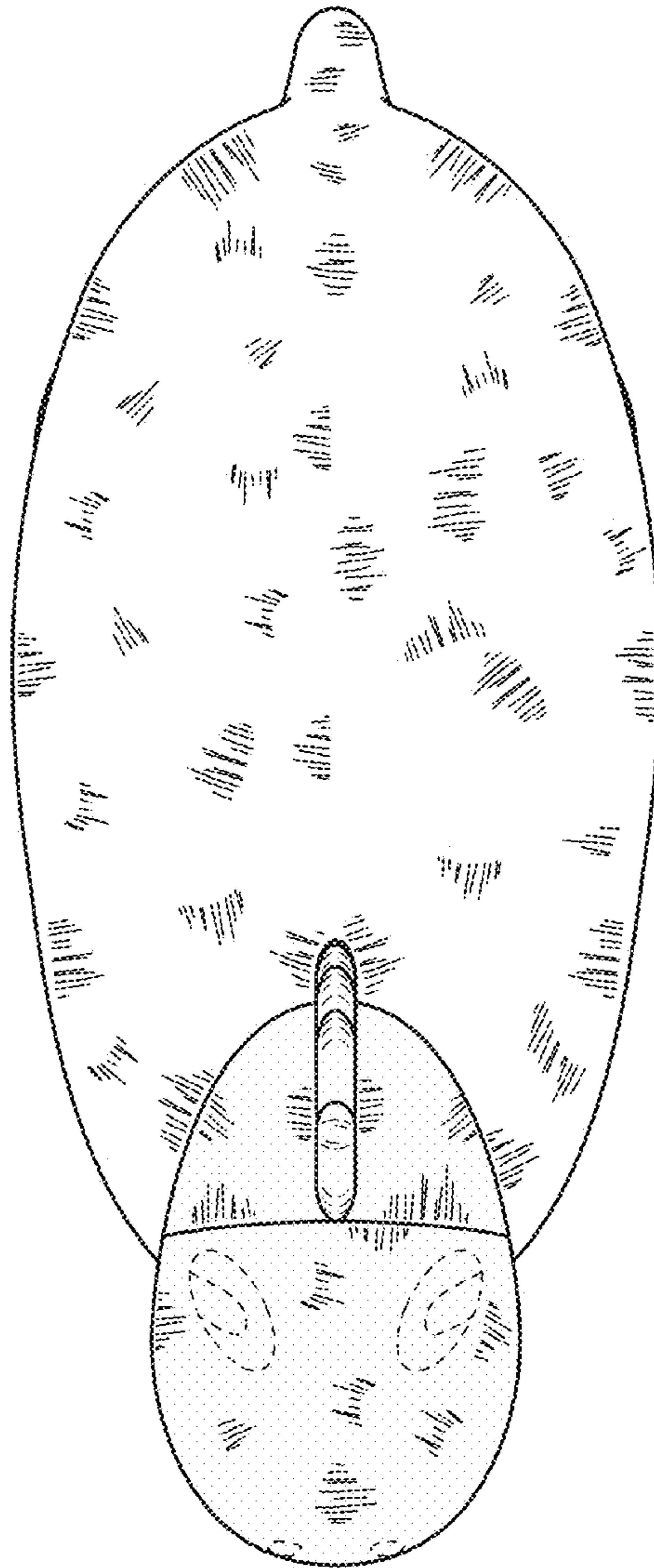

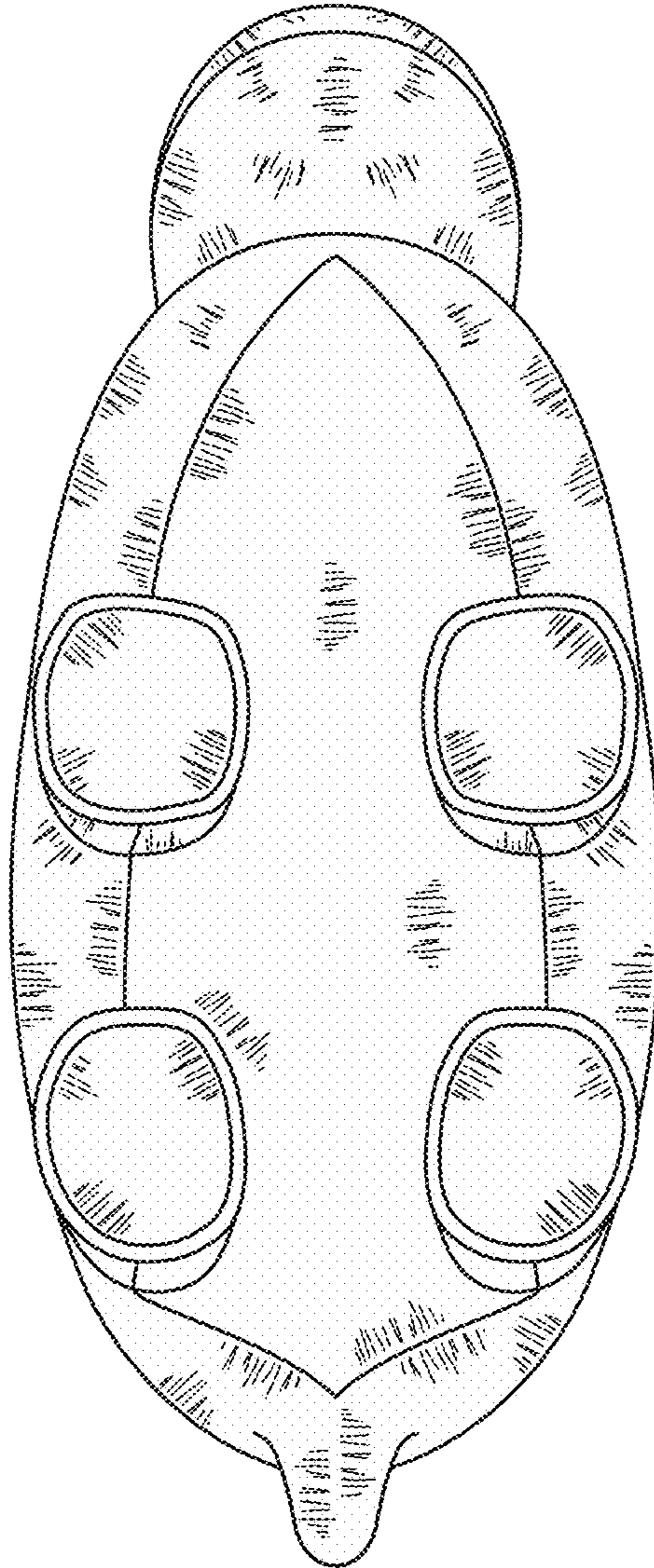

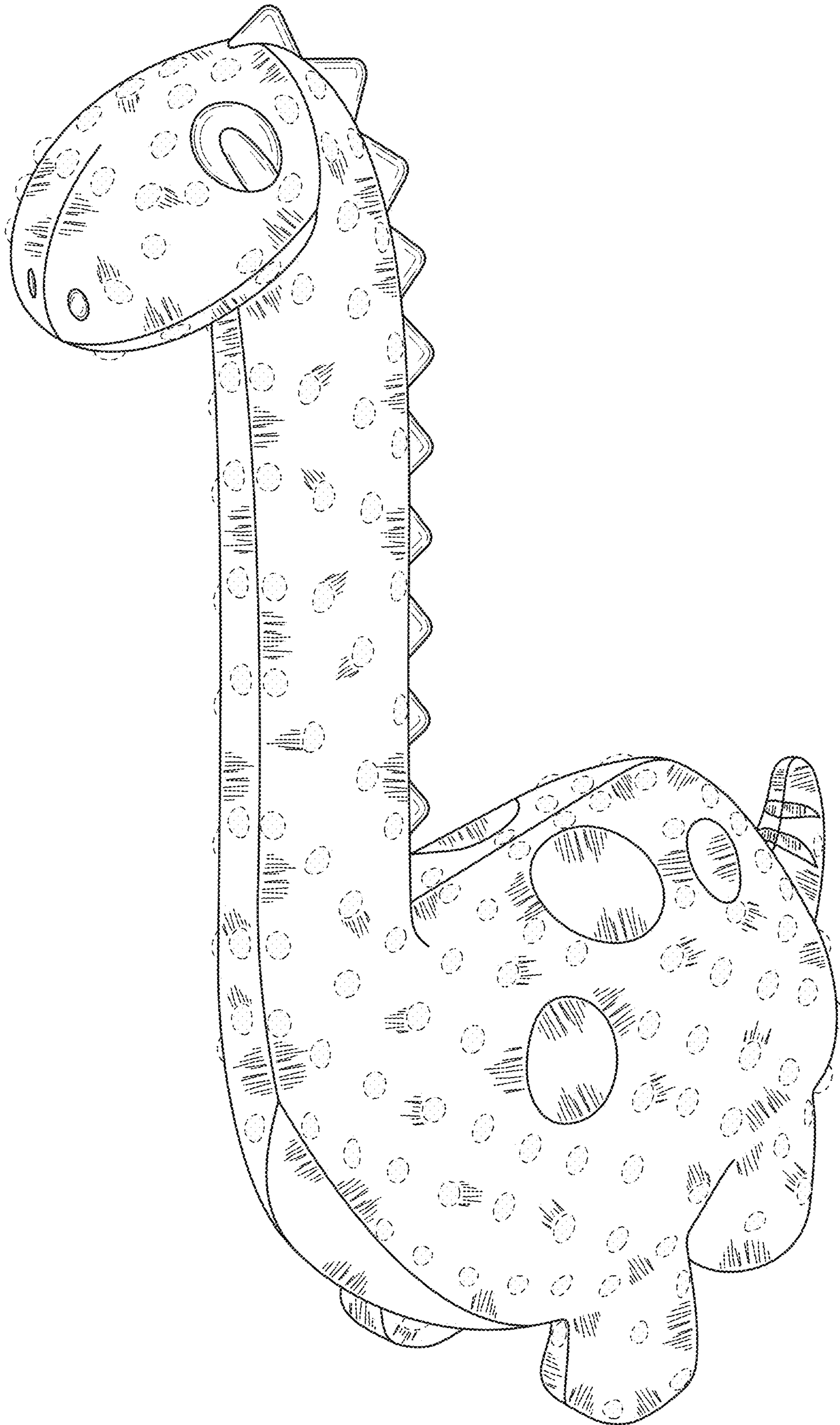

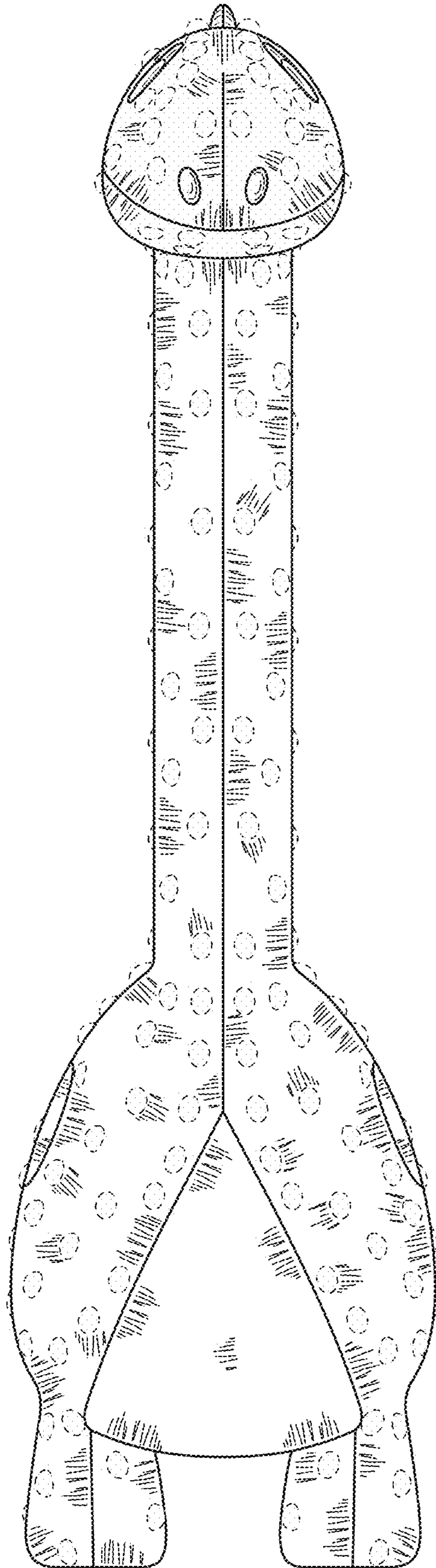

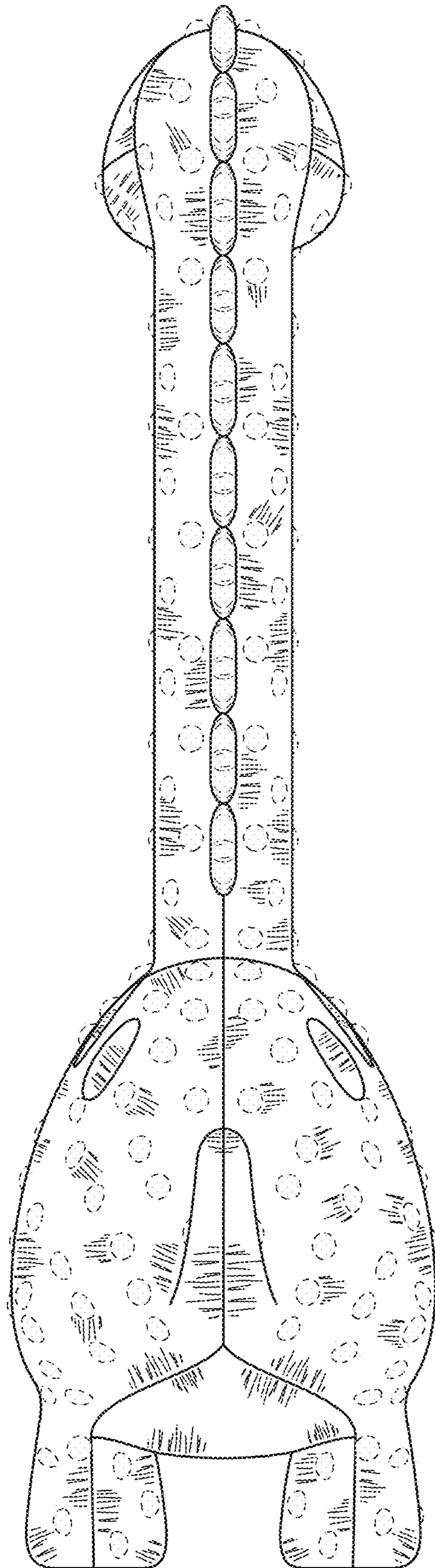

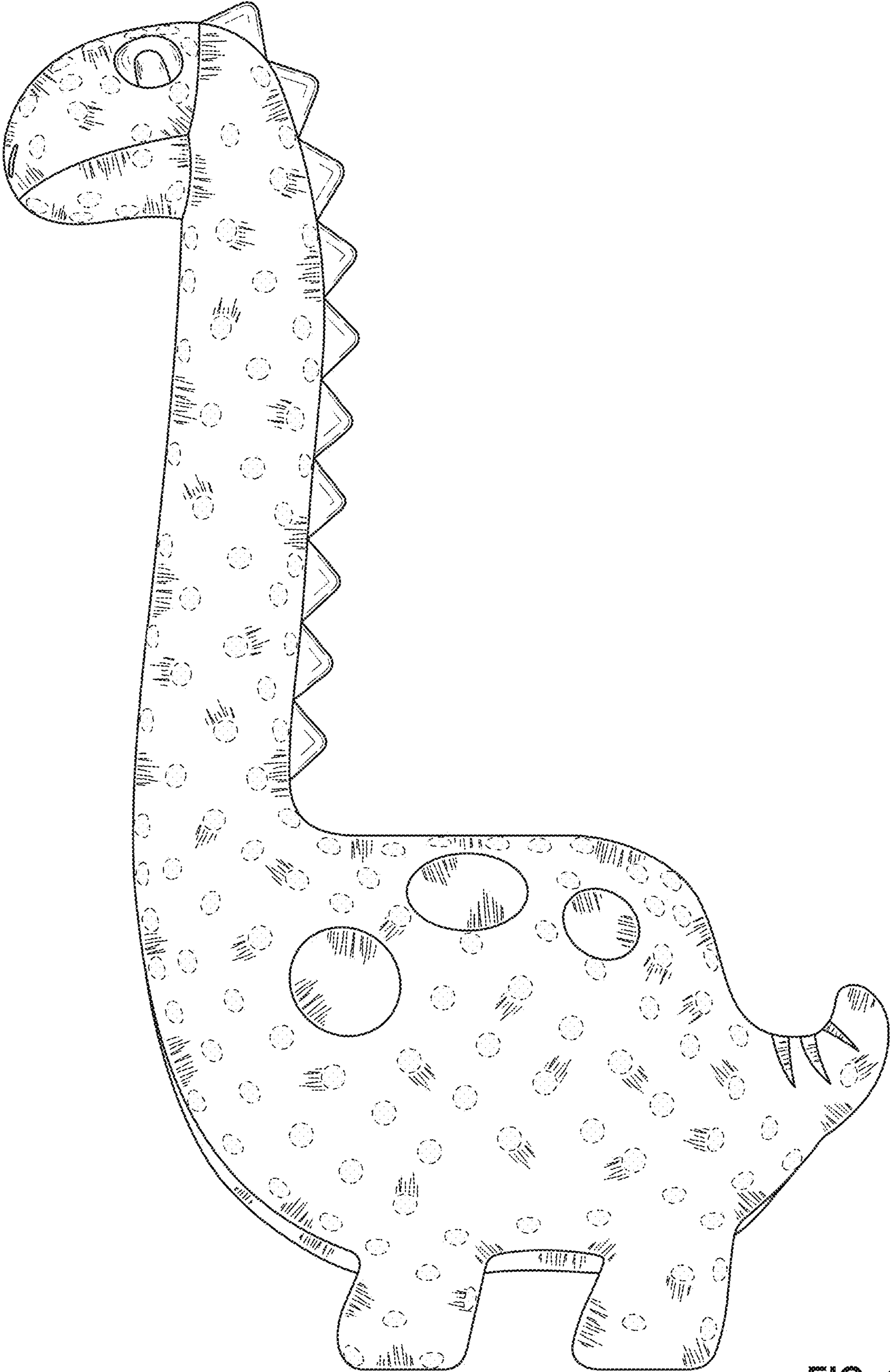

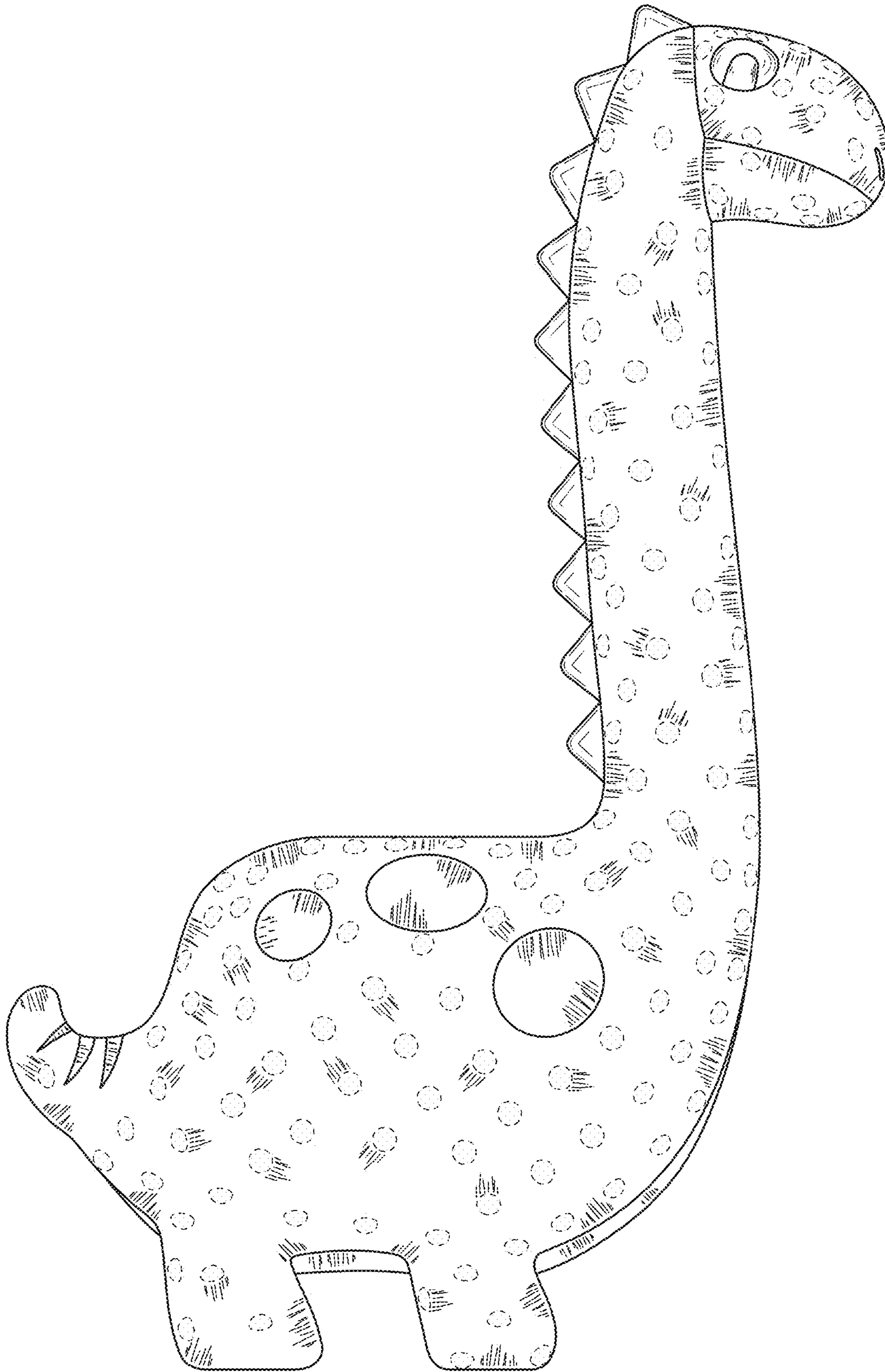

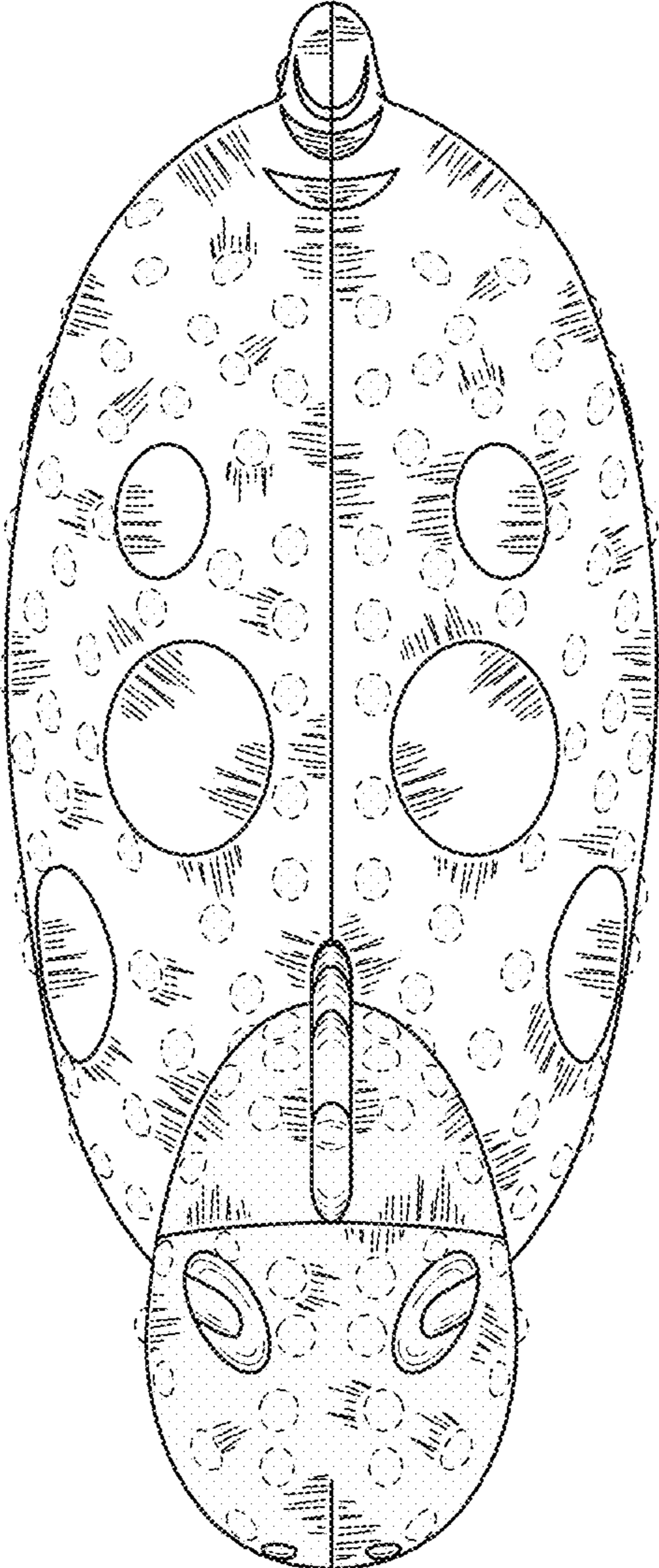

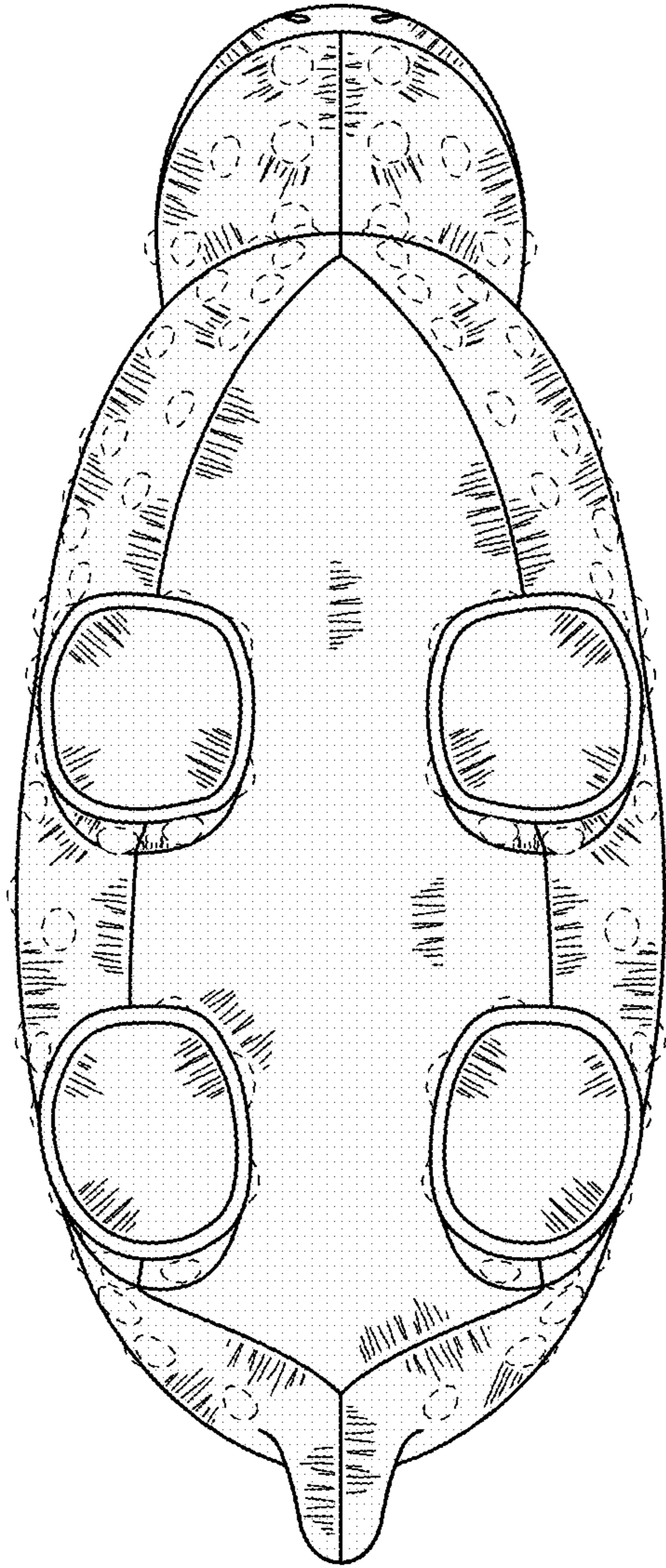
