(57) **CLAIM**

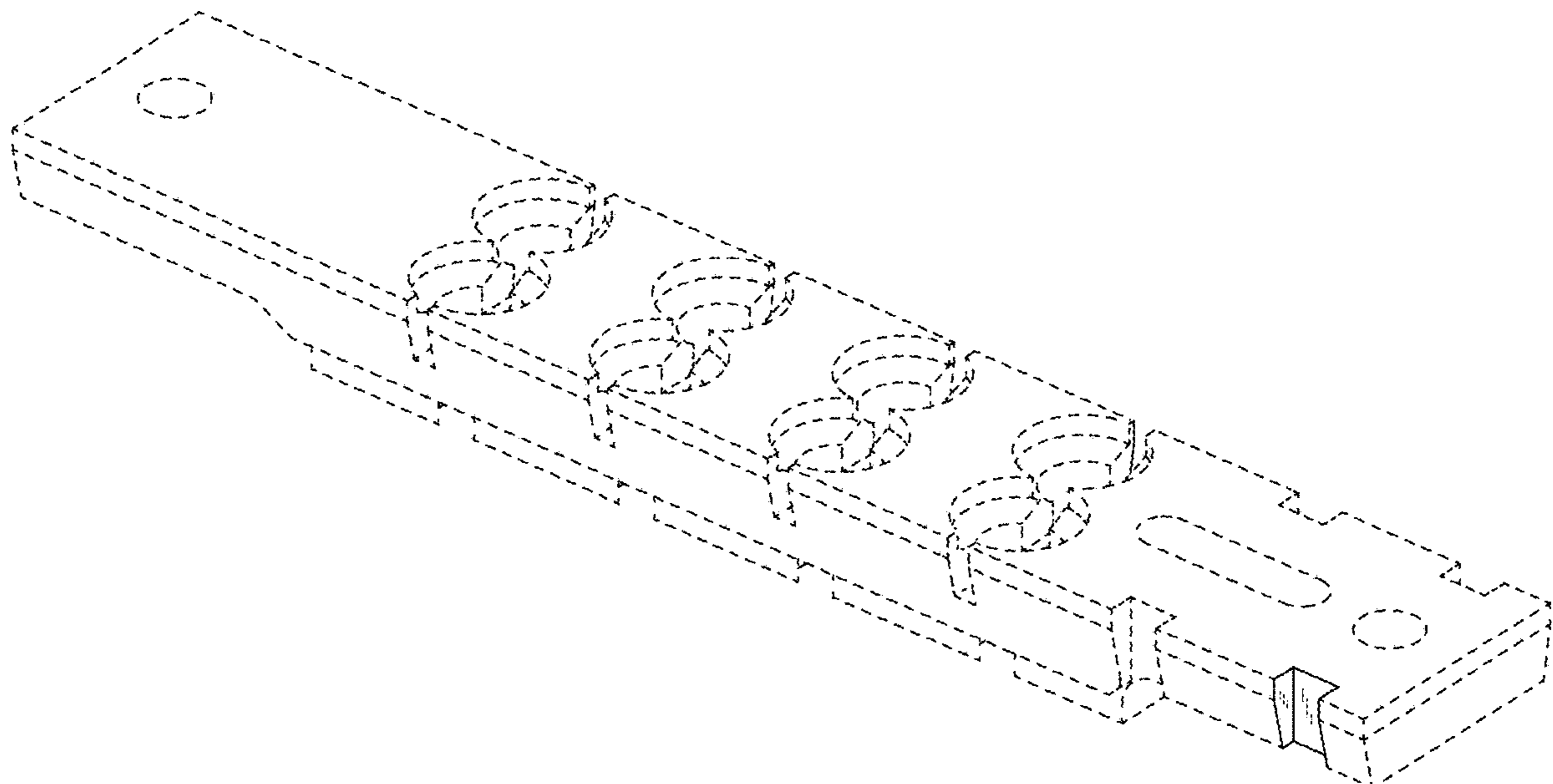
The ornamental design for a bar, as shown and described.

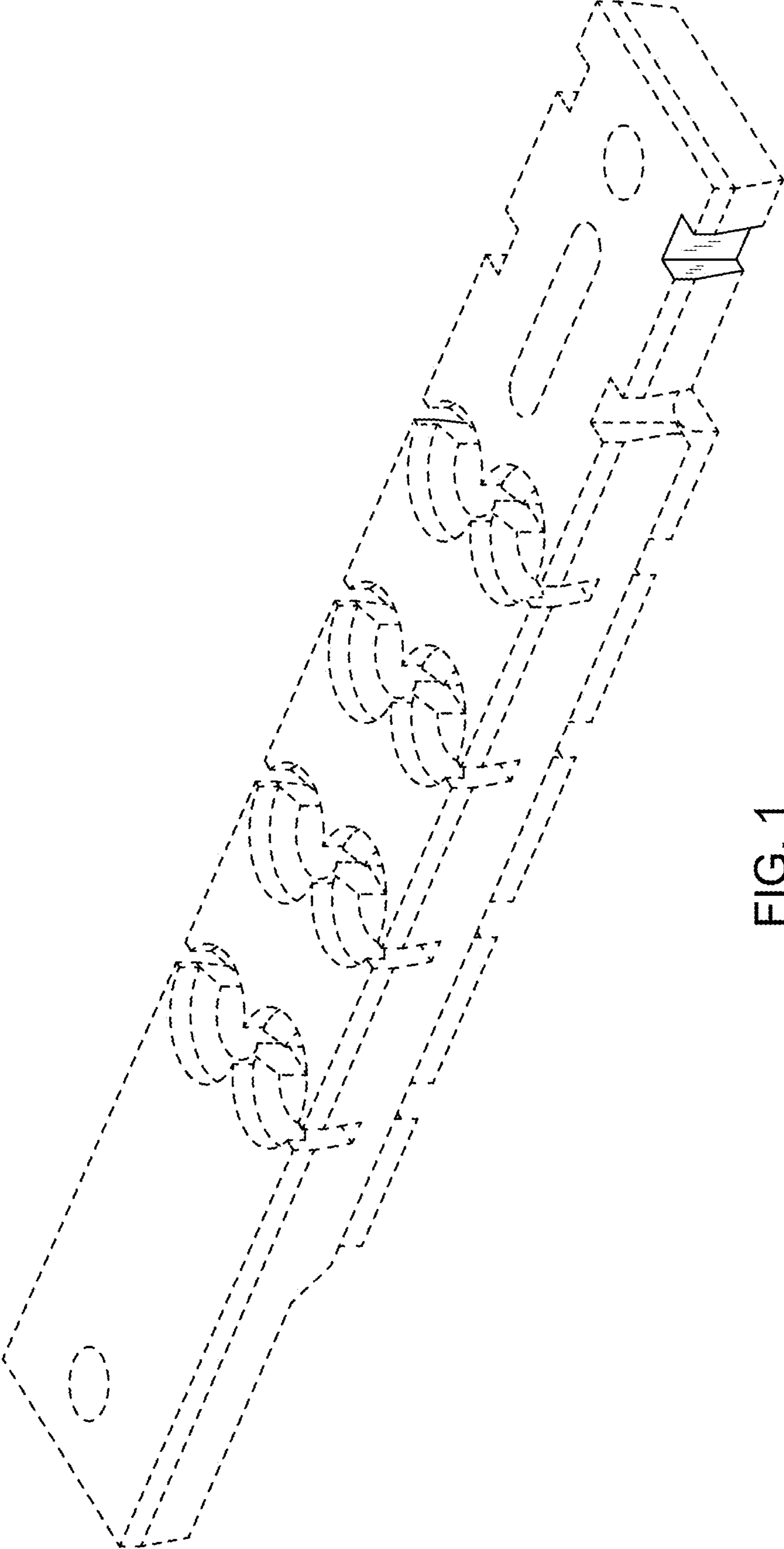

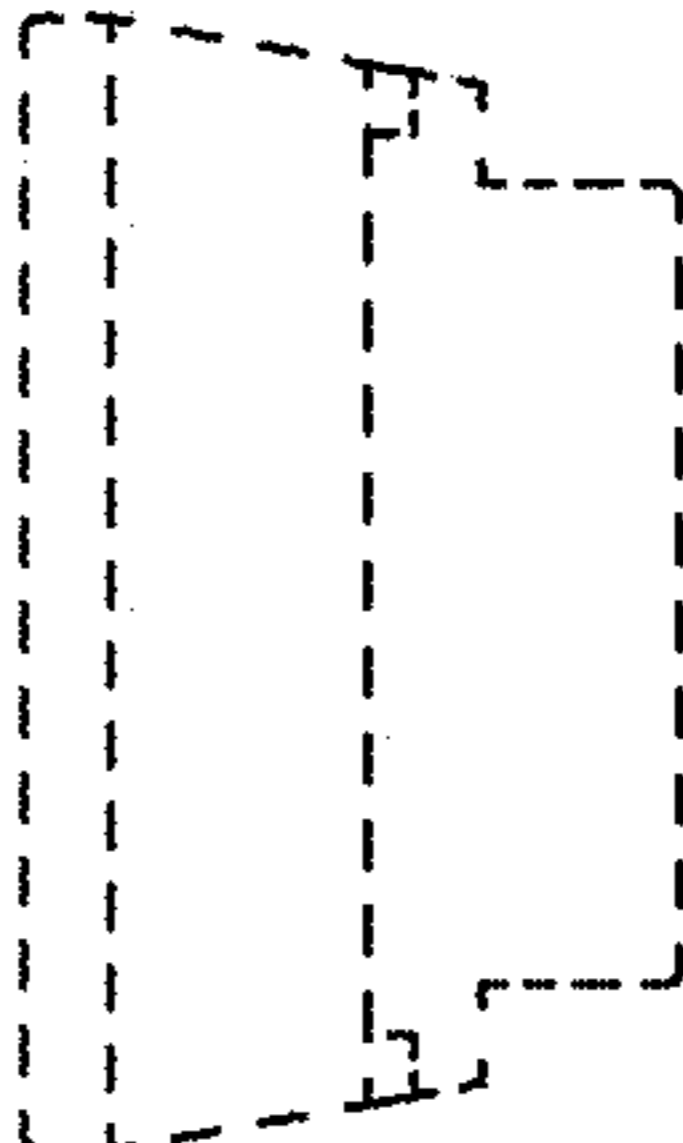

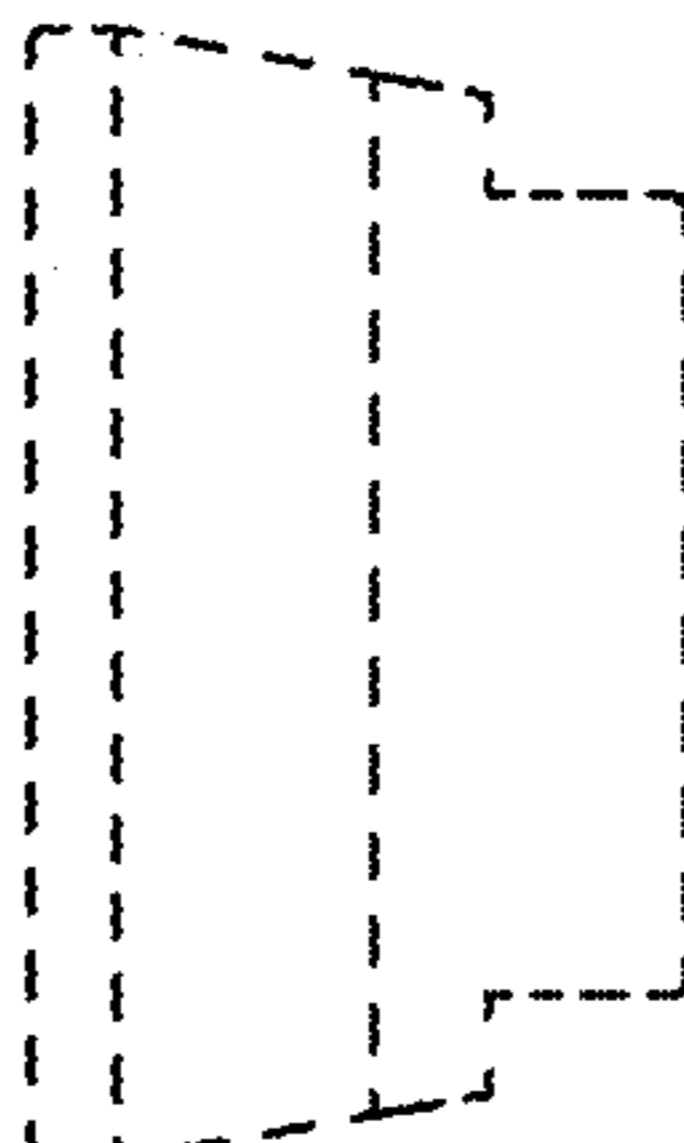

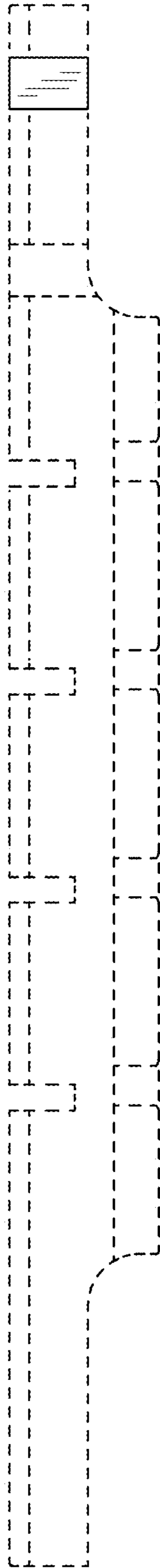

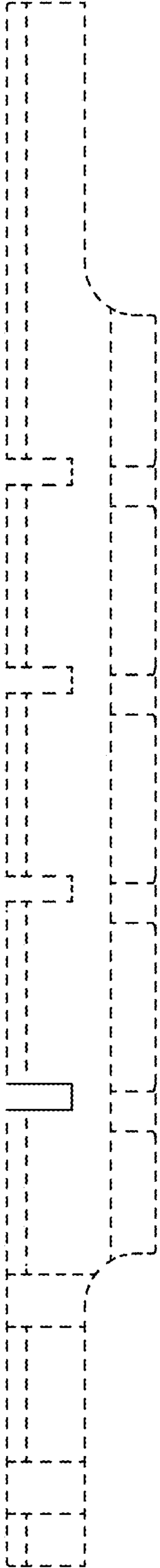

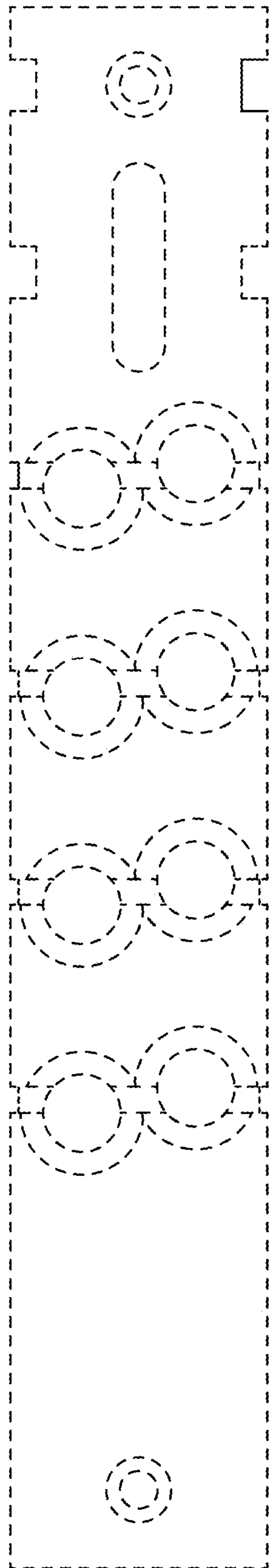

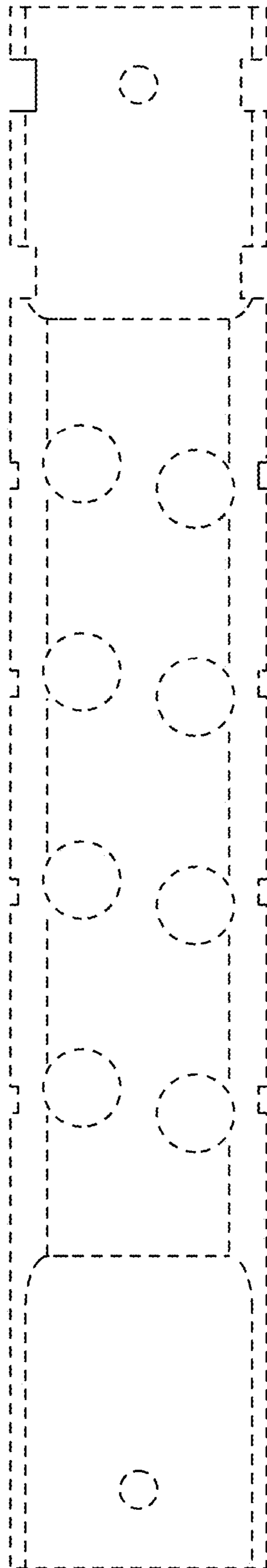
