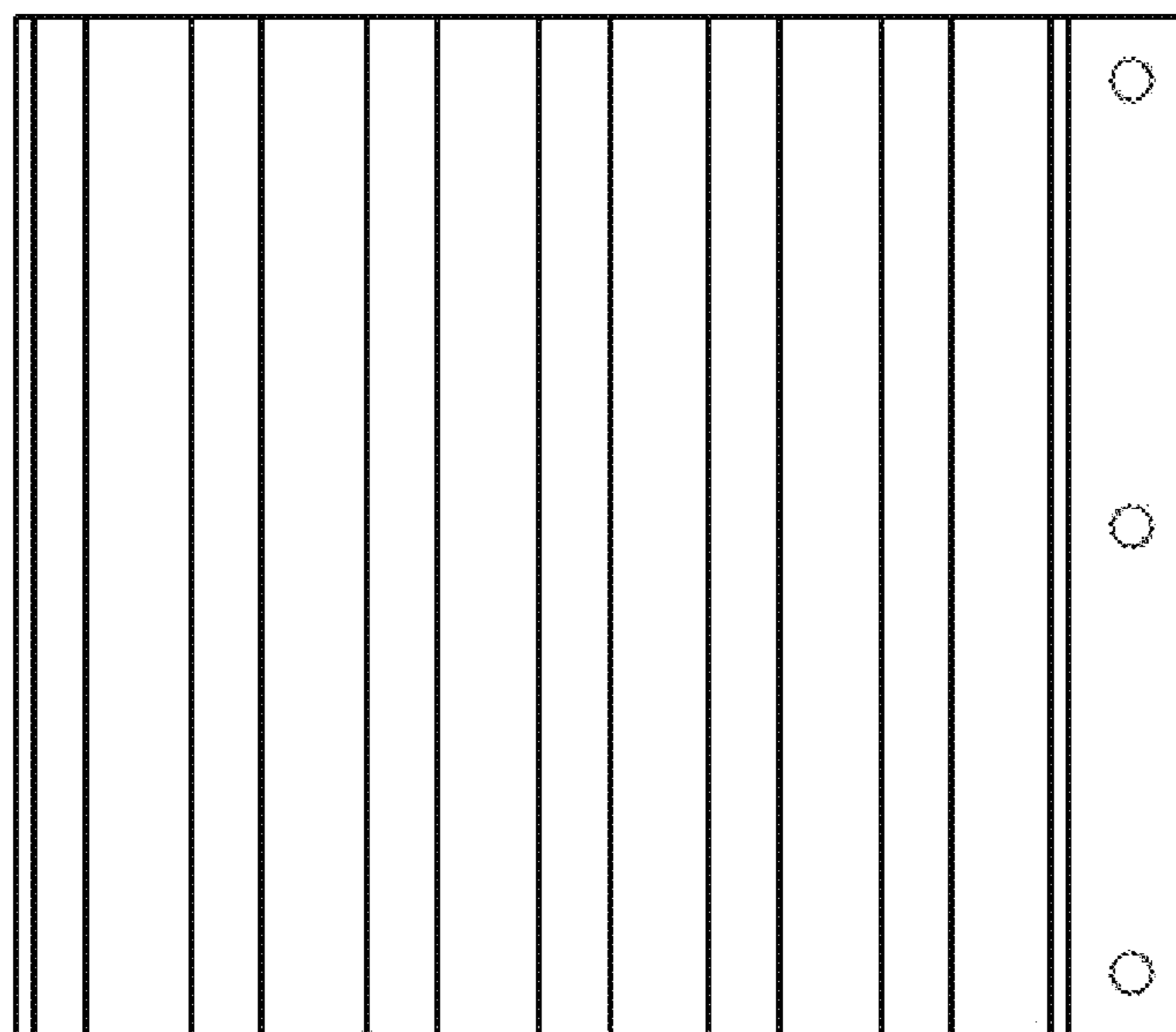
(57) **CLAIM**

The ornamental design for a storage rack for plumbing pipes, as shown.

DESCRIPTION

FIG. 1 is the front view of a storage rack for plumbing pipes according to the present design;

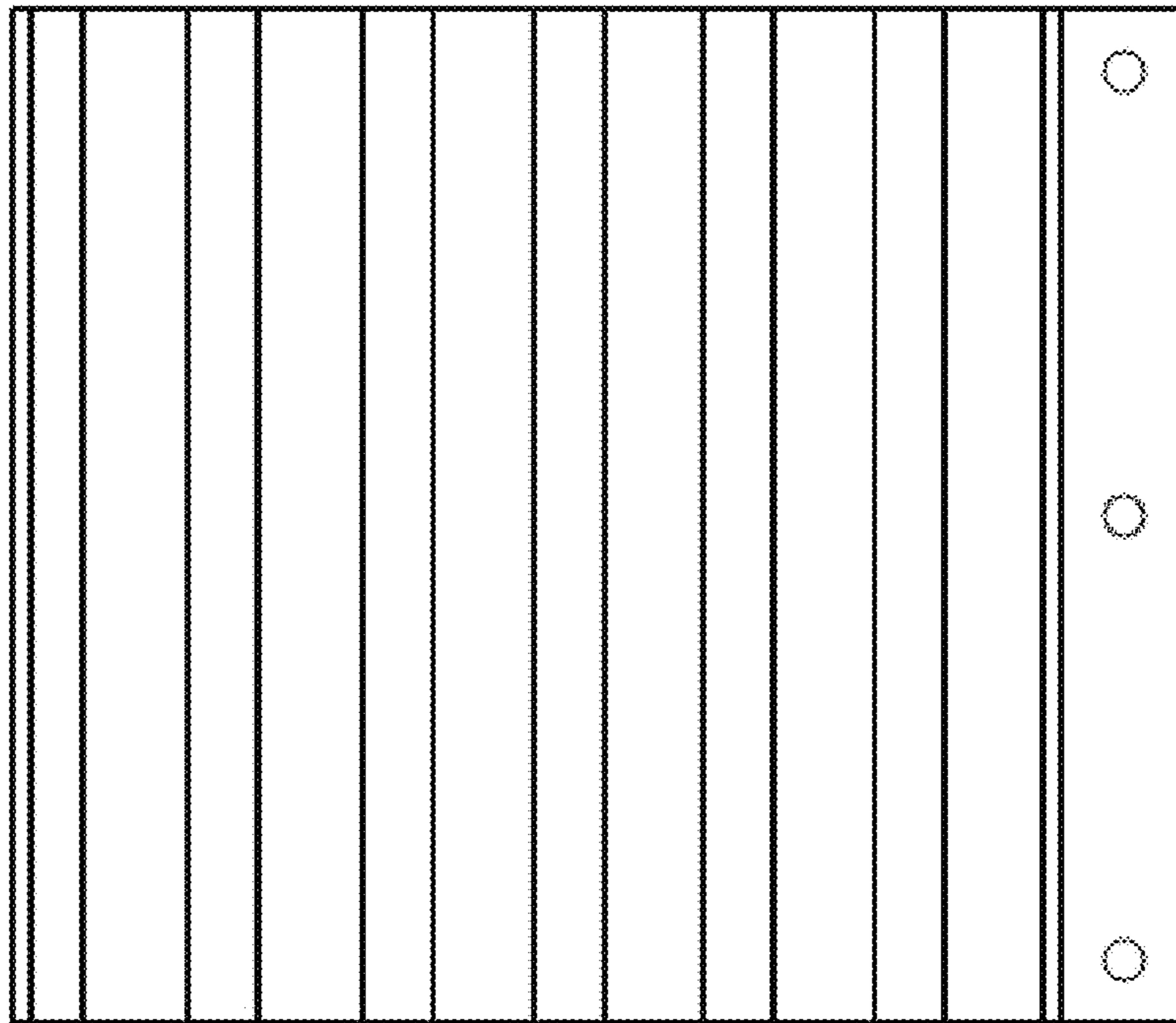

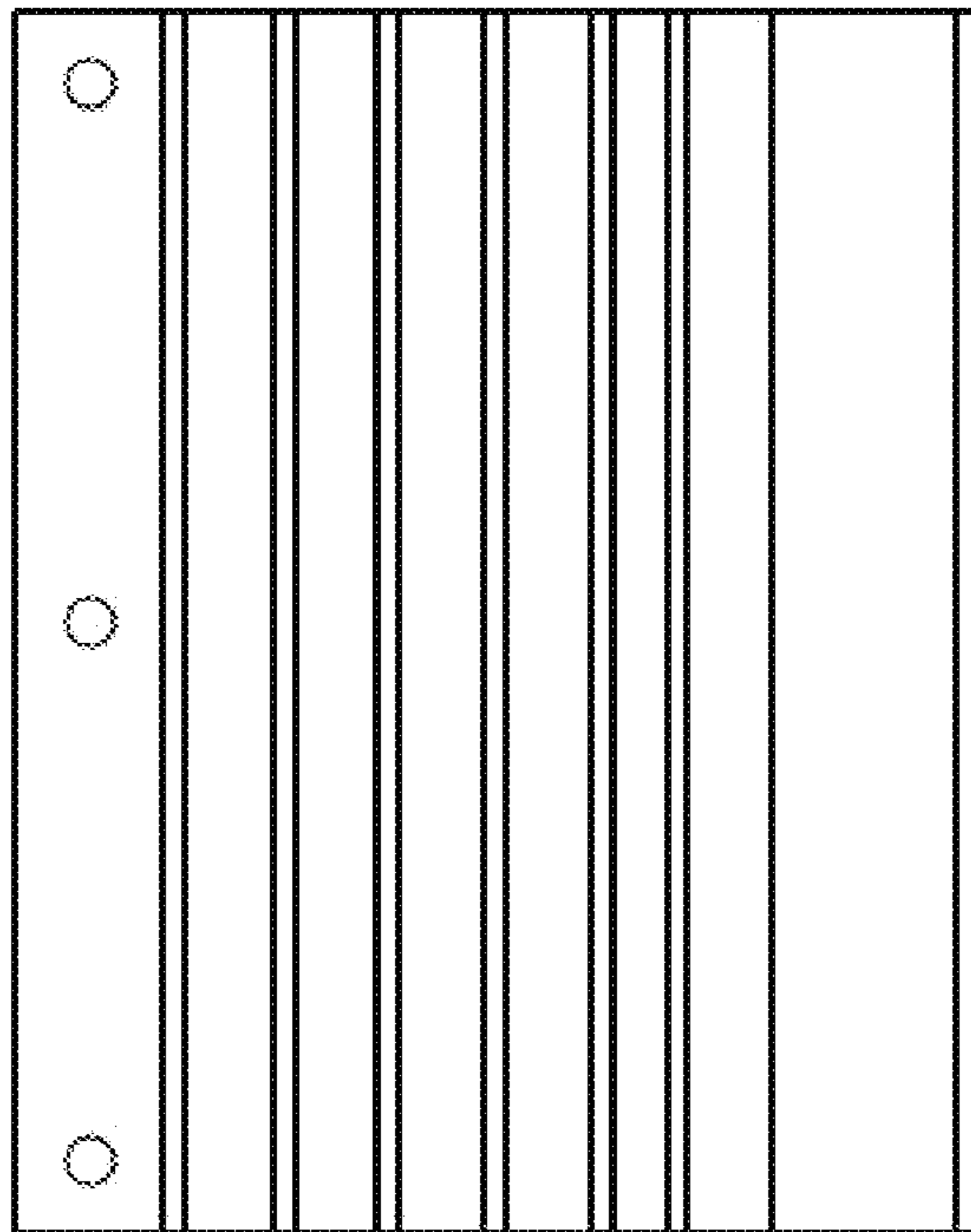

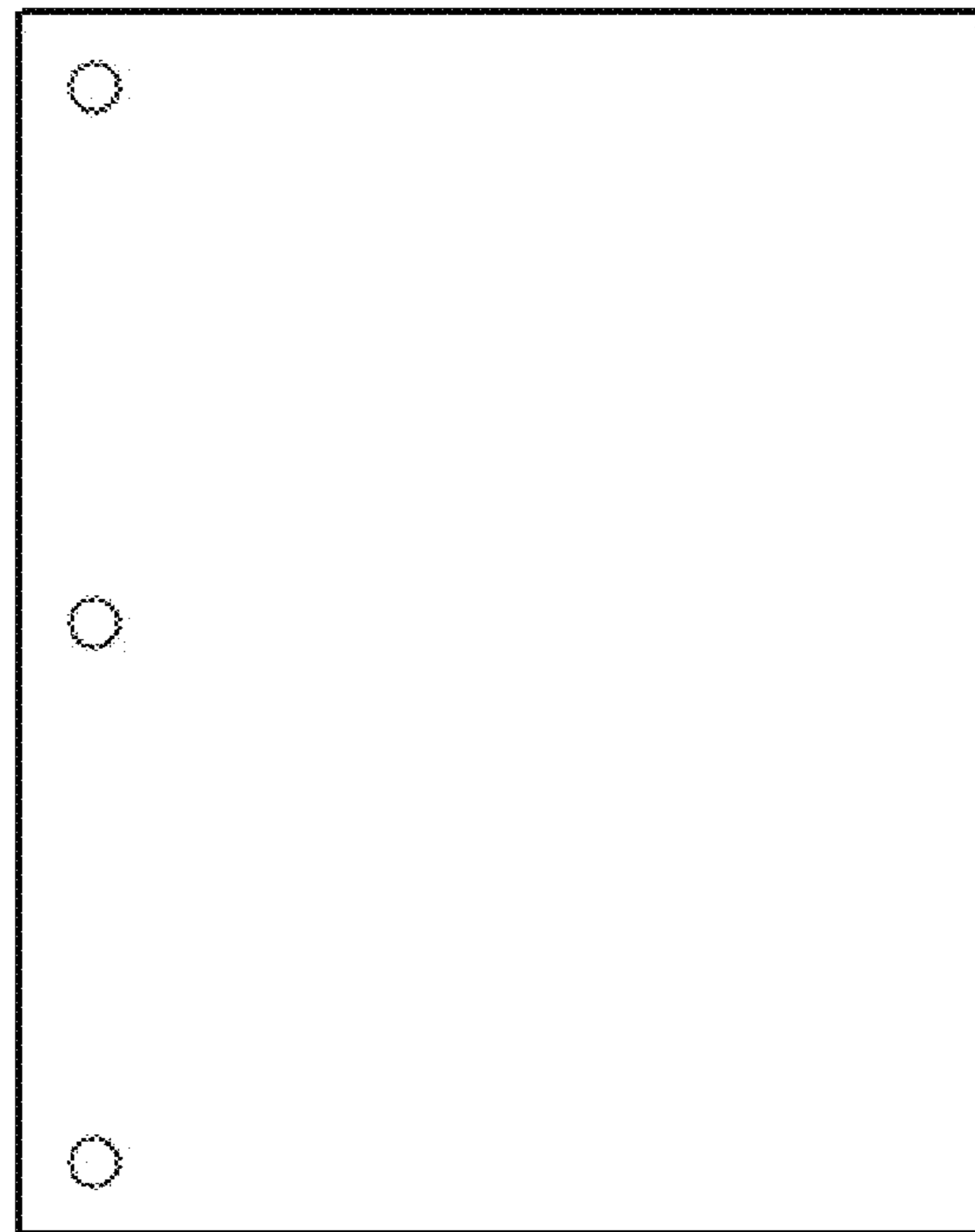

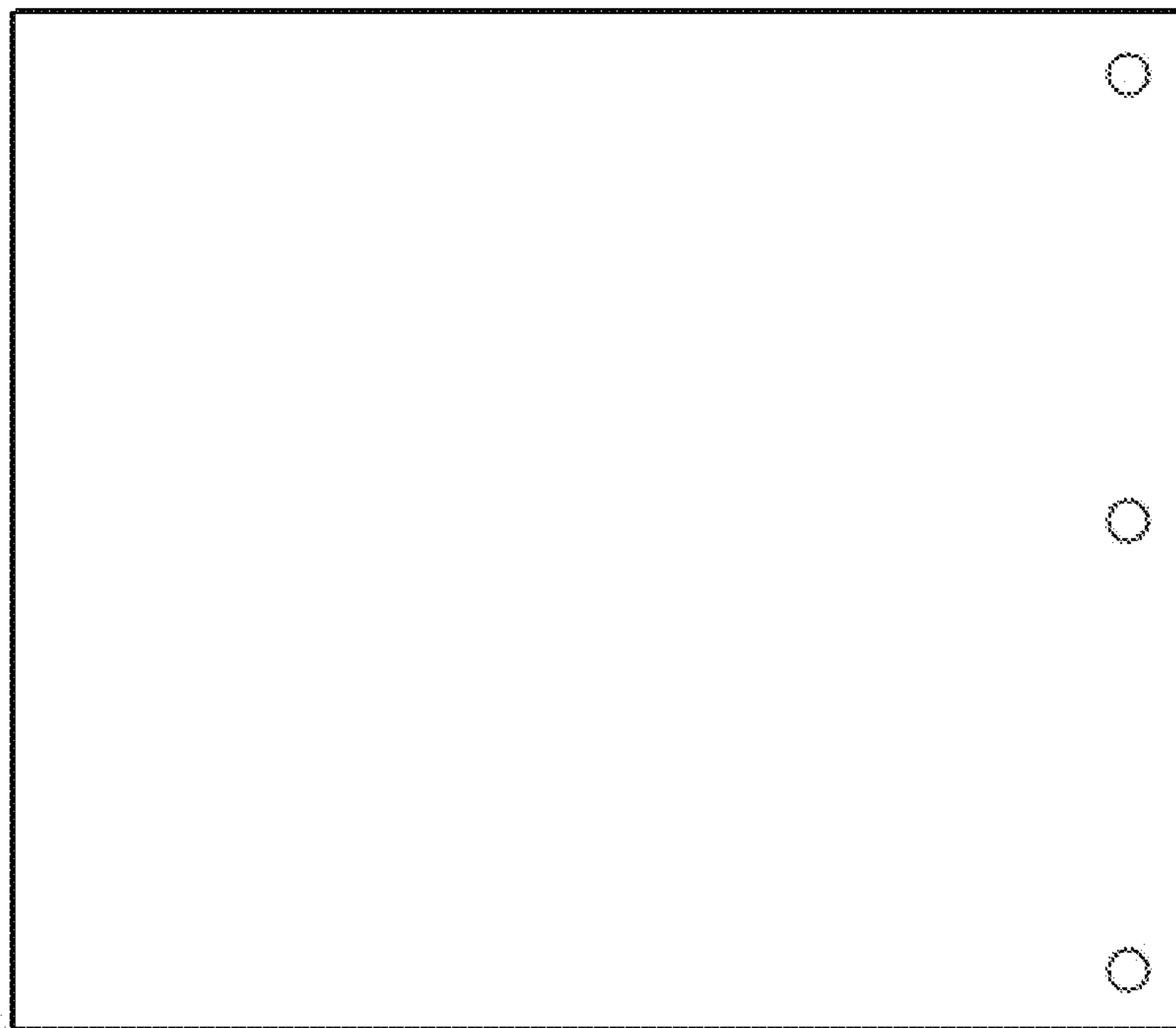

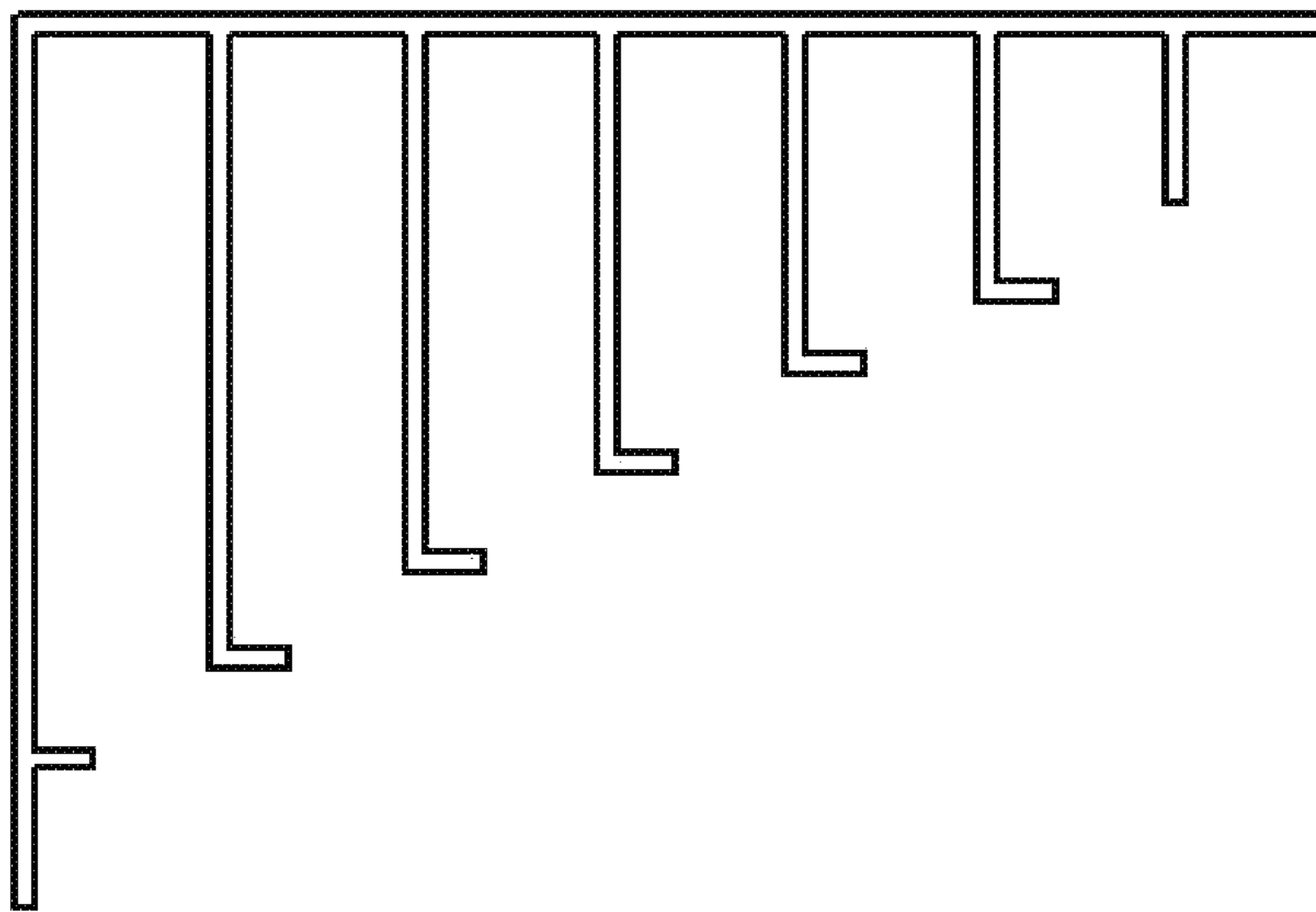

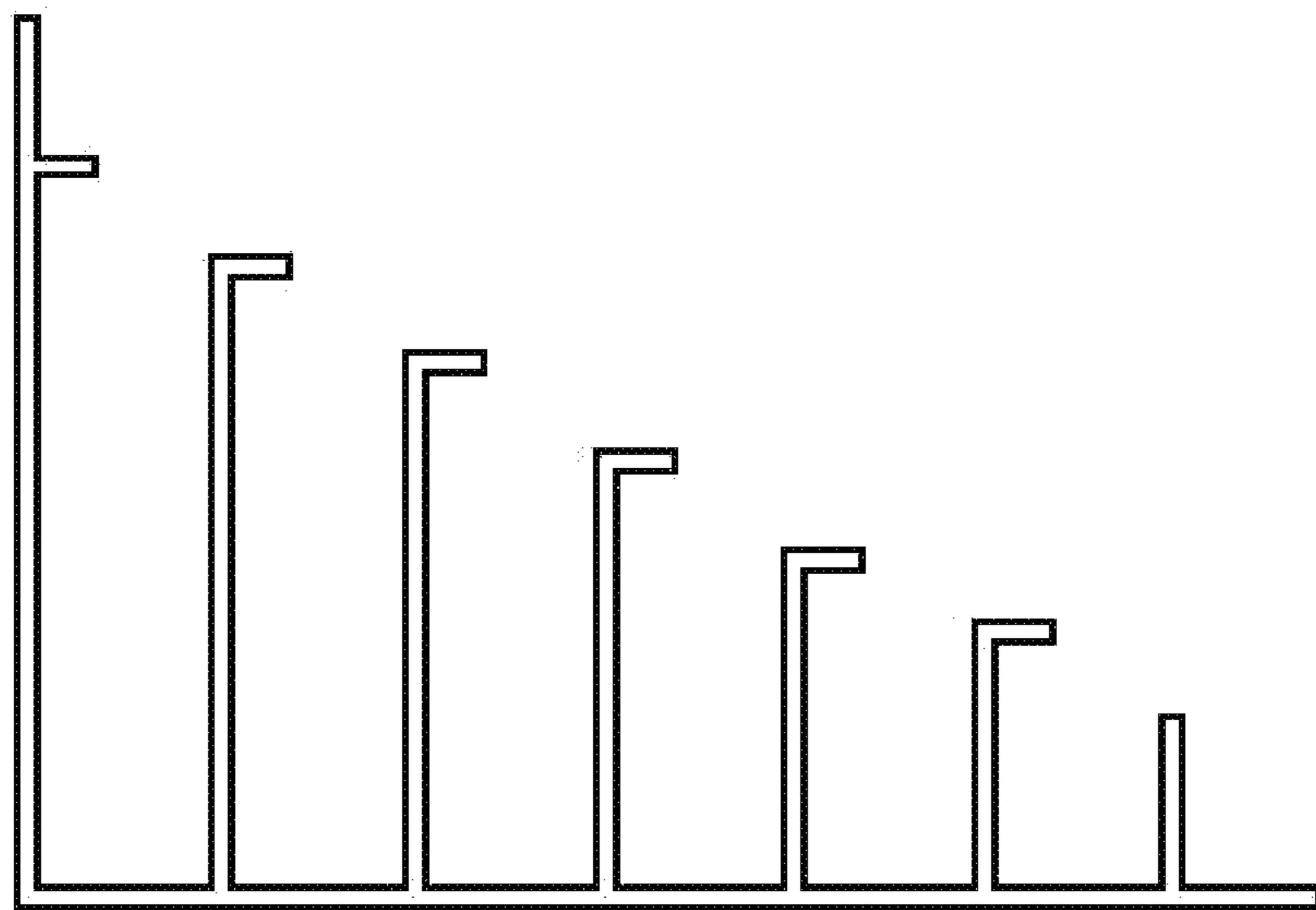

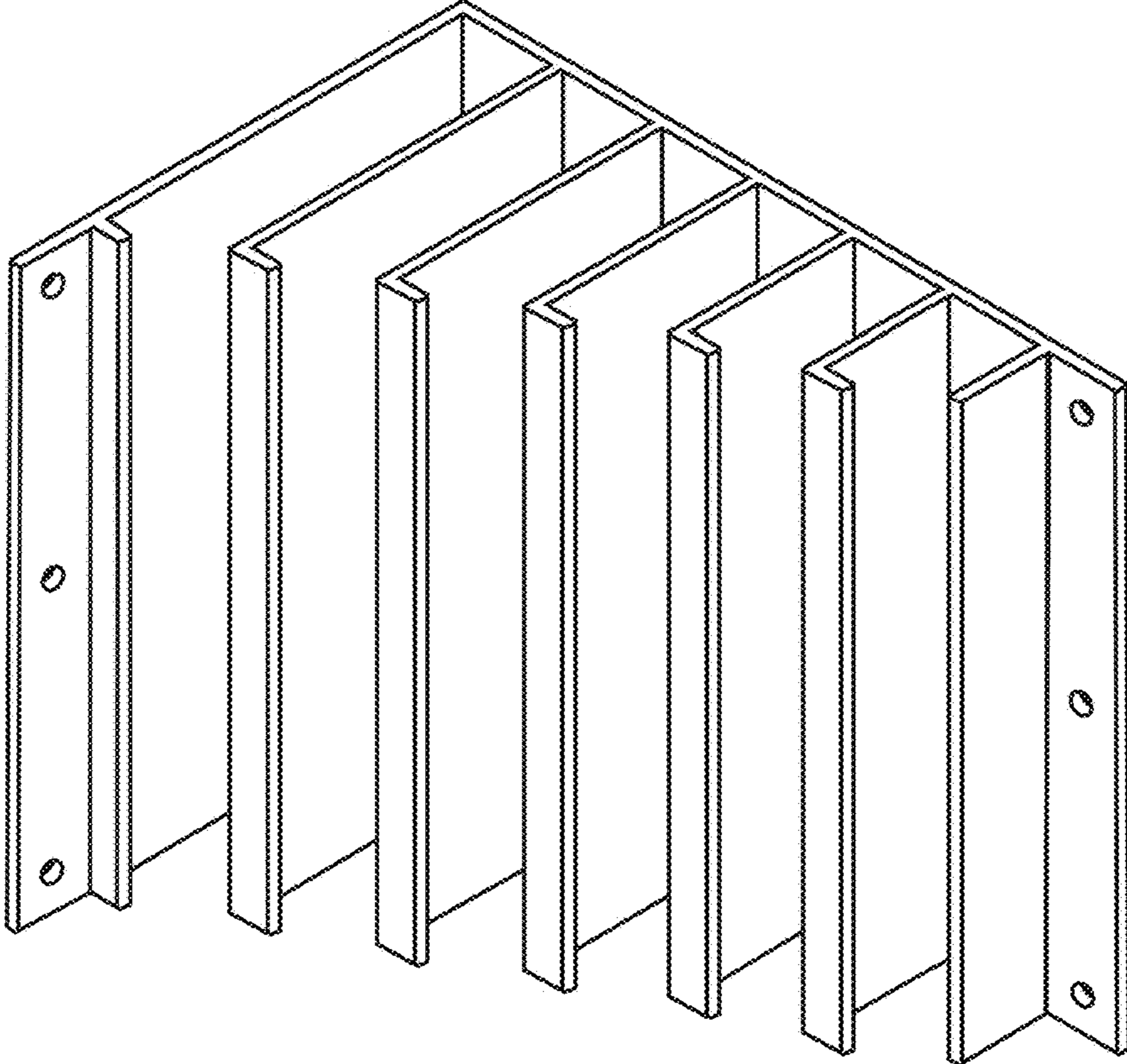
