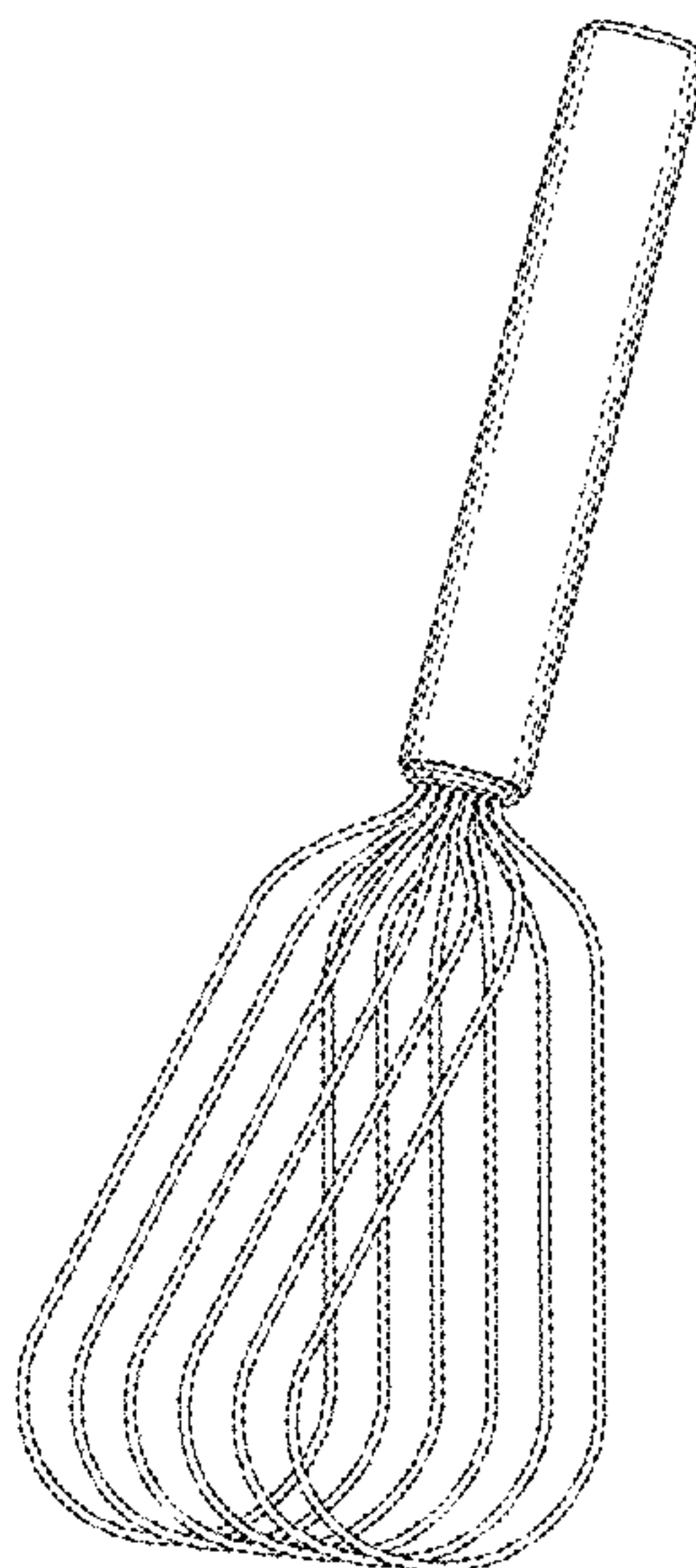

The ornamental design for a whisk, as shown and described.

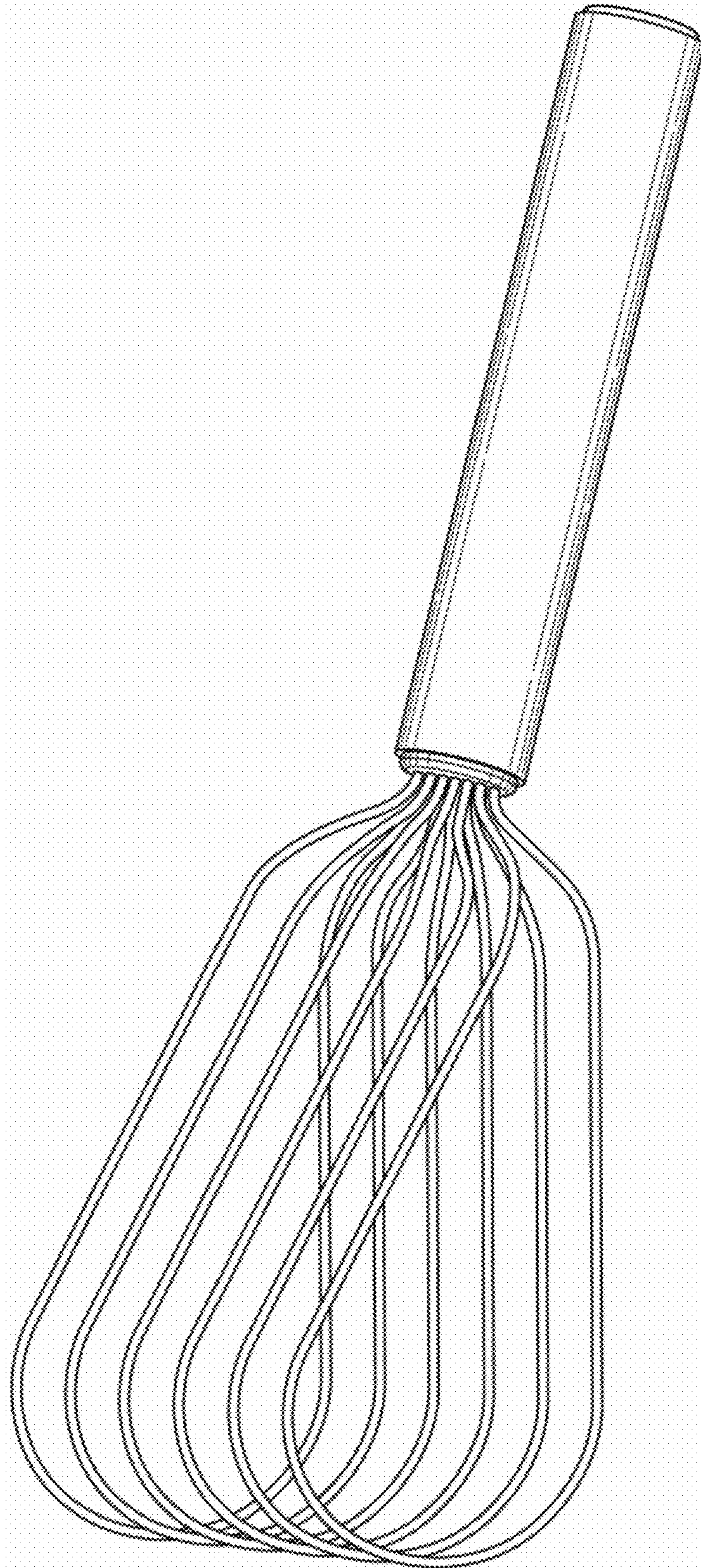
DESCRIPTION

1.7 is a bottom view thereof.

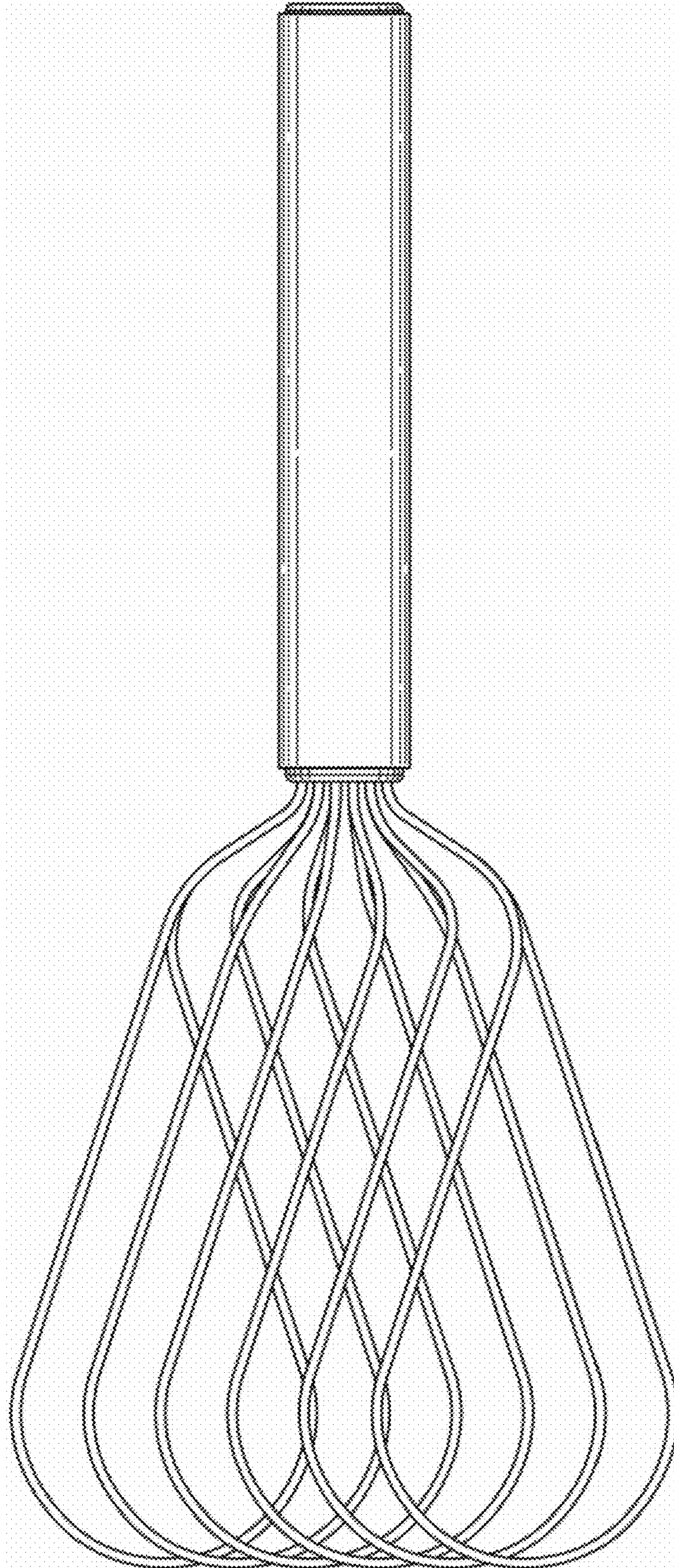

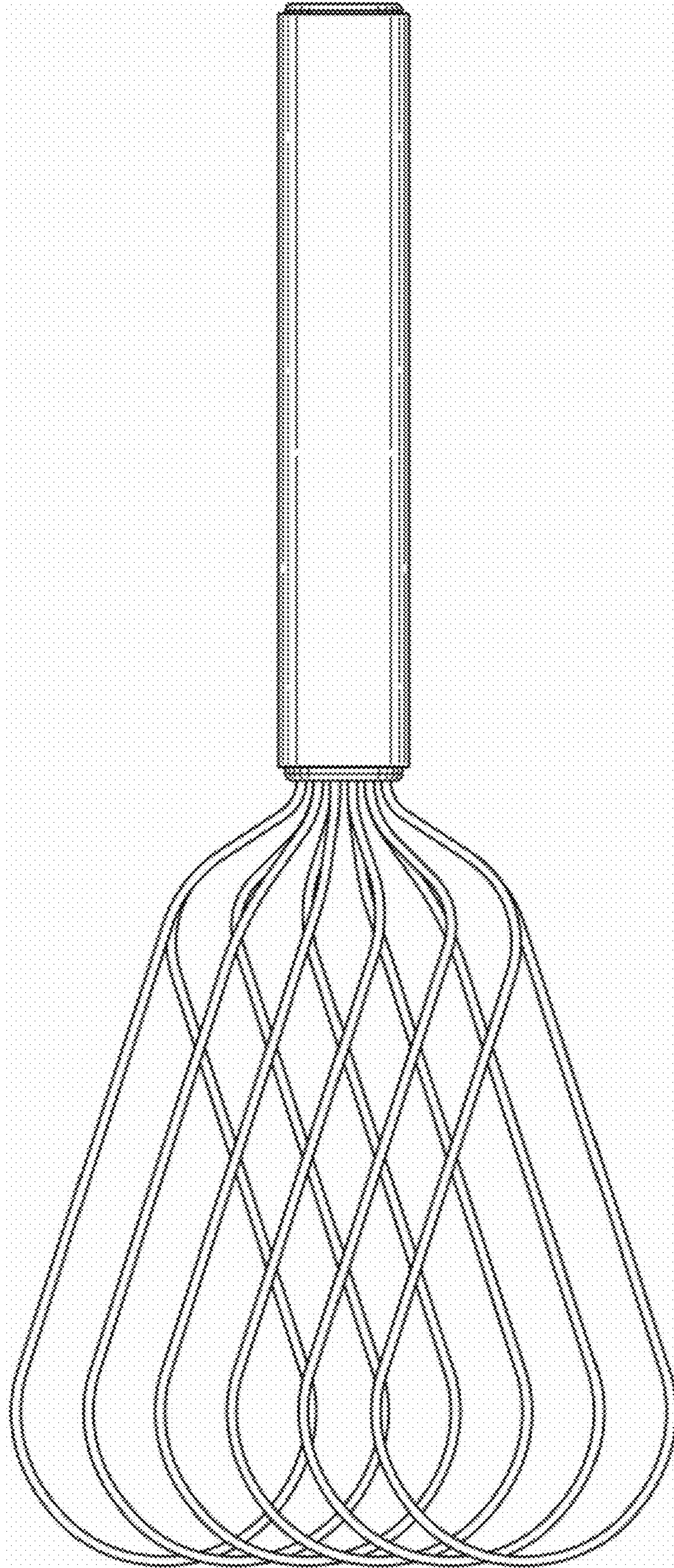

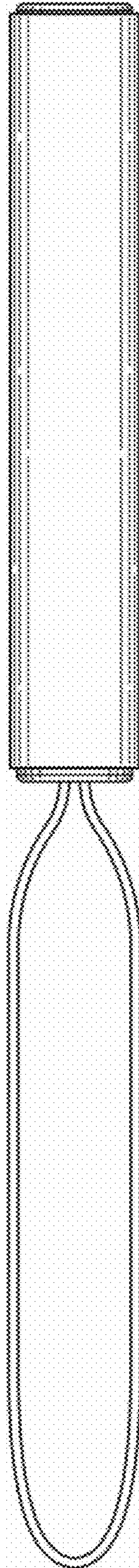

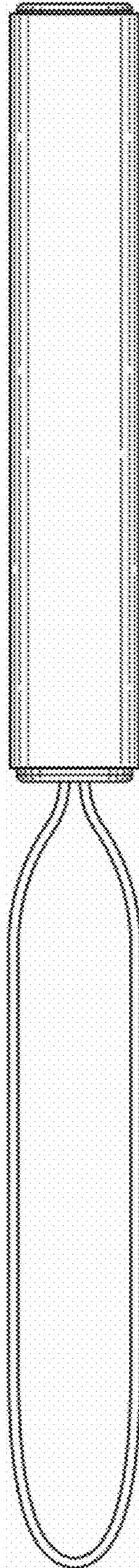

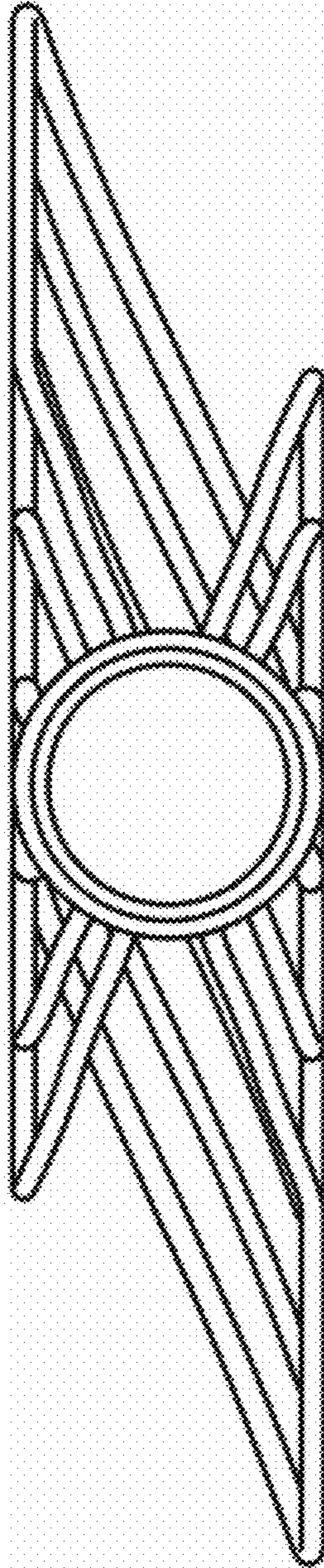
