DESCRIPTION

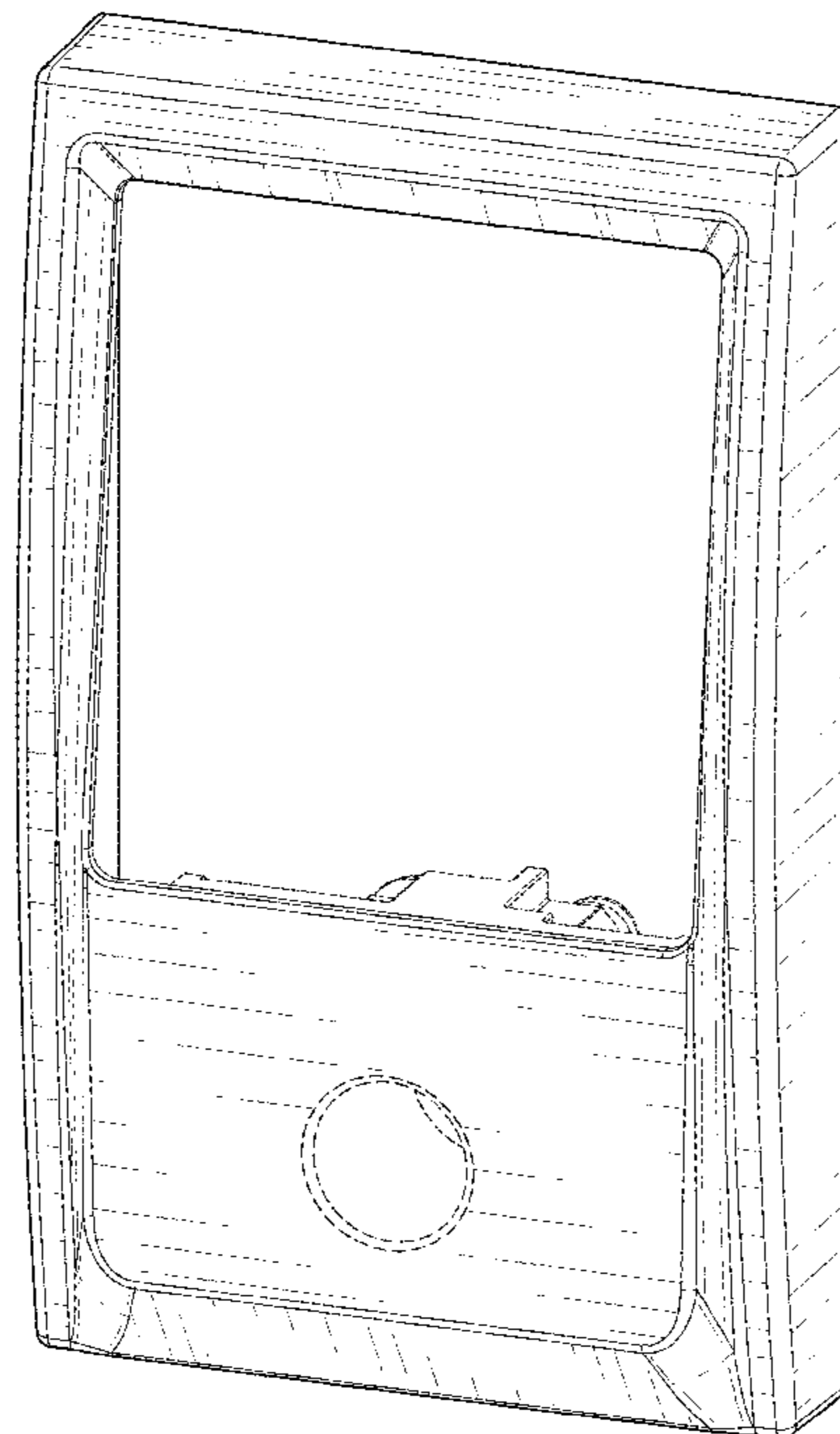
FIG. 1 is a front, right side perspective view of the exterior escutcheon showing my new design;

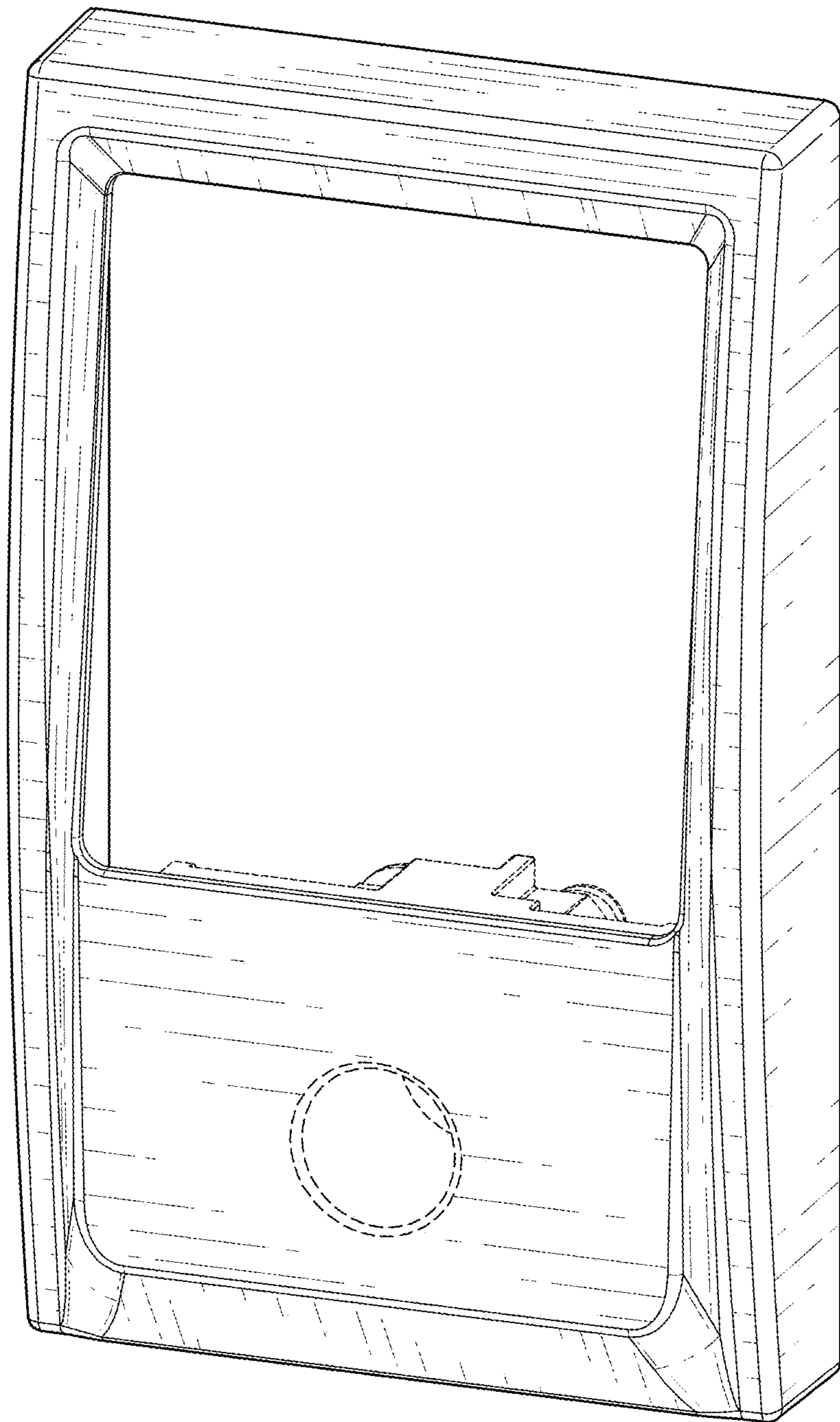

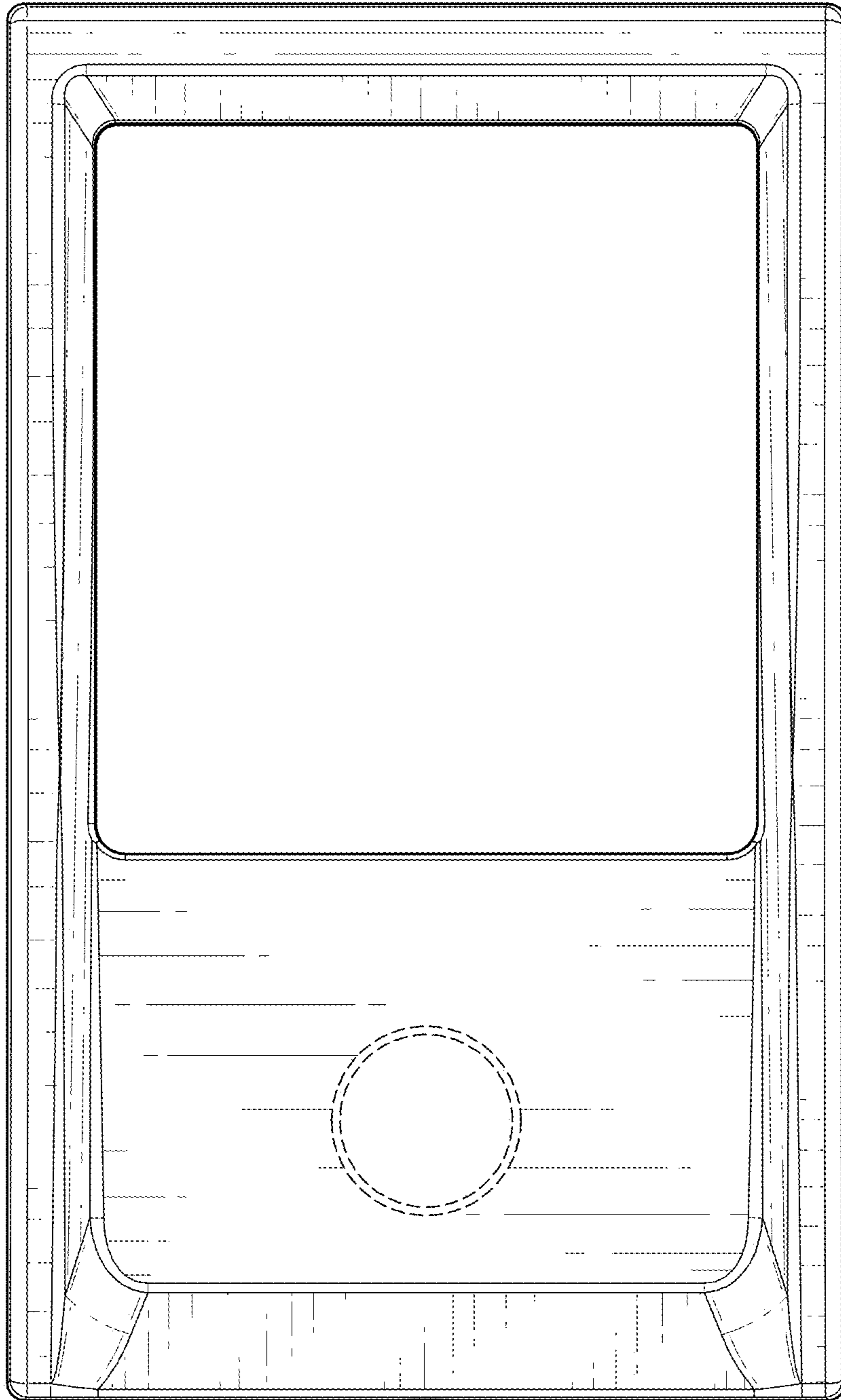

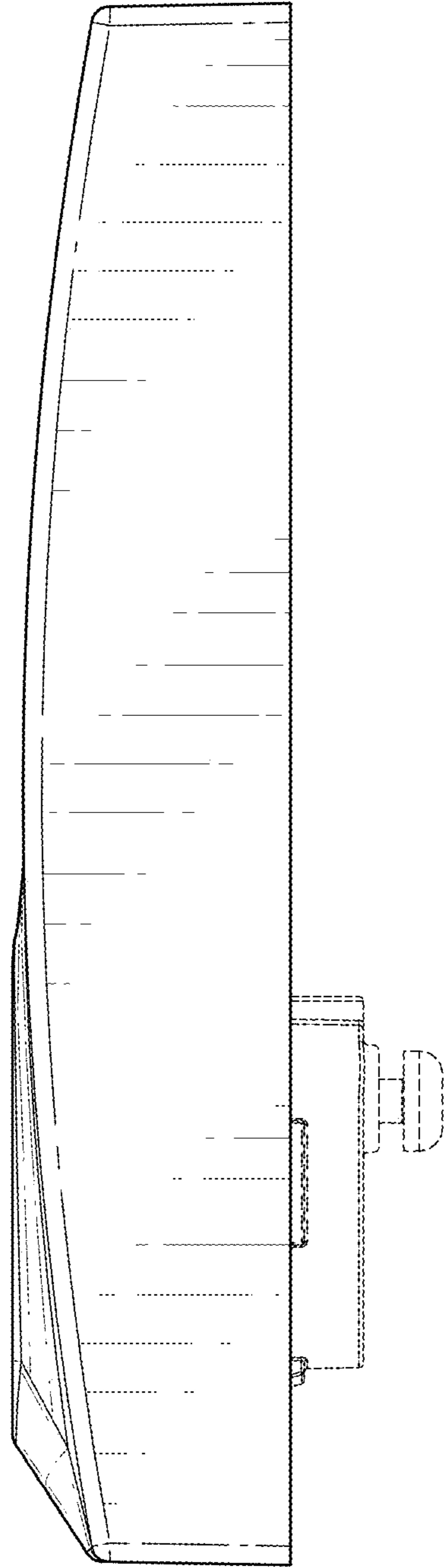

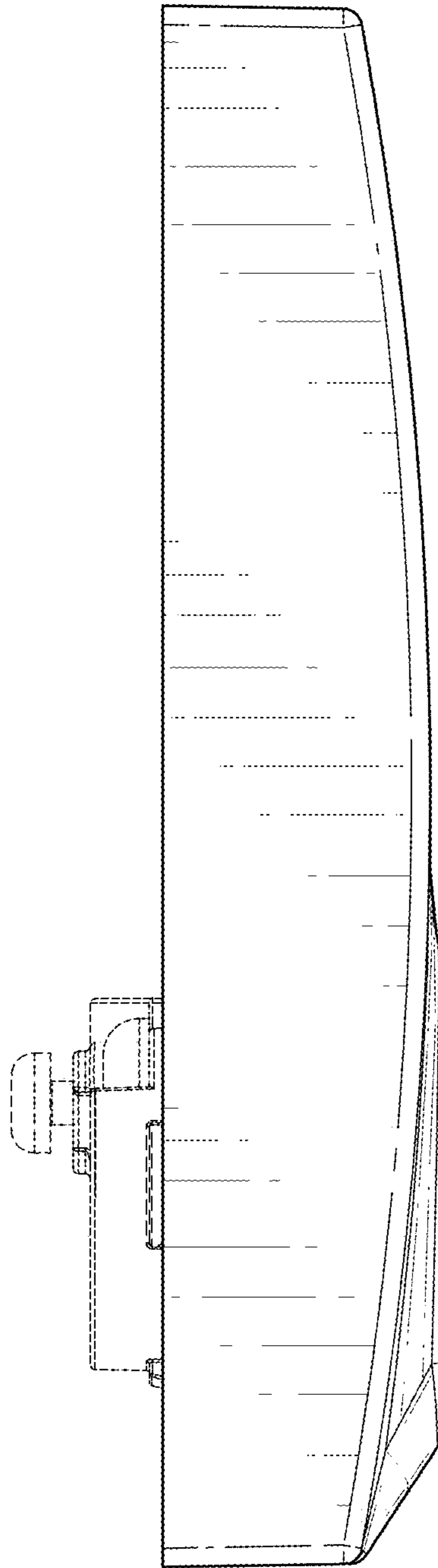

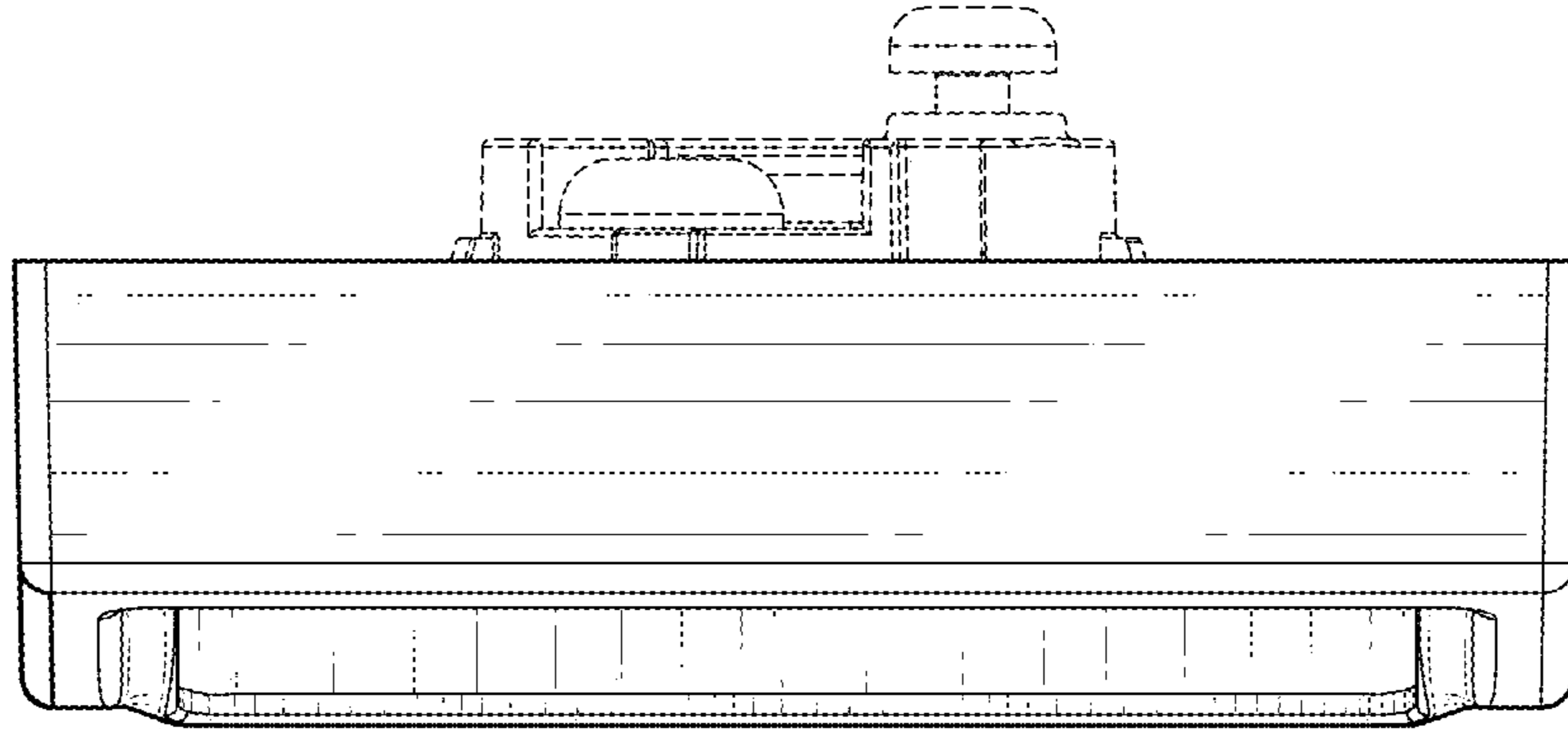

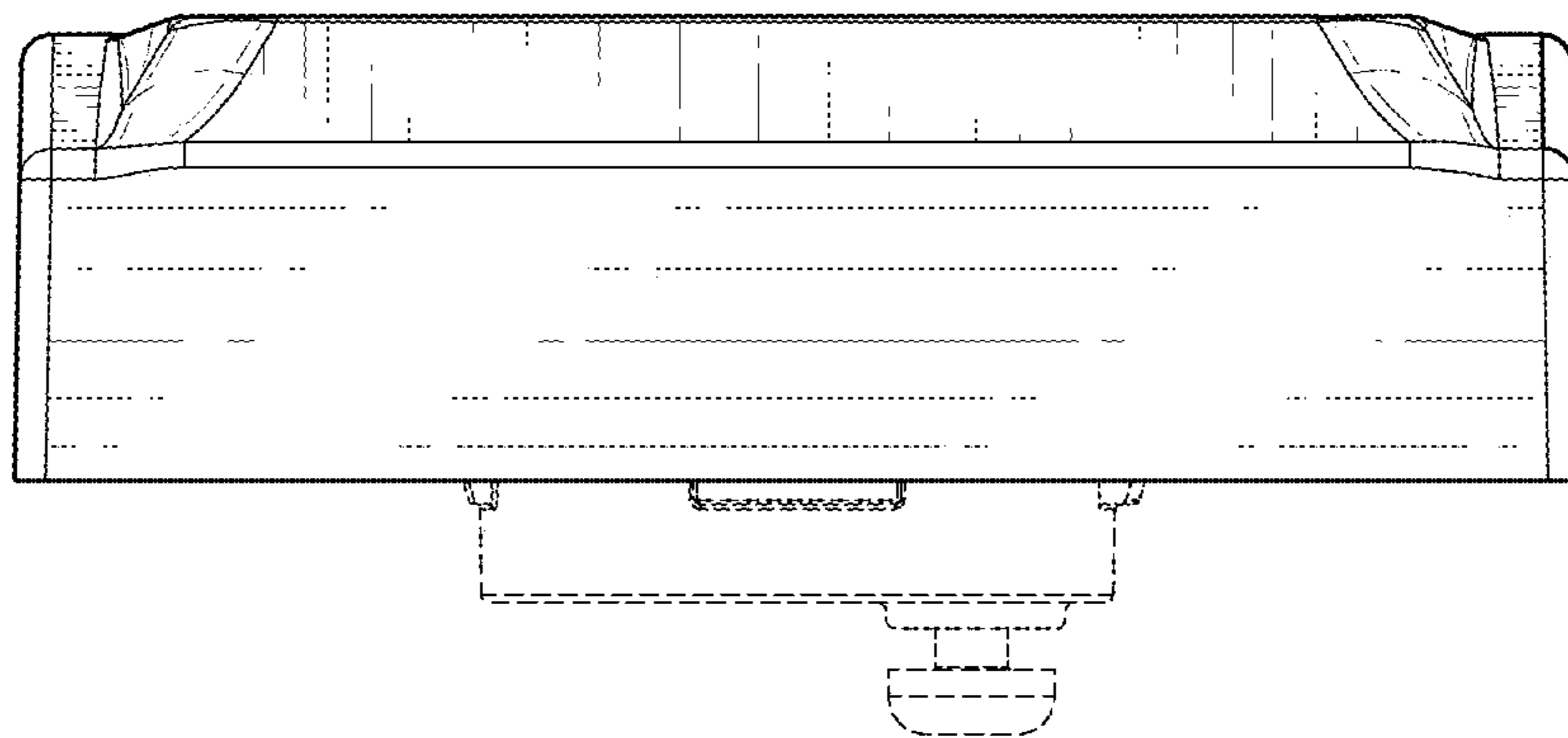
