FIG. 7 is a front, lower isometric view of the fencing wire tensioning bracket of FIG. 1; and,

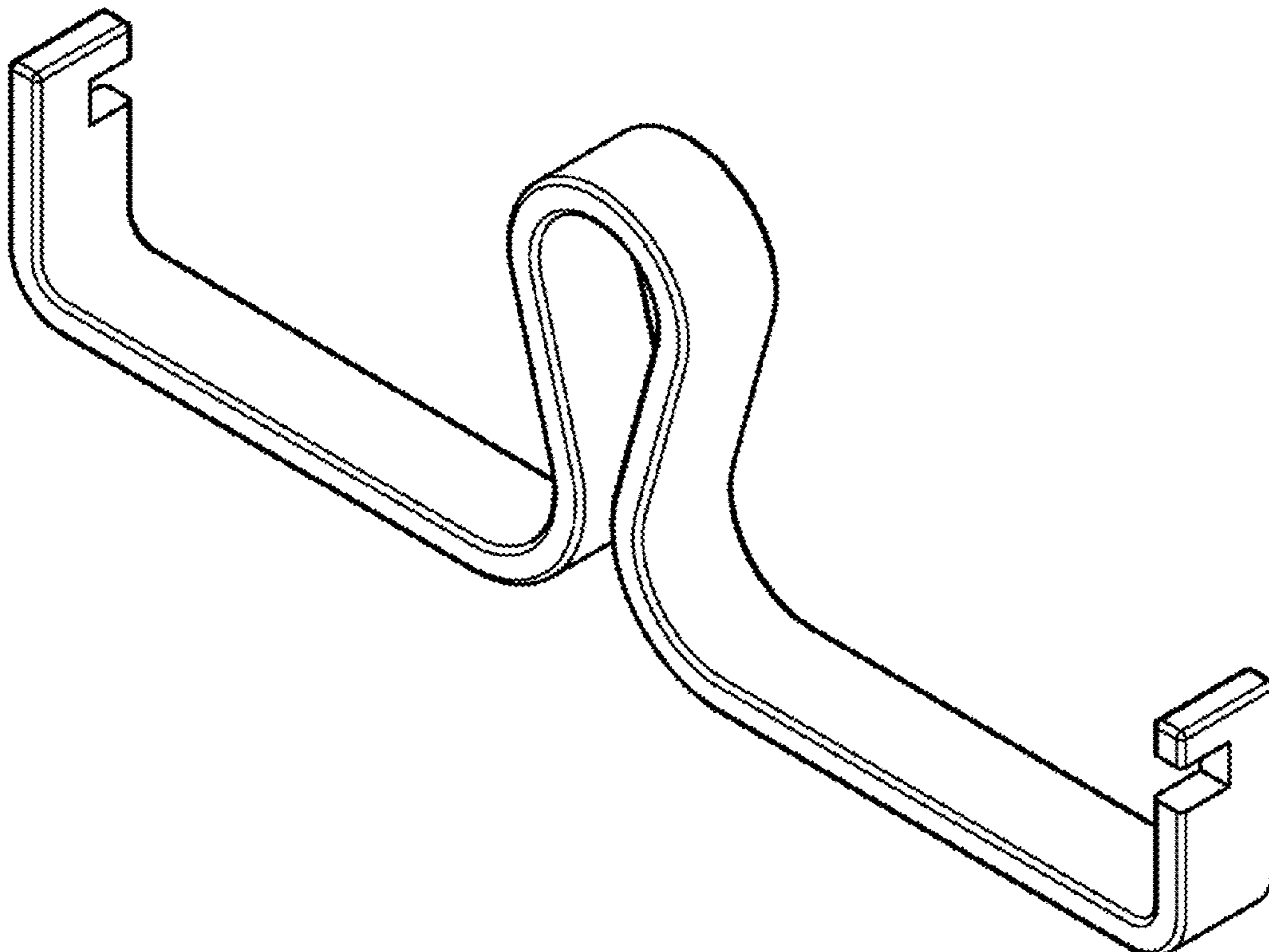
FIG. 8 is a rear, lower isometric view of the fencing wire tensioning bracket of FIG. 1.

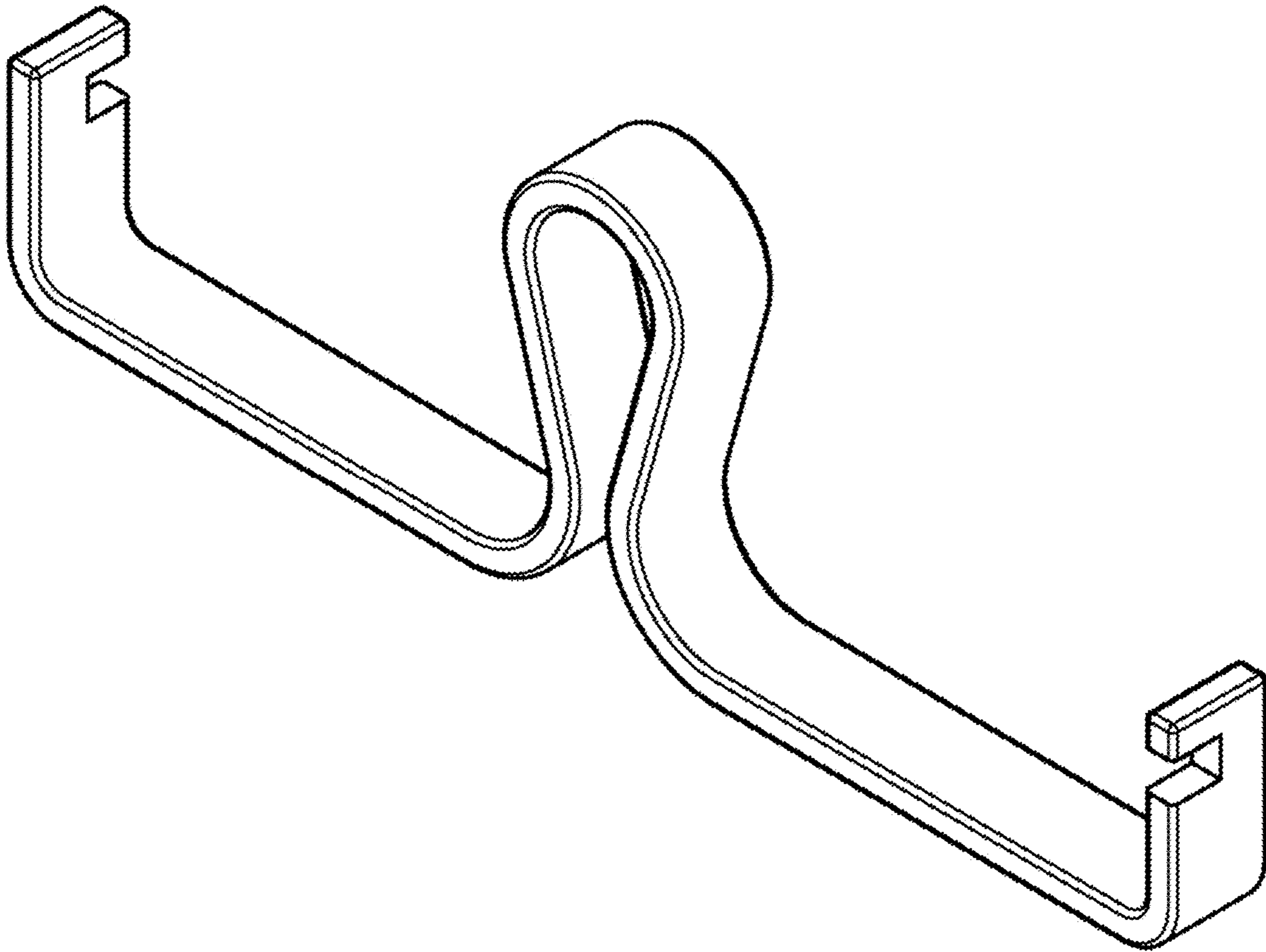

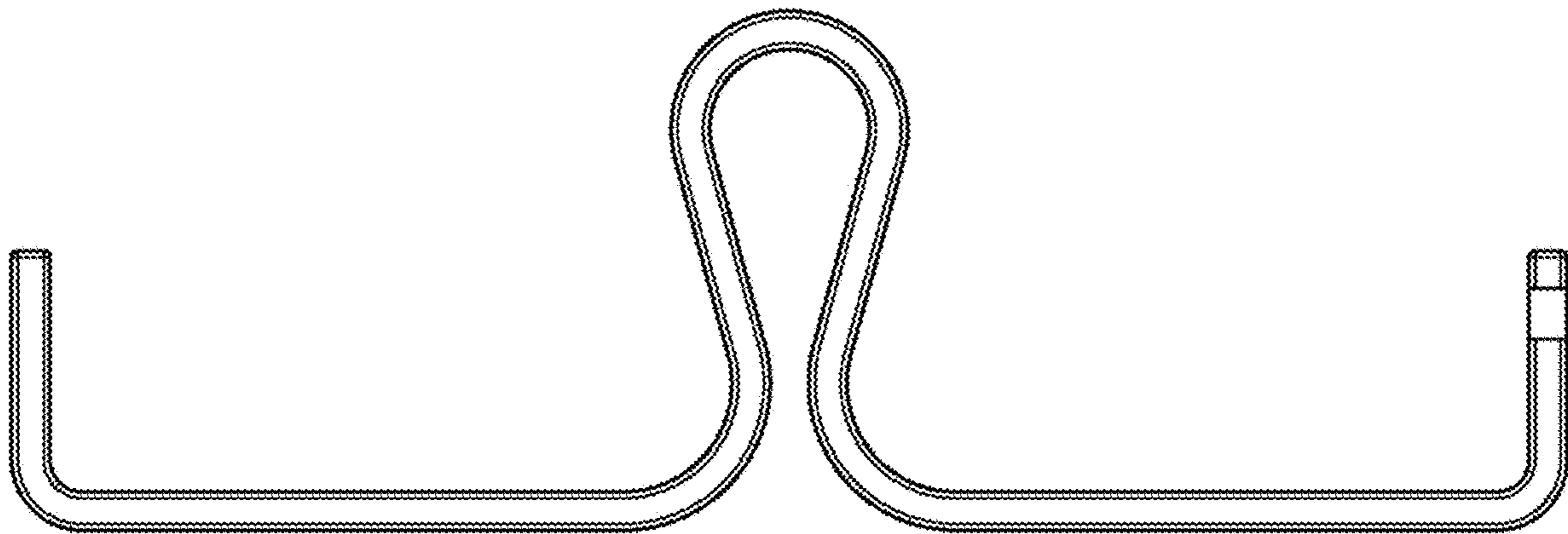

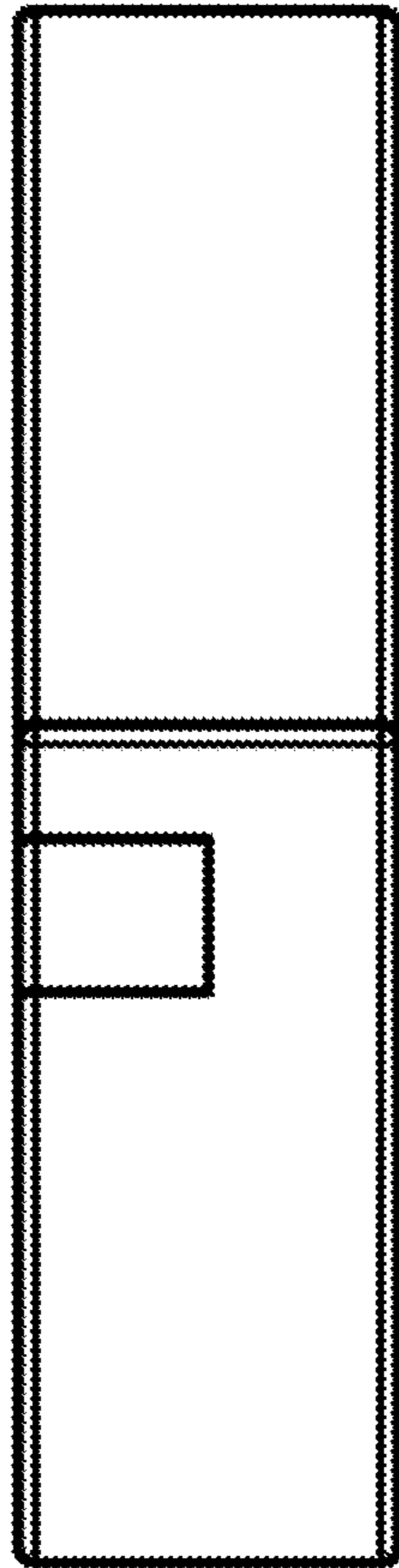

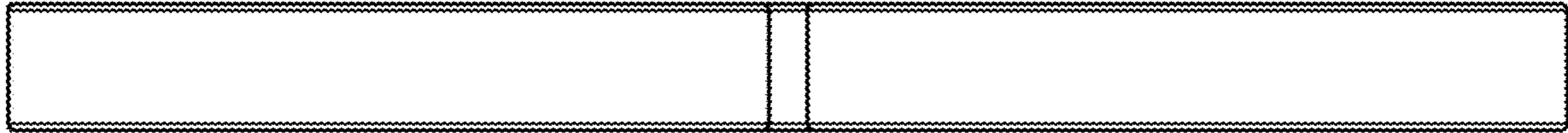

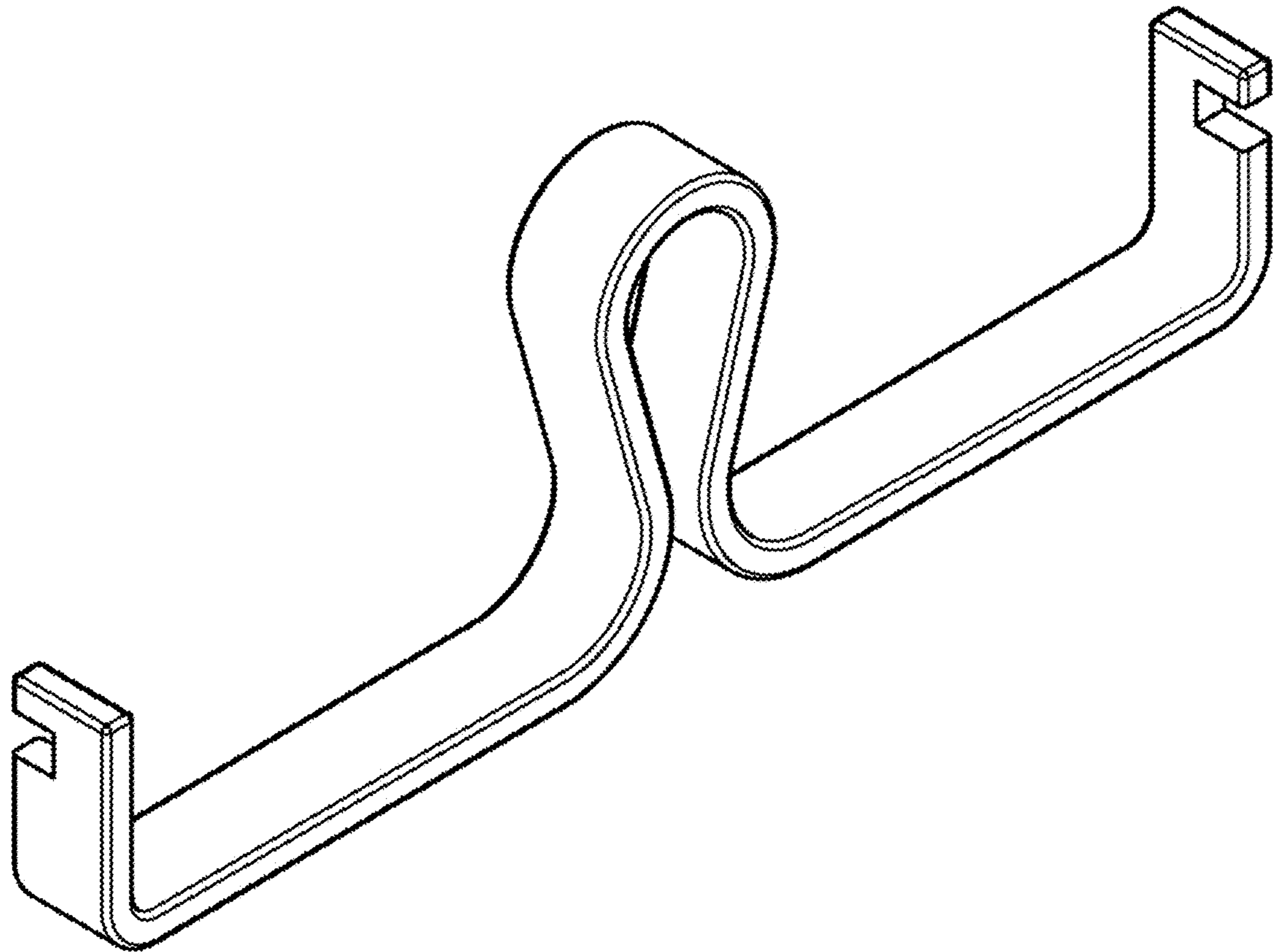

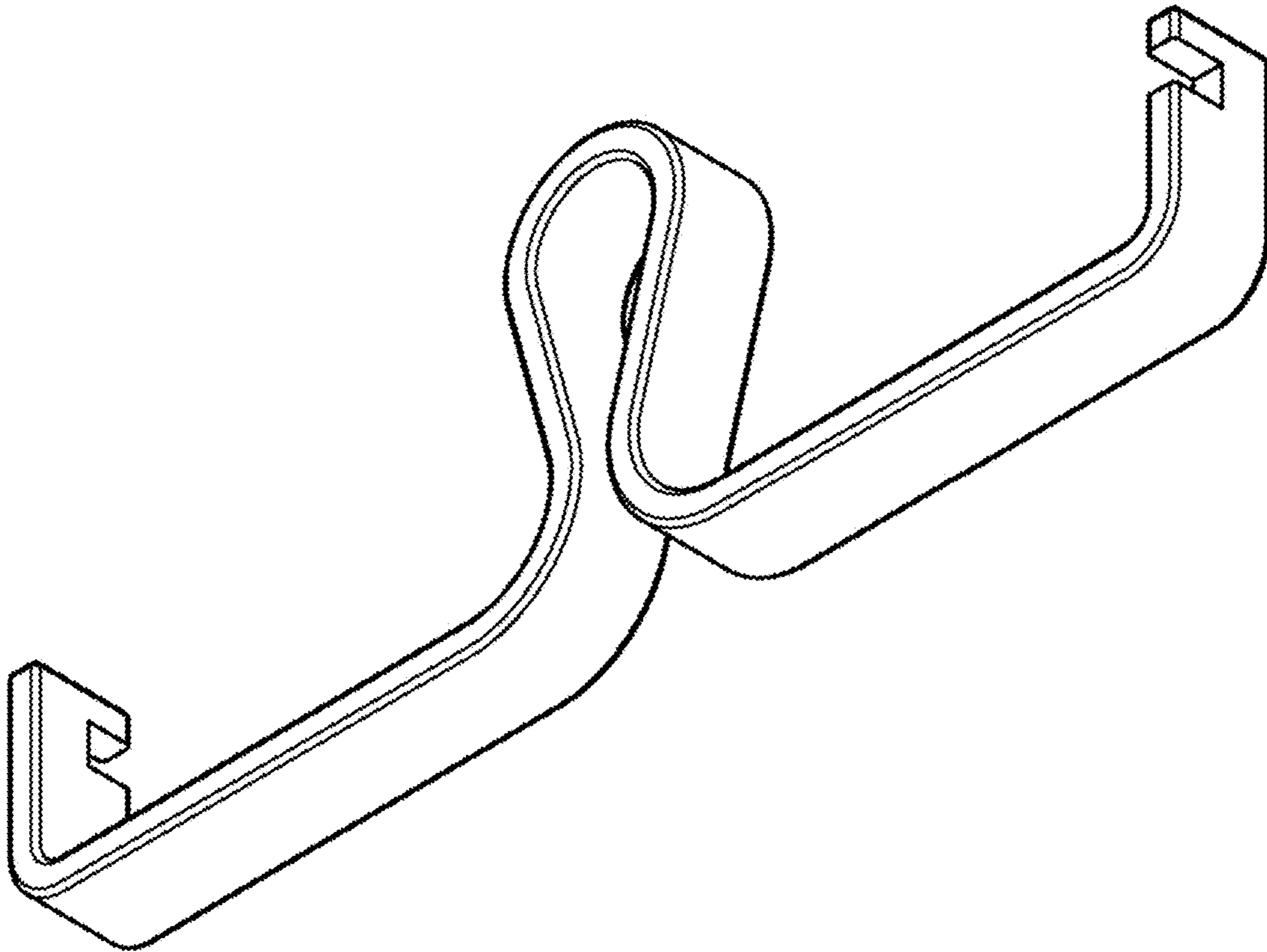

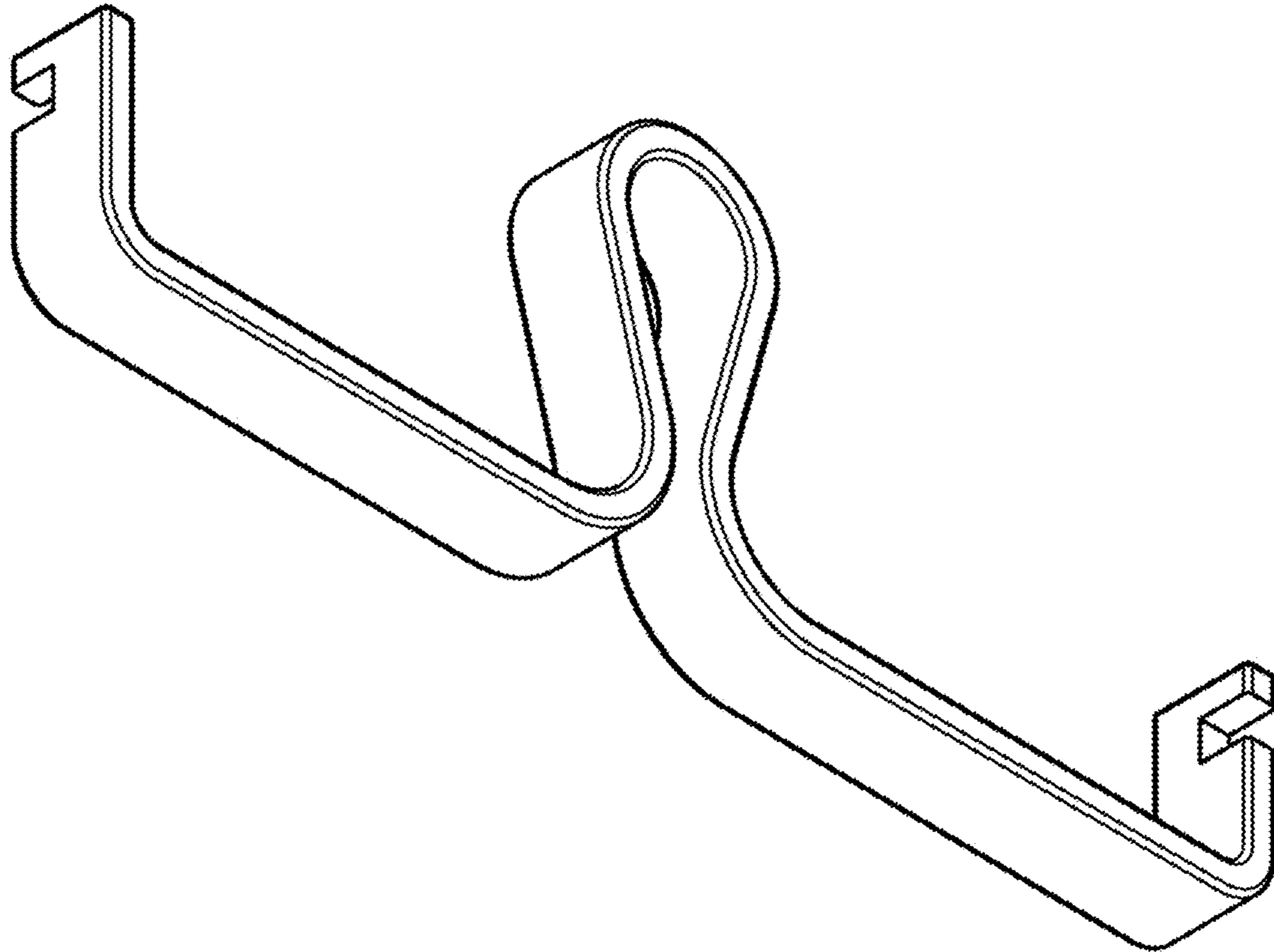
