The ornamental design for an article of jewelry, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, bottom perspective view of an article of jewelry, showing my new design in a first configuration of use;  
FIG. 2 is a front, bottom perspective view of the article of jewelry, shown in a second configuration of use;  
FIG. 3 is a front elevation view of the article of jewelry of FIG. 1, the rear elevation view being identical thereto;  
FIG. 4 is a left side view thereof; wherein the right side view being identical thereto;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a bottom plan view of the article of jewelry of FIG. 2.

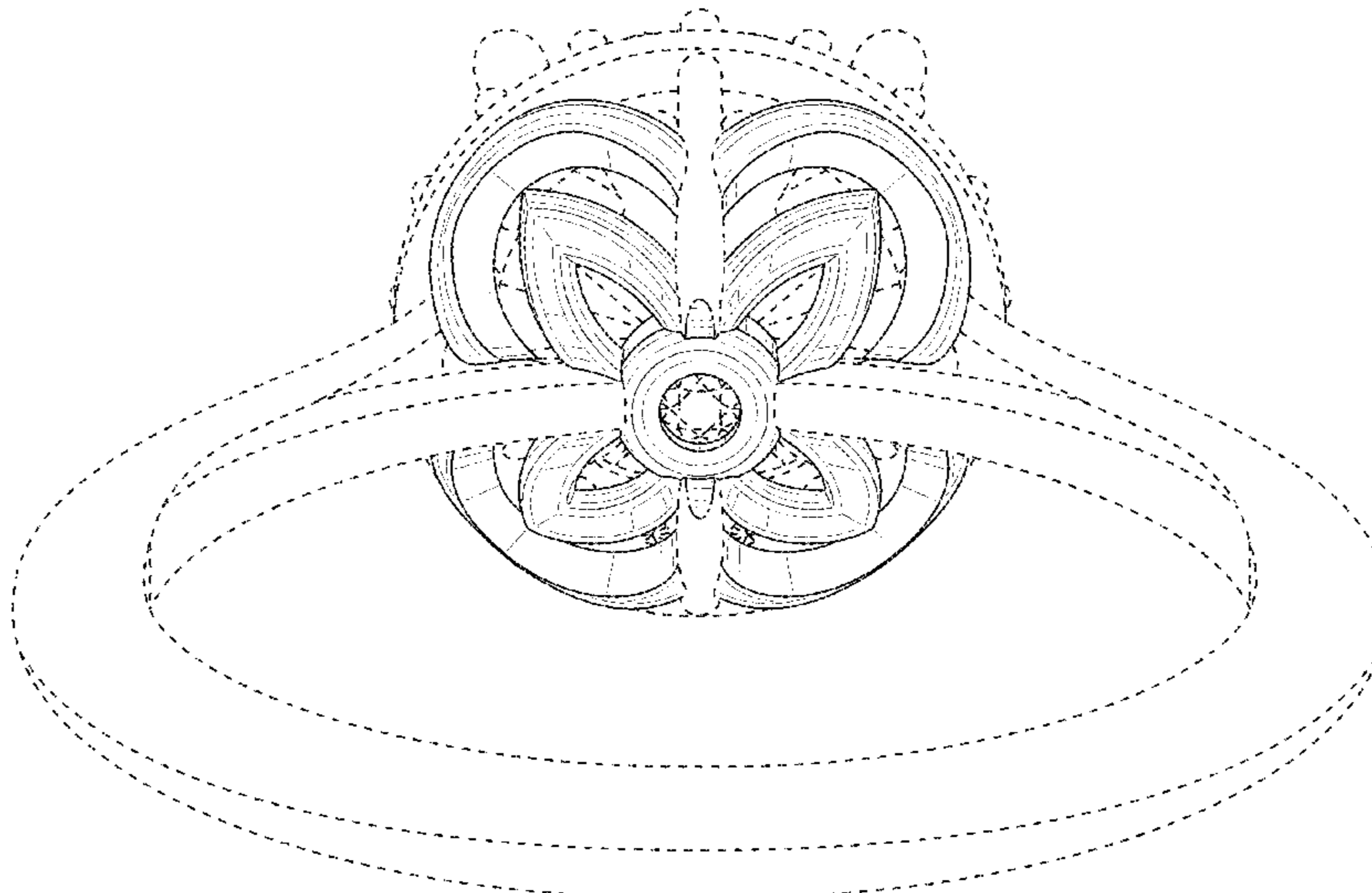

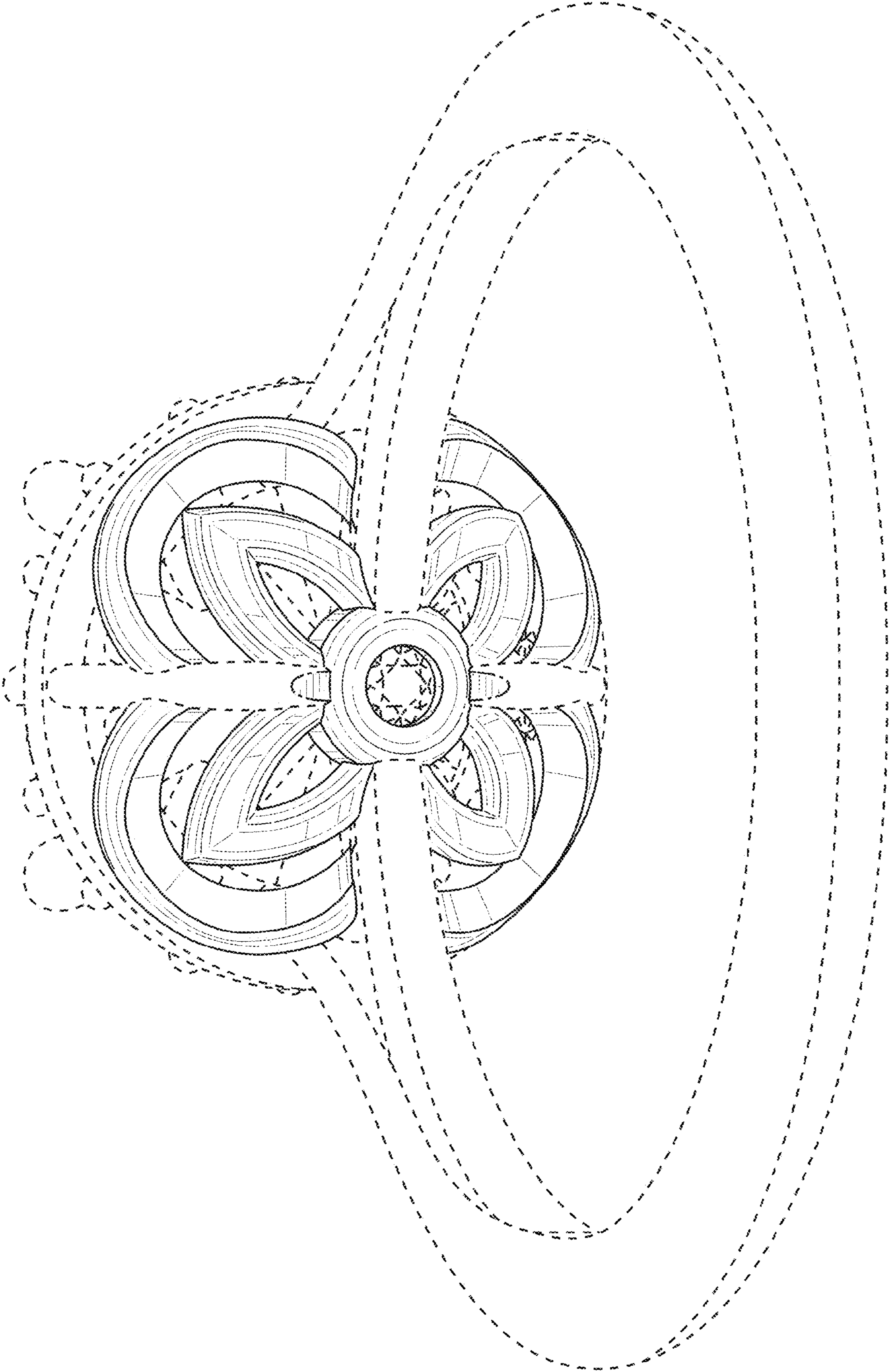
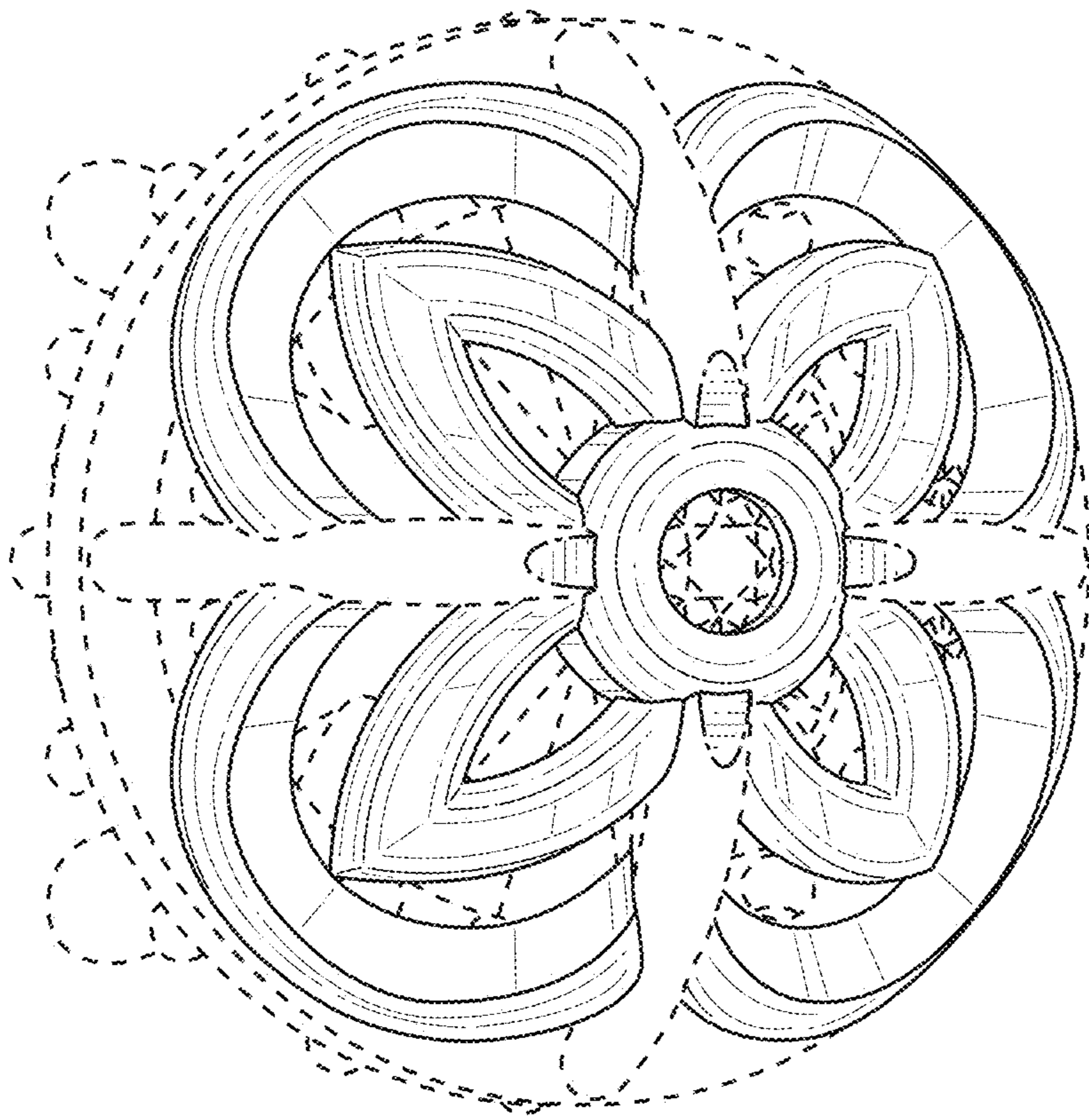
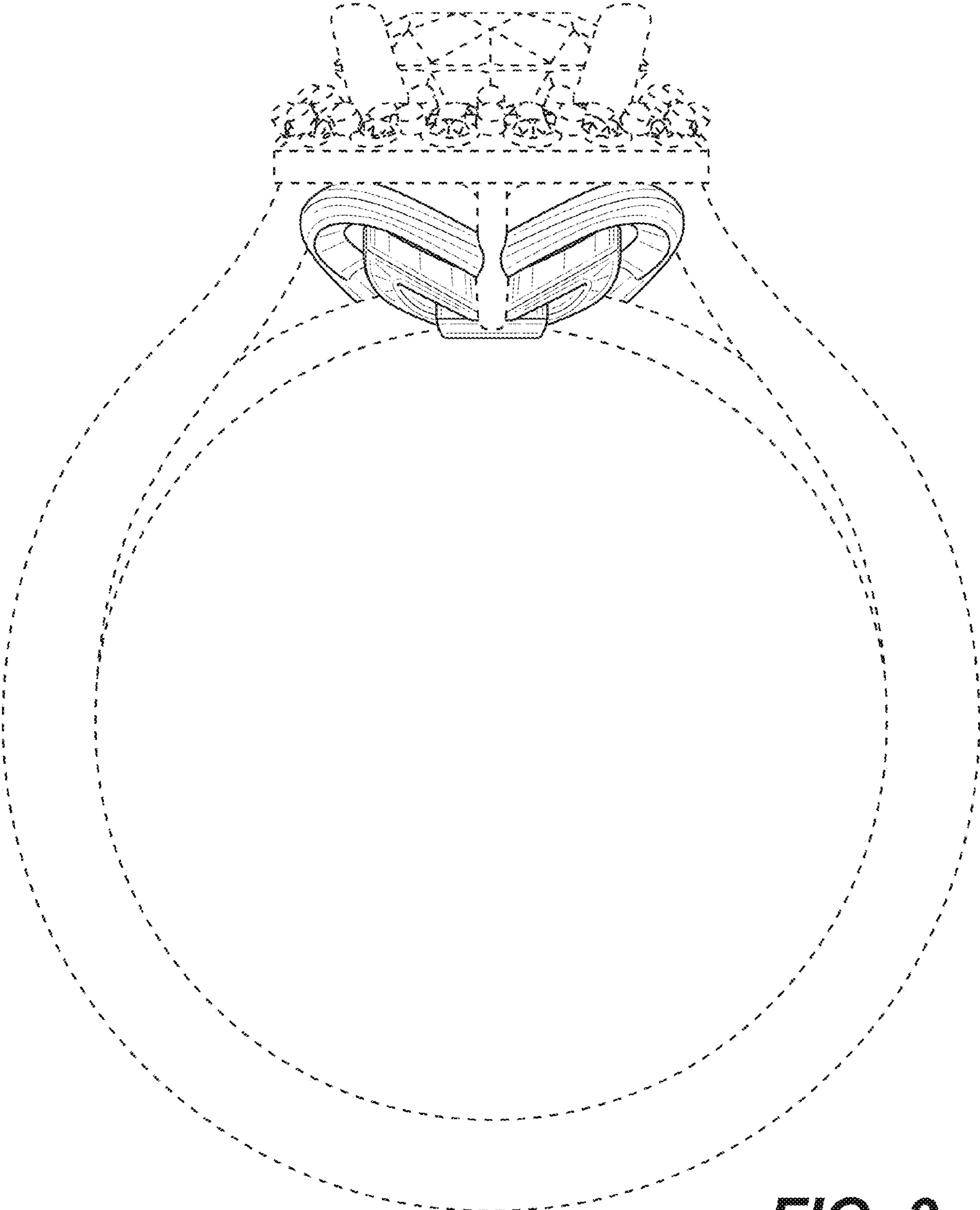


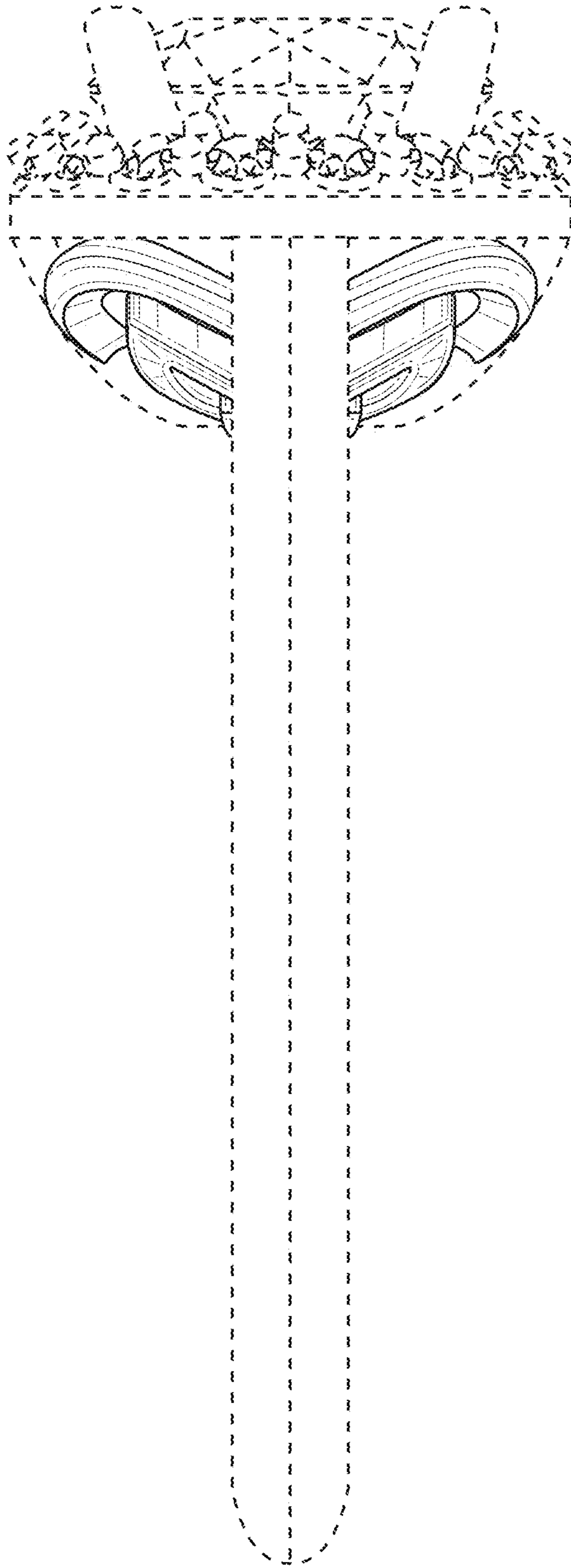

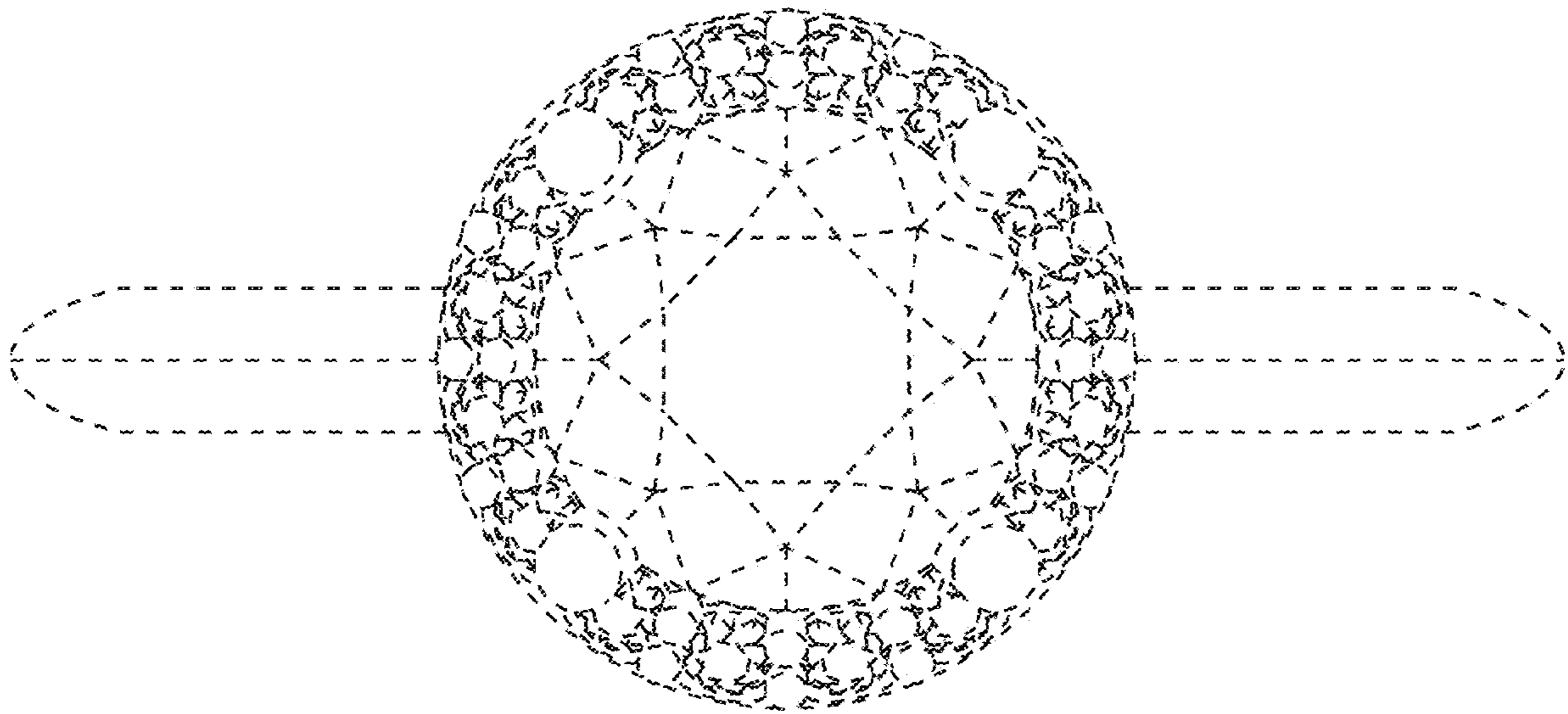

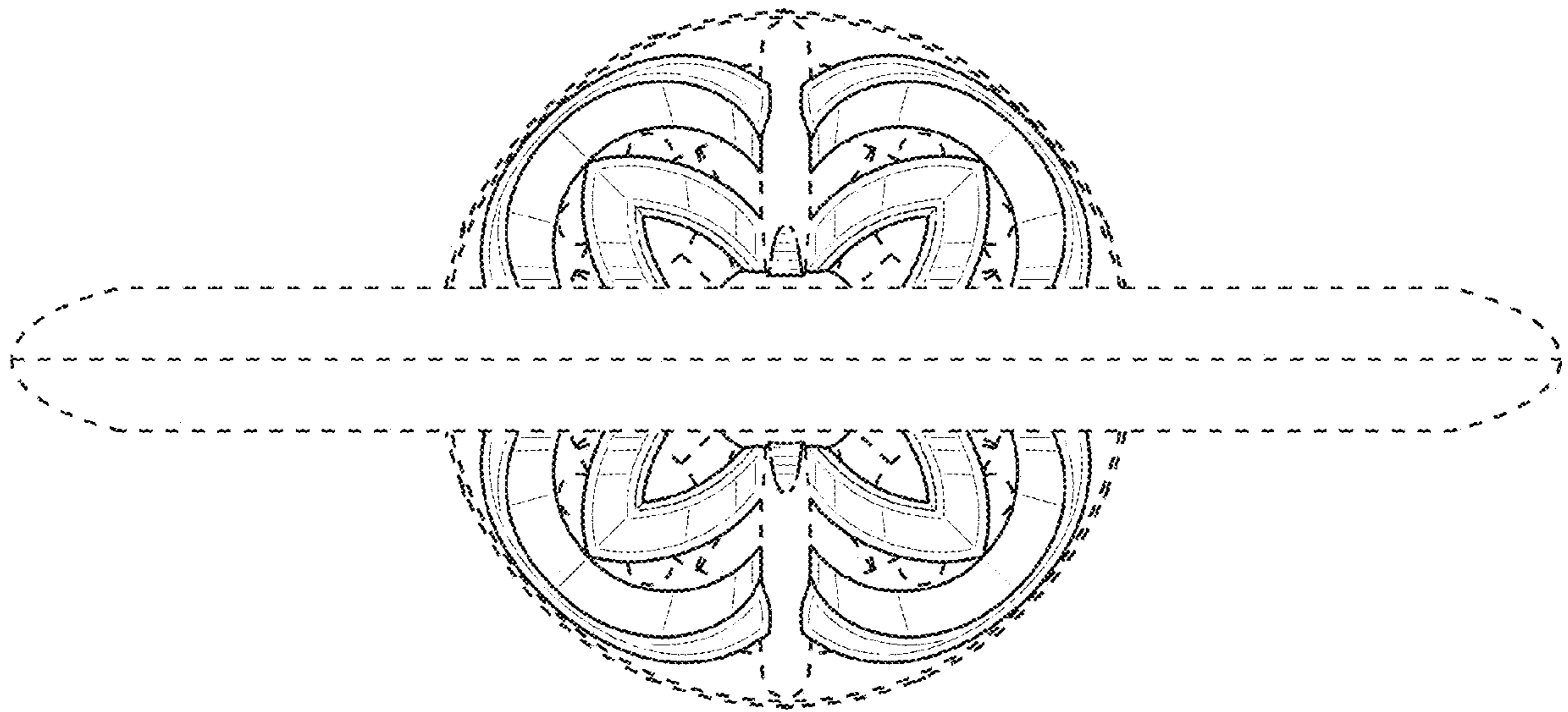

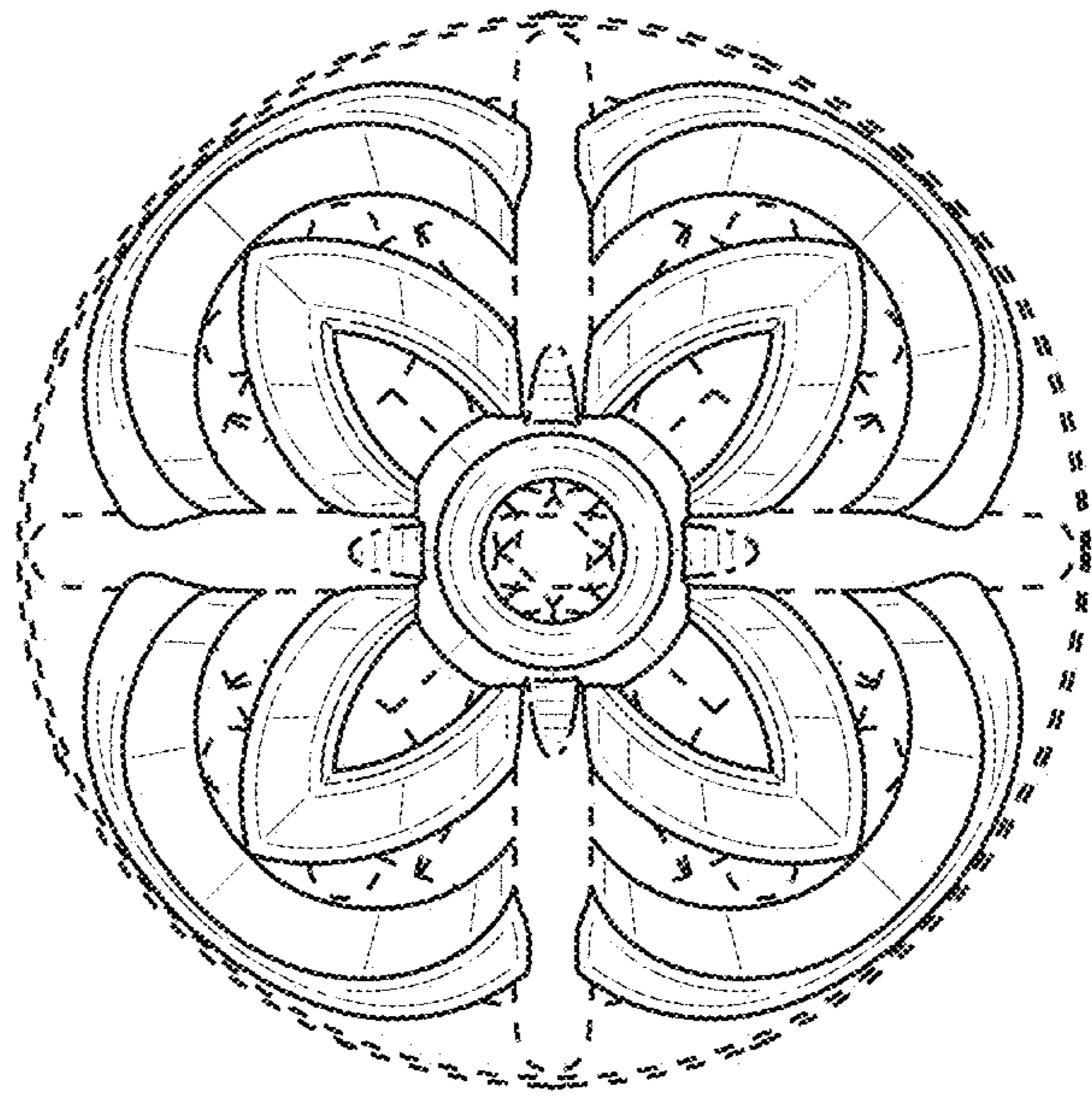
