(57) **CLAIM**

I claim the ornamental design for the leg pendant, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the leg pendant showing my new design in a configuration of use;
FIG. 2 is a side view of the leg pendant in a configuration of use;
FIG. 3 is another rear perspective view of the leg pendant in a configuration of use;
FIG. 4 is another rear perspective view of the leg pendant;
FIG. 5 is a left side view of the leg pendant;
FIG. 6 is a top view of the leg pendant;
FIG. 7 is a bottom view of the leg pendant;
FIG. 8 is a front view of the leg pendant;
FIG. 9 is a right side view of the leg pendant;
FIG. 10 is a rear view of the leg pendant; and,
FIG. 11 is a perspective view of the leg pendant laid flat.

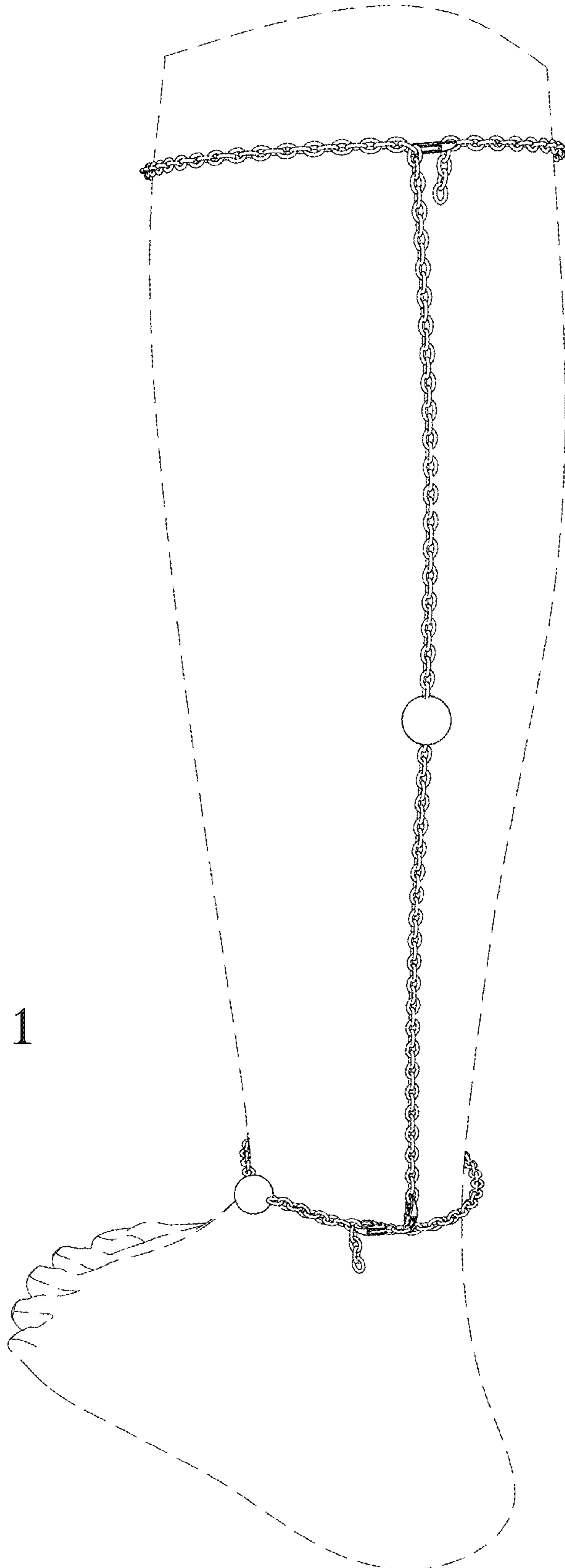

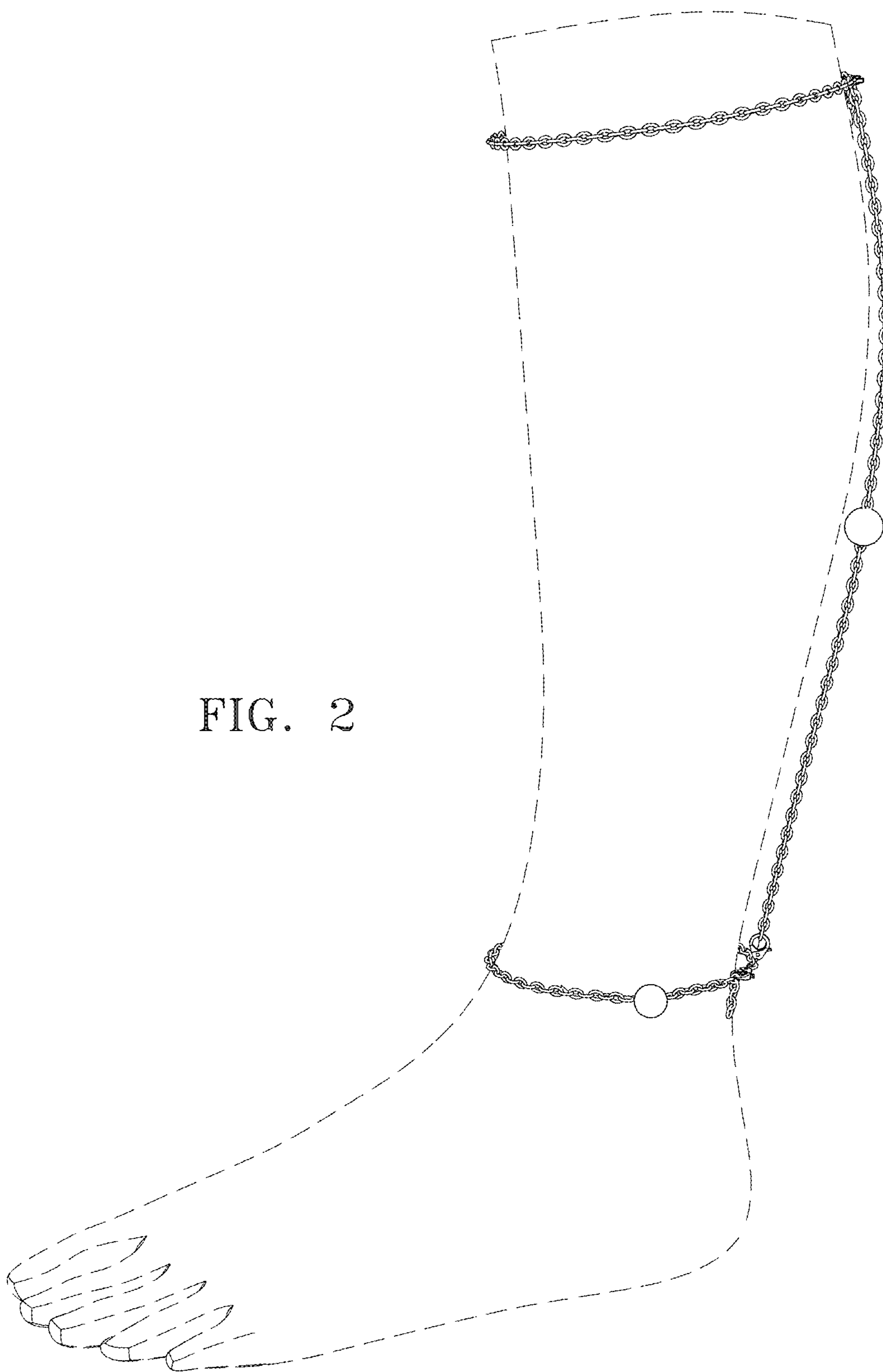

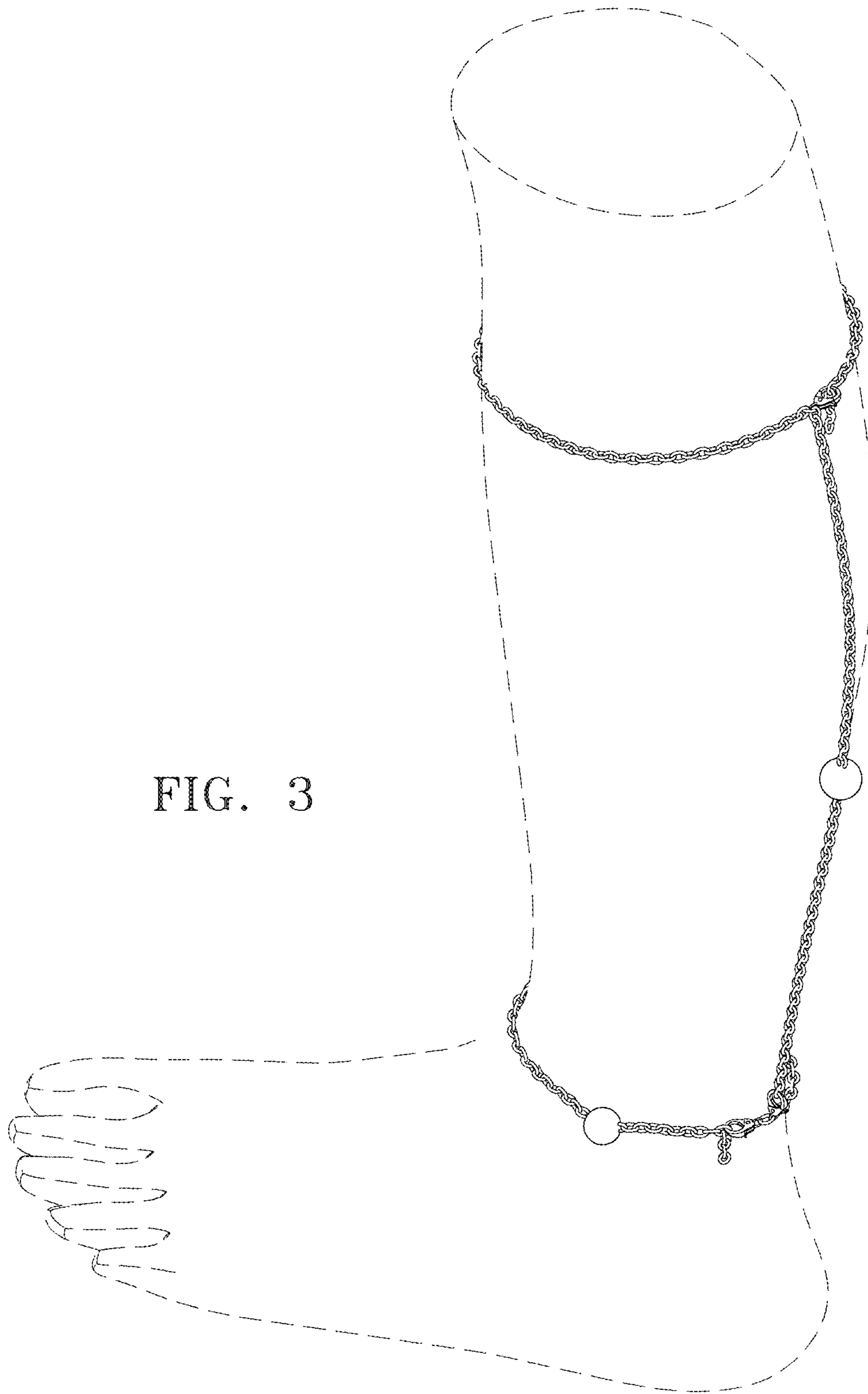

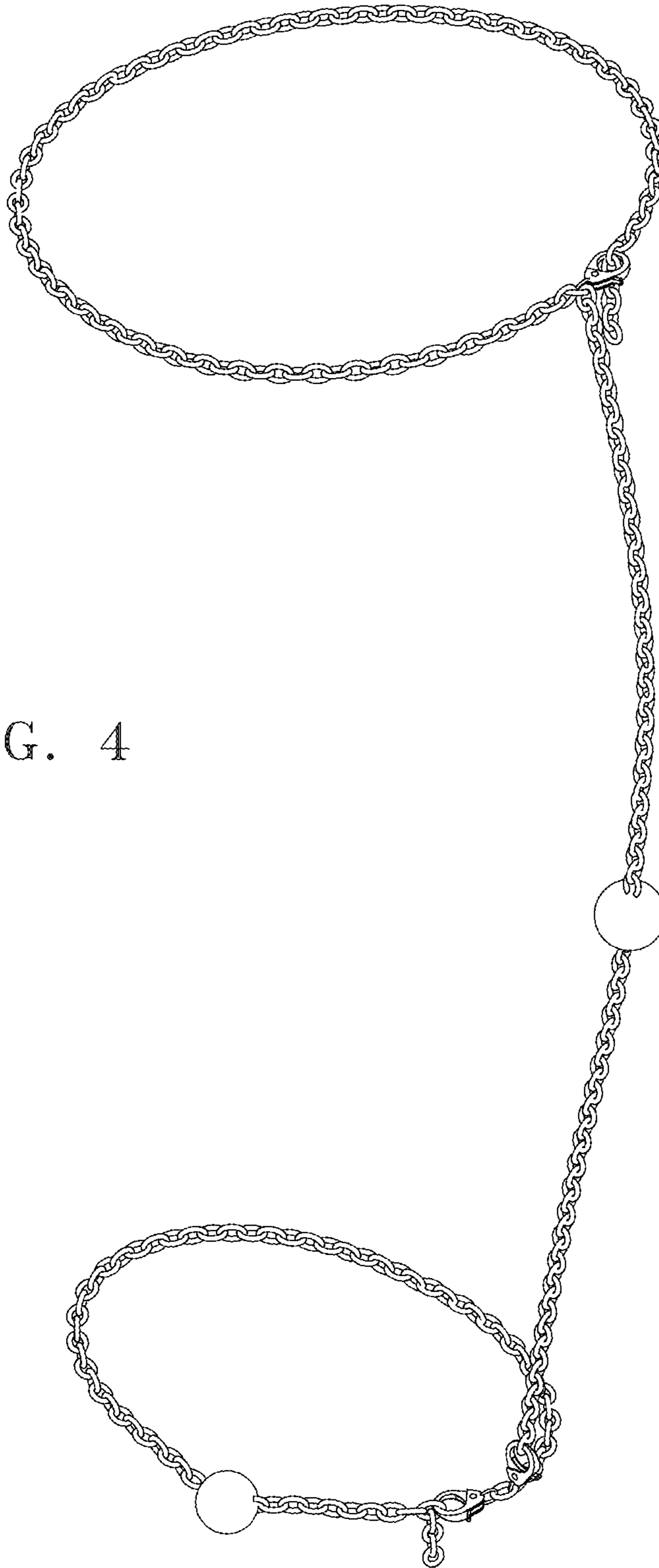


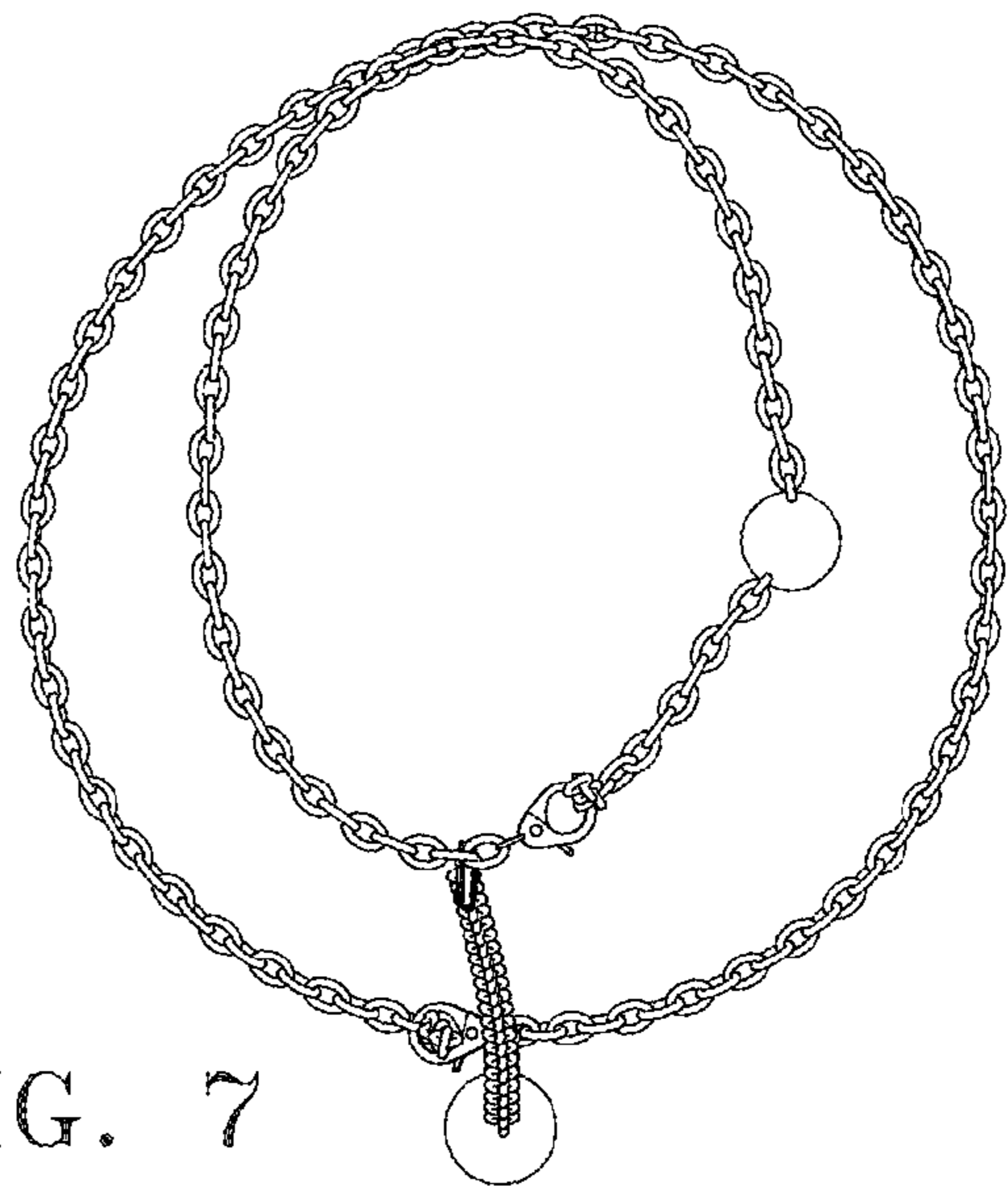

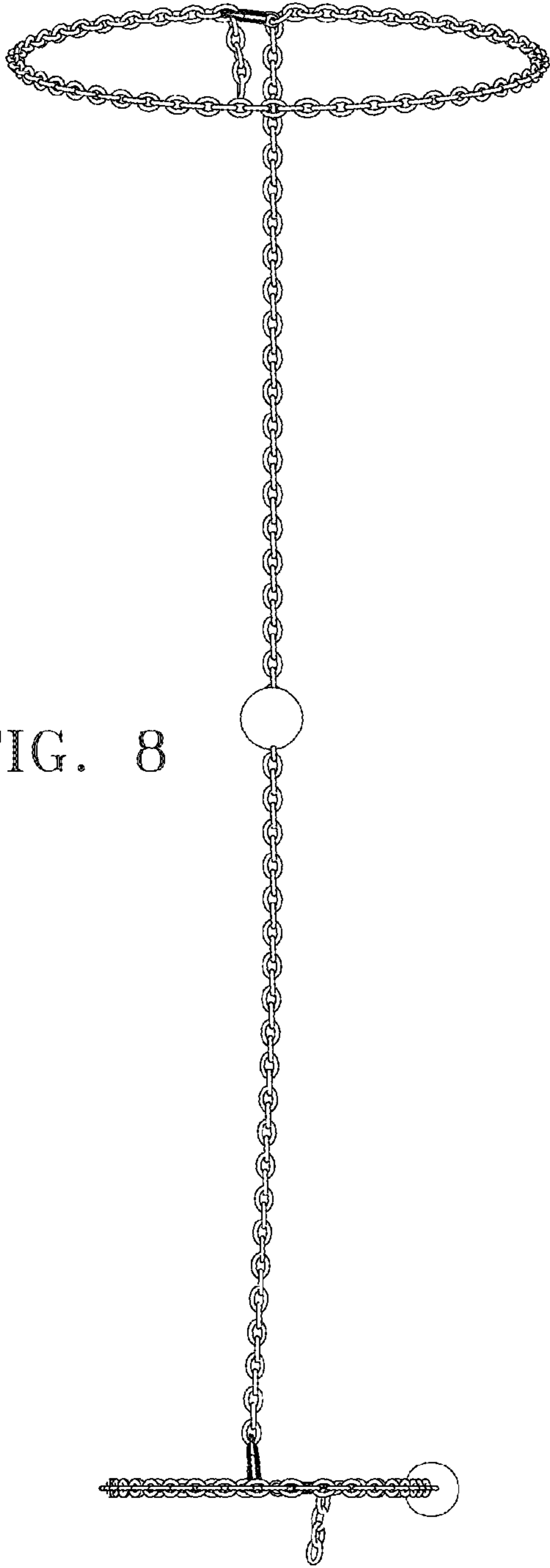

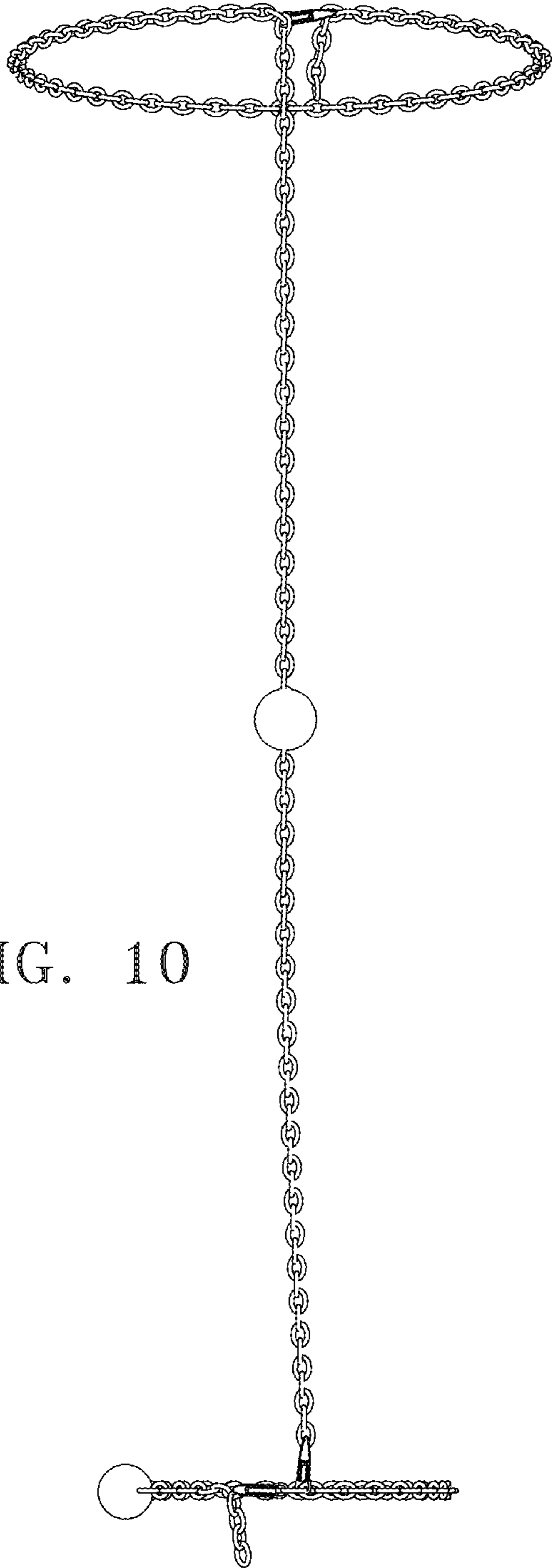

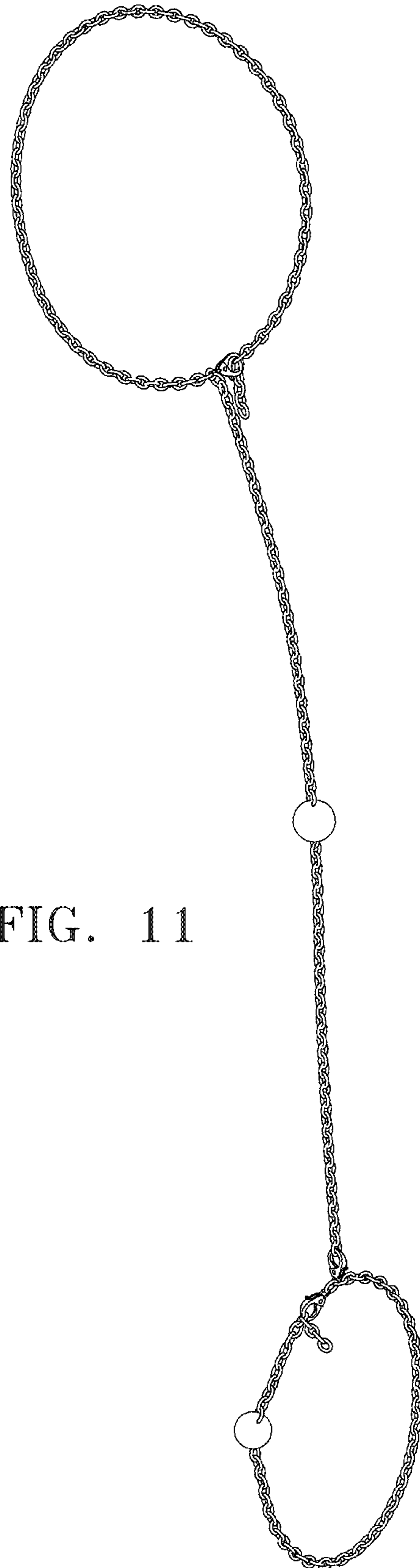
