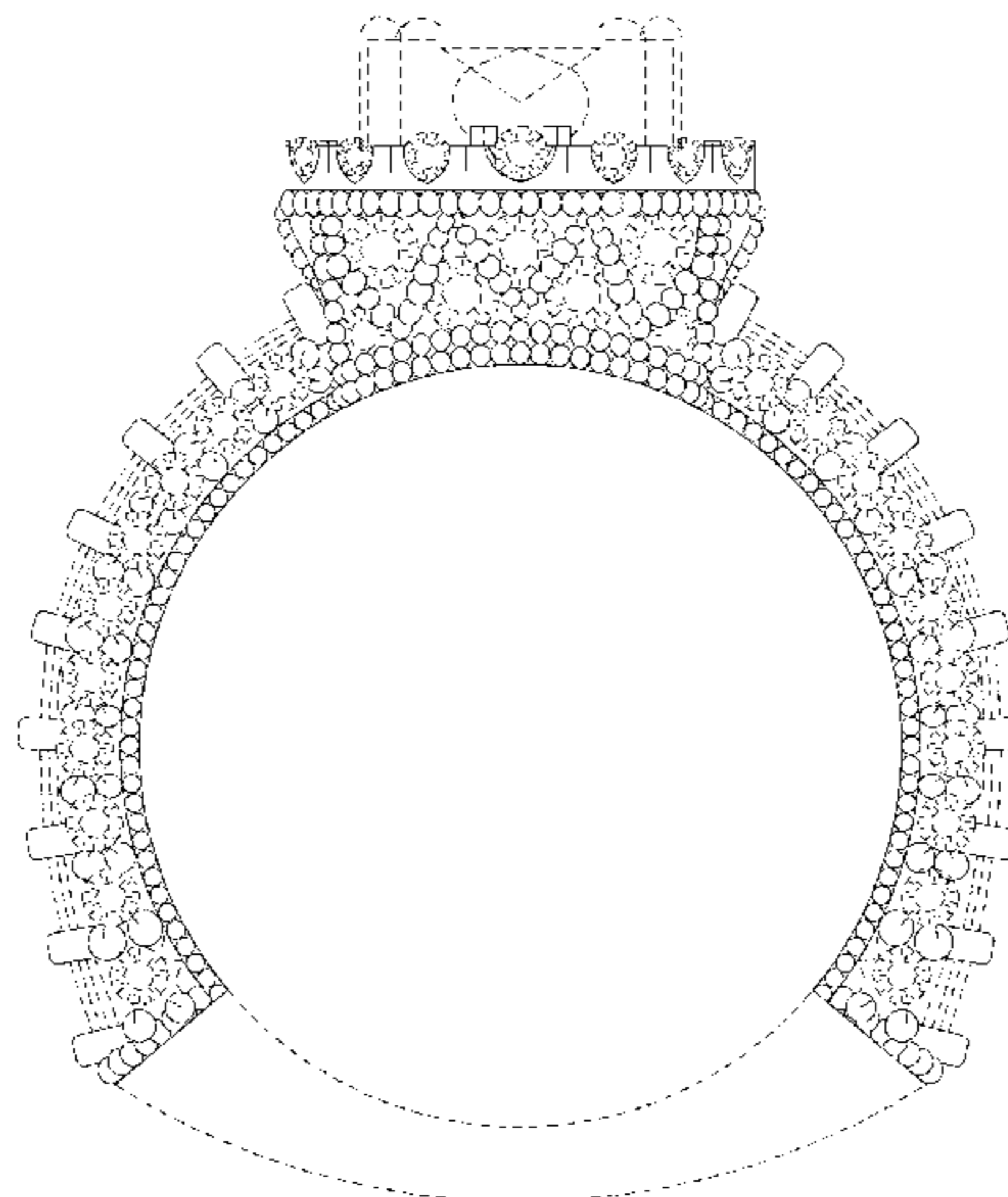
(57) **CLAIM**

FIG. 1 is a front view of a ring showing our new design, the rear view being a mirror image thereof;
 FIG. 2 is another front view thereof, the rear view being a mirror image thereof;

 FIG. 4 is a top view thereof; and,
 FIG. 5 is a bottom view thereof.

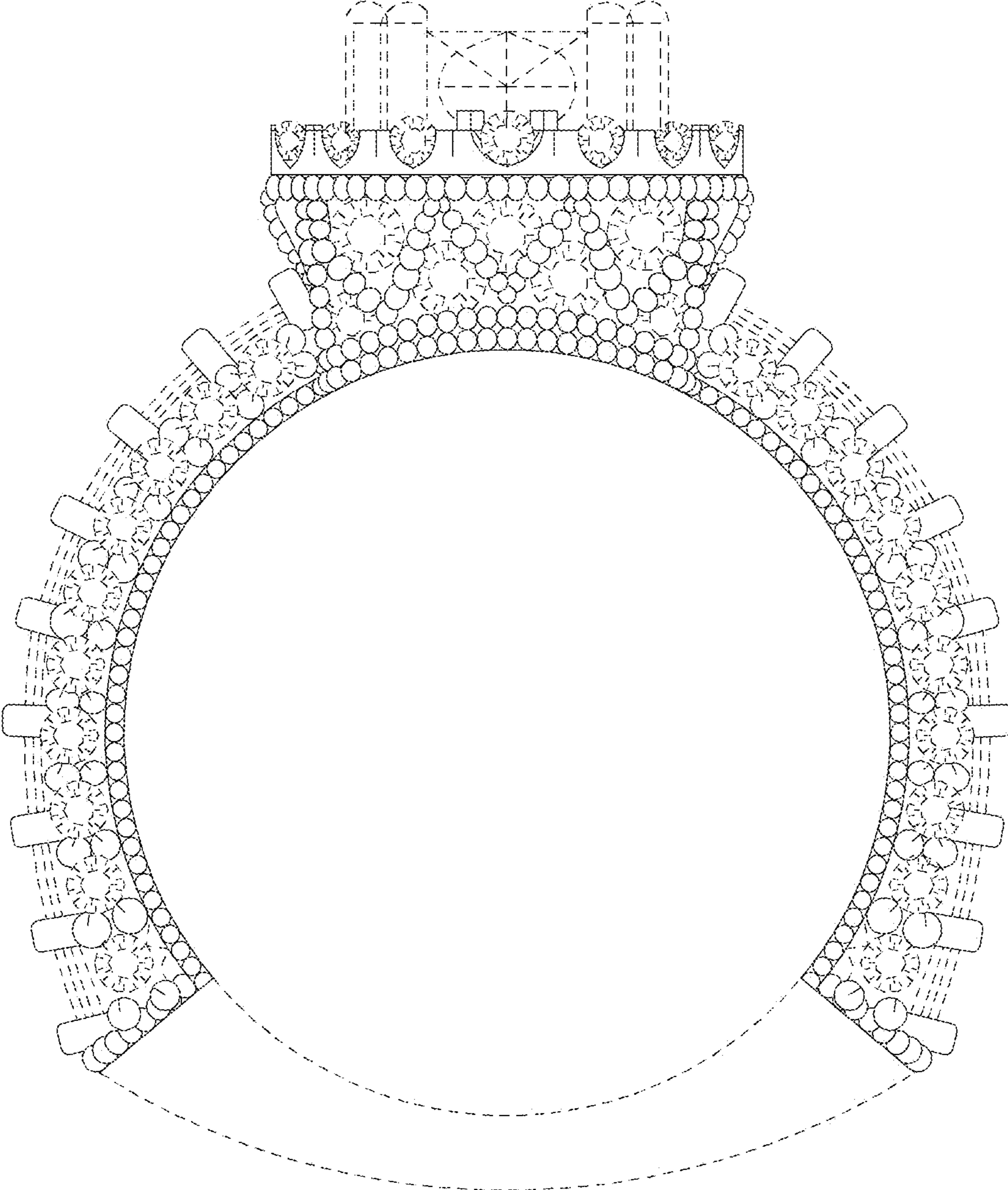

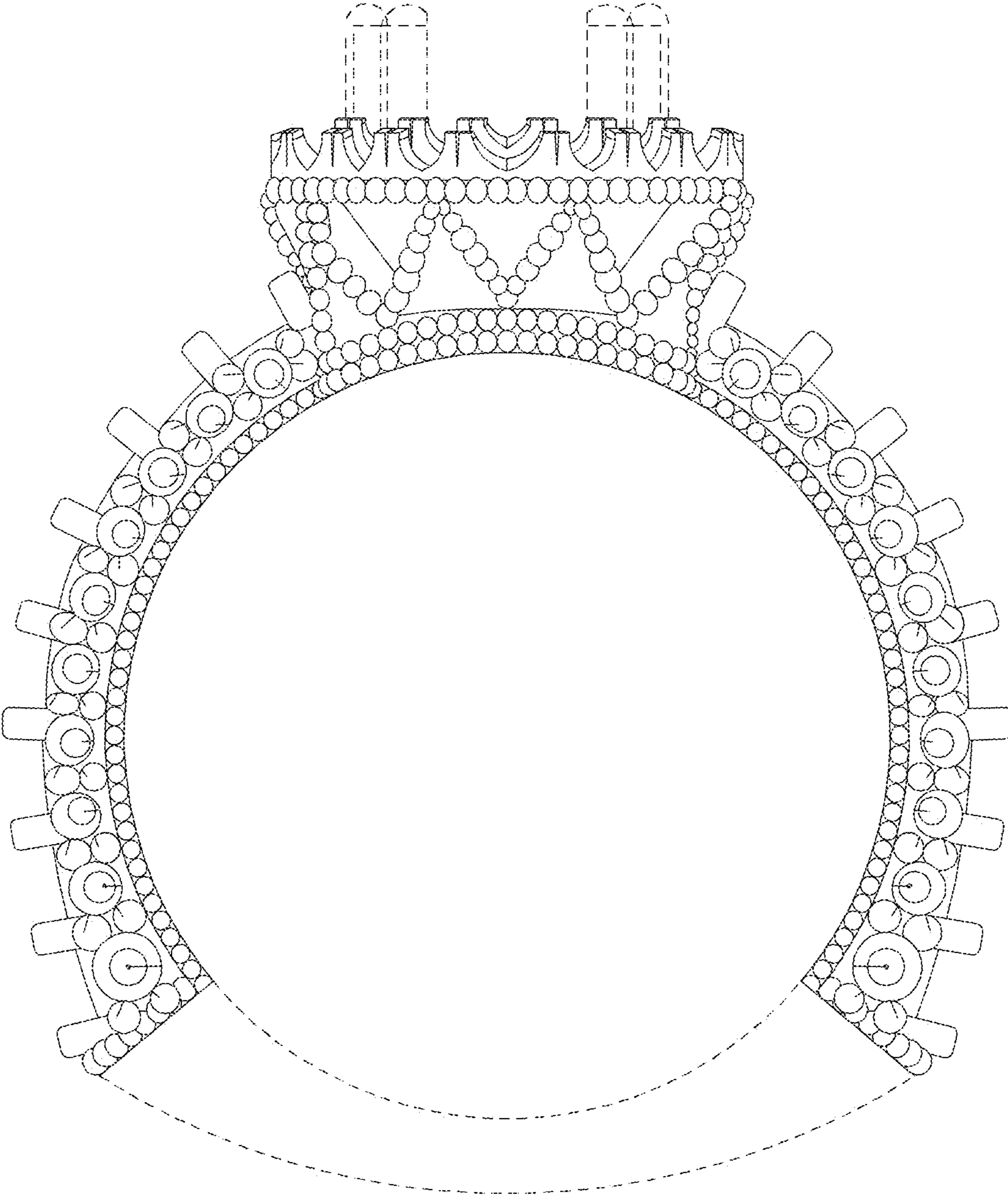

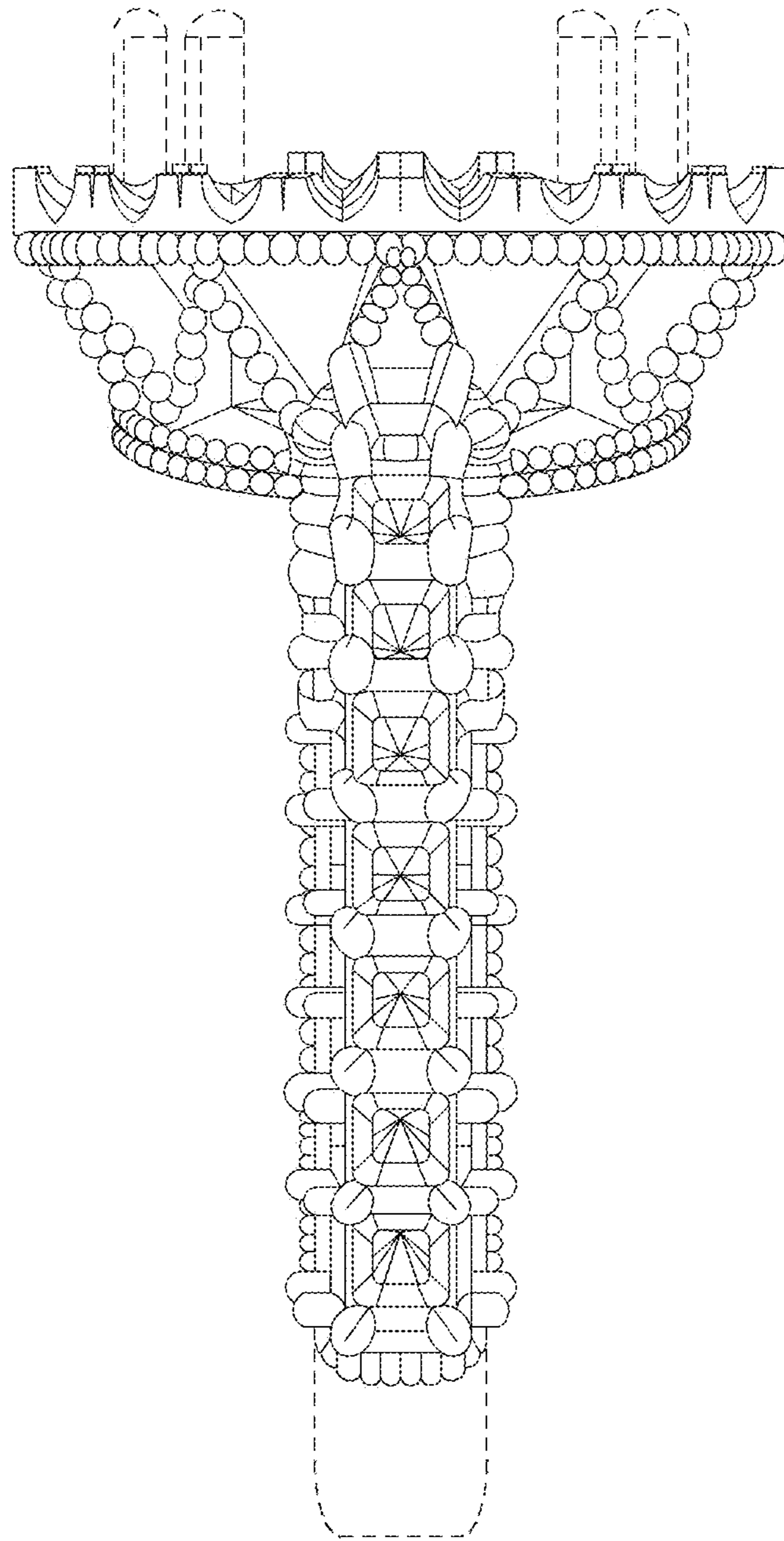

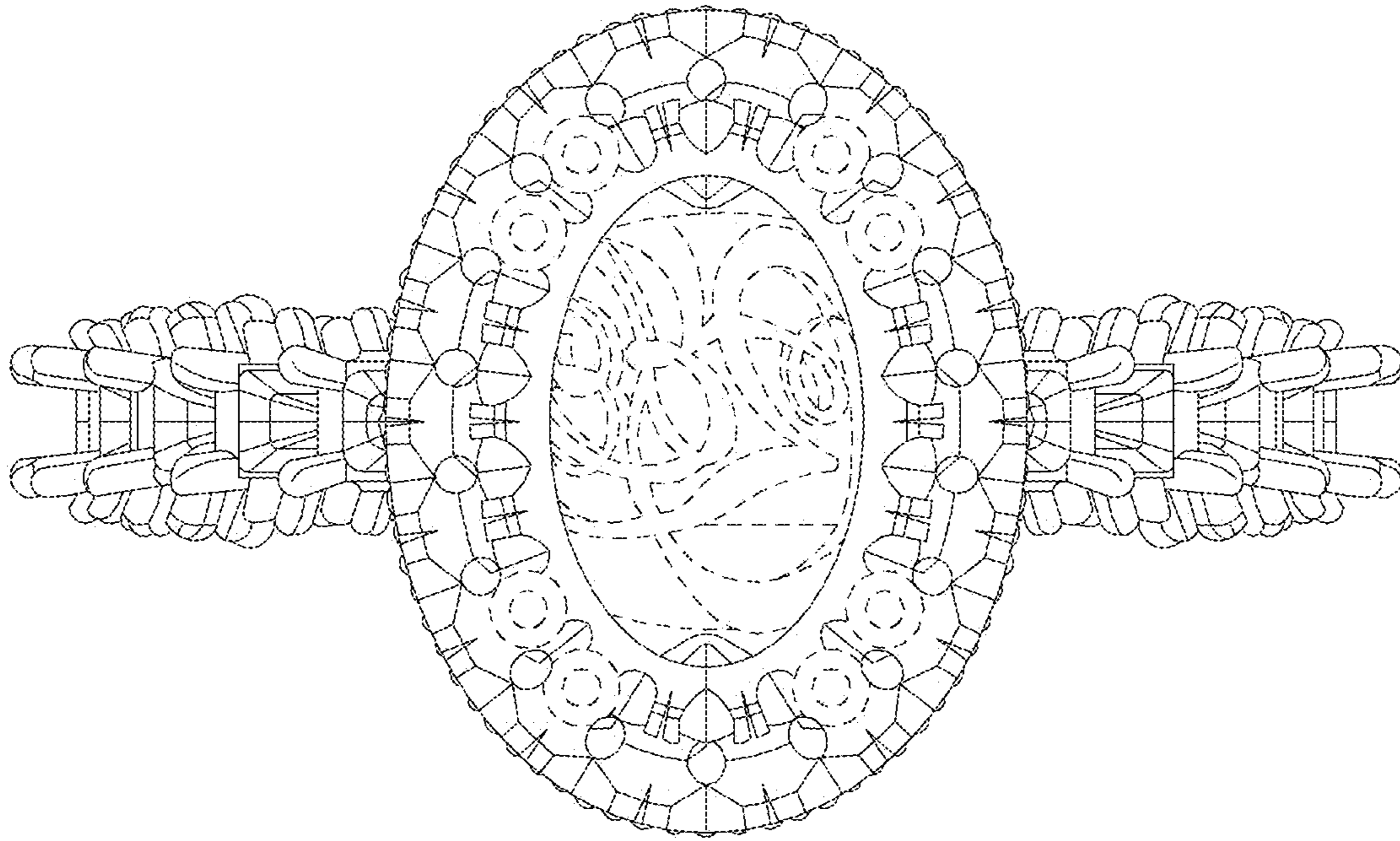

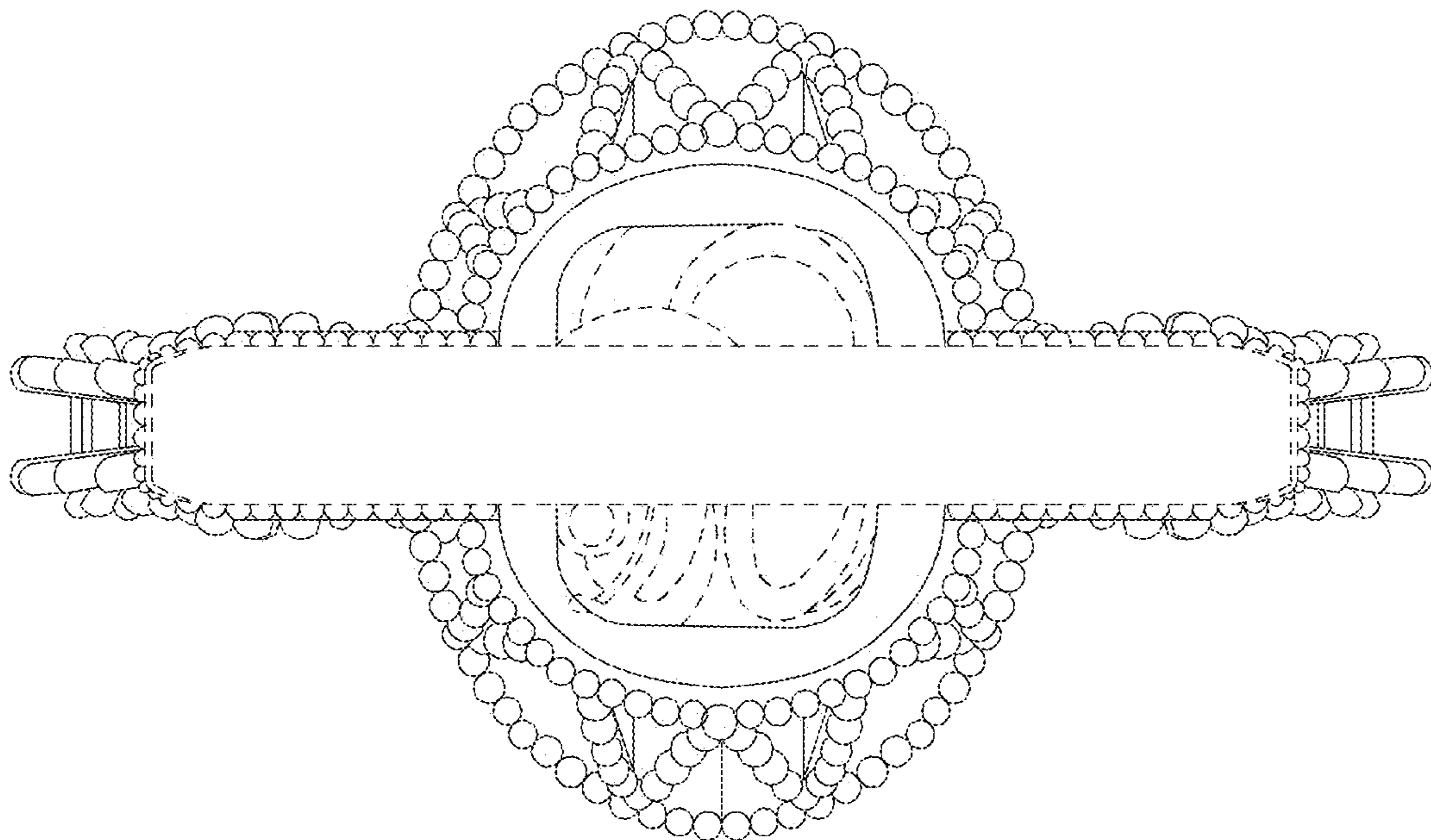
