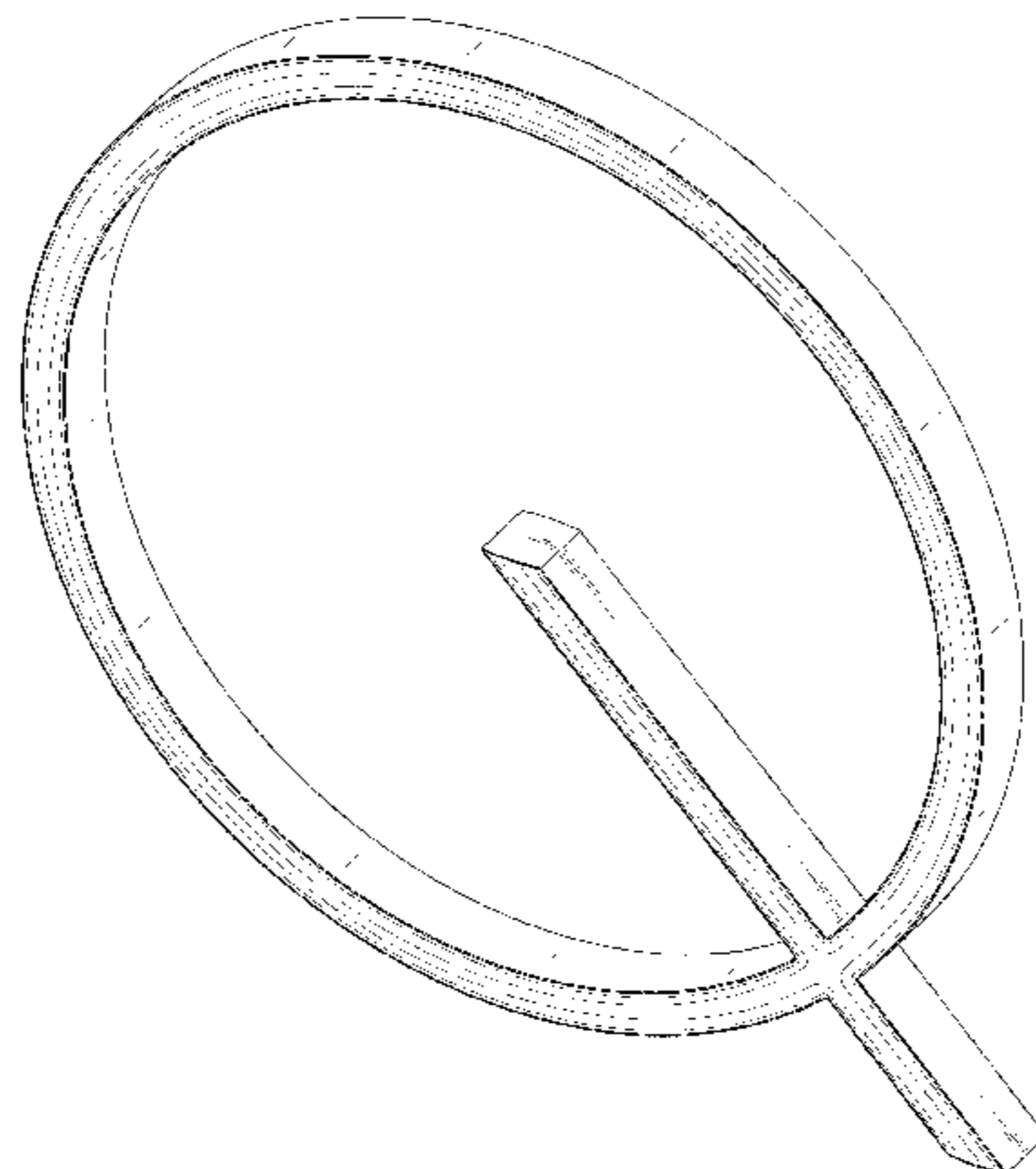
(57) **CLAIM**

The ornamental design for a sculpture, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a sculpture showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left-side elevation view thereof;
FIG. 5 is a right-side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a cross-sectional view taken along the line 8-8 in FIG. 2; and,
FIG. 9 is a front perspective view thereof, shown in an example environment.
The dash-dash broken lines shown in FIG. 8 illustrate portions of the sculpture that form no part of the claimed design. The dot-dashed broken lines and associated stippled surface in FIG. 9 depict environmental subject matter that forms no part of the claimed design.

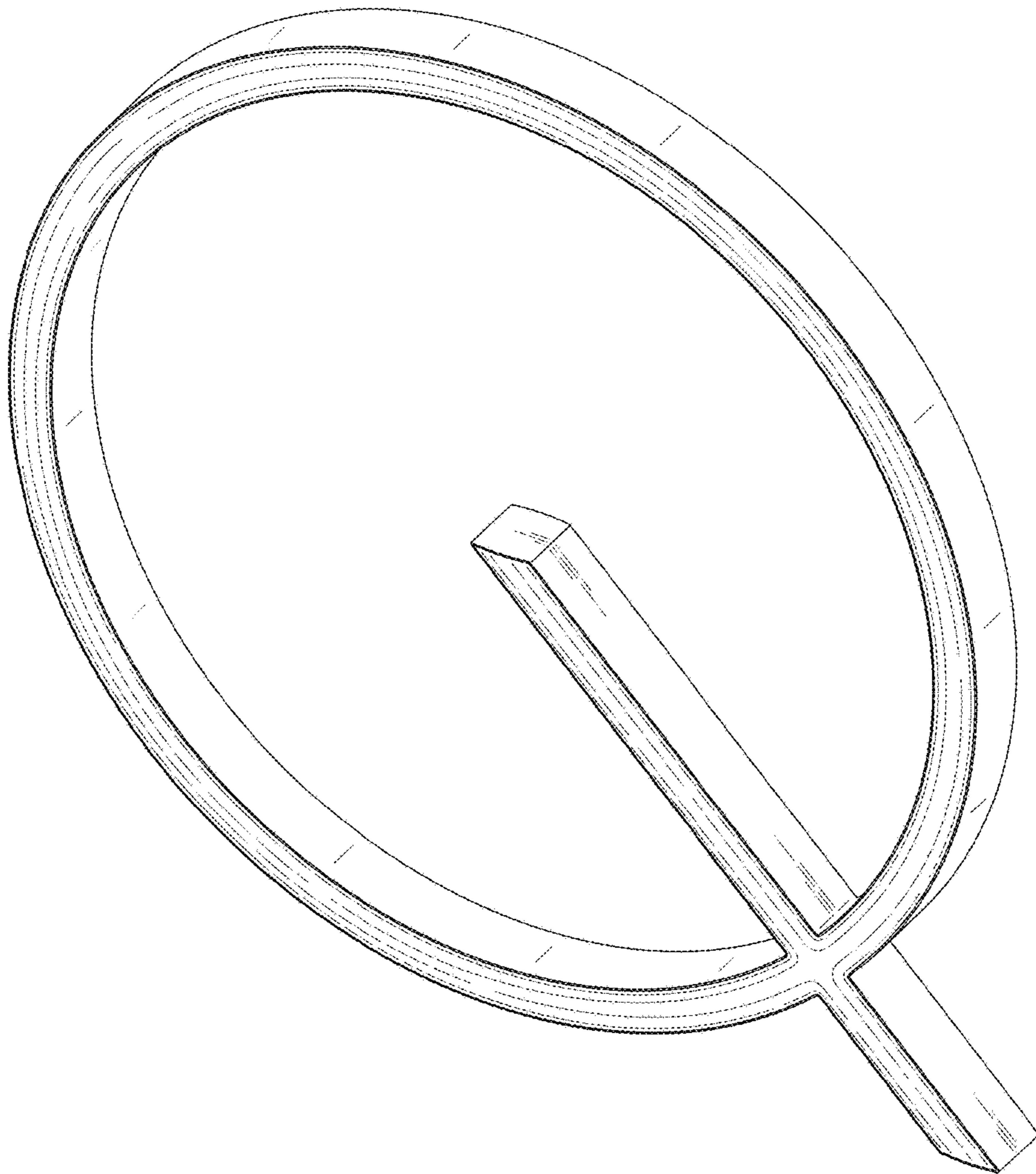

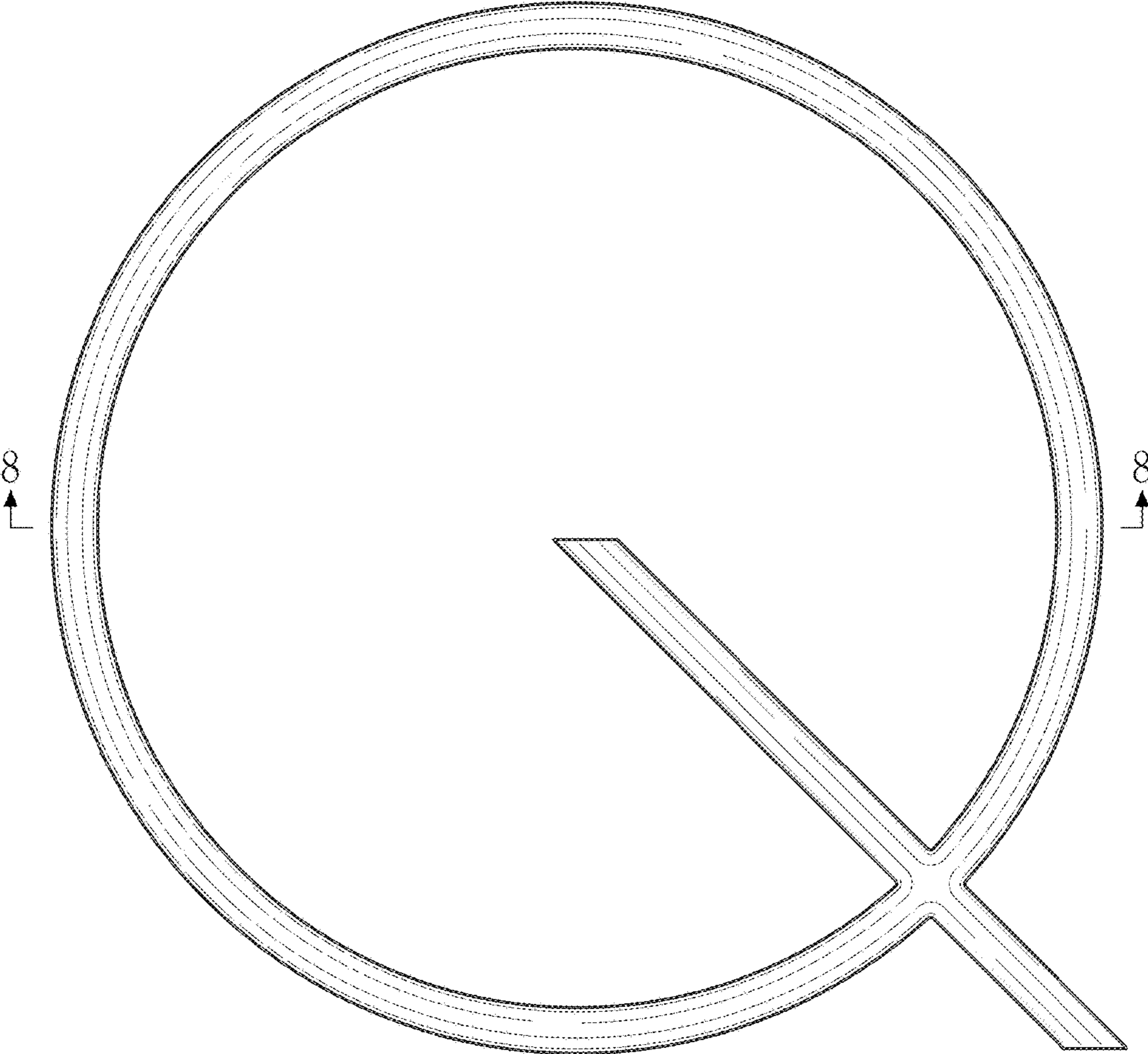

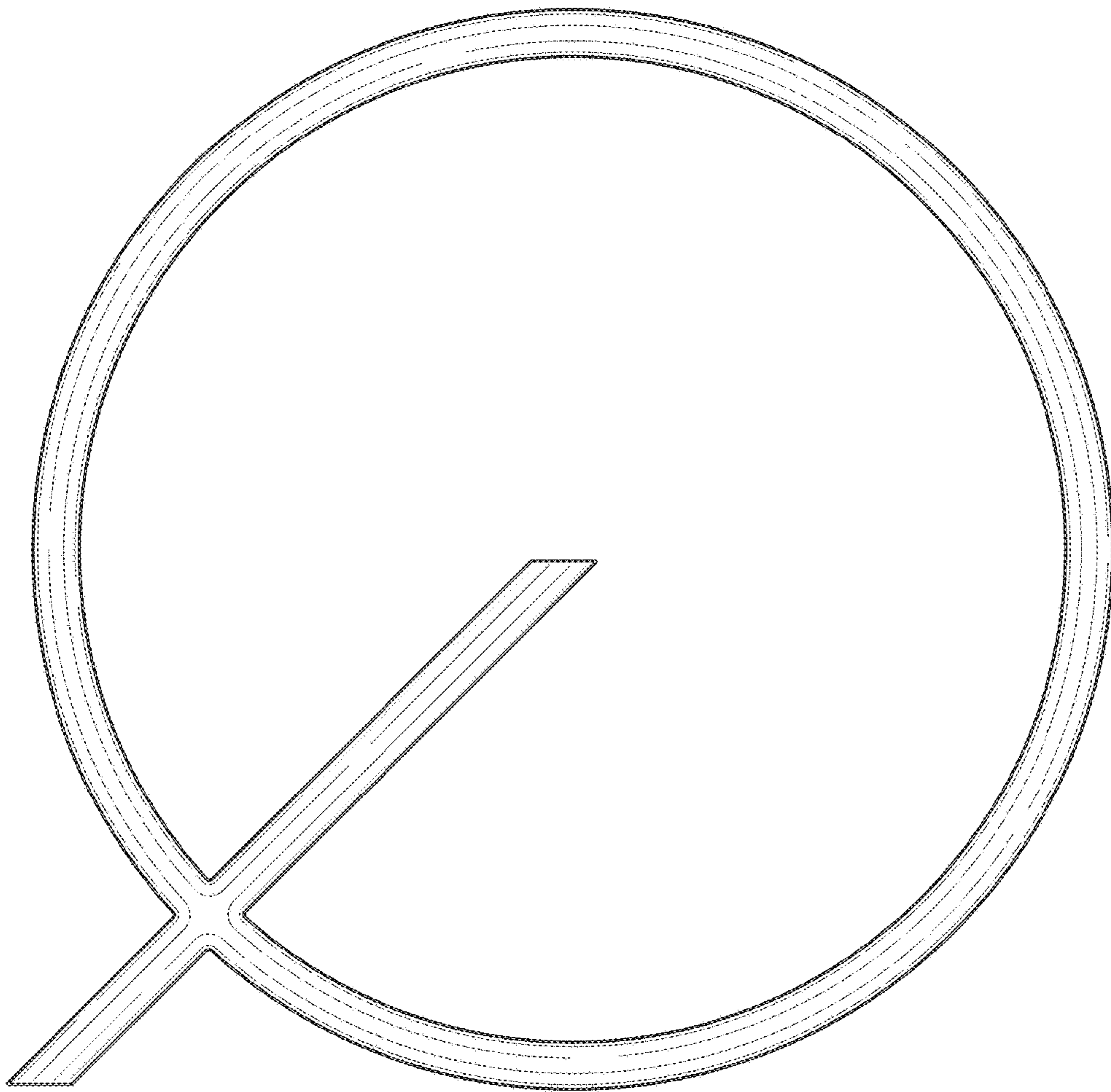

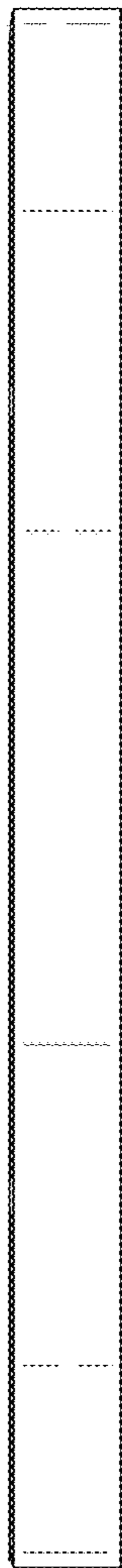

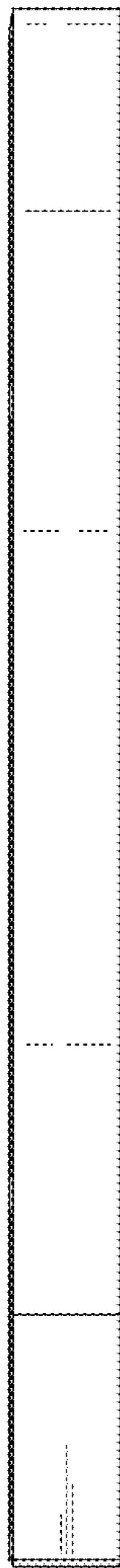
