(57) **CLAIM**

The ornamental design for a motor vehicle and/or toy replica thereof, as shown and described.

**DESCRIPTION**

FIG. 1 is a left, front perspective view of a motor vehicle and/or toy replica thereof showing our new design; FIG. 2 is a left, rear perspective view thereof; FIG. 3 is a right, front perspective view thereof; FIG. 4 is a right, rear perspective view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a front view thereof; FIG. 8 is a rear view thereof; and, FIG. 9 is a top view thereof.

The claimed design is indicated by the relatively dark portions in the figures. The relatively light portions form no part of the claimed design.














