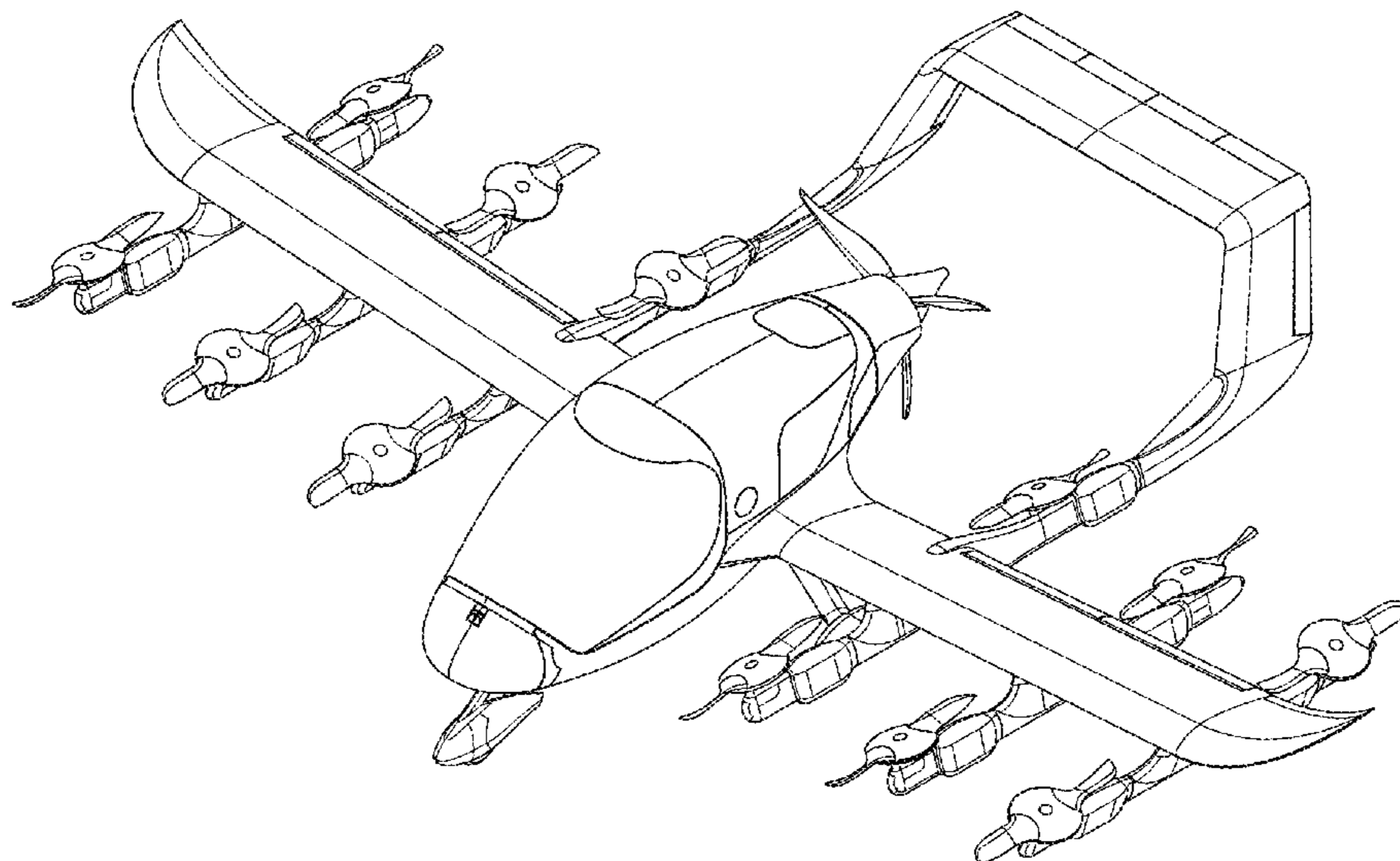
We claim the ornamental design for an aircraft, as shown and described.

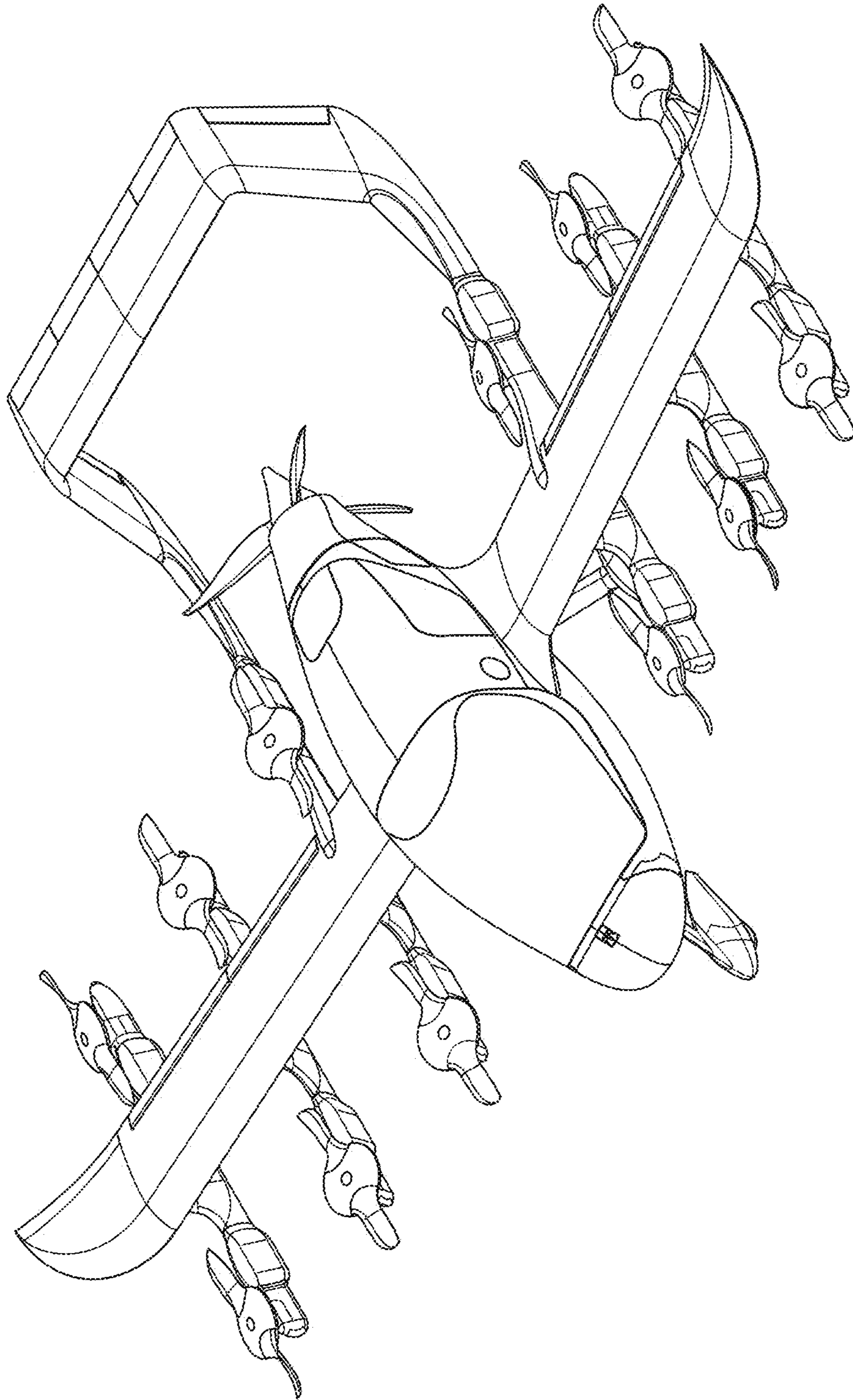

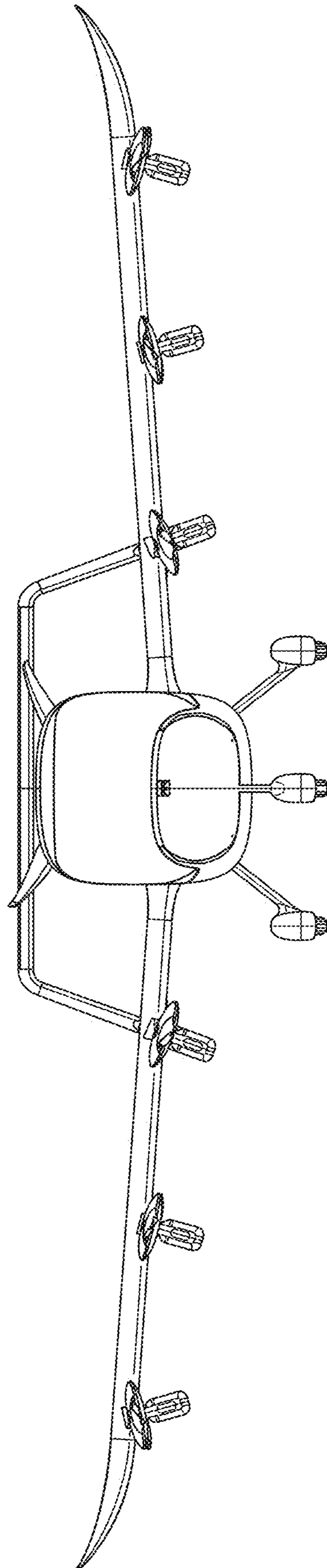

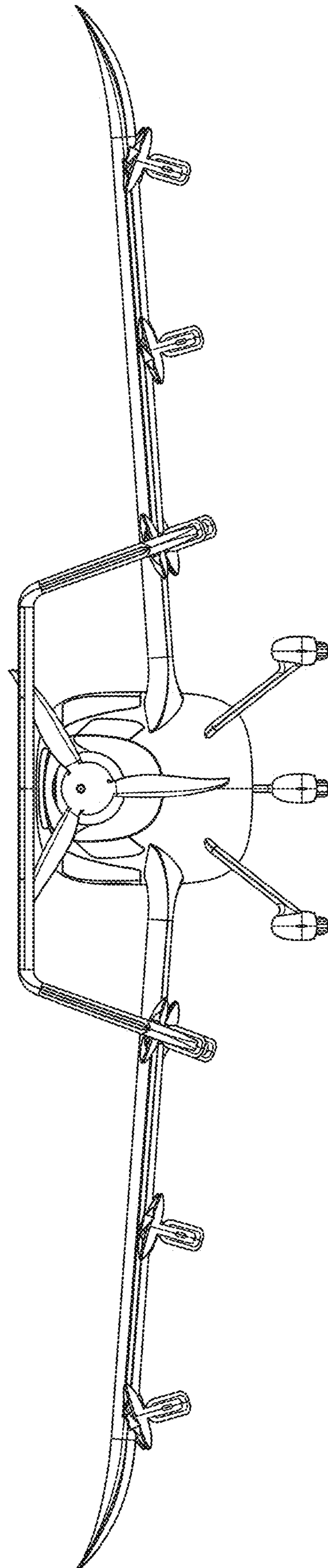

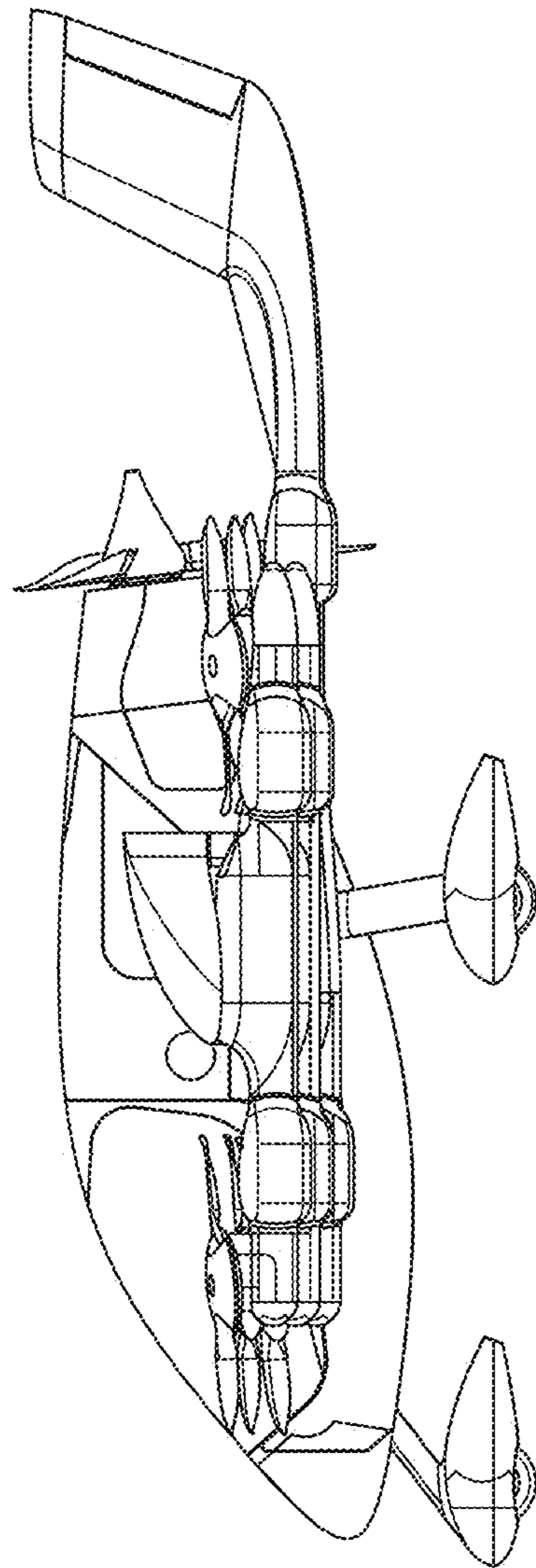

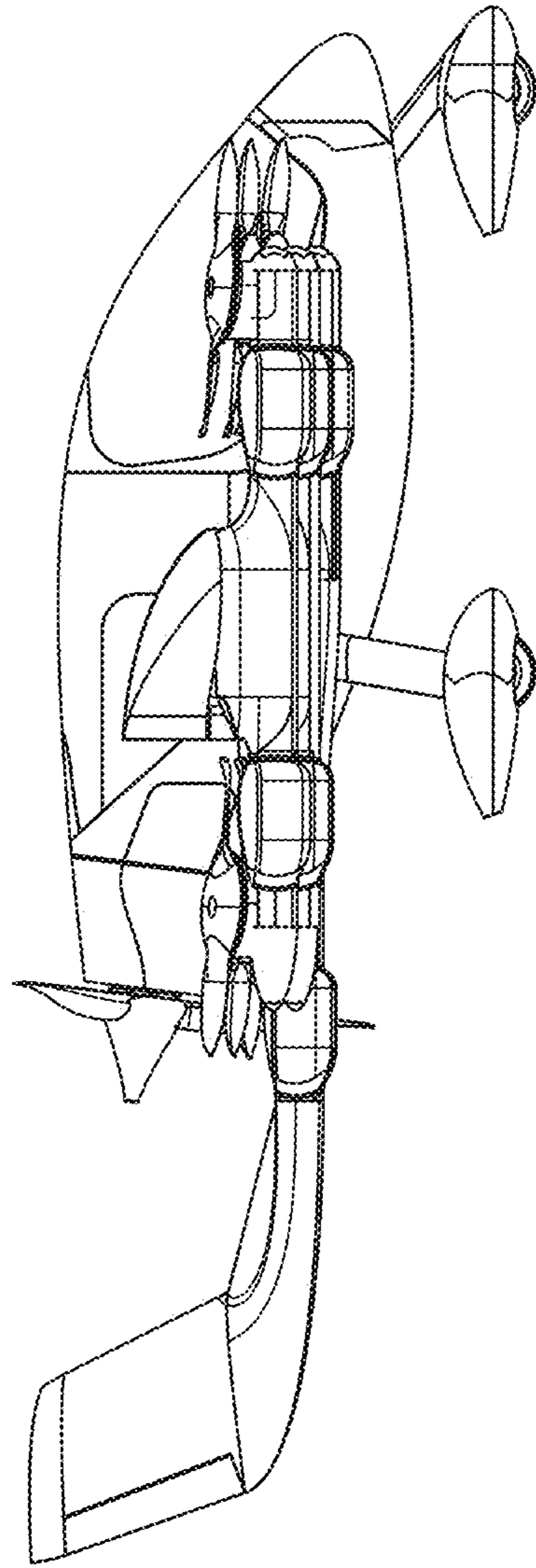

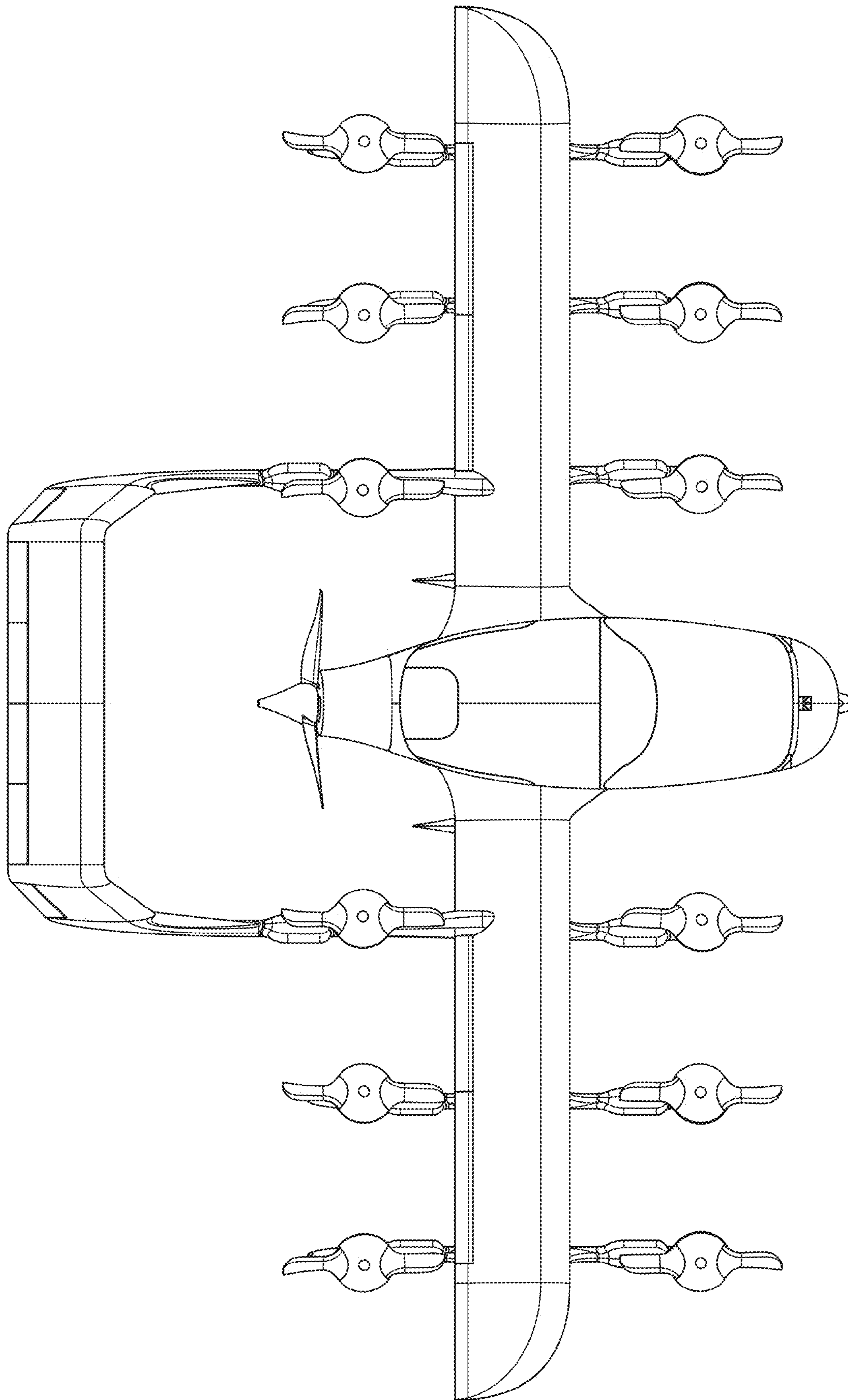

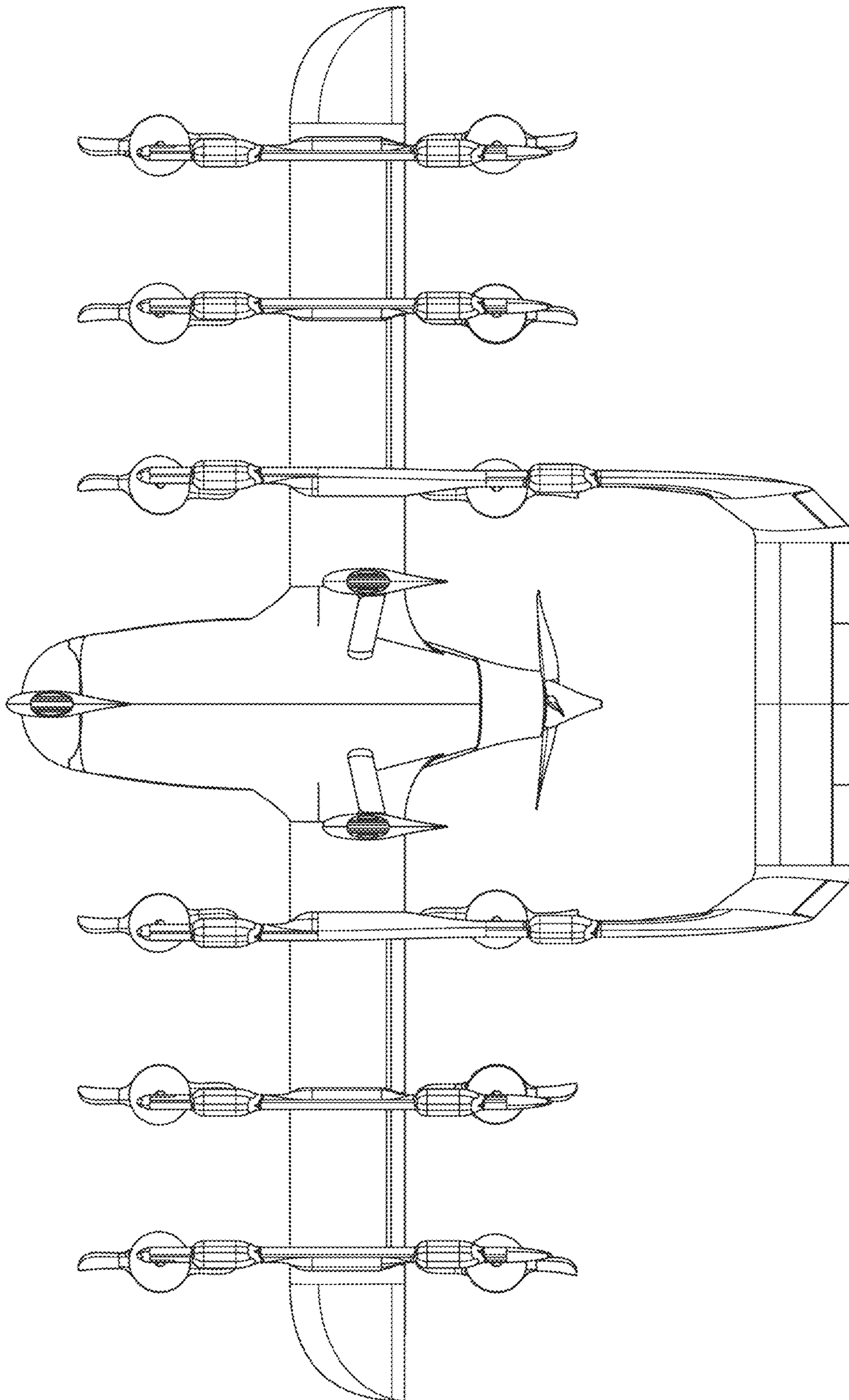
