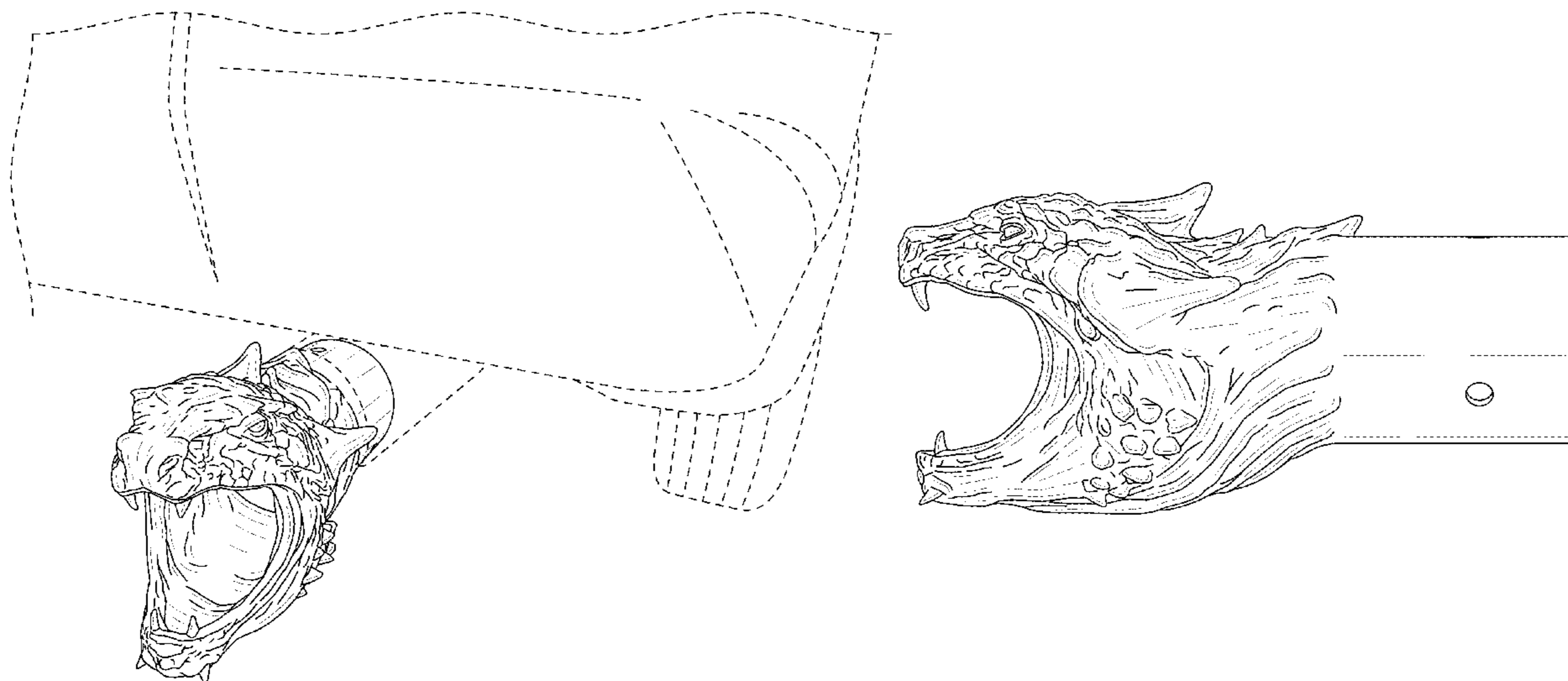
The ornamental design for the exhaust pipe tip, as shown and described.

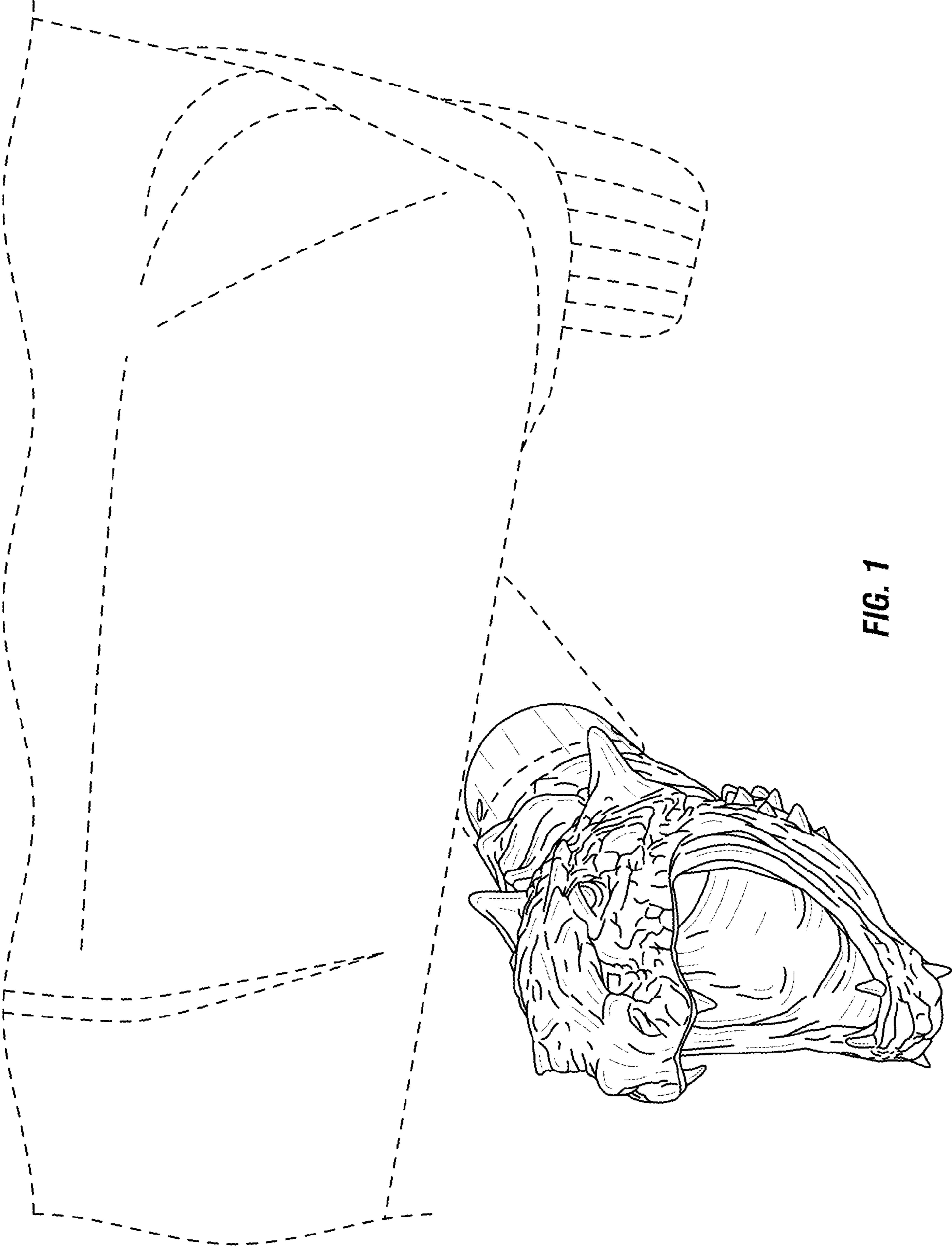

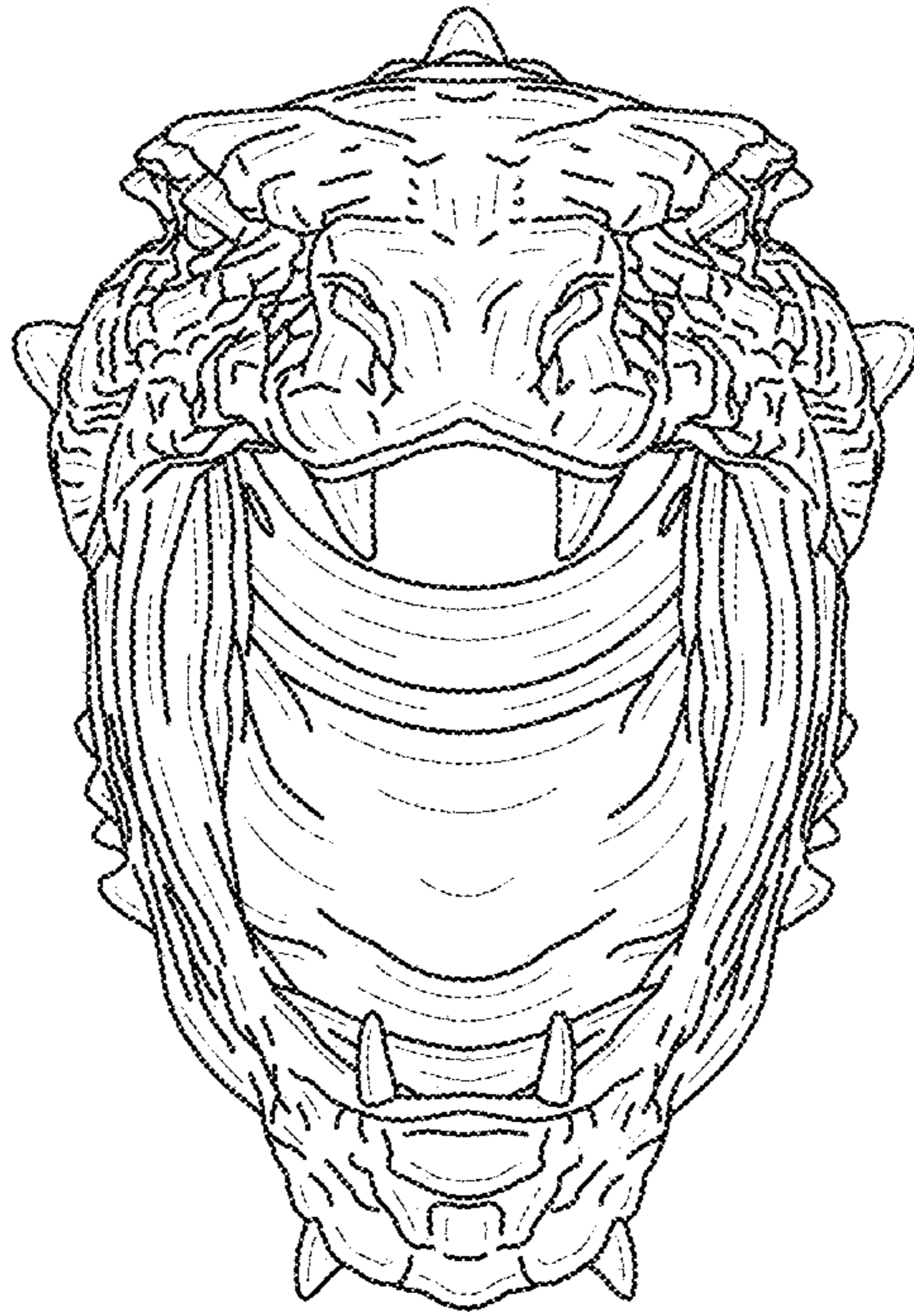

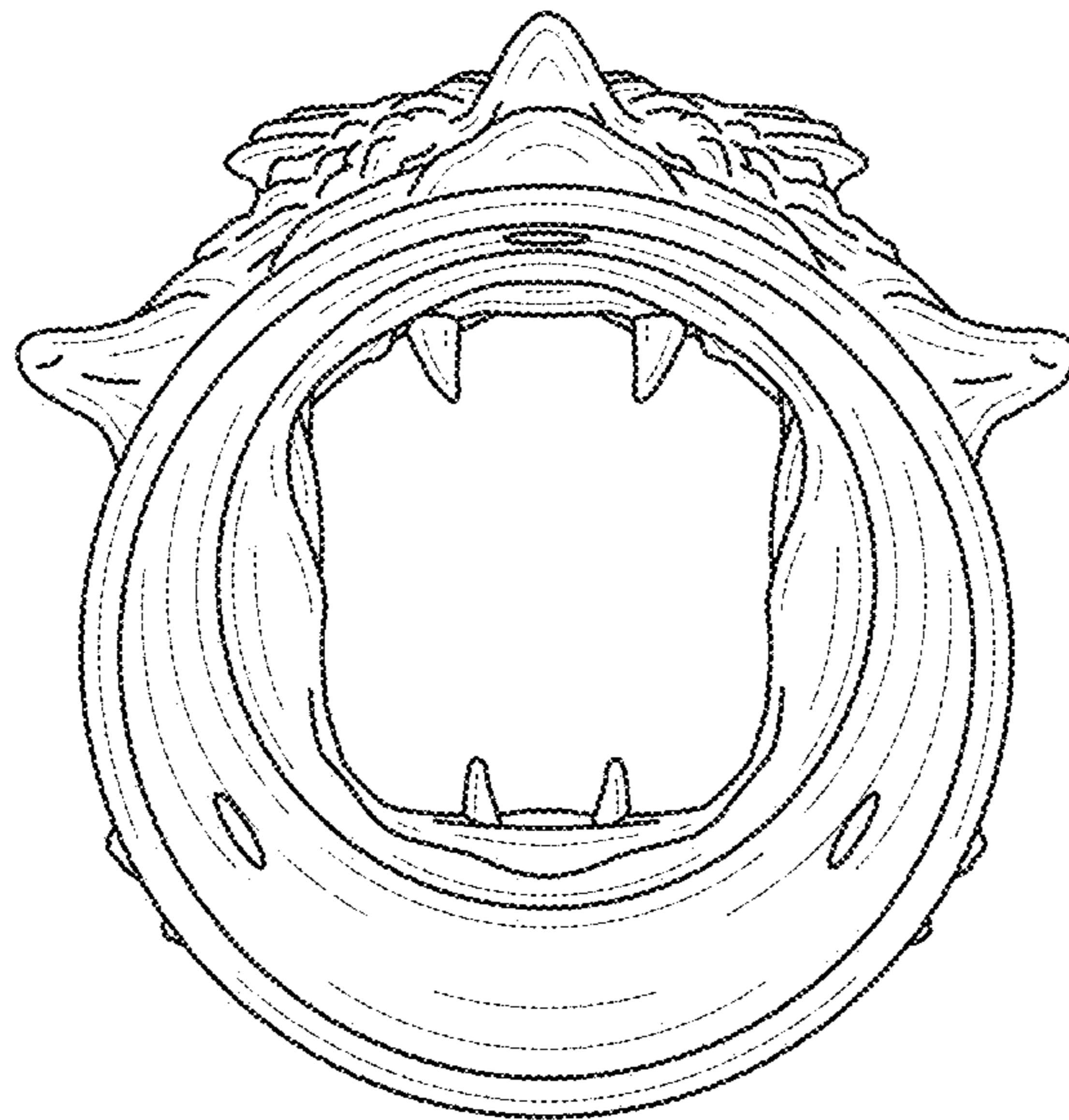

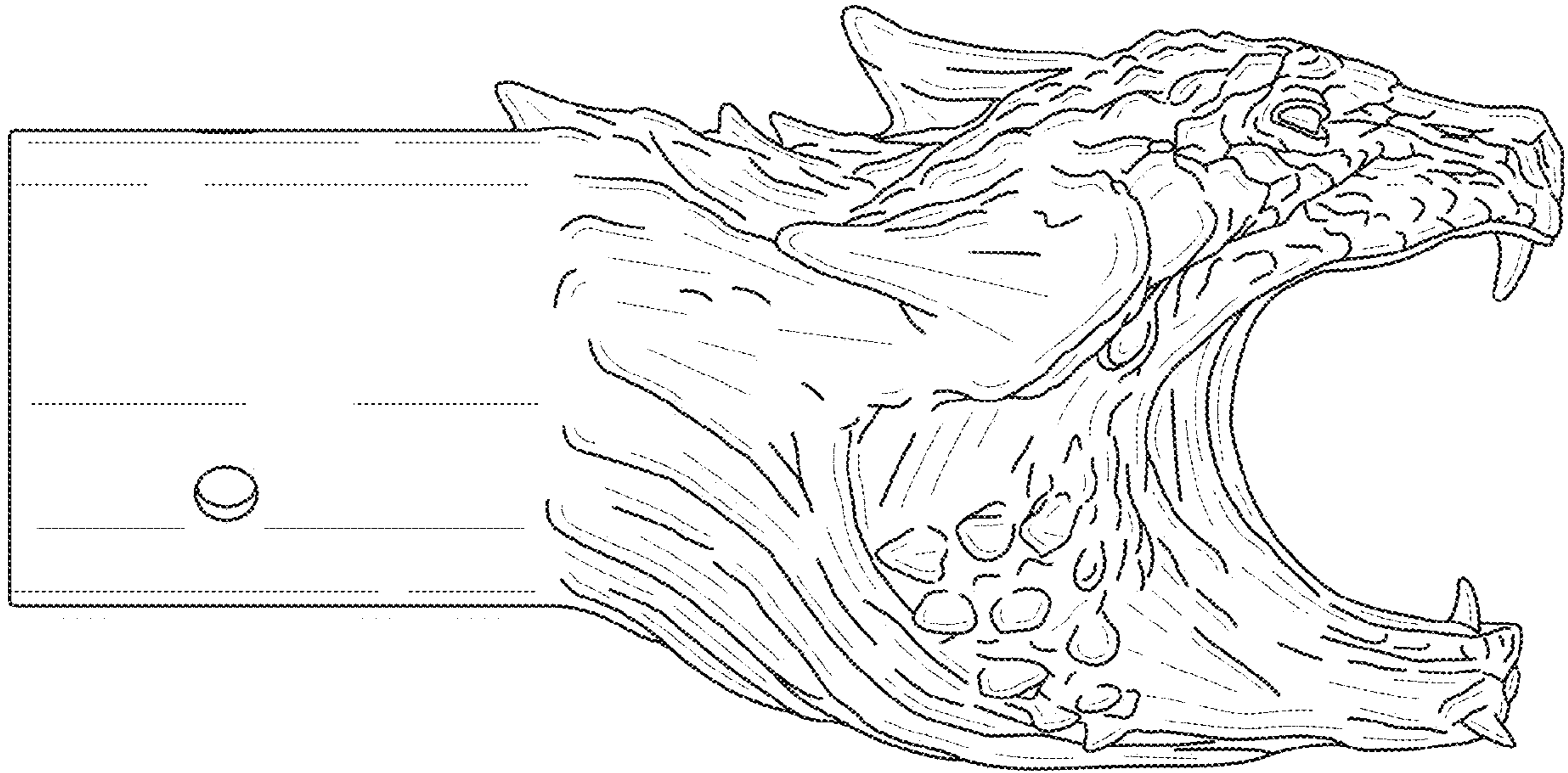

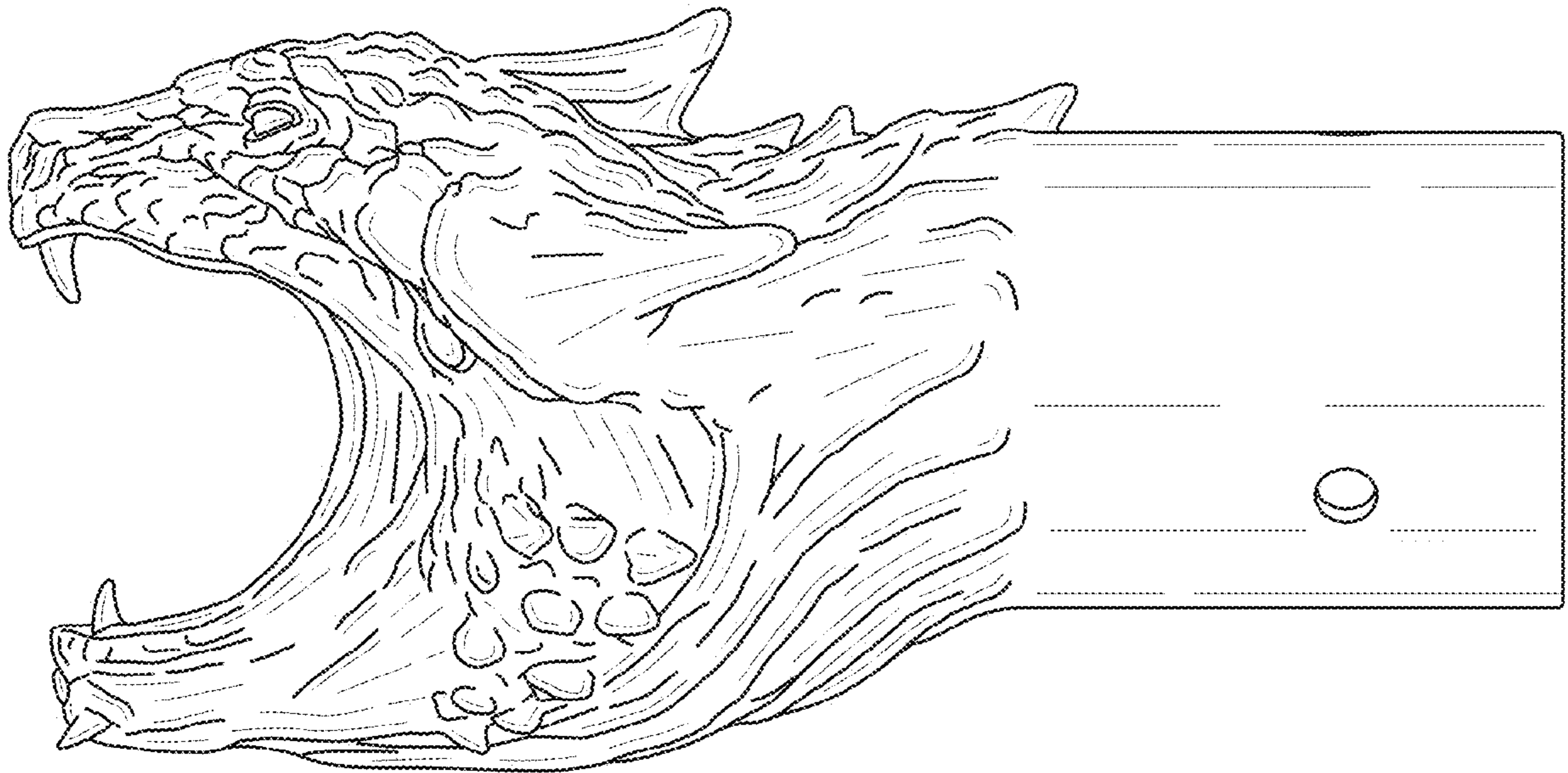
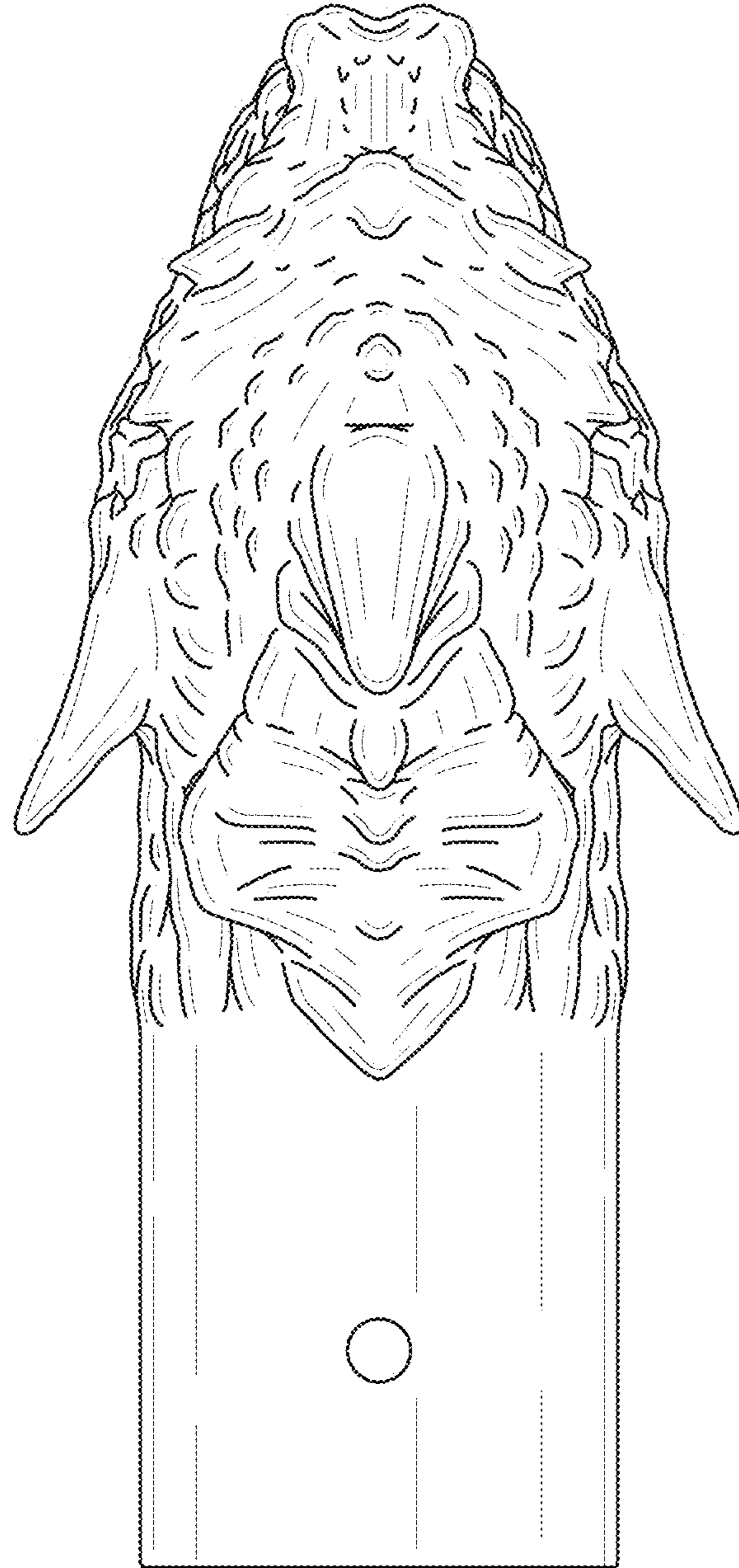
