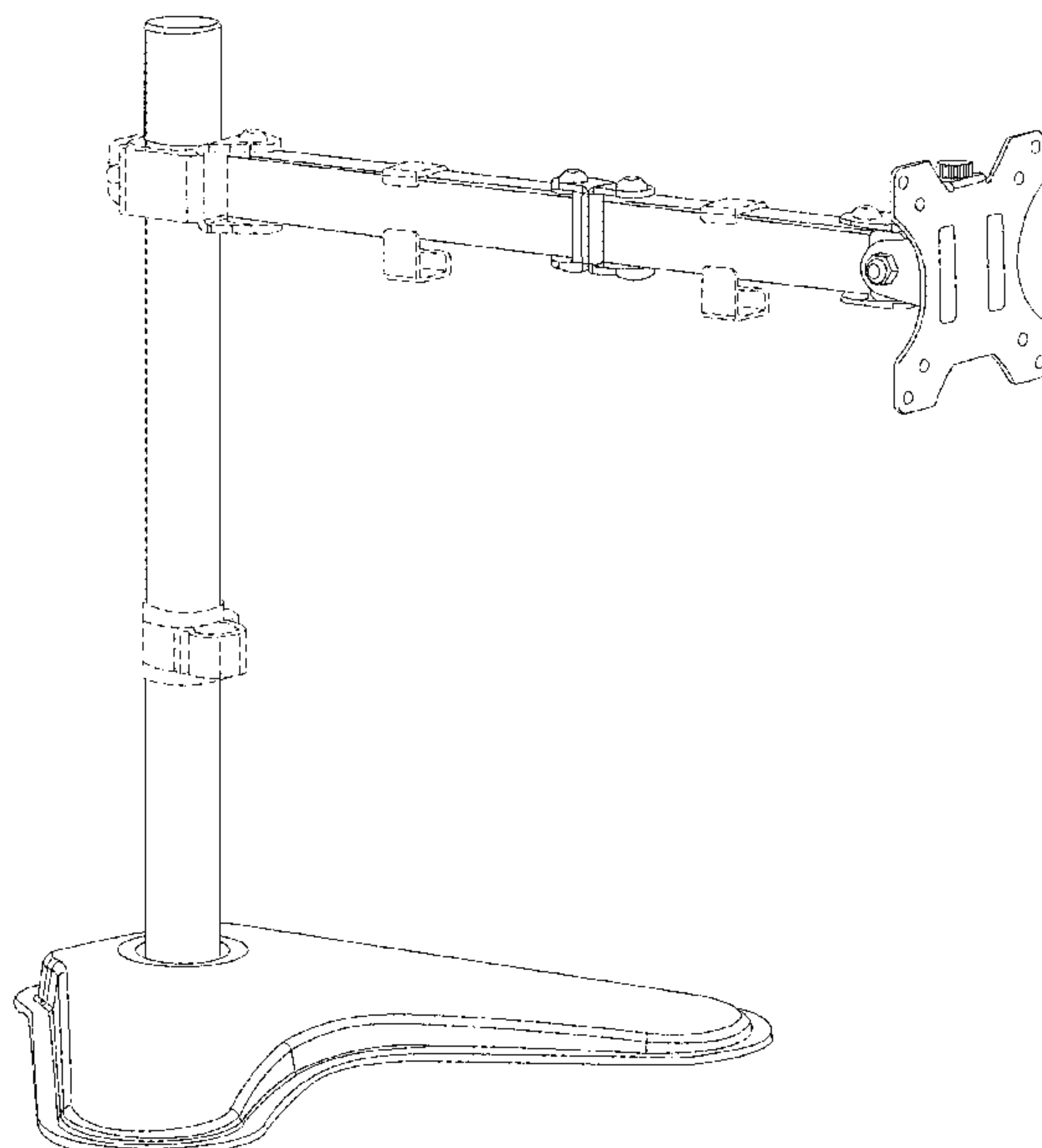
FIG. 1 is a first isometric view of an articulating display mount.

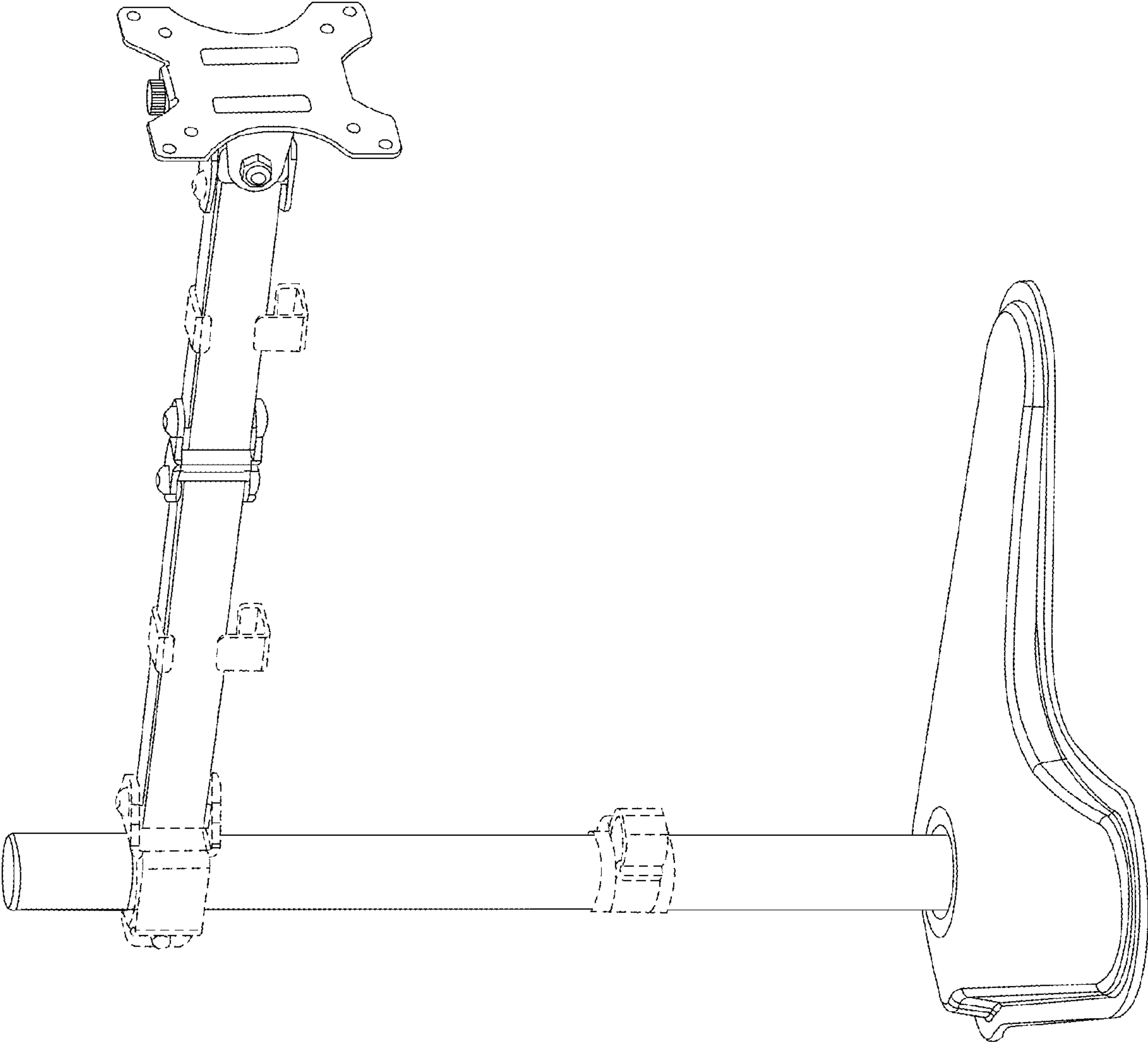

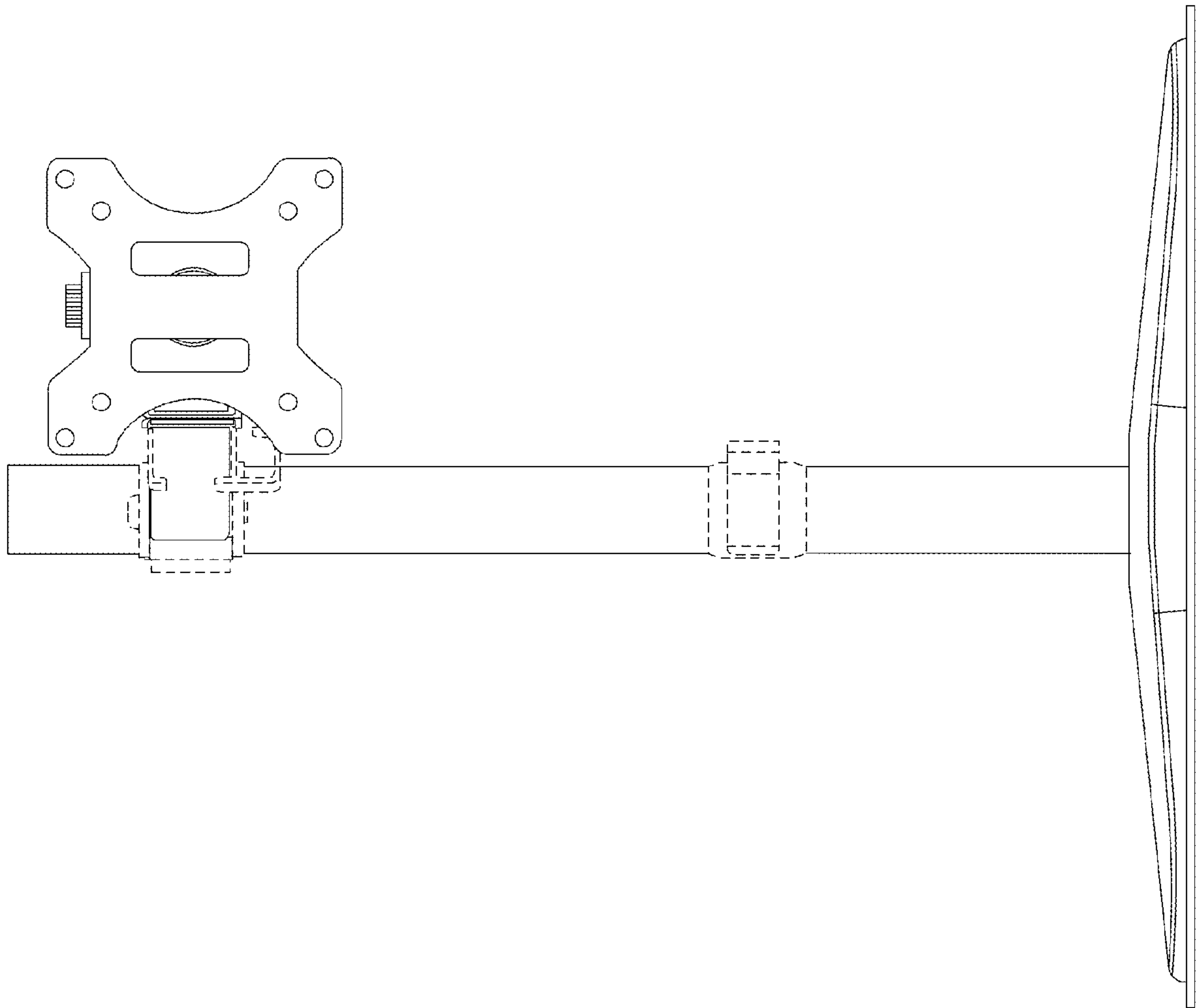

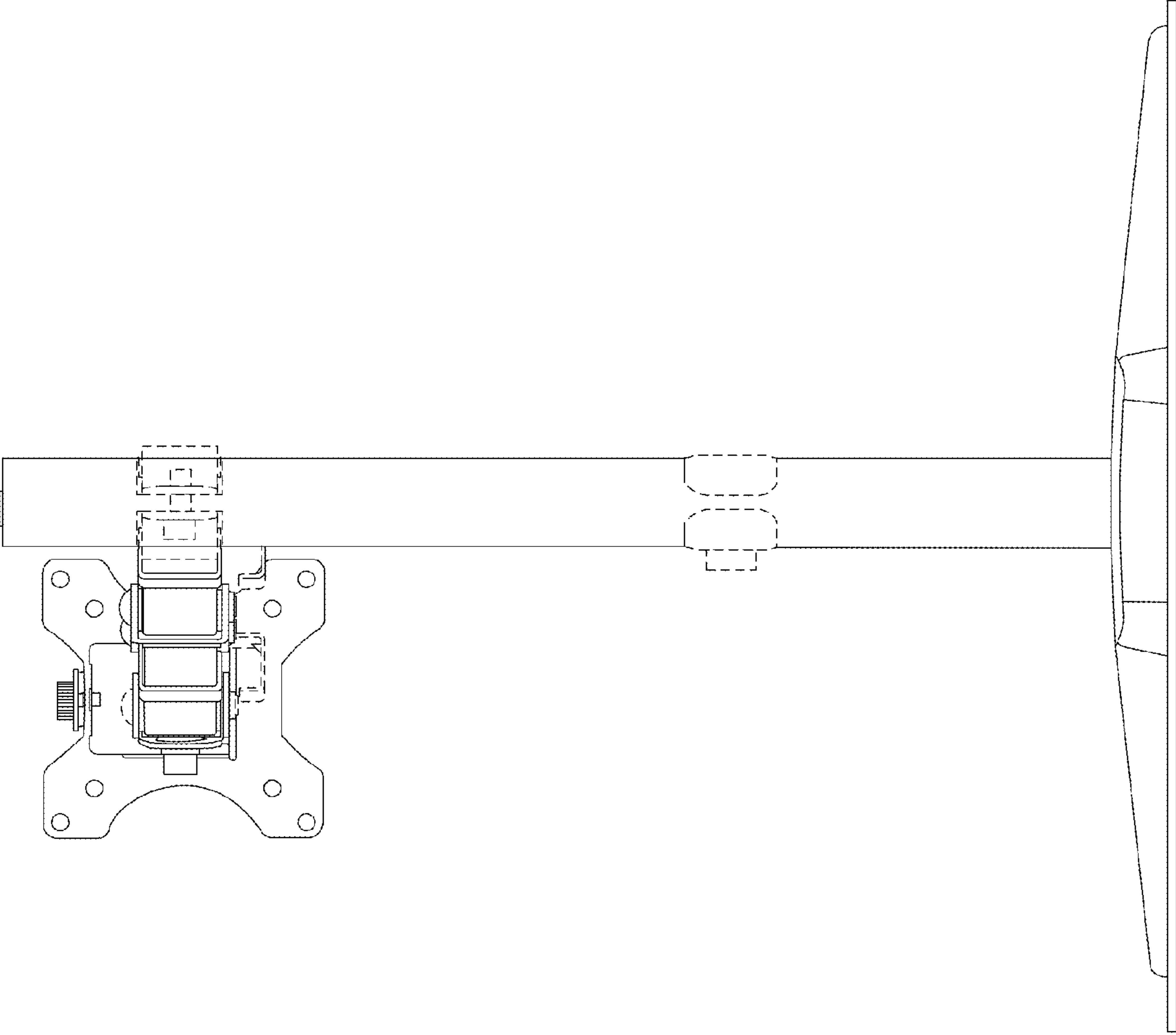

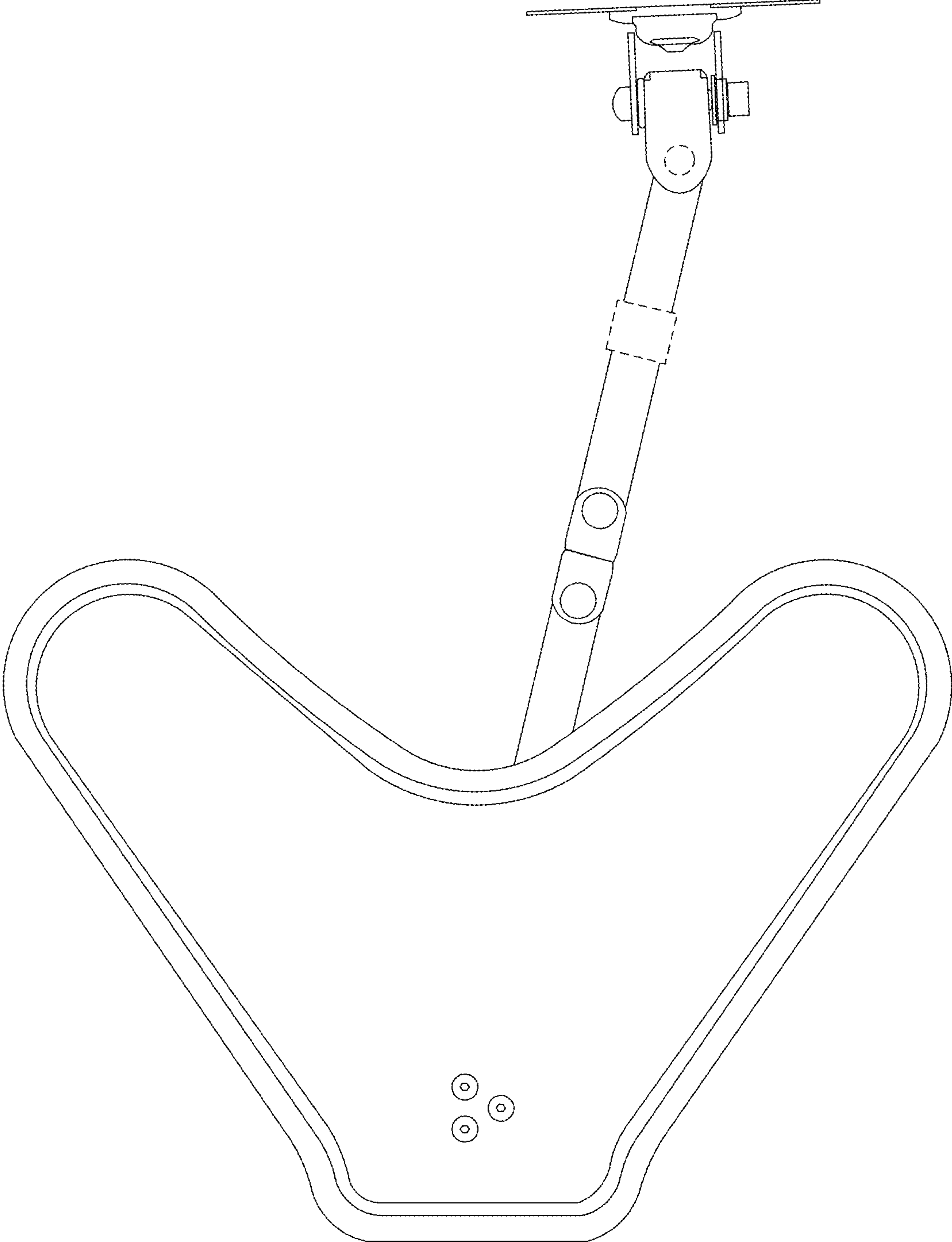

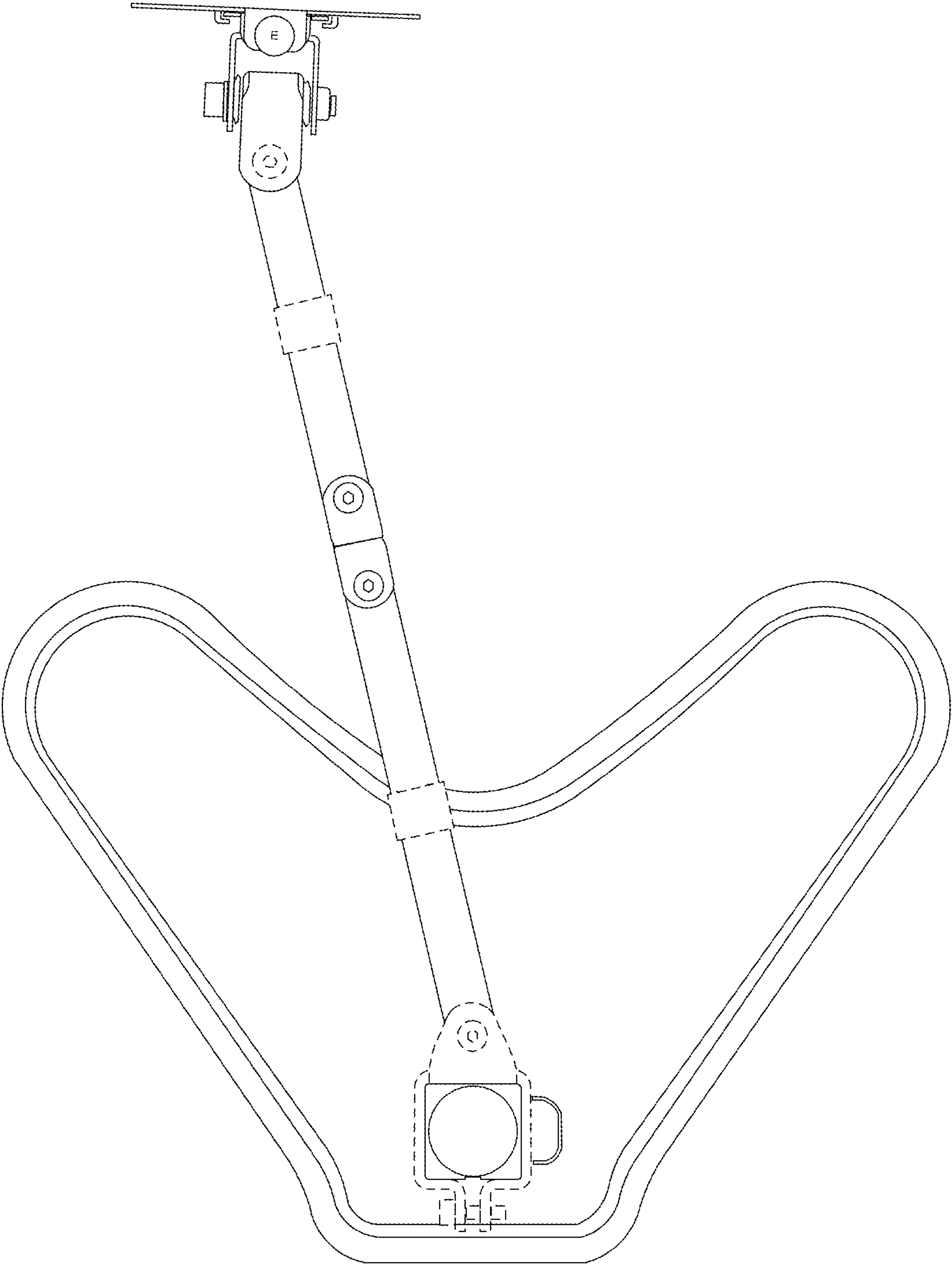

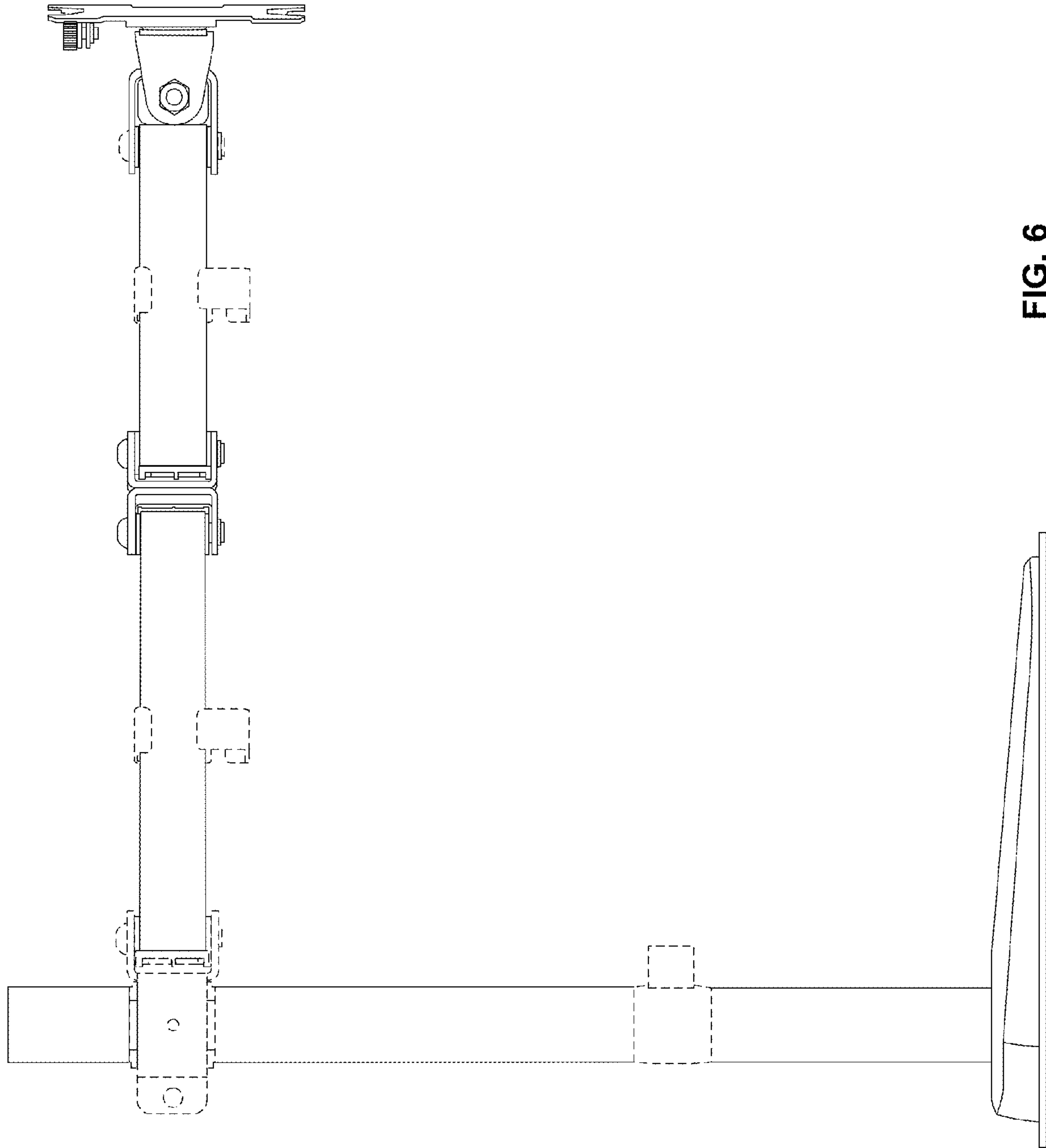

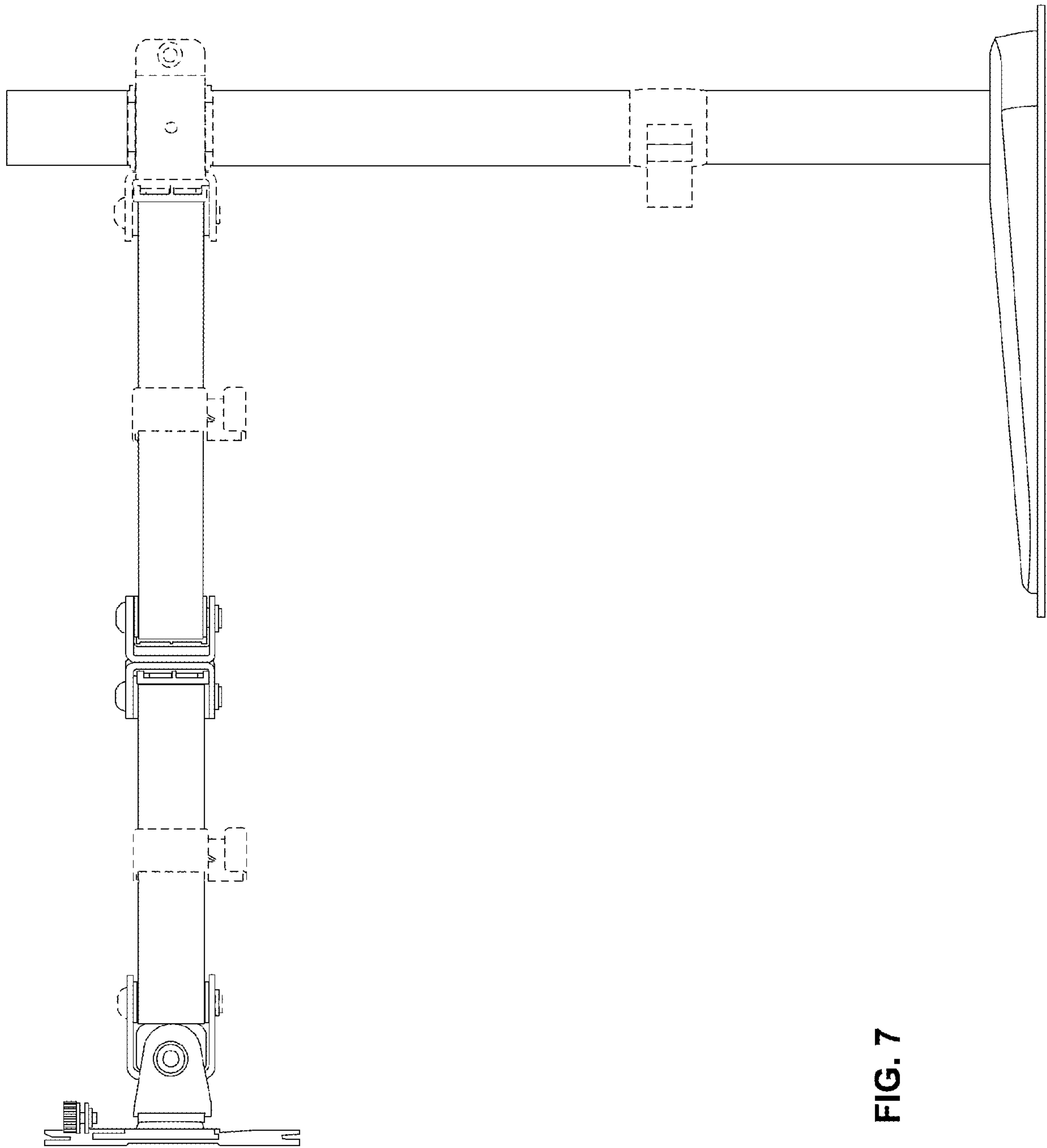
