(57) **CLAIM**

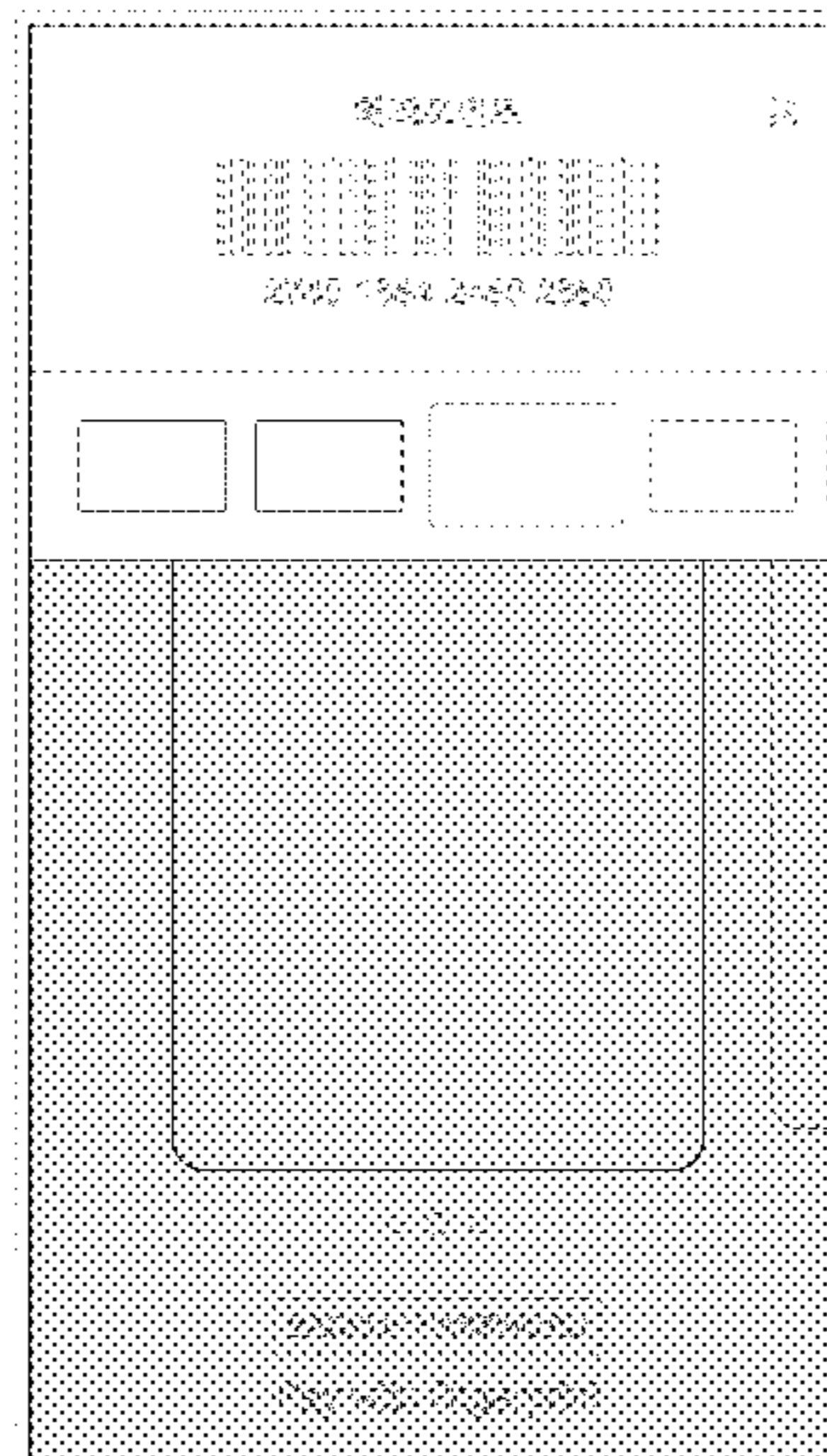
We claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

The sole FIGURE is a front view of a display screen or portion thereof with graphical user interface showing our new design in which the portions having low brightness are illustrated in grey.
